DESCRIPTION

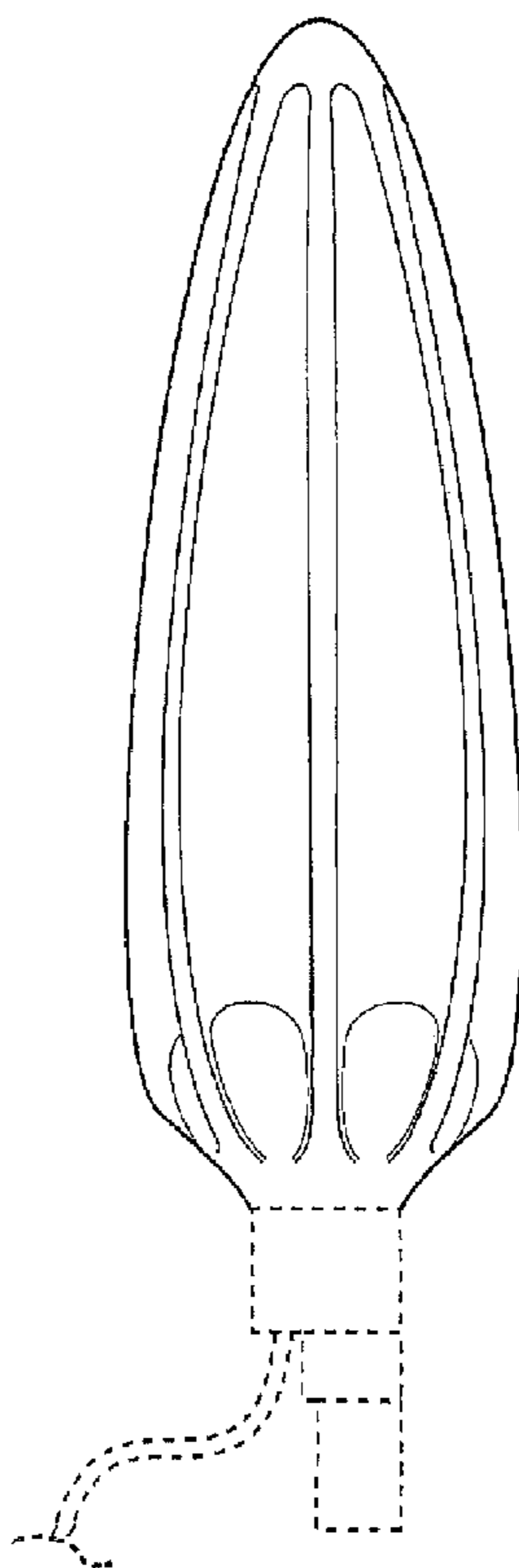
FIG. 1 is a side elevational view of an elastic housing for an infusion device;

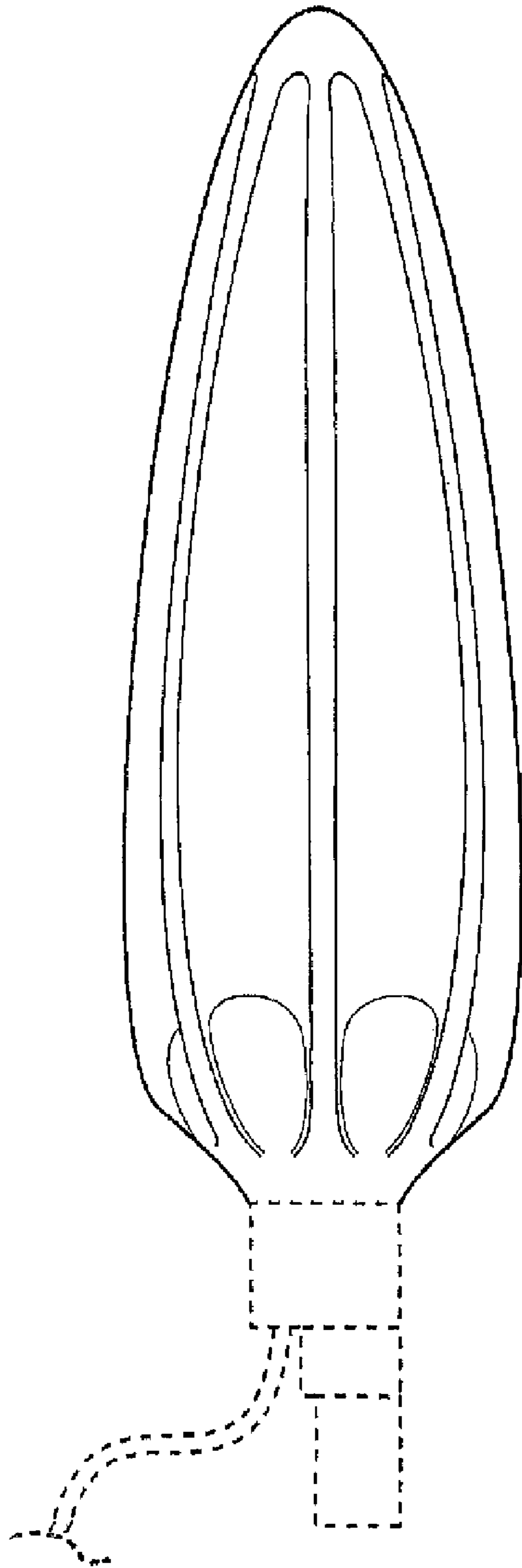

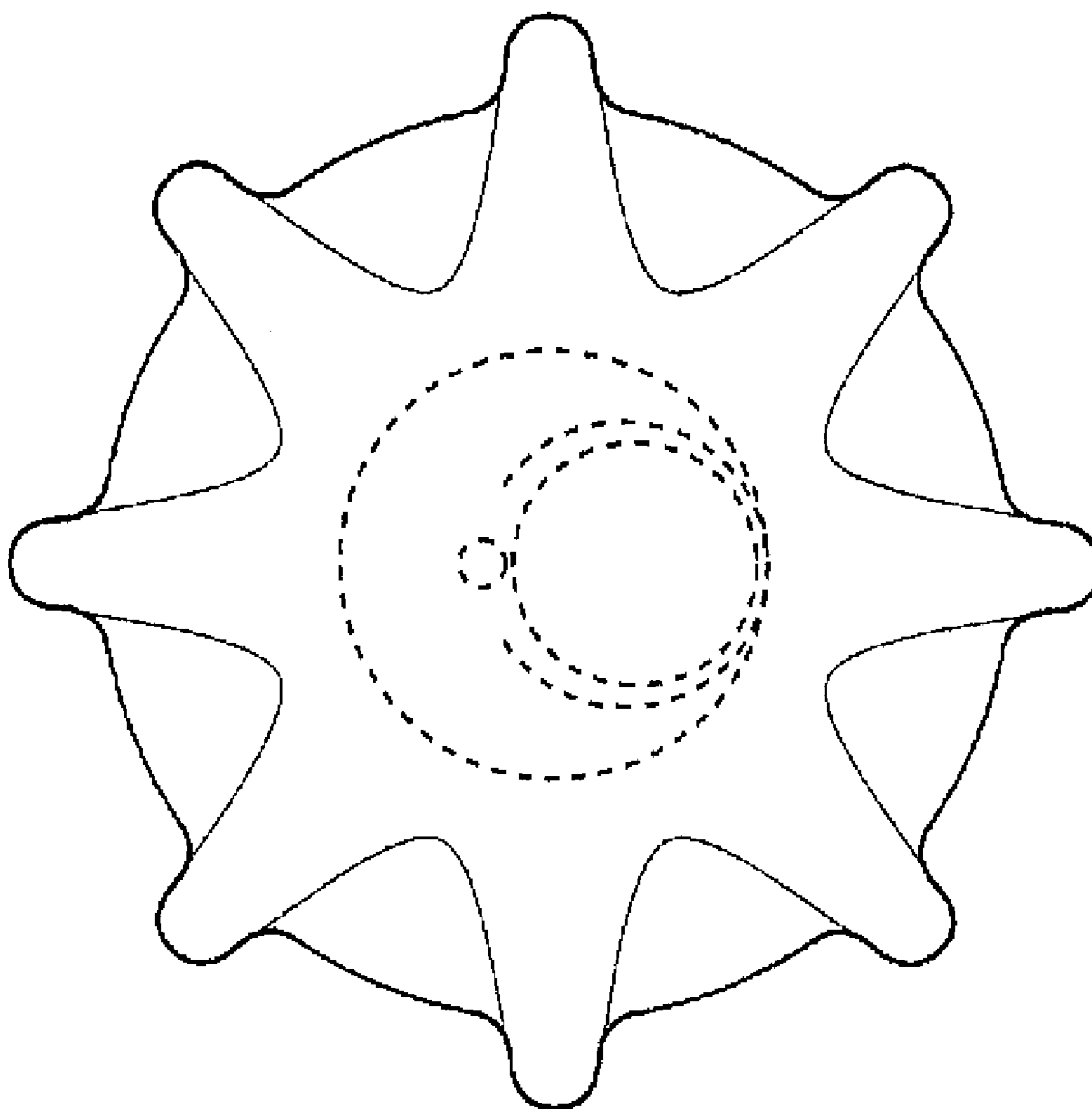

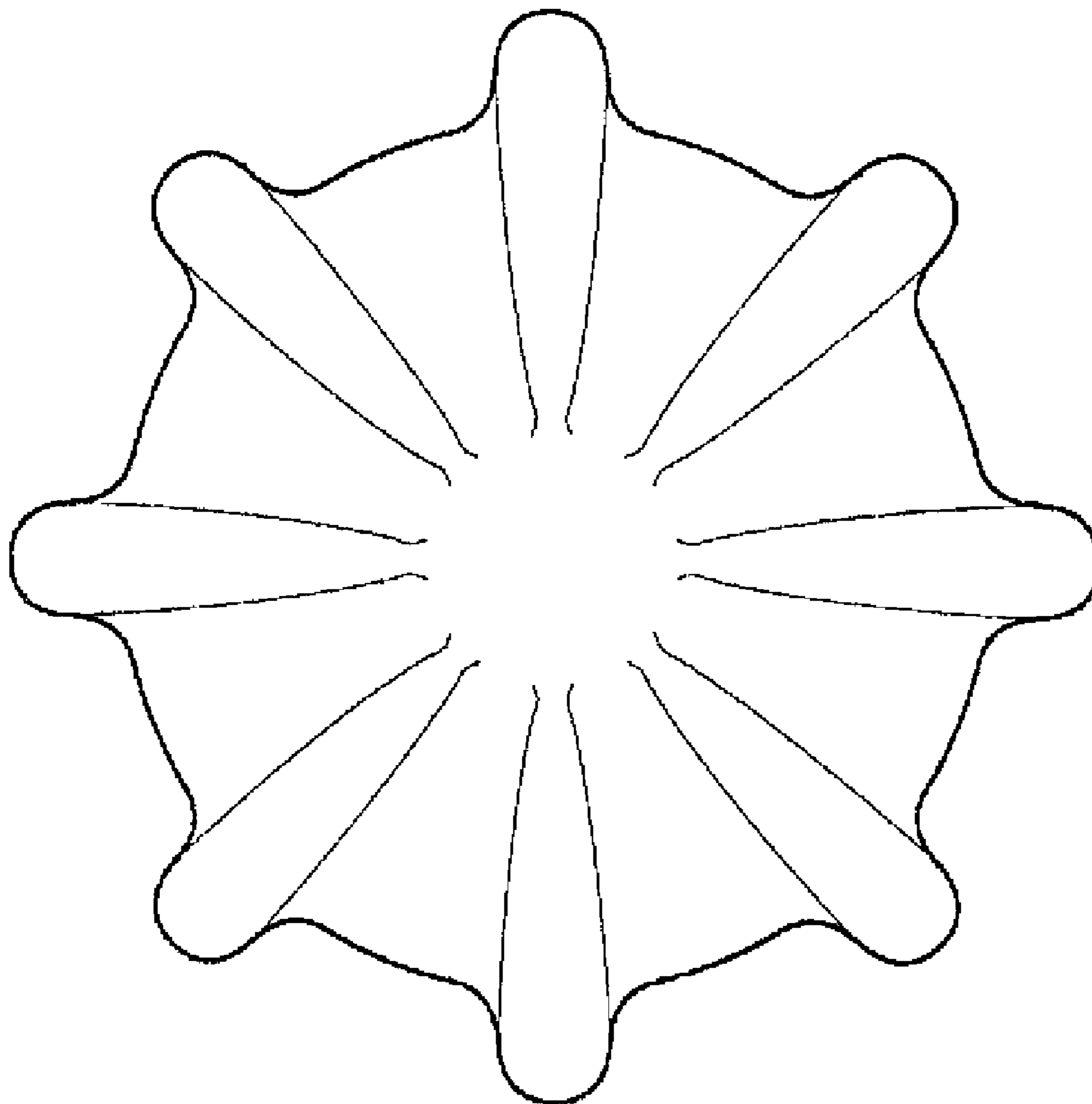
