(57) **CLAIM**

We claim the ornamental design for a landscape edging, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the landscape edging.

FIG. 2 is a cross sectional view taken along line 2—2 of FIG. 1.

FIG. 3 is a cross sectional view taken along line 3—3 of FIG. 1.

FIG. 4 is a back view.

FIG. 5 is a top view.

FIG. 6 is a bottom view.

The claimed design is shown fragmented on the ends to indicate indeterminate length.

FIG. 7 is a front view of a second embodiment of the landscape edging.

FIG. 8 is a cross sectional view taken along line 8—8 of FIG. 7.

FIG. 9 is a cross sectional view taken along line 9—9 of FIG. 7.

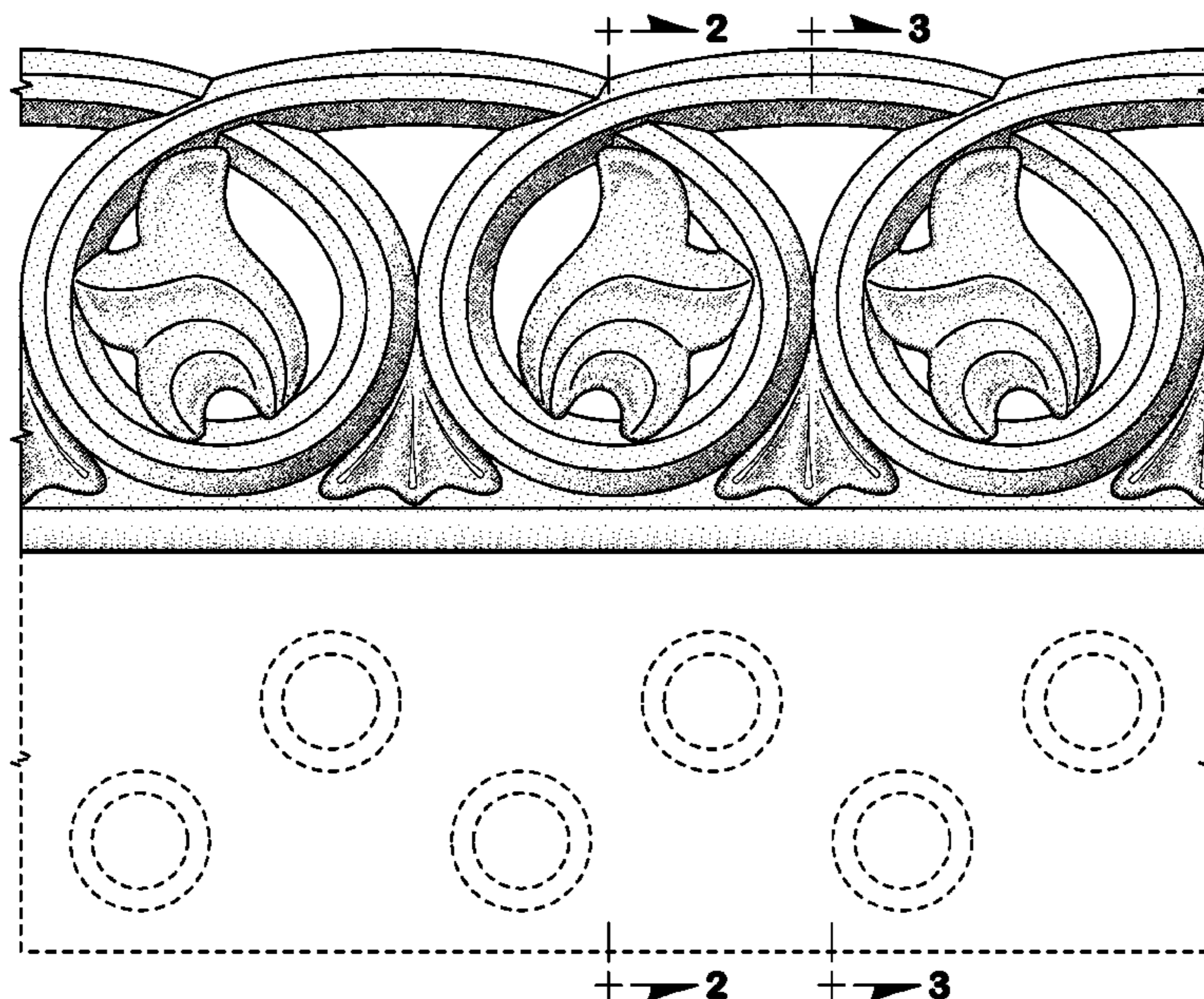
FIG. 10 is a back view.

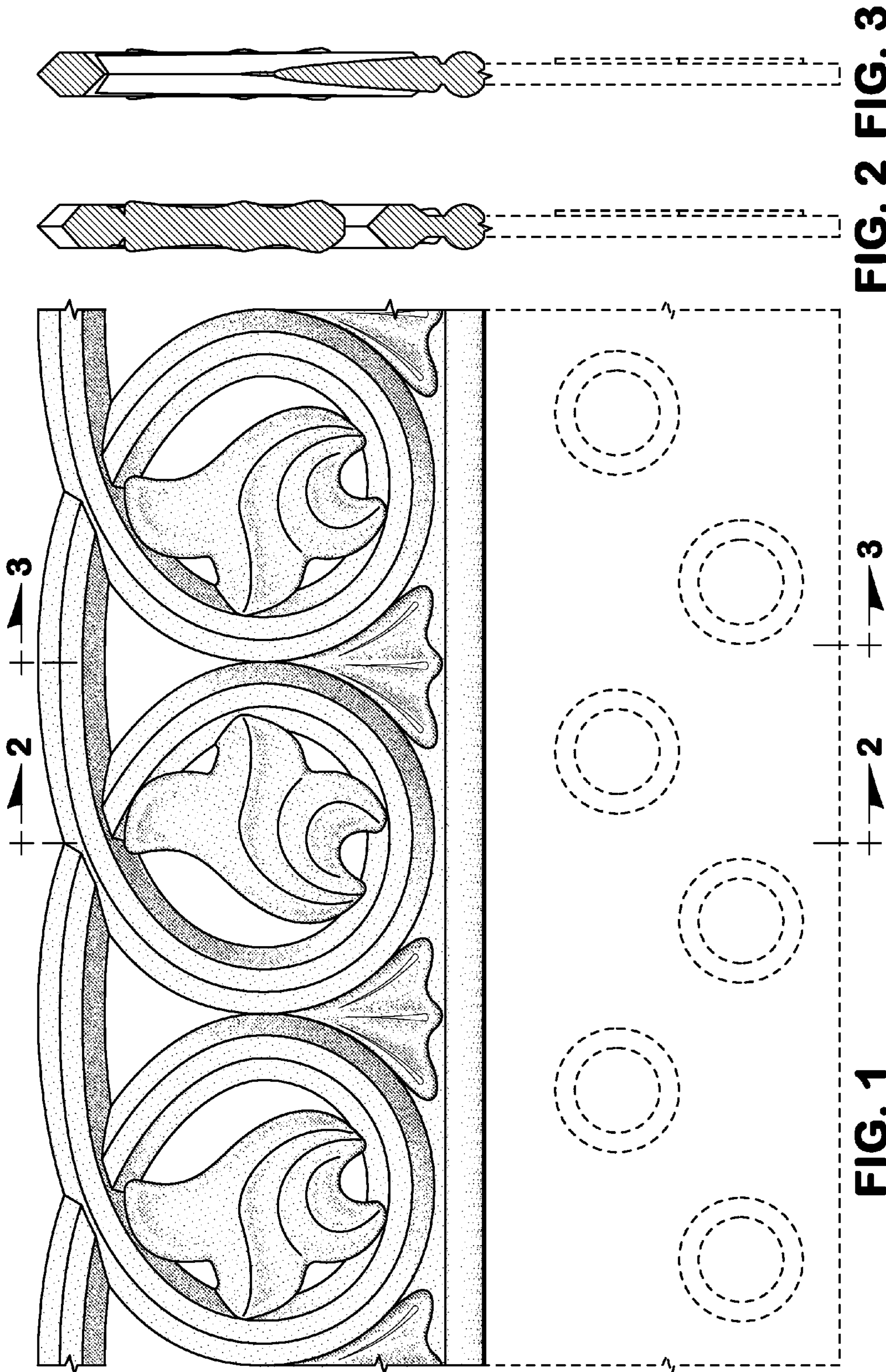


FIG. 2 FIG. 3

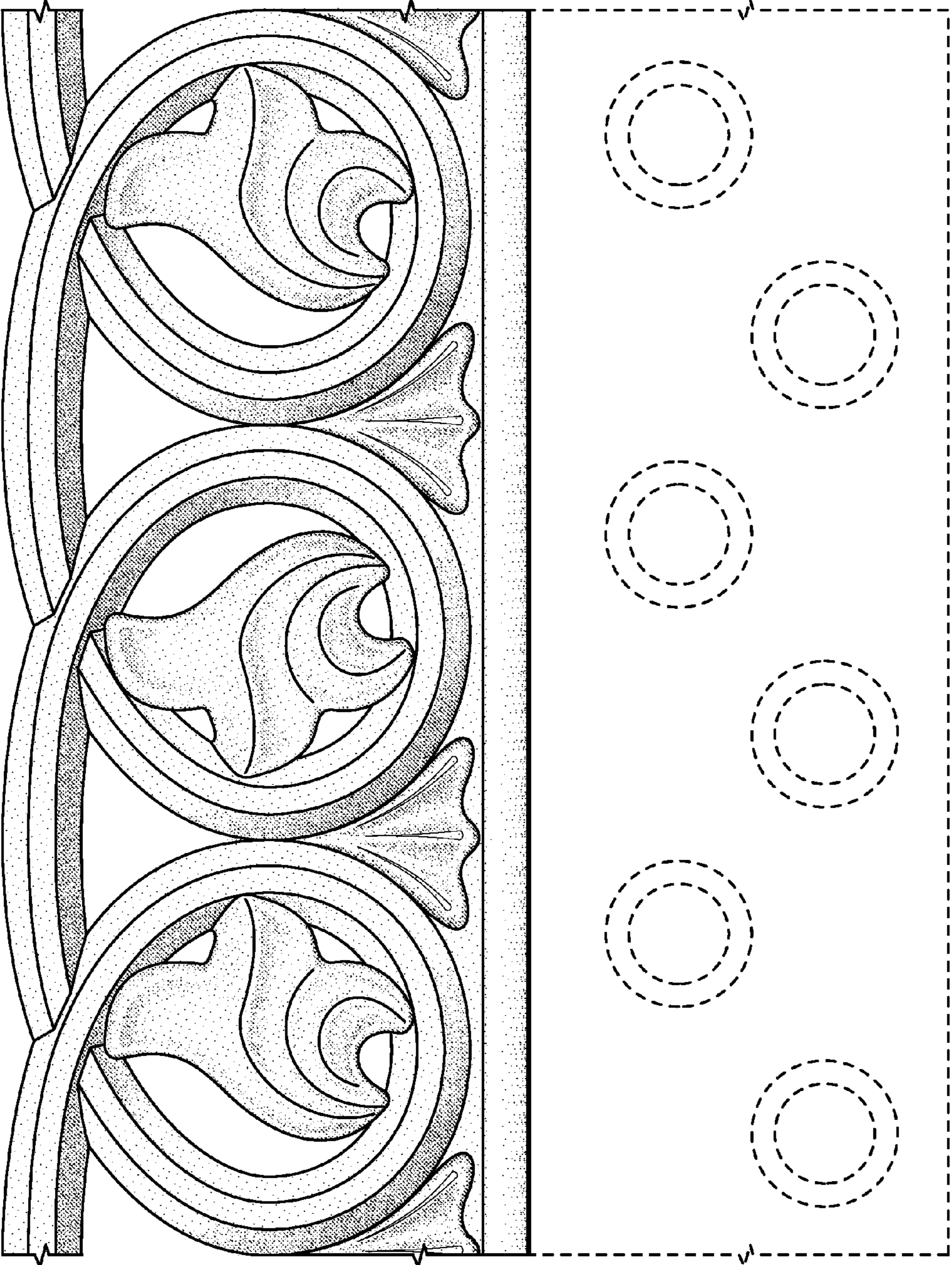

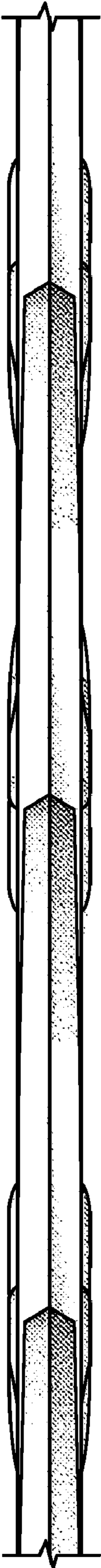

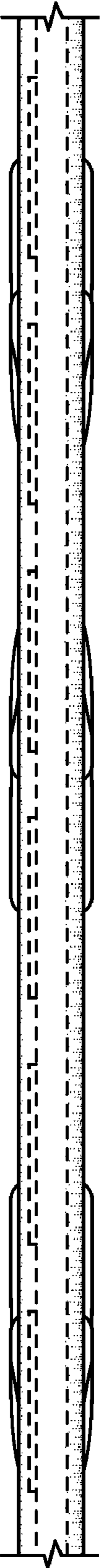

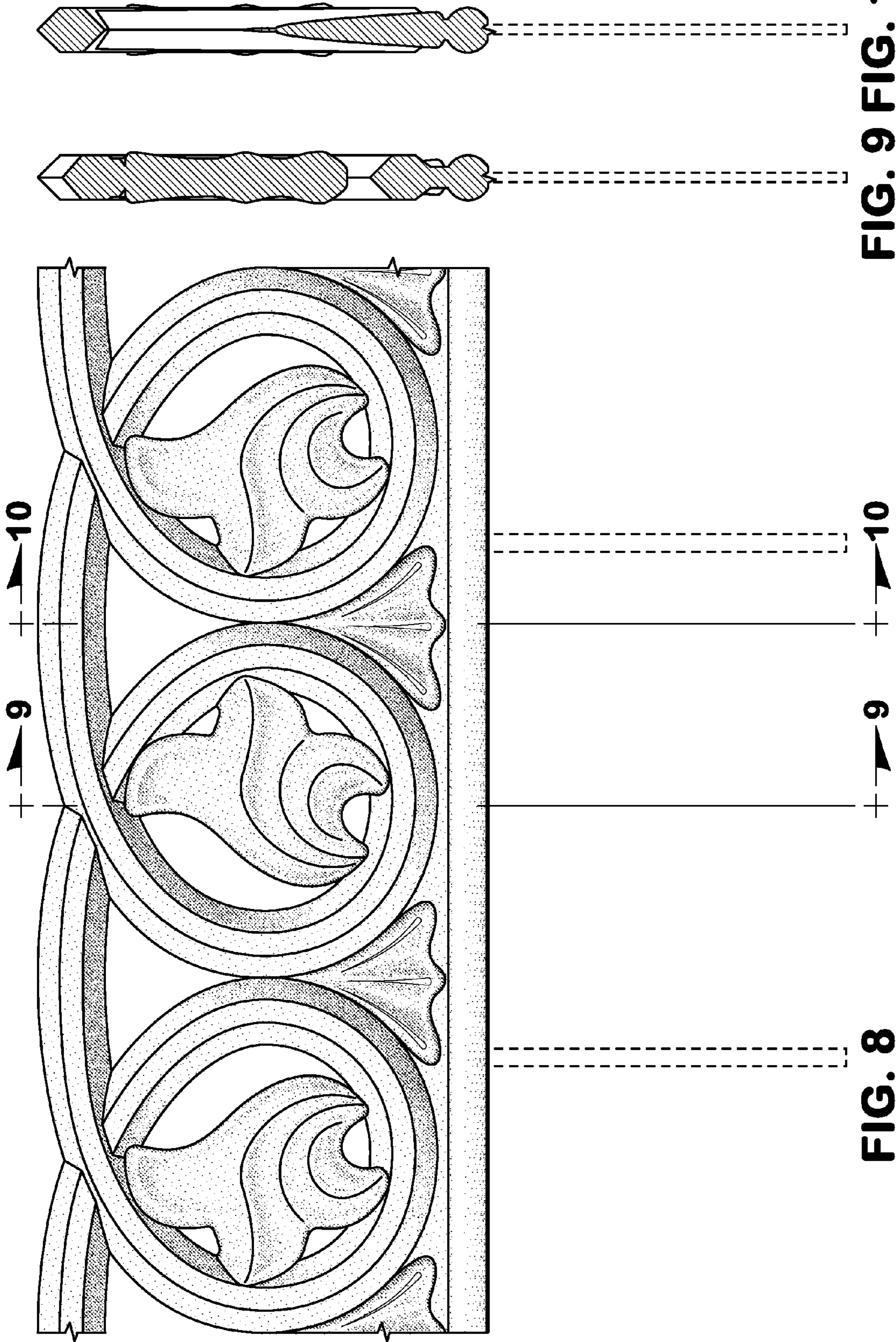

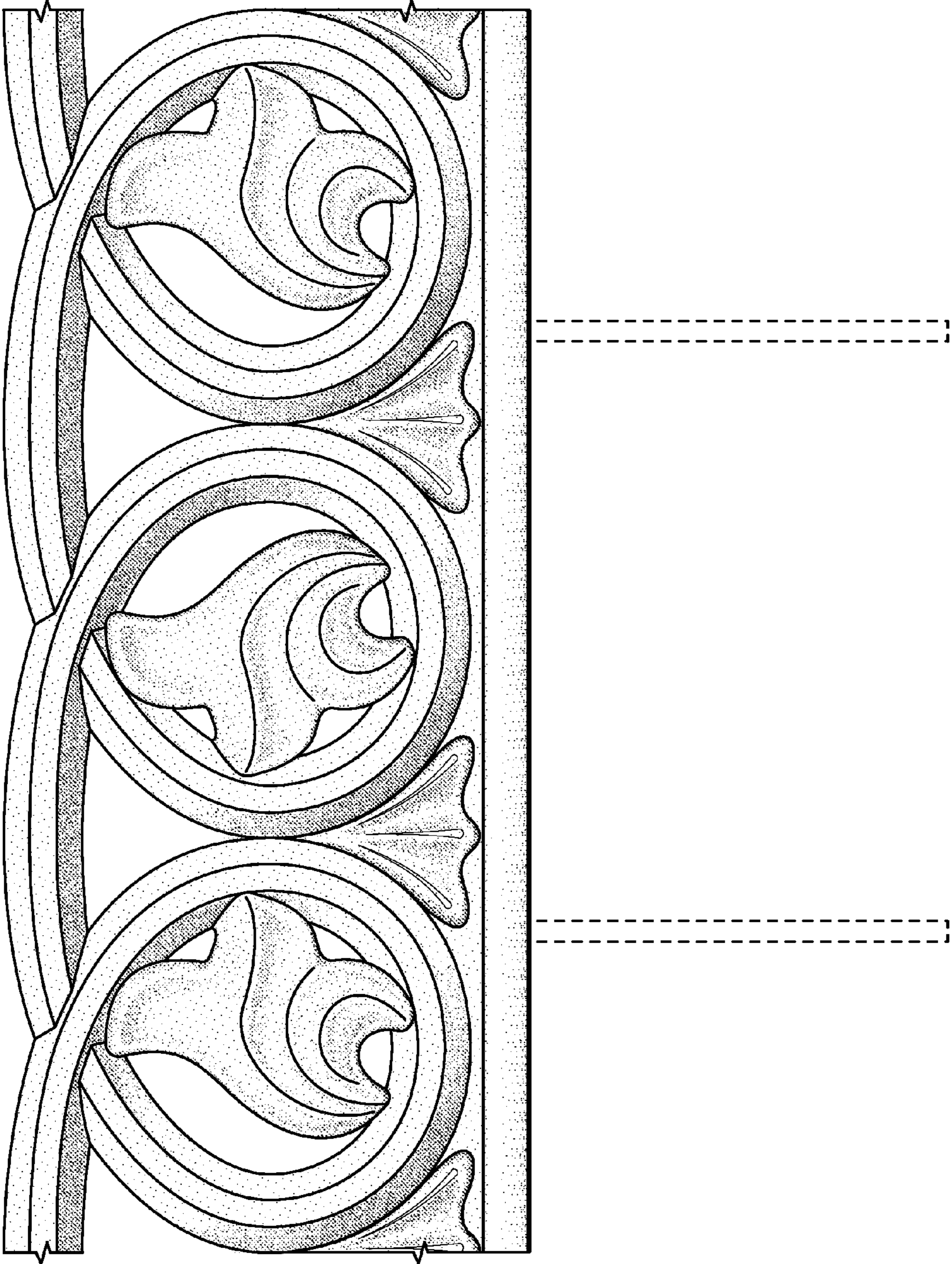

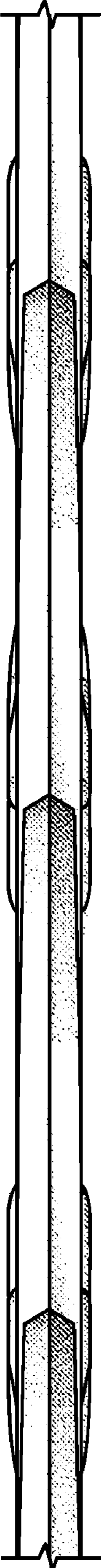
