(57) **CLAIM**

The ornamental design for a shaving razor cartridge, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an ornamental appearance of a shaving razor cartridge in accordance with the present invention;

FIG. 2 is a front elevational view of the shaving razor cartridge of FIG. 1;

FIG. 3 is a rear elevational view of the shaving razor cartridge of FIG. 1;

FIG. 4 is a side view of the shaving razor cartridge of FIG. 1;

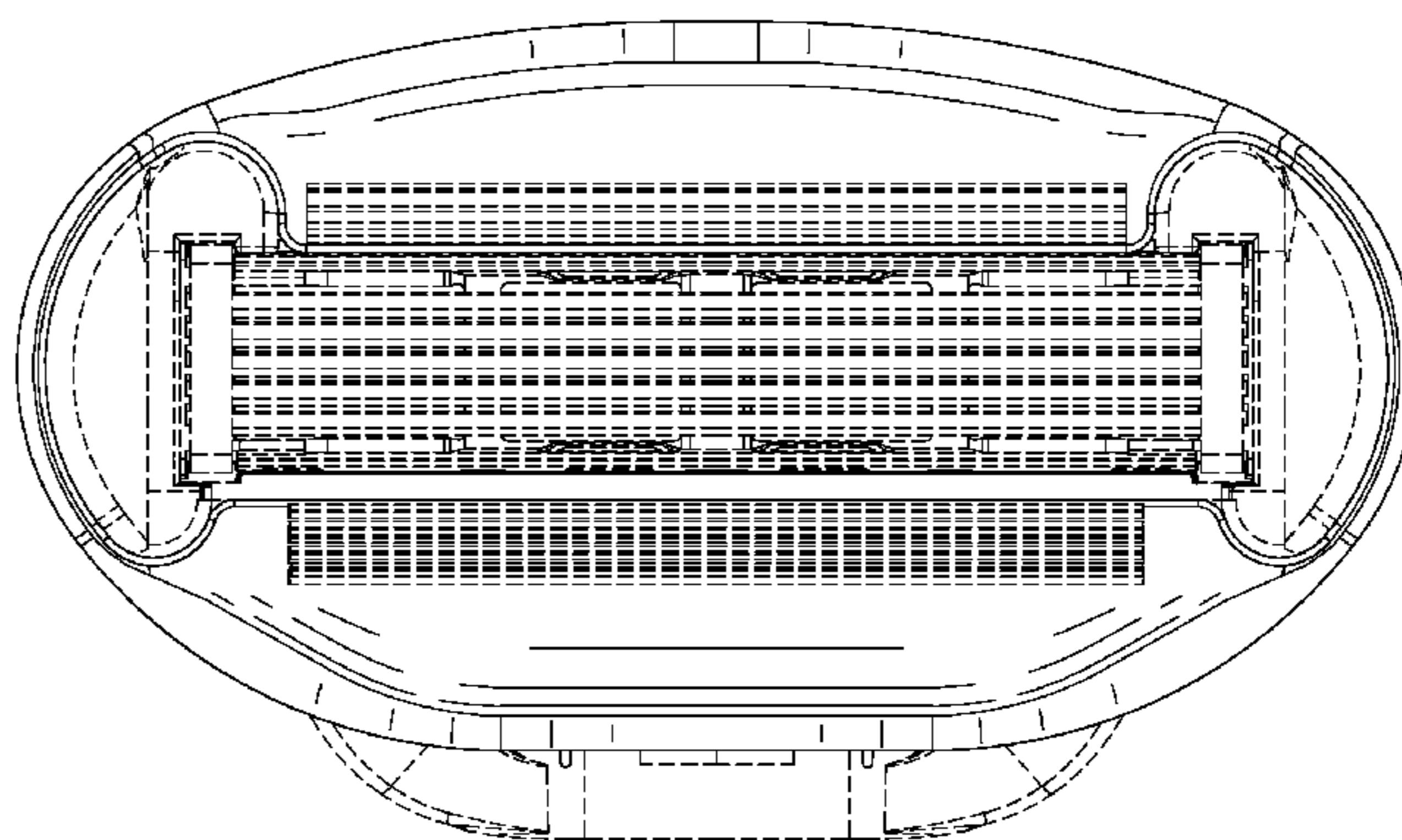
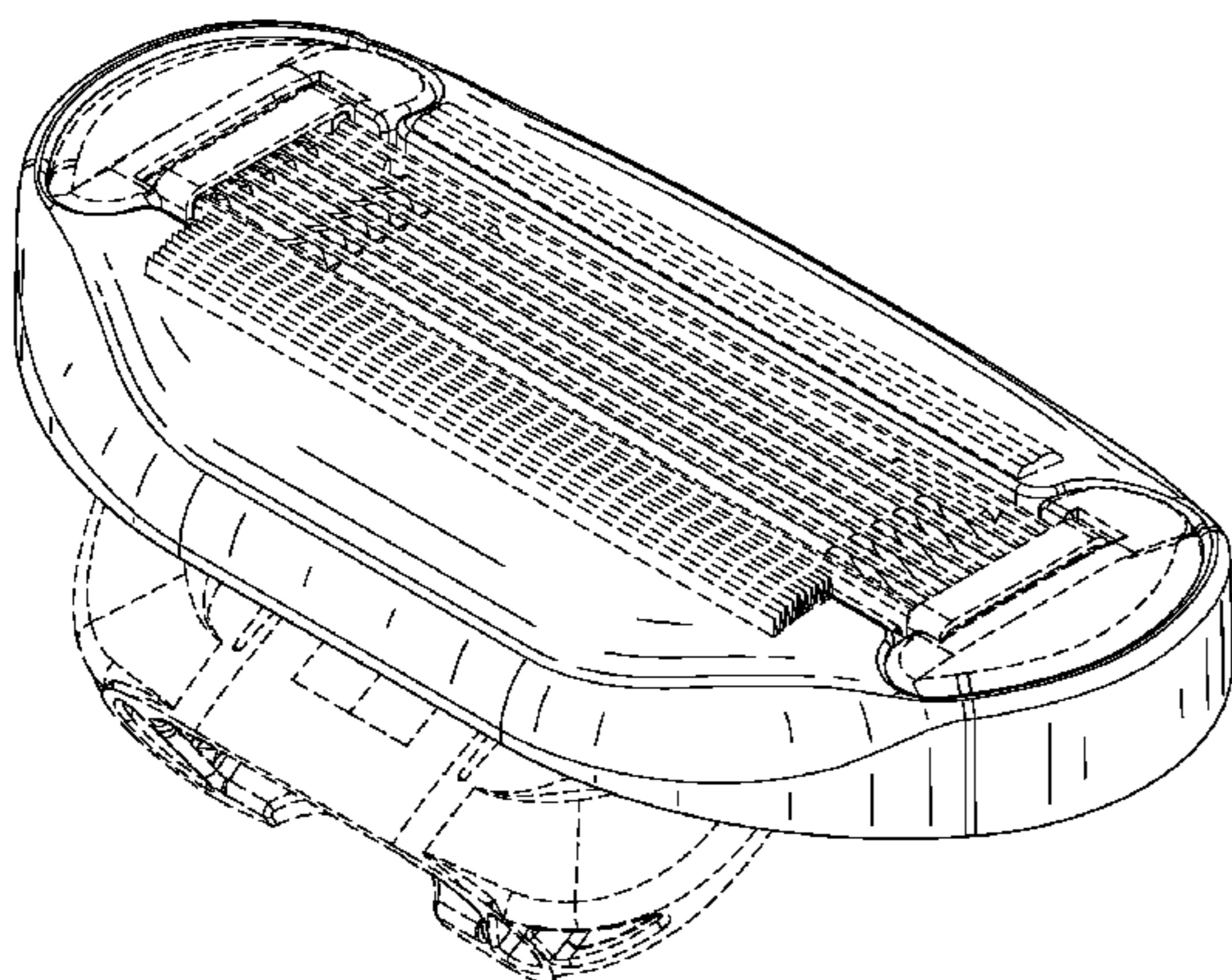
FIG. 5 is another side view of the shaving razor cartridge of FIG. 1, opposite the side view shown in FIG. 4;

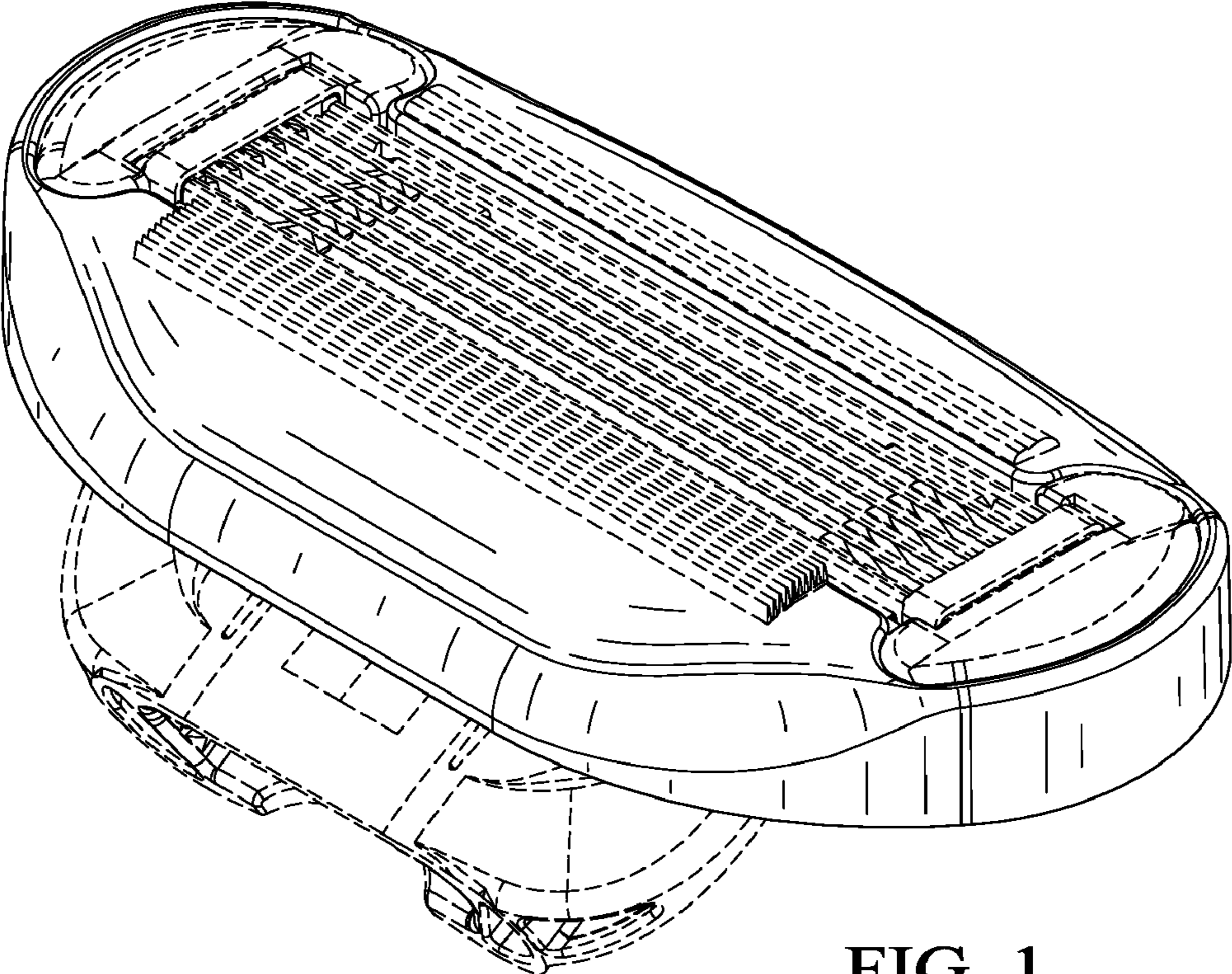

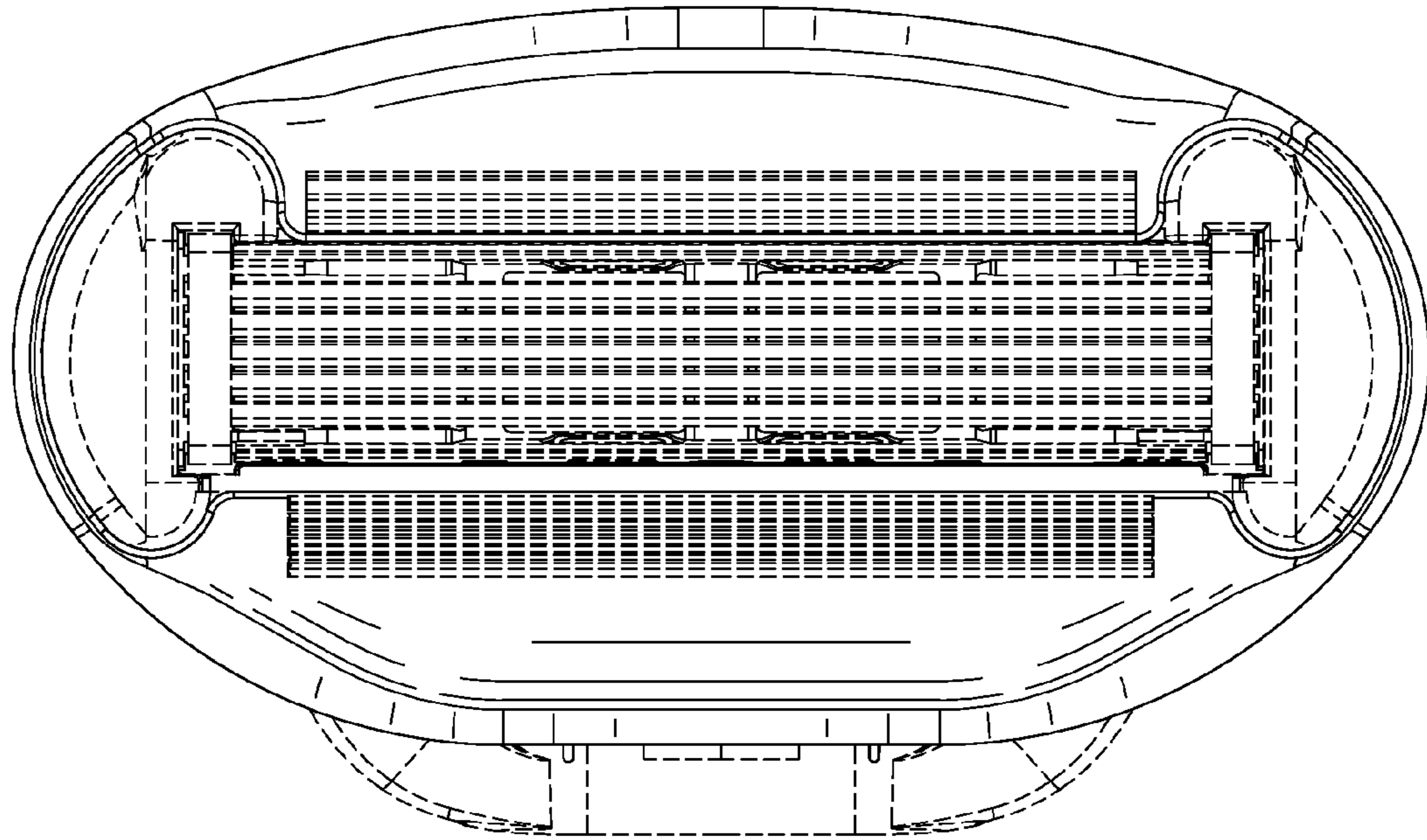

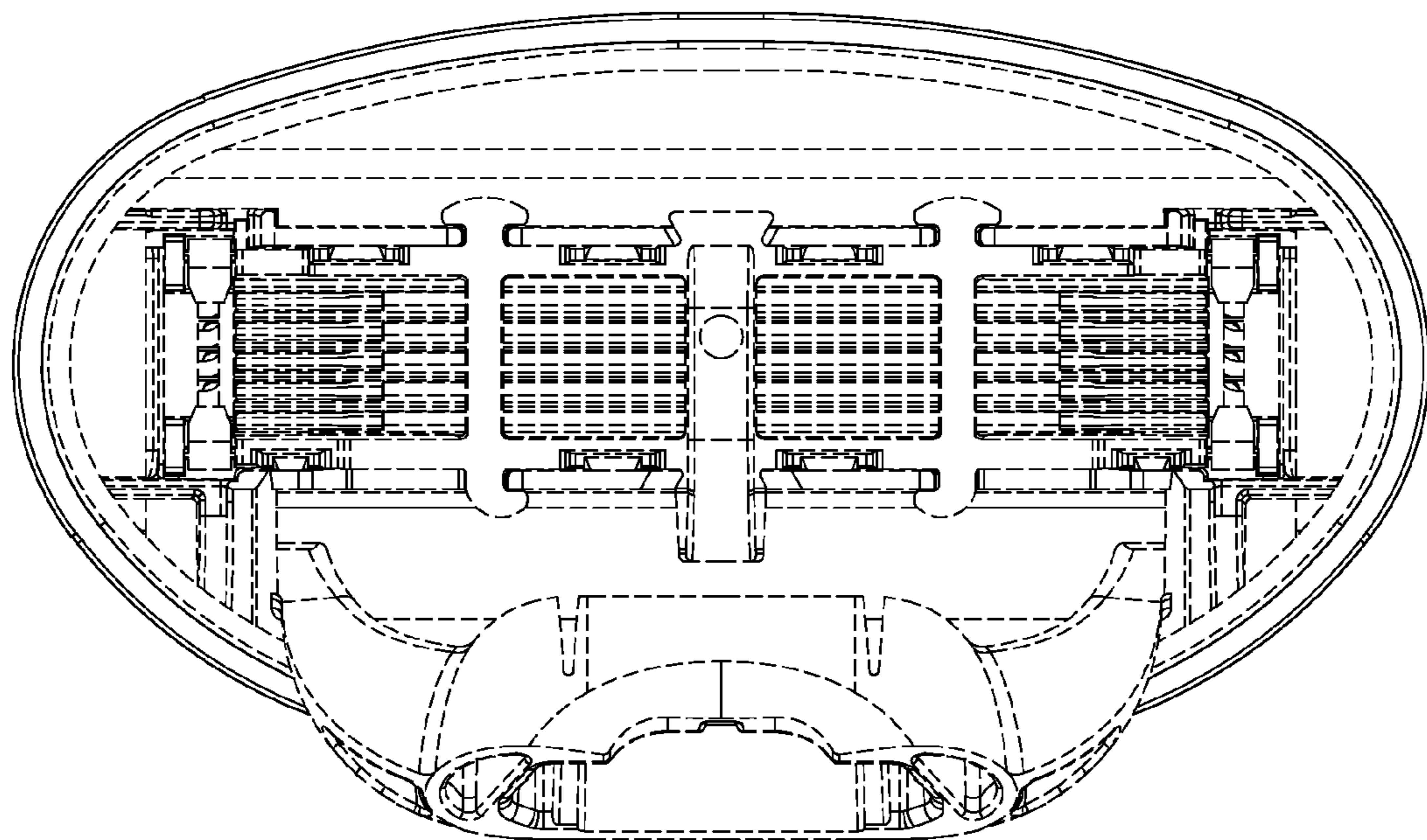

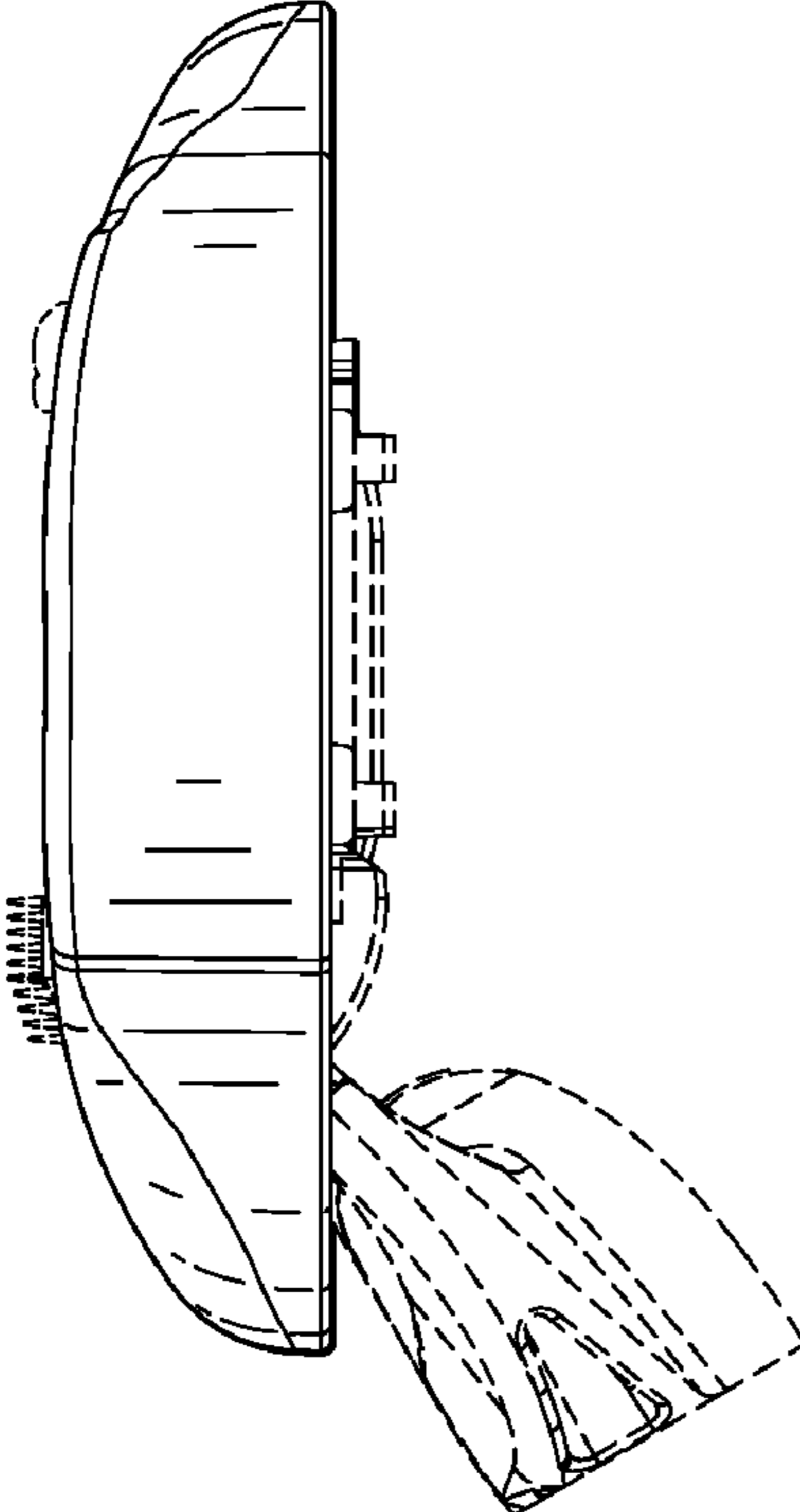
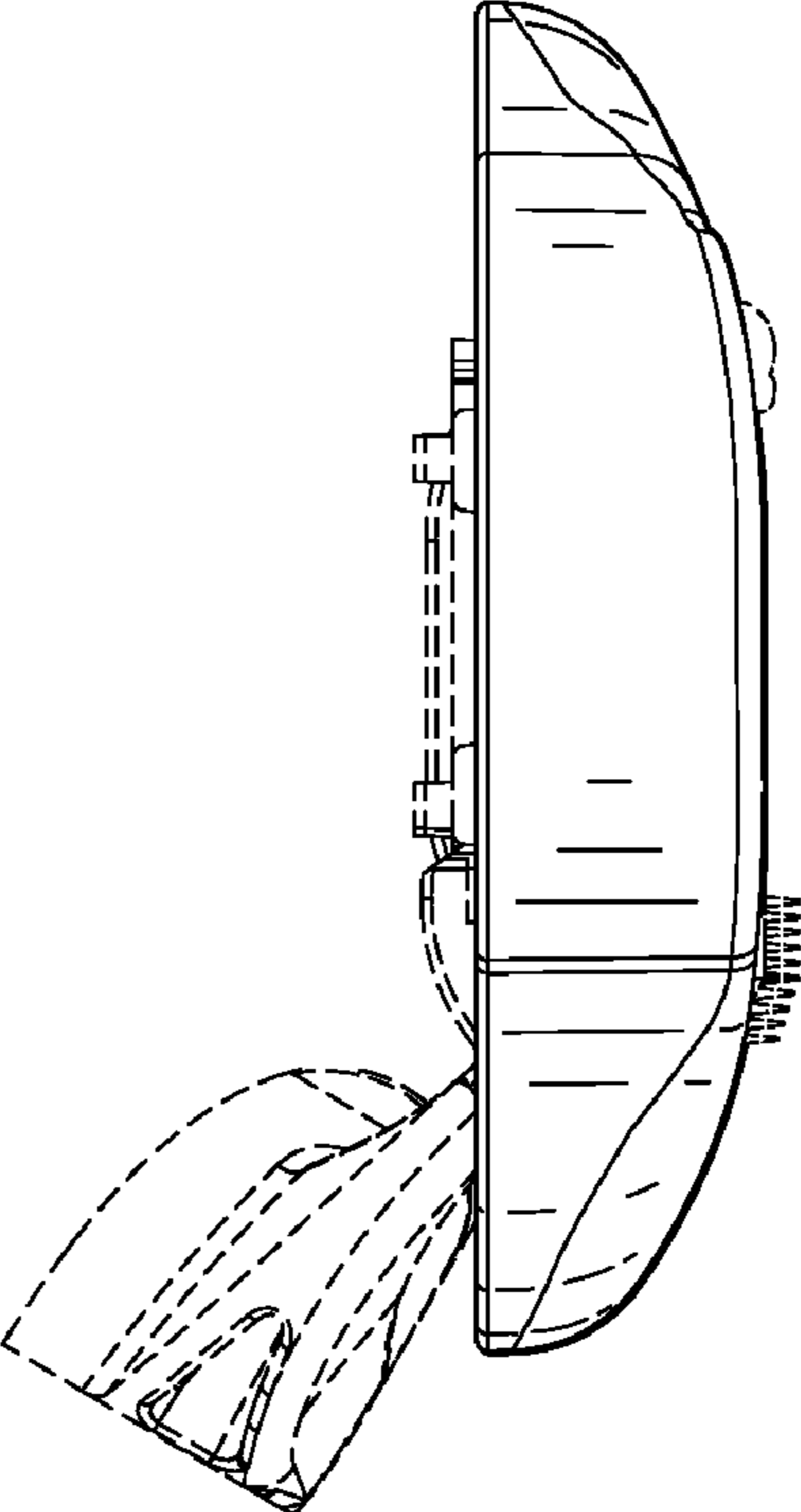

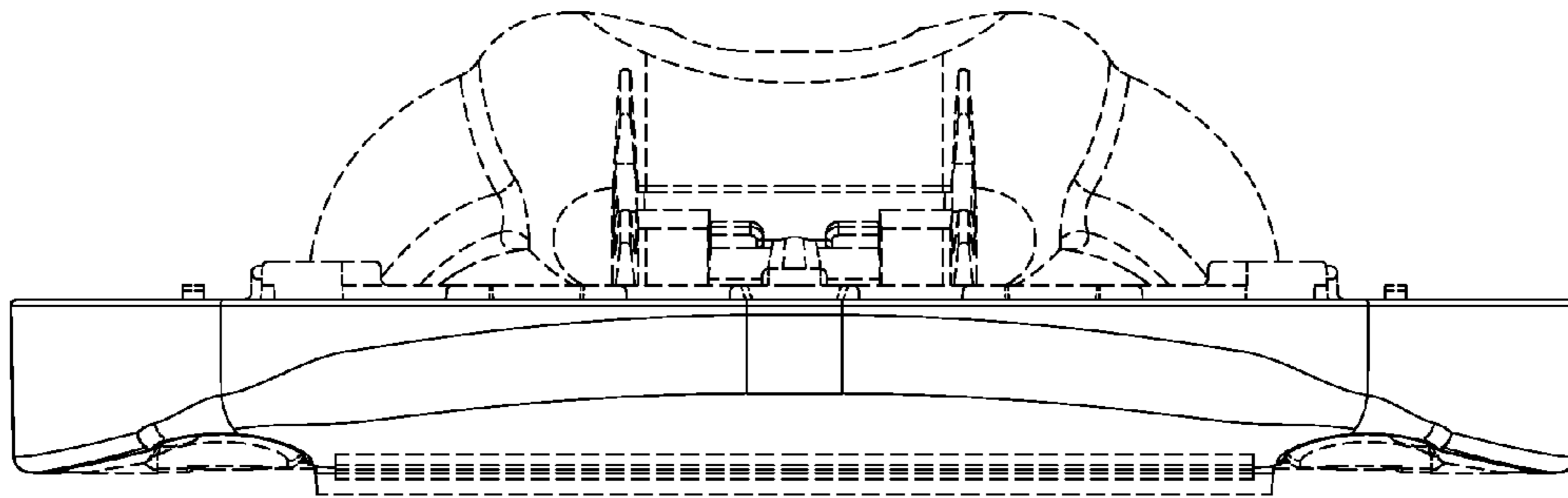

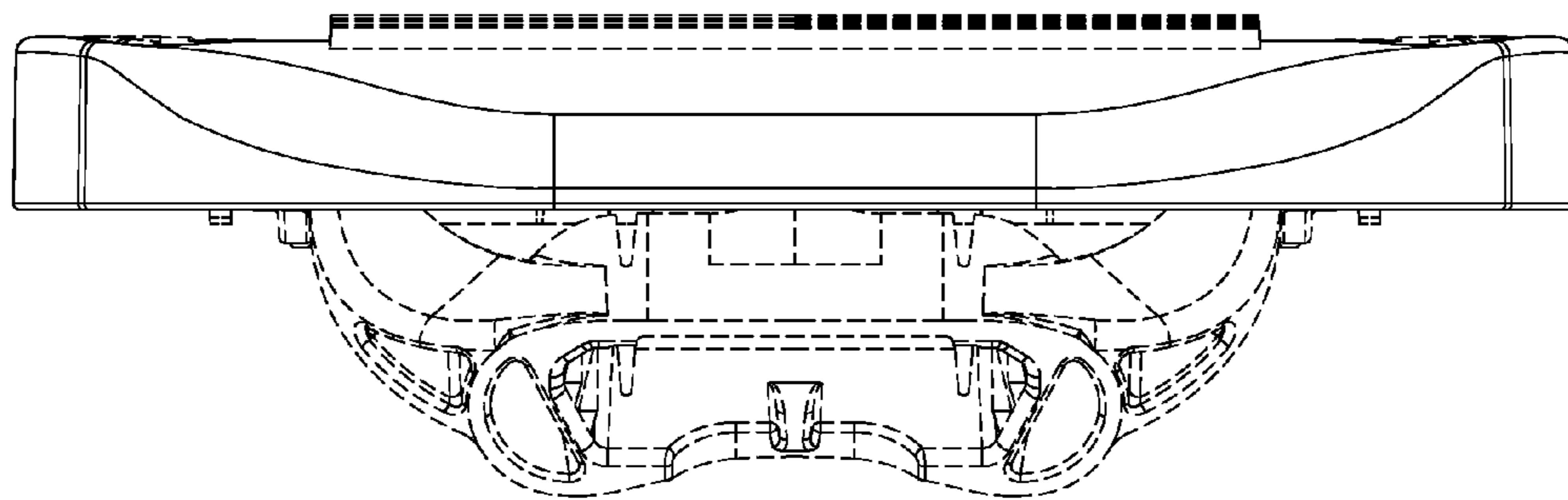
