The ornamental design for an over the collar bandana with pocket, as shown and described.

DESCRIPTION

FIG. 1 is a top view of an over the collar bandana with pocket showing my new design;

FIG. 2 is a bottom view thereof;

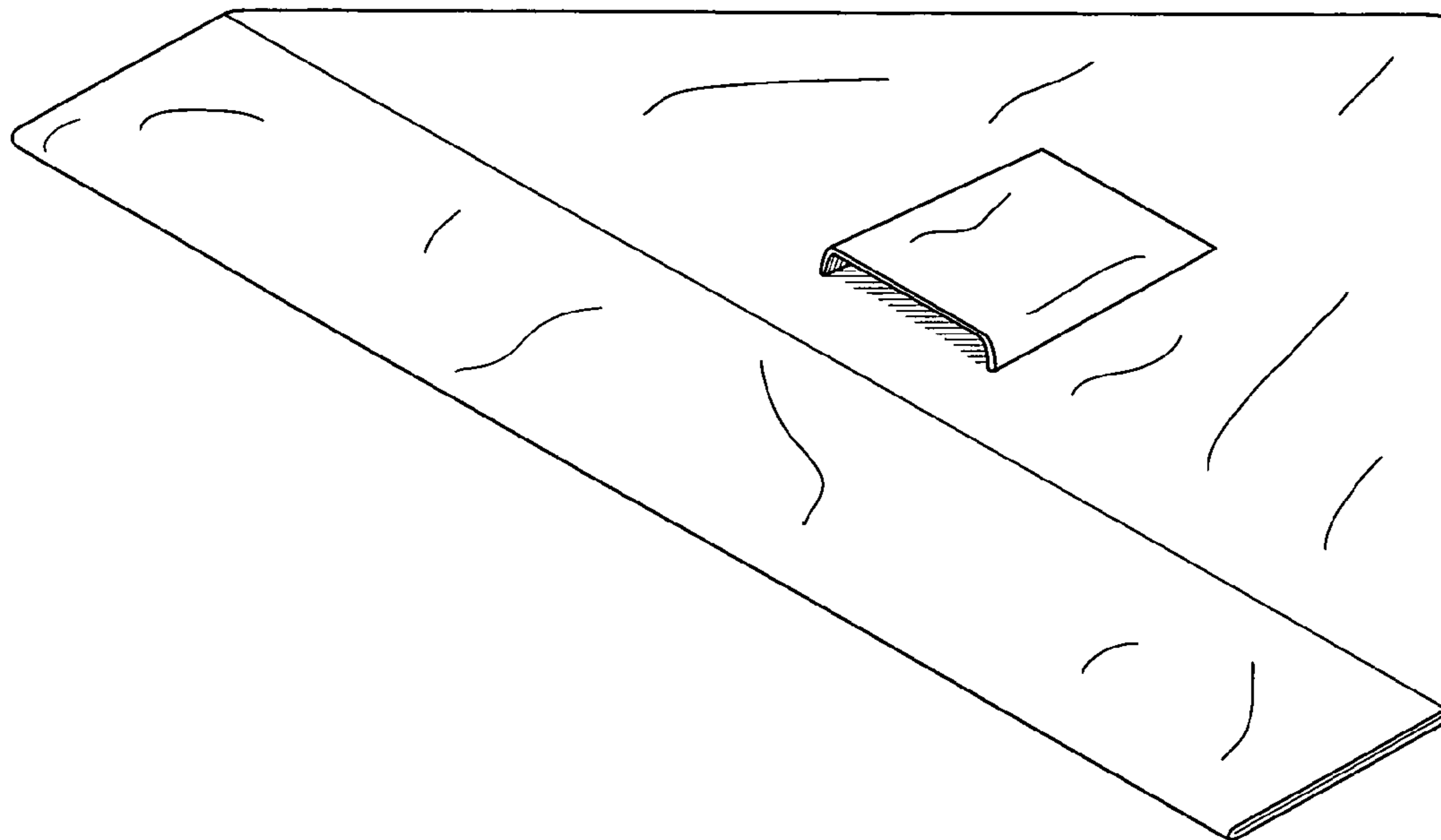
FIG. 3 is a right side view thereof, where as the left side is a mirror image;

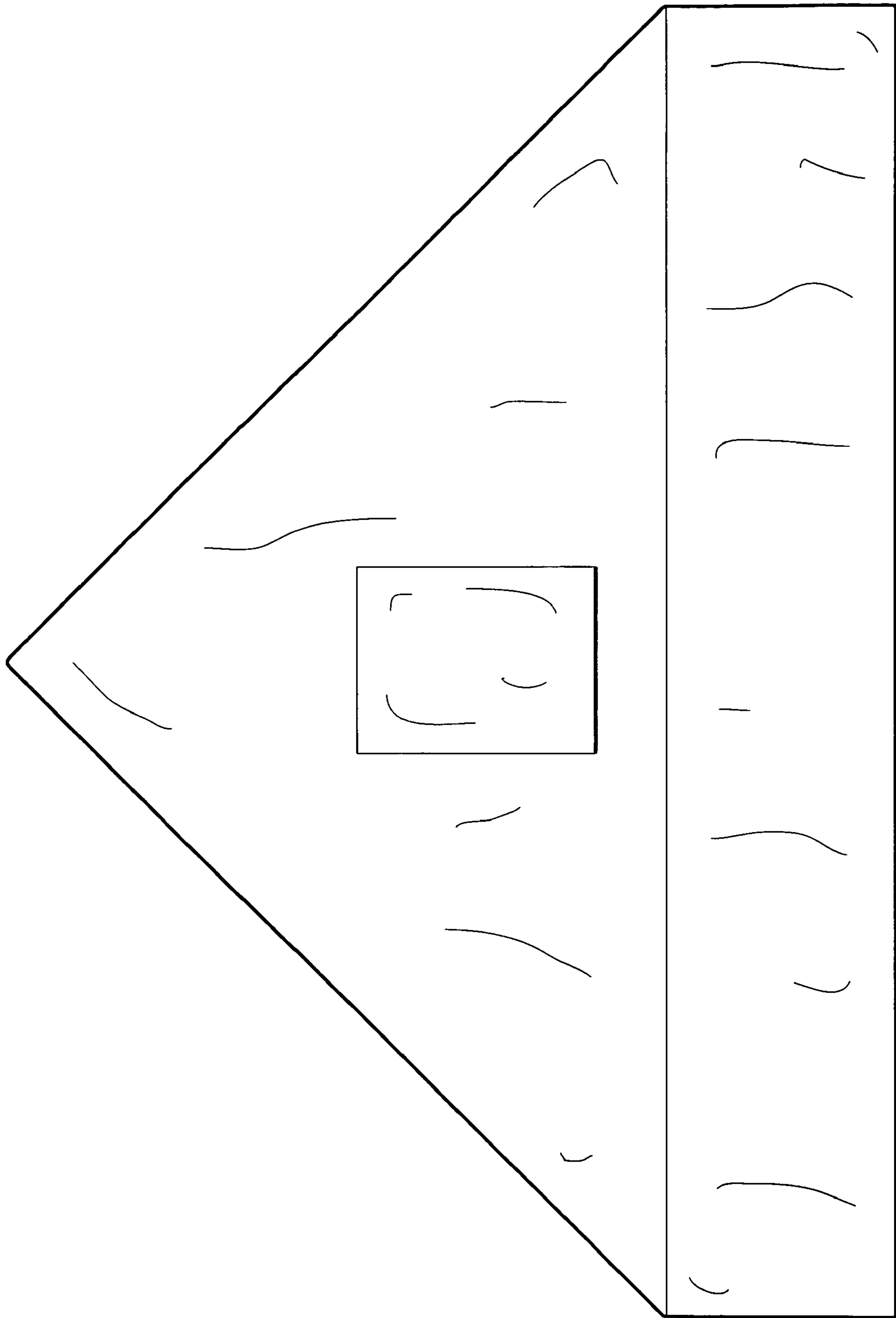

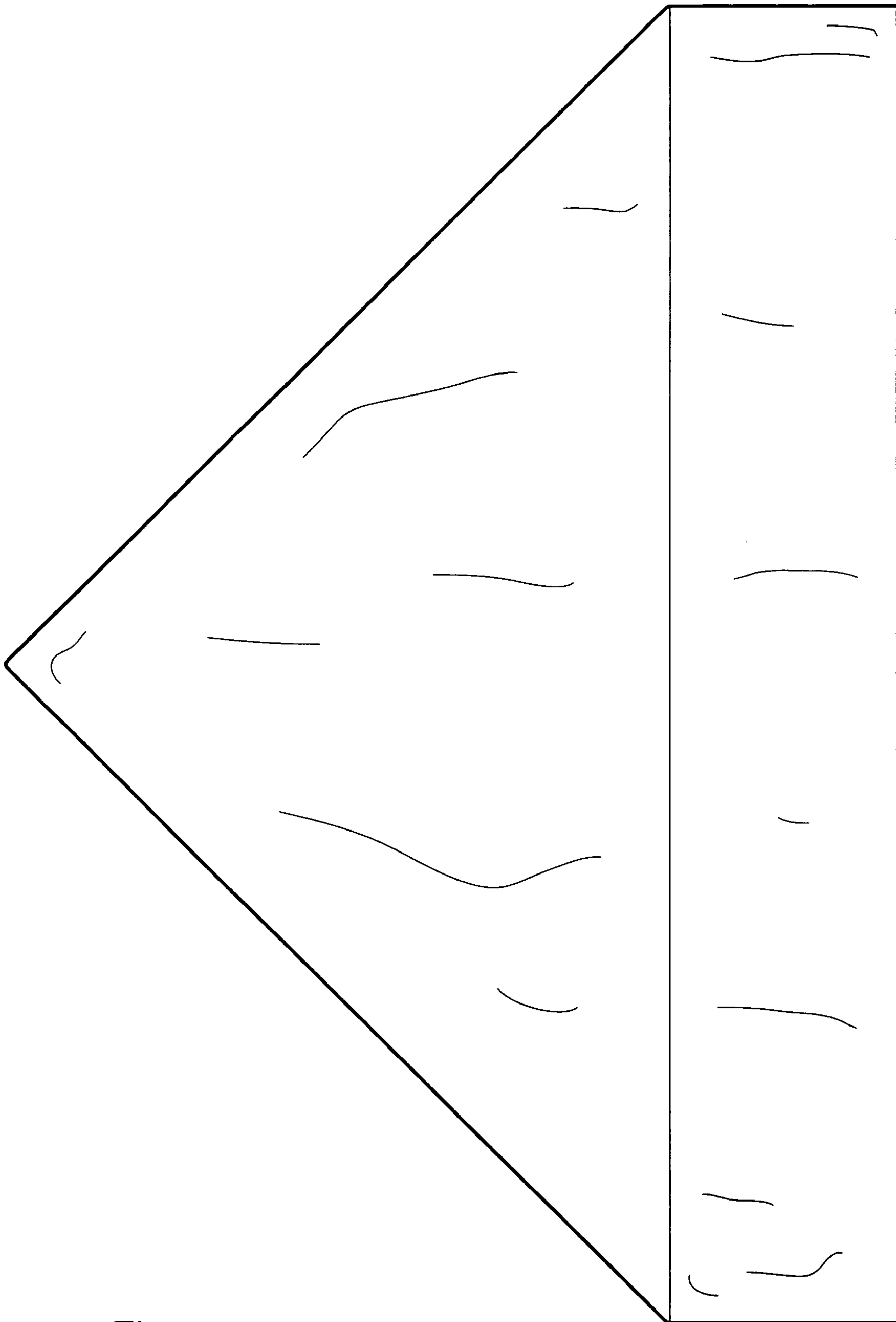

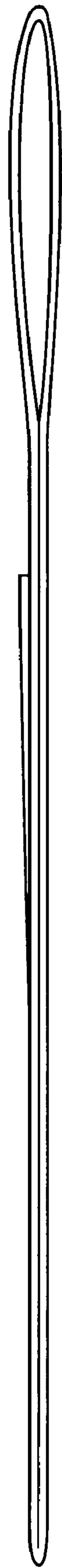

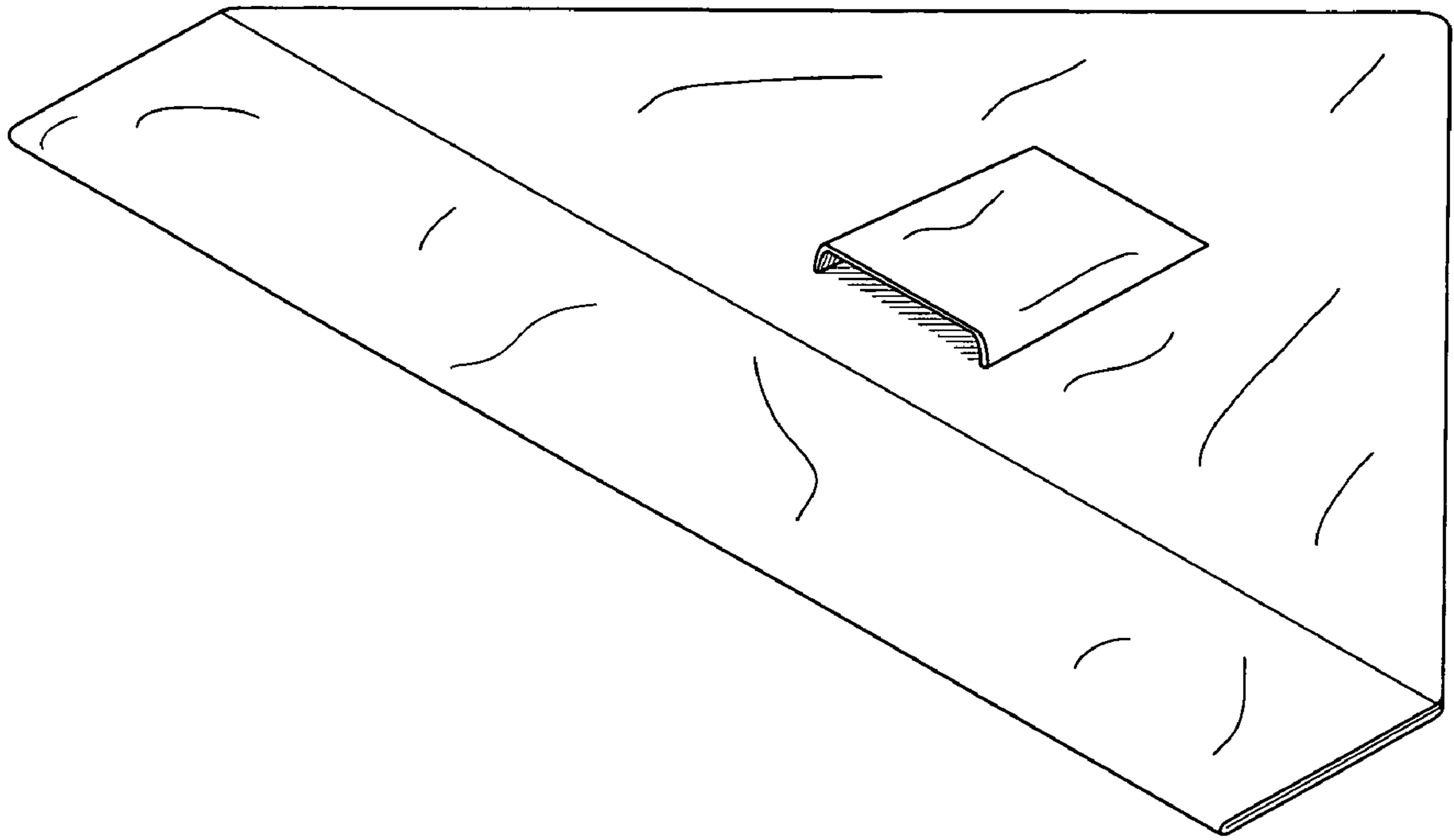

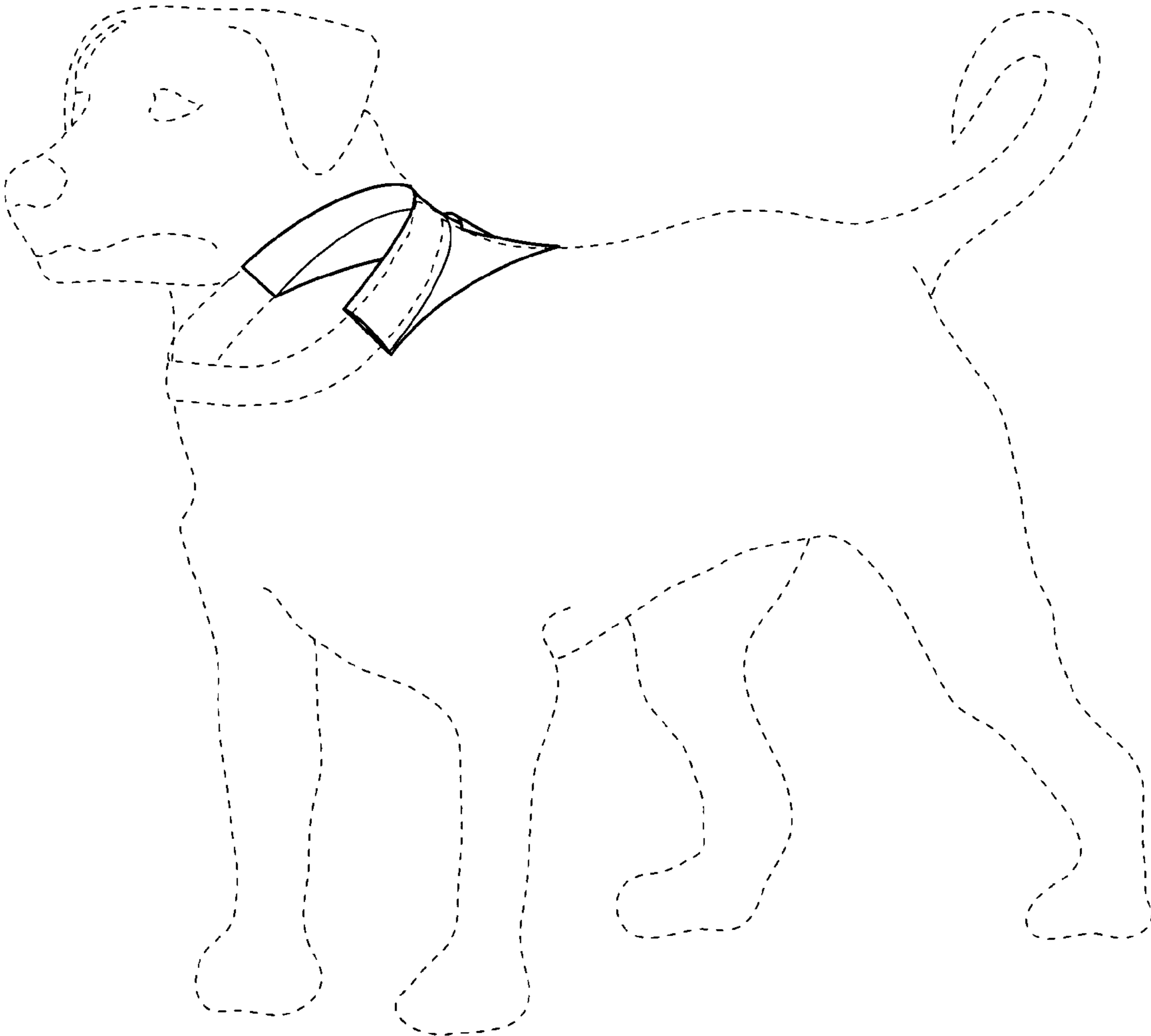
