(57) **CLAIM**

I claim the ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe sole showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right side elevational view thereof;

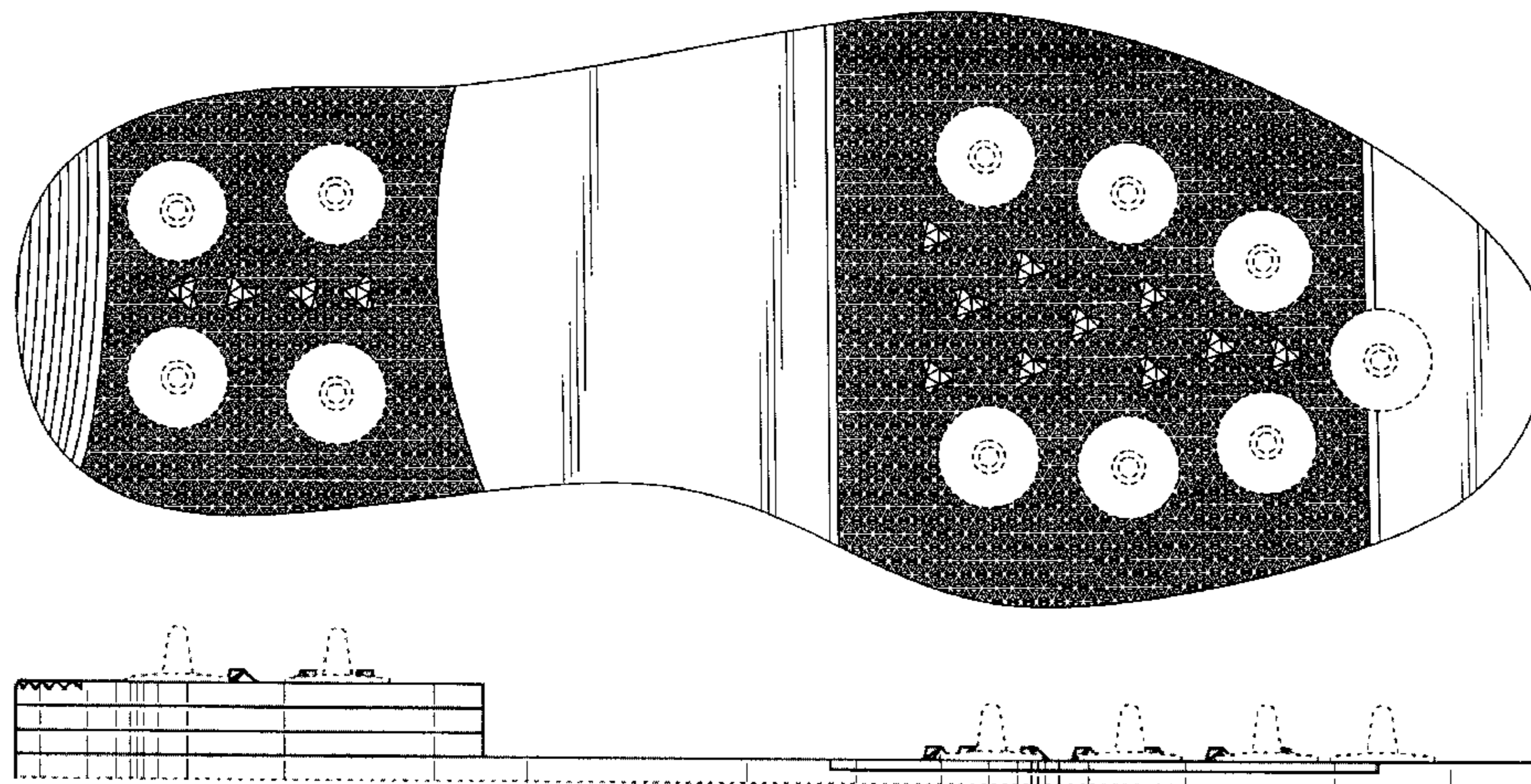
FIG. 7 is a left side elevational view thereof;

FIG. 8 is an enlarged partial front view of a larger middle projection and a smaller projection on the shoe sole; and,

FIG. 9 is an enlarged partial perspective view thereof.

Any portions shown by the broken lines in FIGS. 1-7 do not form a part of the design sought to be protected. The broken line perimeters in the FIGS. 8 and 9 views indicate the borders of the partial views, and also form no part of the claimed design.

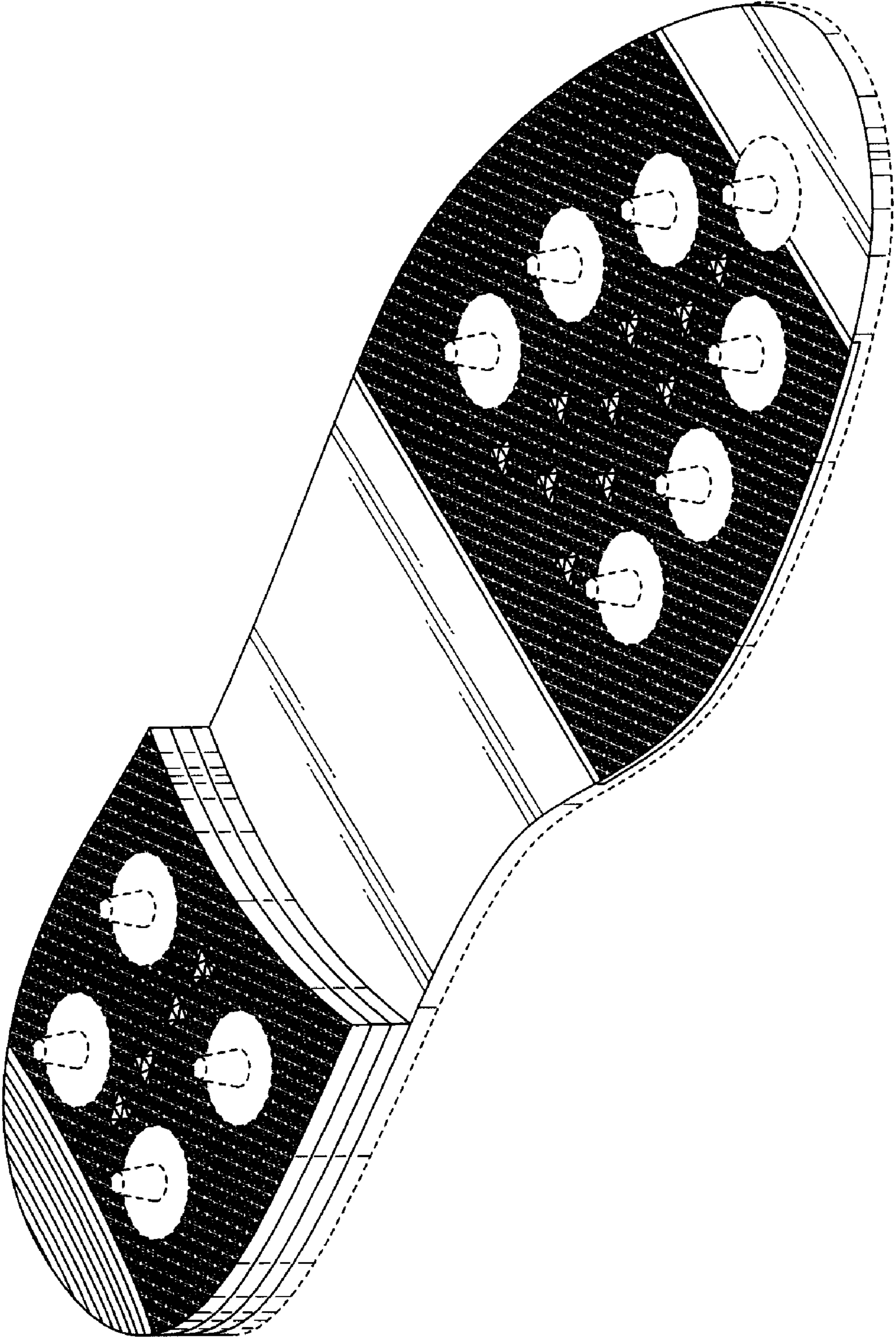

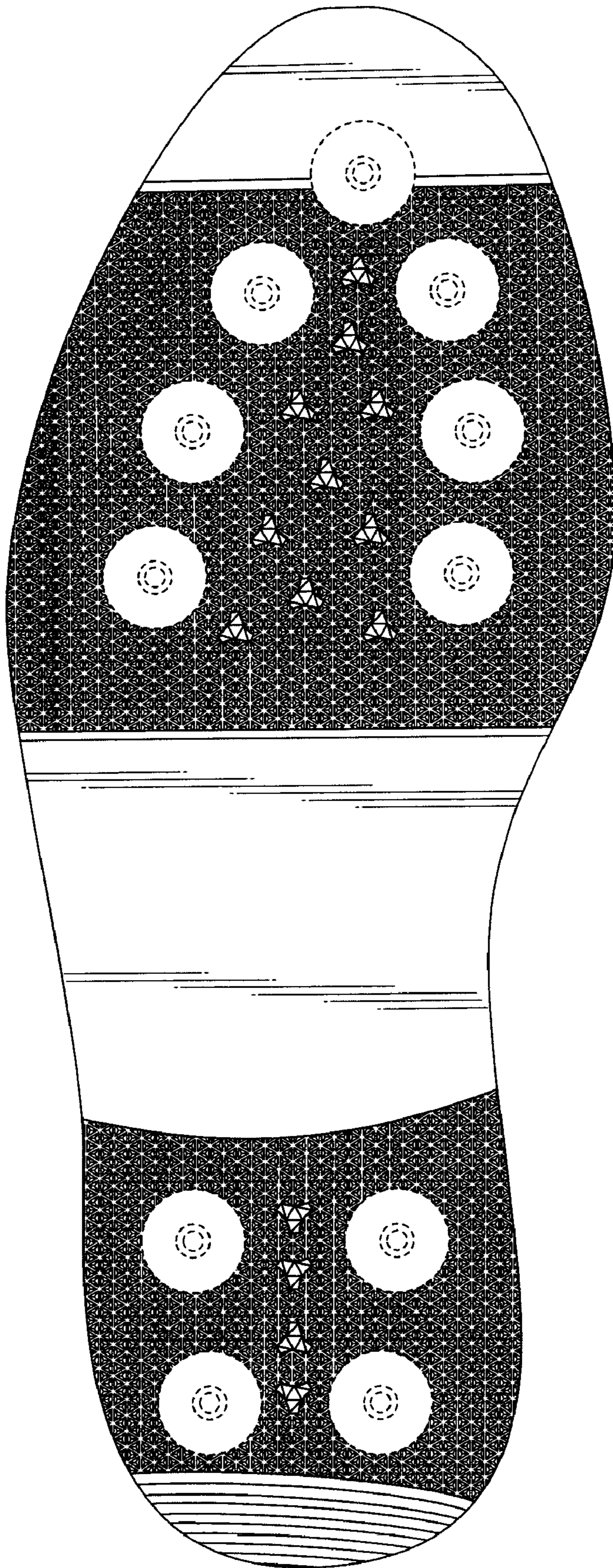

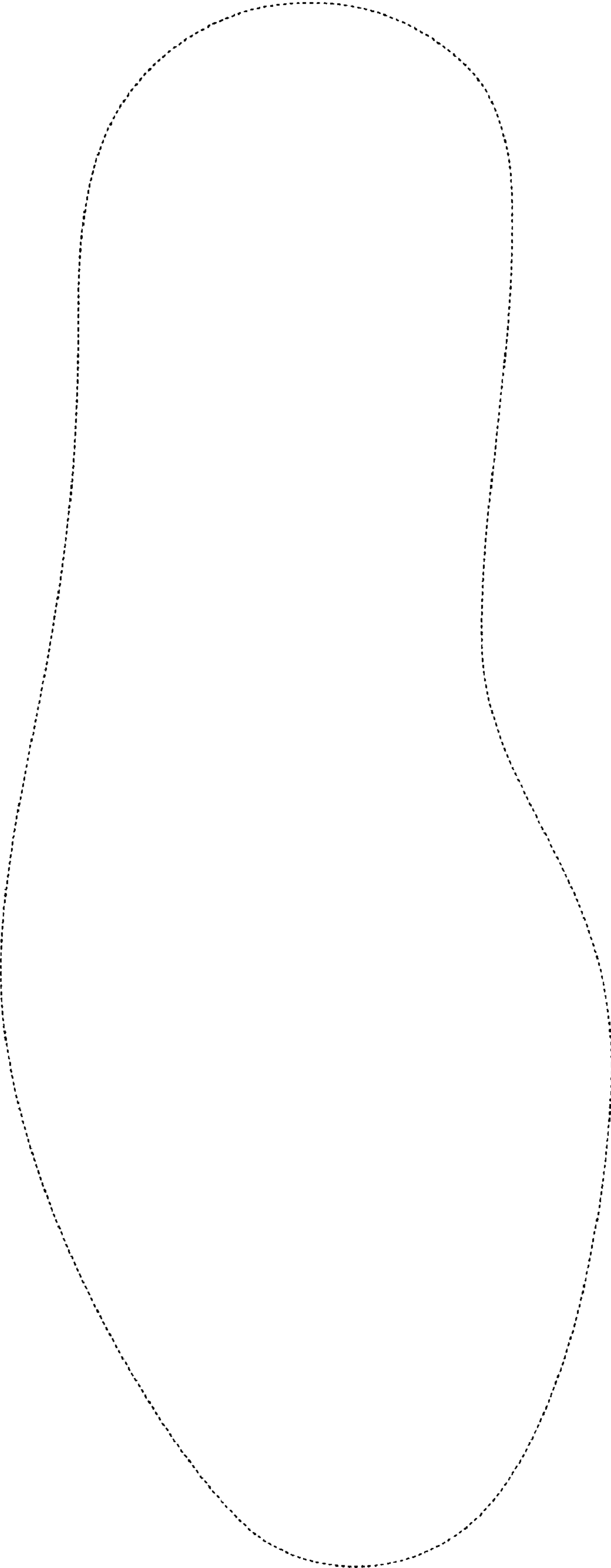

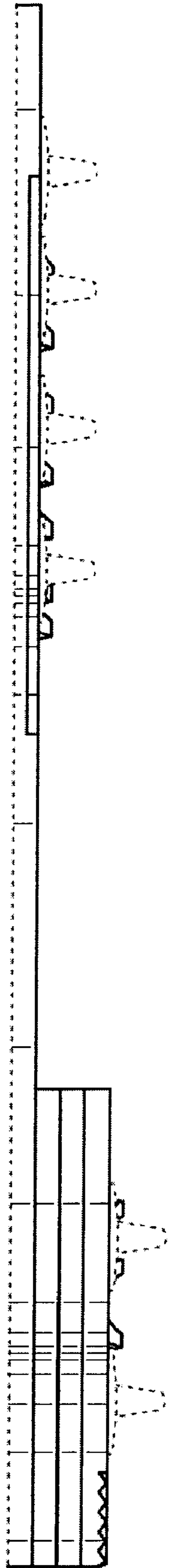

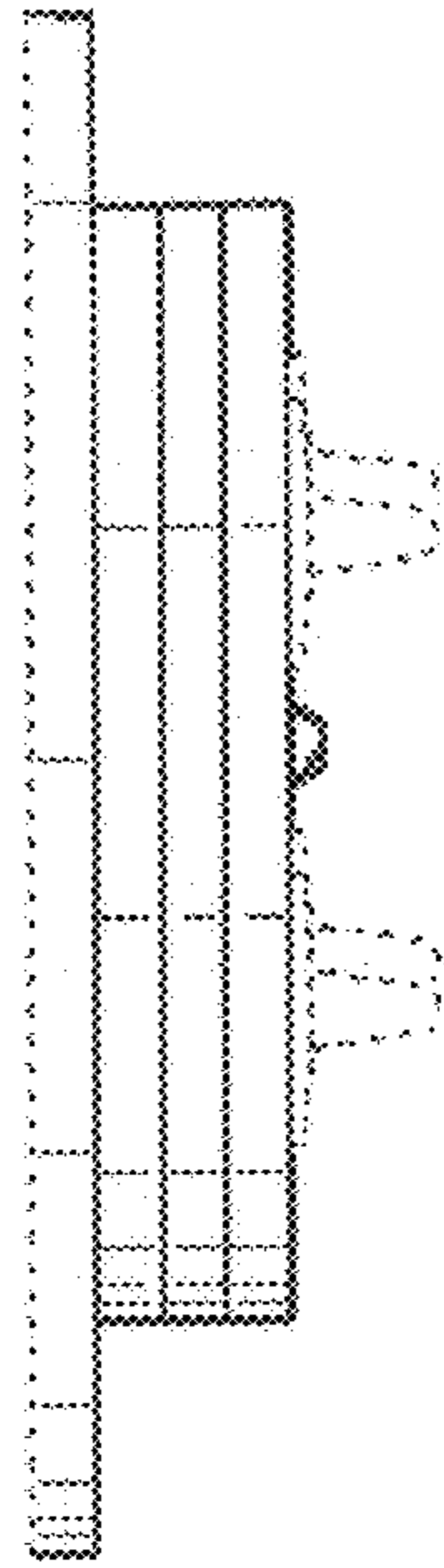

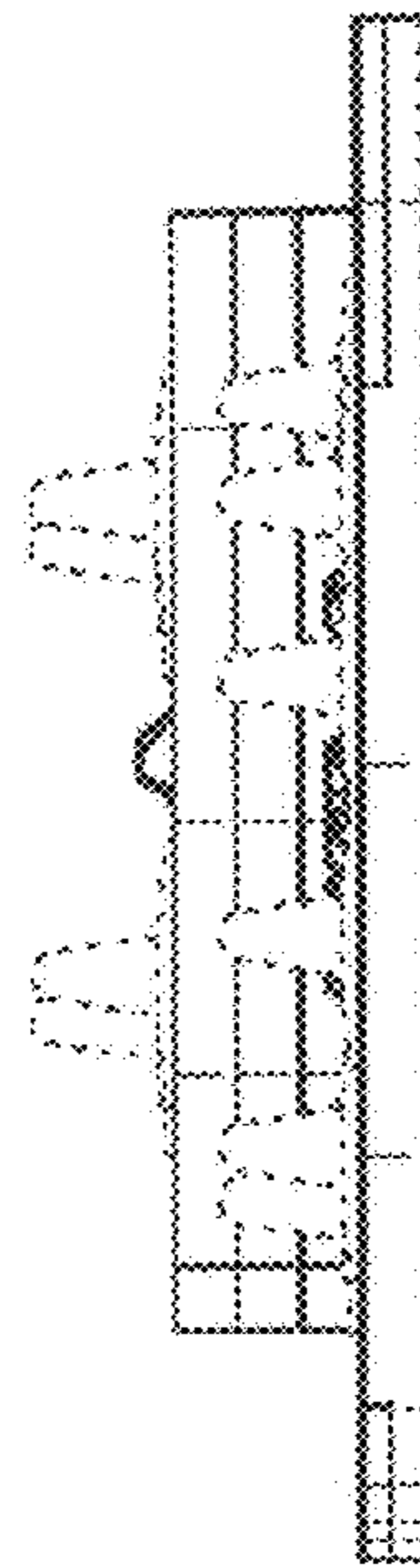

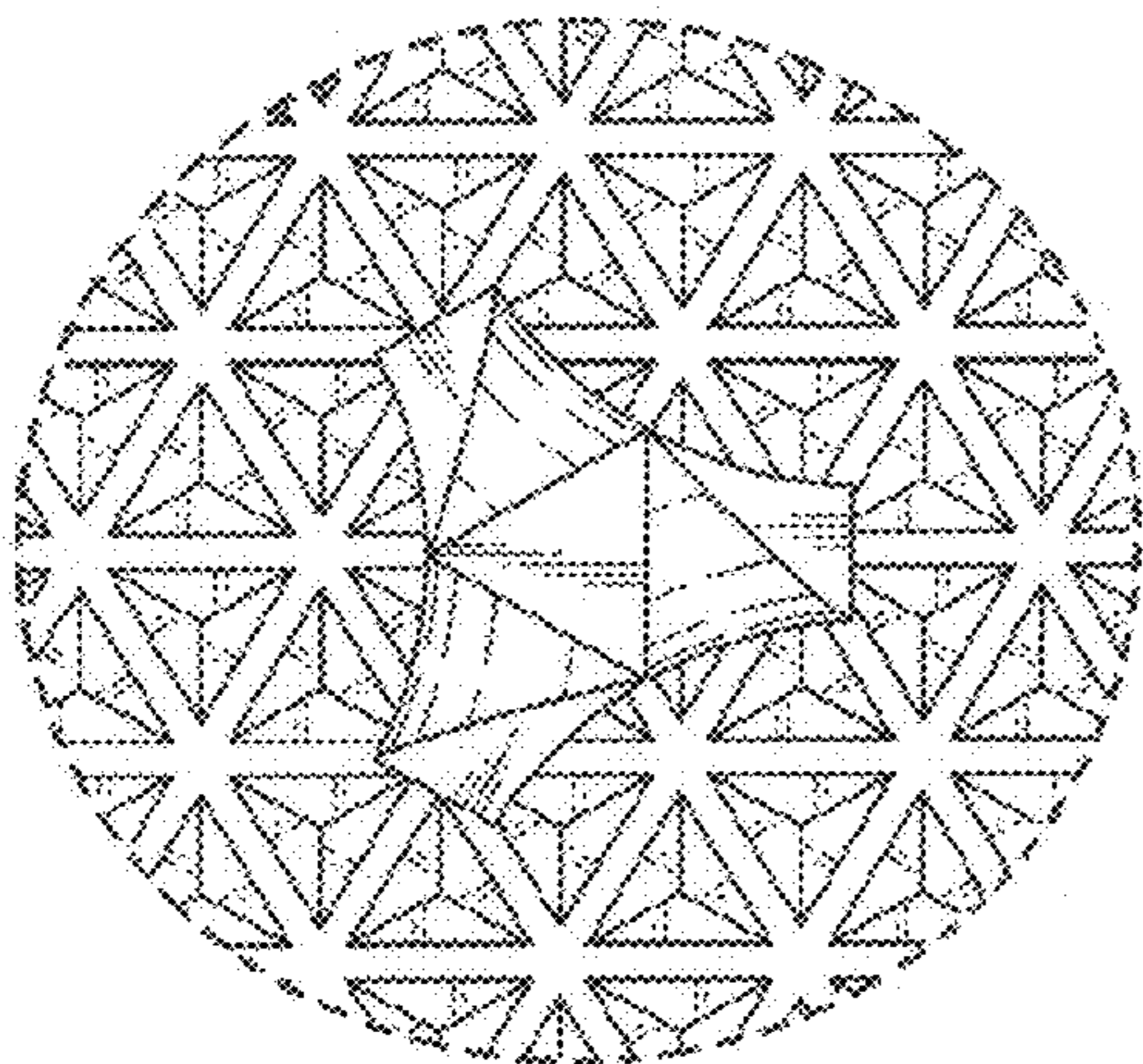
