(57) **CLAIM**

I claim the ornamental design for a combined cell phone case and pill carrier, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of the combined cell phone case and pill carrier showing my new design;

FIG. 6 is a bottom plan view thereof;

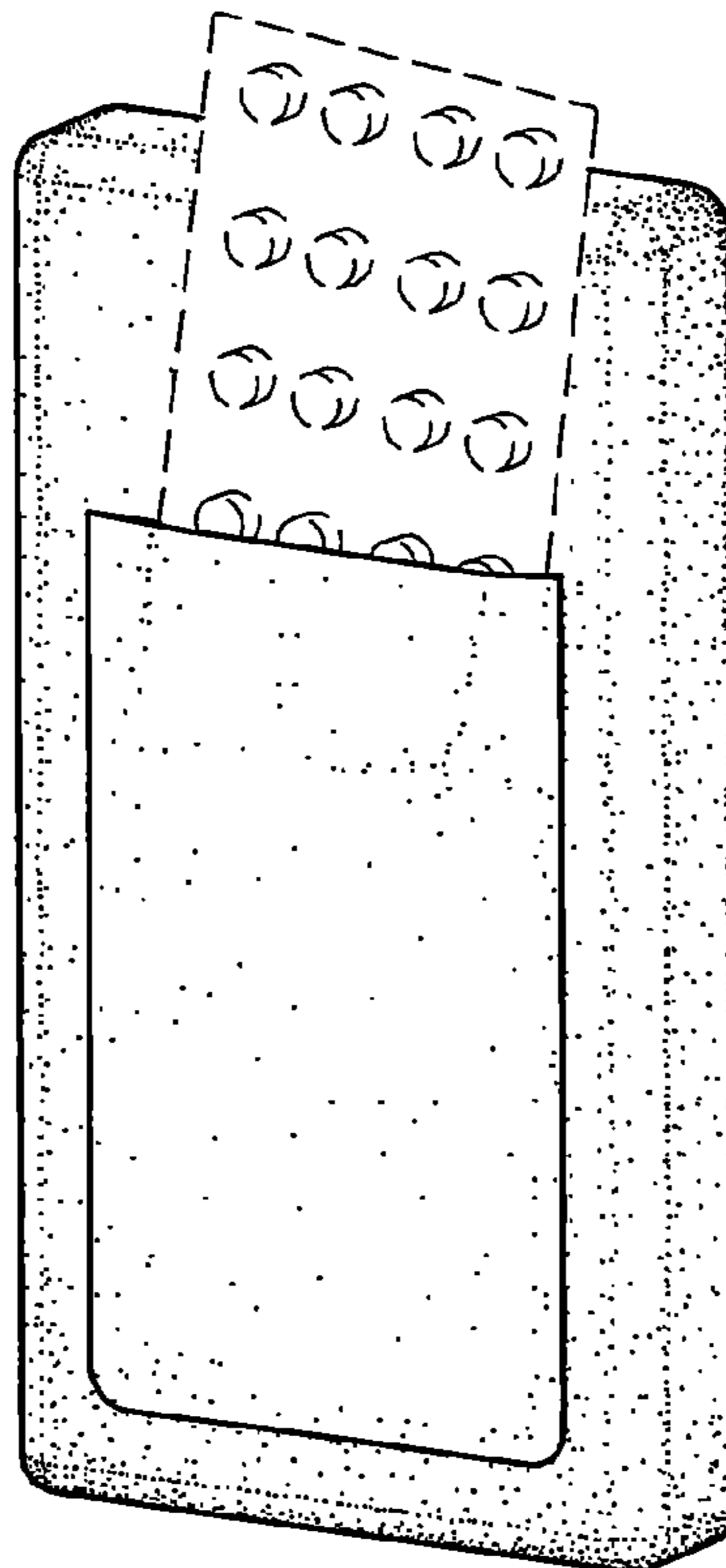
FIG. 7 is a side elevation view thereof;

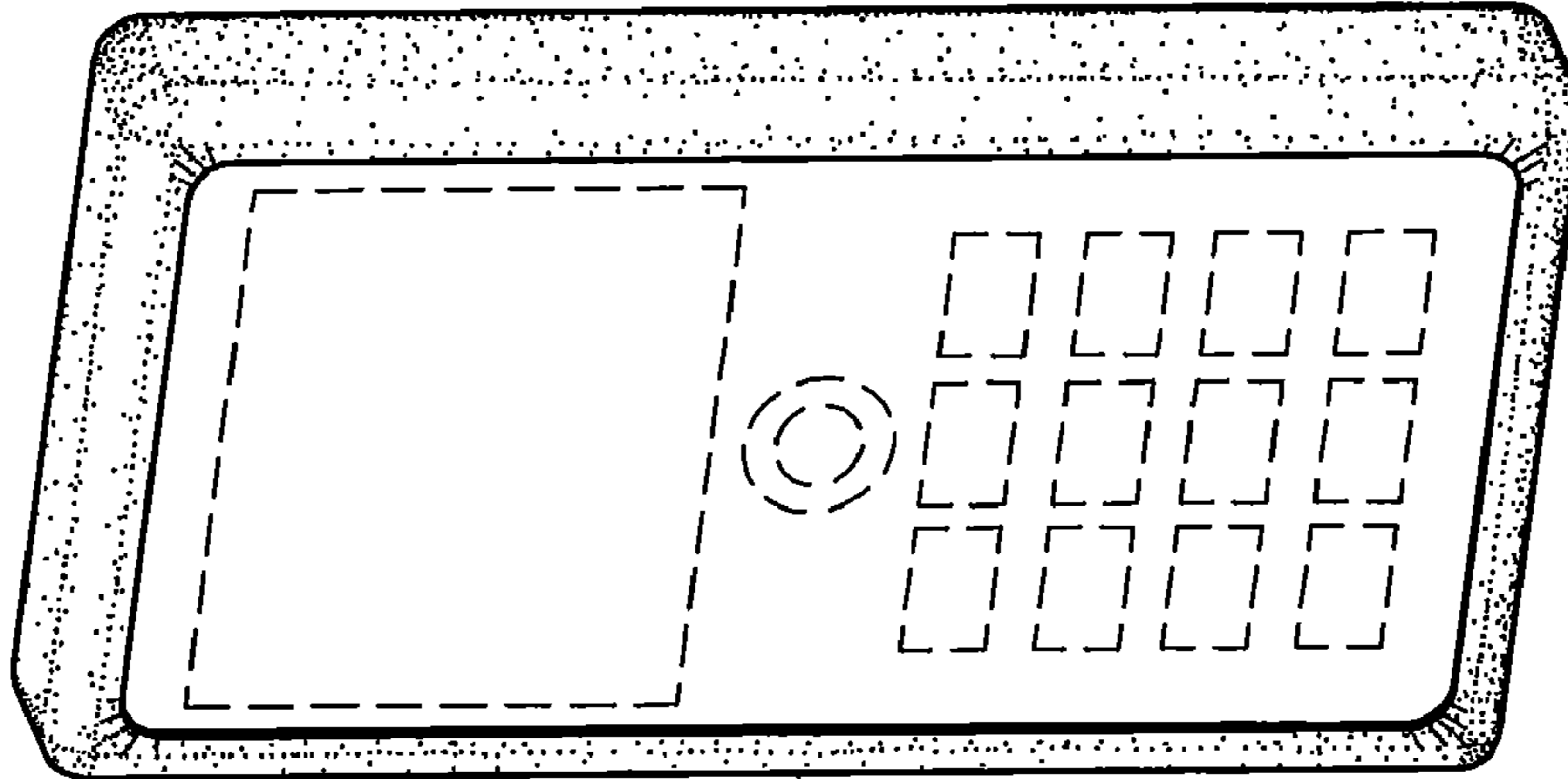

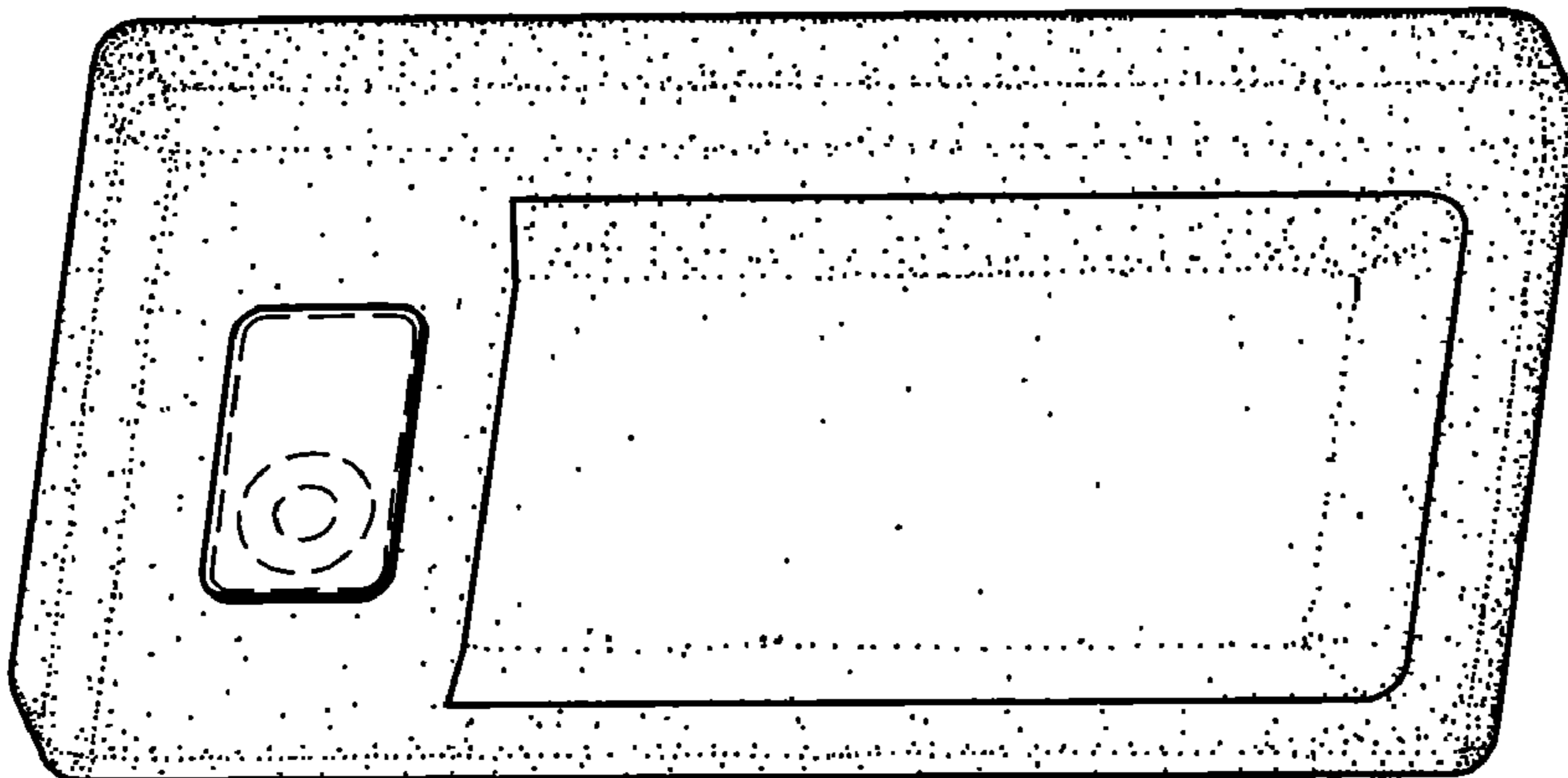

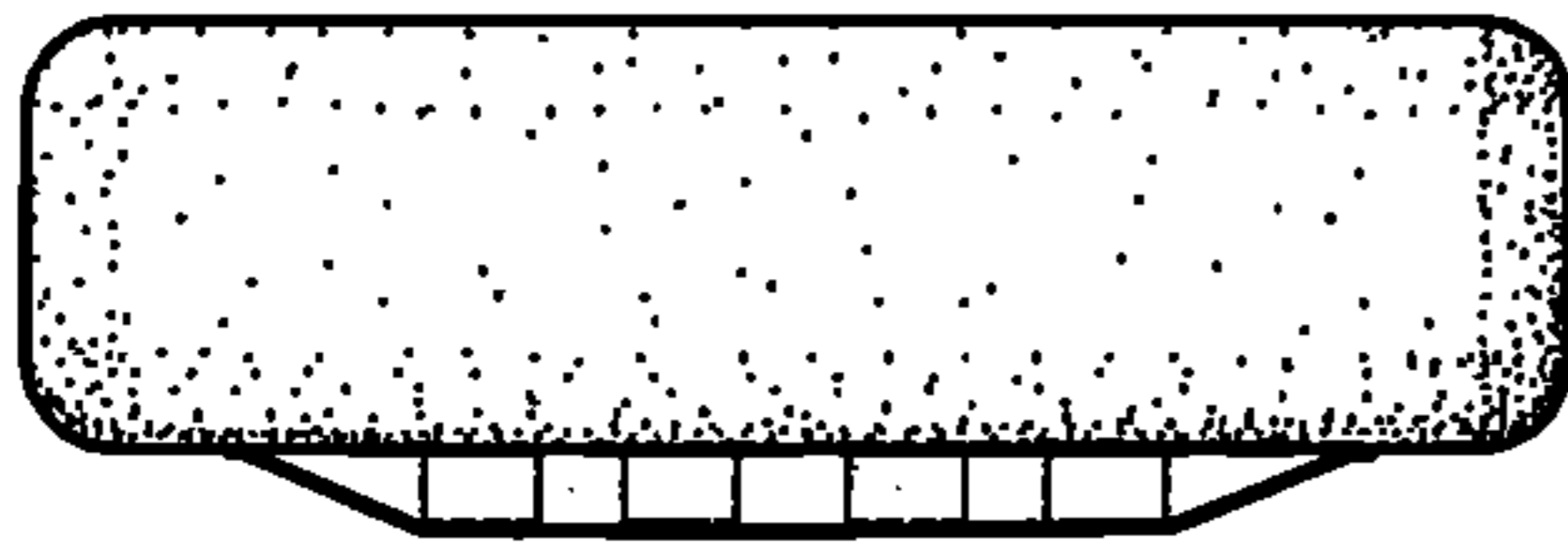

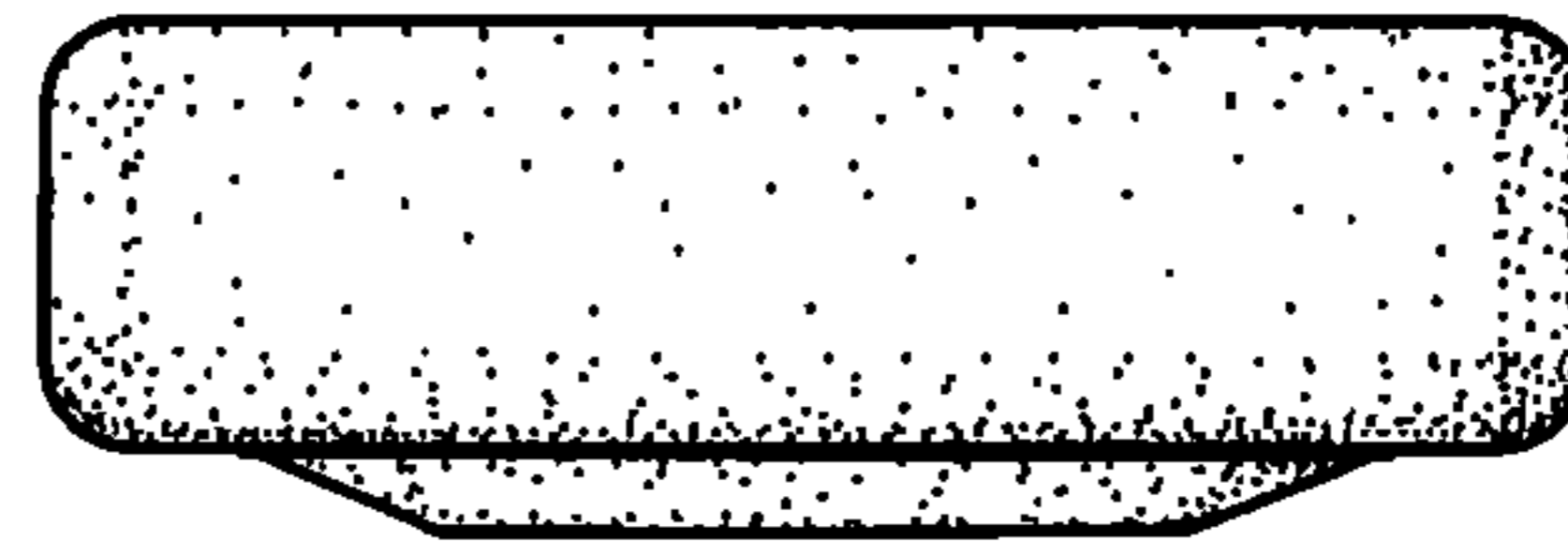

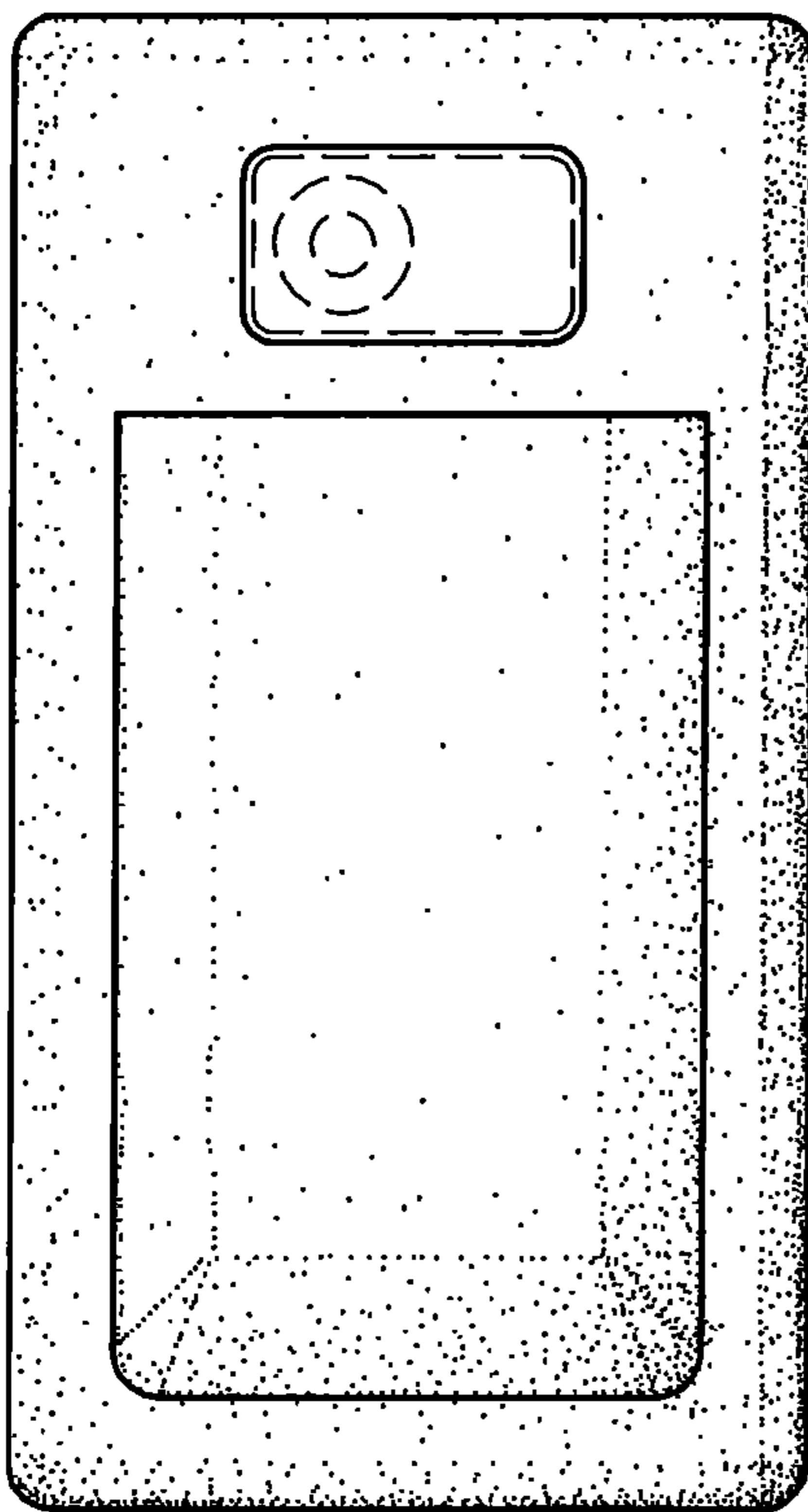

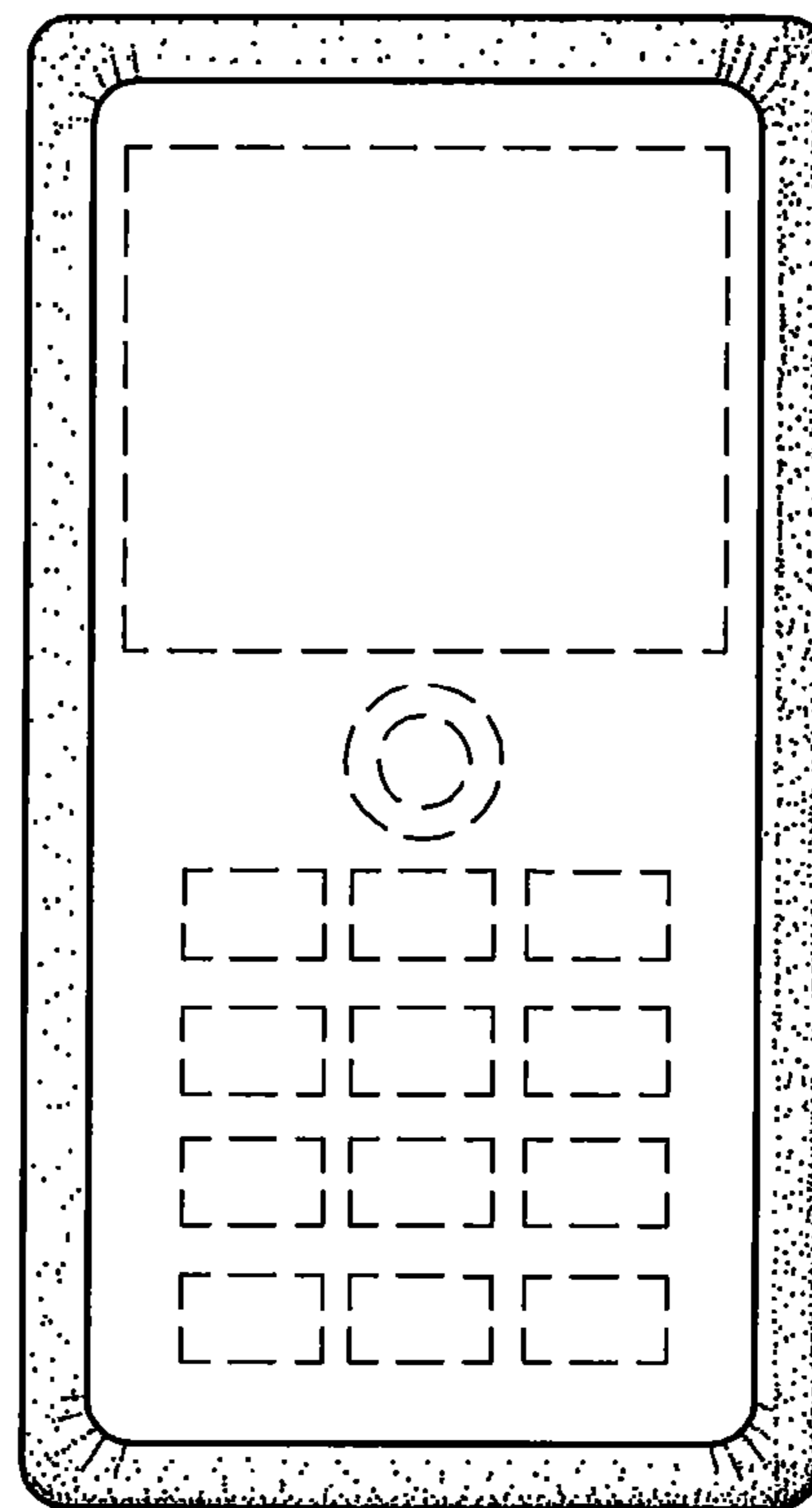

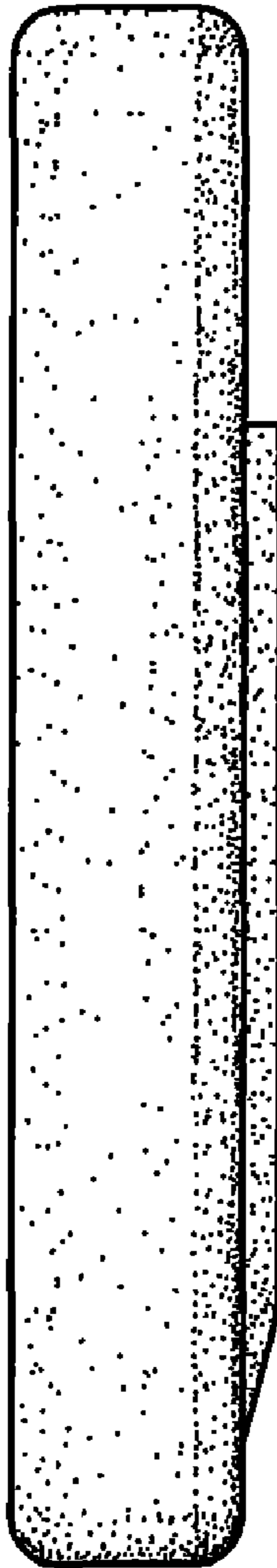

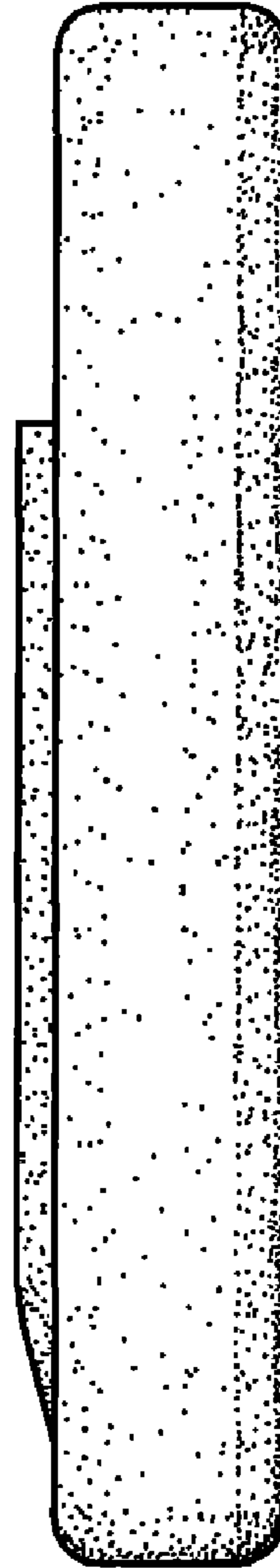

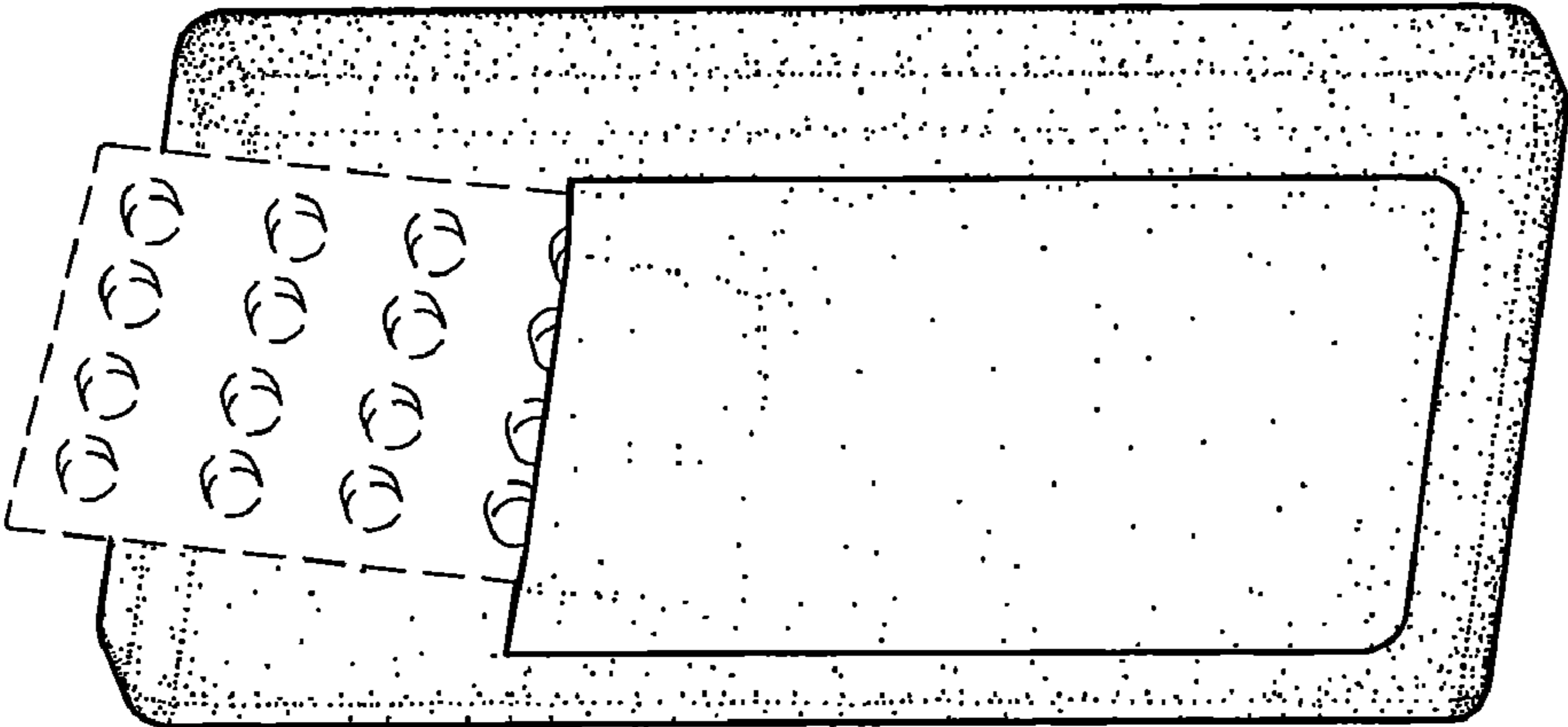
