(57) **CLAIM**

The ornamental design for the jewelry case, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the jewelry case in the open position according to the present invention, pieces of jewelry mounted within the case being shown in dashed lines for illustrative purposes only and not forming part of the claimed design;

FIG. 2 is a top plan view of the jewelry case in the closed position;

FIG. 3 is a front elevational view of the jewelry case in the closed position;

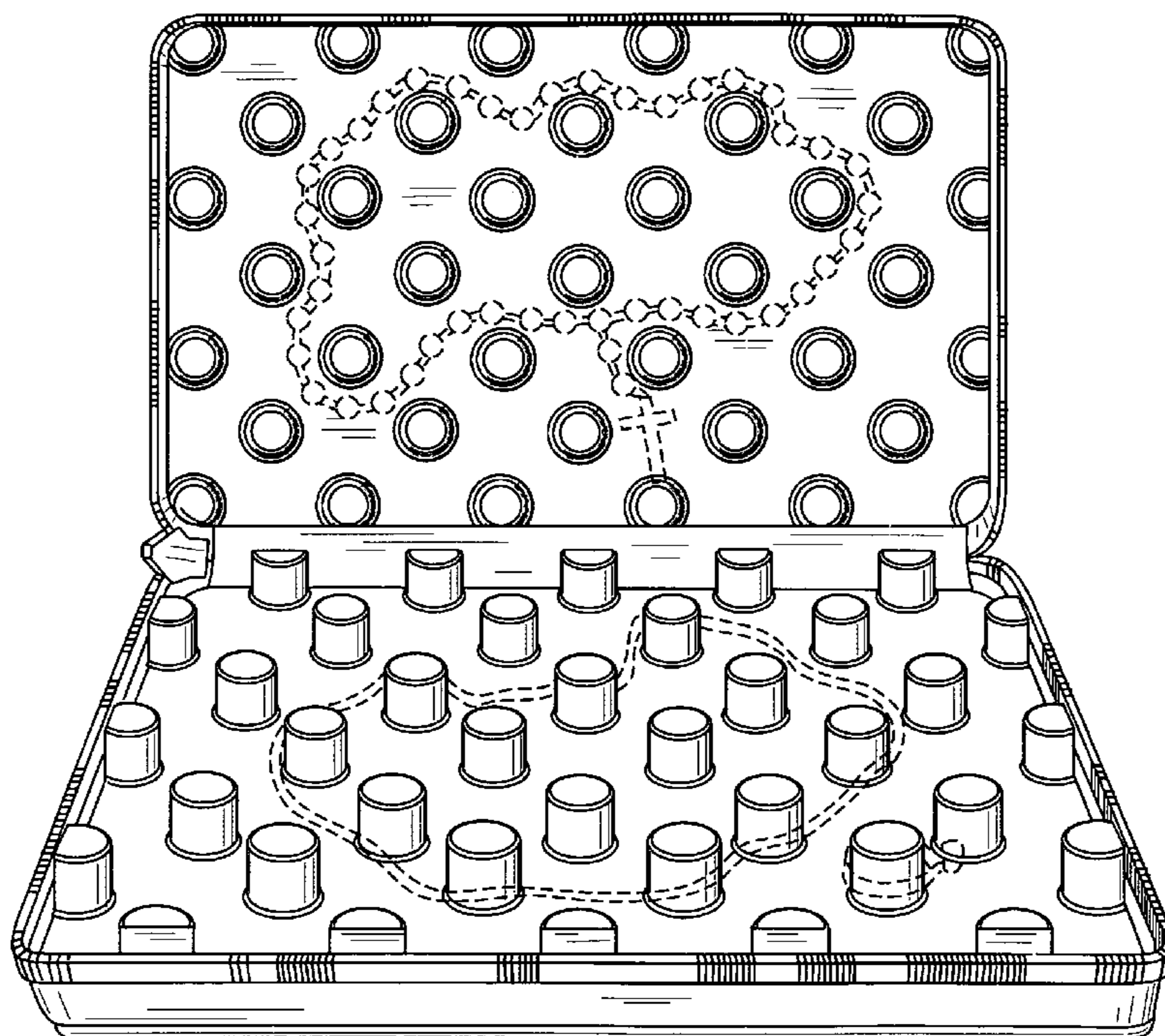
FIG. 4 is a rear elevational view of the jewelry case in the closed position;

FIG. 5 is left side elevational view of the jewelry case in the unzipped position;

FIG. 6 is right side elevational view of the jewelry case in the unzipped position; and,

FIG. 7 is a cross-sectional view taken on line 7—7 of FIG. 2.

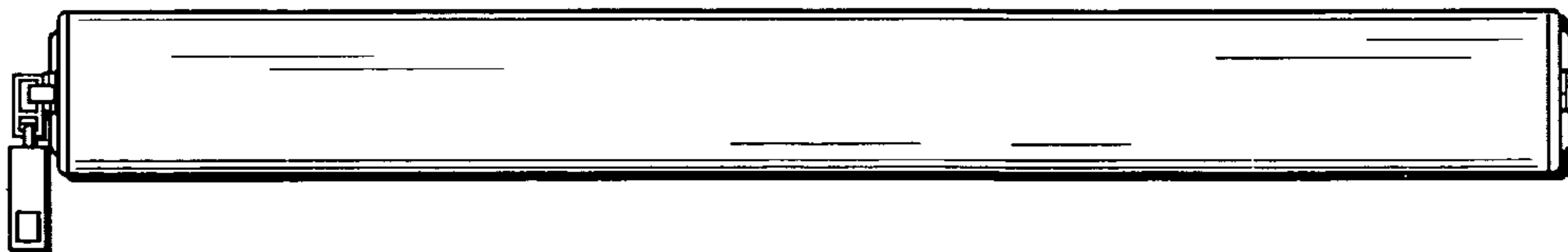
