**DESCRIPTION**

FIG. 5 is a front elevational view of my new design without the gloves engaged therewith;

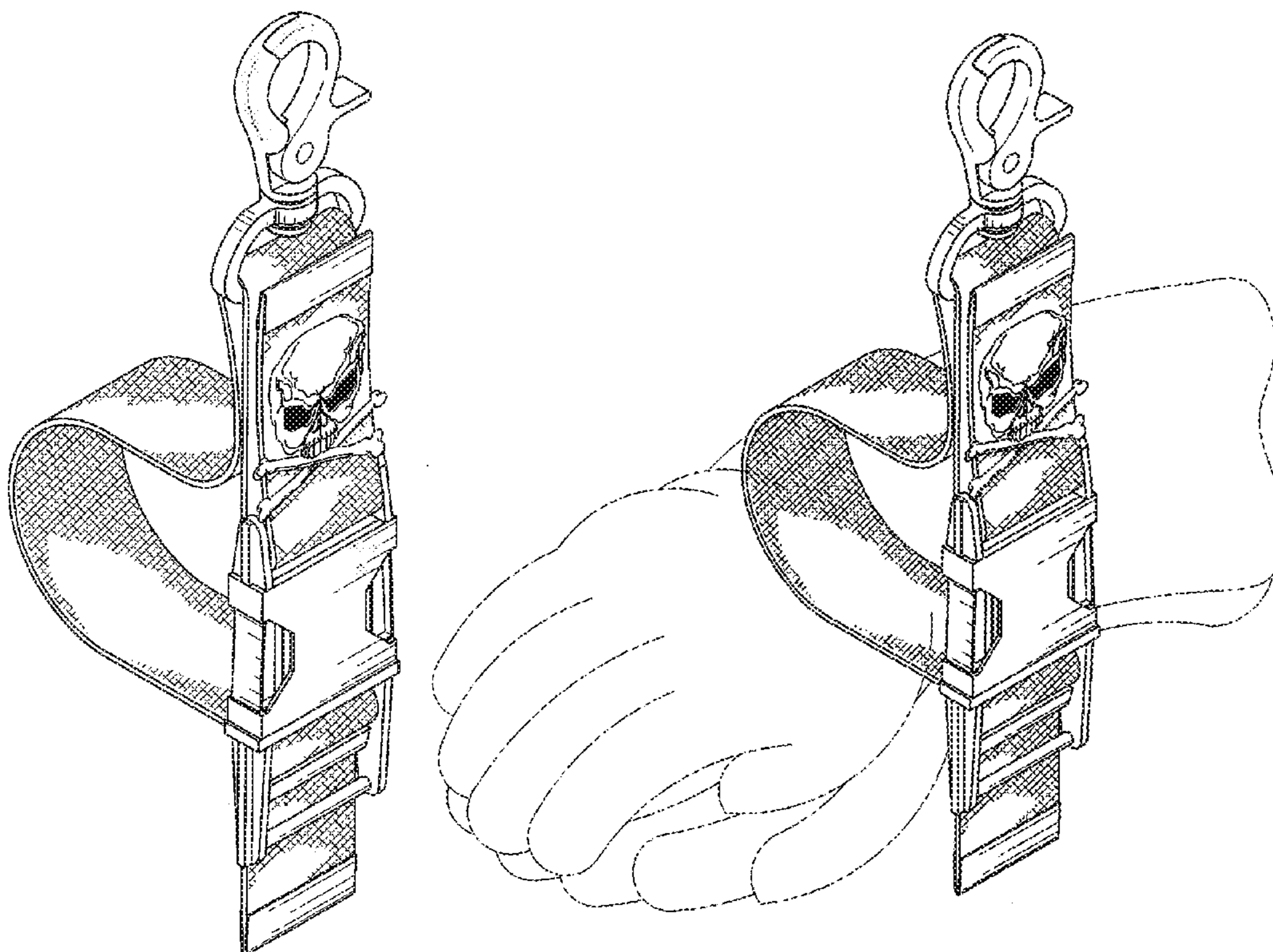
FIG. 6 is a right side elevational view of my new design without the gloves engaged therewith;

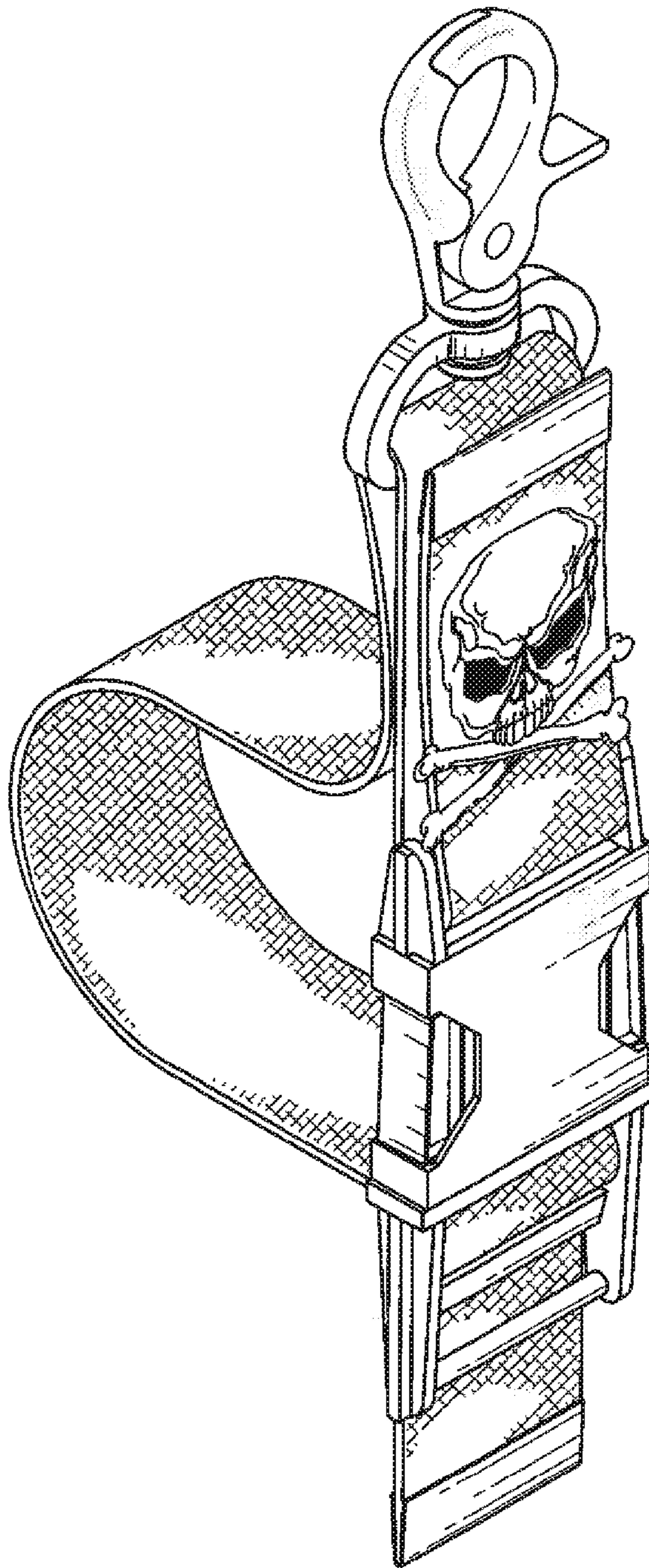
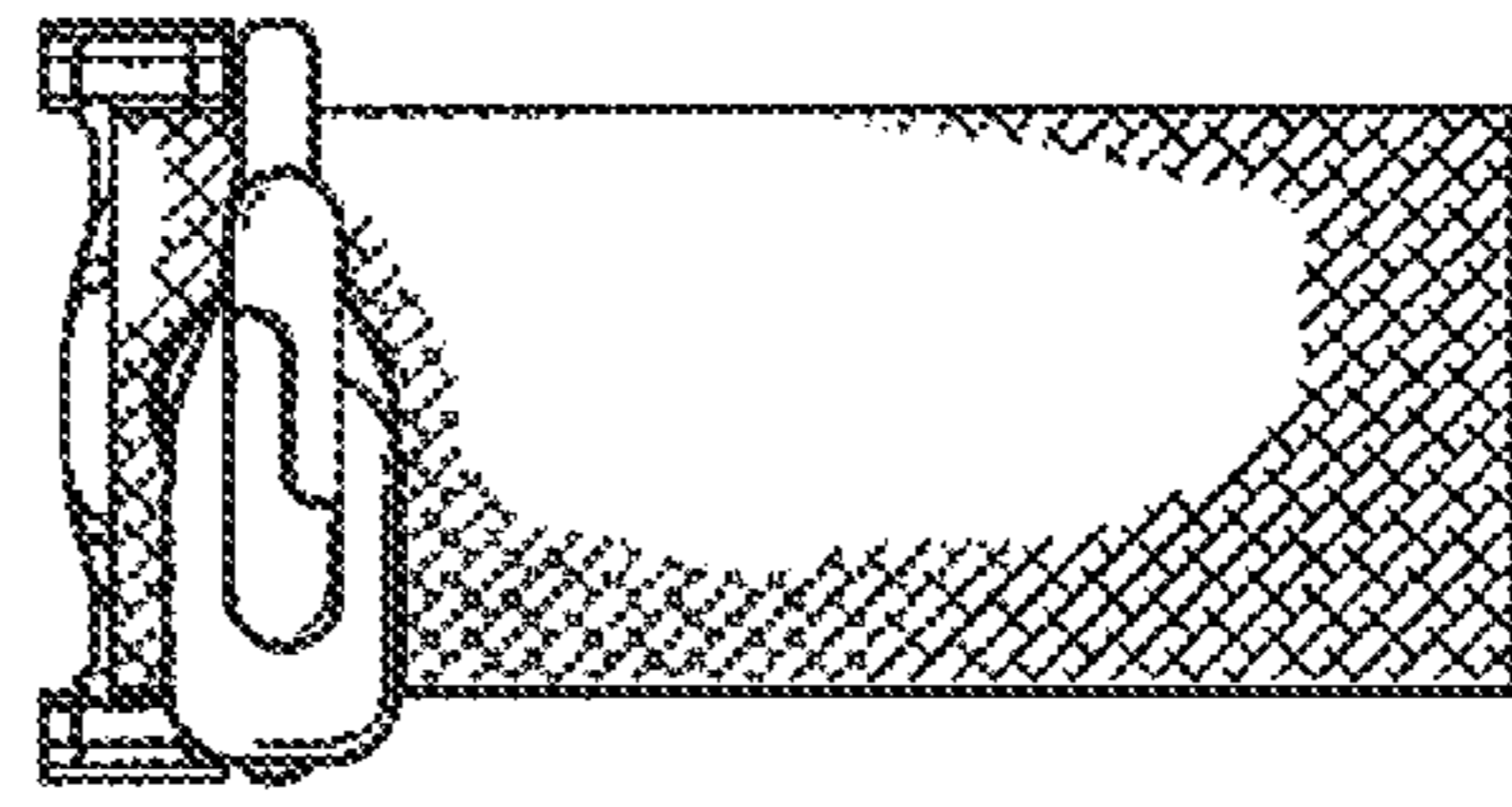
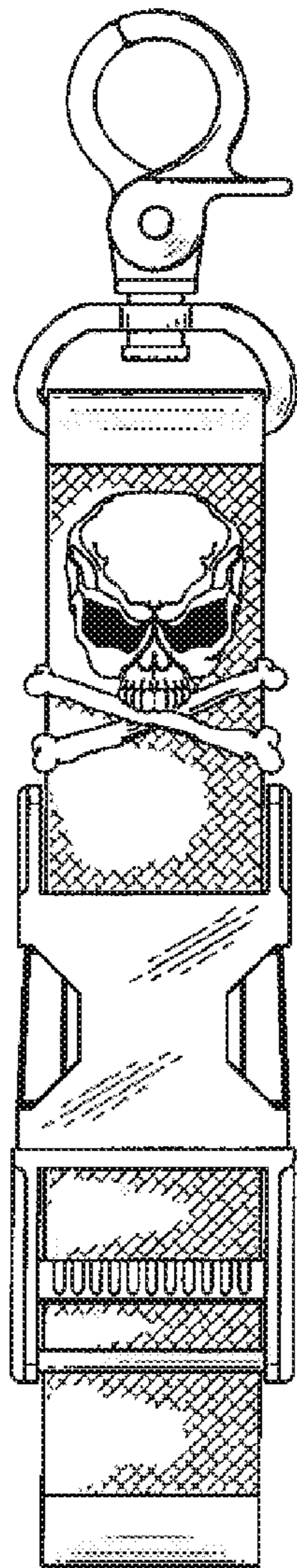


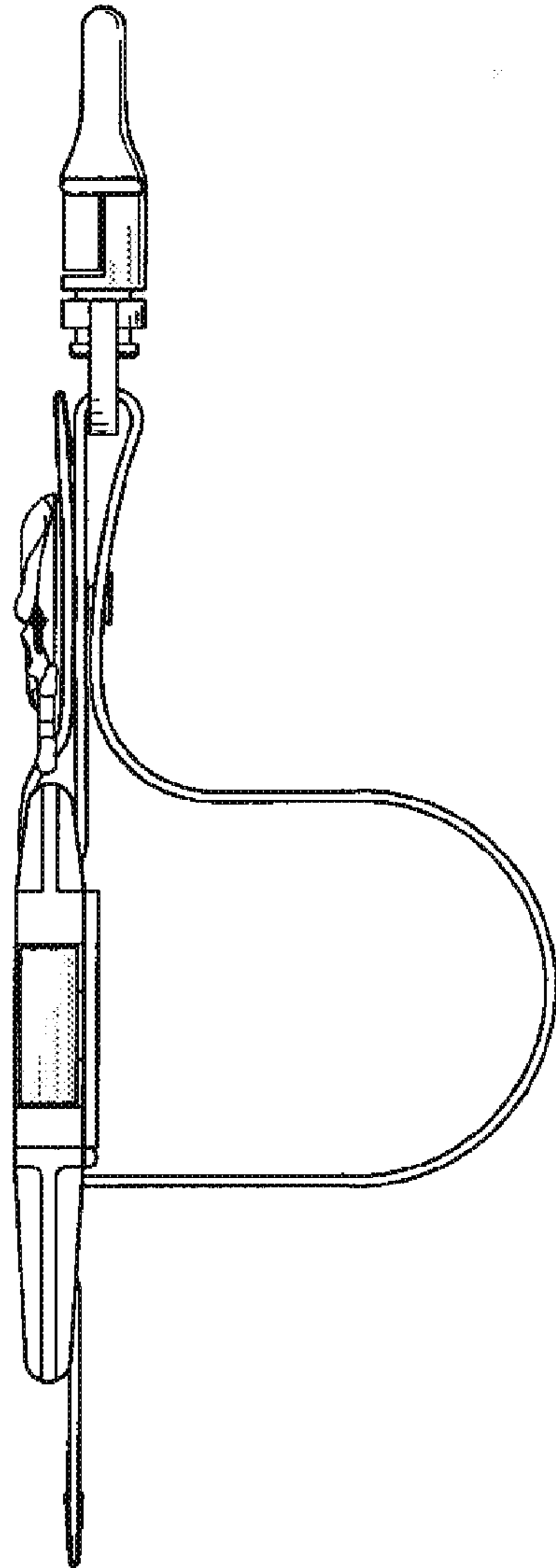

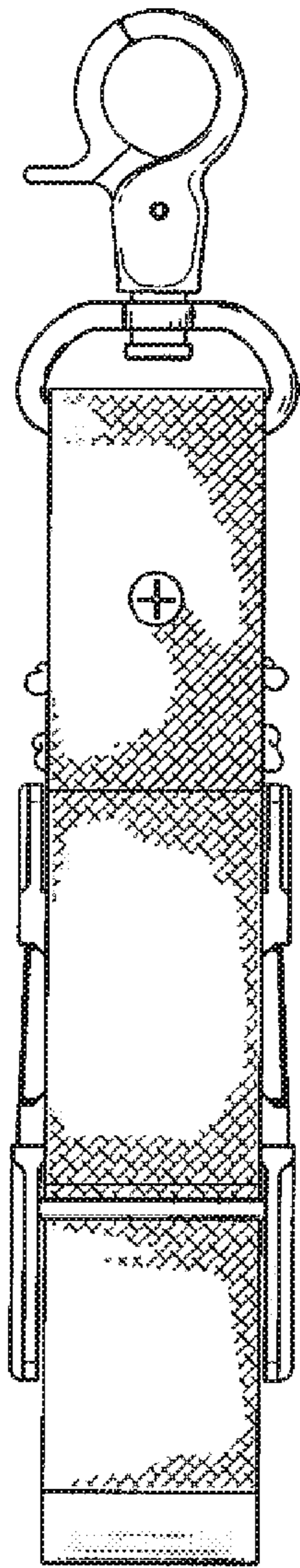

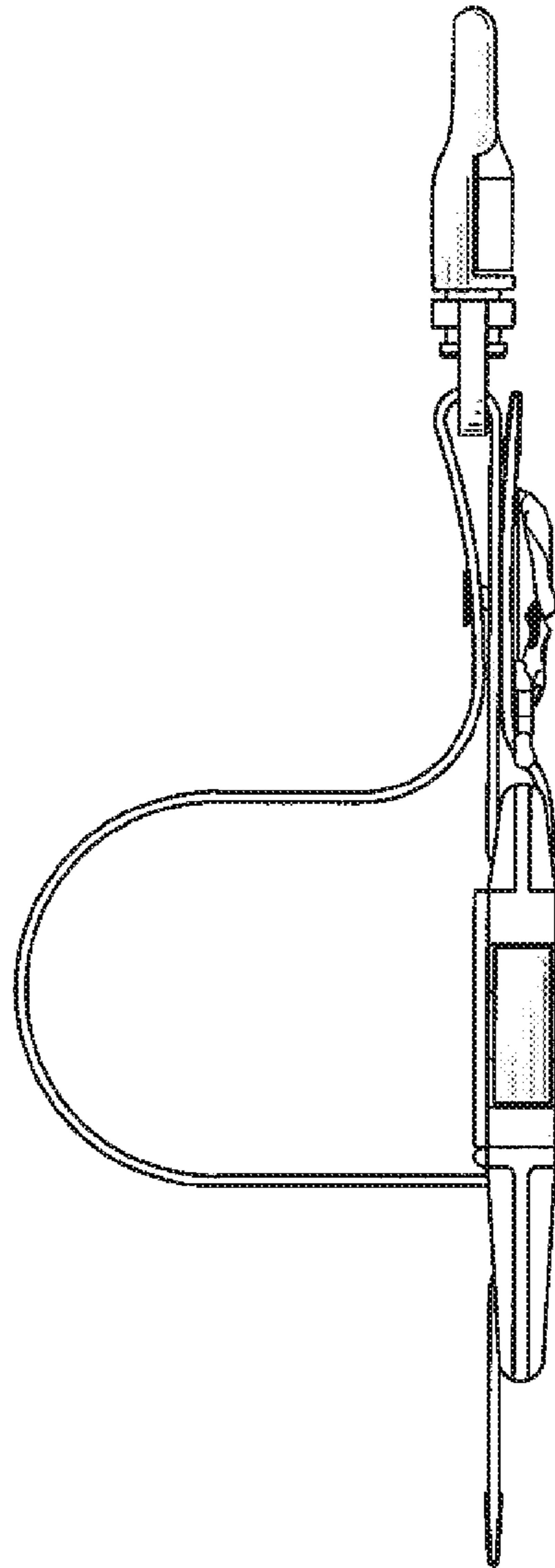

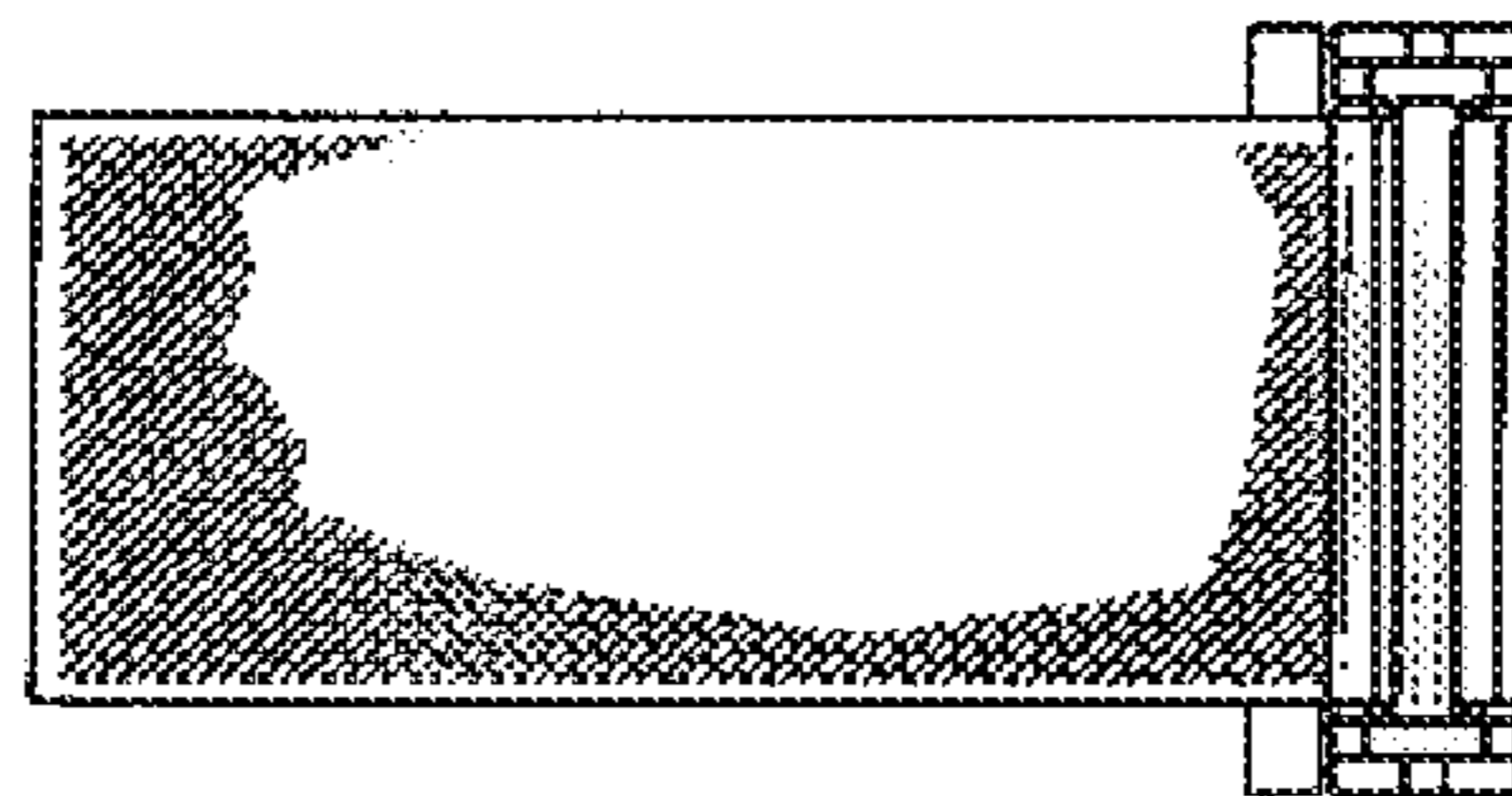

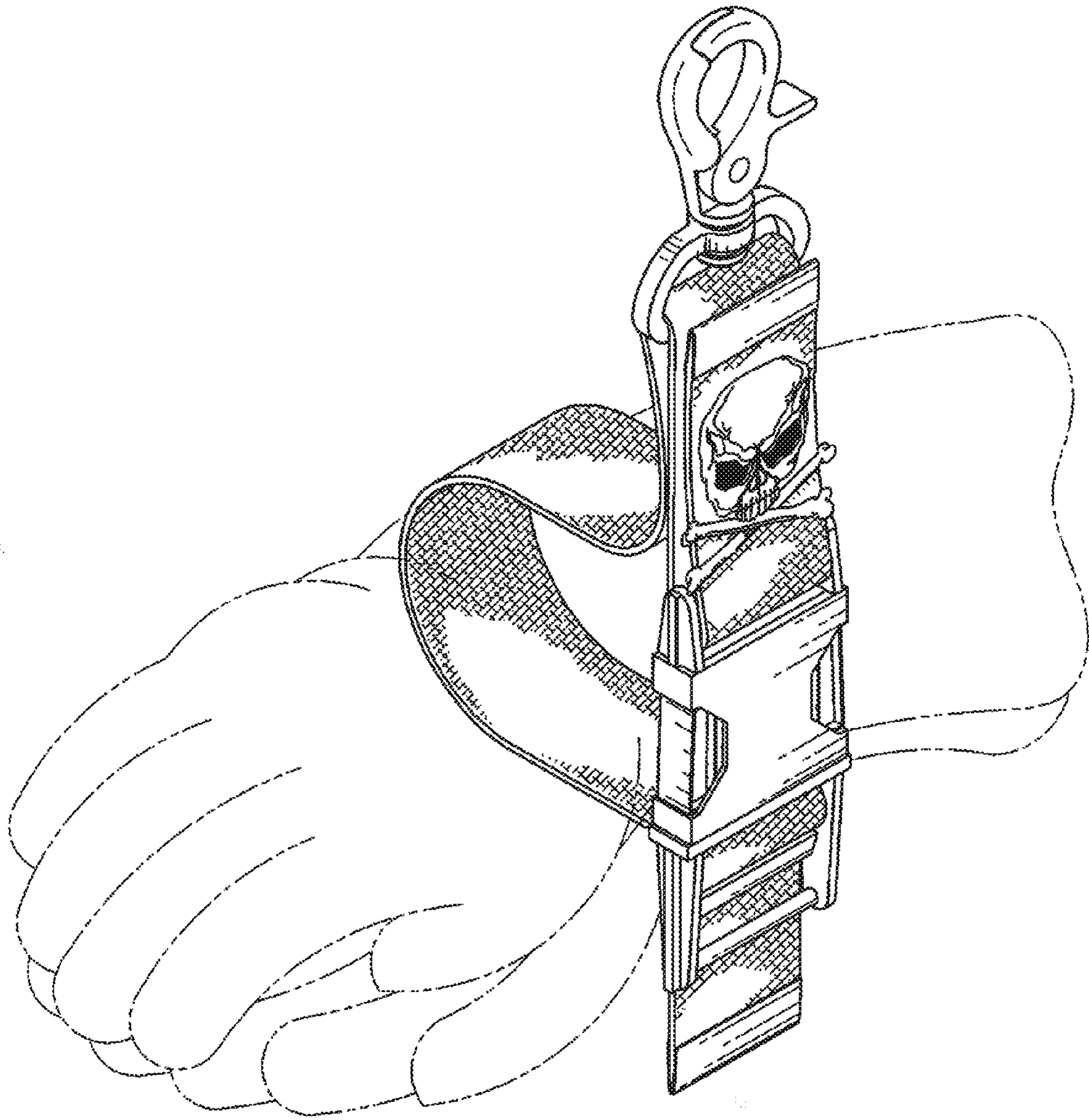

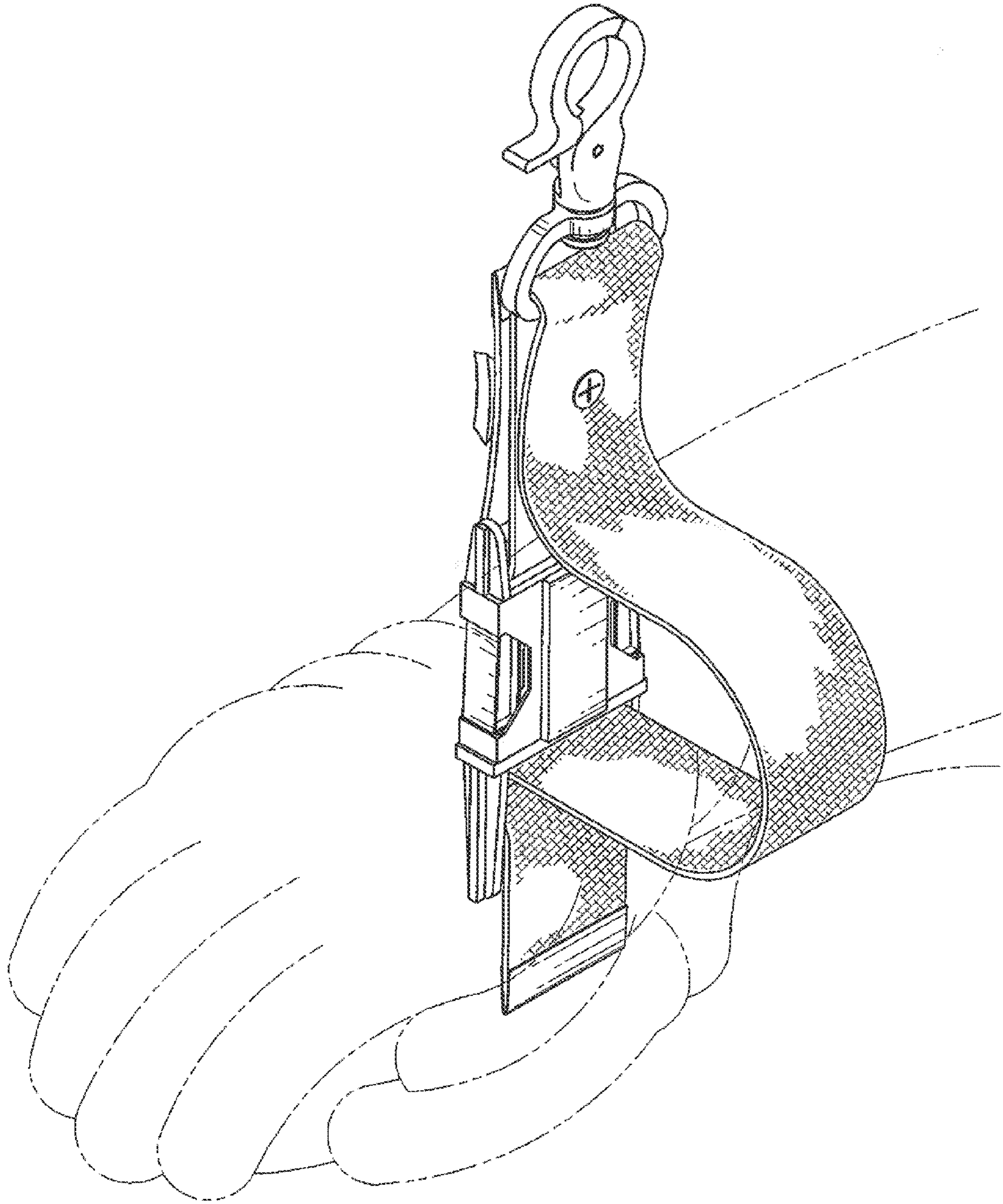
