The ornamental design for a combination towel holder and grab bar, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the combined towel holder and grab bar showing our new design.

FIG. 2 is a top plan view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a bottom plan view thereof; and,

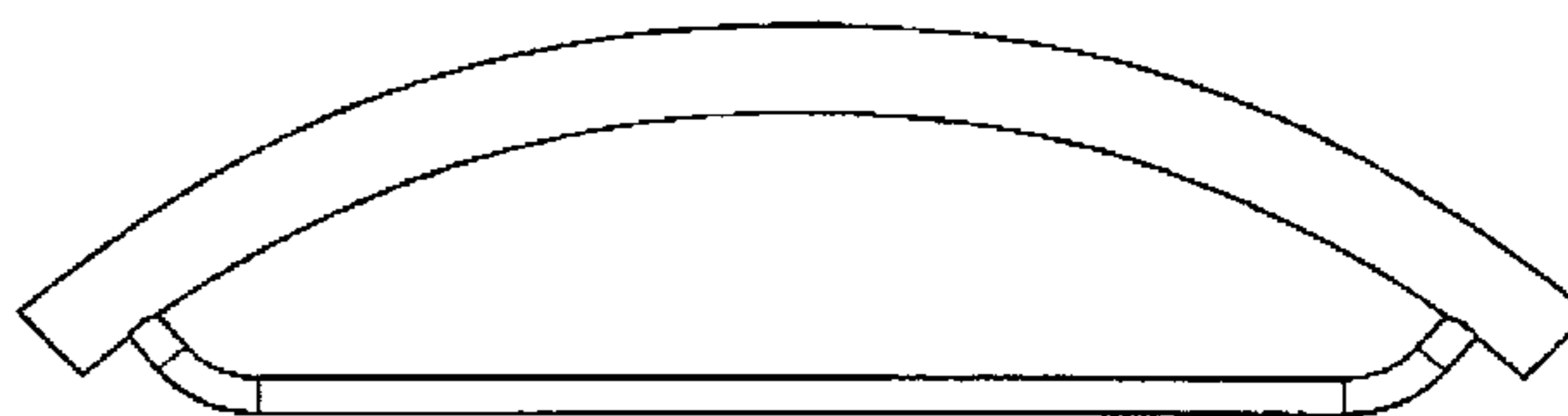
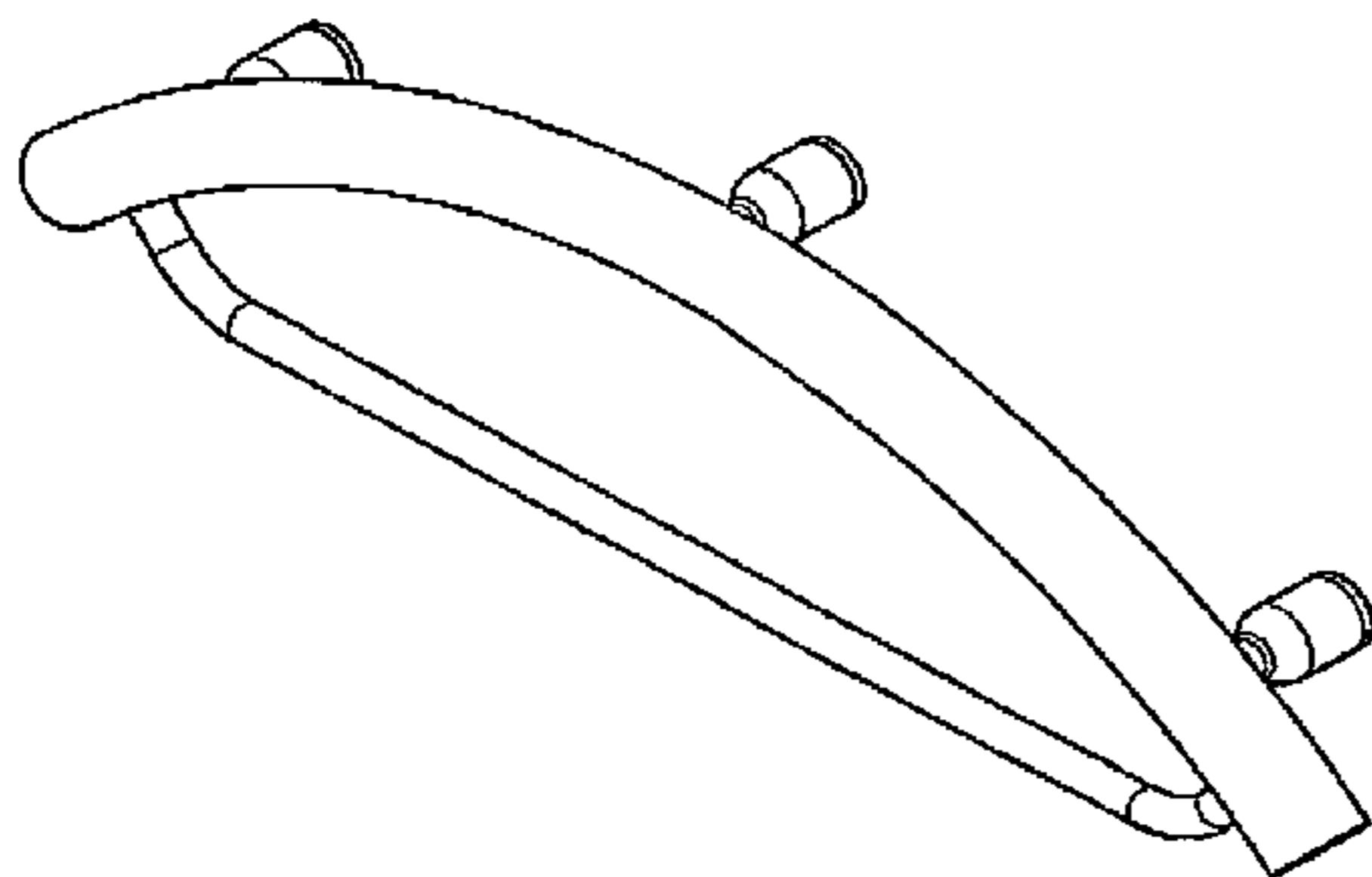

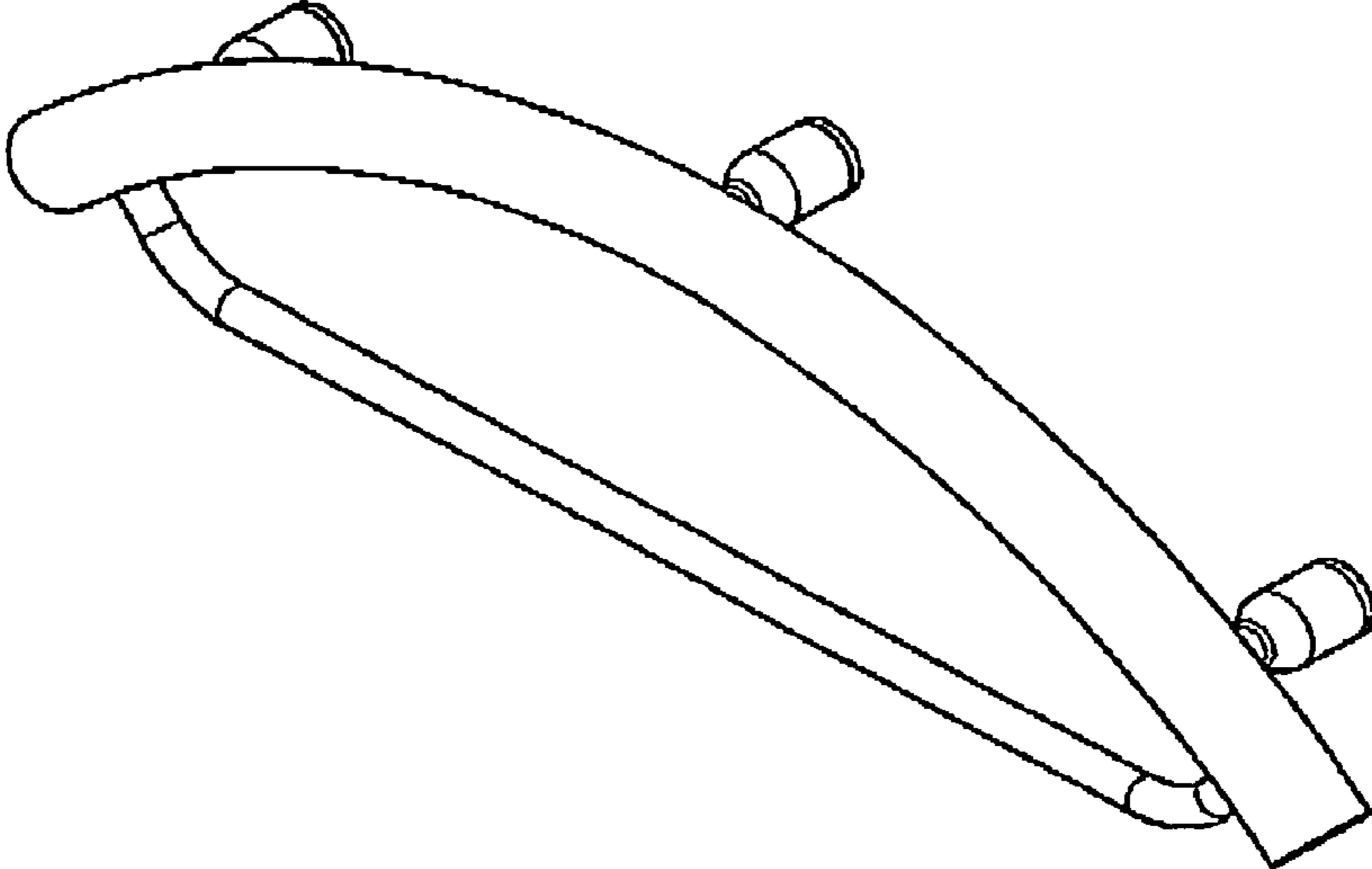

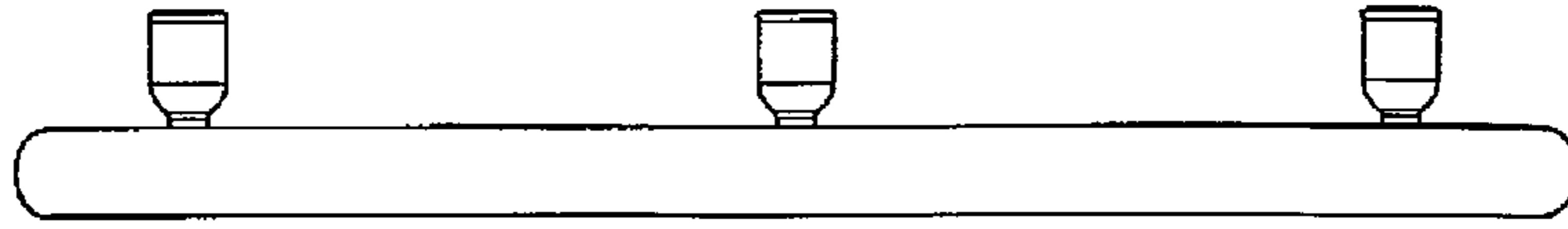

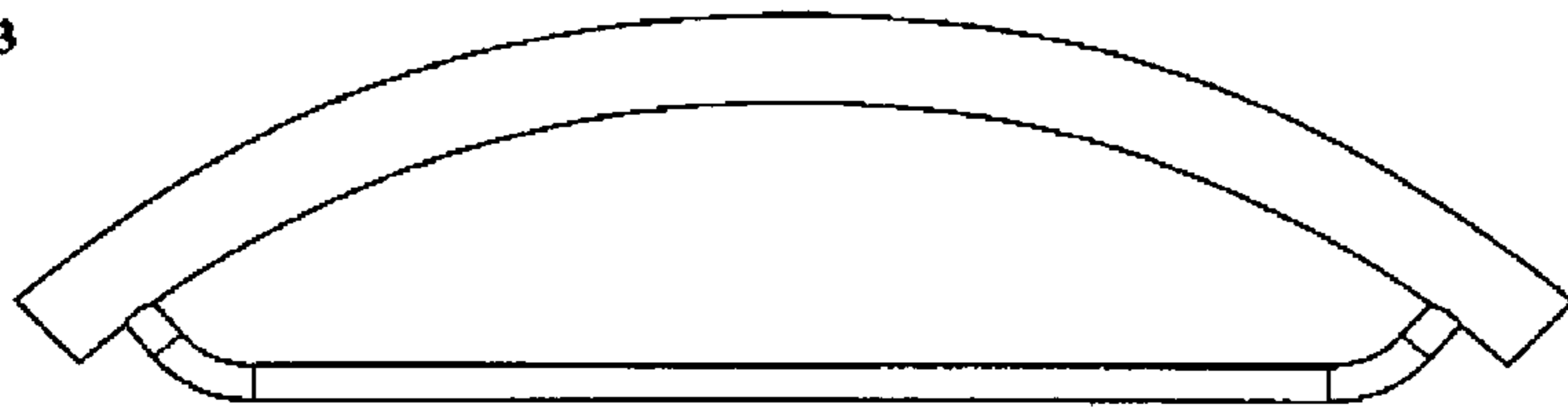

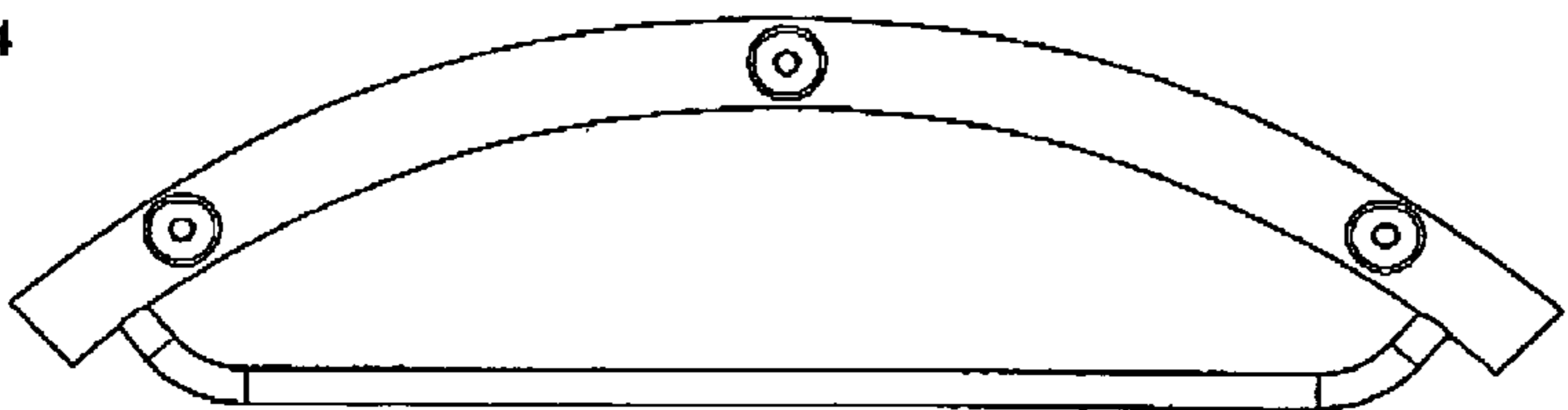
