The ornamental design for a food processor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the food processor according to the present invention;

FIG. 2 is an elevation view from a first side;

FIG. 3 is an elevation view from a second side;

FIG. 4 is a front elevation;

FIG. 5 is a back elevation, the broken line showing of the vent is for illustrative purposes only and forms no part of the claimed design;

FIG. 6 is a plan view from above; and,

FIG. 7 is a perspective view showing a goblet in place, the goblet is shown for illustrative purposes only and forms no part of the claimed design.

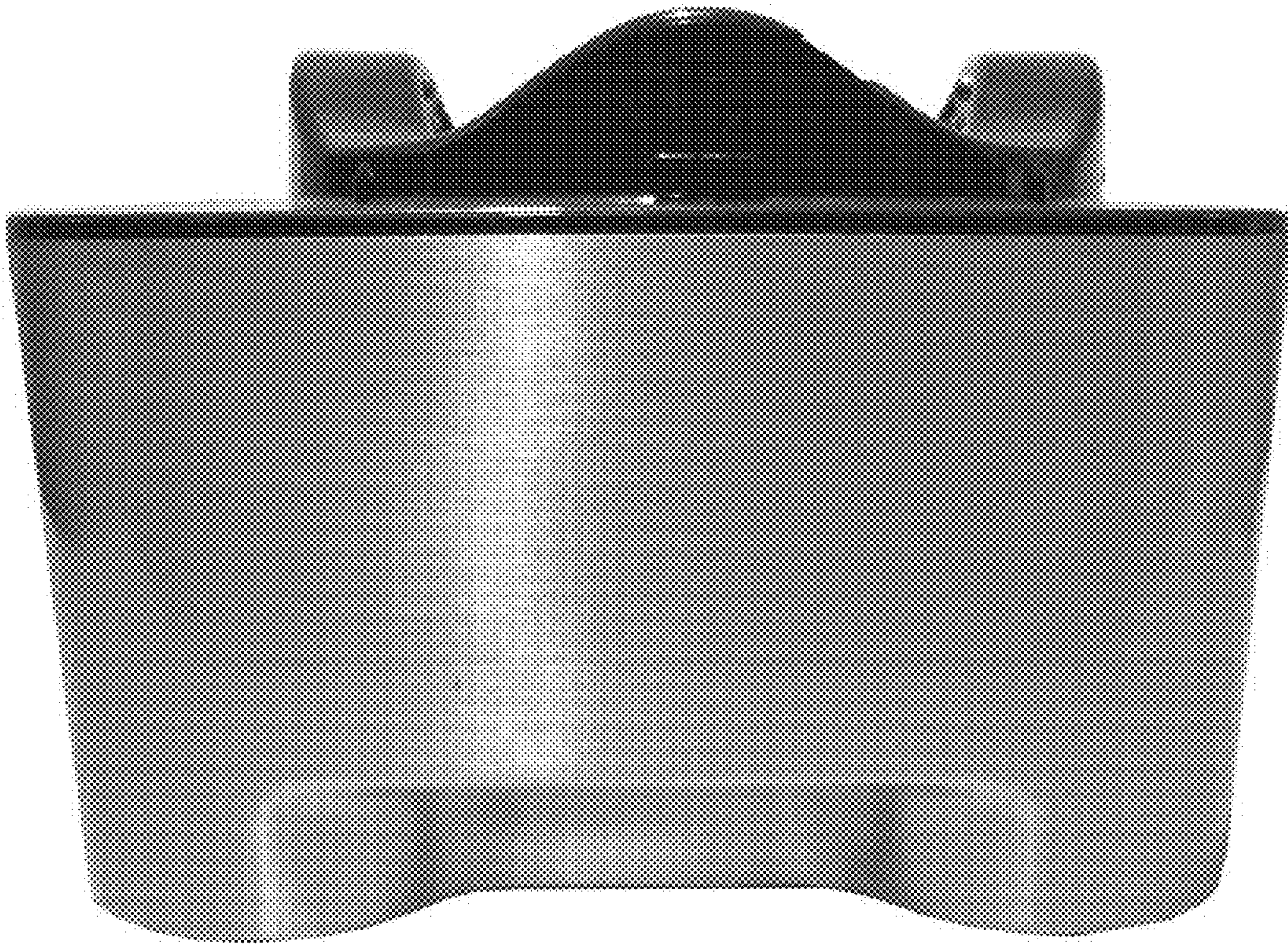

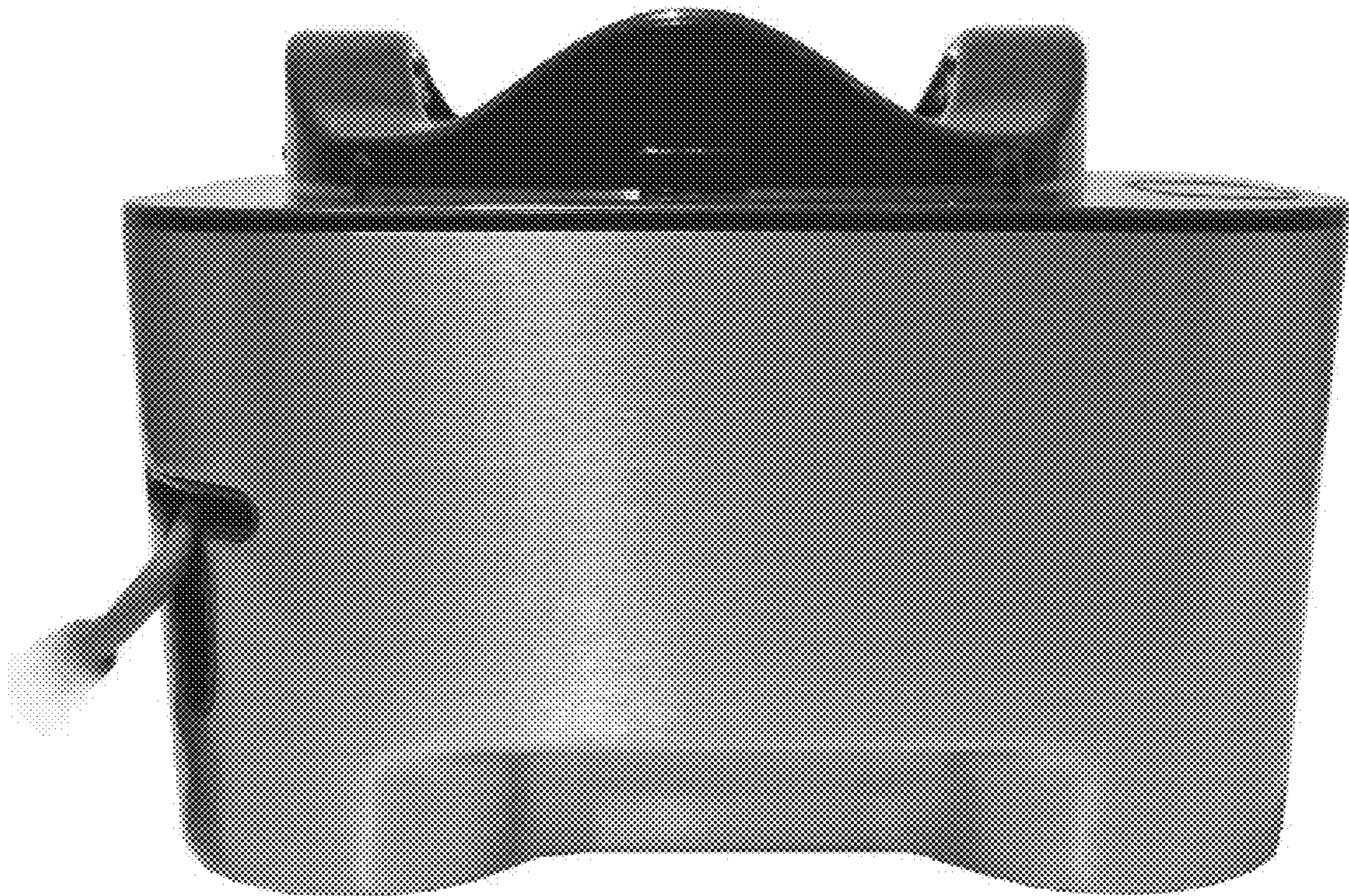

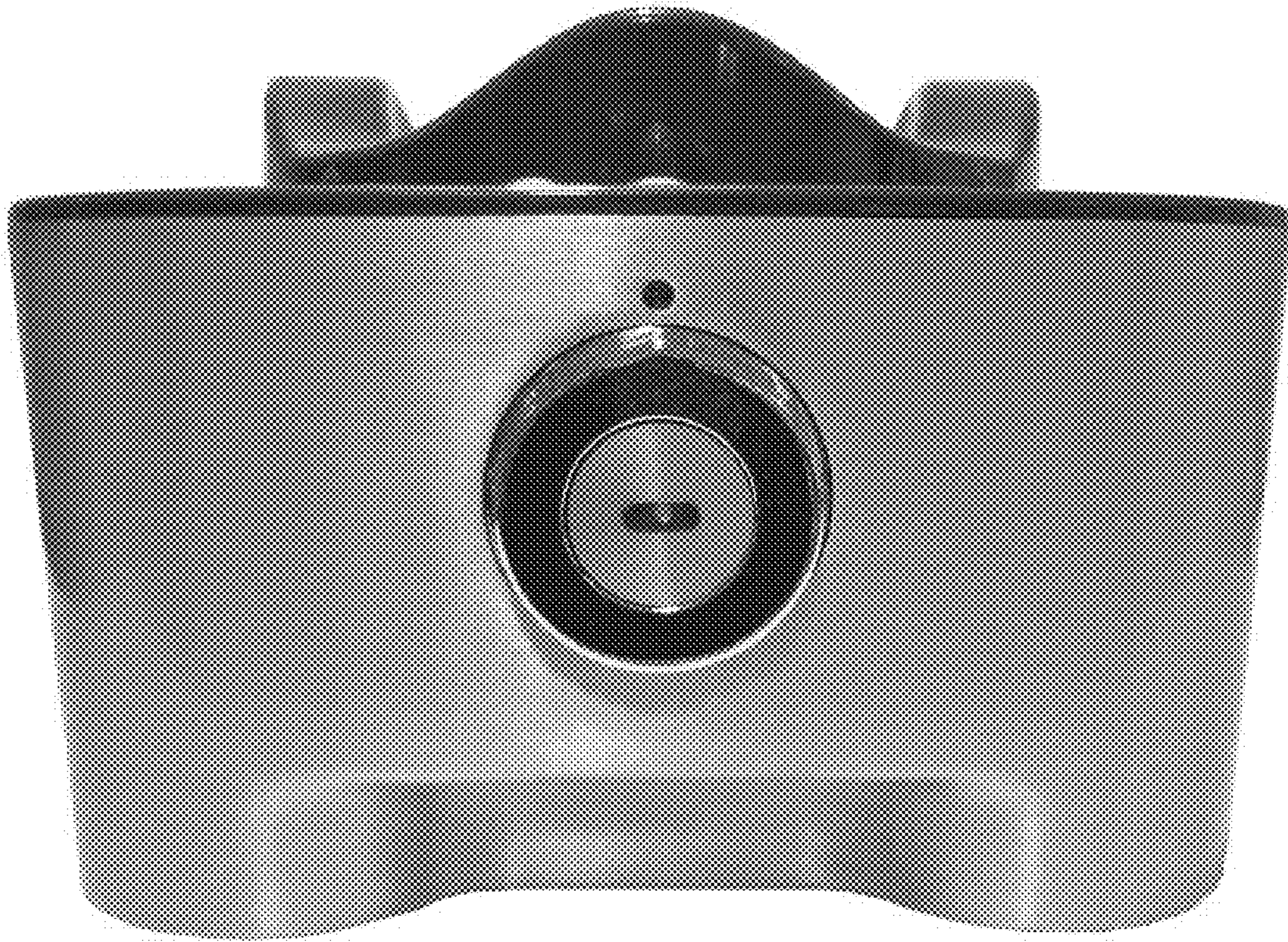

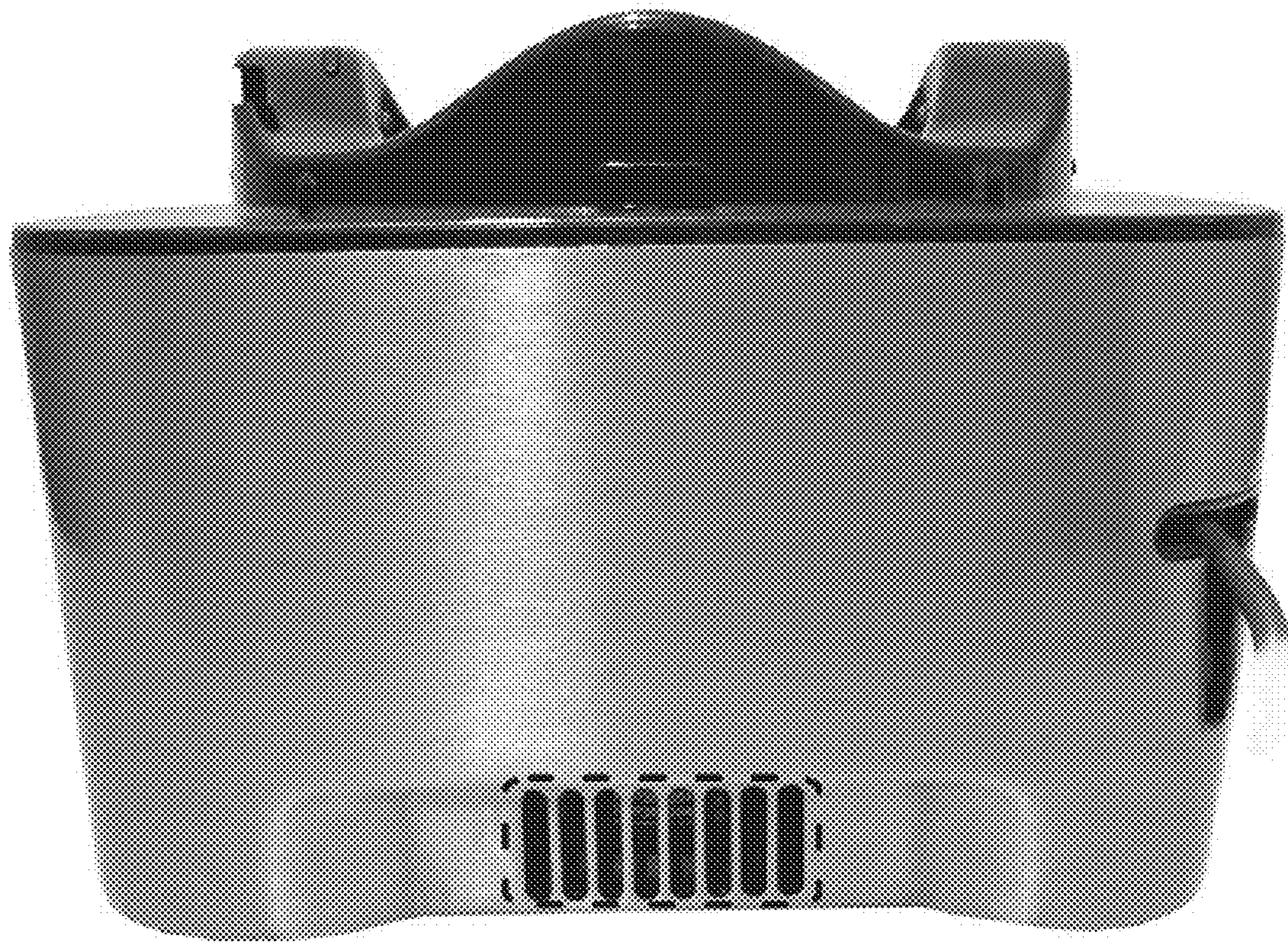

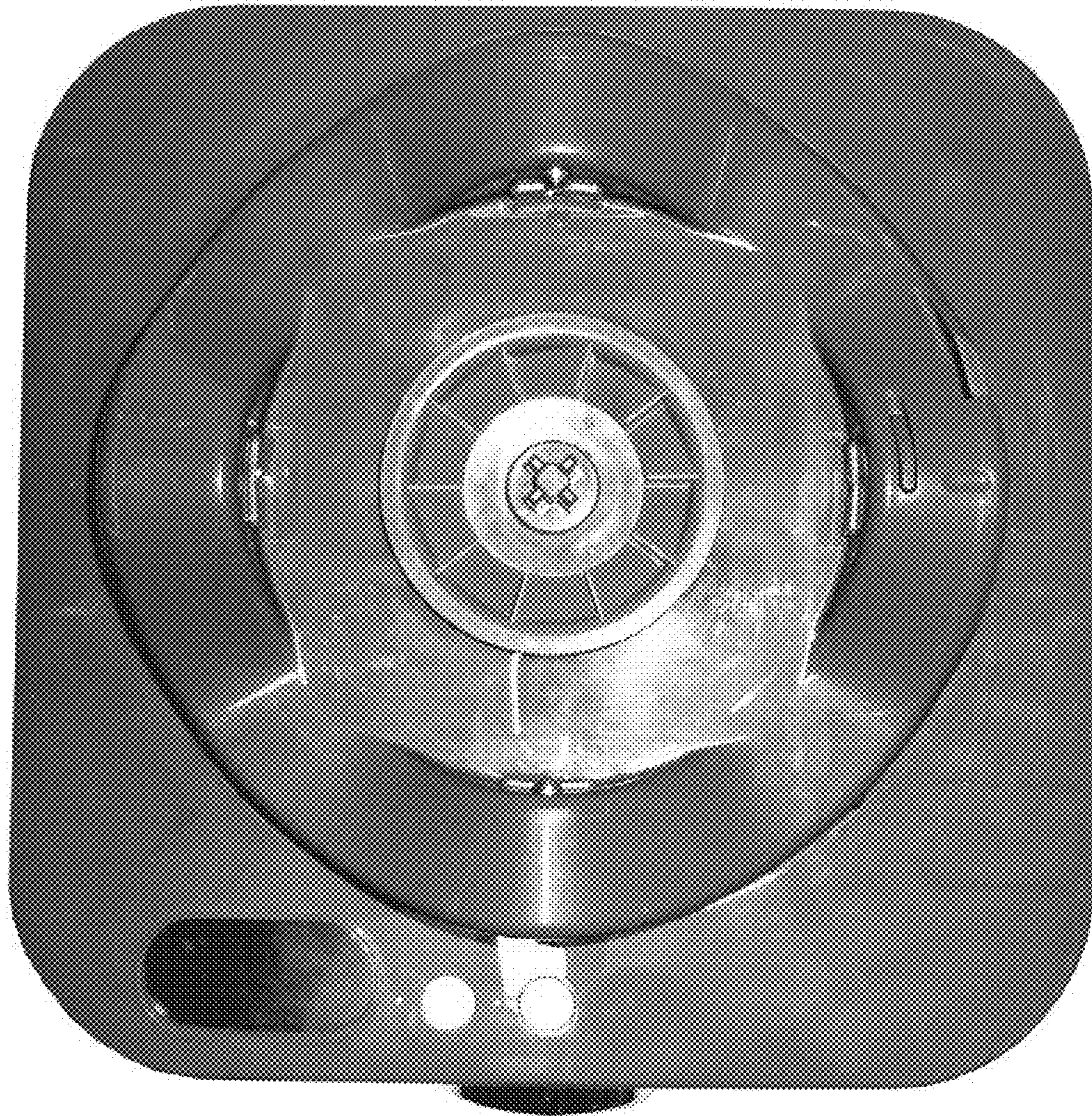
