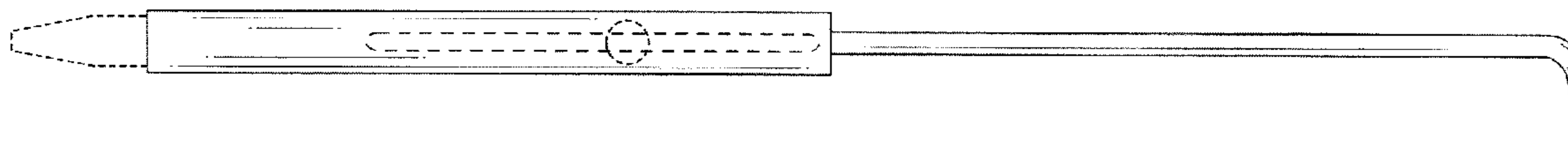
(57) **CLAIM**

The ornamental design for a roofing tool, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of a roofing tool;
FIG. 2 is an elevation view of the reverse side thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is an end view thereof; and,
FIG. 6 is a fragmentary view showing the second end thereof.

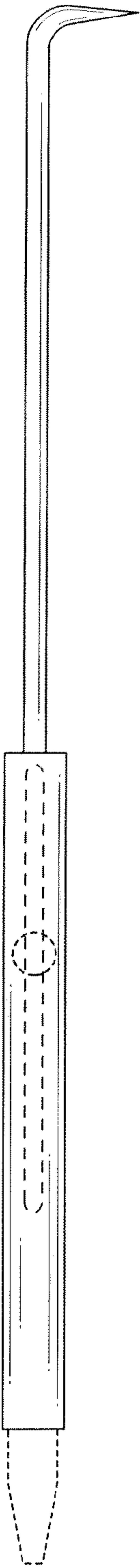

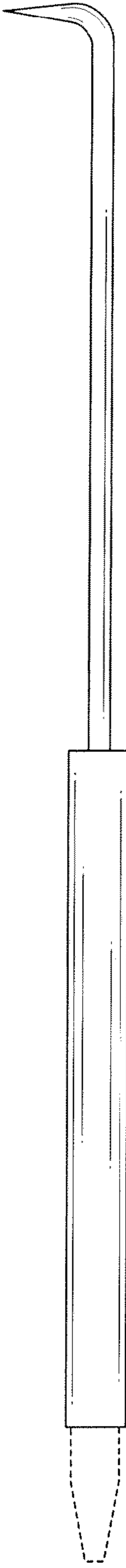

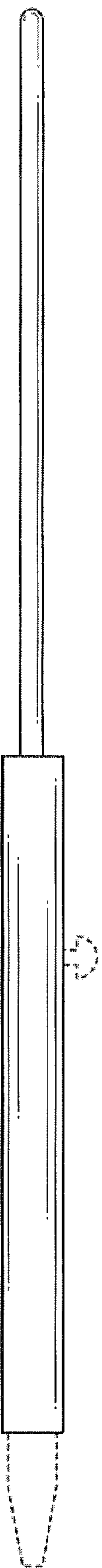

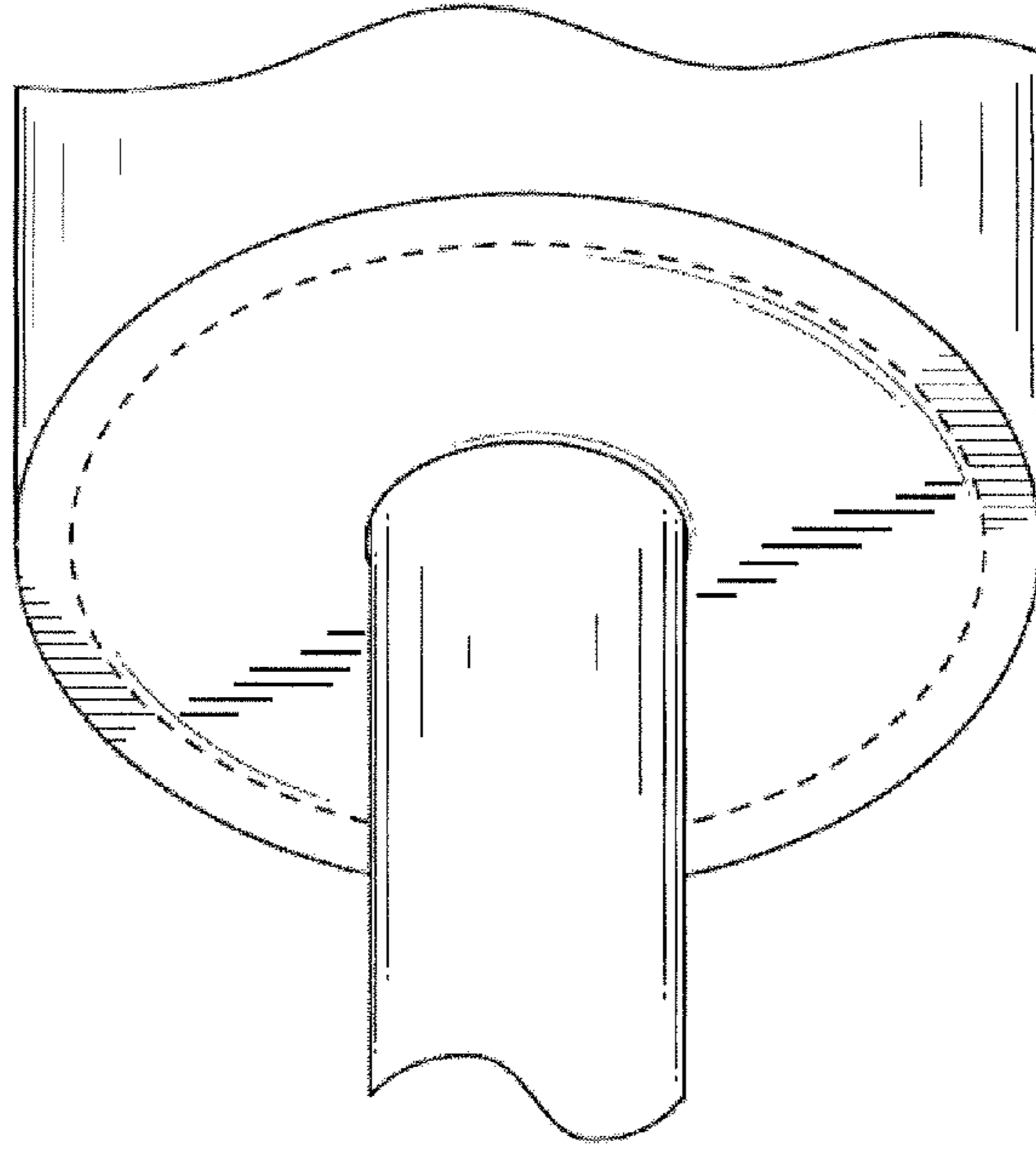

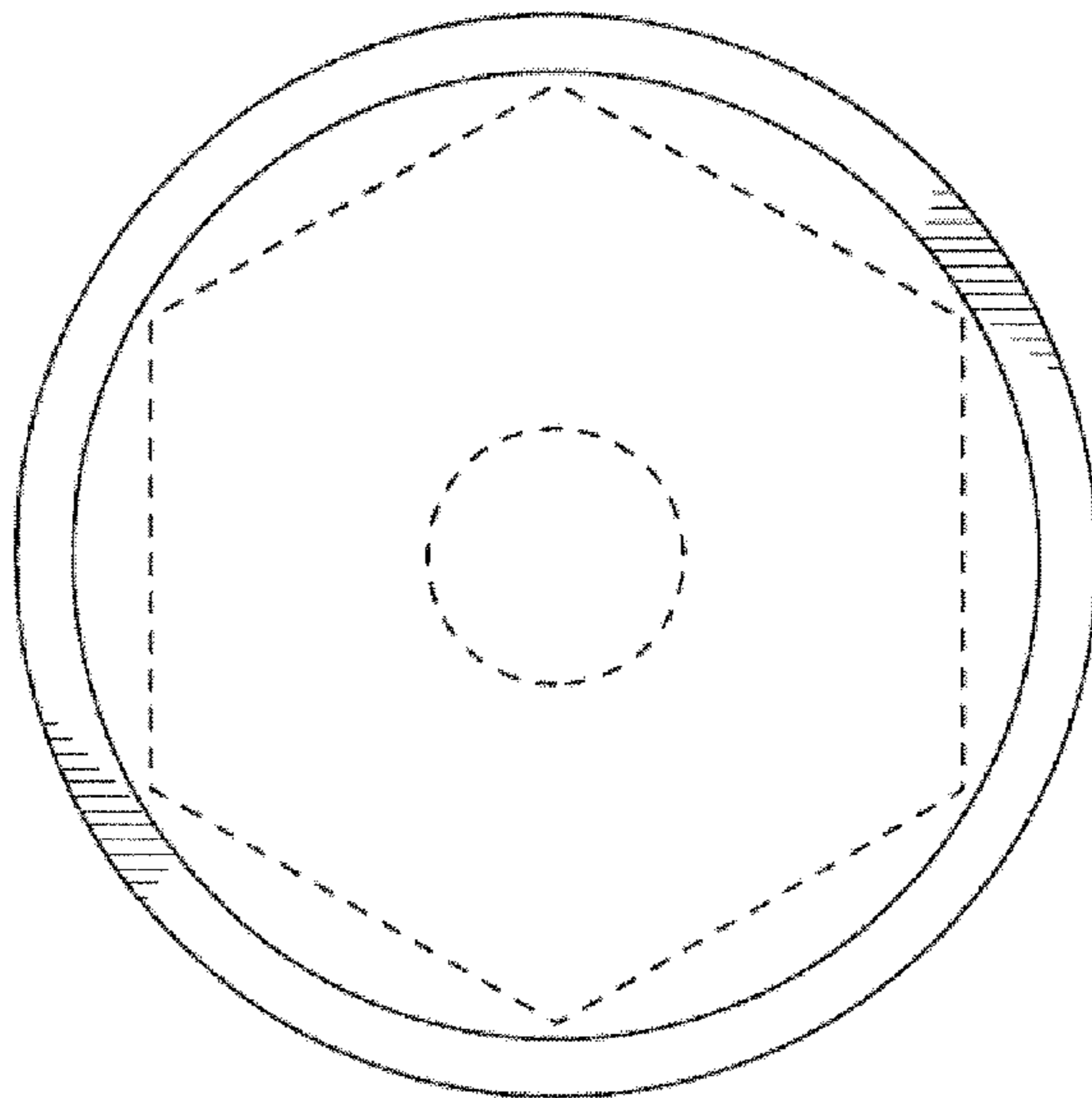
