**DESCRIPTION**

FIG. 1 is a perspective view of a bolt cap, showing my new design;

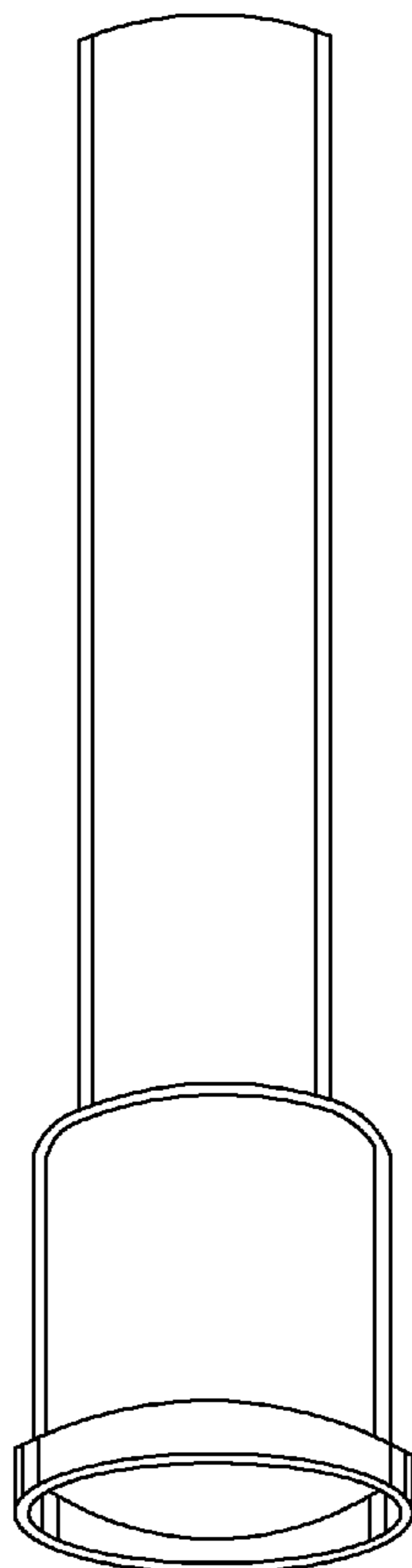
FIG. 2 is a bottom view thereof;

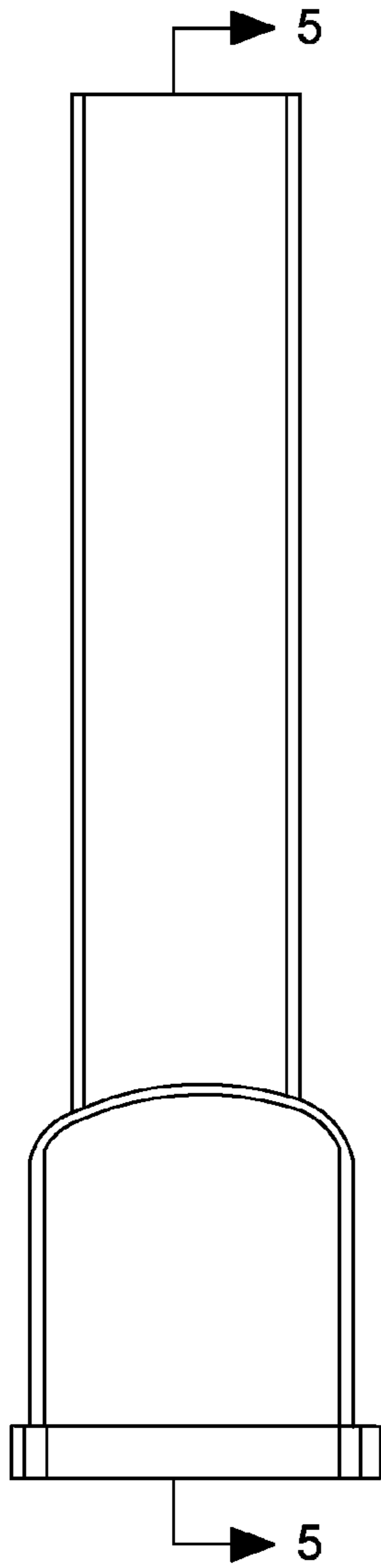

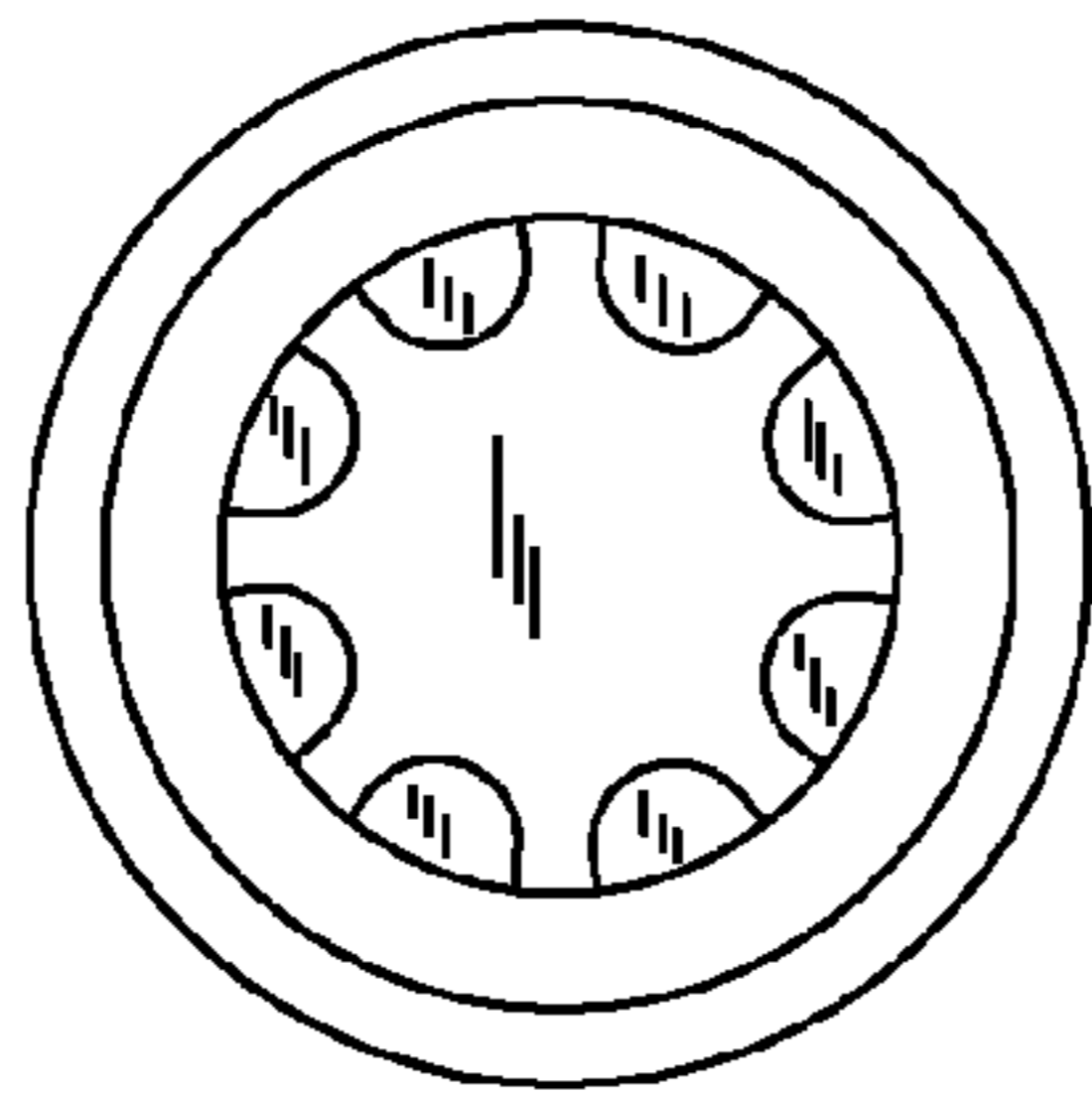

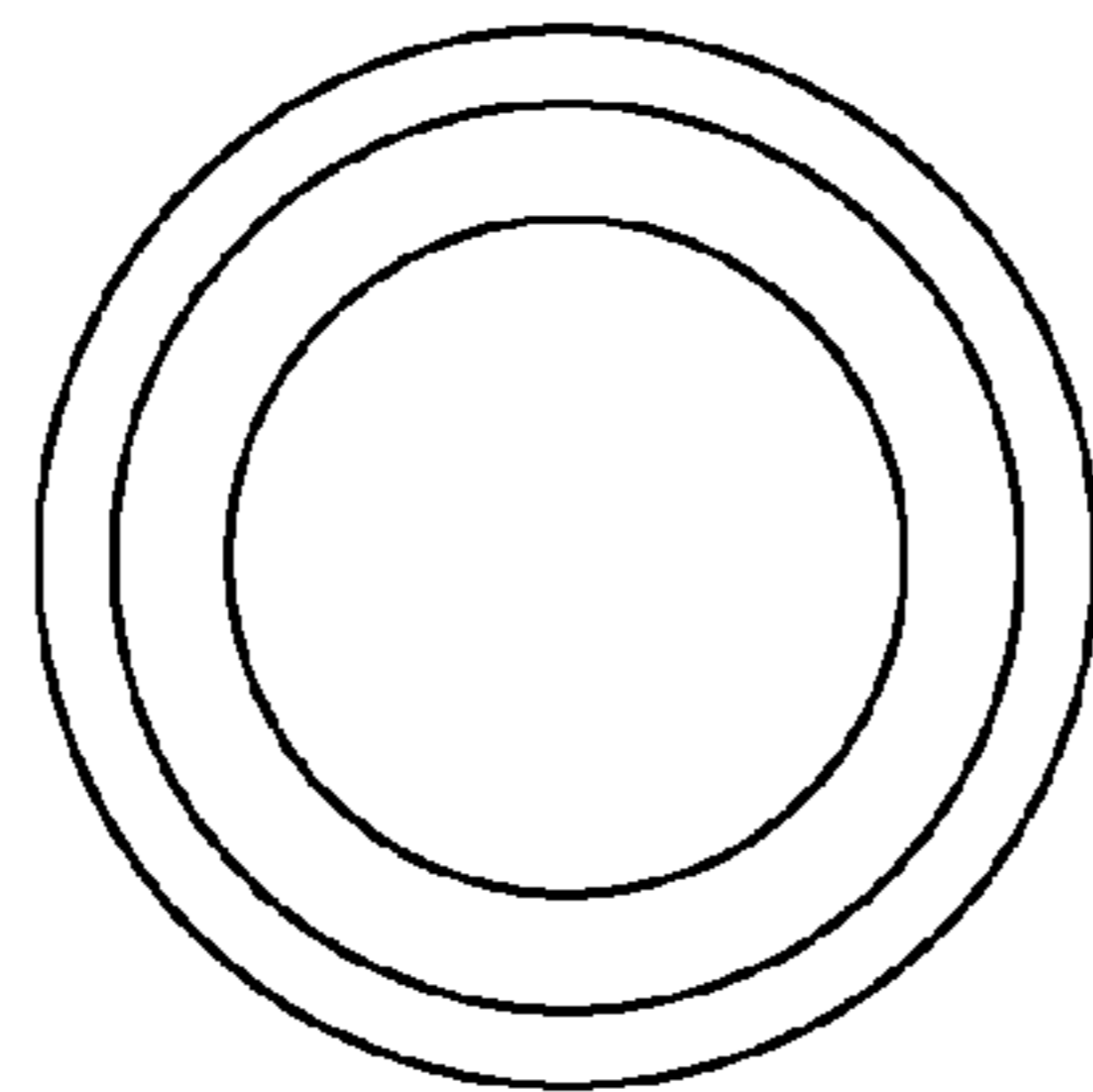

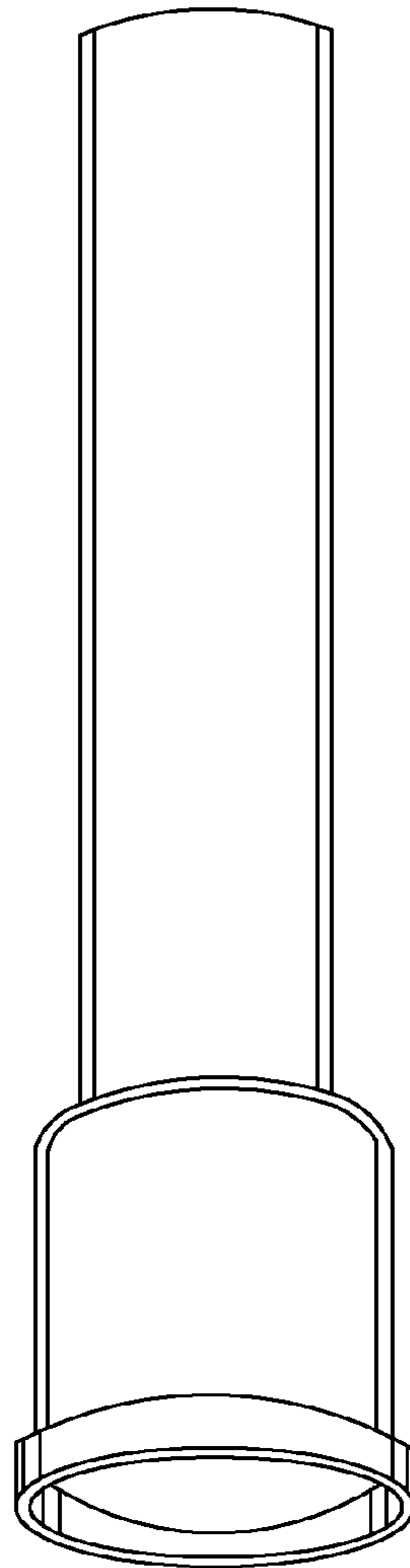

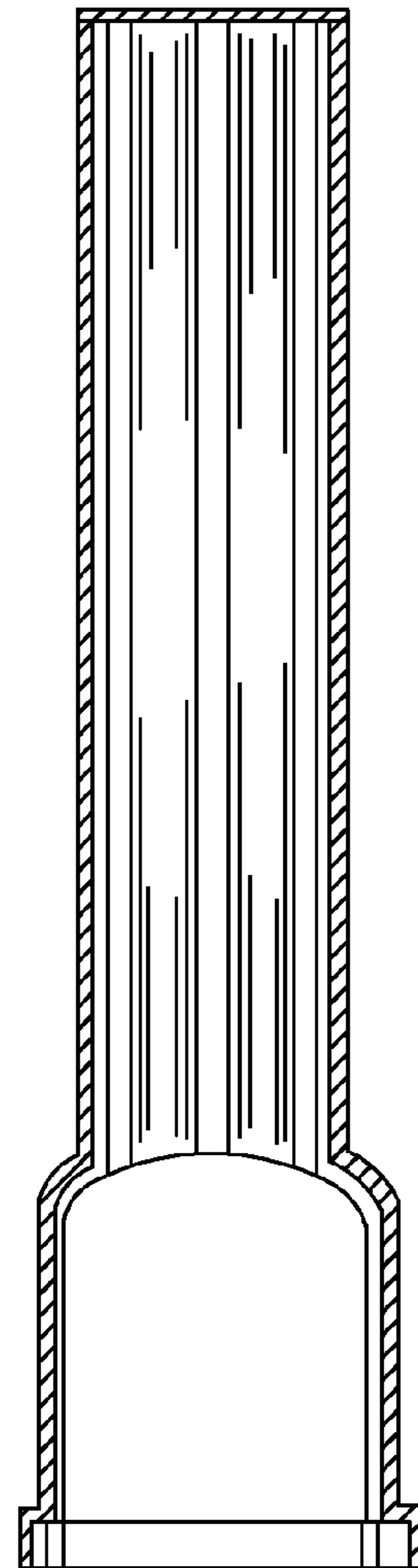
