The ornamental design for a flexible hinge food service container, as shown and described.

FIG. 5 is a left side elevation thereof;

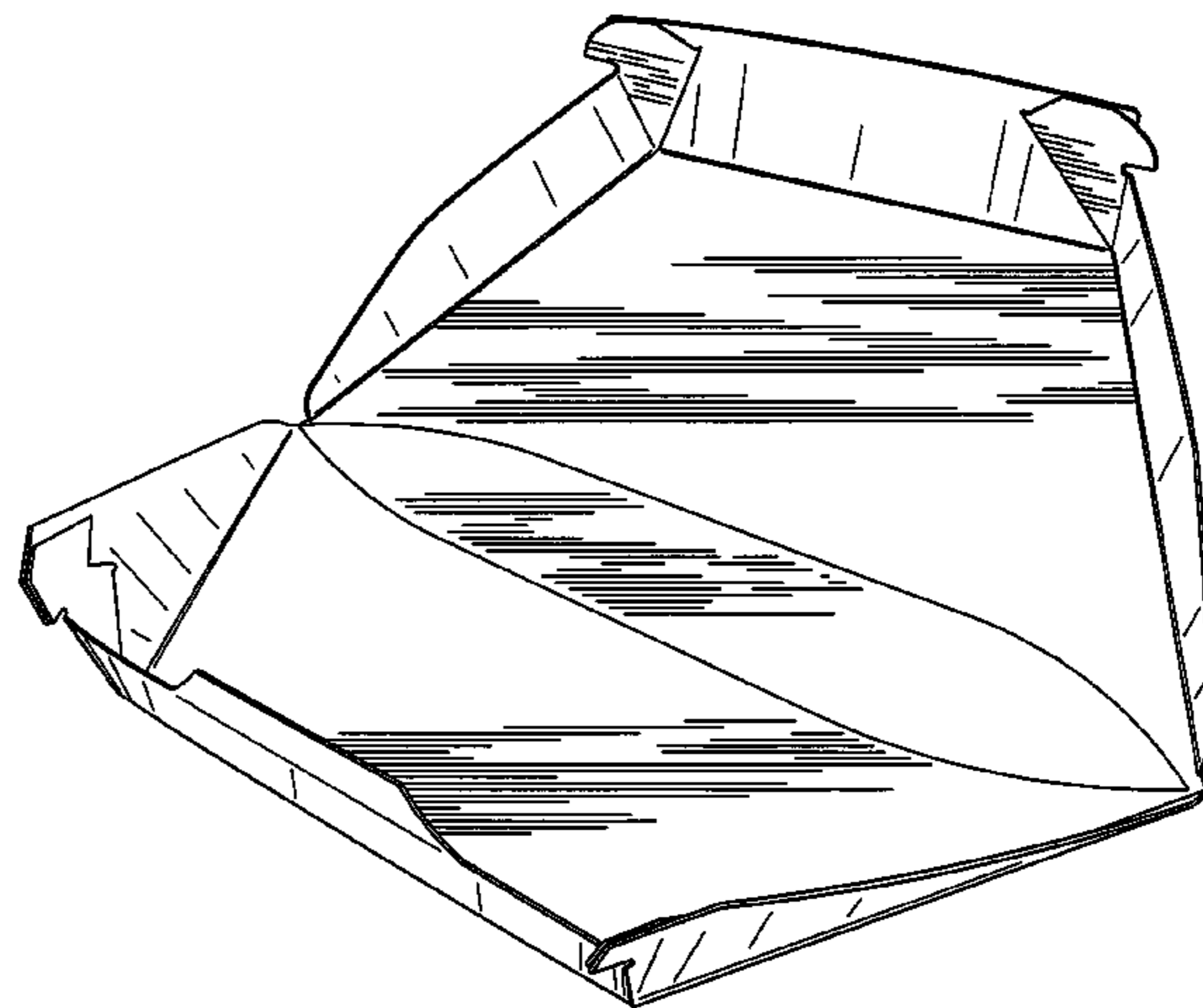
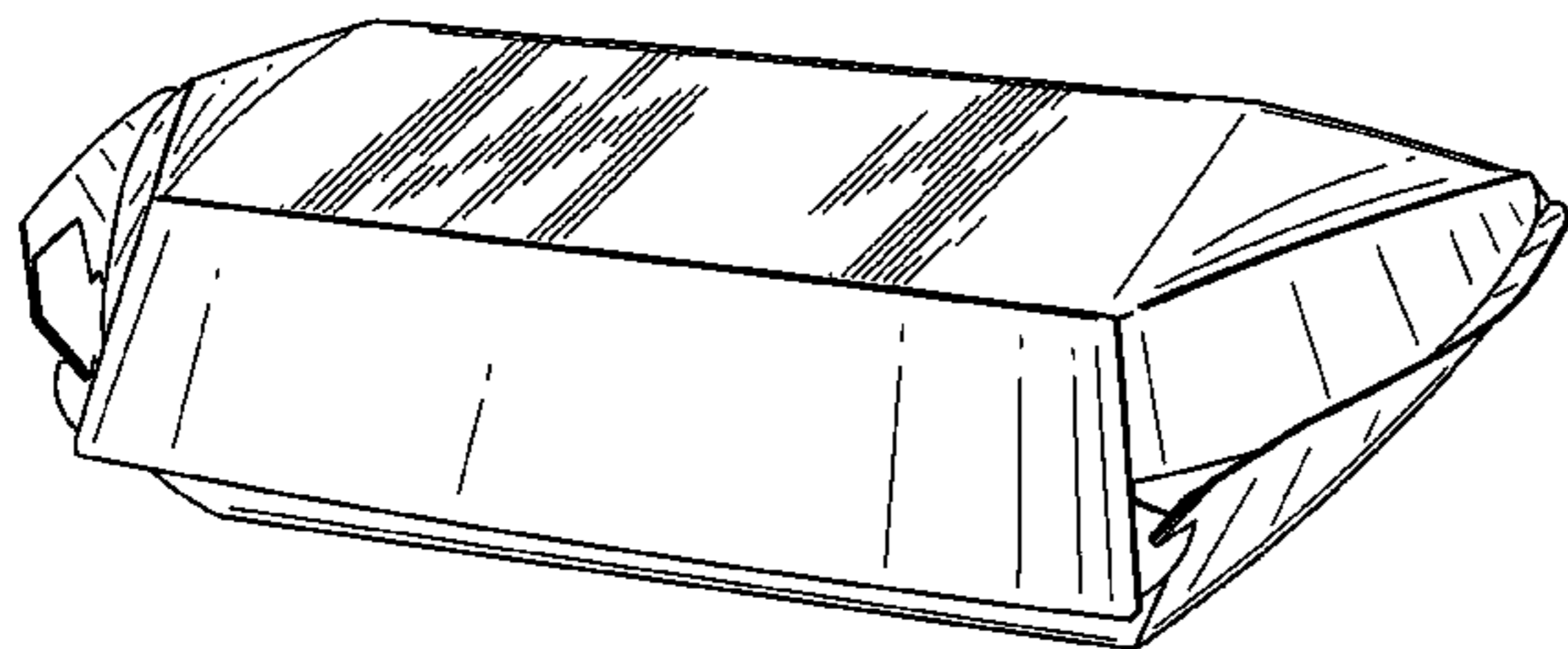
FIG. 6 is a top plan view thereof;

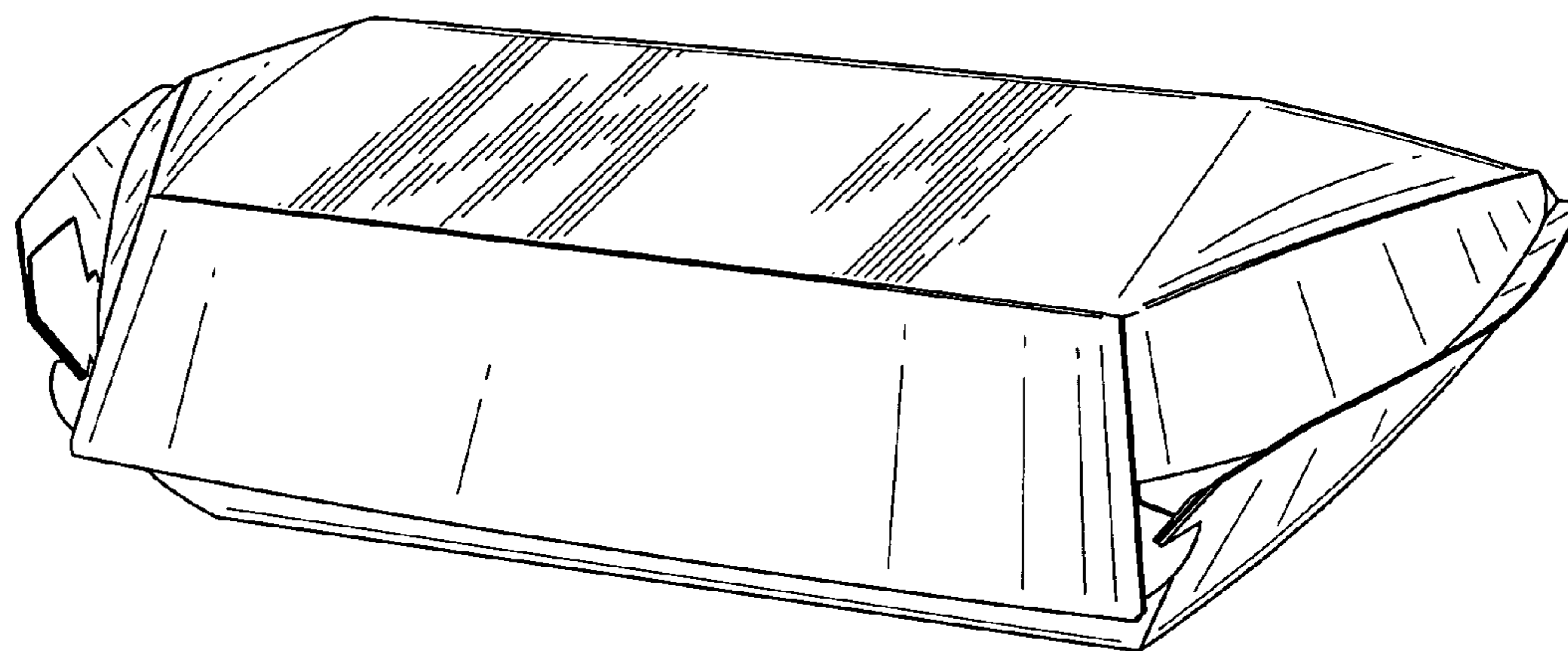

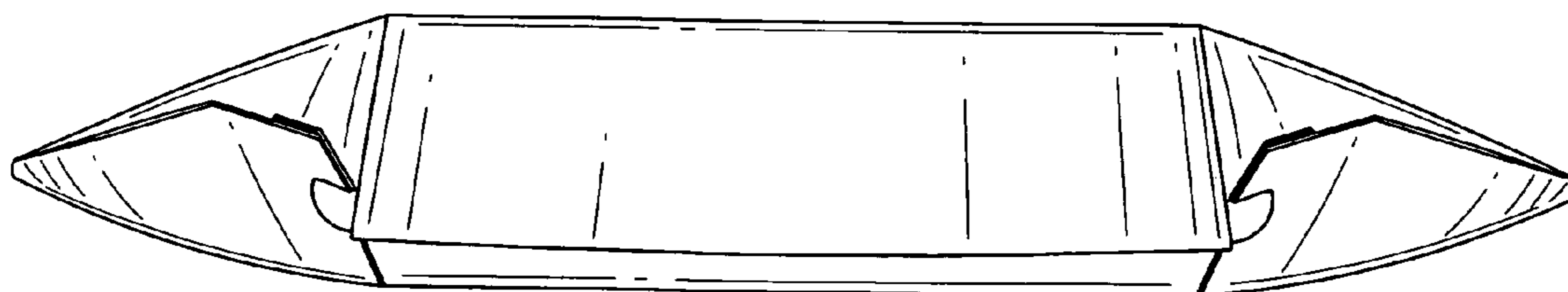

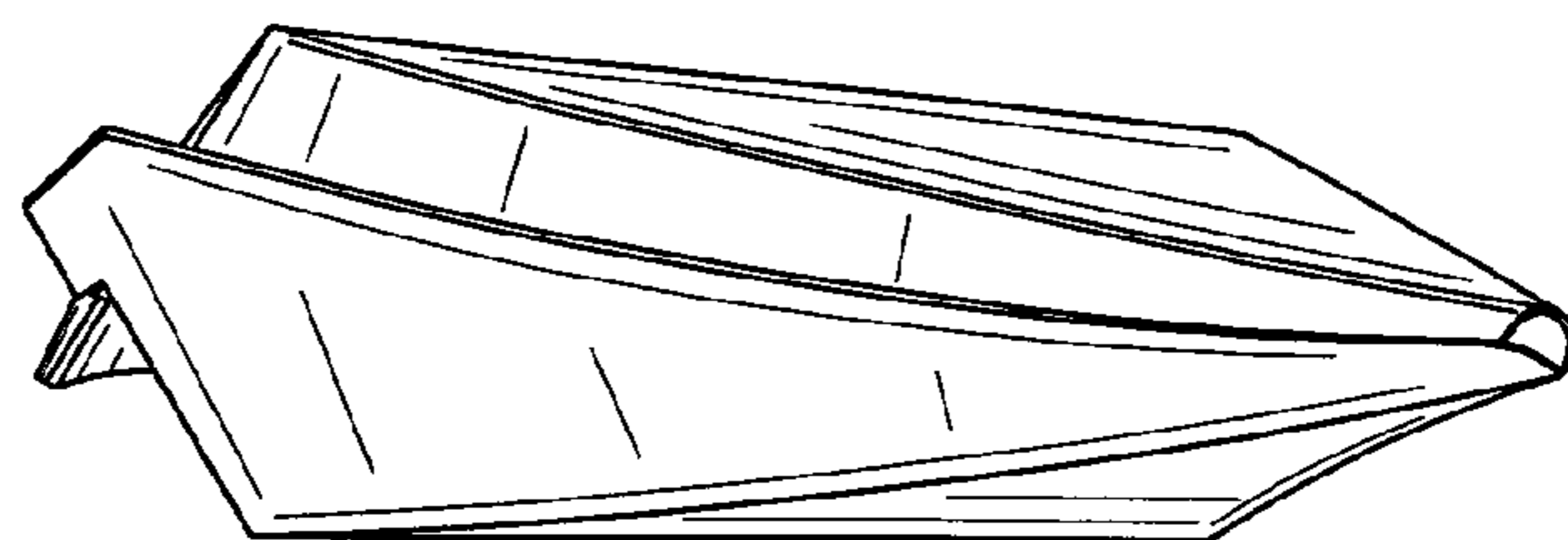

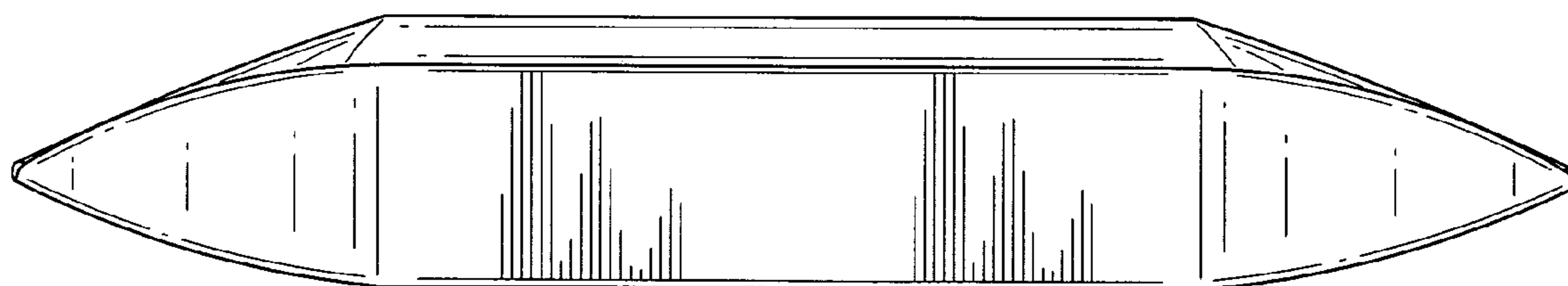

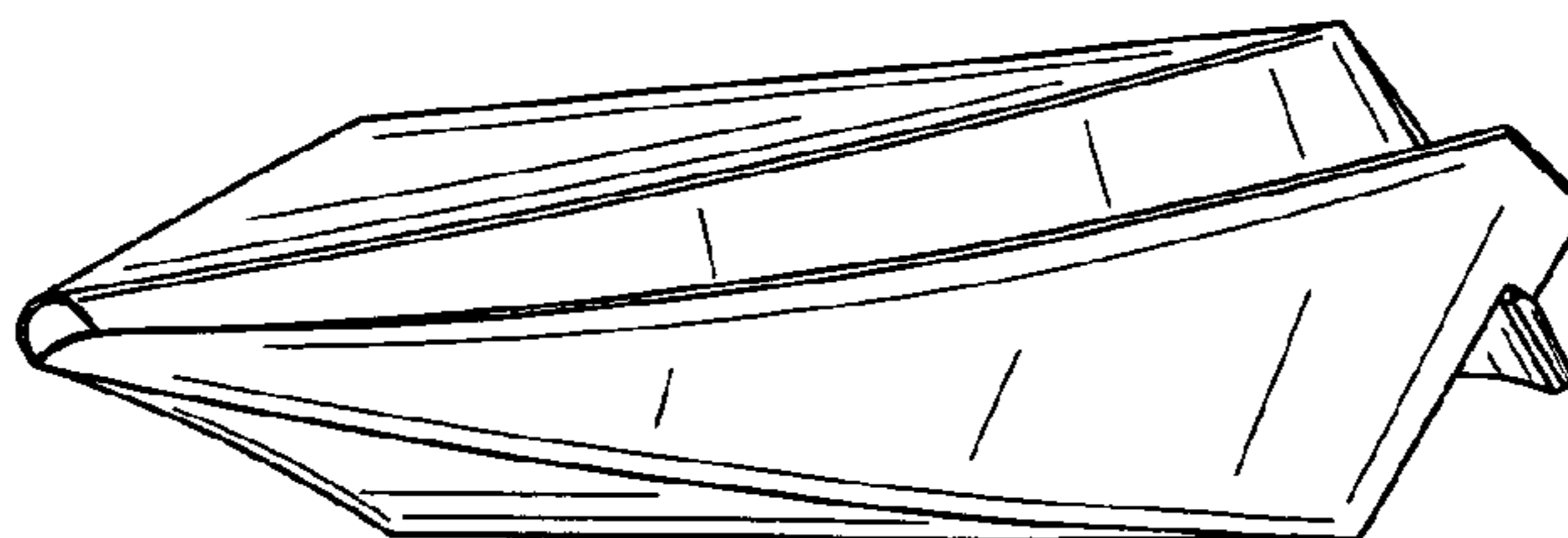

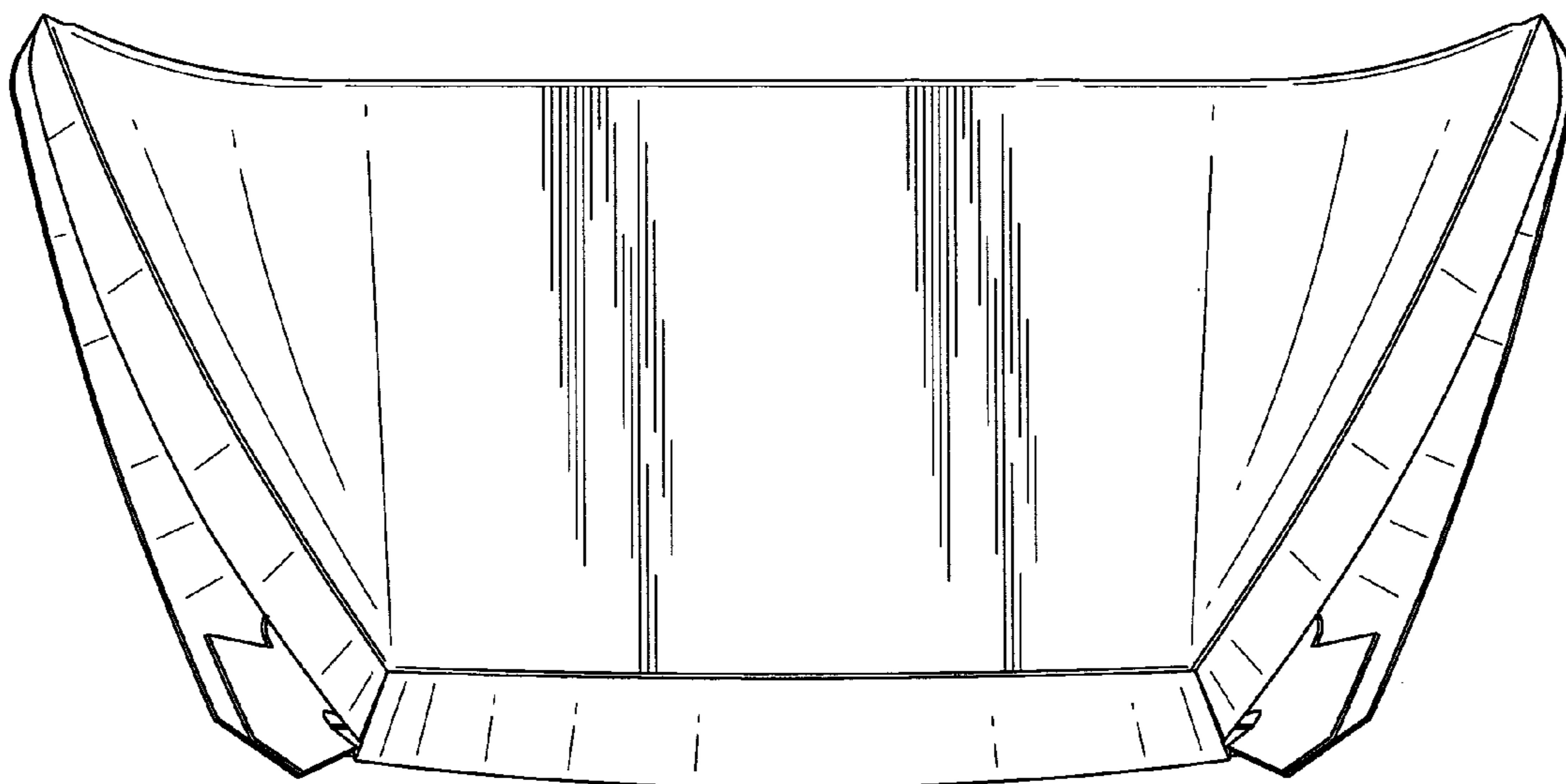

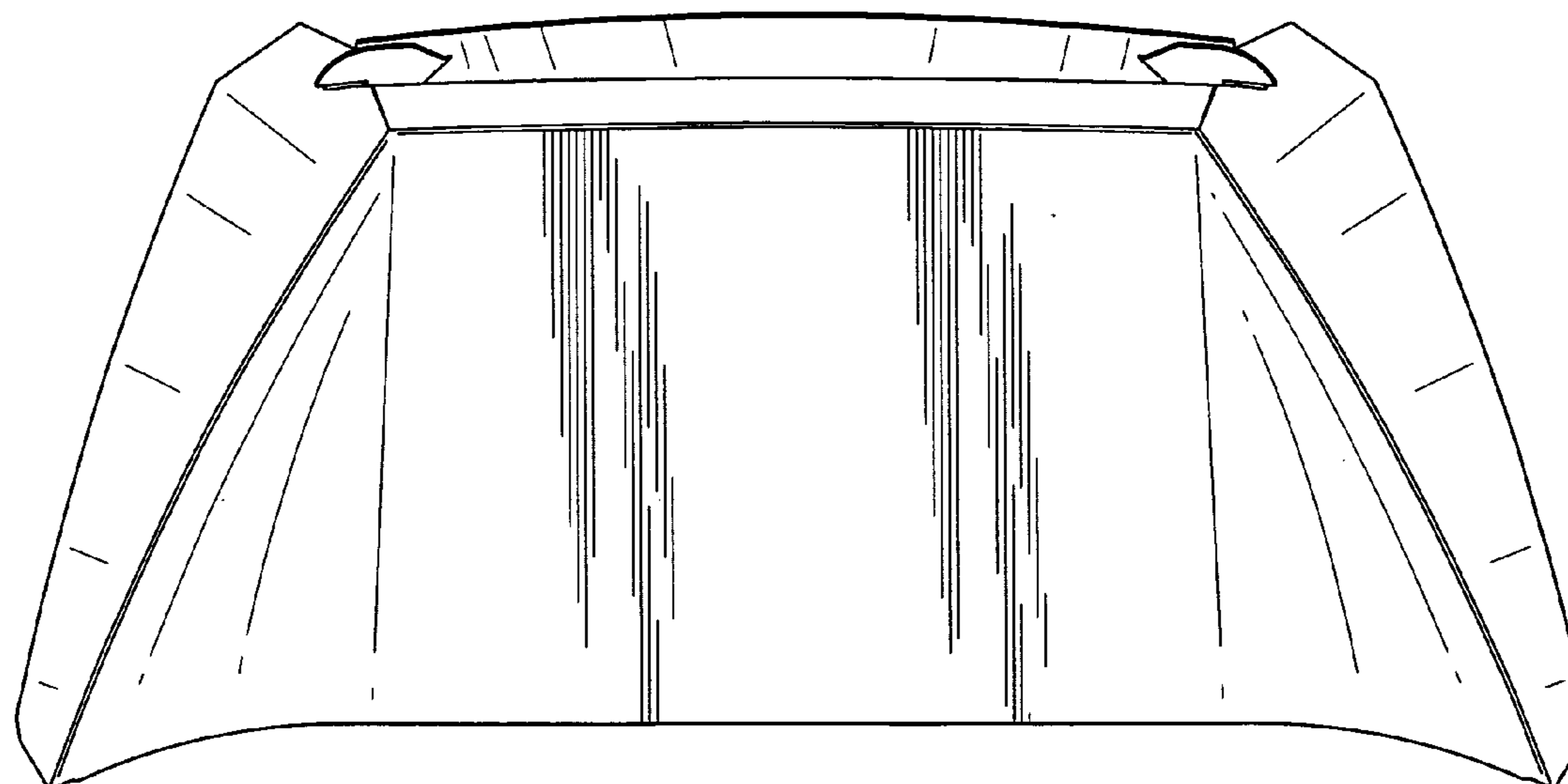

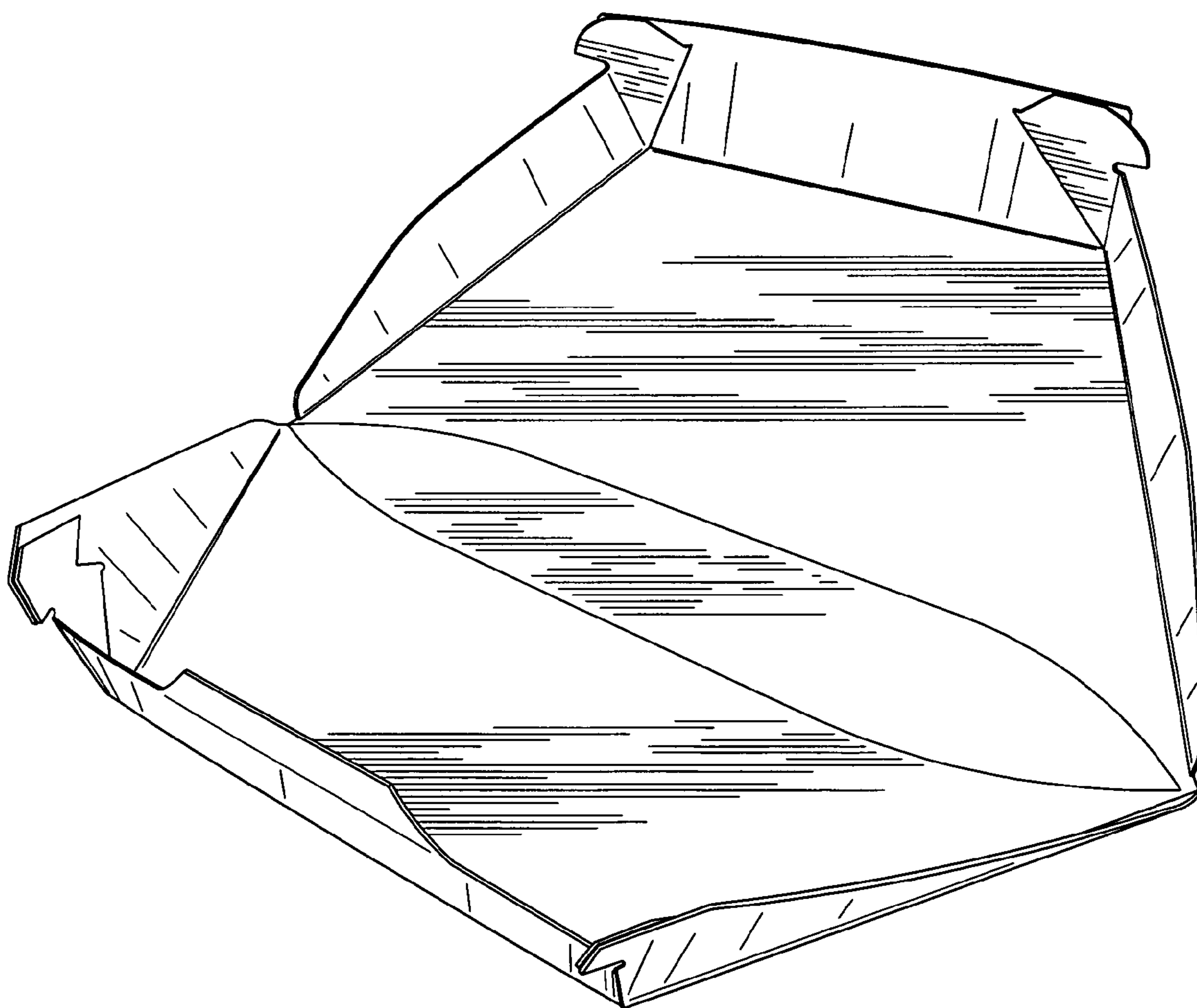

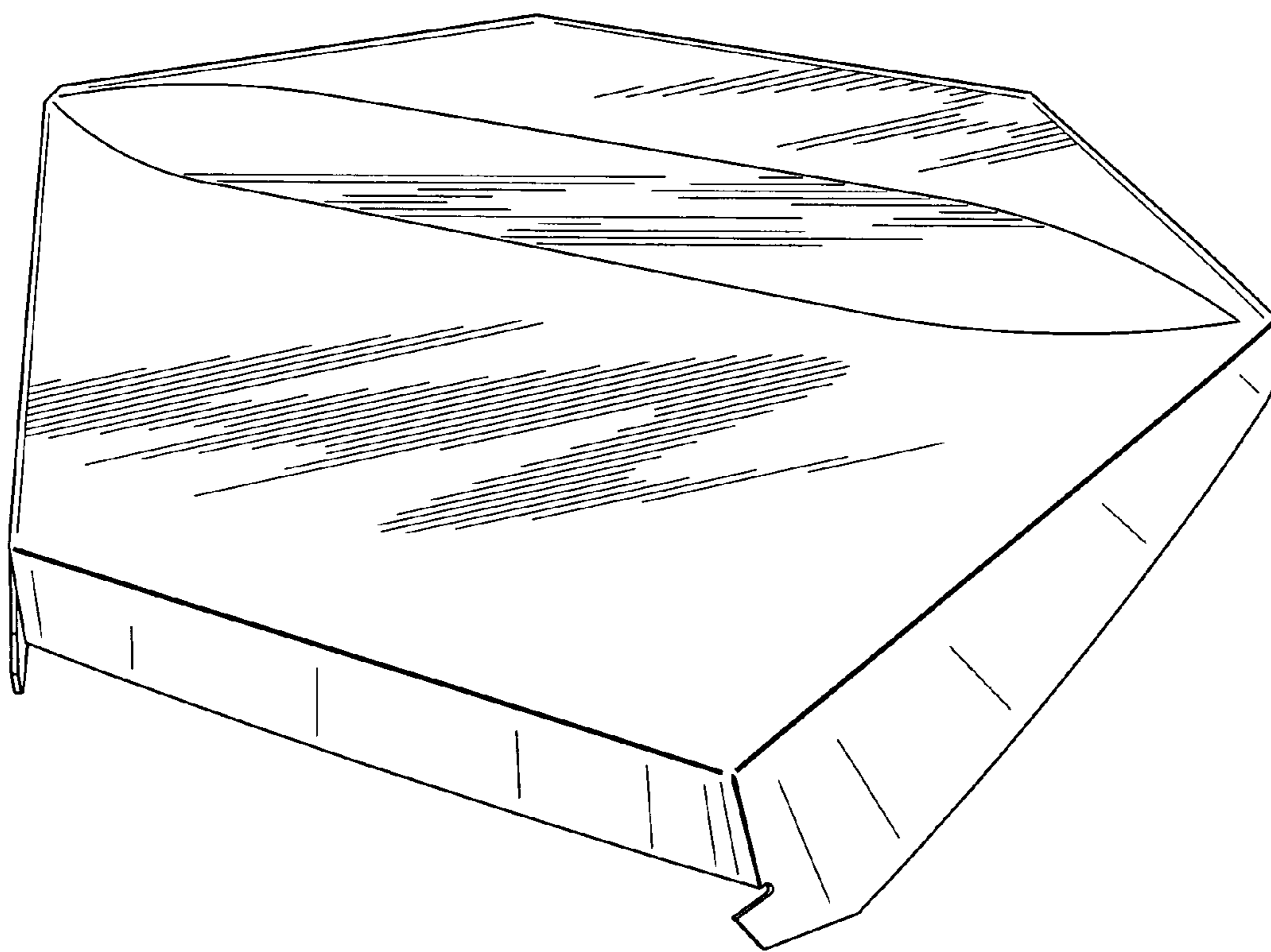
