FIG. 7 is a bottom plan view thereof.

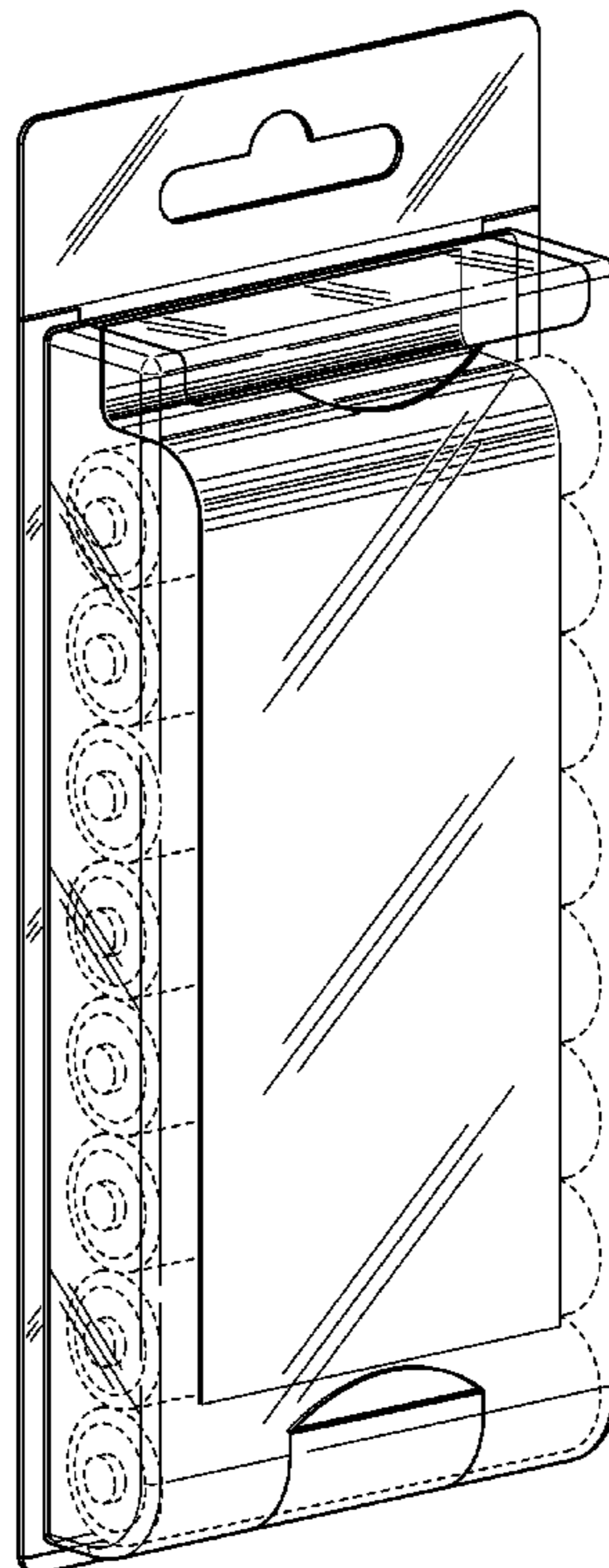
The broken lines are included for the purpose of illustrating the contents of the dispenser for batteries that form no part of the claimed design.

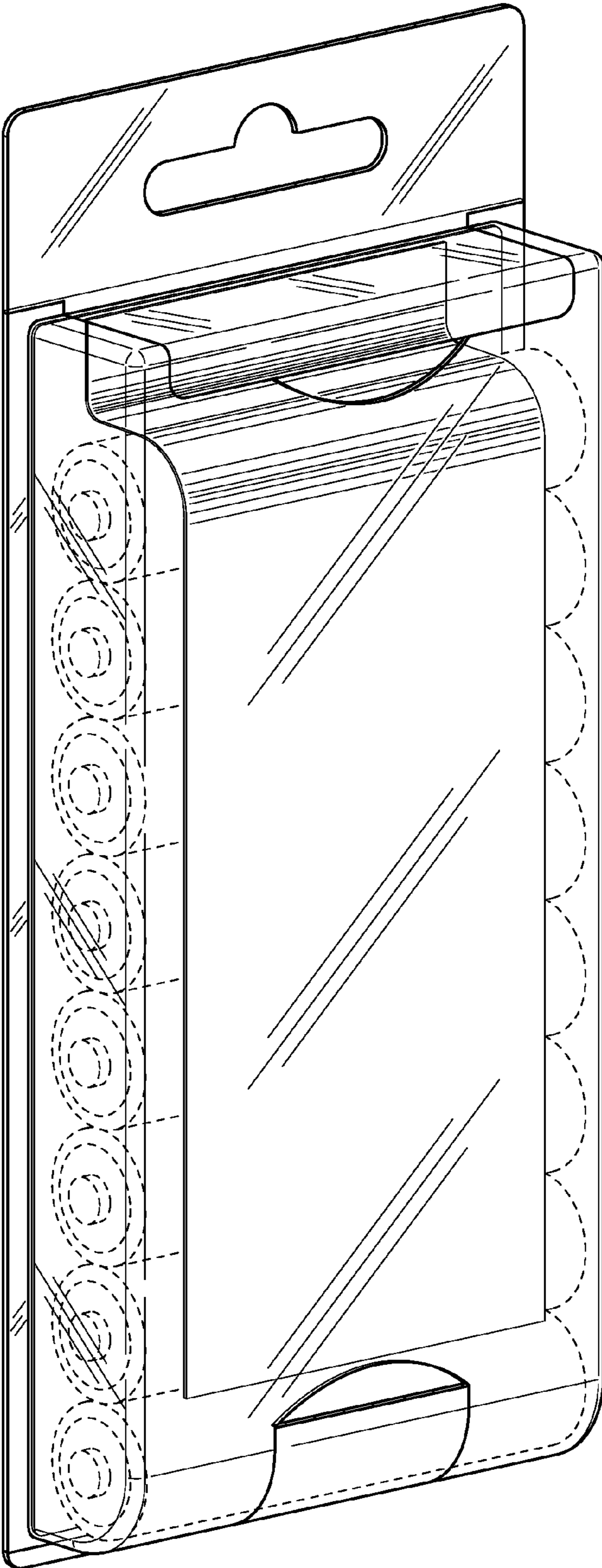

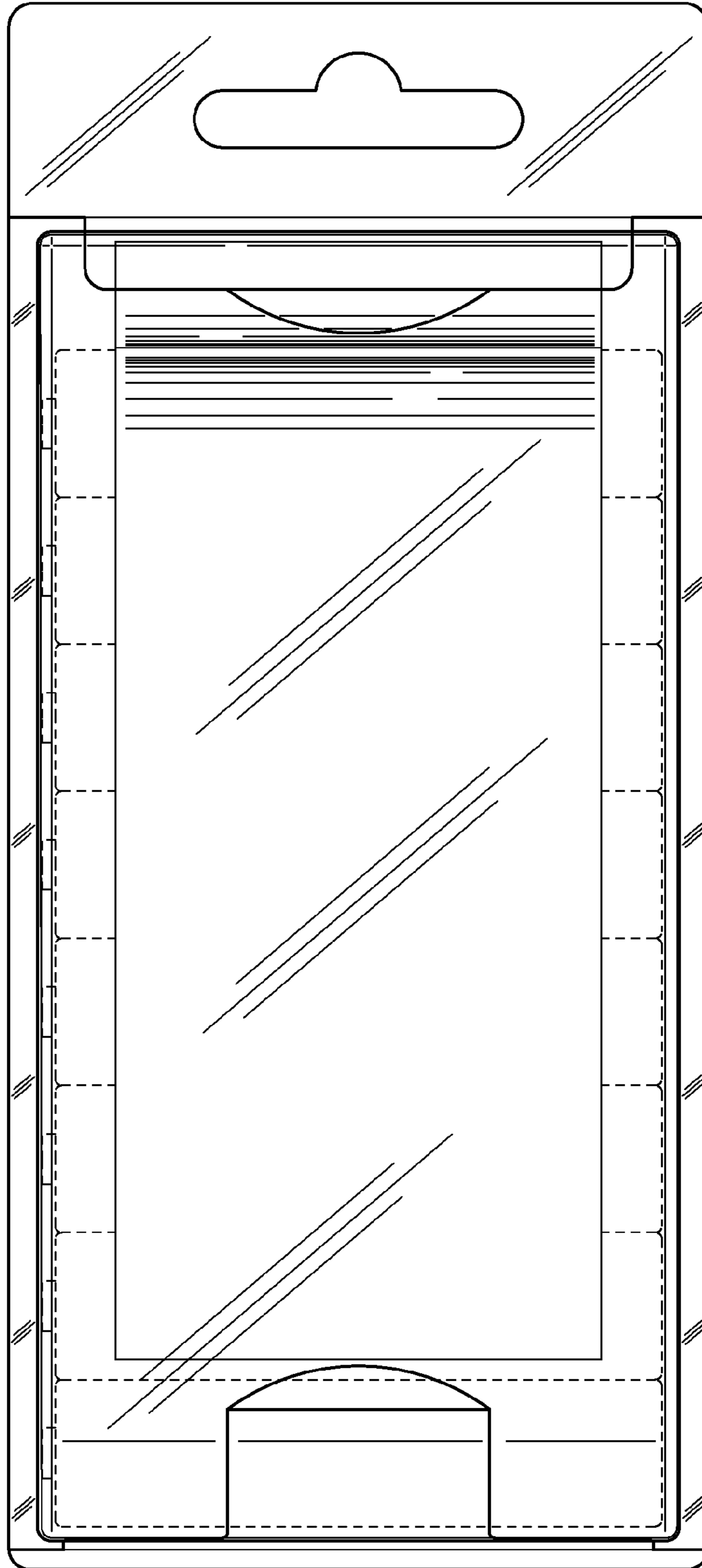

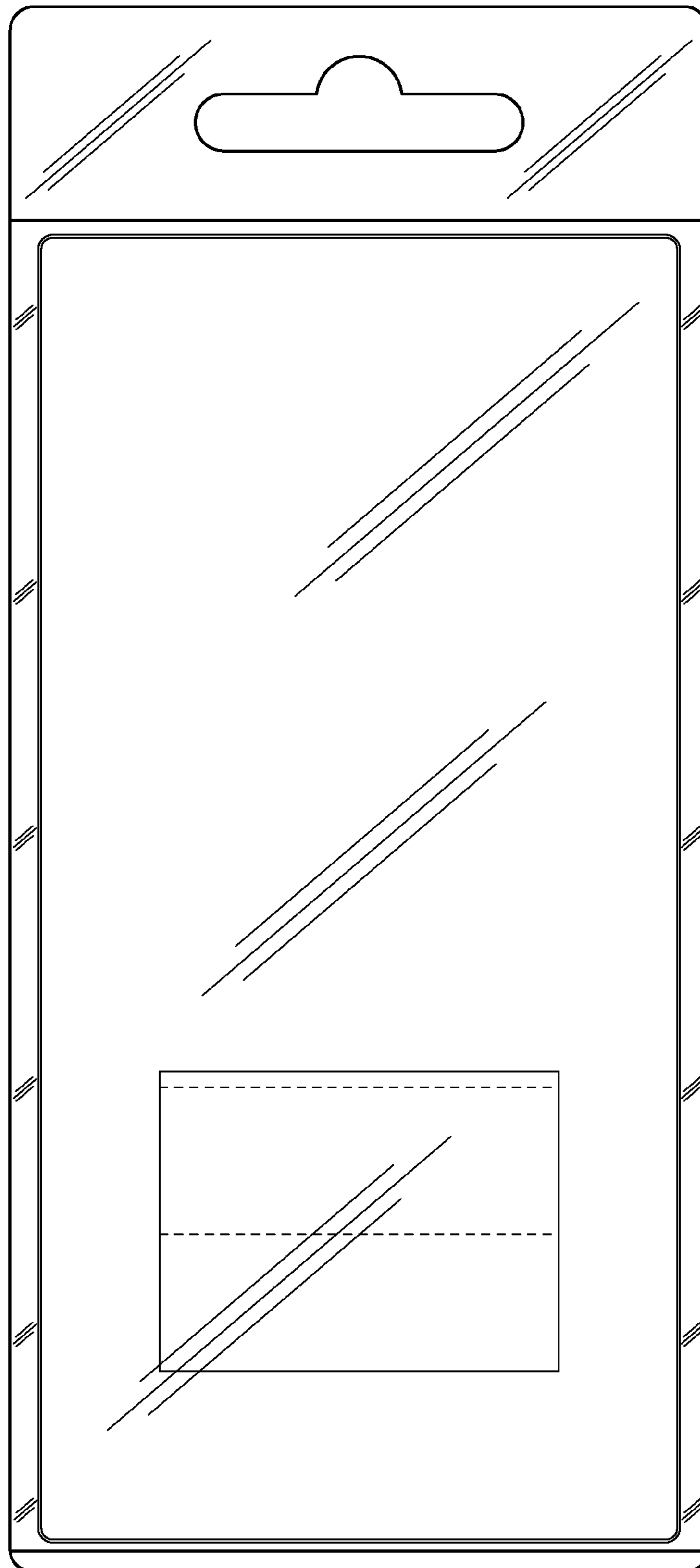

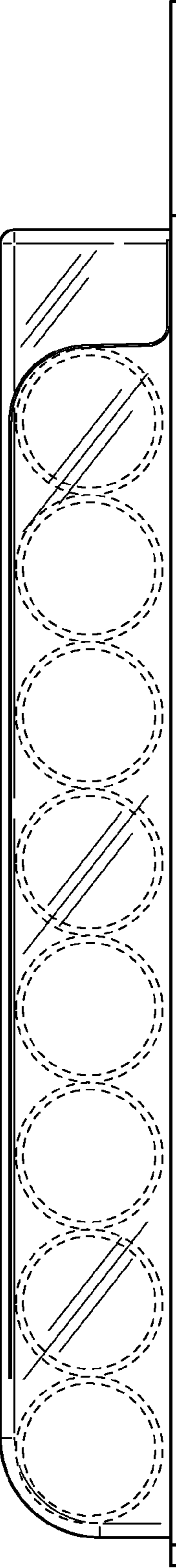

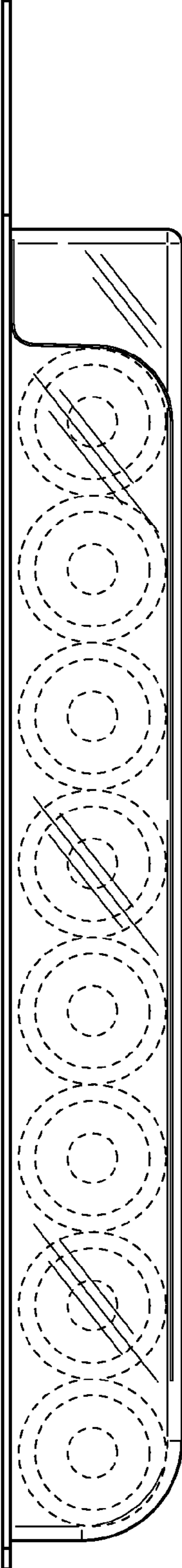

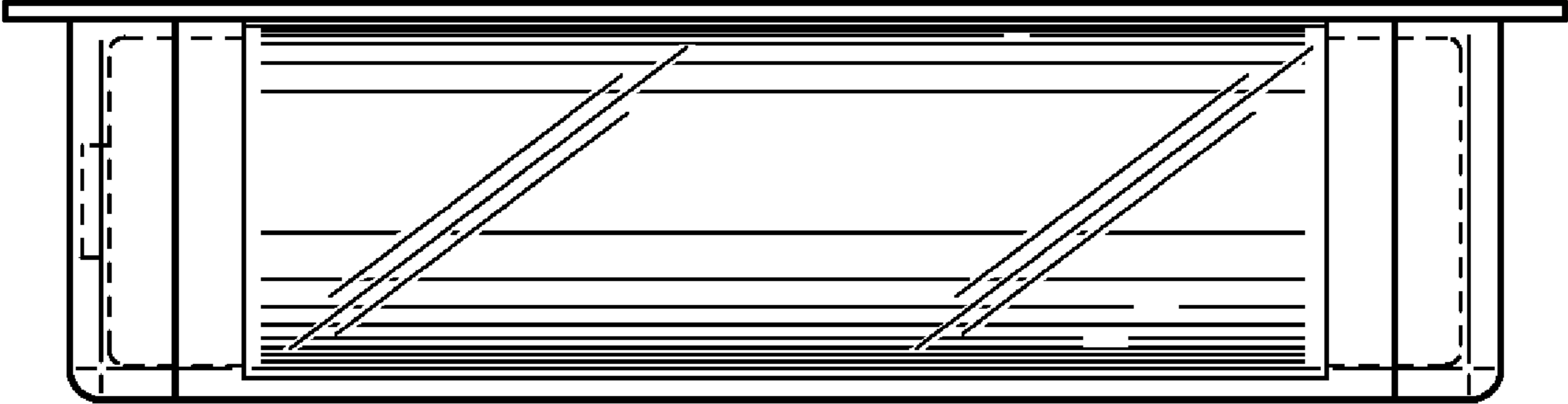

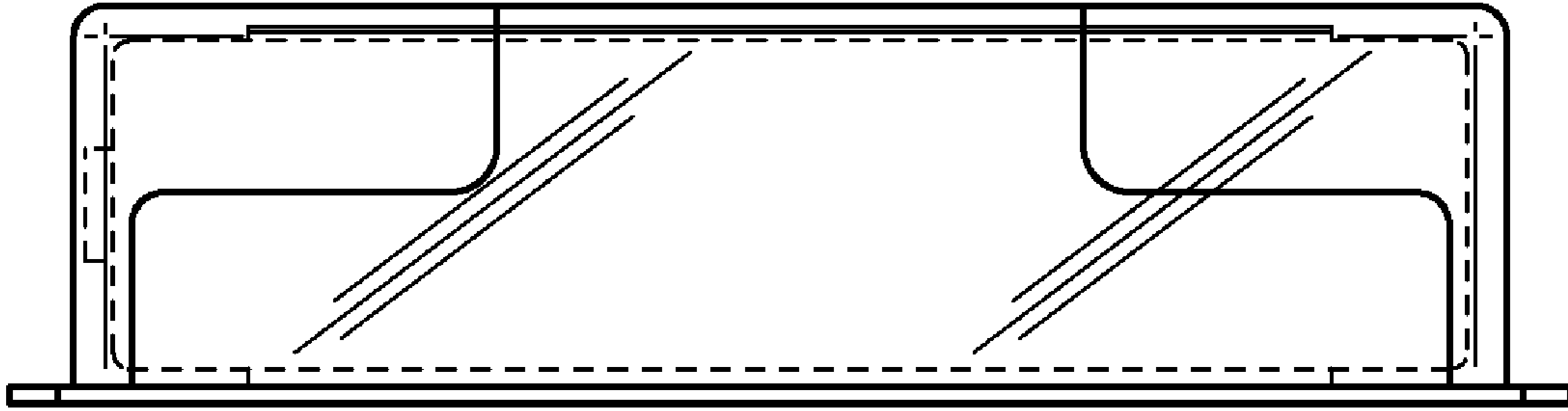
