FIG. 2 is a side view of the right side of the watch

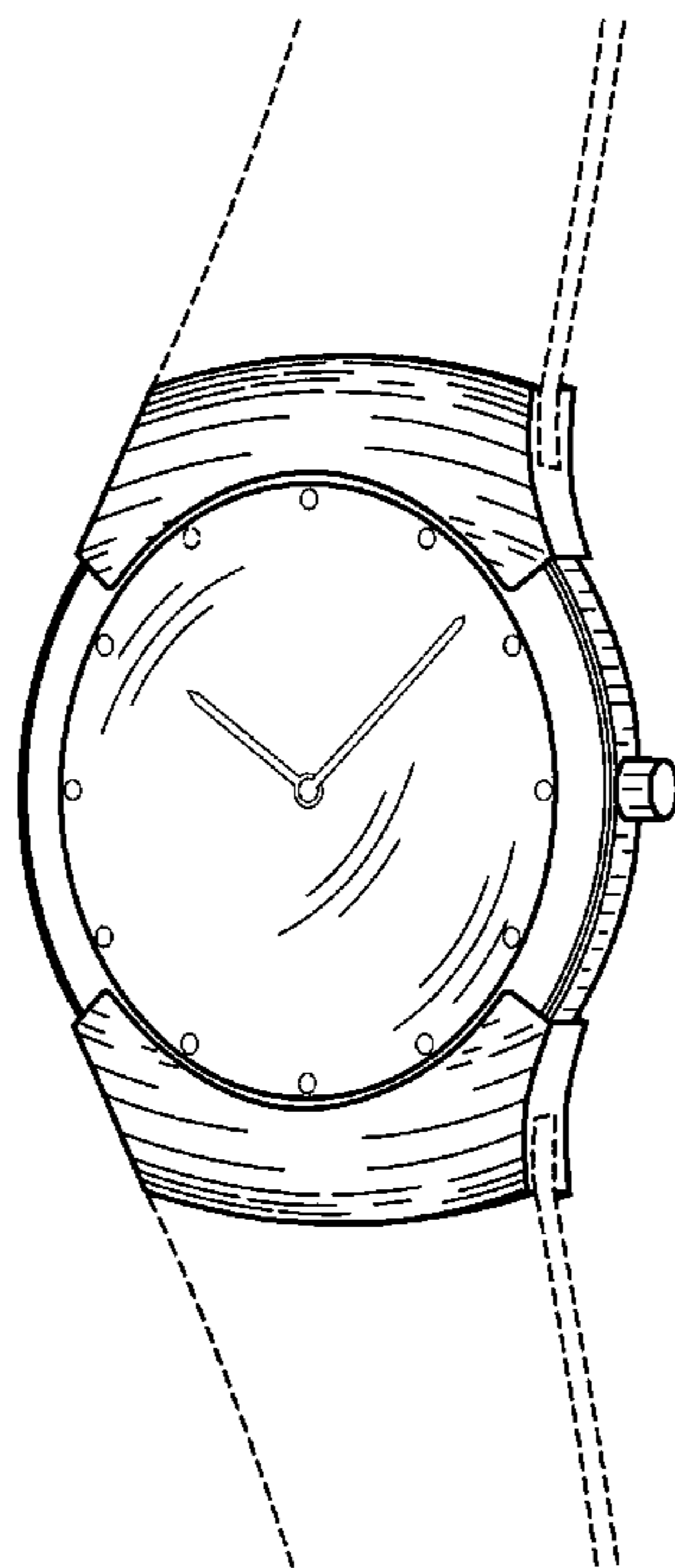
FIG. 3 is a side view of the left side of the watch

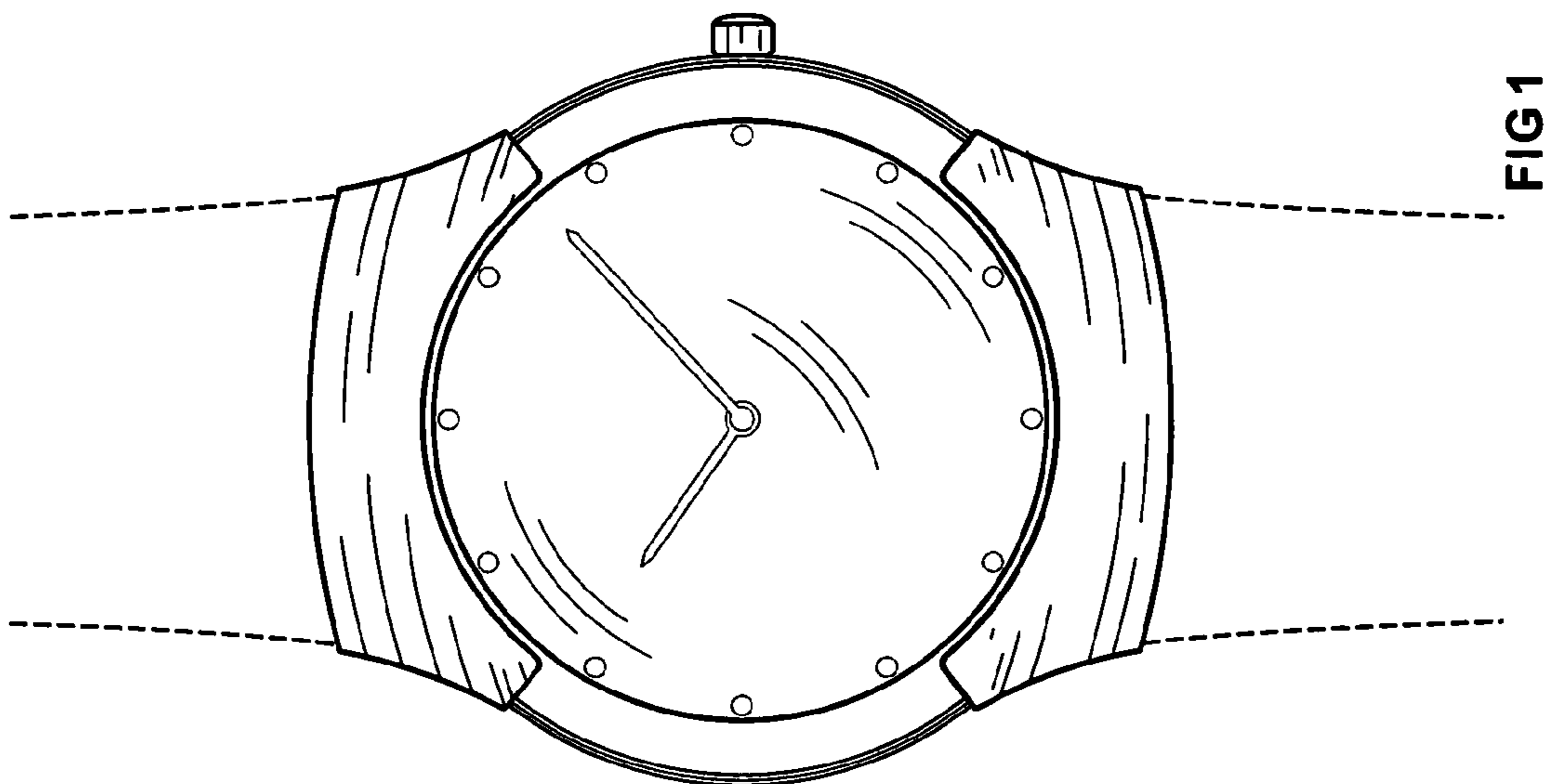
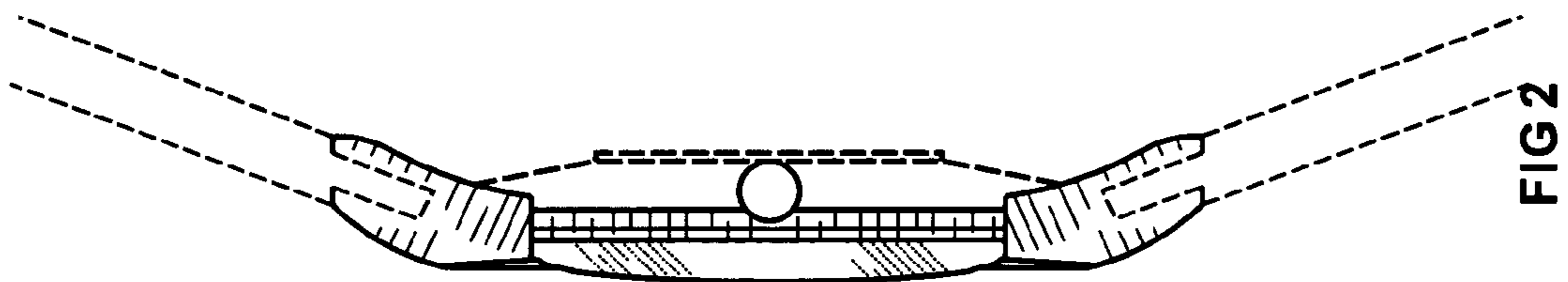
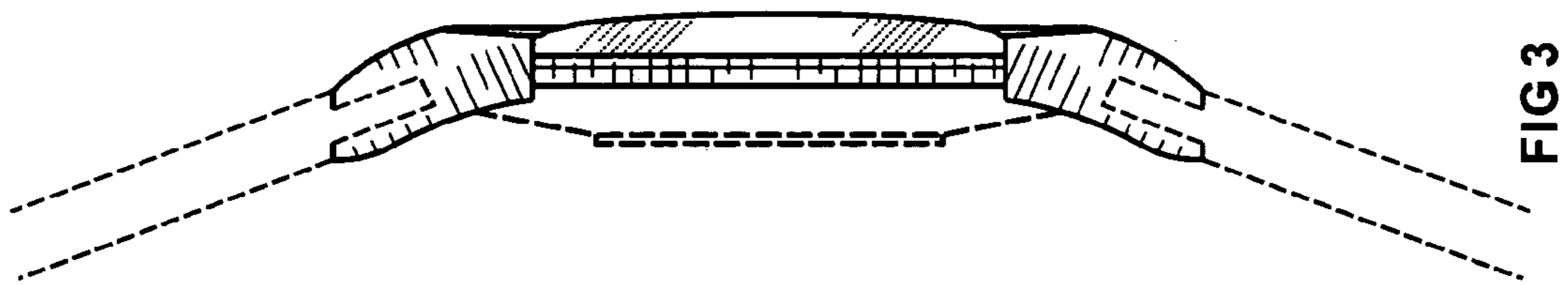
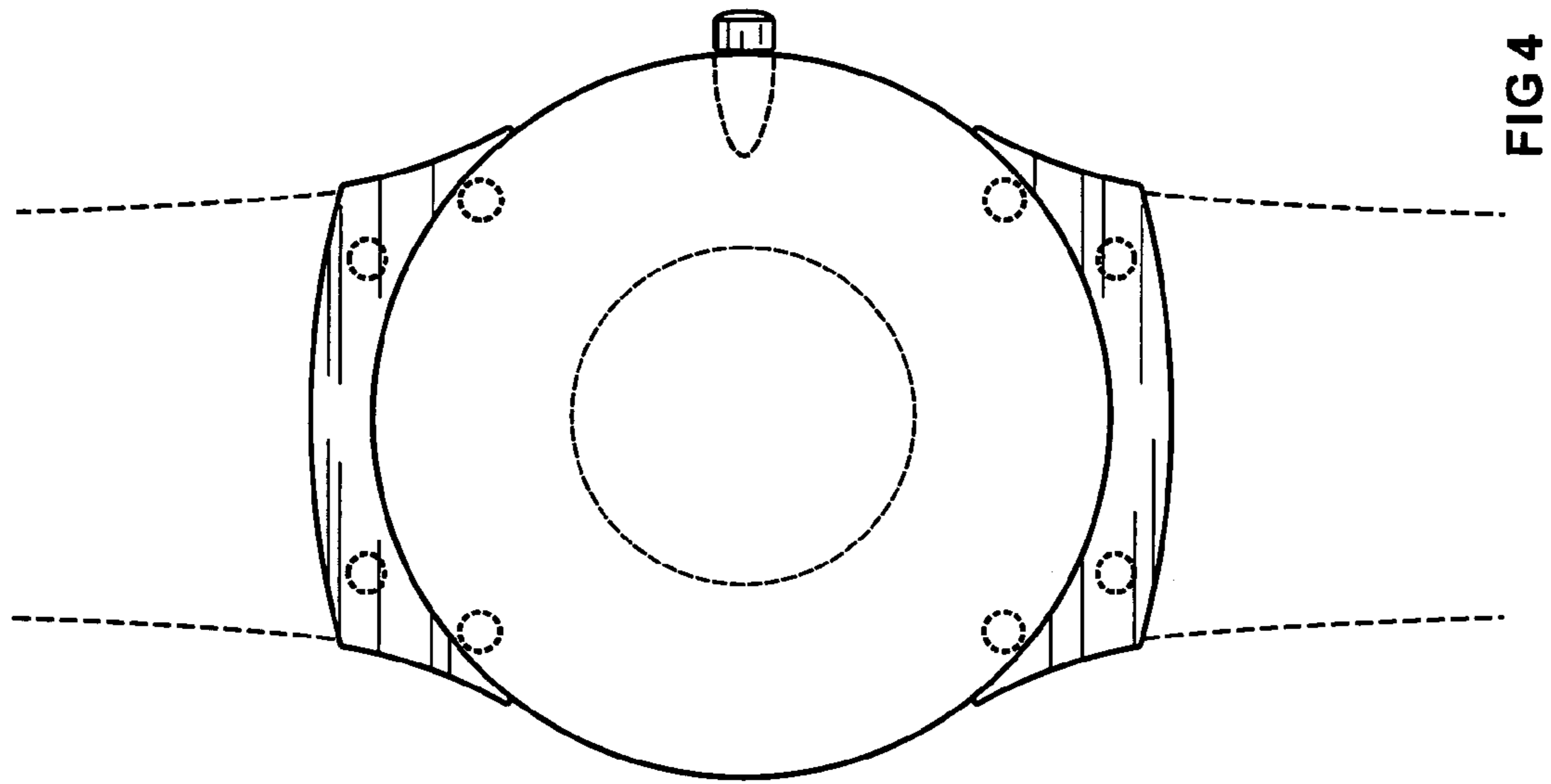
FIG. 4 is a back or bottom view of the watch

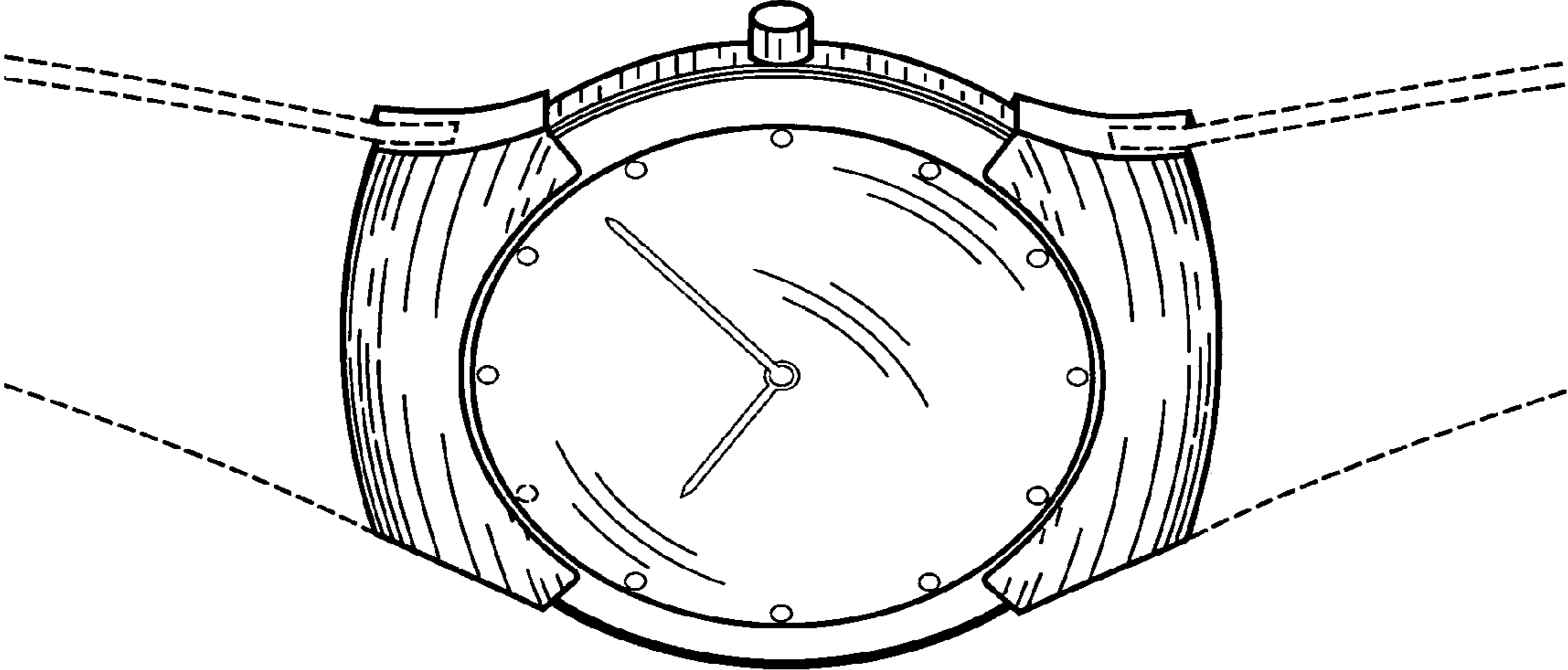

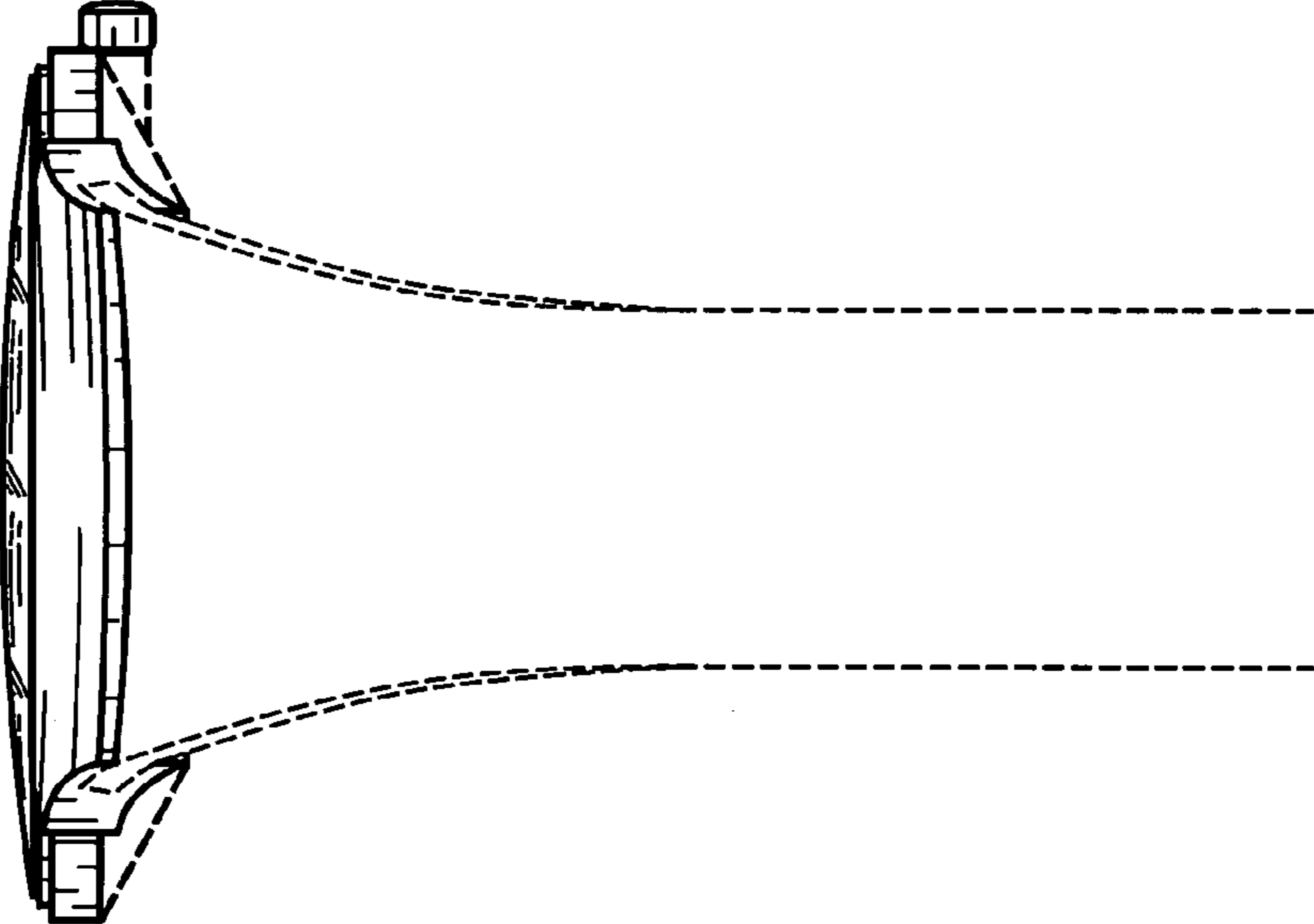
