**DESCRIPTION**

FIG. 5 is a front elevational view of the vehicle and/or replica thereof in accordance with our new design;

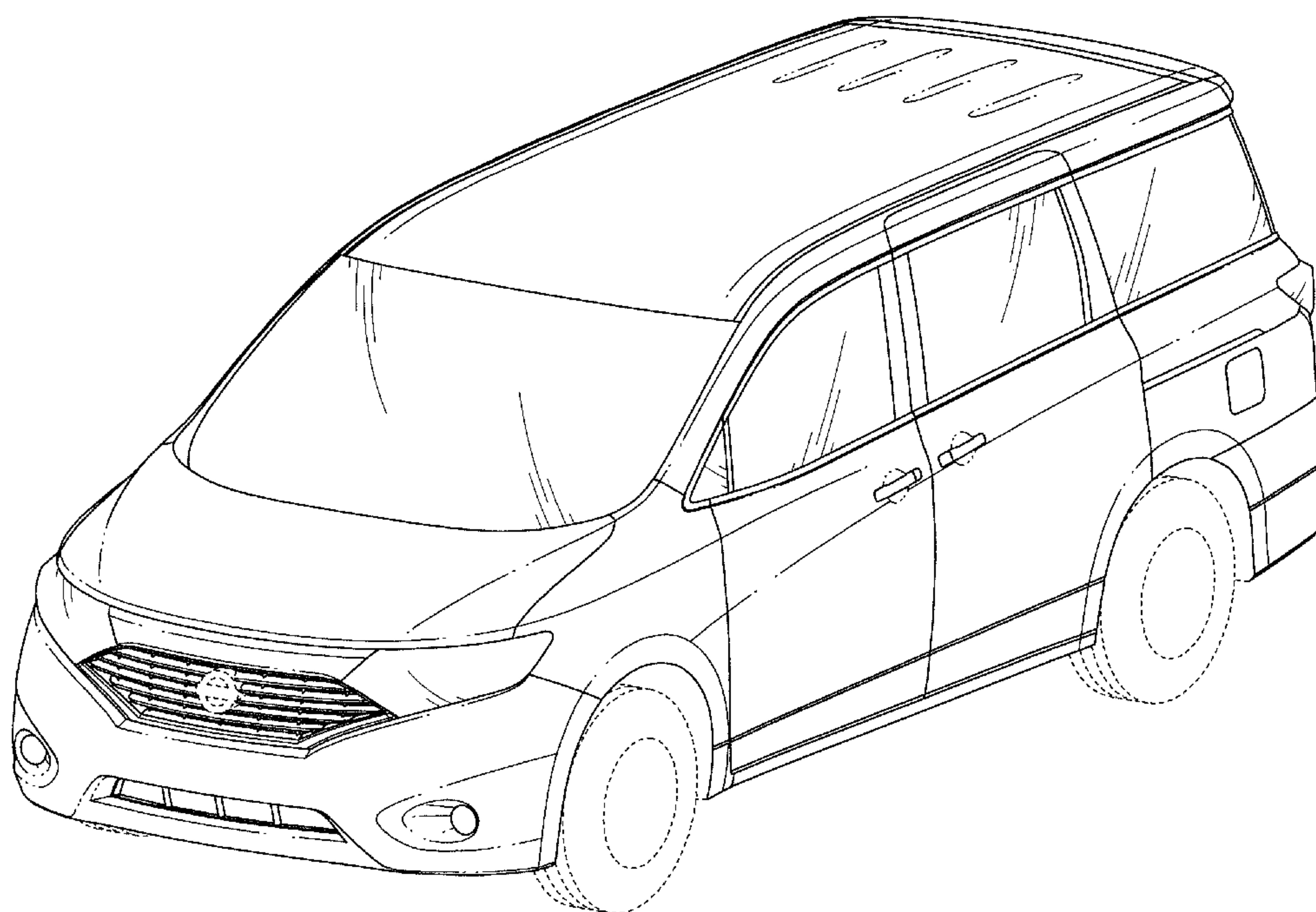
FIG. 6 is a rear elevational view of the vehicle and/or replica thereof in accordance with our new design;

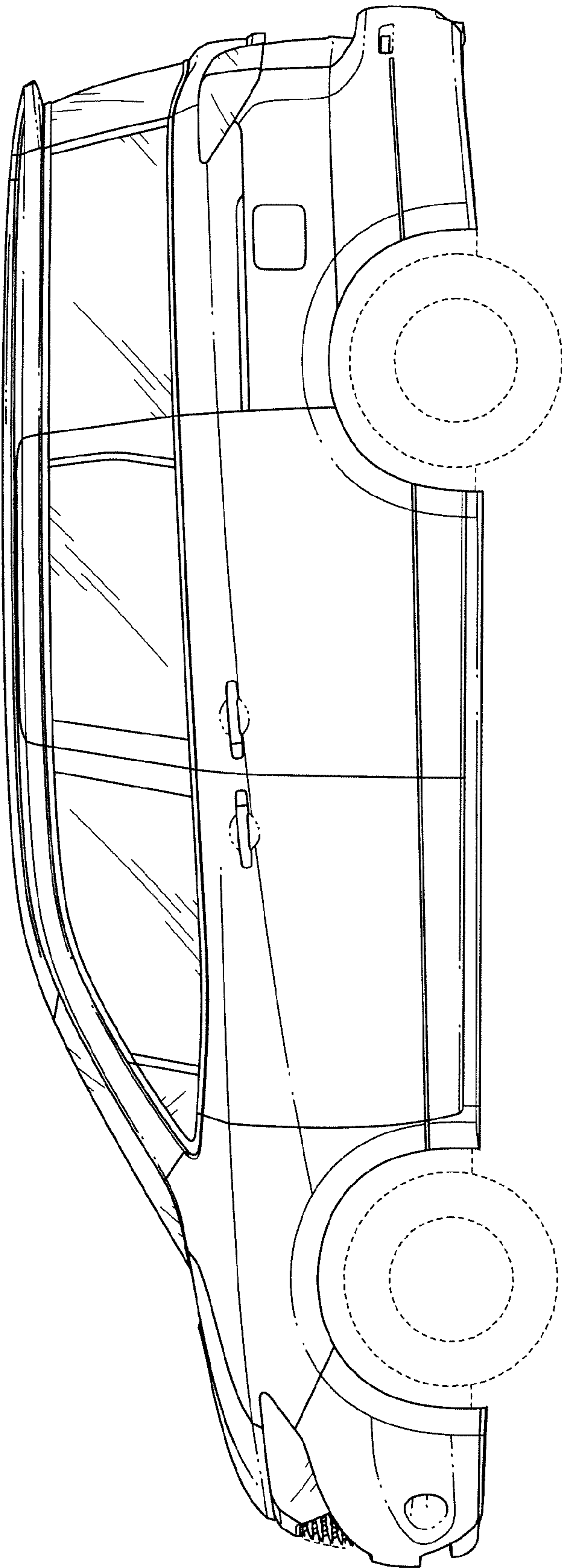

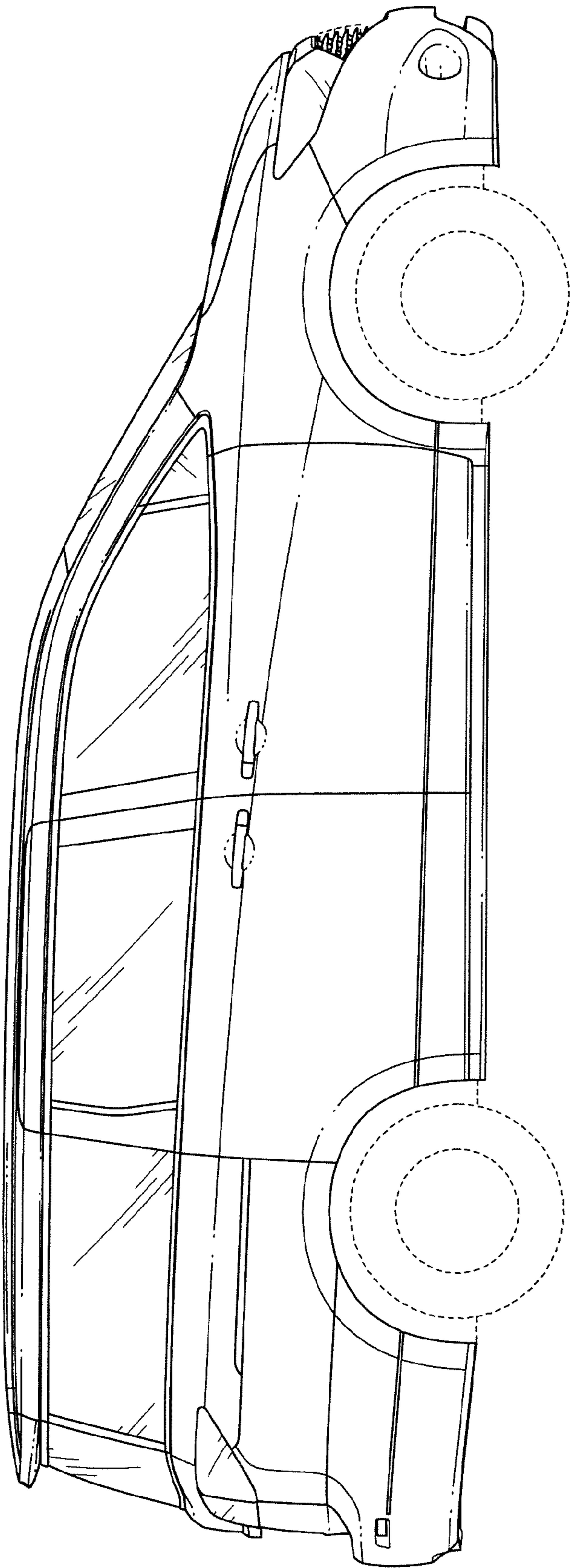

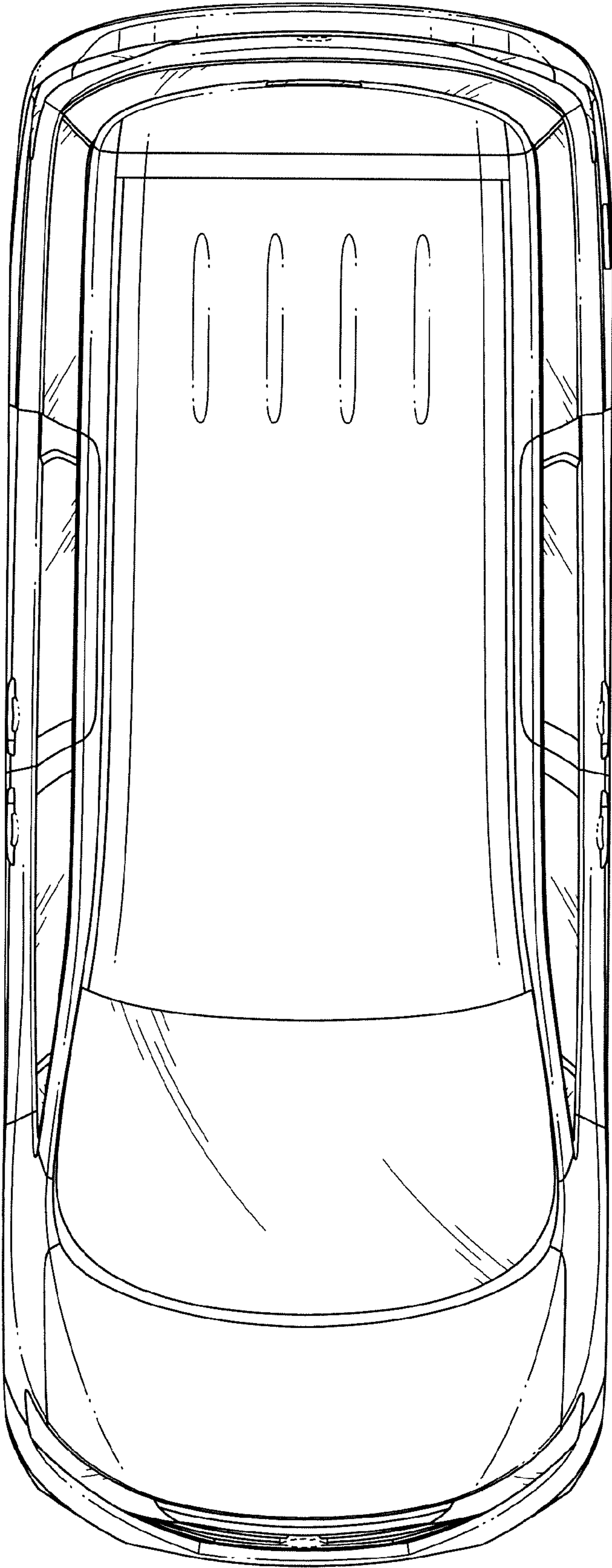

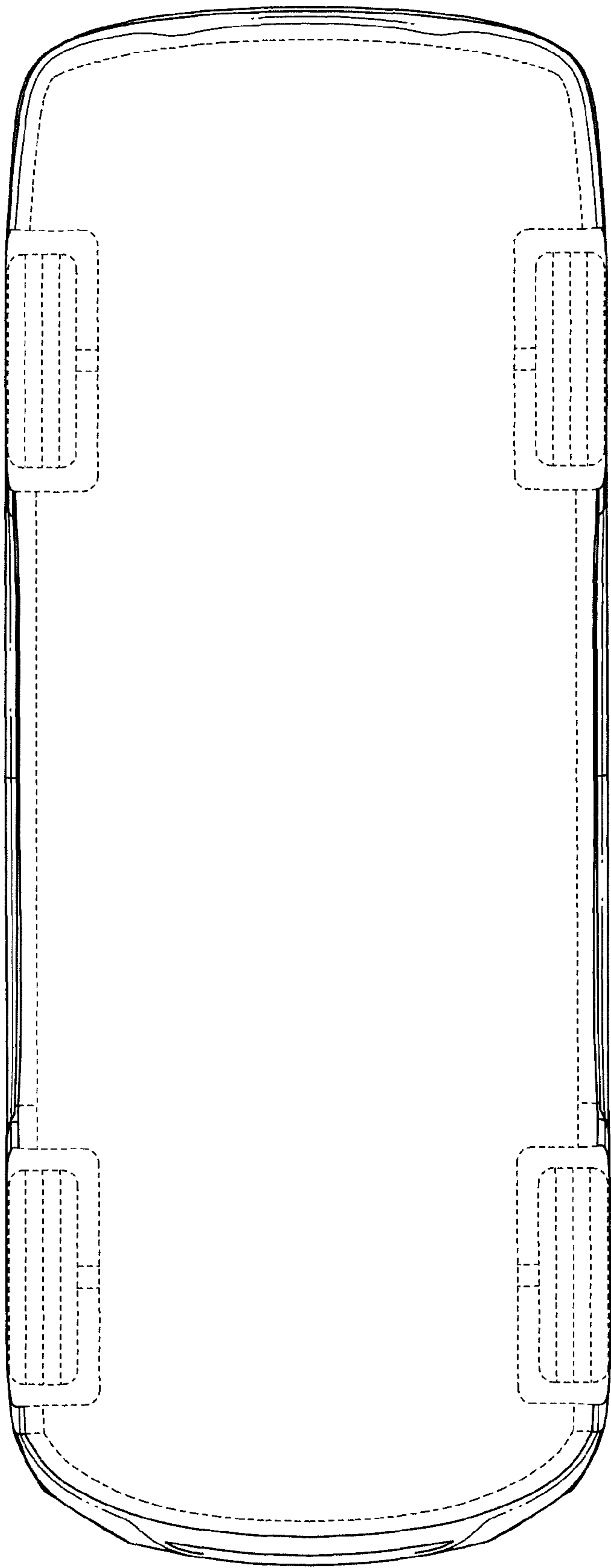

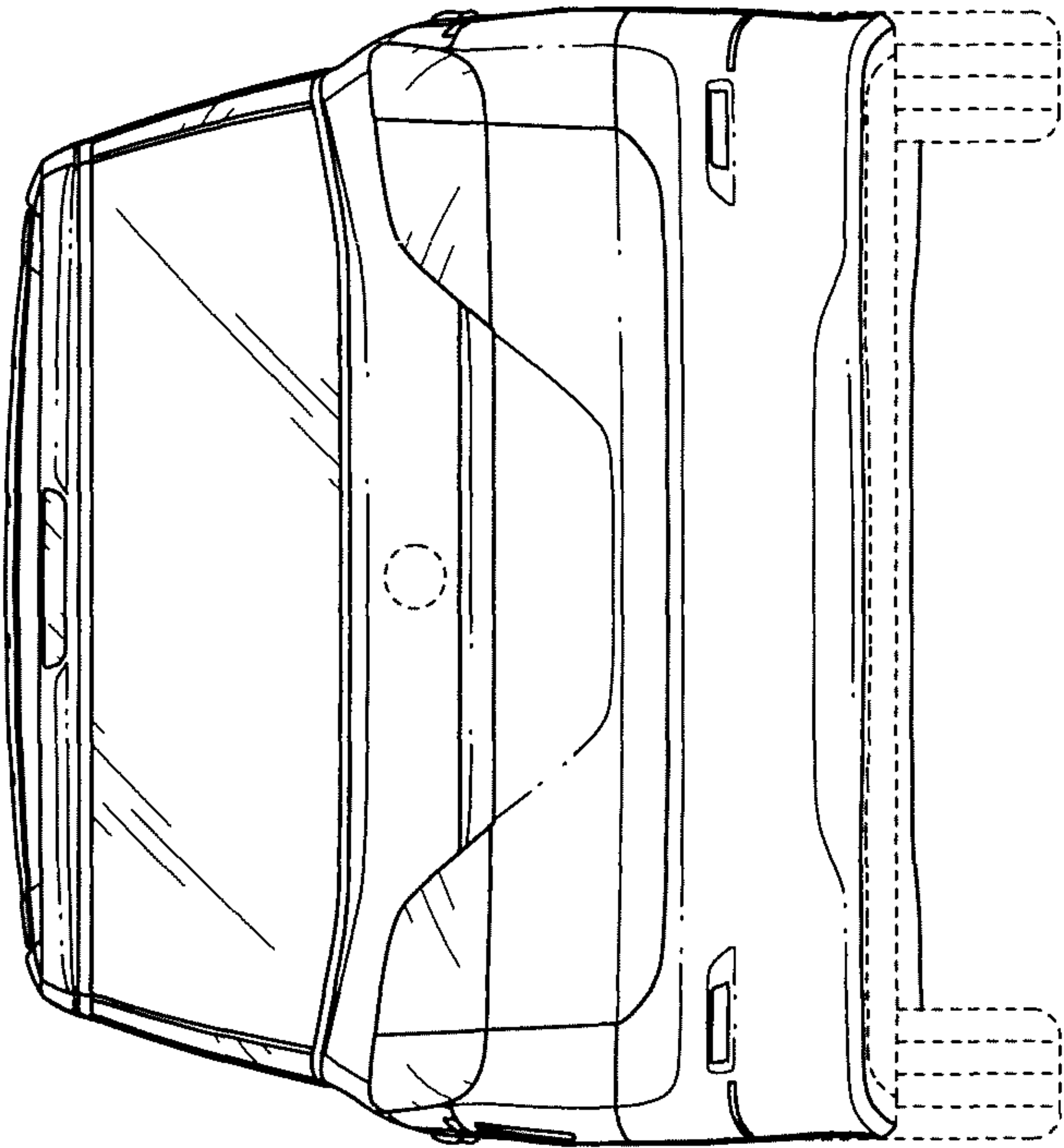

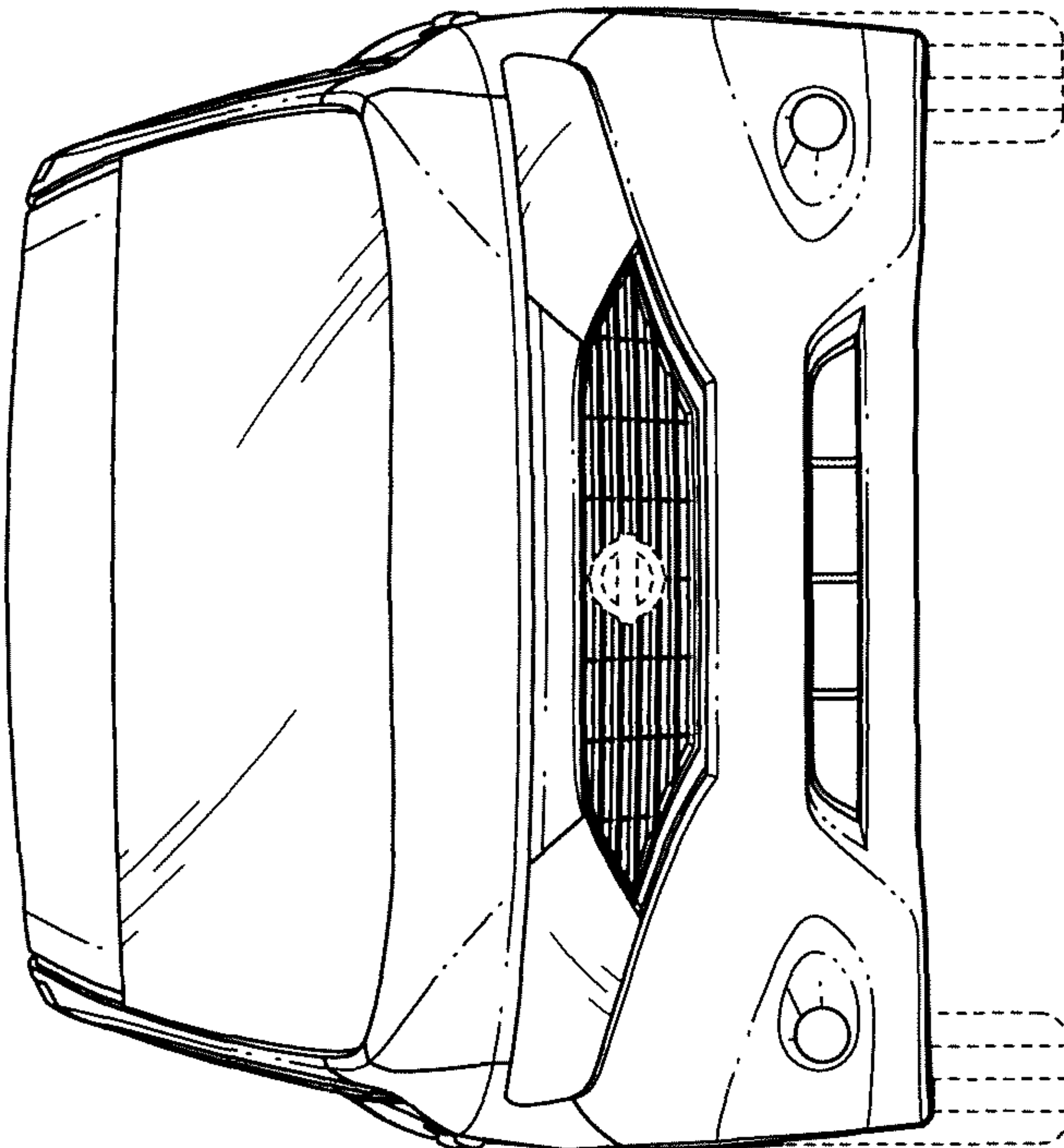

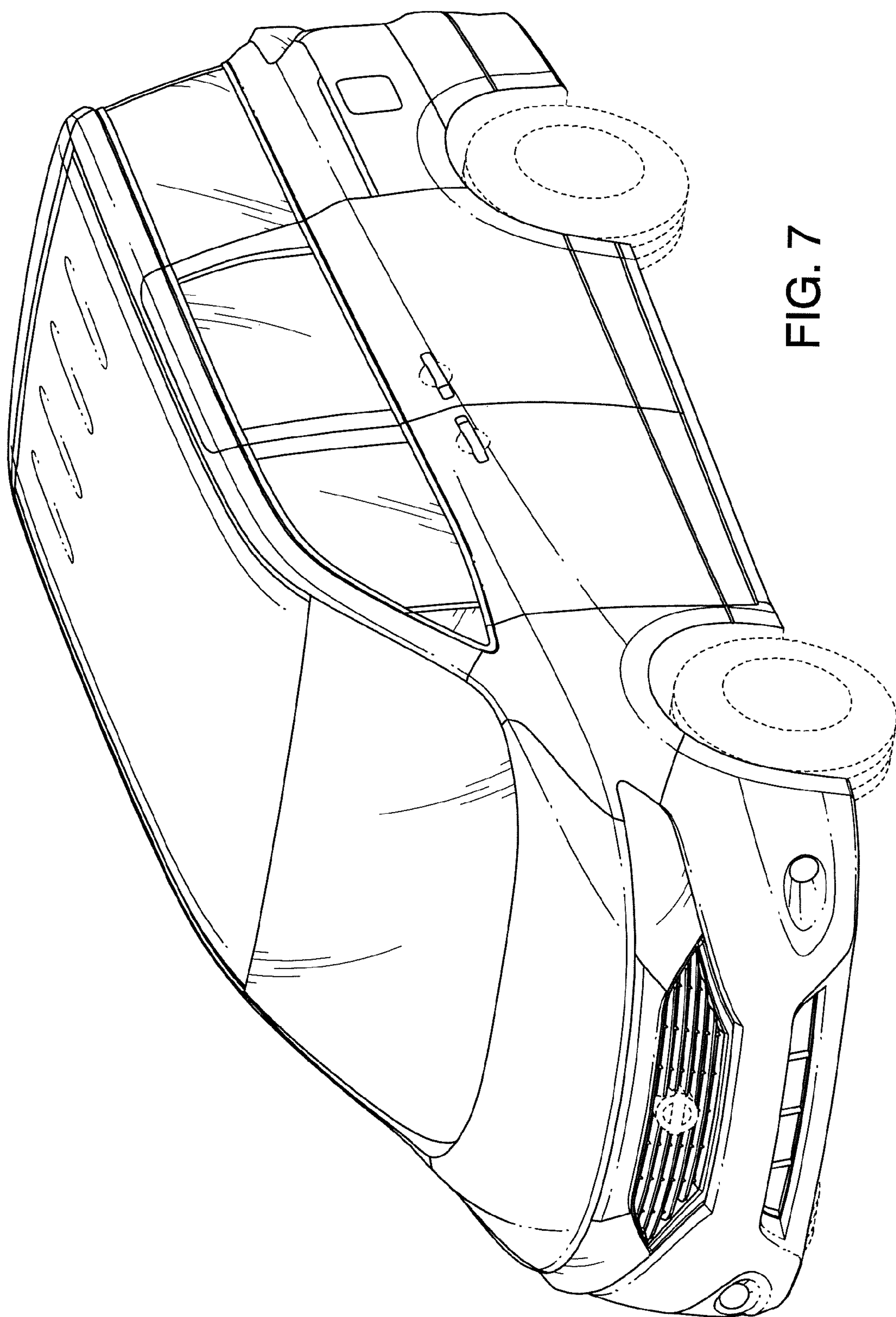

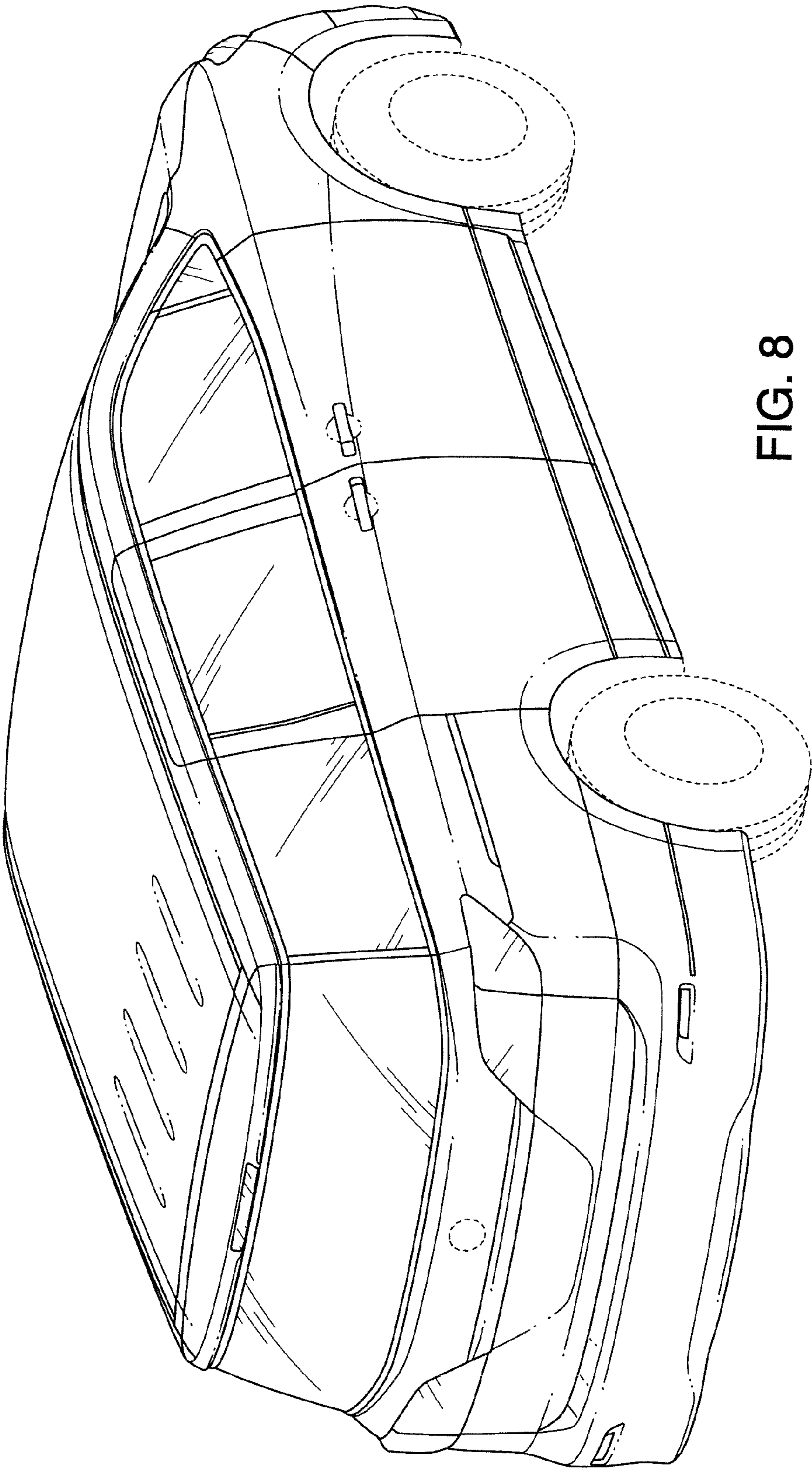
