(57) **CLAIM**

The ornamental design for a friction pad of disk brakes for an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of top, front and right side of a friction pad of disk brakes for an automobile showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom view thereof; and,

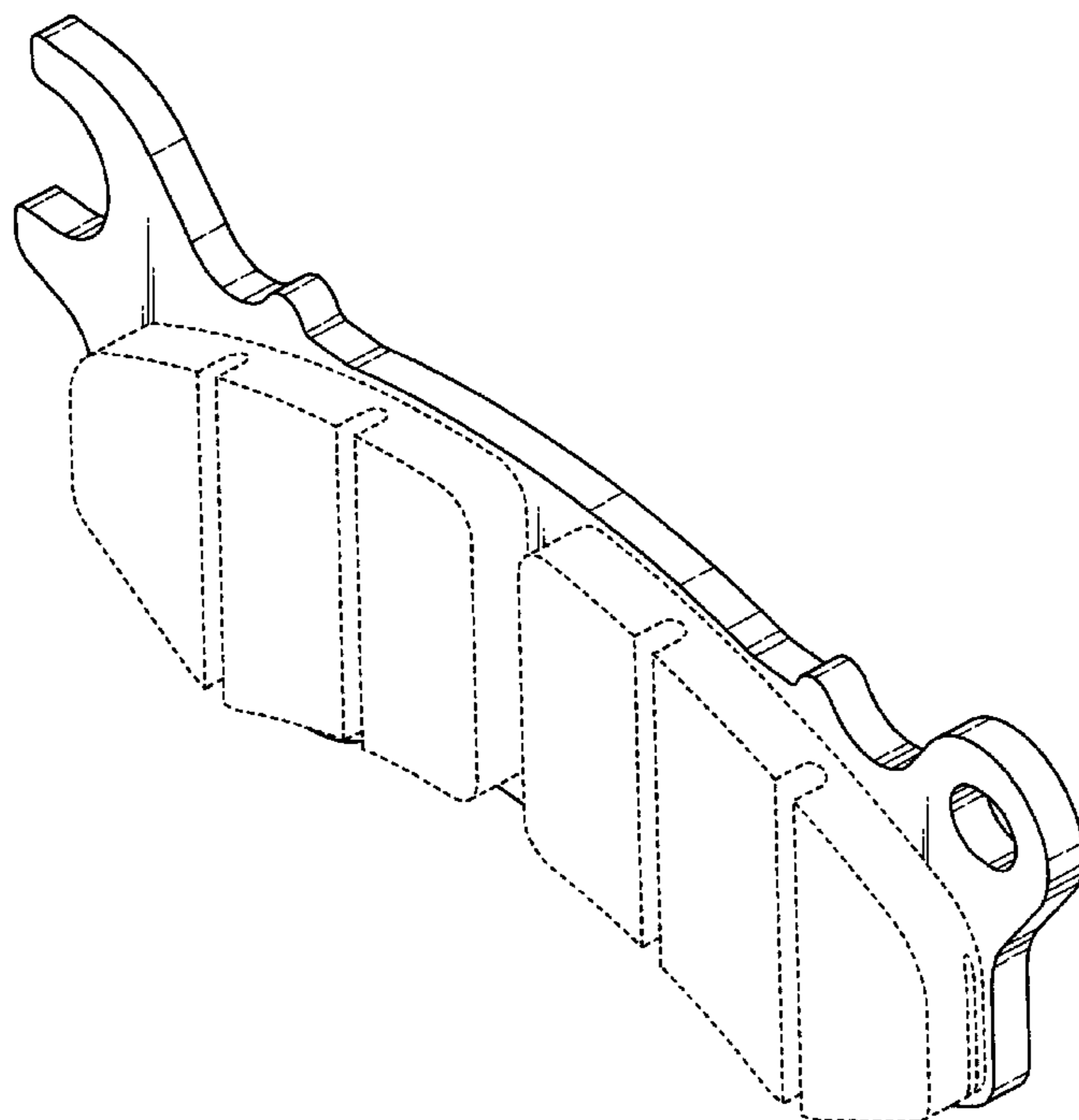

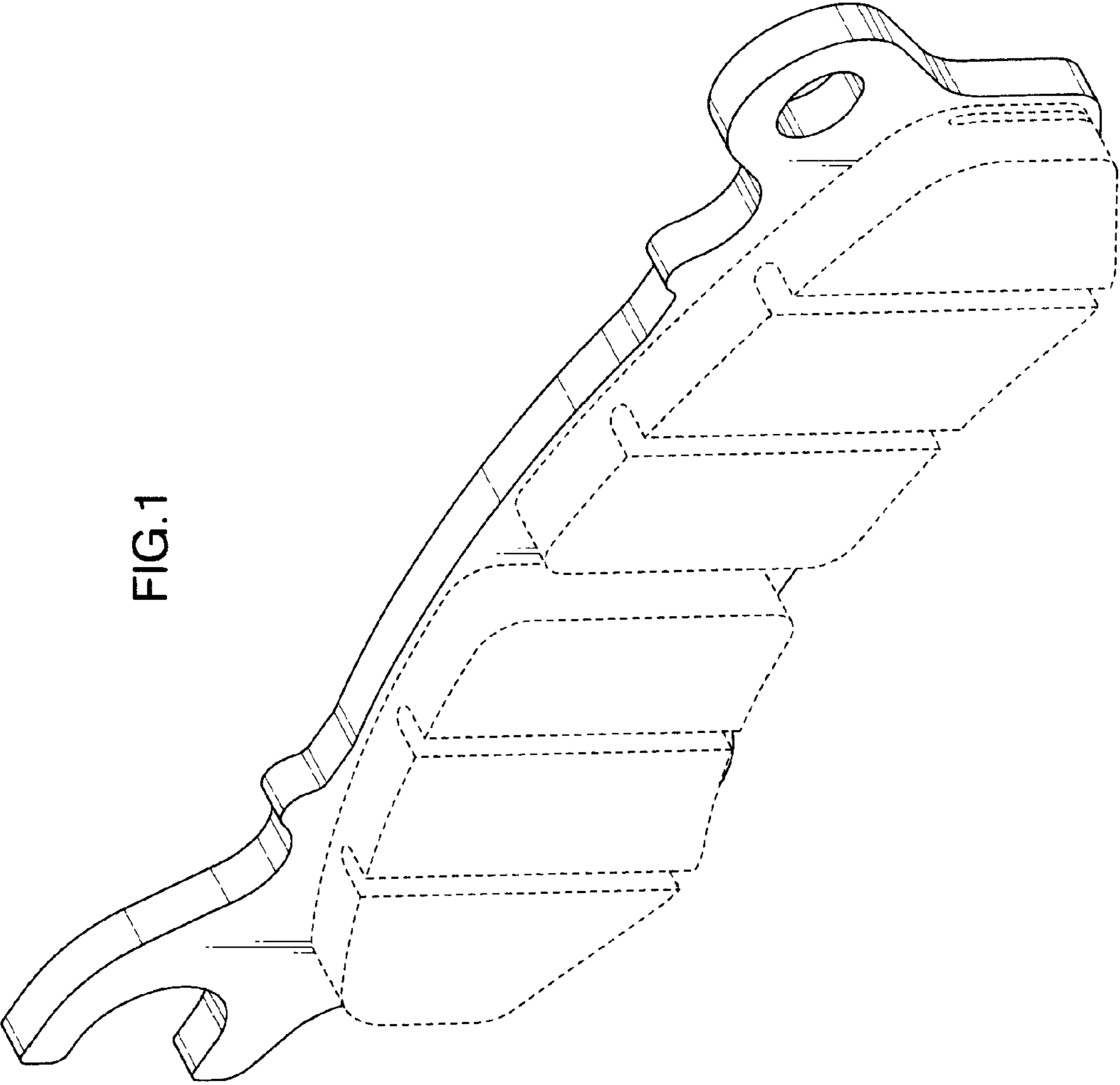

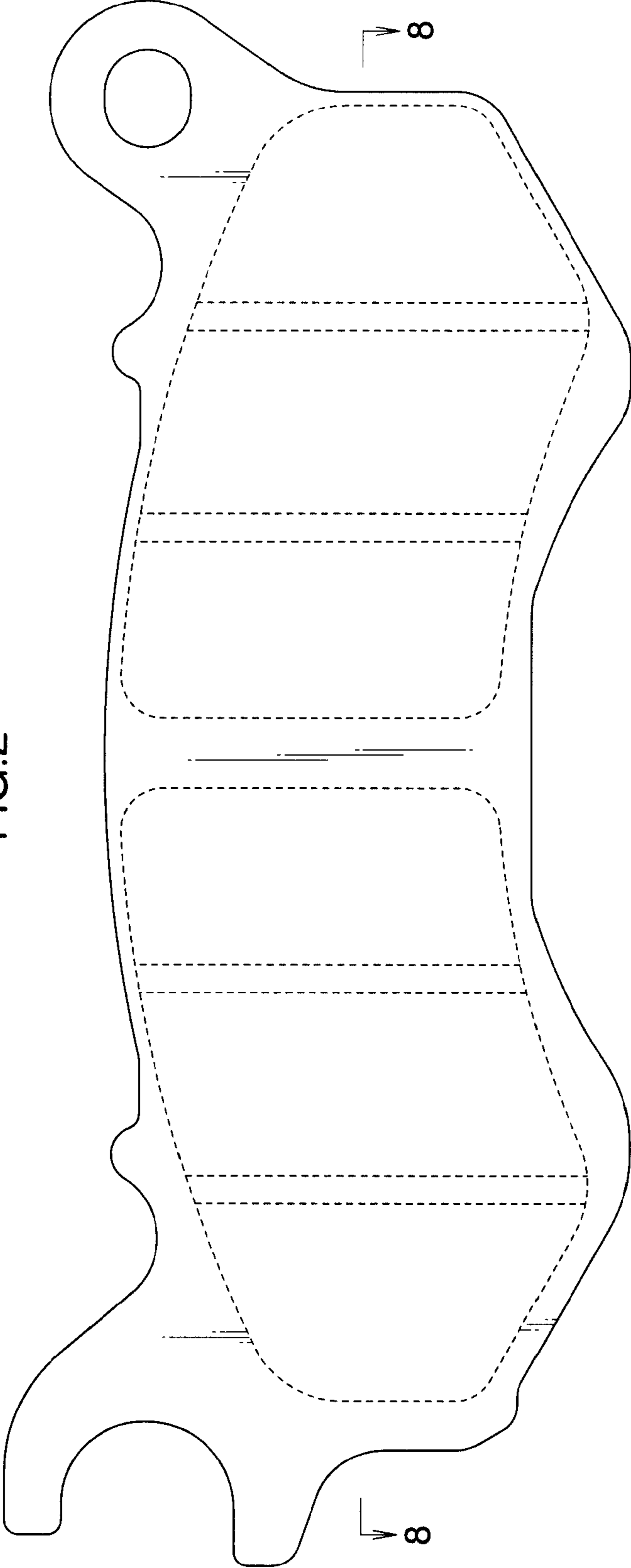

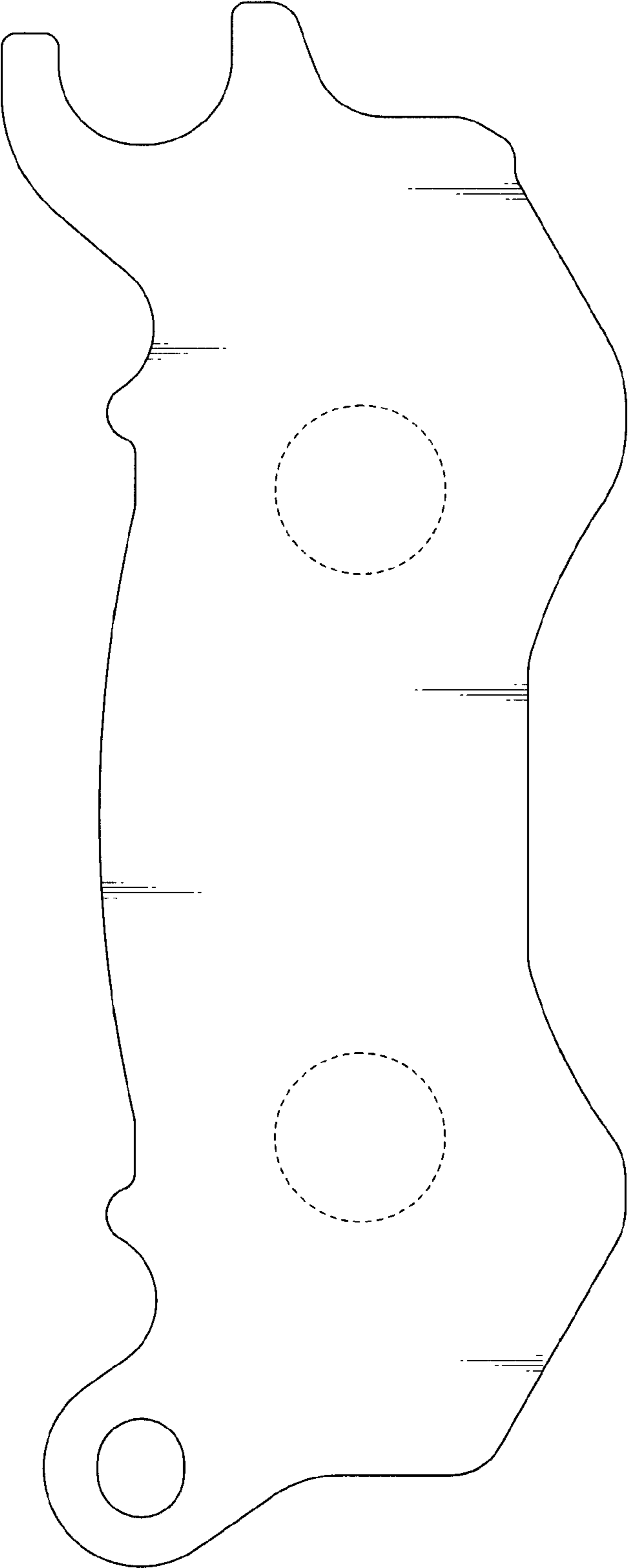

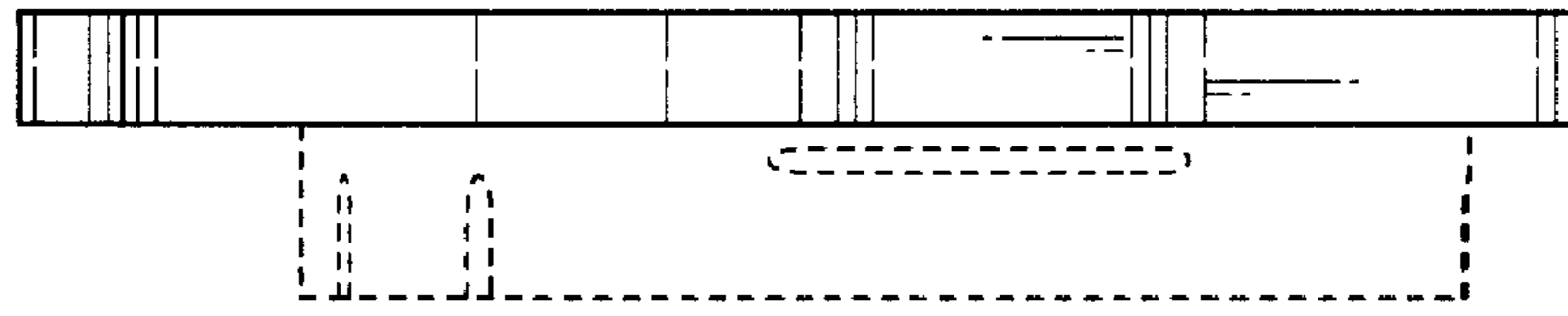

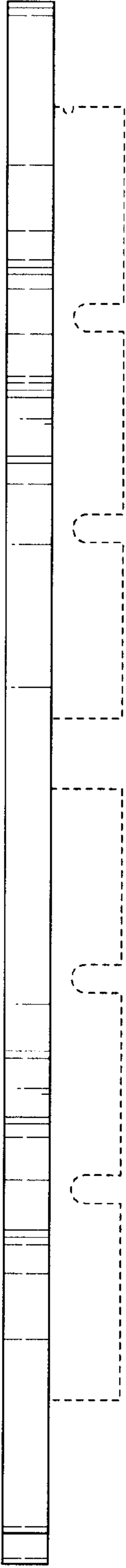

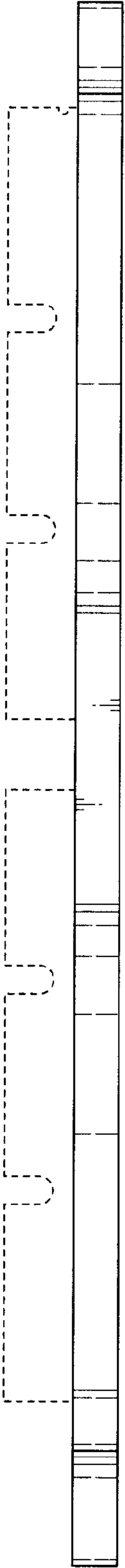
