FIG. 1 is a perspective view of a mount socket for use in vehicle dash mounted equipment showing my new design;

FIG. 2 is a perspective view thereof;

FIG. 3 is an perspective view thereof showing the mount in an engaged position;

FIG. 4 is a rear view thereof; and,

FIG. 5 is an end view thereof.

The broken lines showing the device in which the mount is disposed are for the purpose of illustrating an environment in which the mount is used and forms no part of the claimed design.

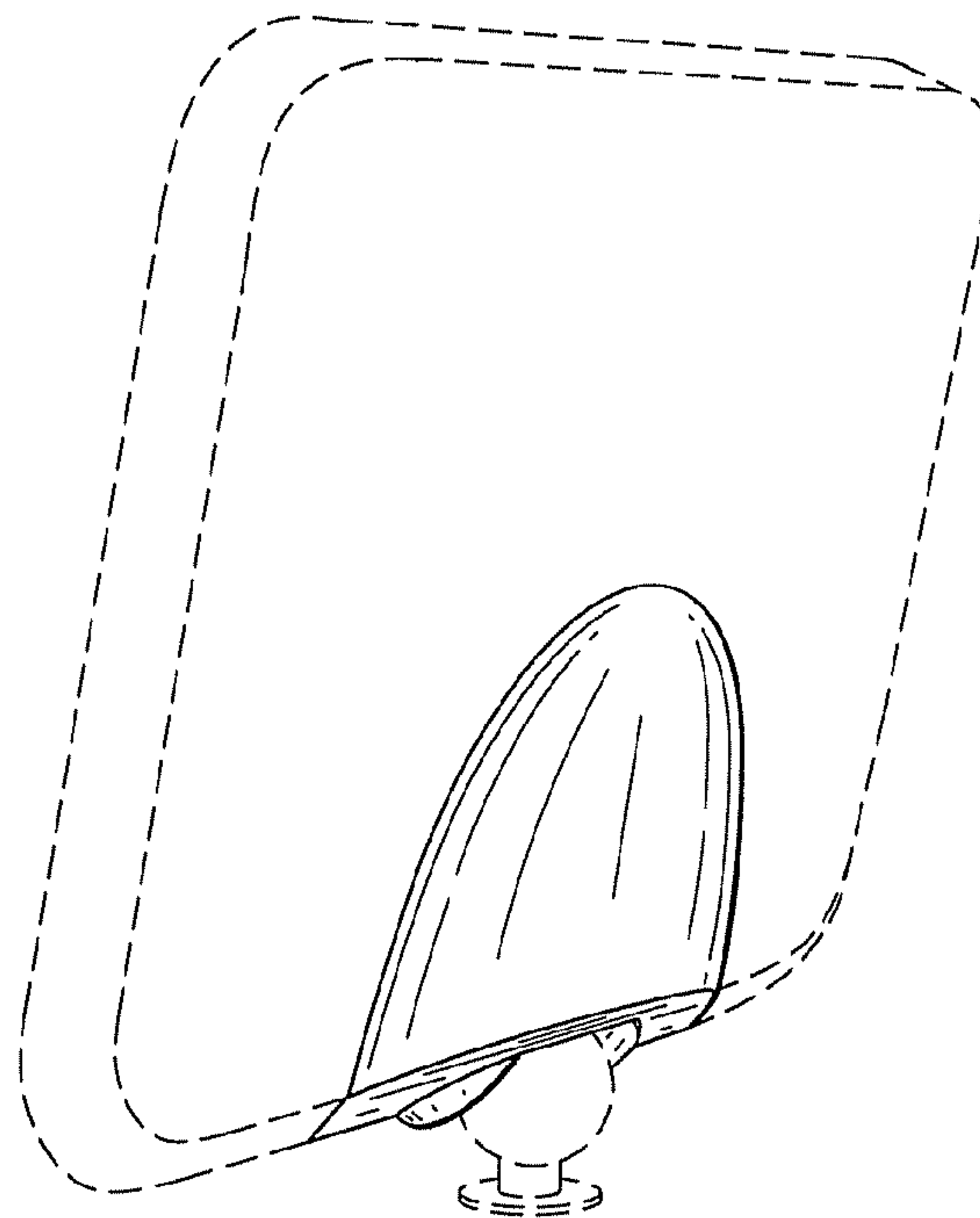
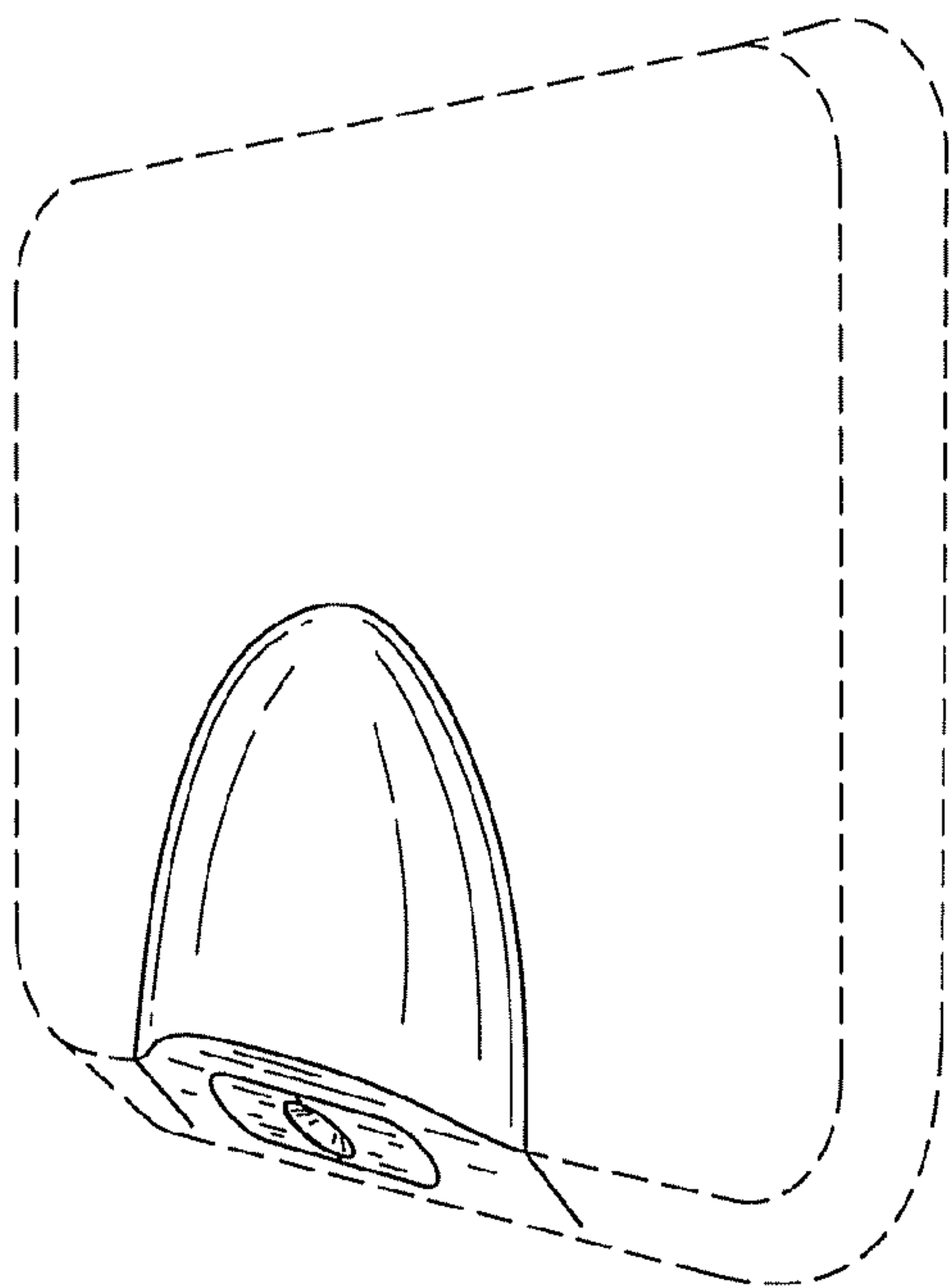

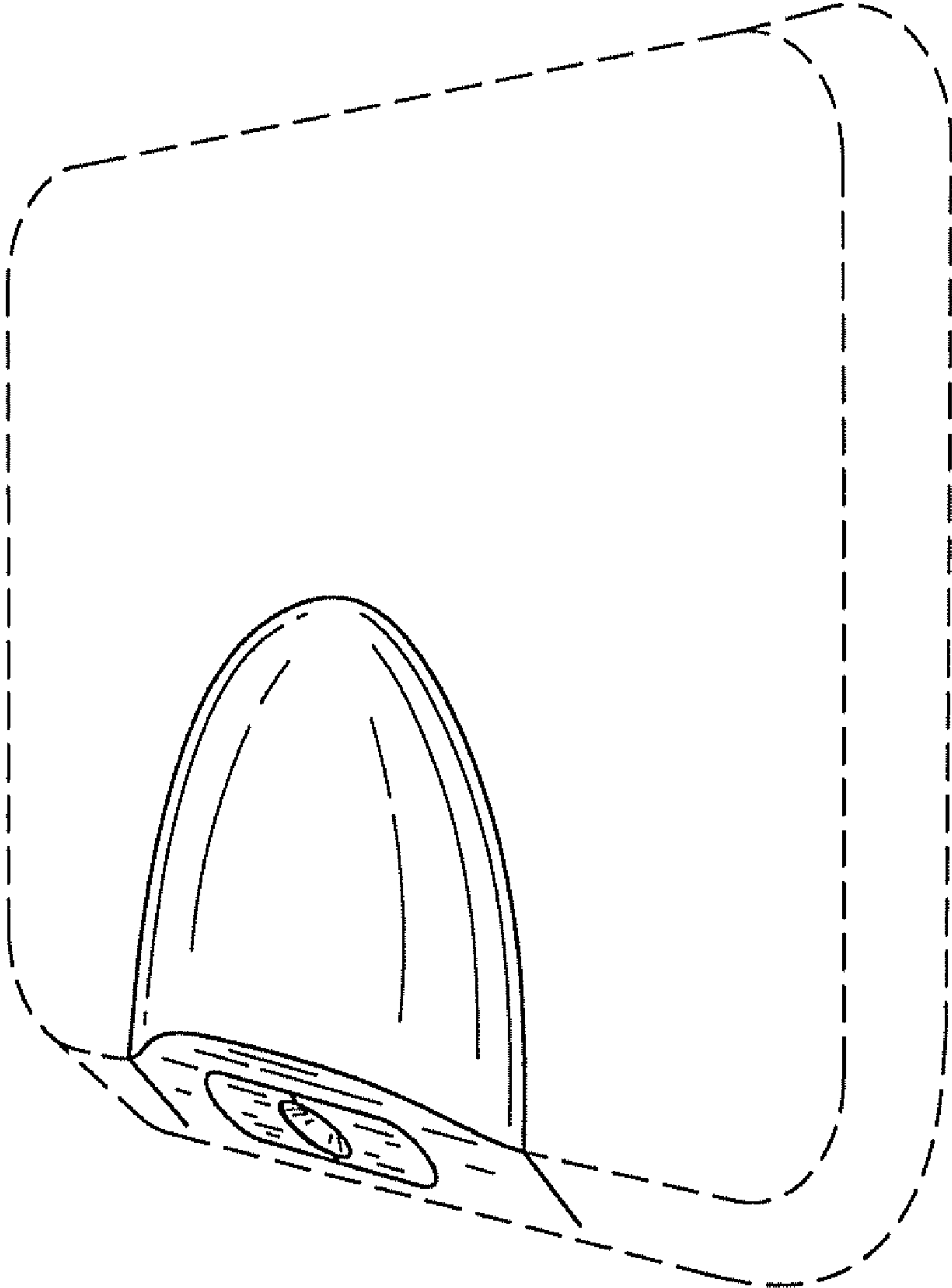

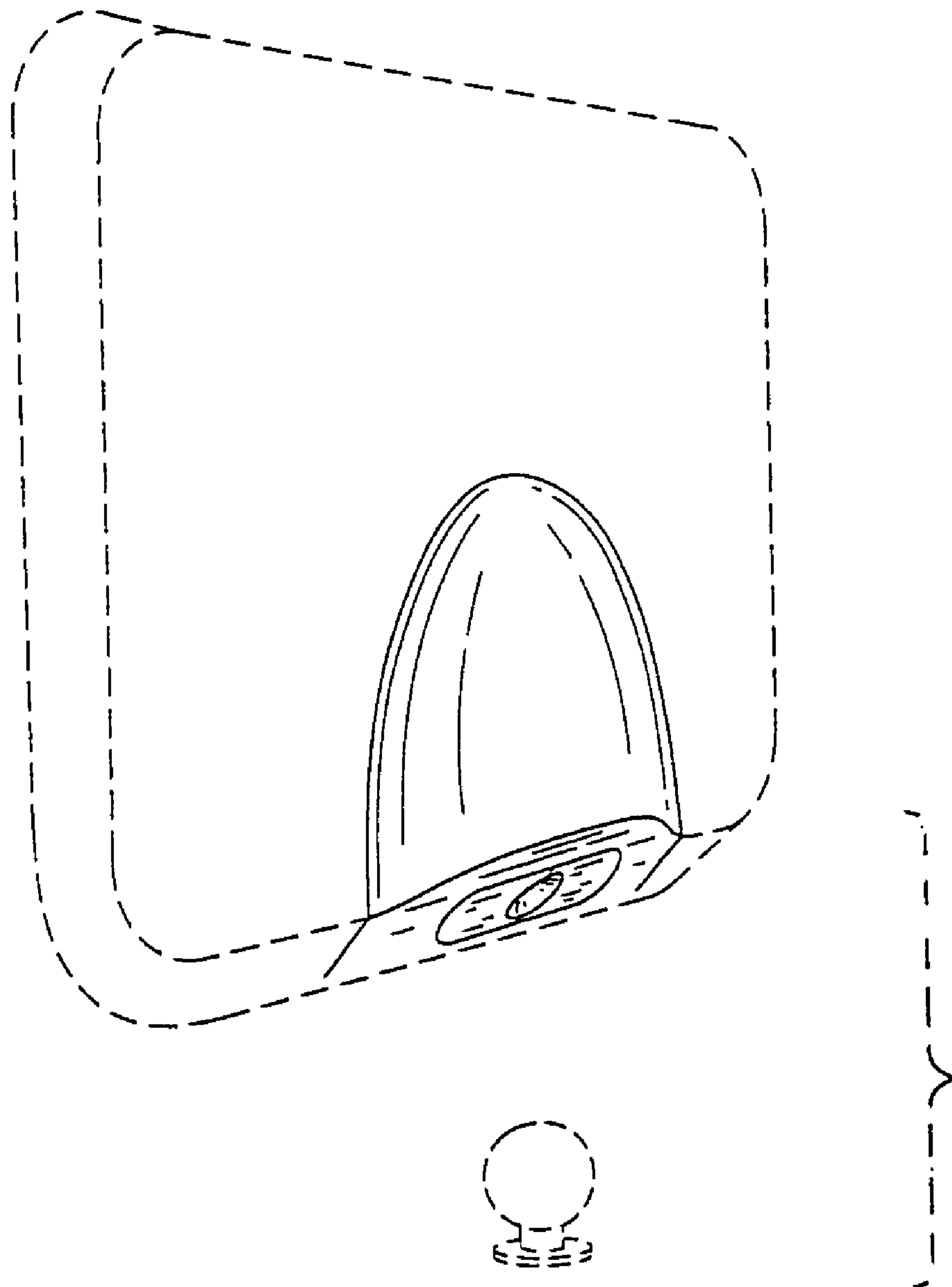

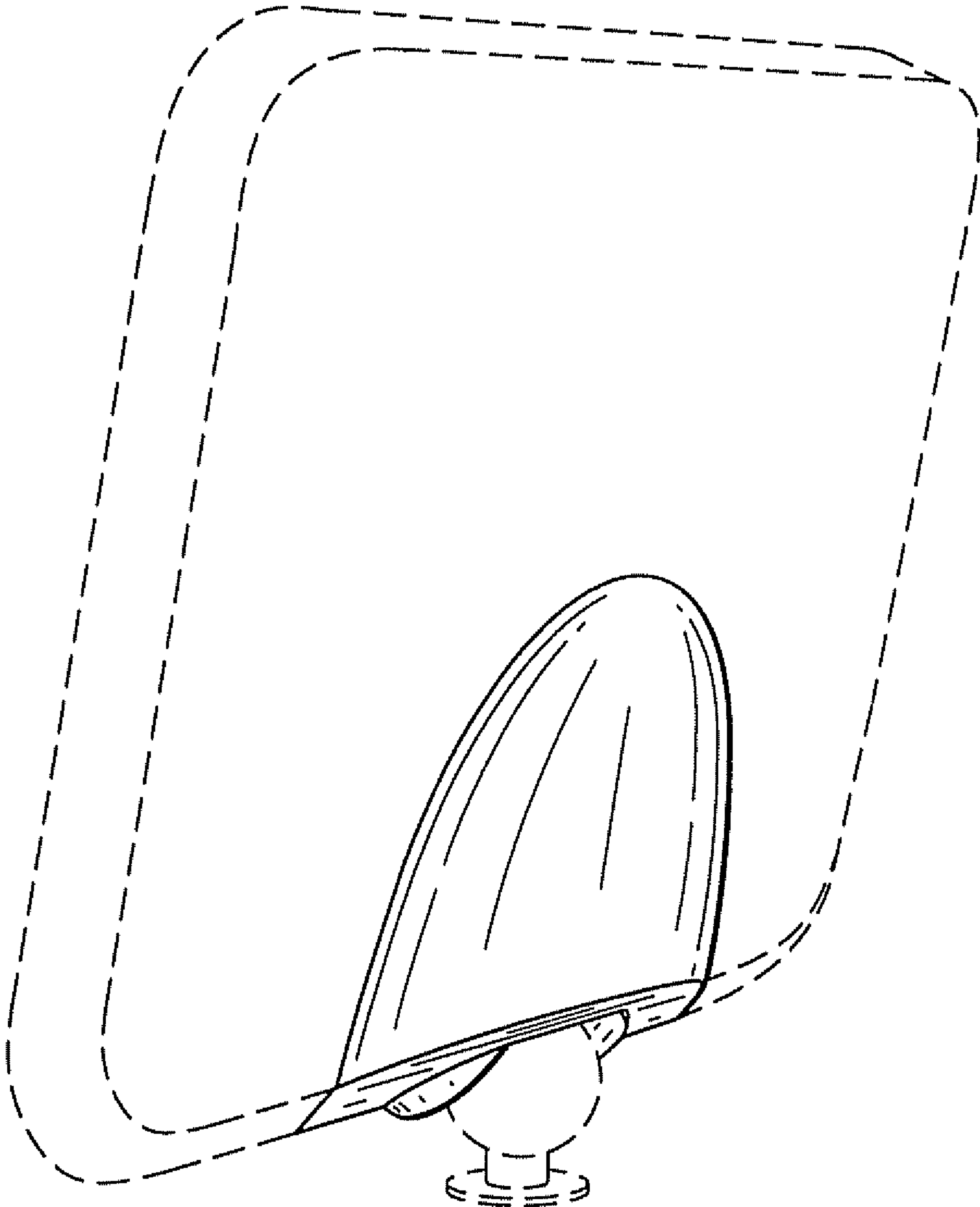

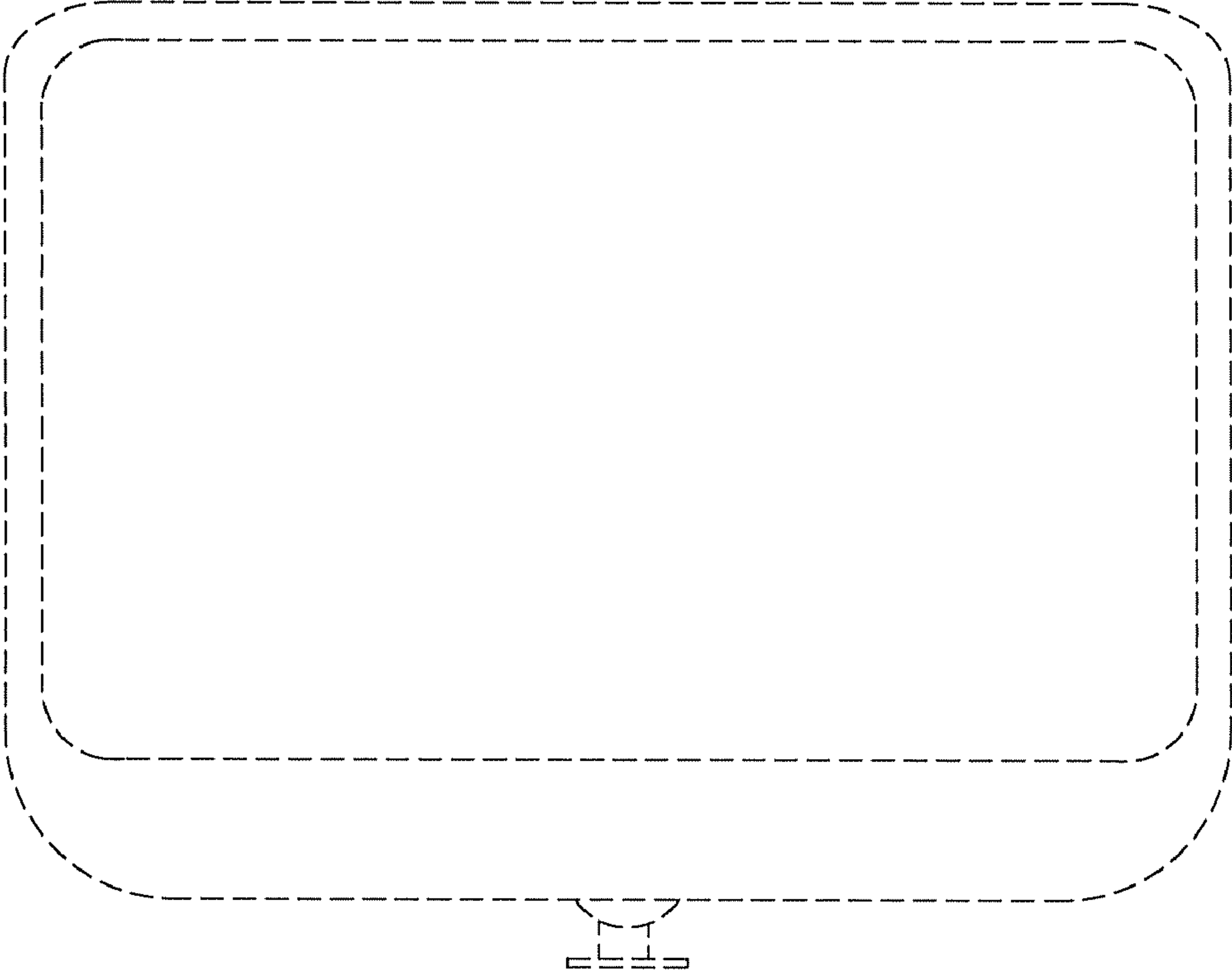
