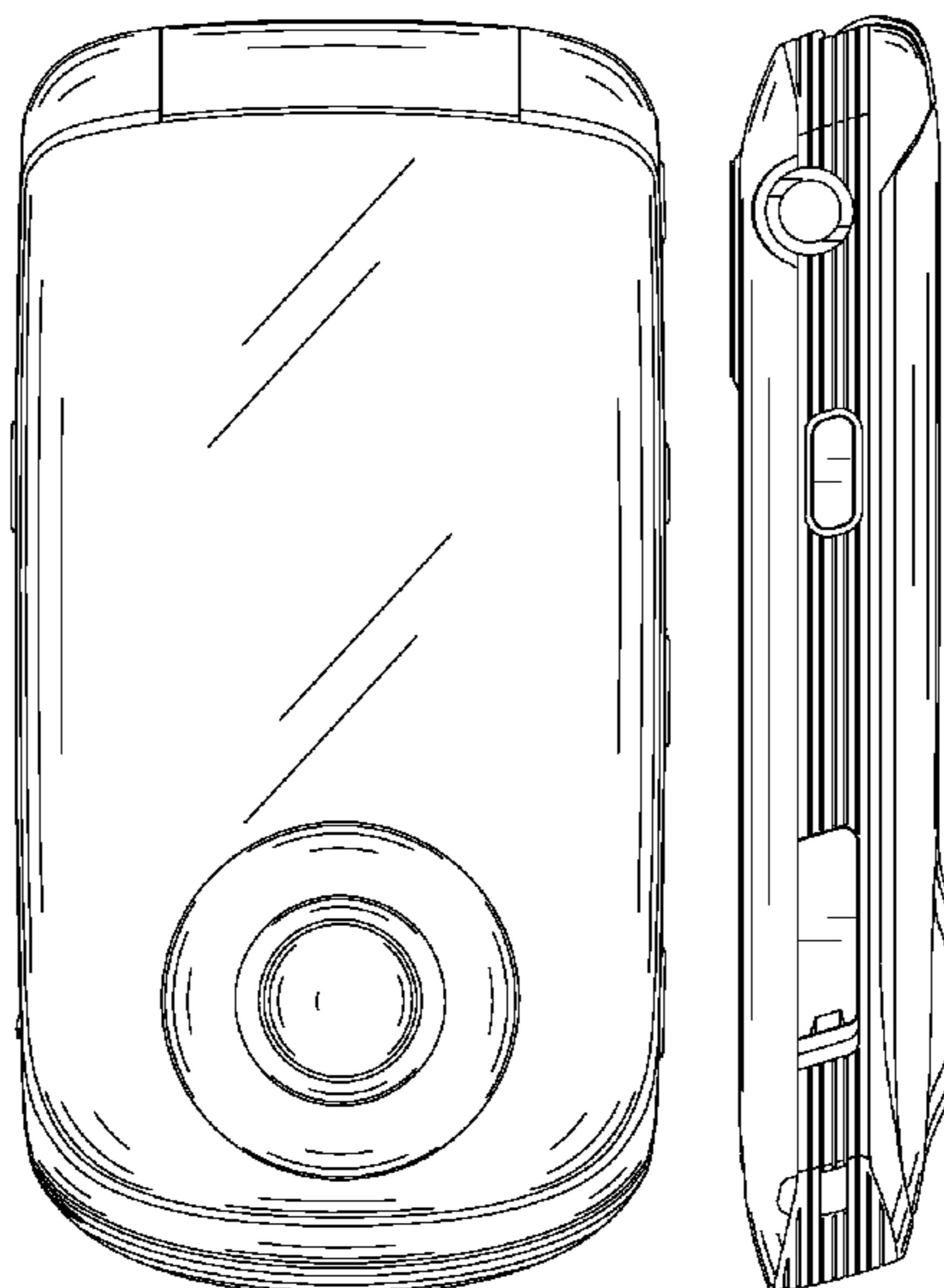

DESCRIPTION

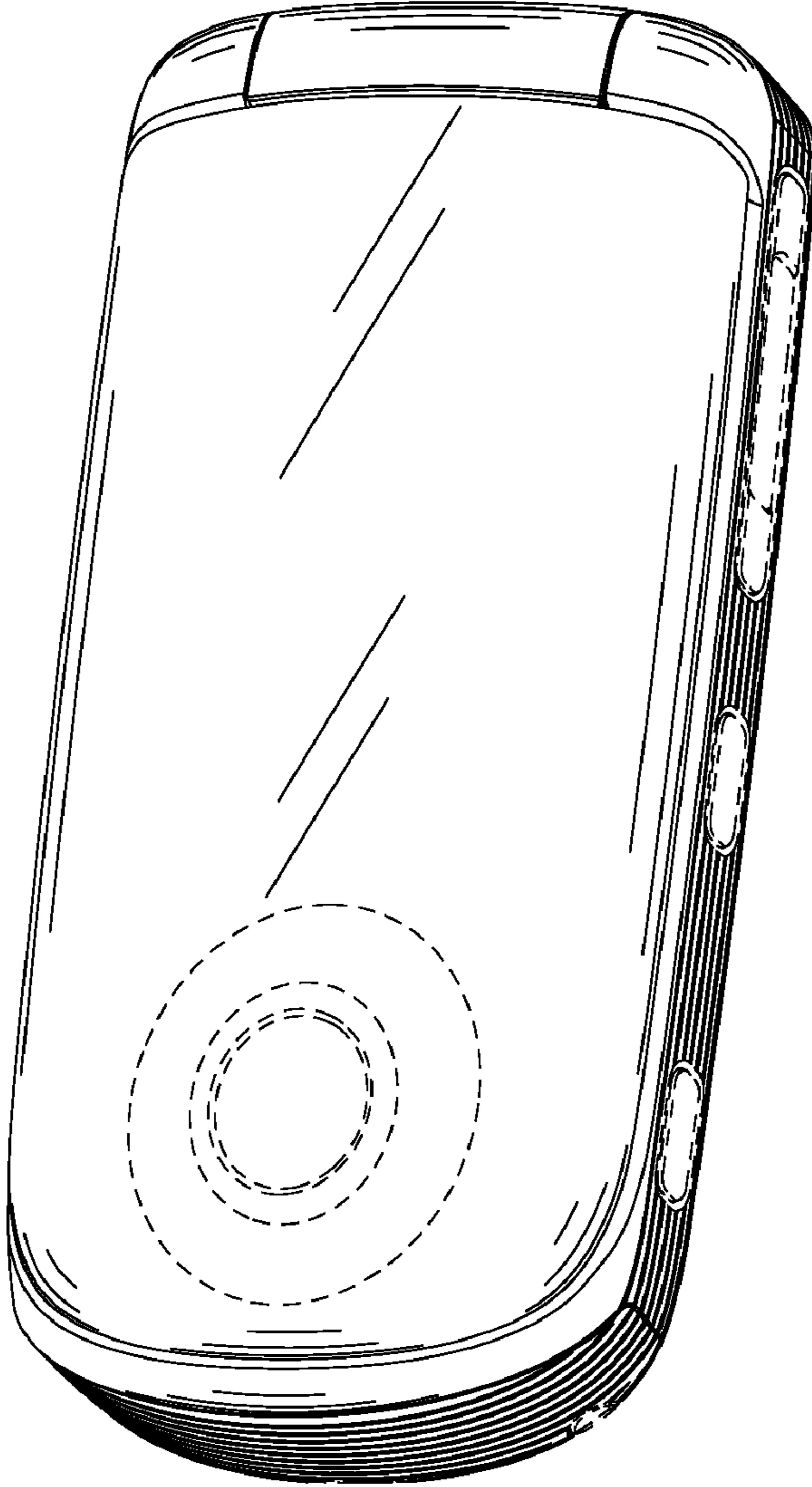

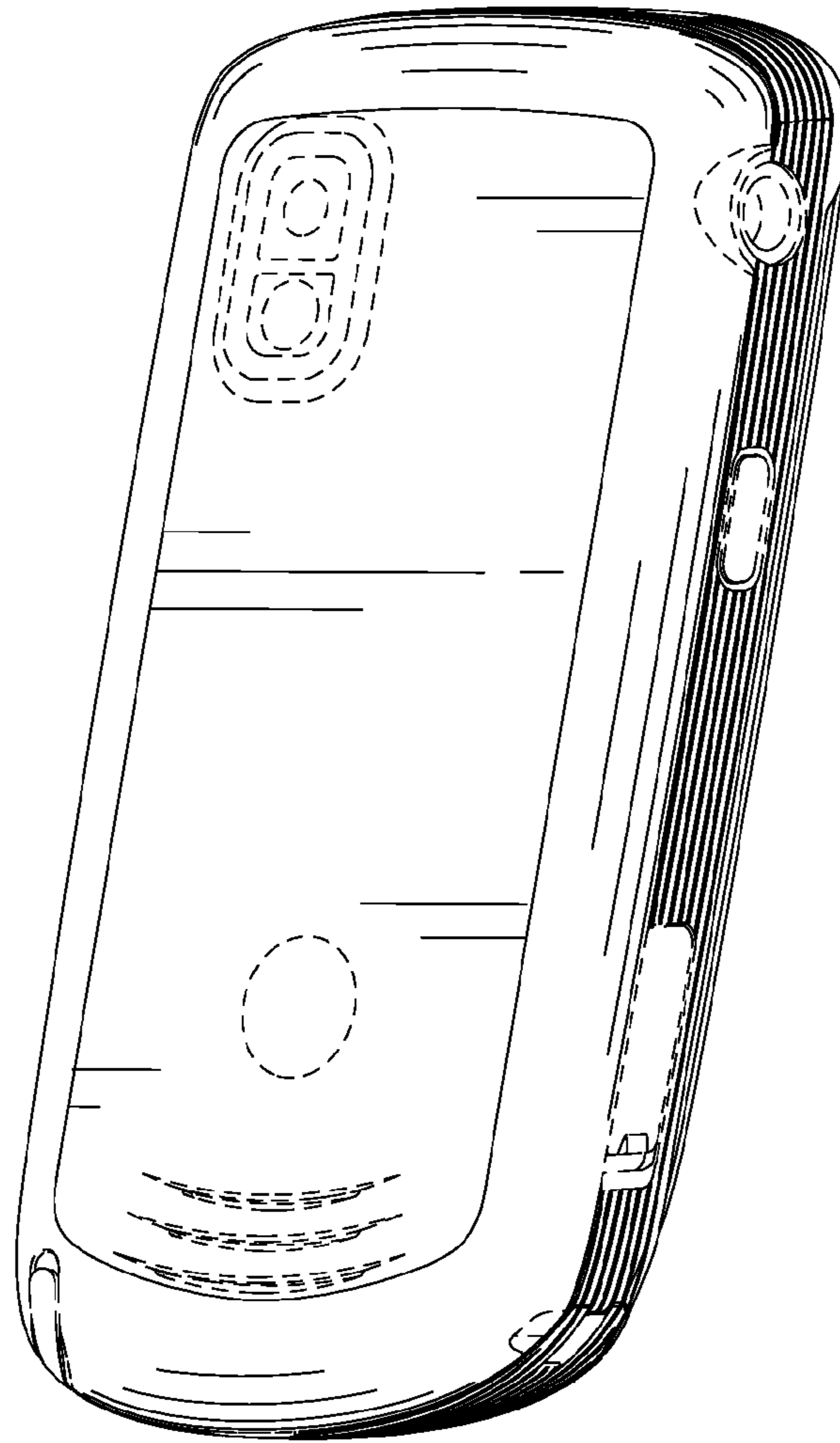

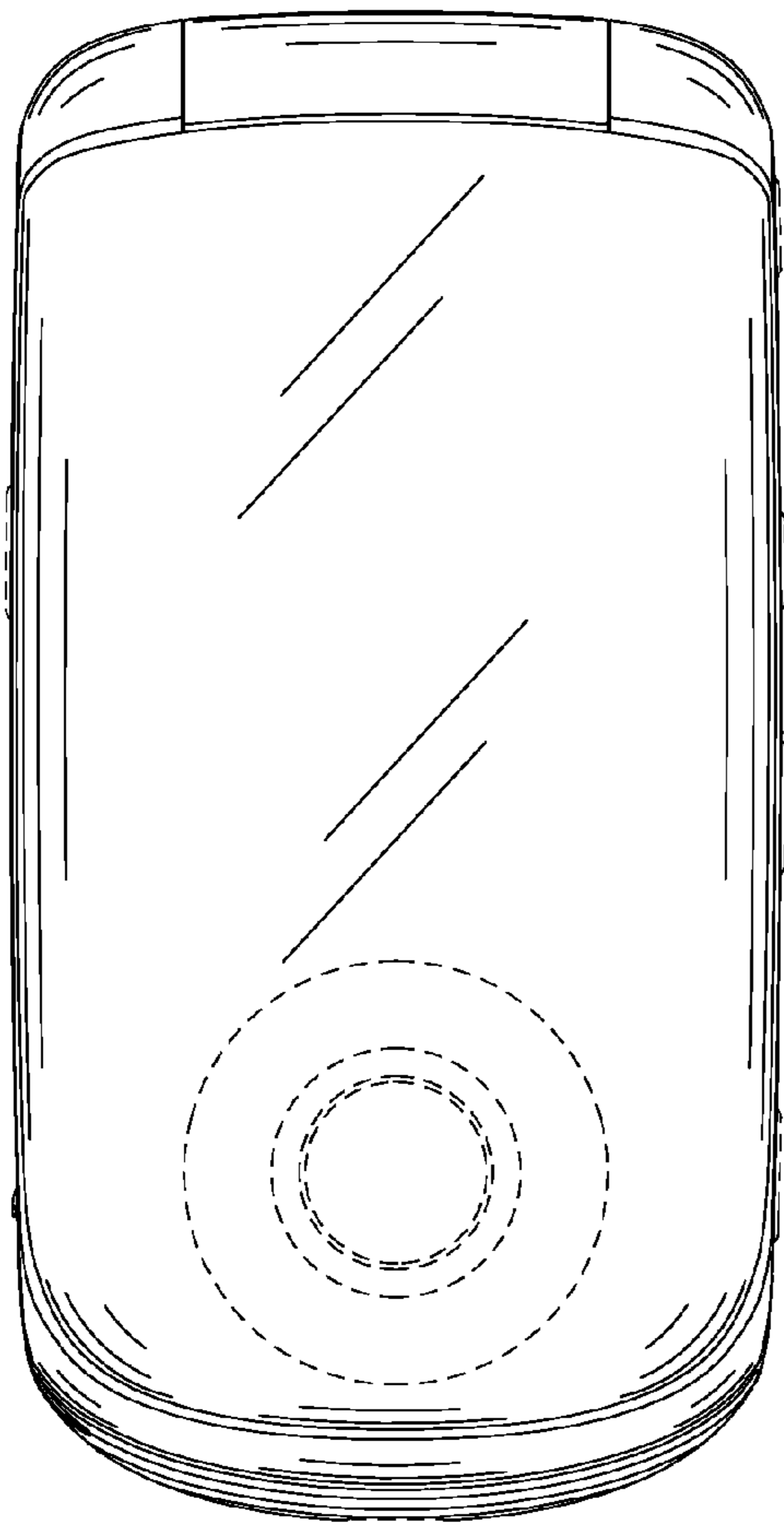

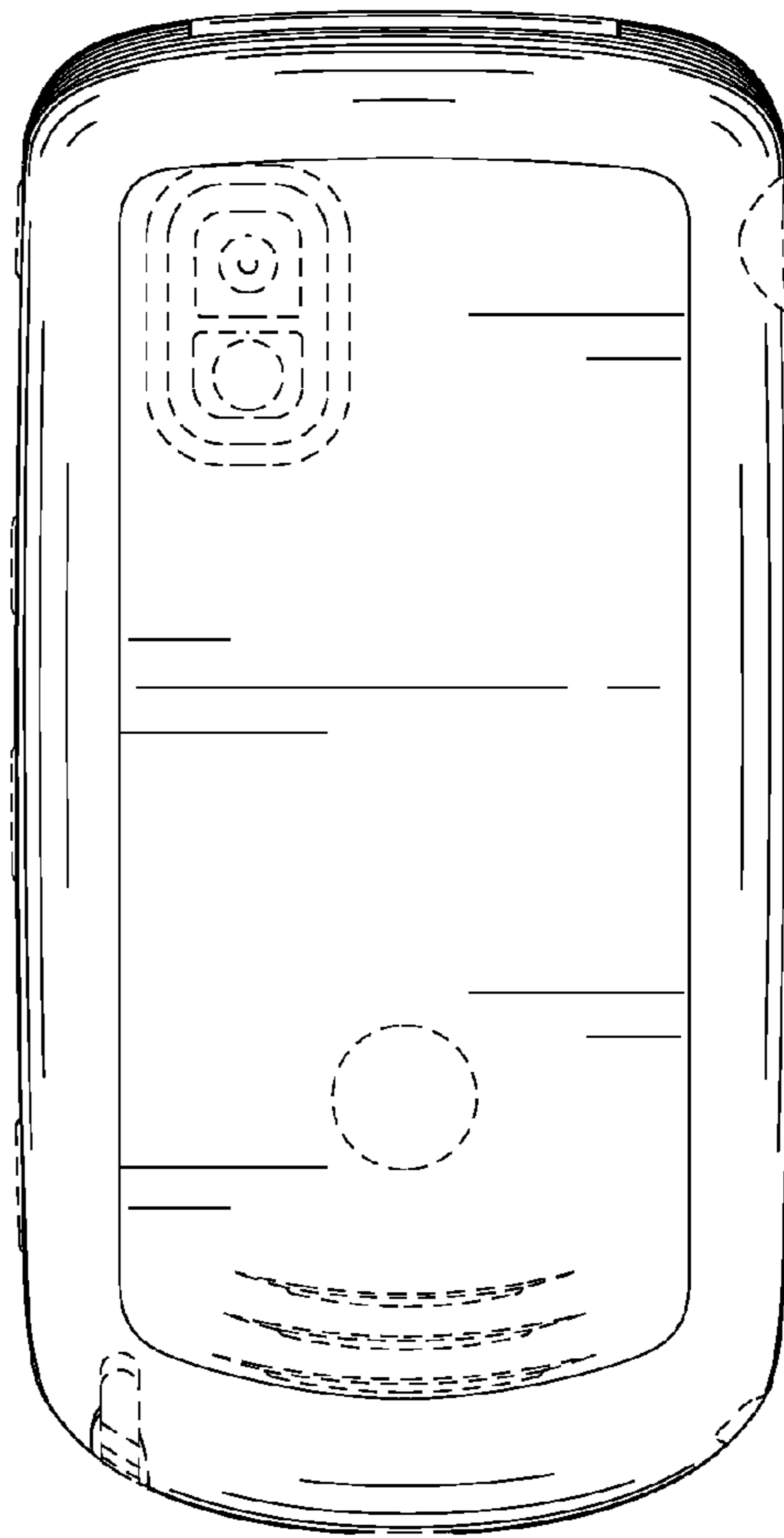

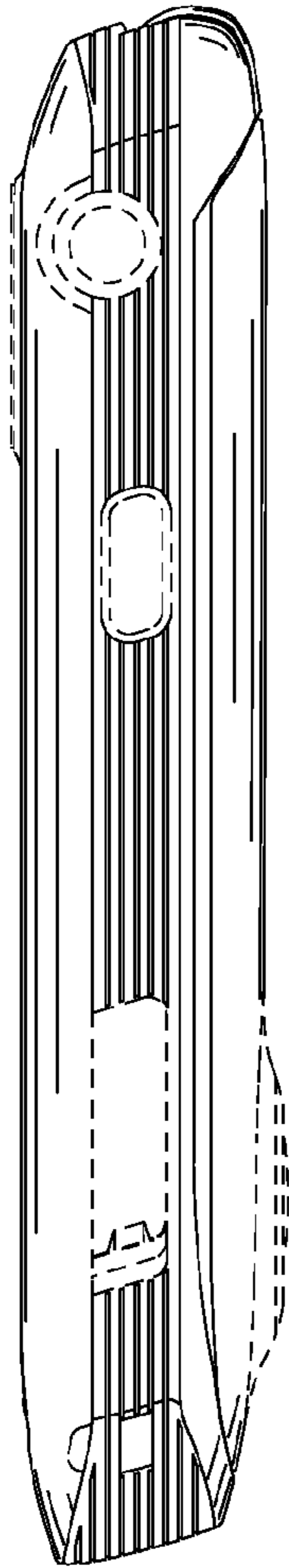

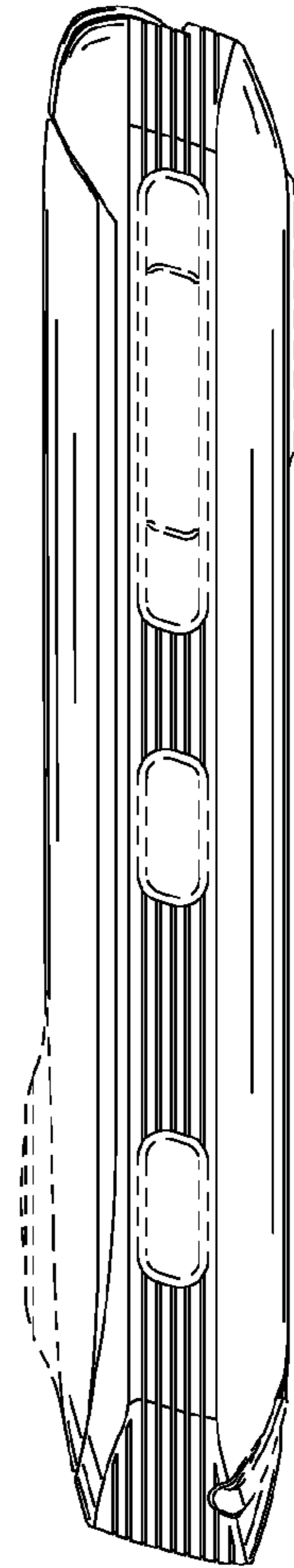

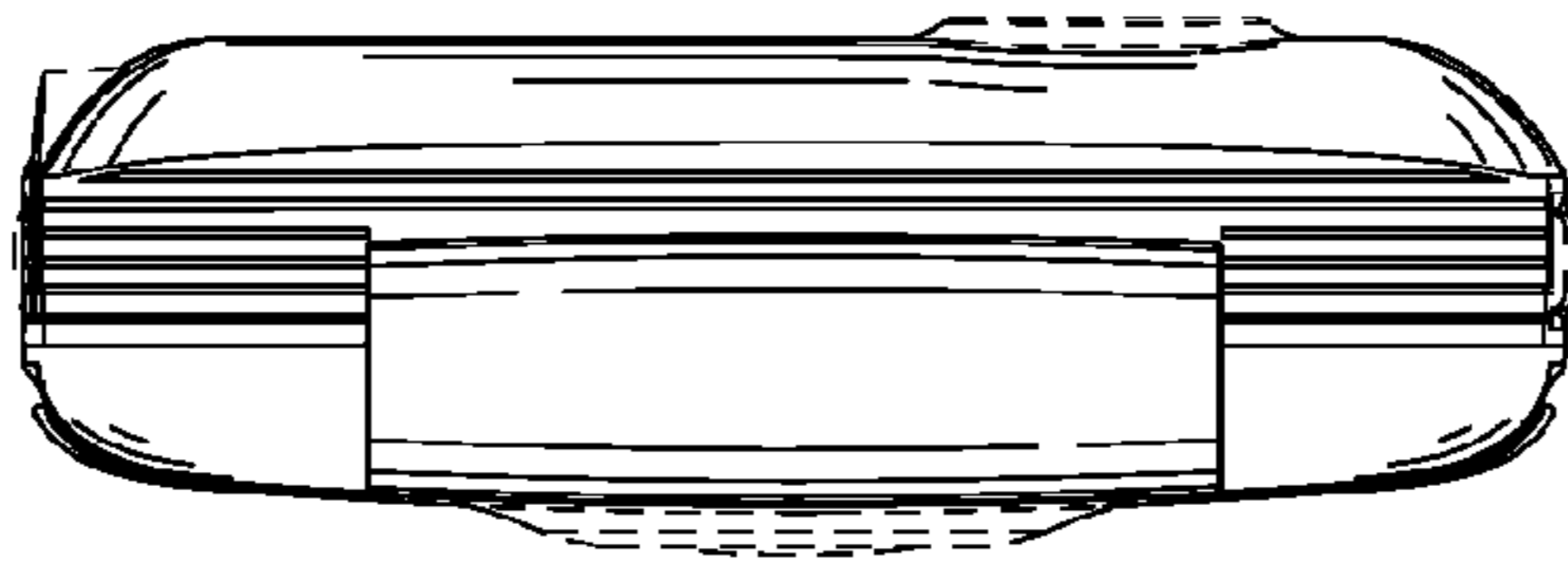

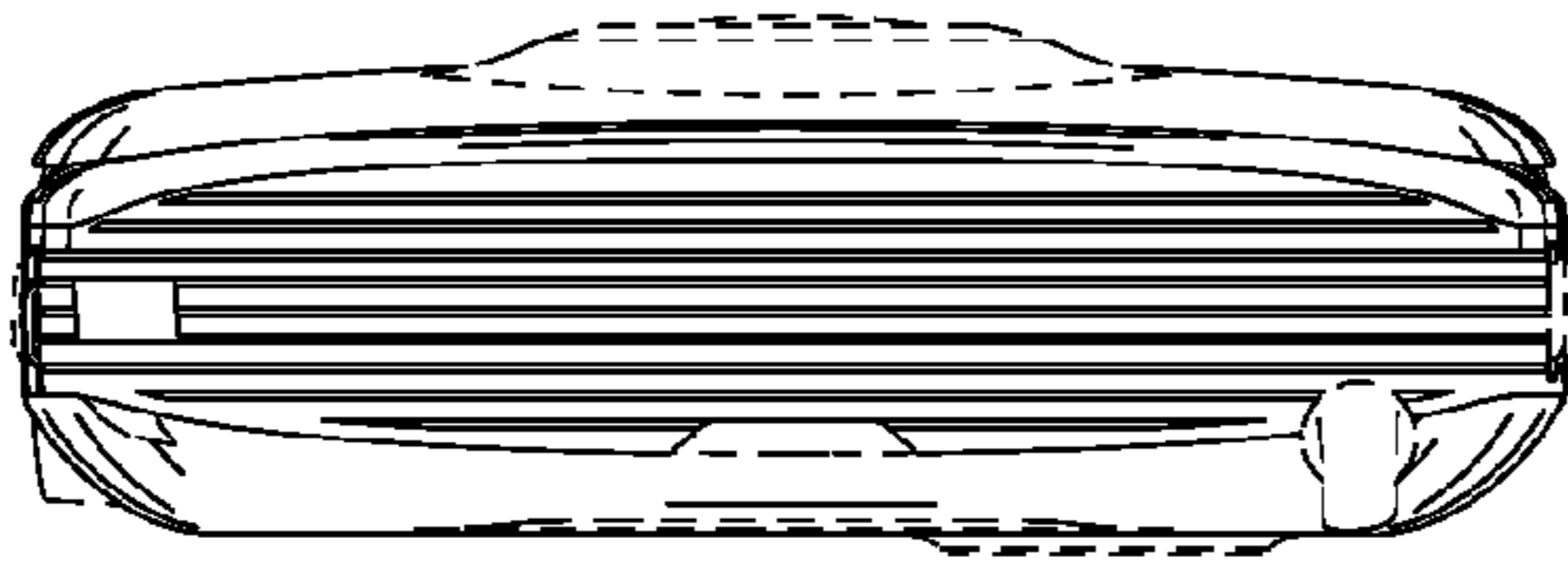

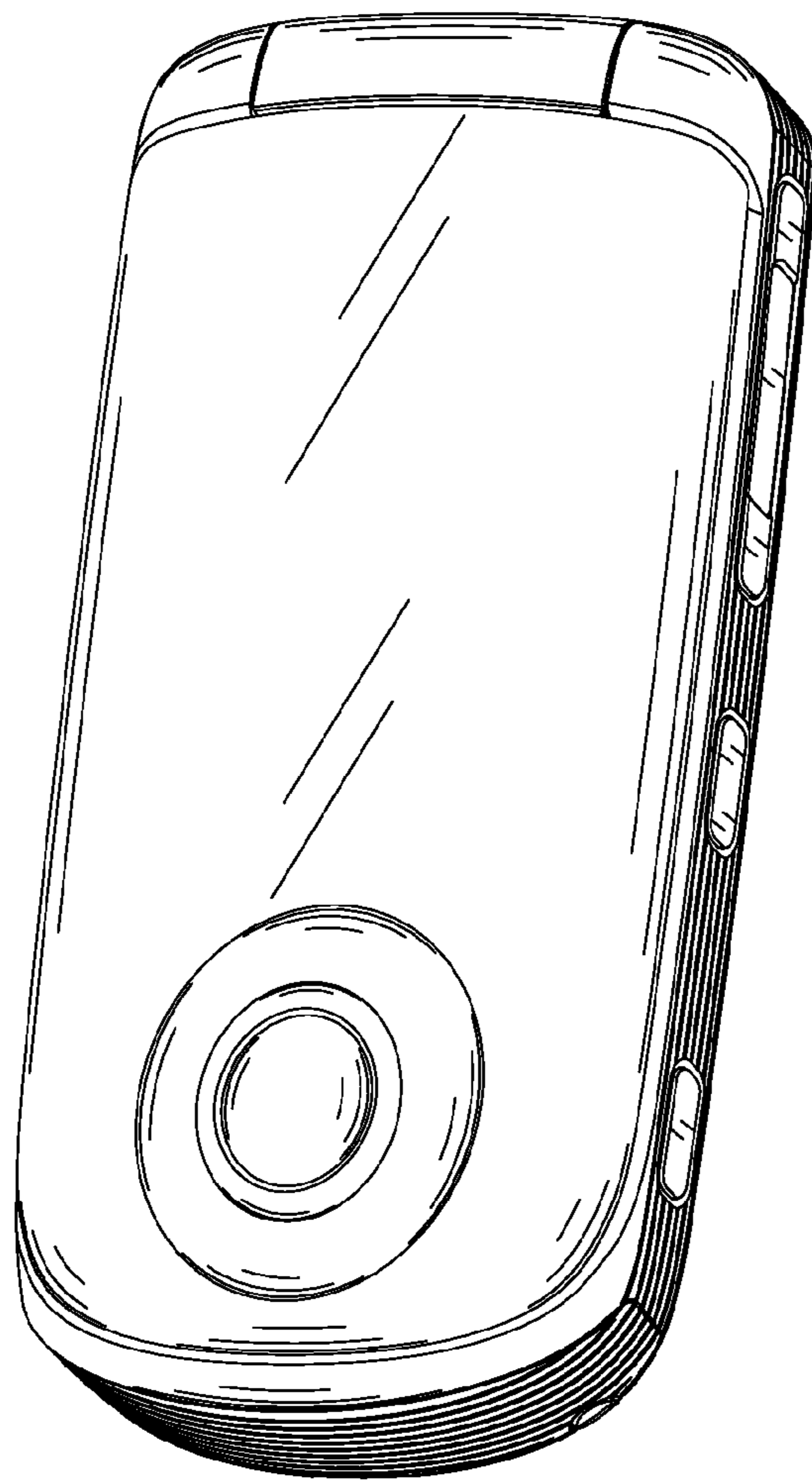

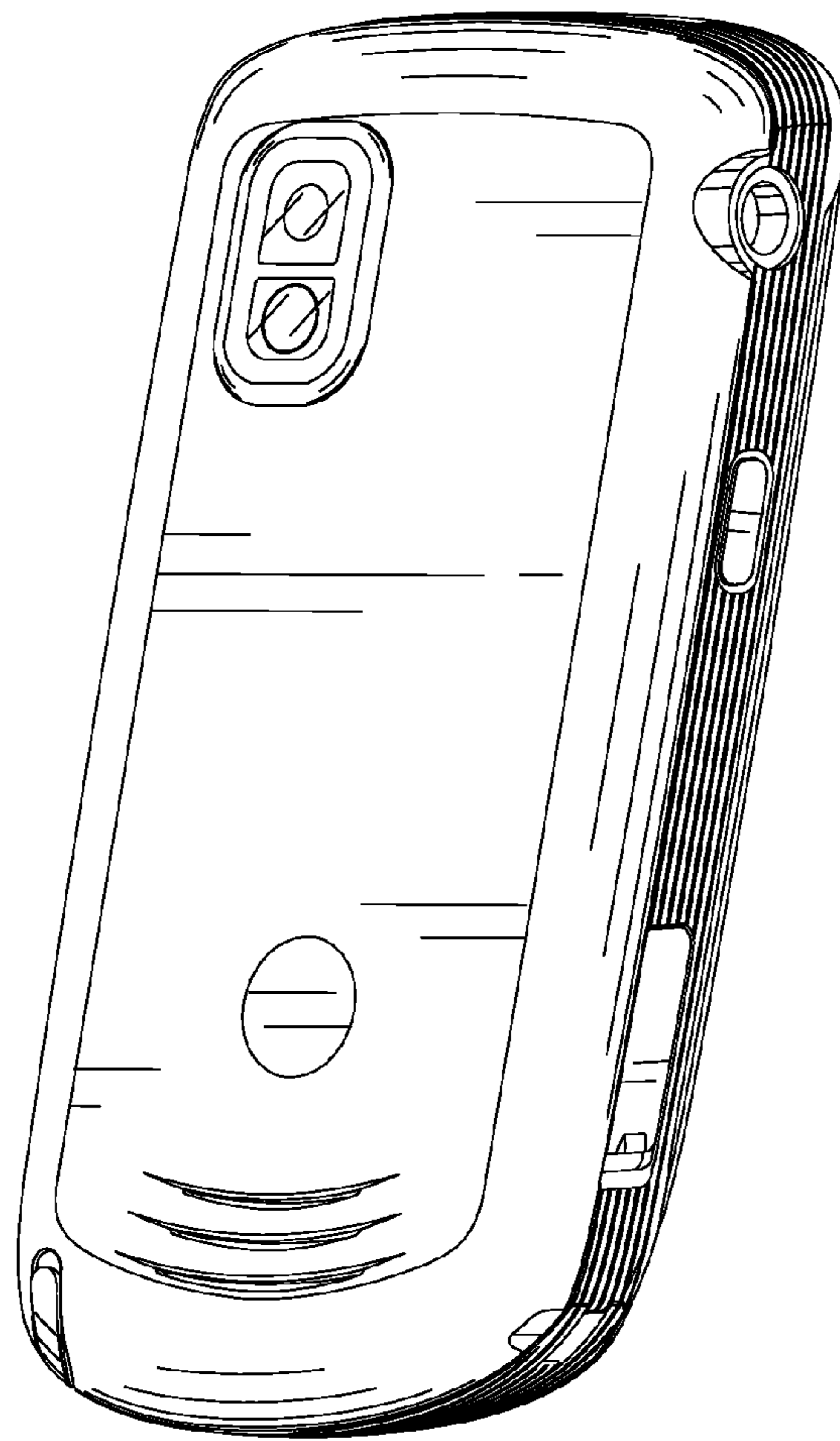

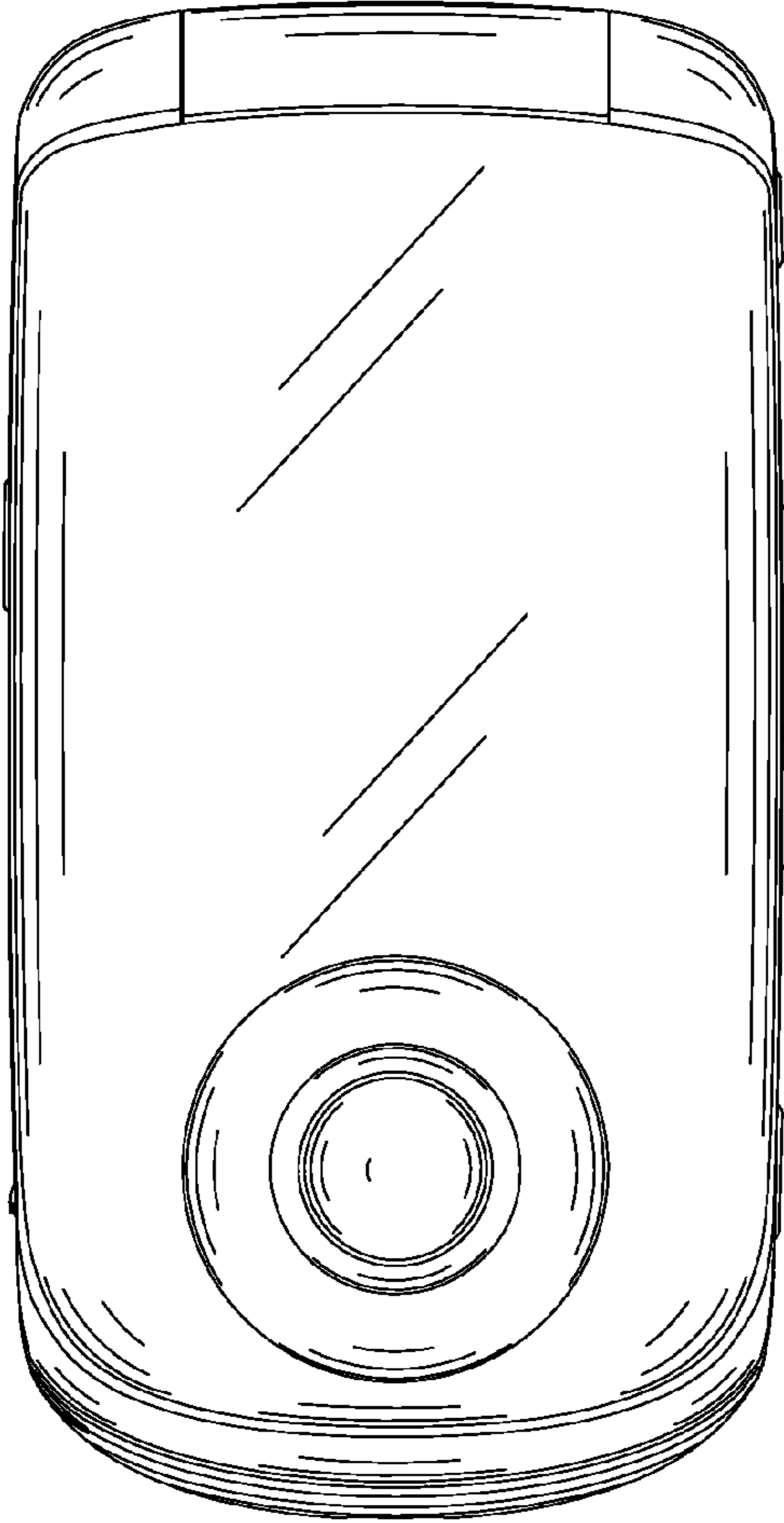

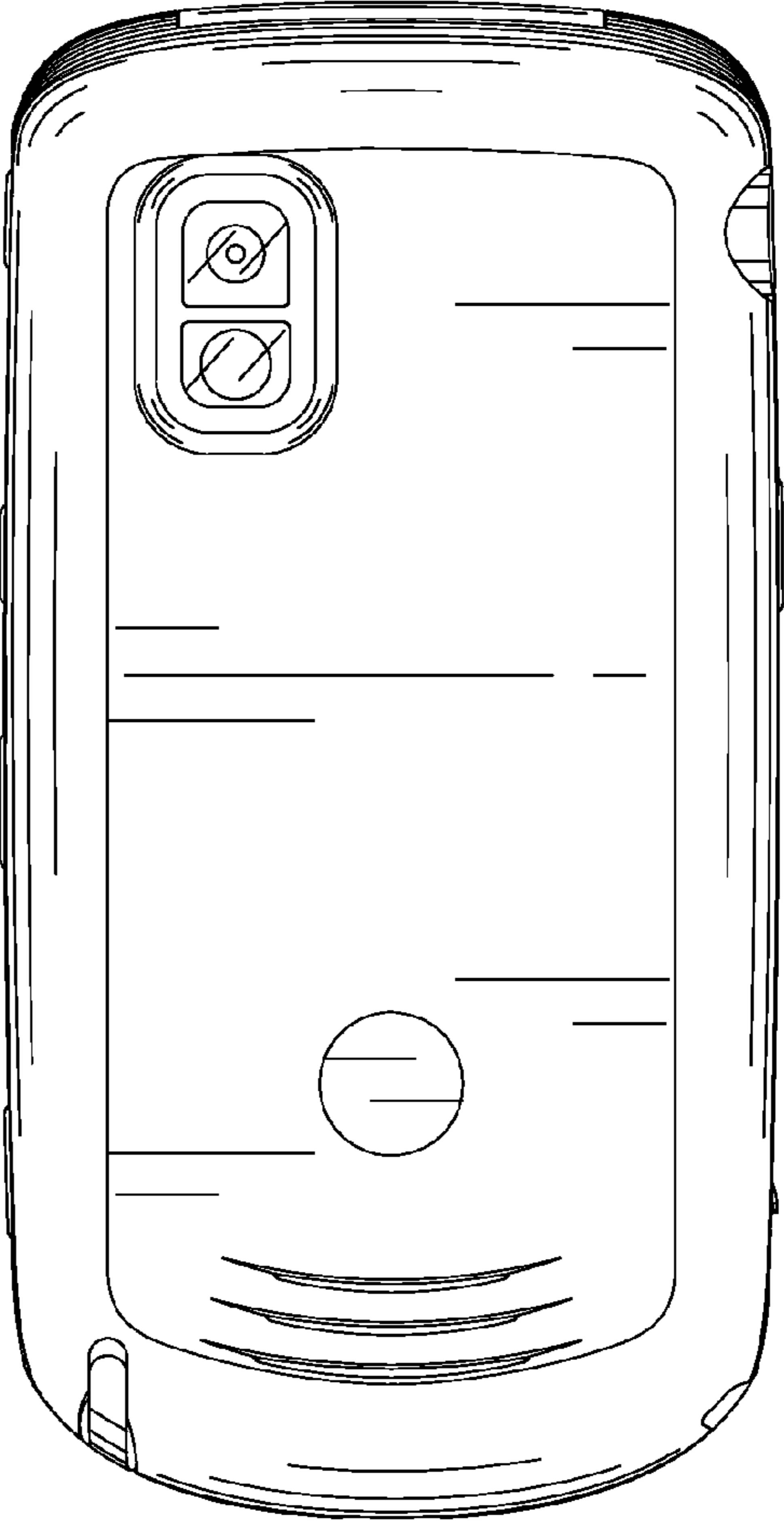

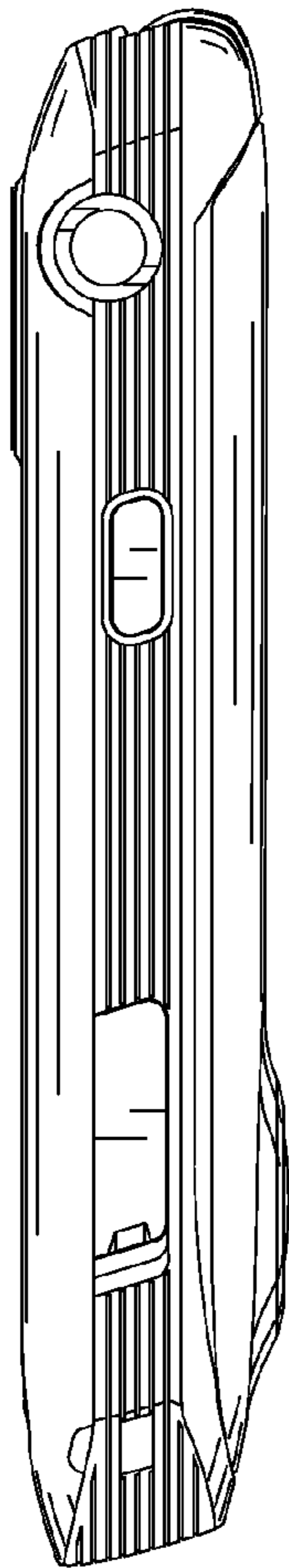

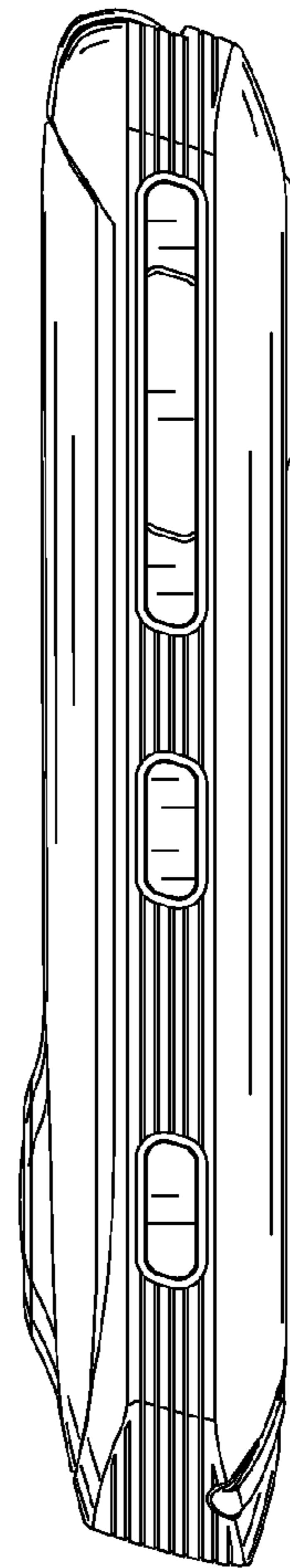

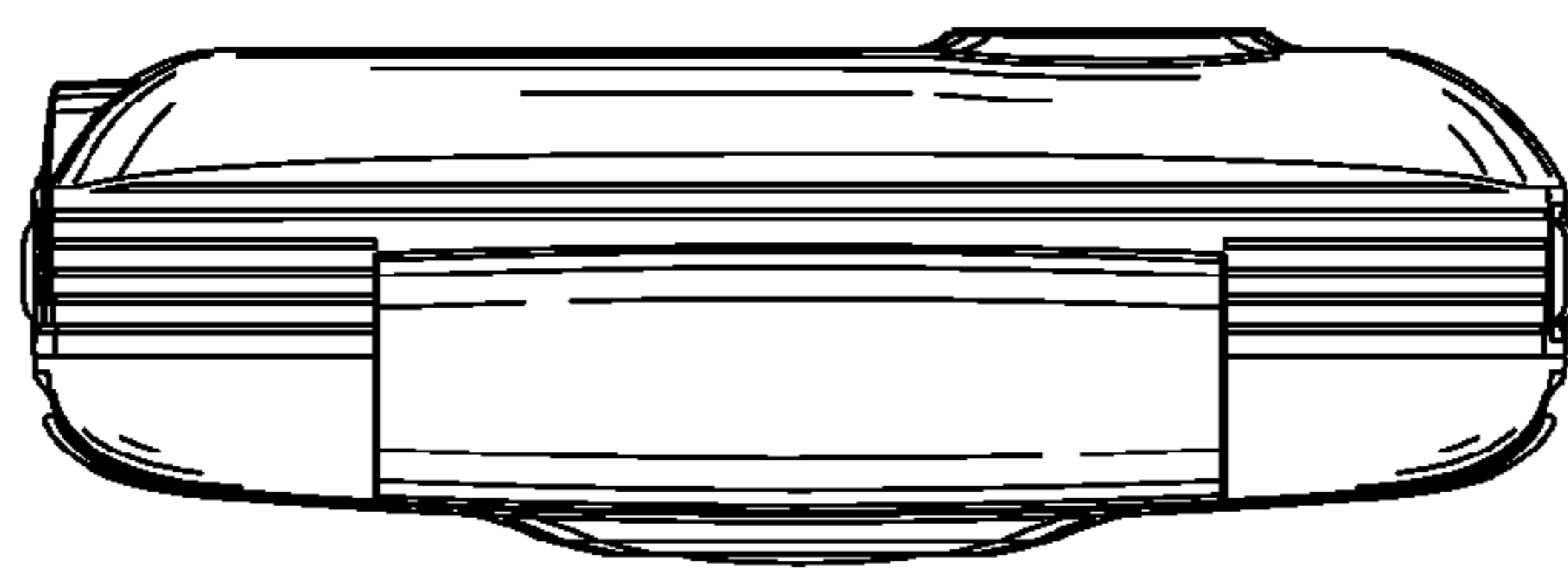

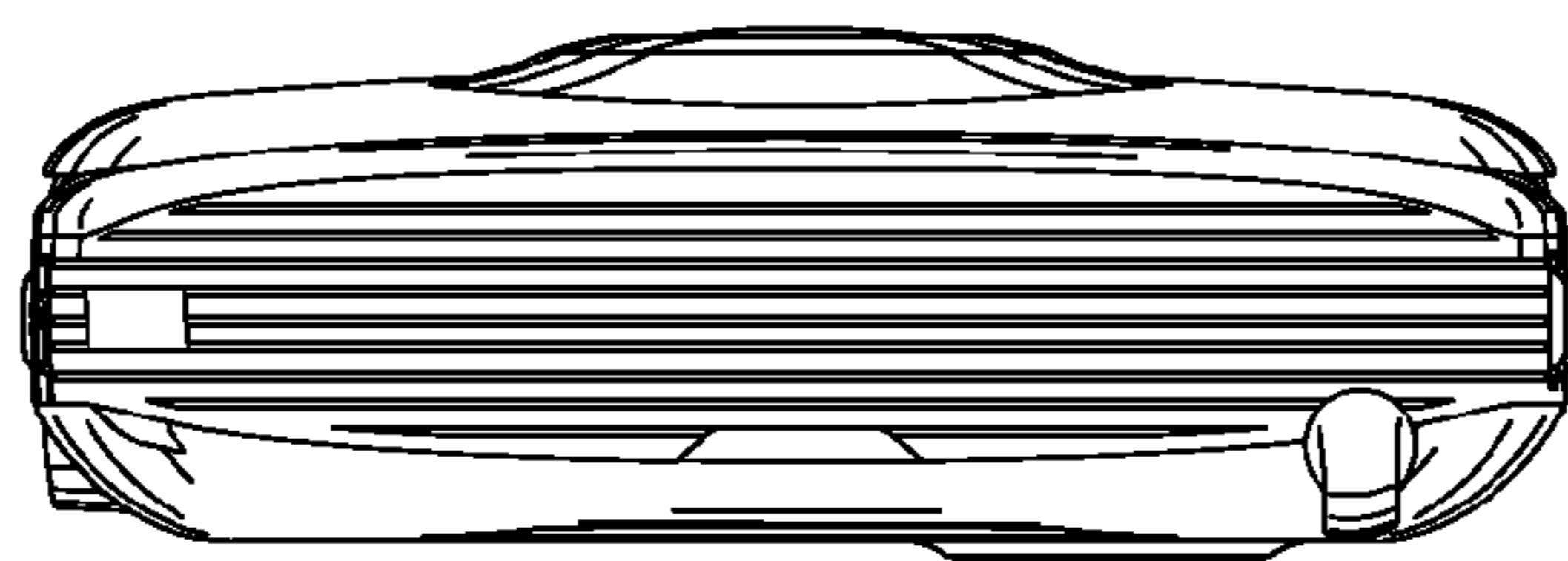

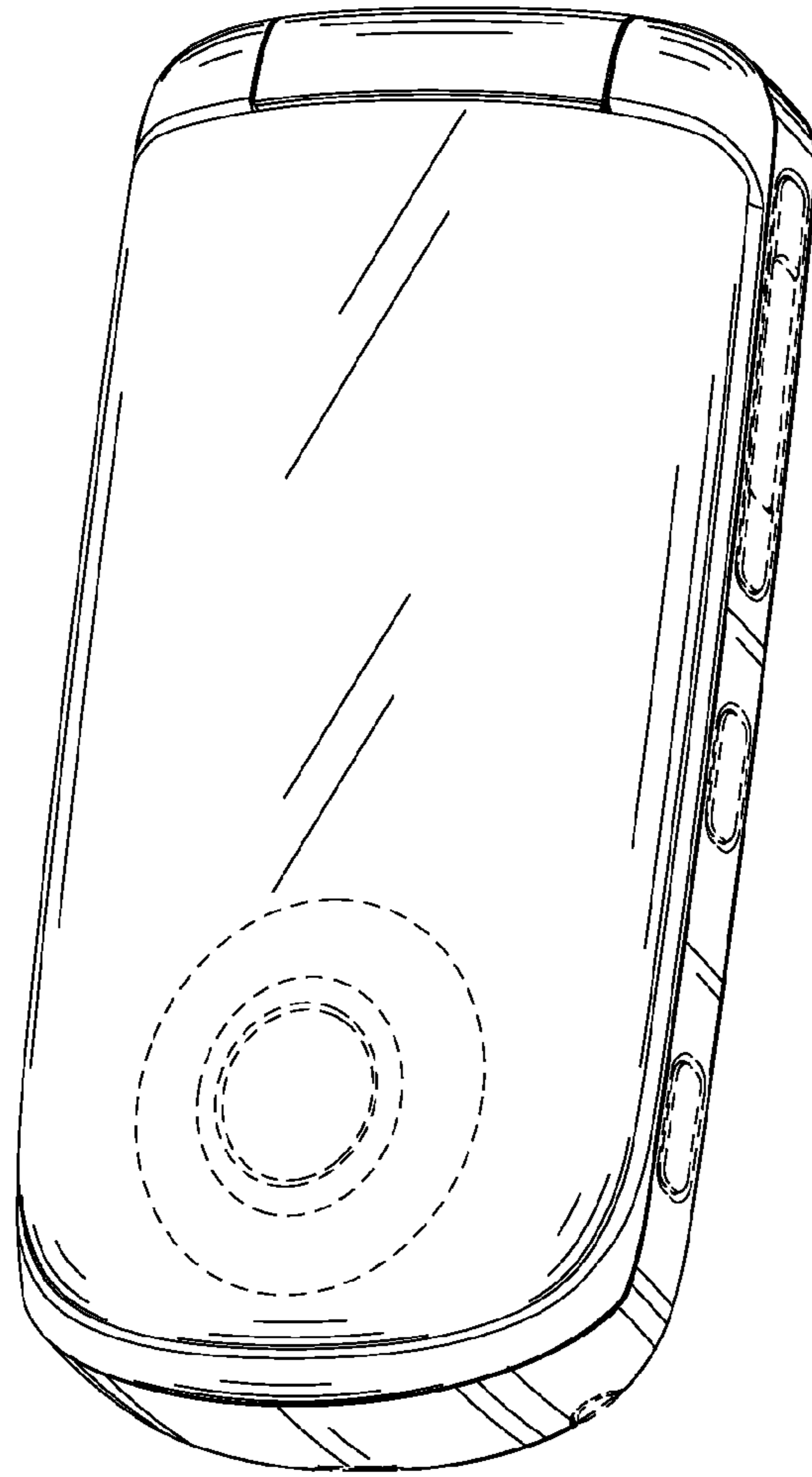

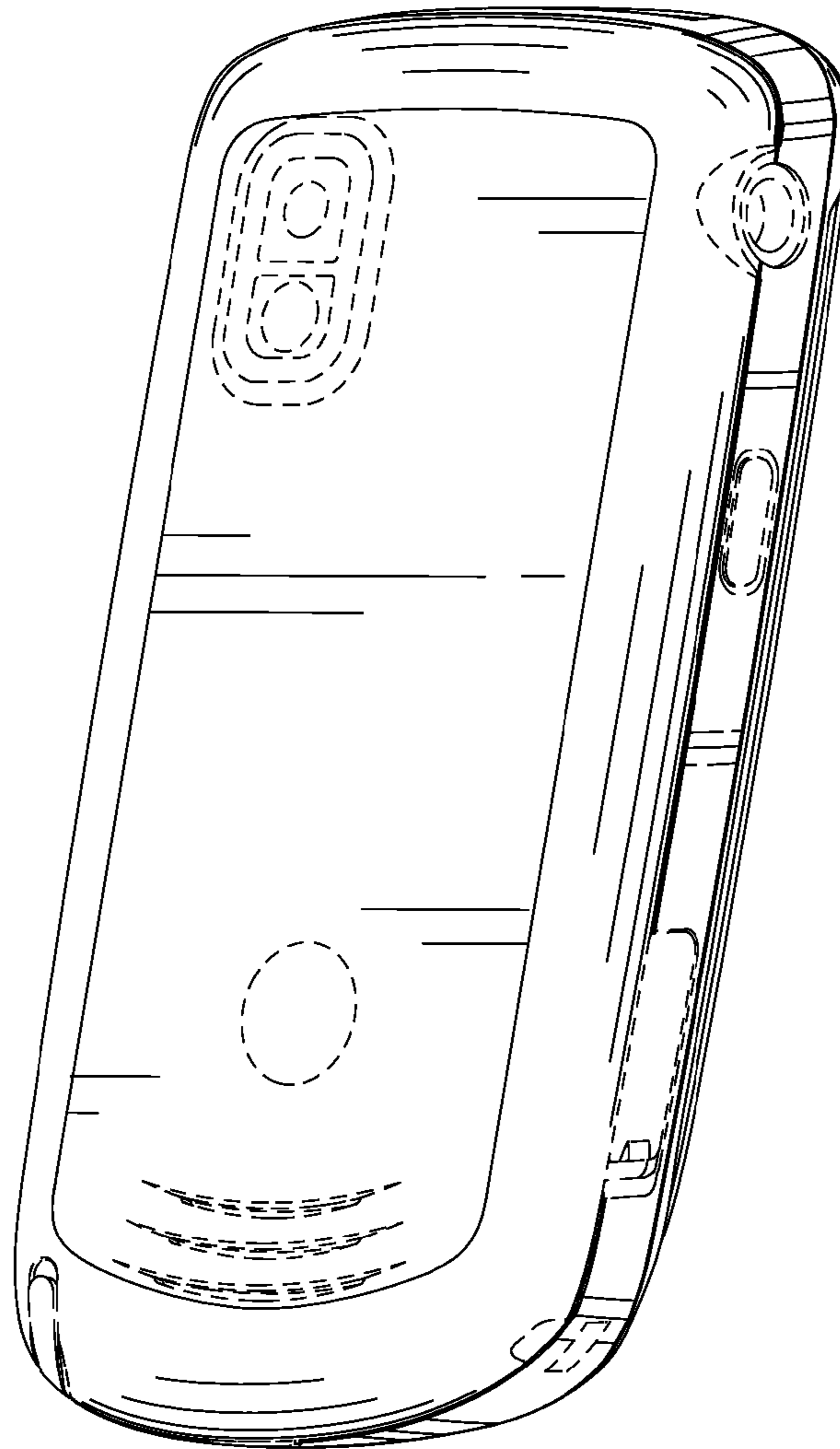

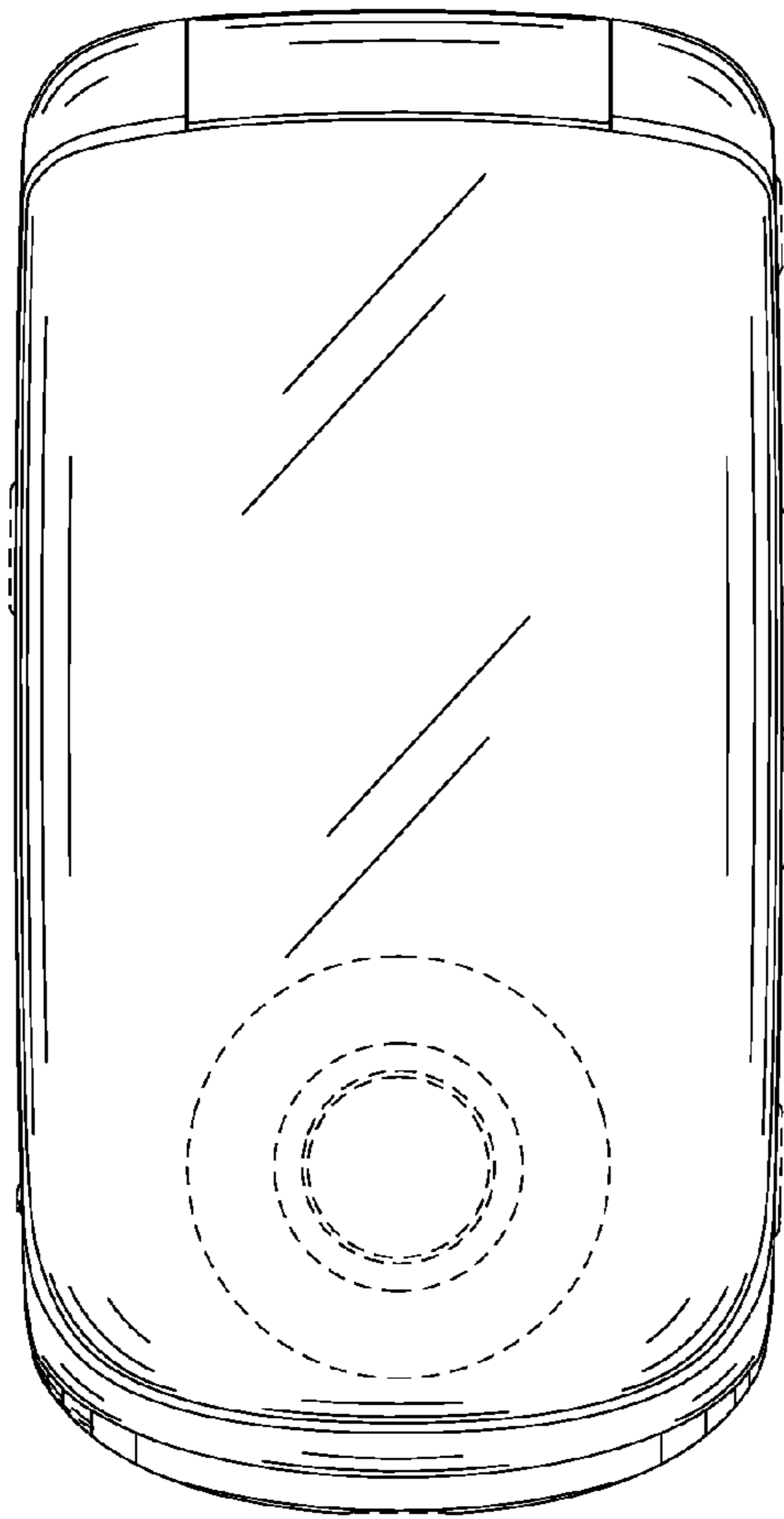

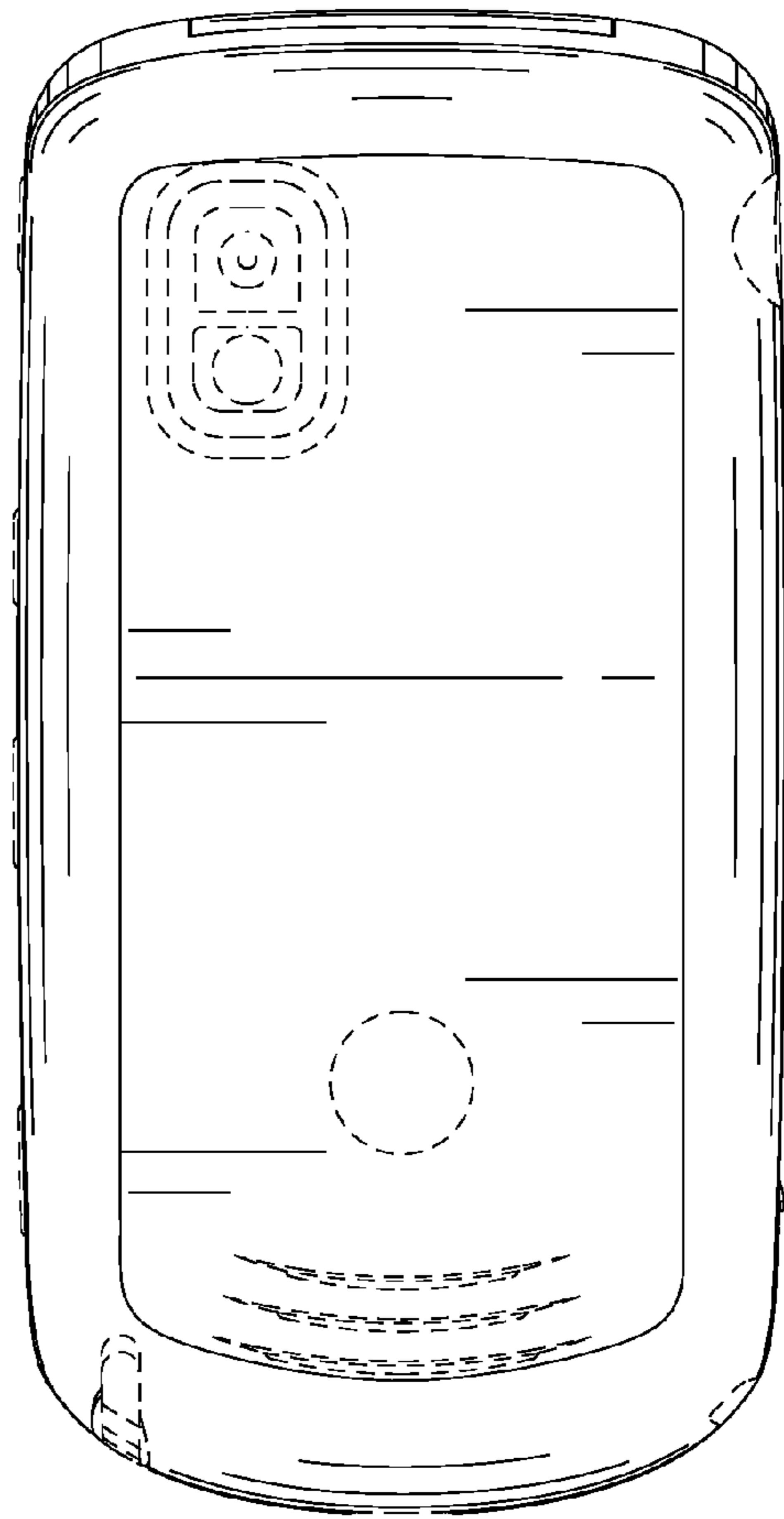

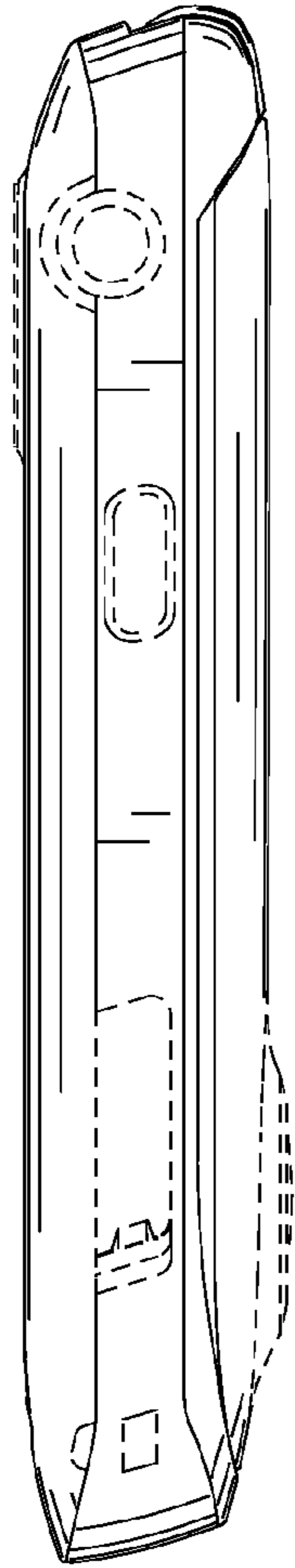

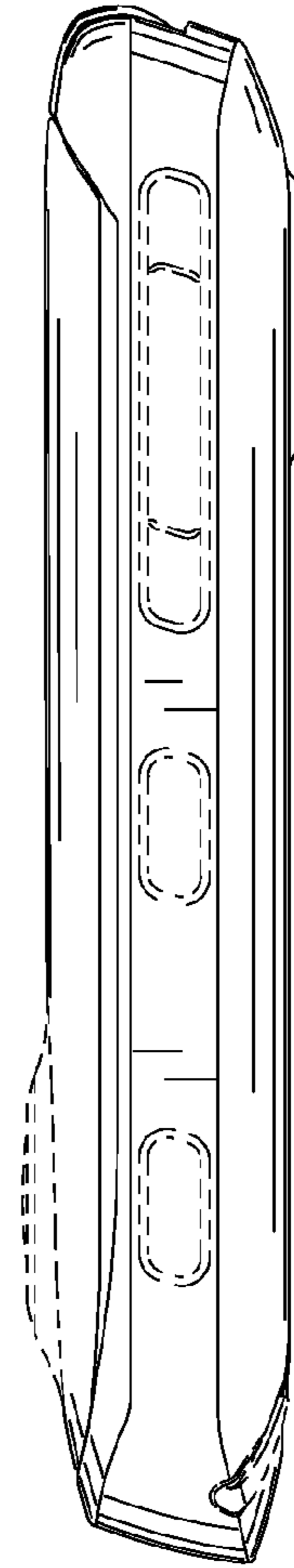

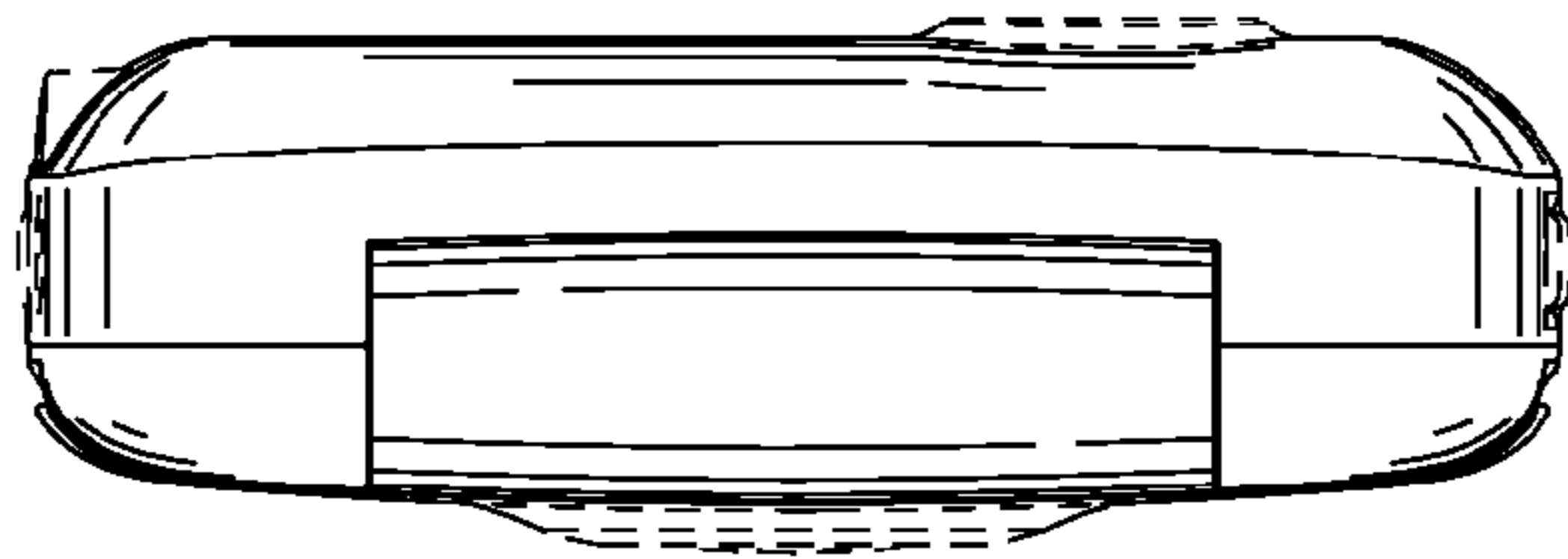

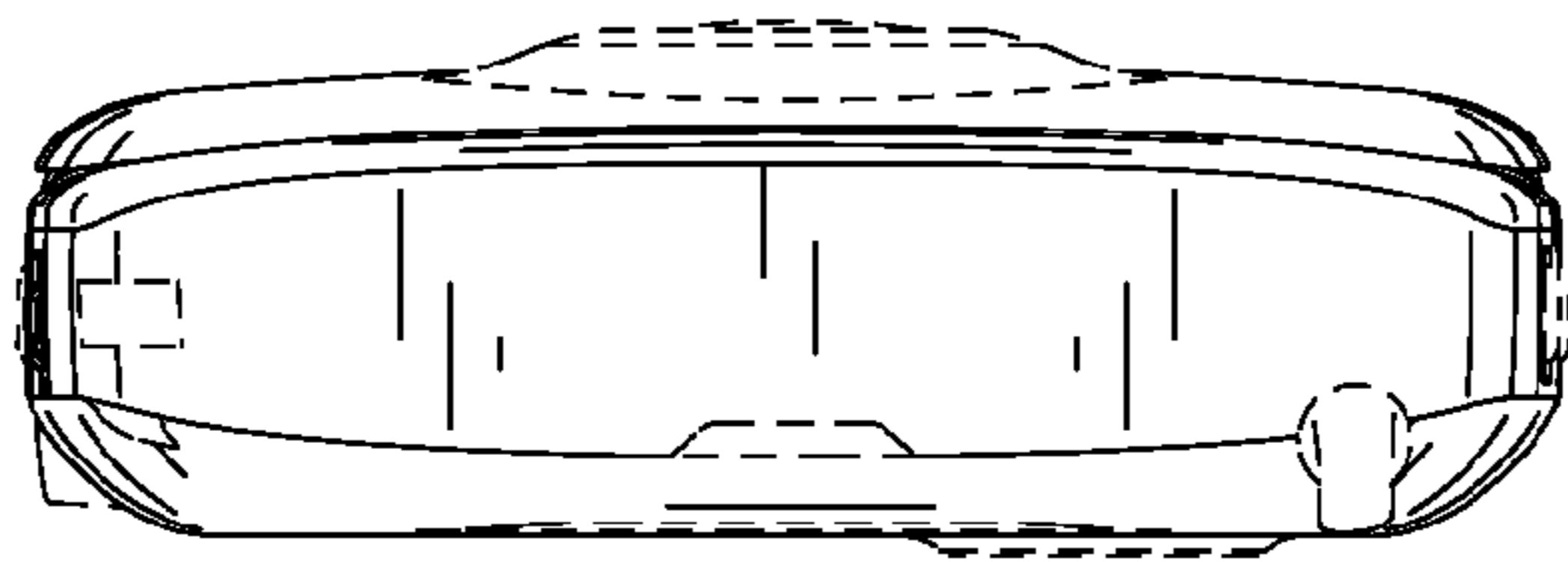

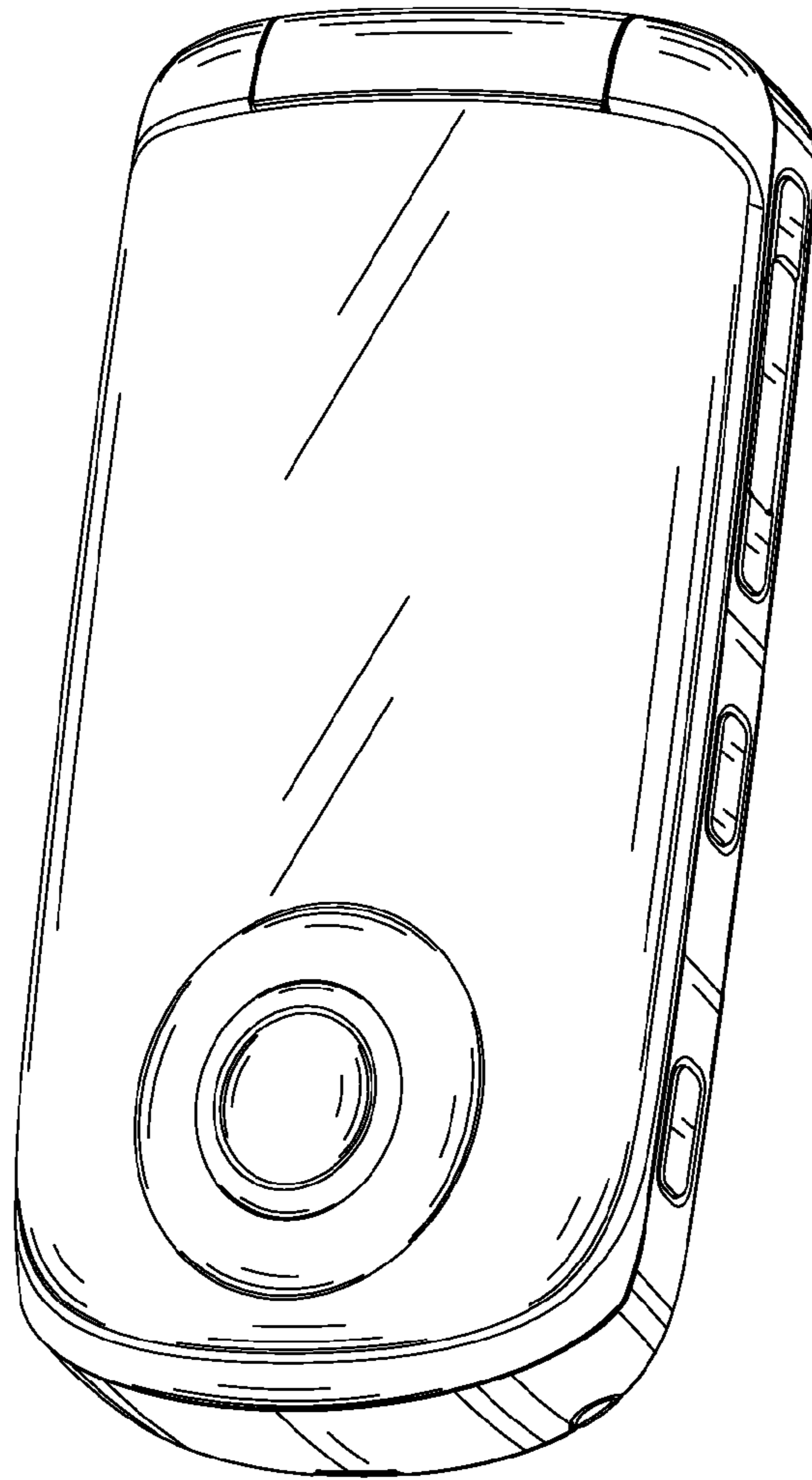

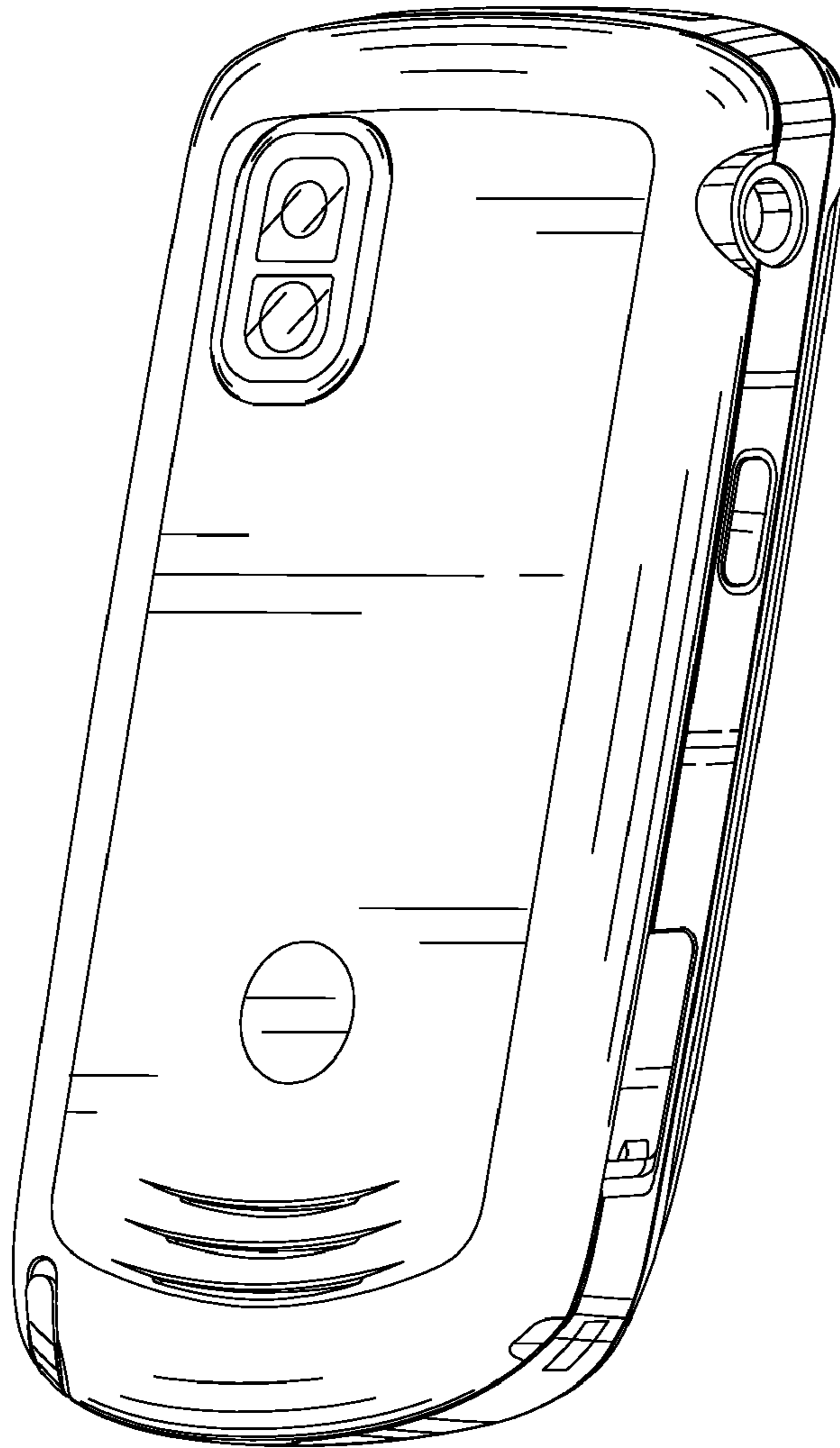

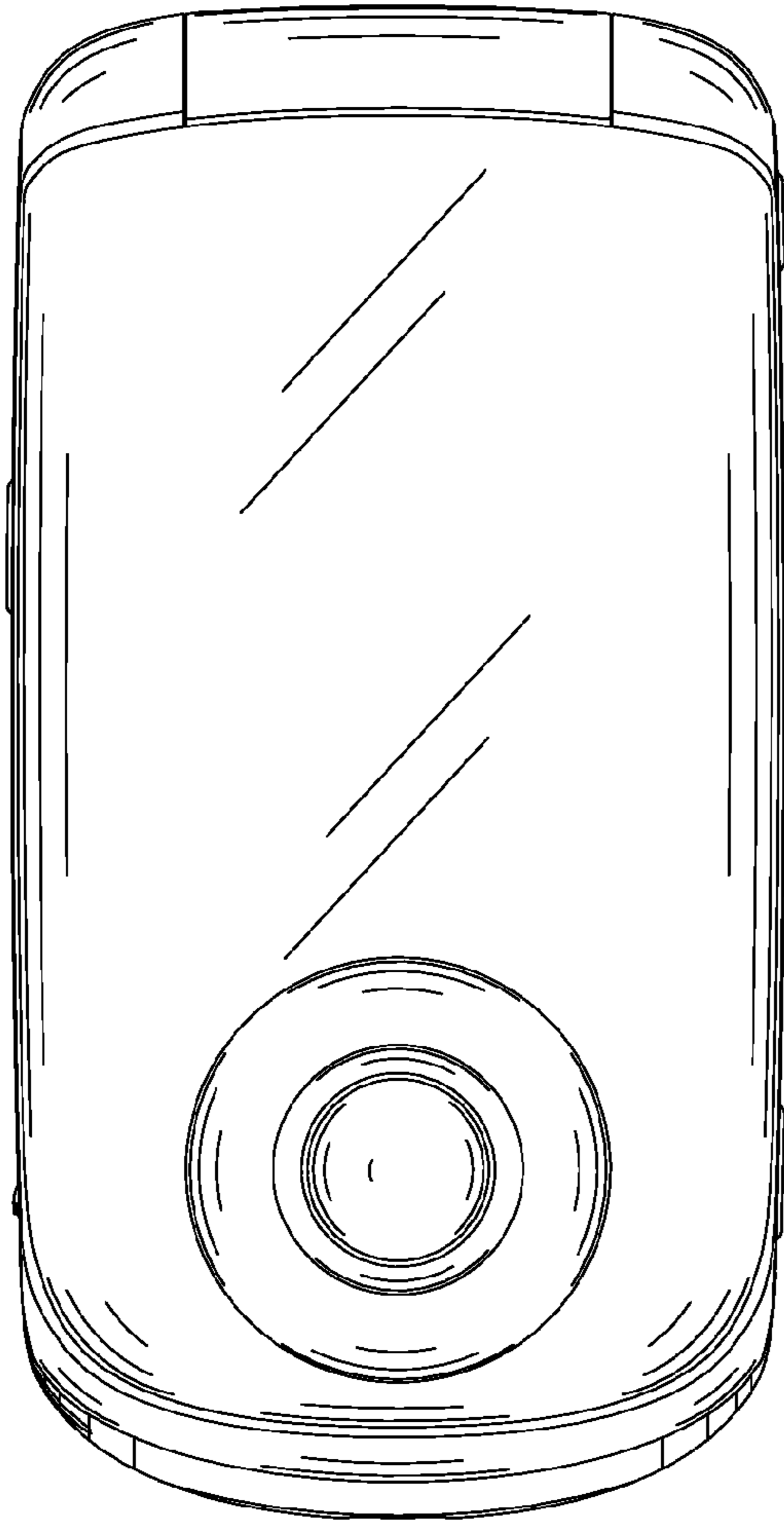

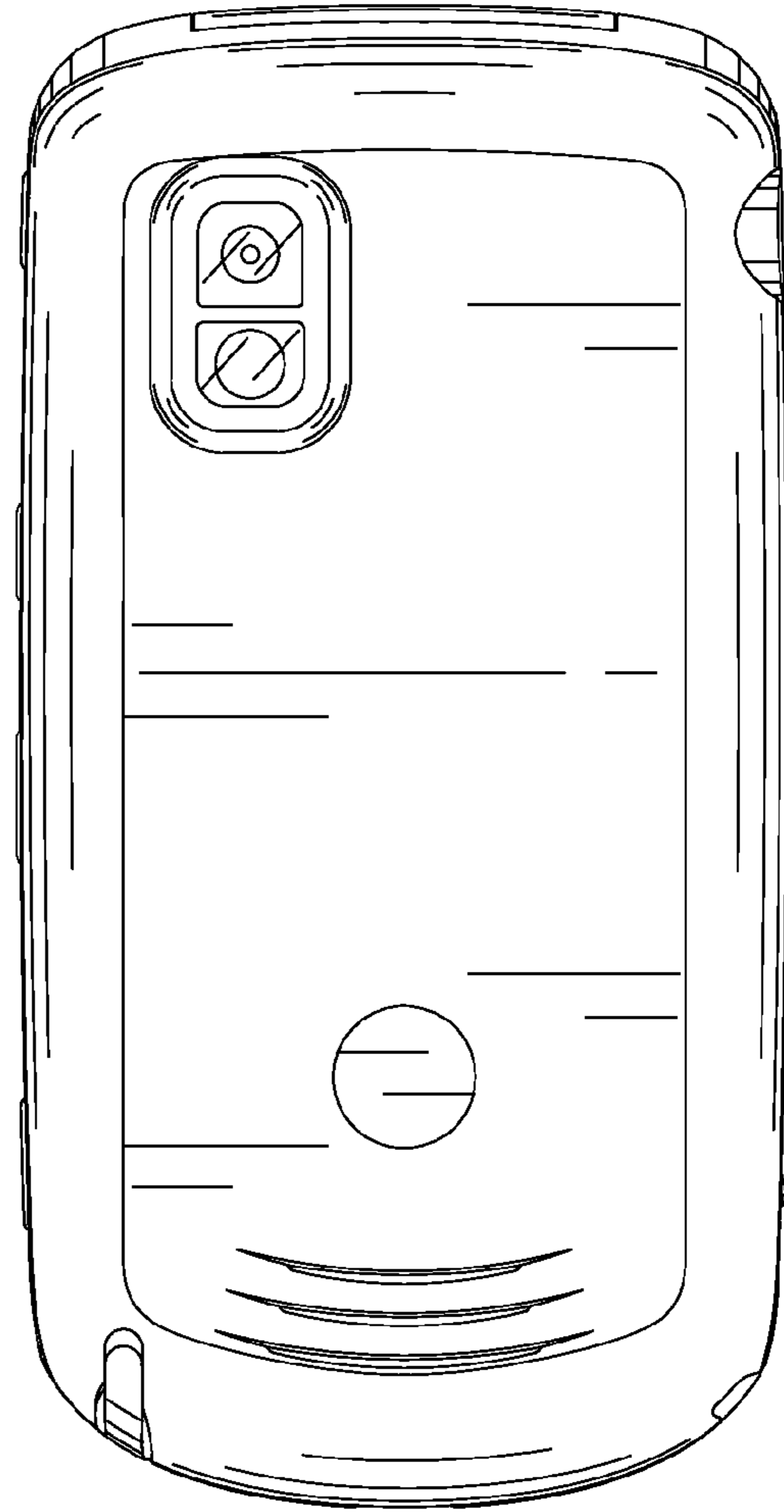

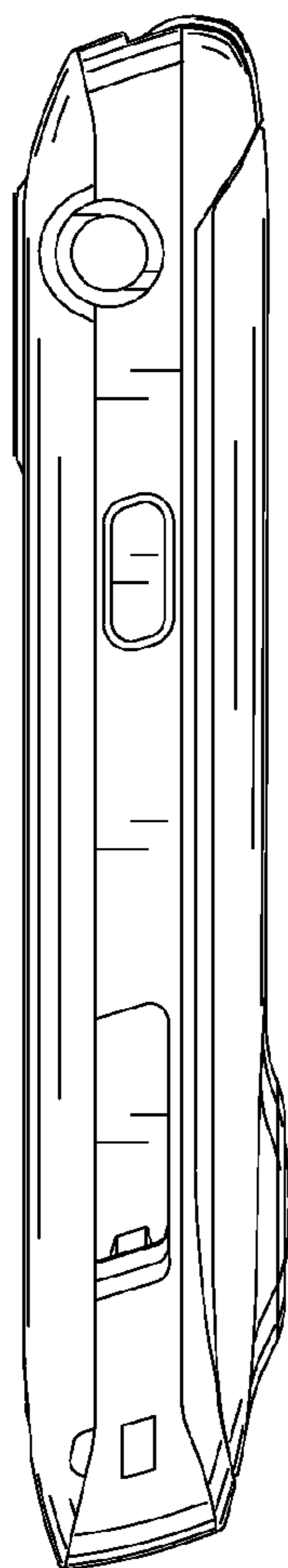

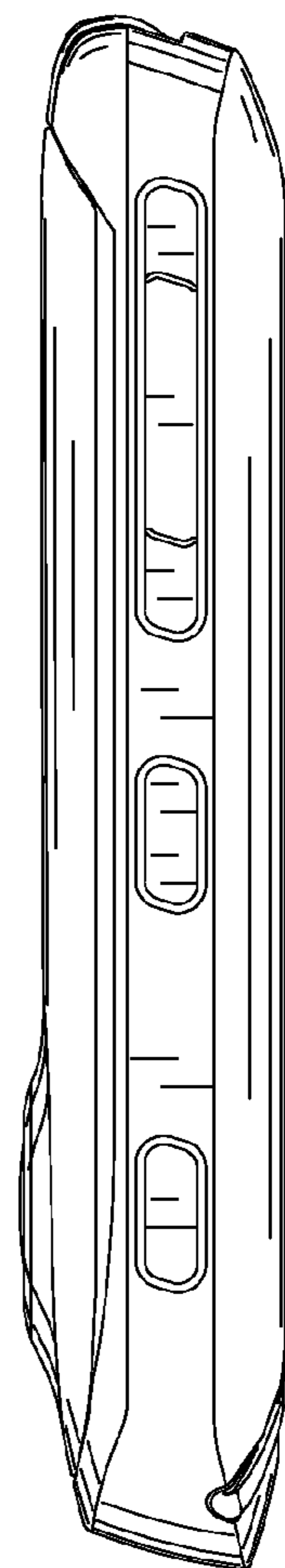

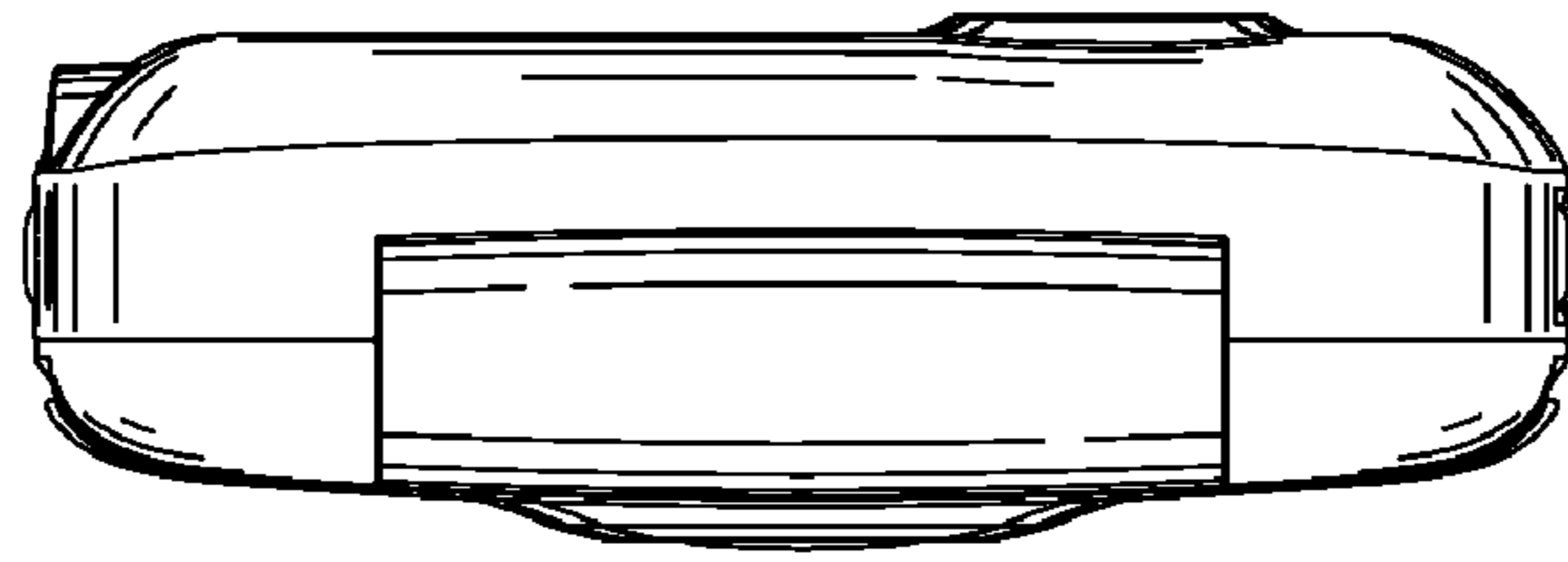

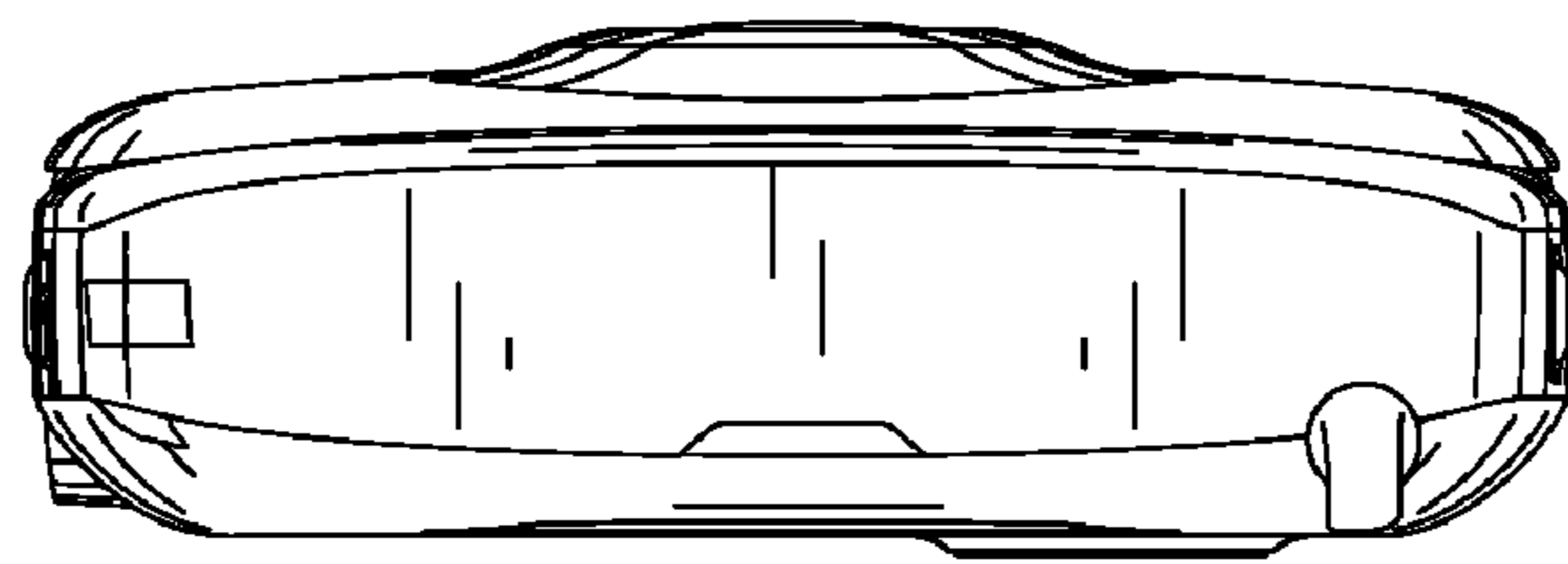
