FIG. 3 is a right side elevational view thereof,

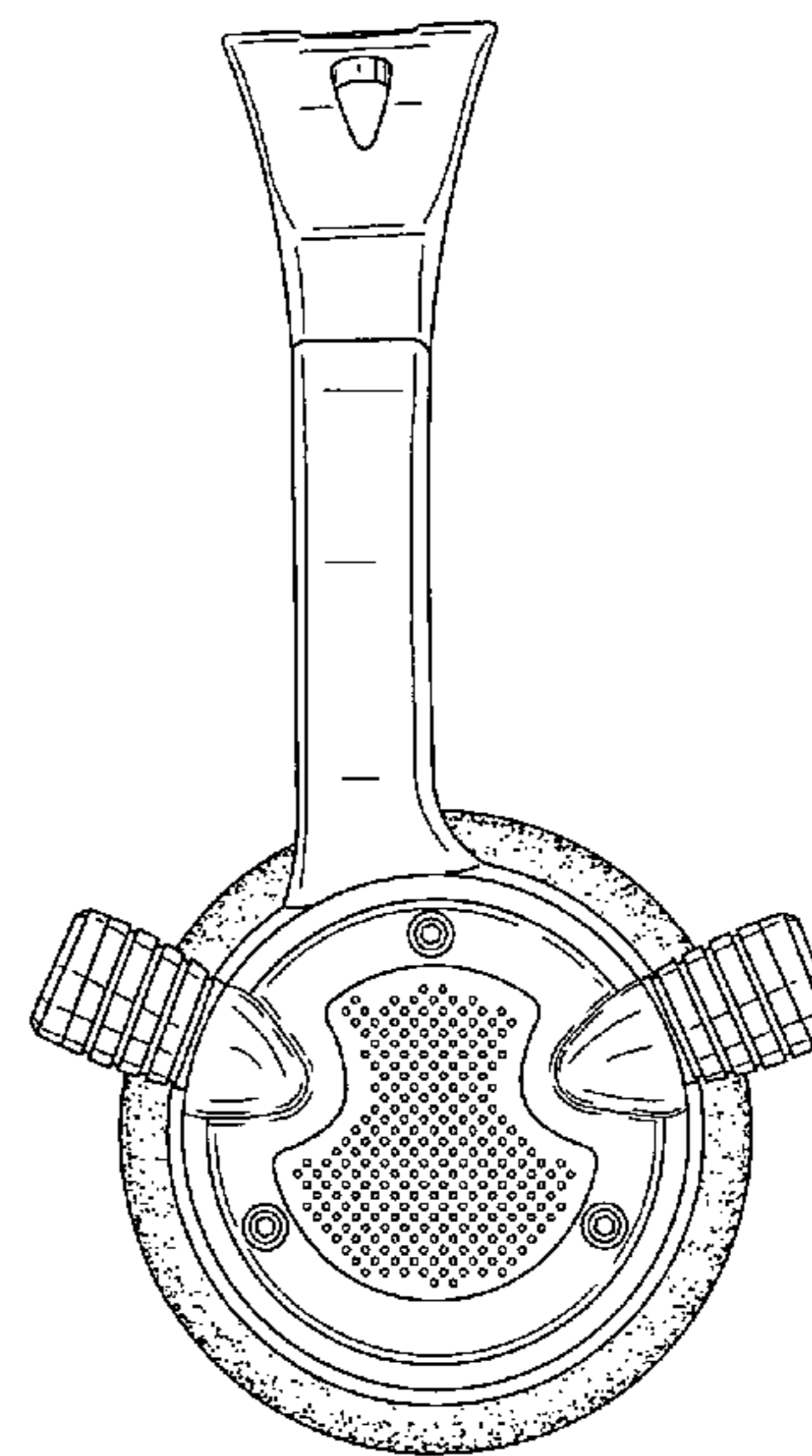
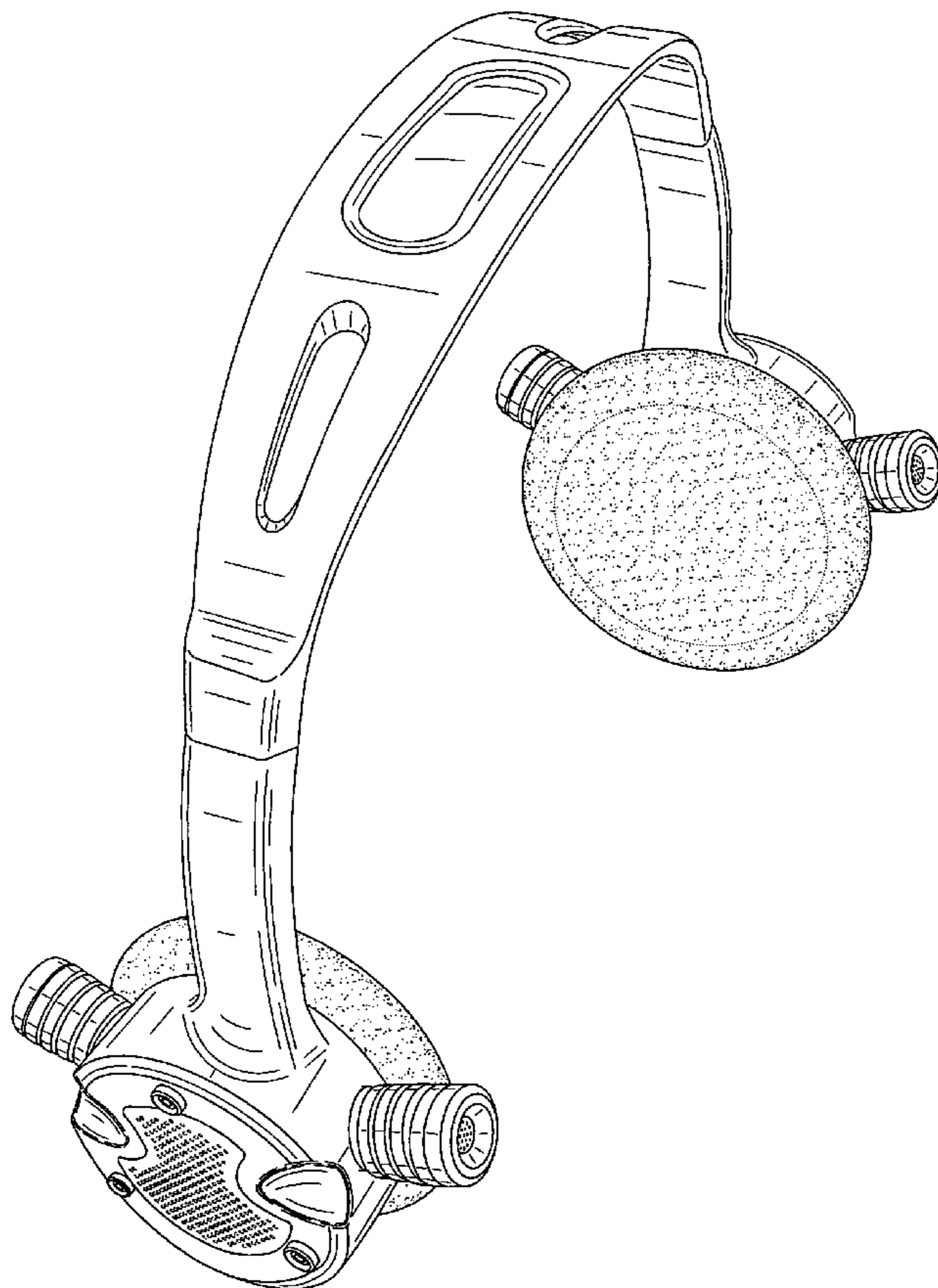
FIG. 4 is a front elevational view thereof,

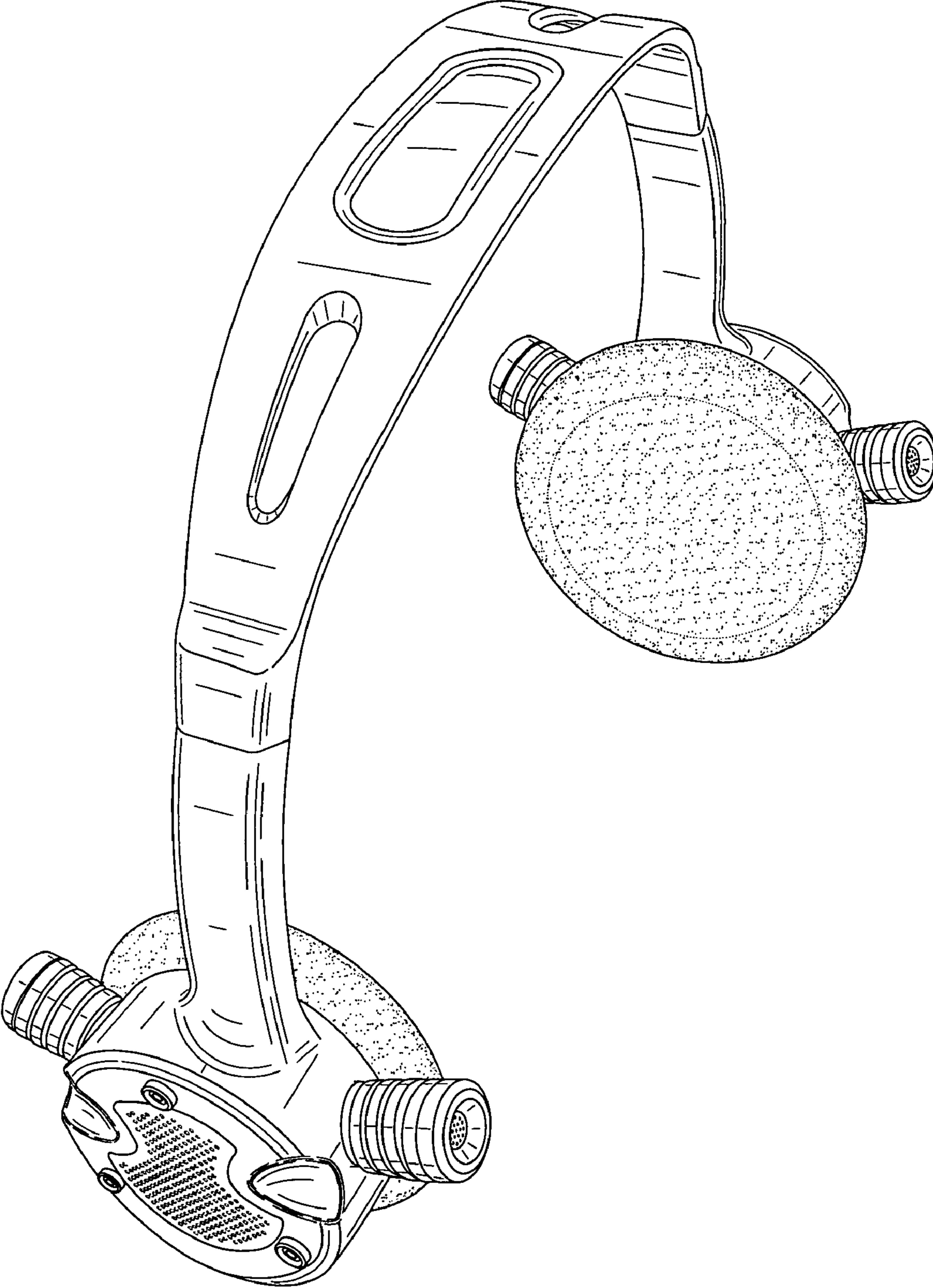

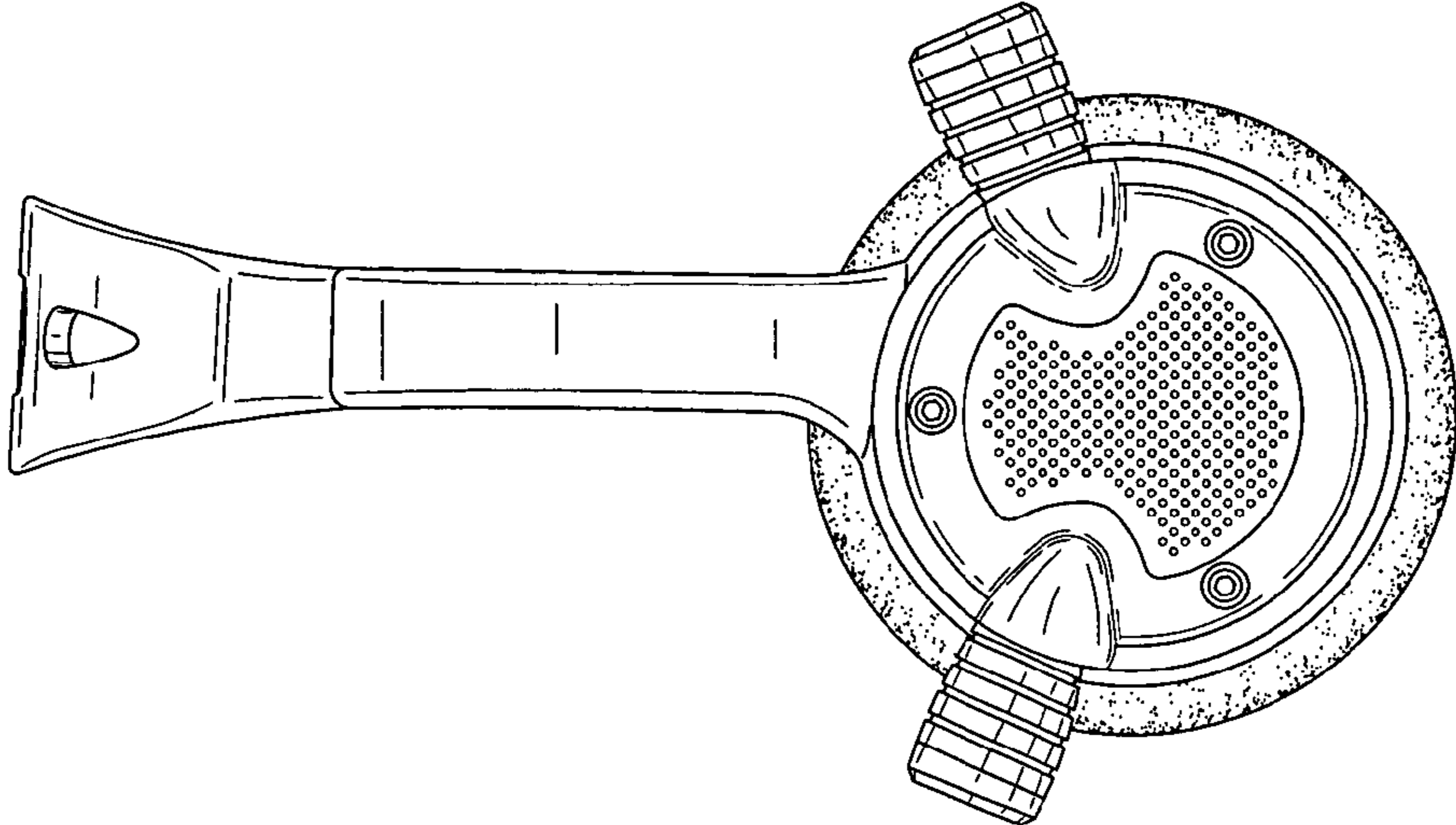

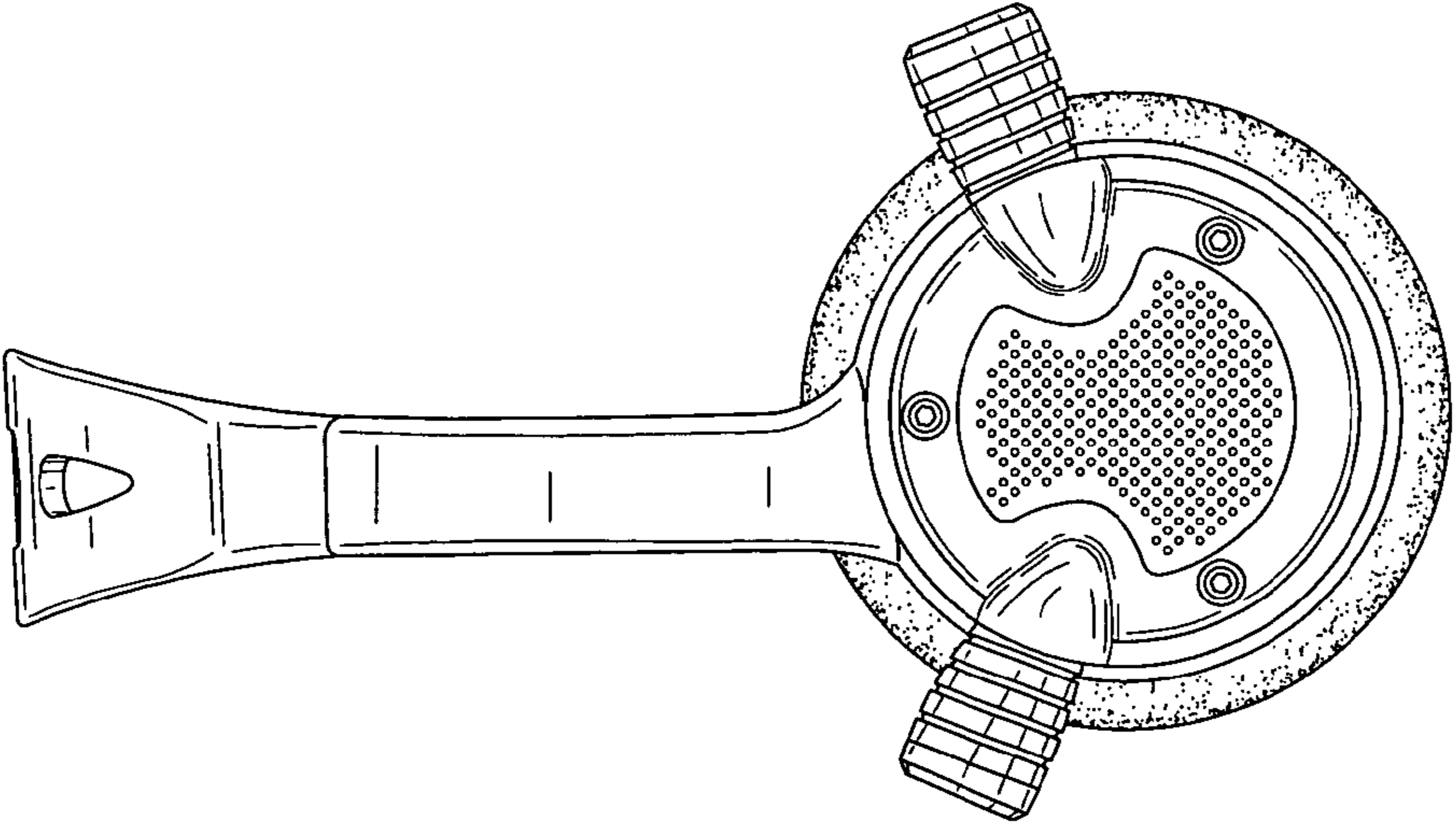

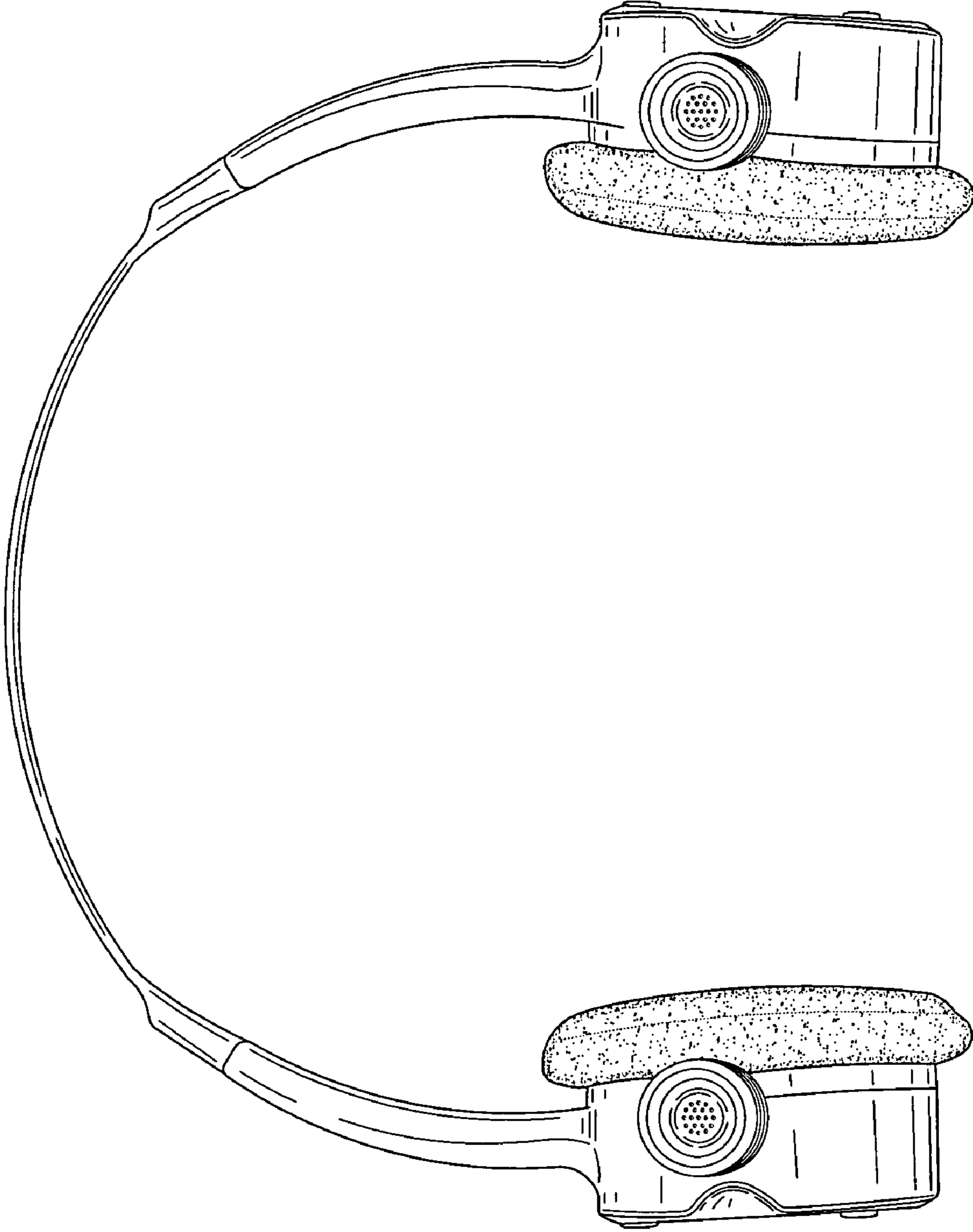

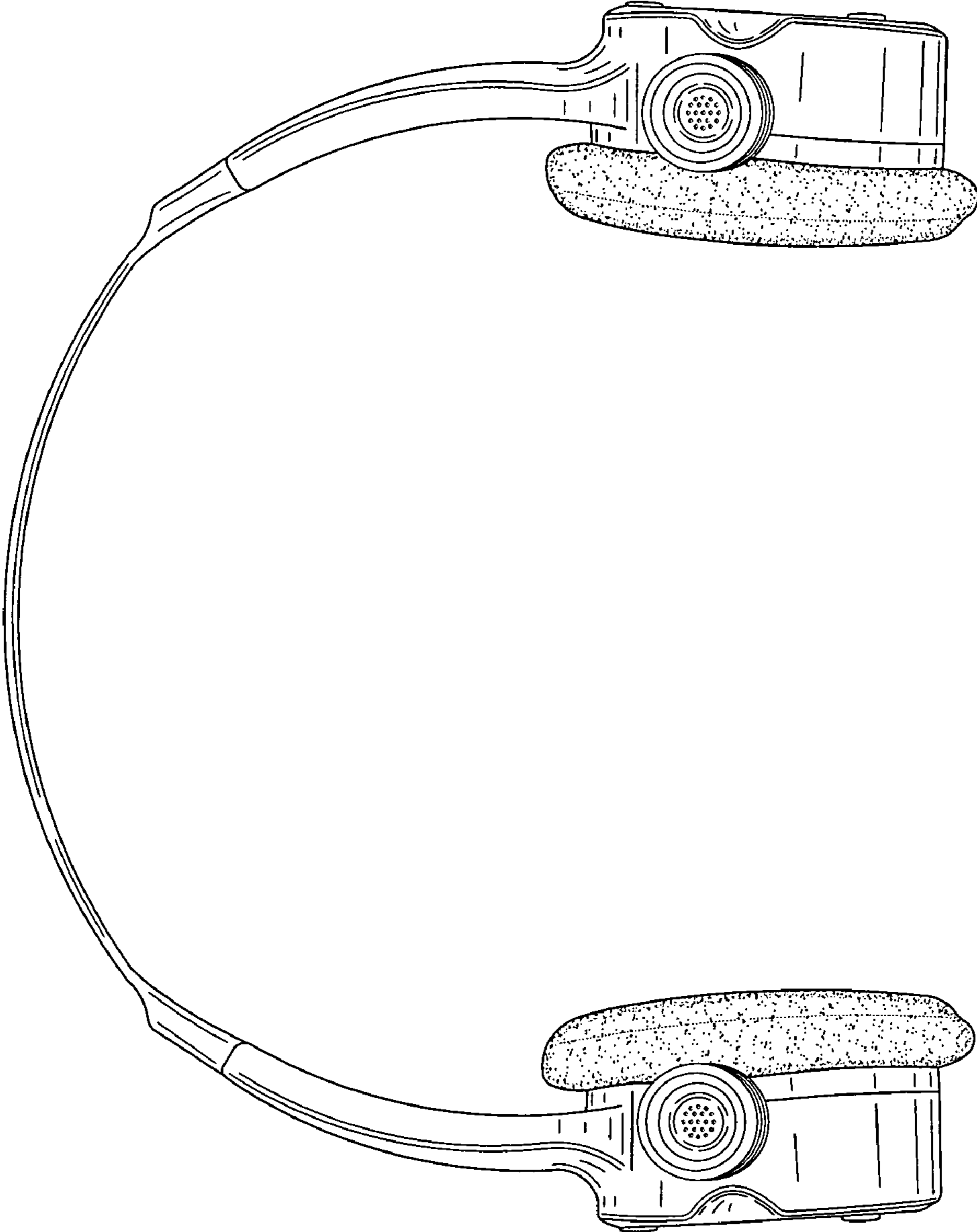
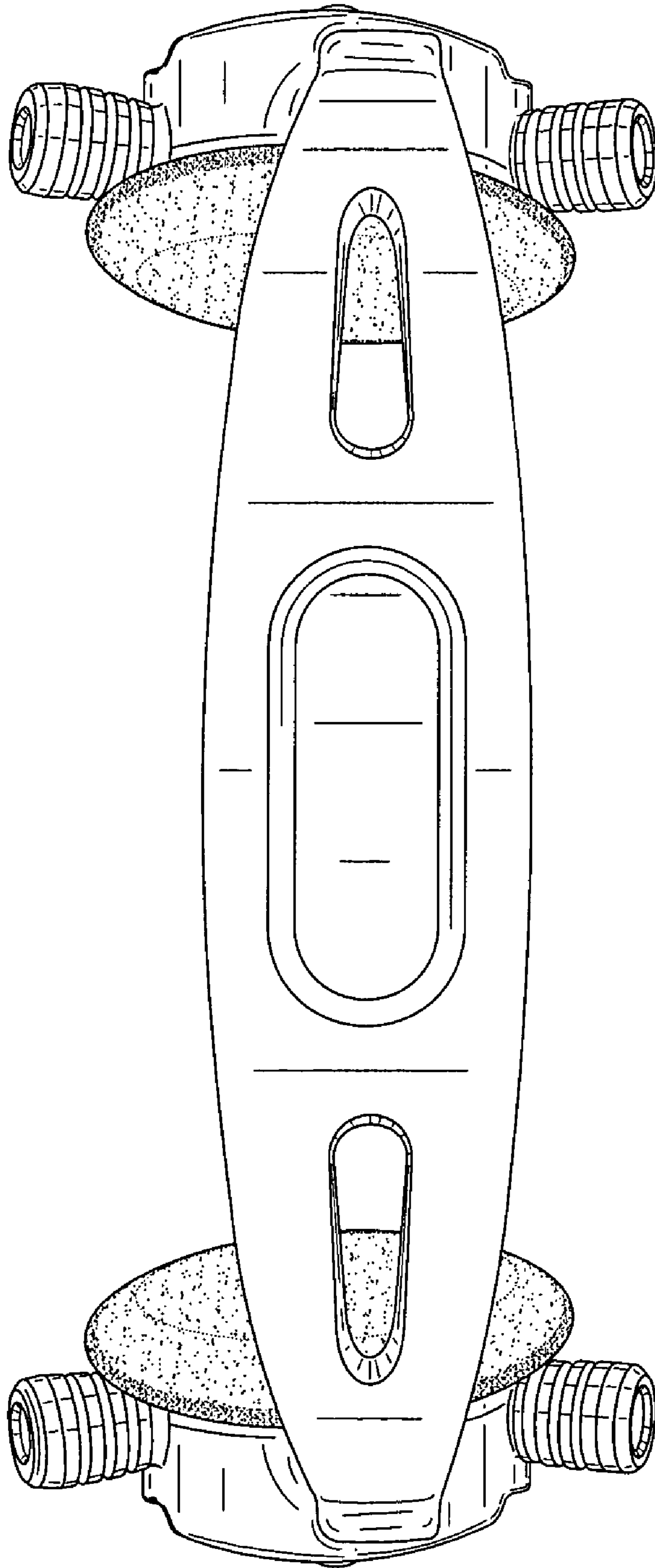

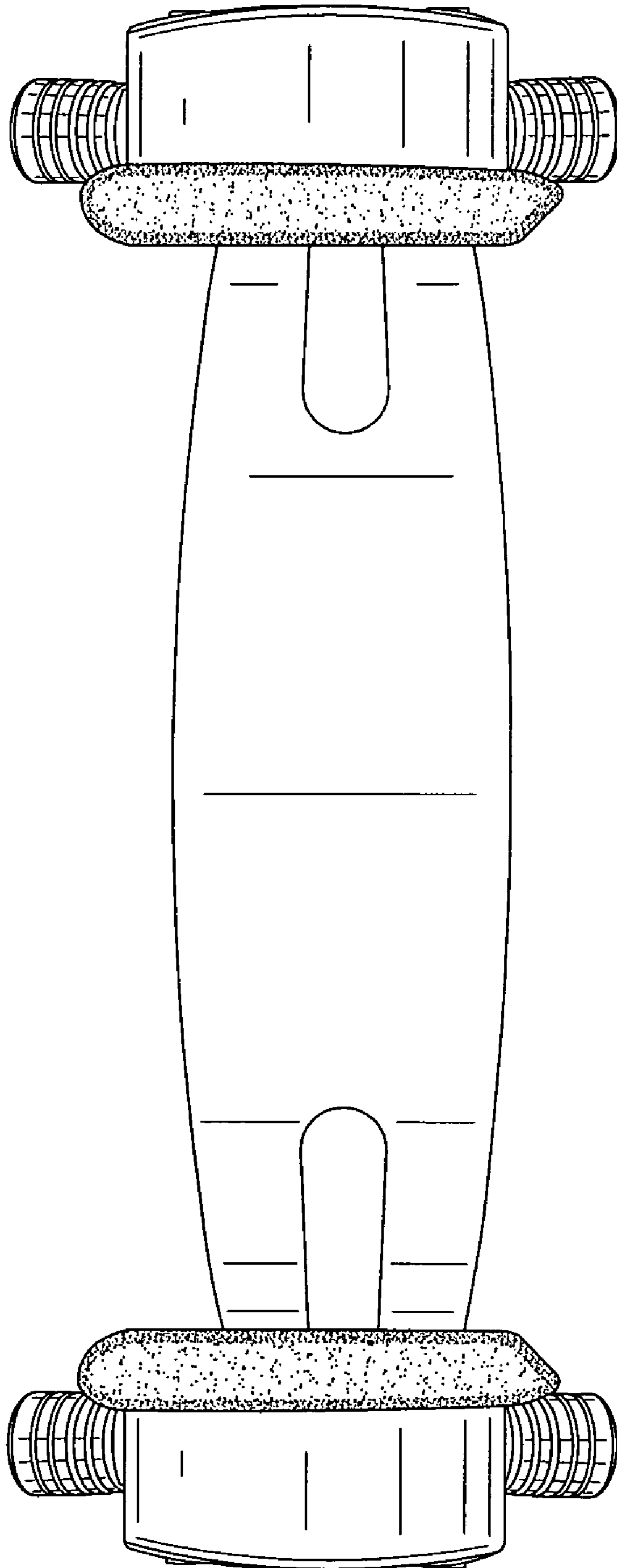
