FIG. 1 is a front perspective view of the flexible storage sleeve for holding two USB storage devices;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a right elevation view thereof;

FIG. 6 is a bottom plan view thereof;

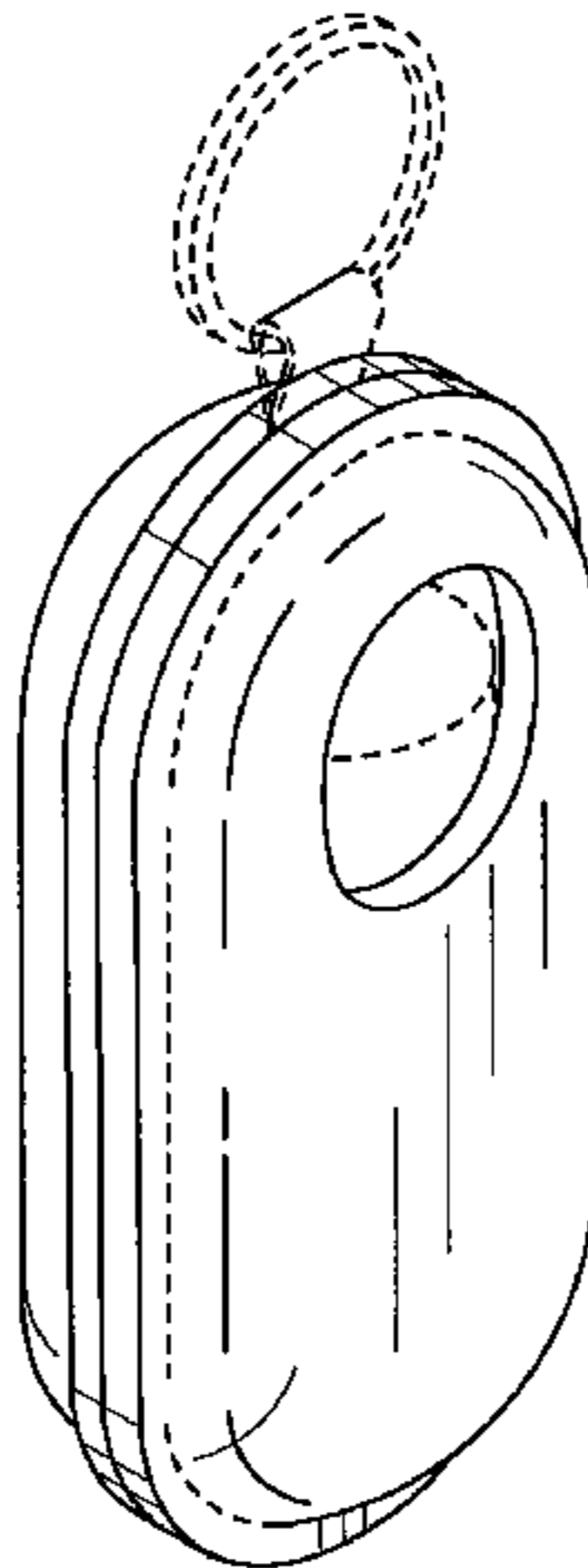

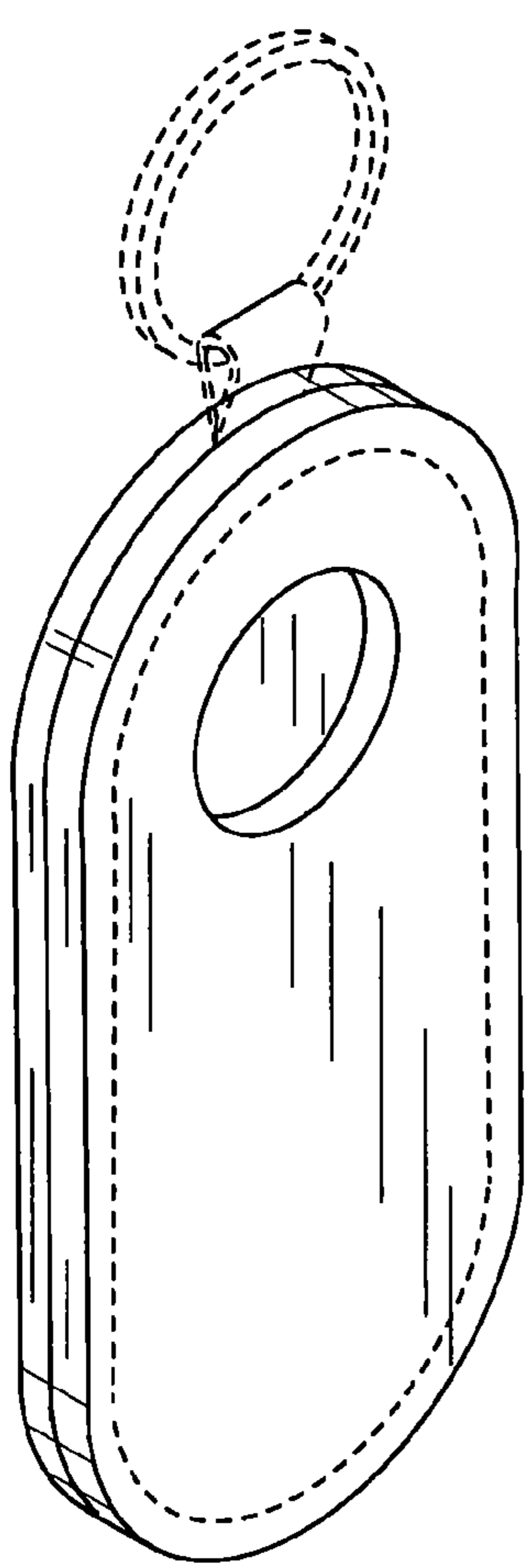

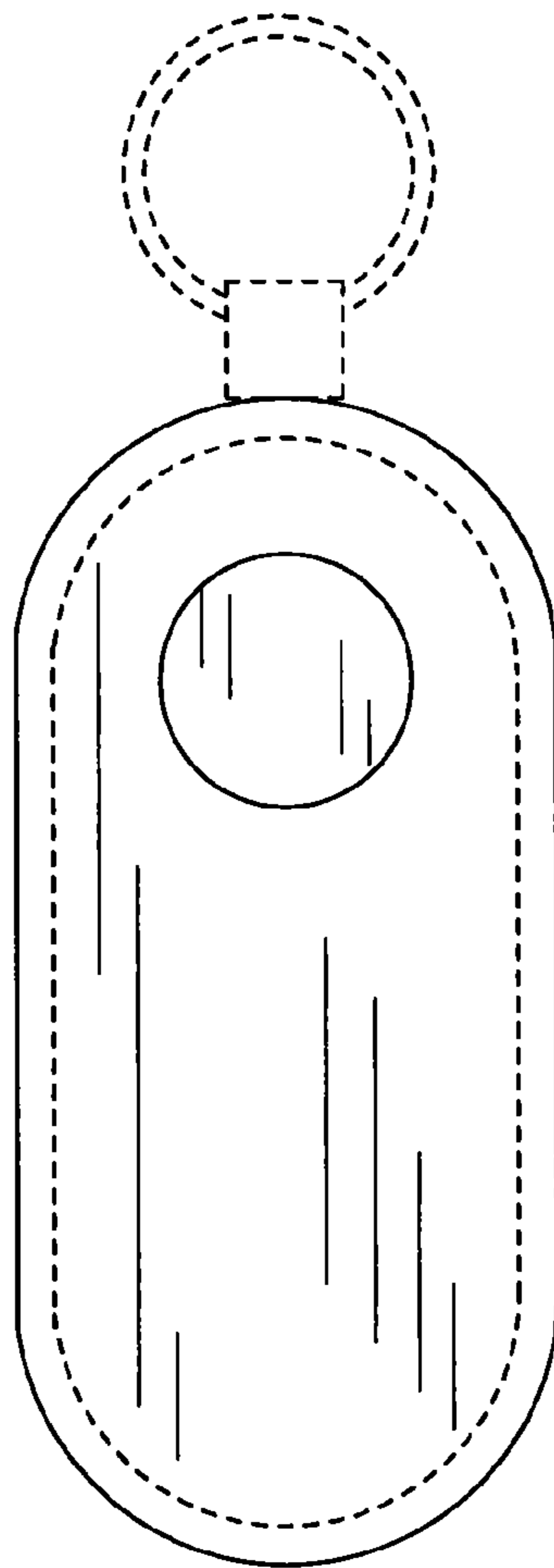

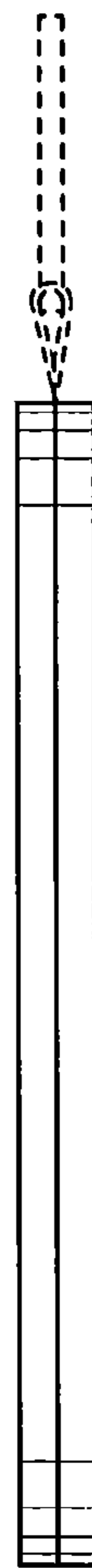

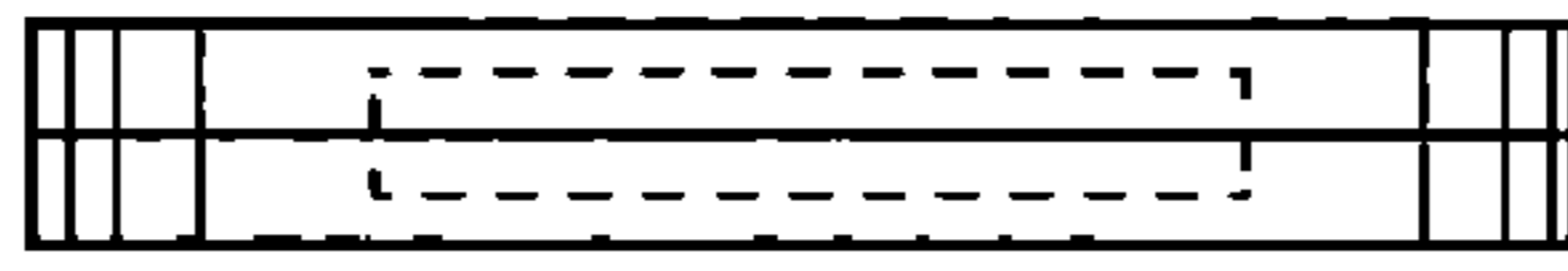

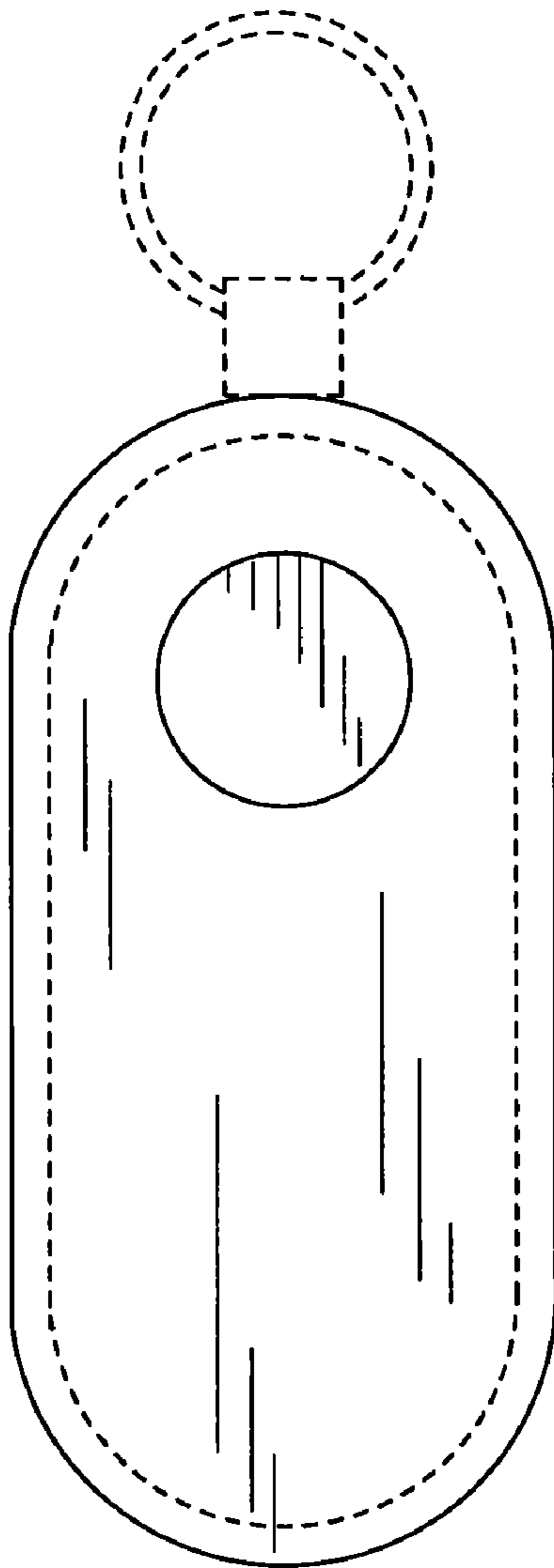

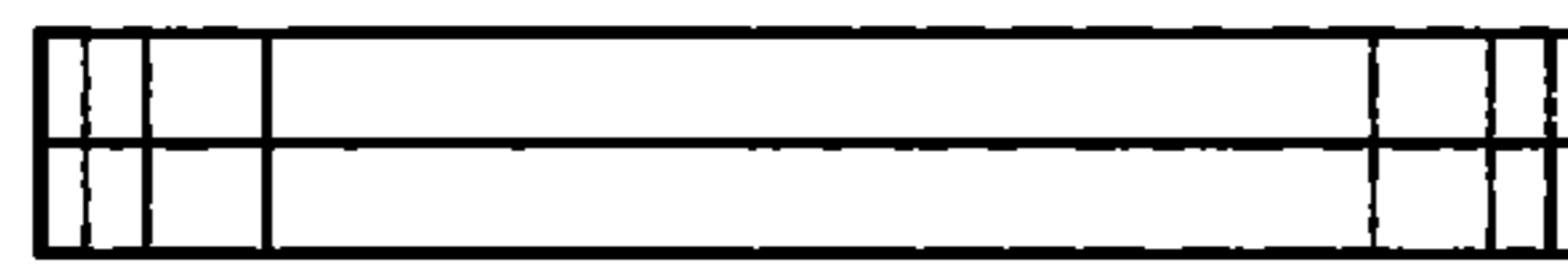
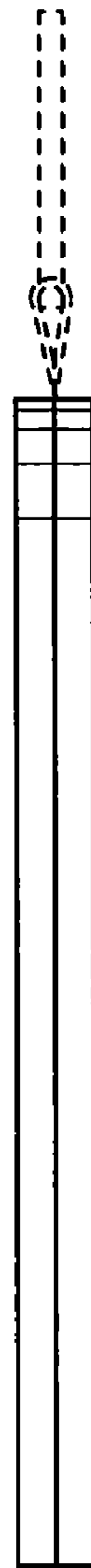

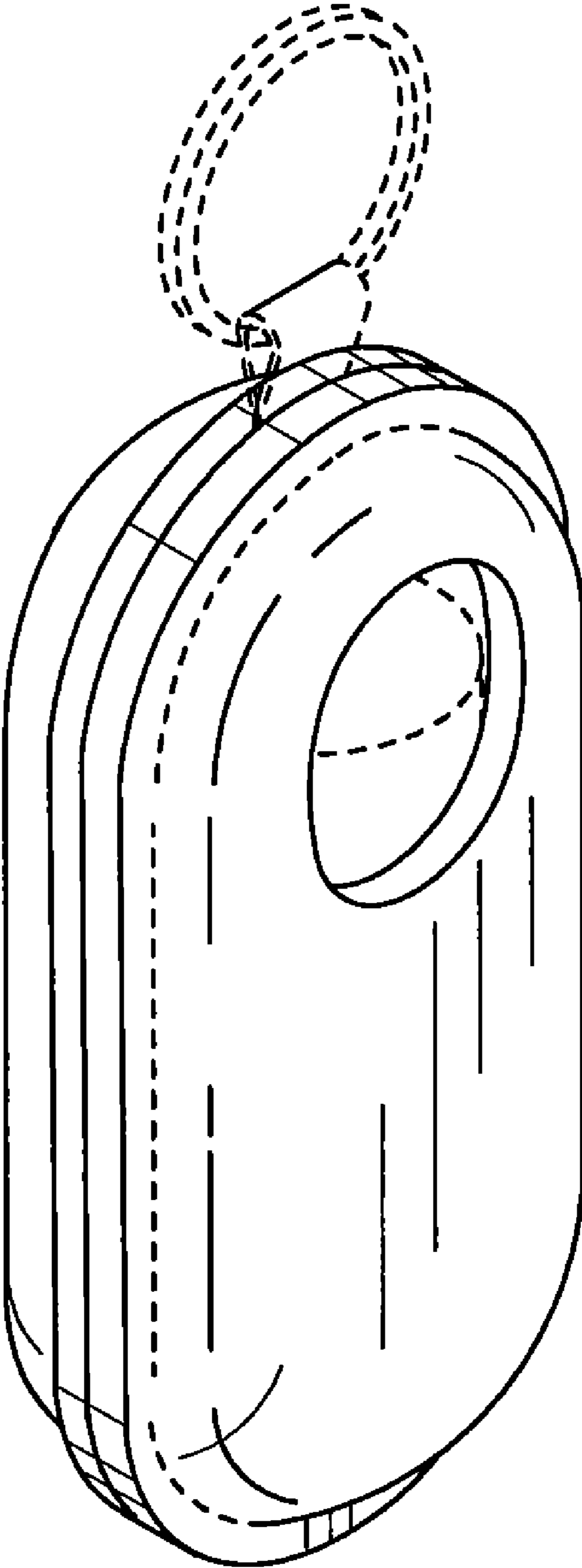
