The ornamental design for a computer with an icon, as shown and described.

**DESCRIPTION**

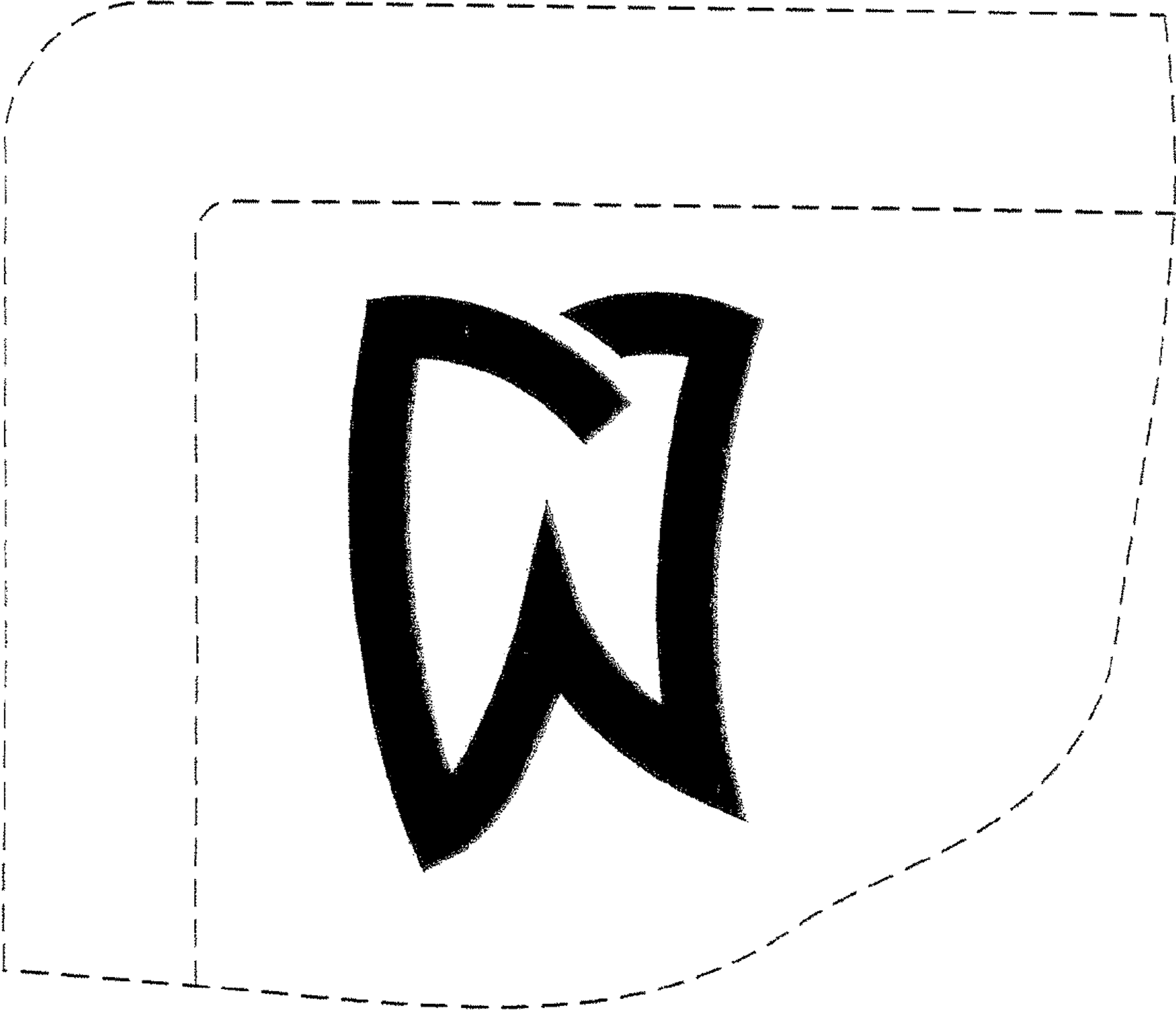
FIG. 1 is a front view of a computer with an icon according to the present design; and,
