FIG. 1 is a perspective view of the wear resistant block for use in lining mineral processing equipment showing our new design;

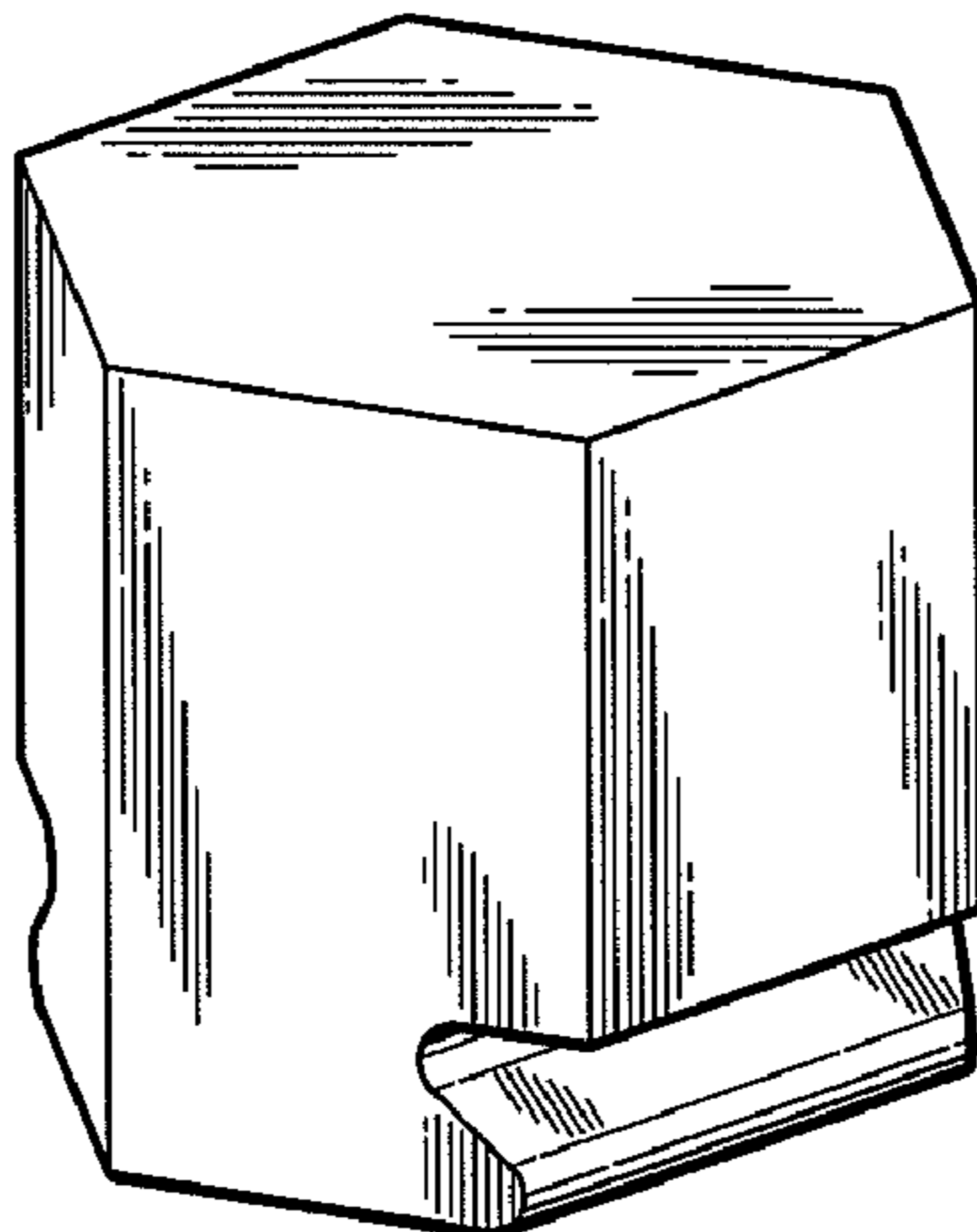
FIG. 2 is a right side view thereof;

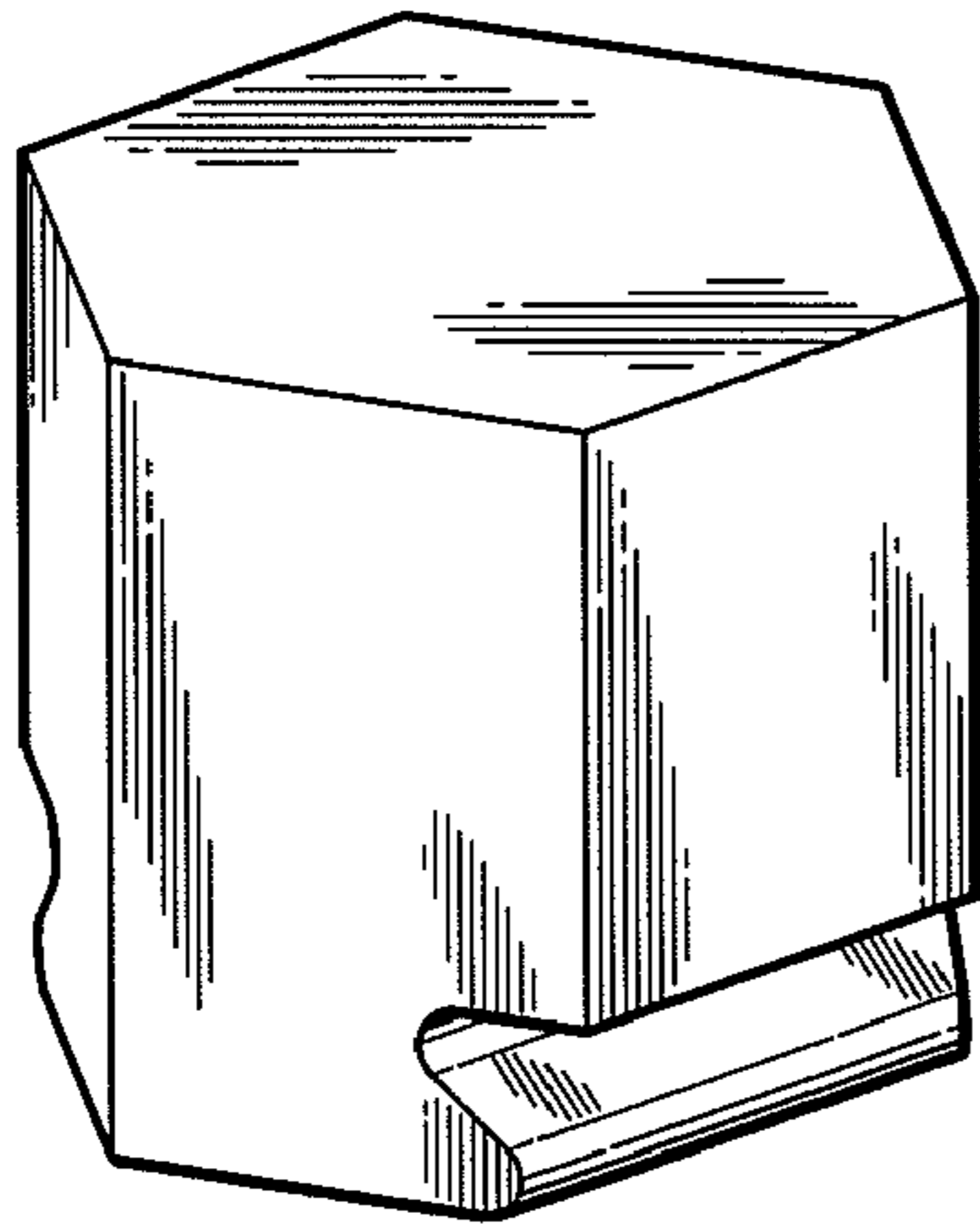

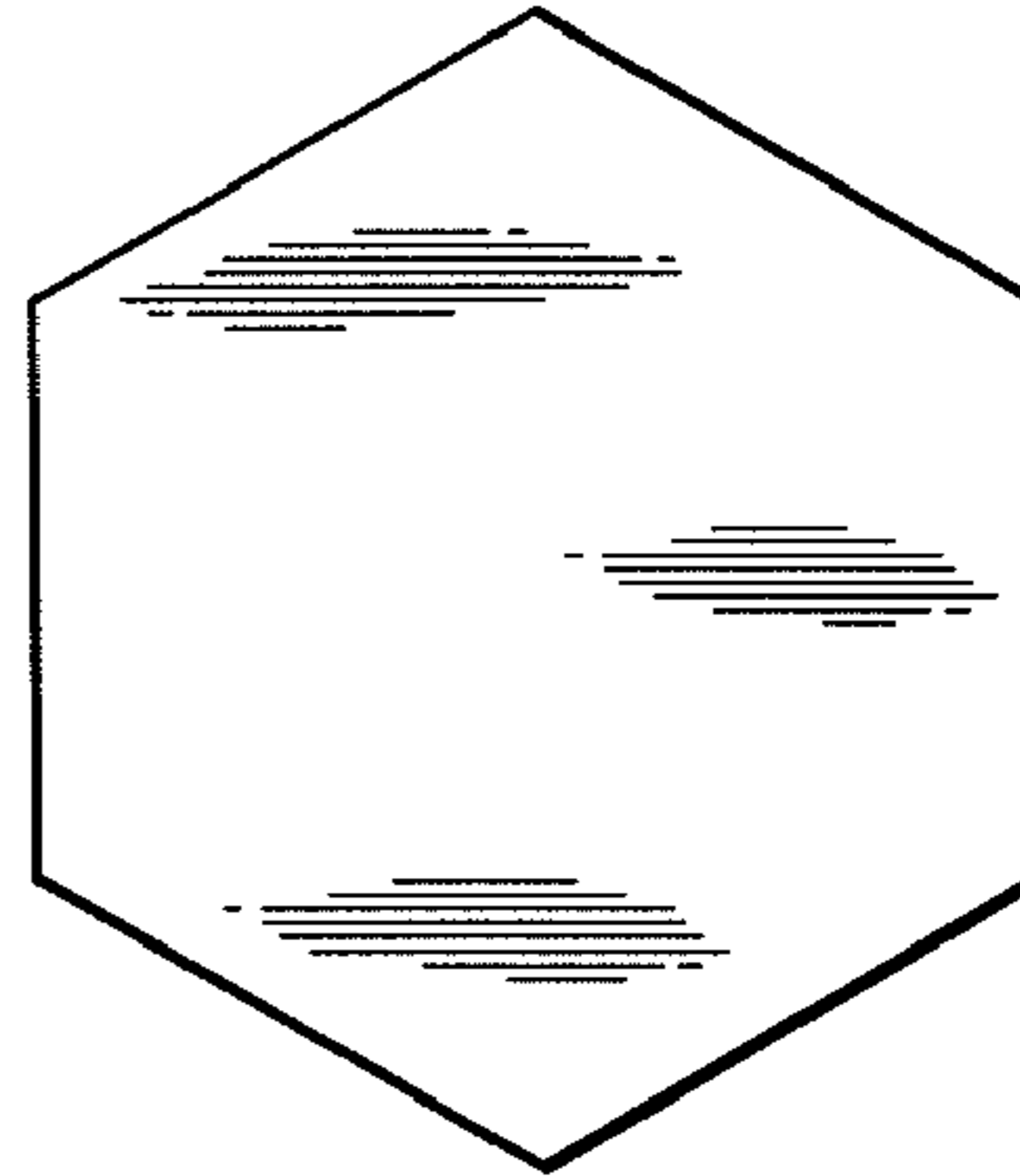

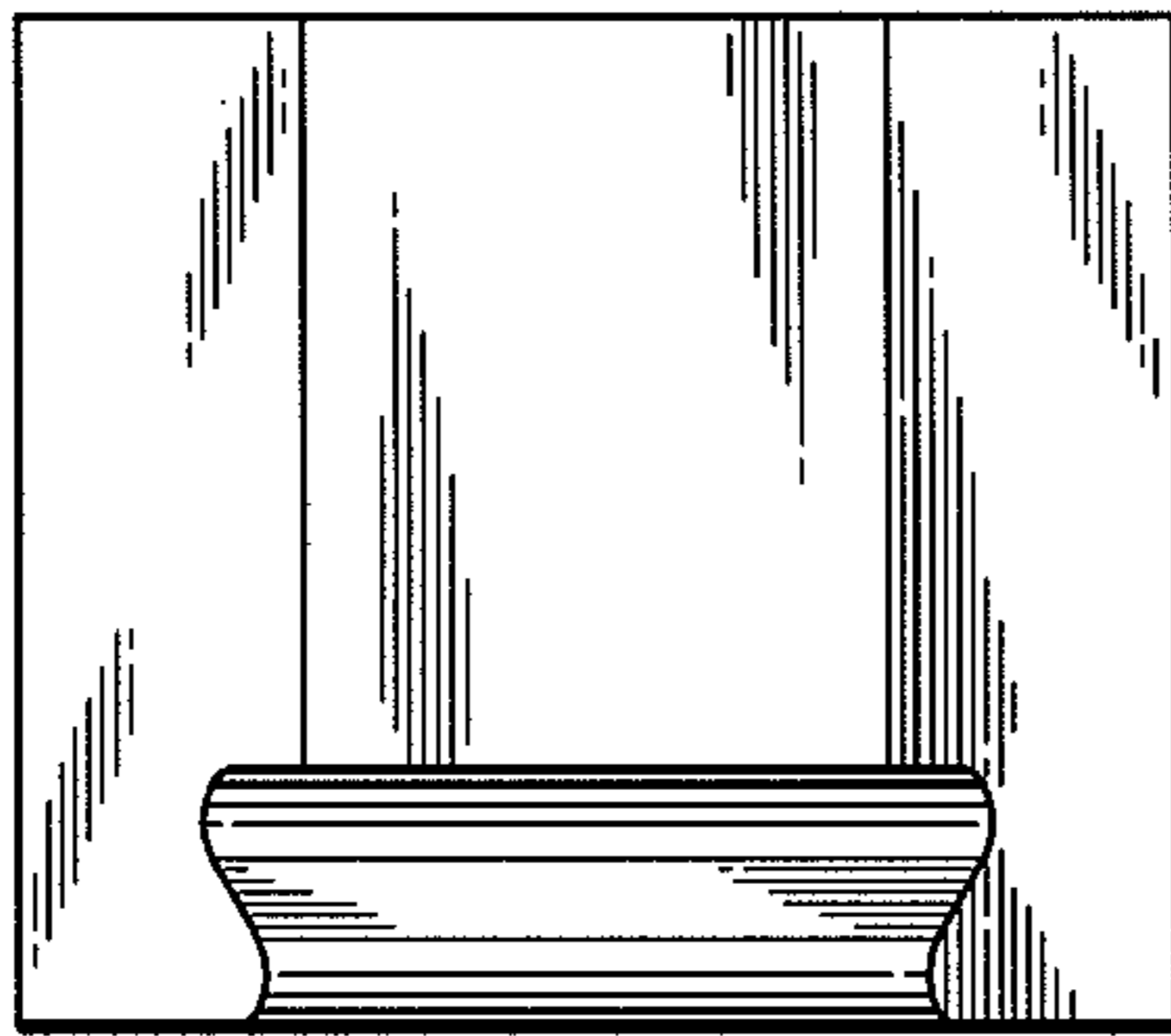

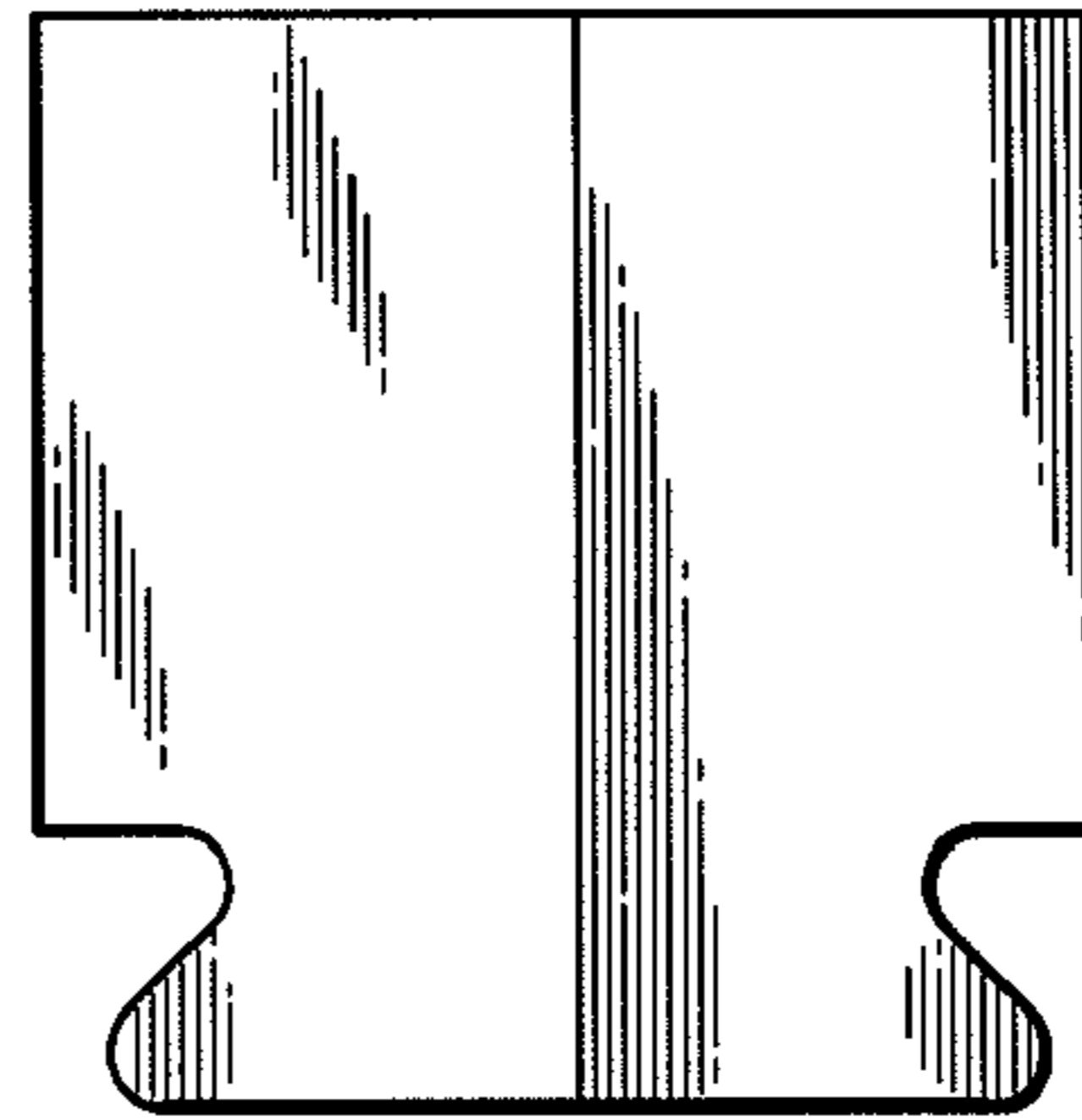

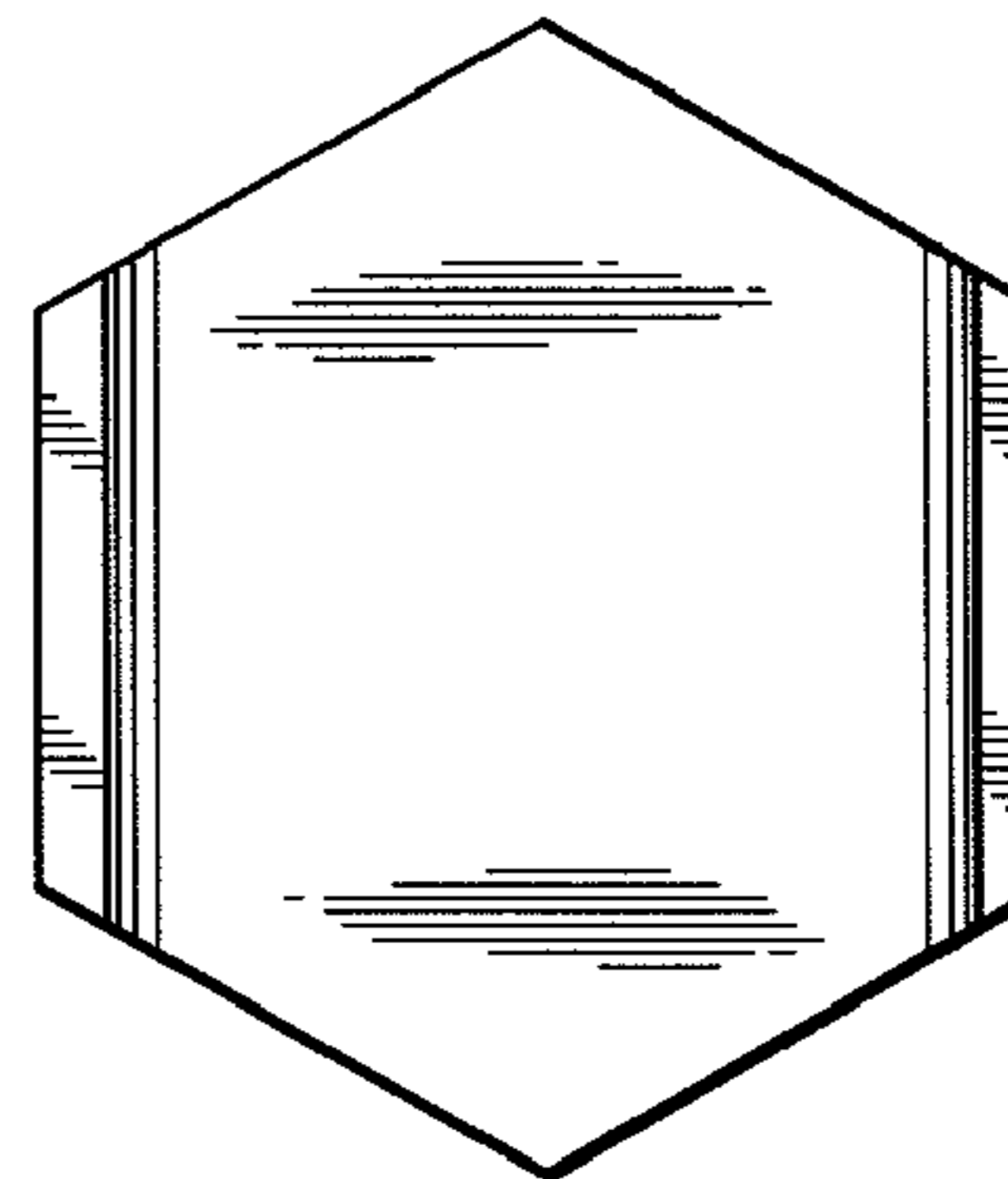
