FIG. 3 is a left side view thereof, the right side view thereof being a mirror image of the left side view;

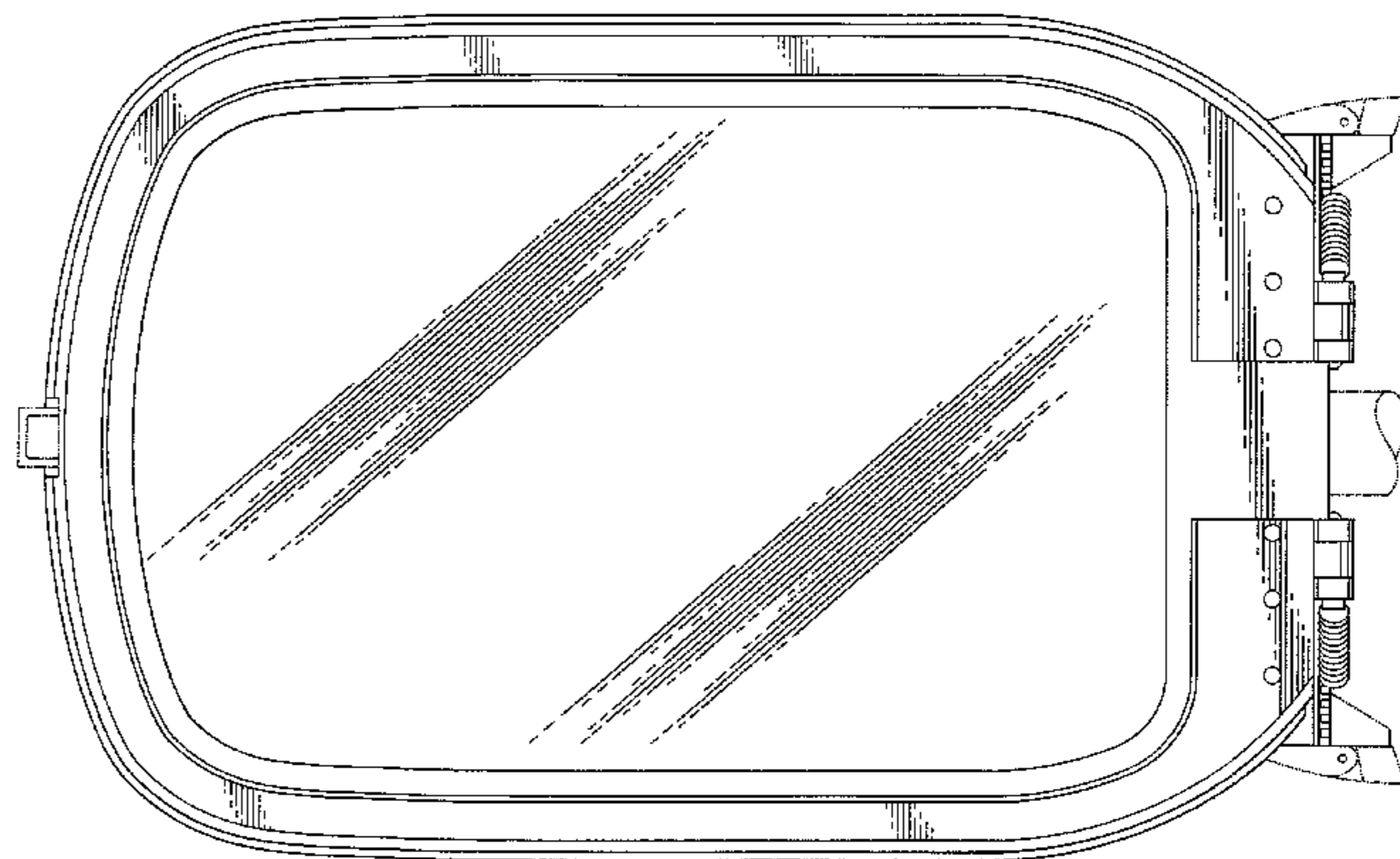
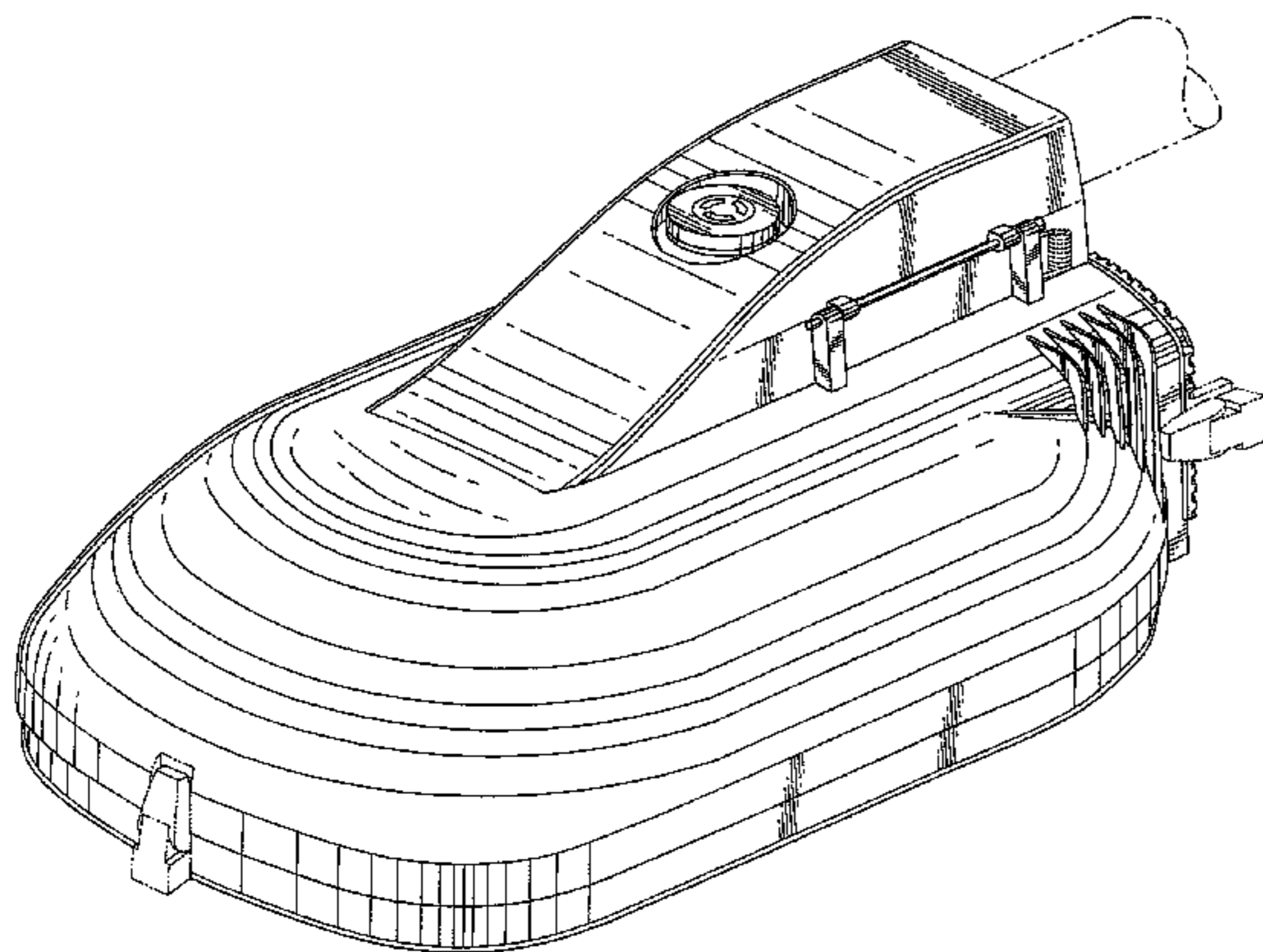
FIG. 4 is a bottom plan view thereof;

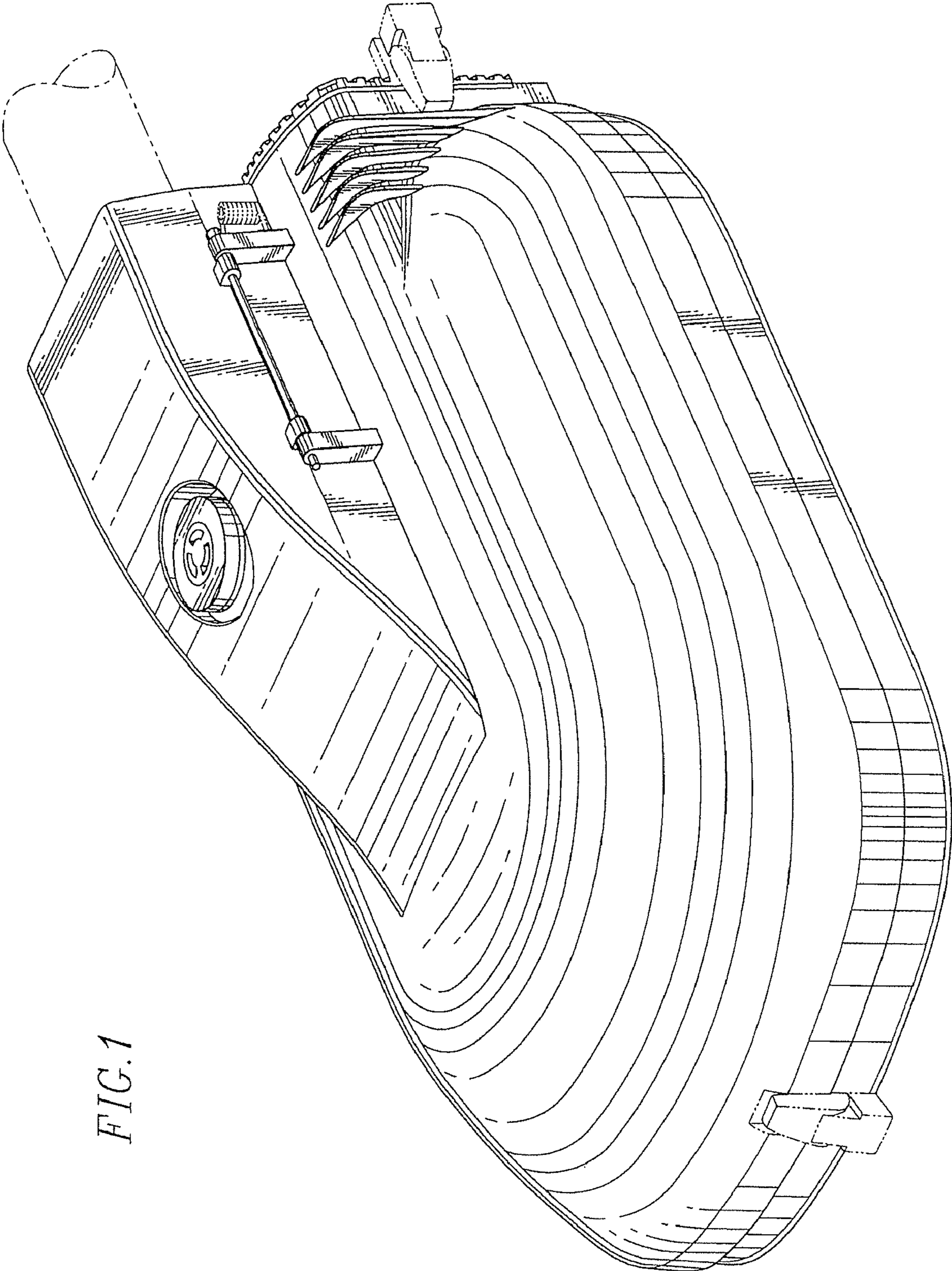
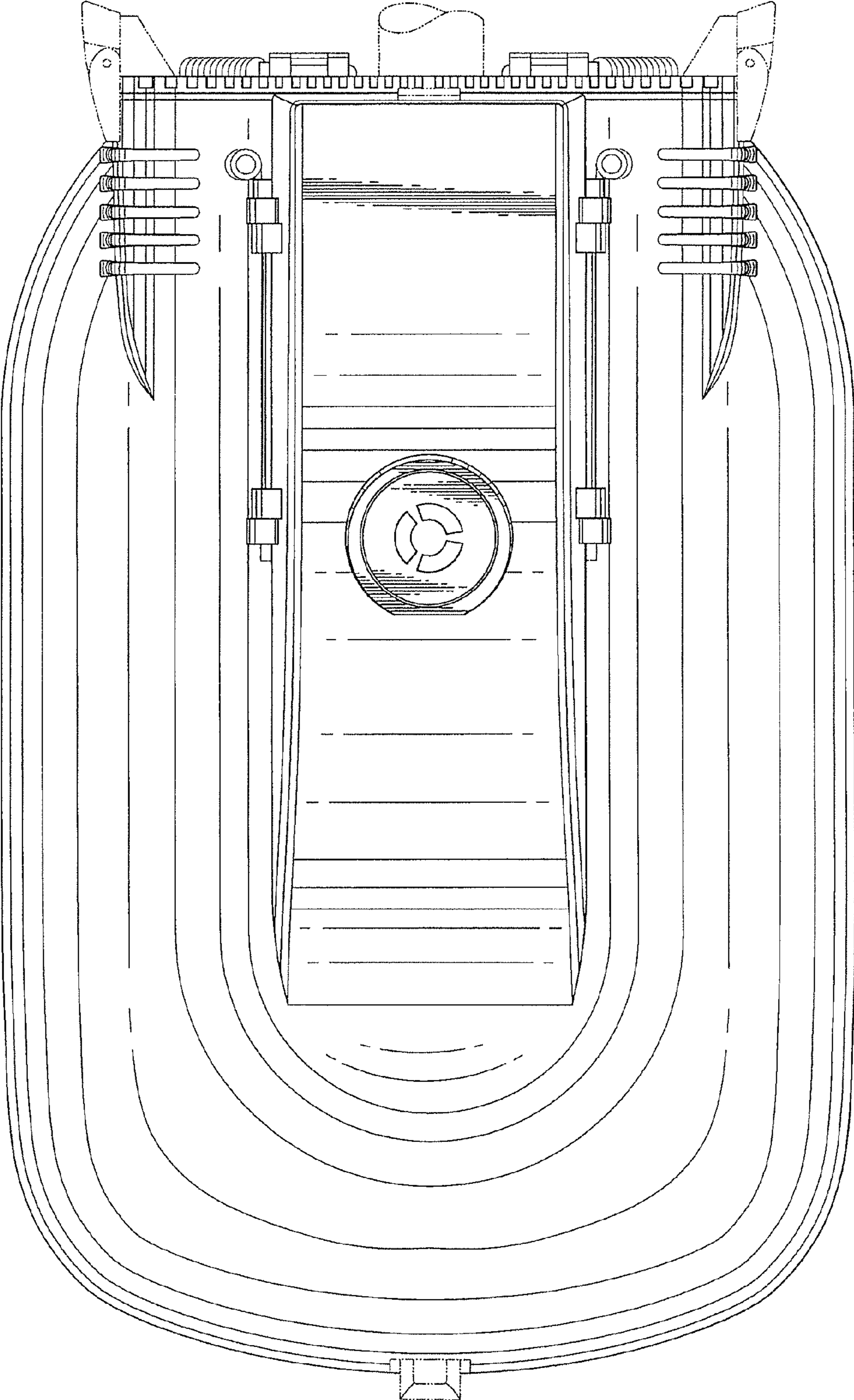

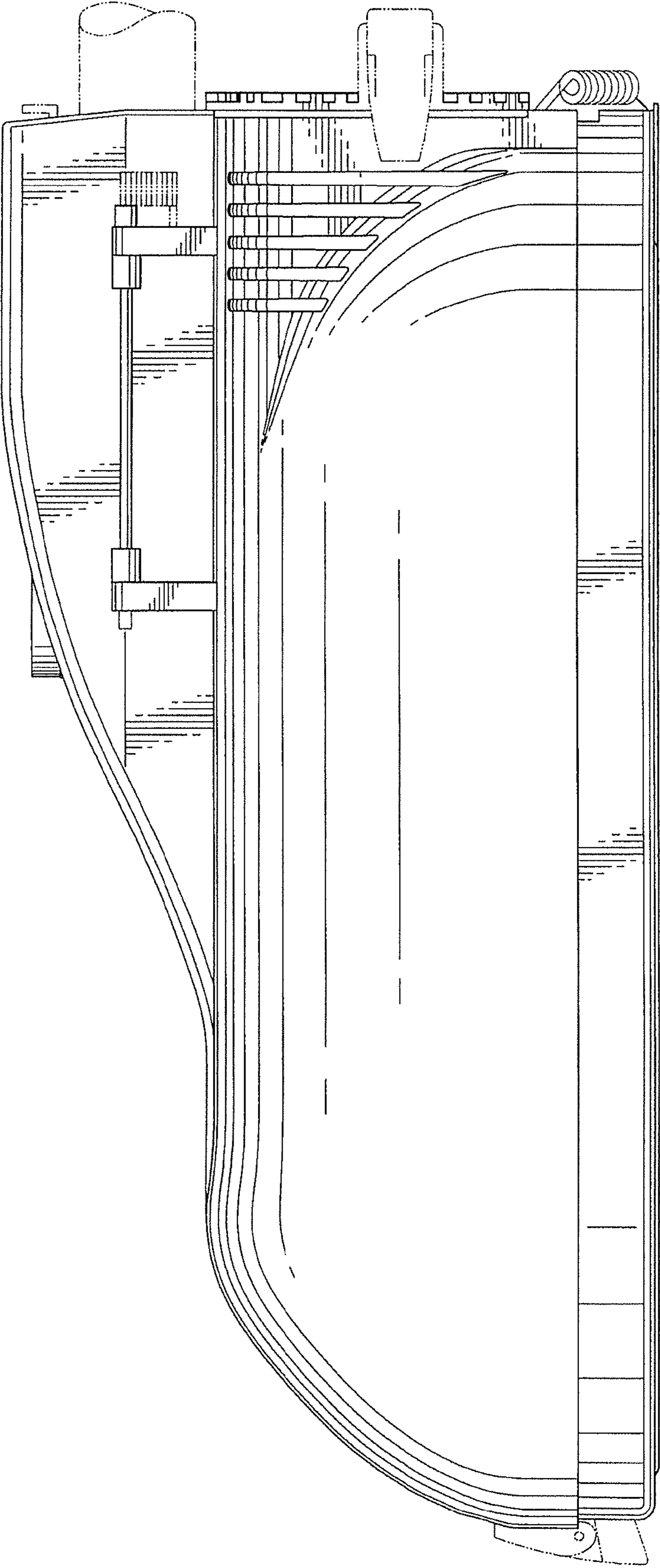

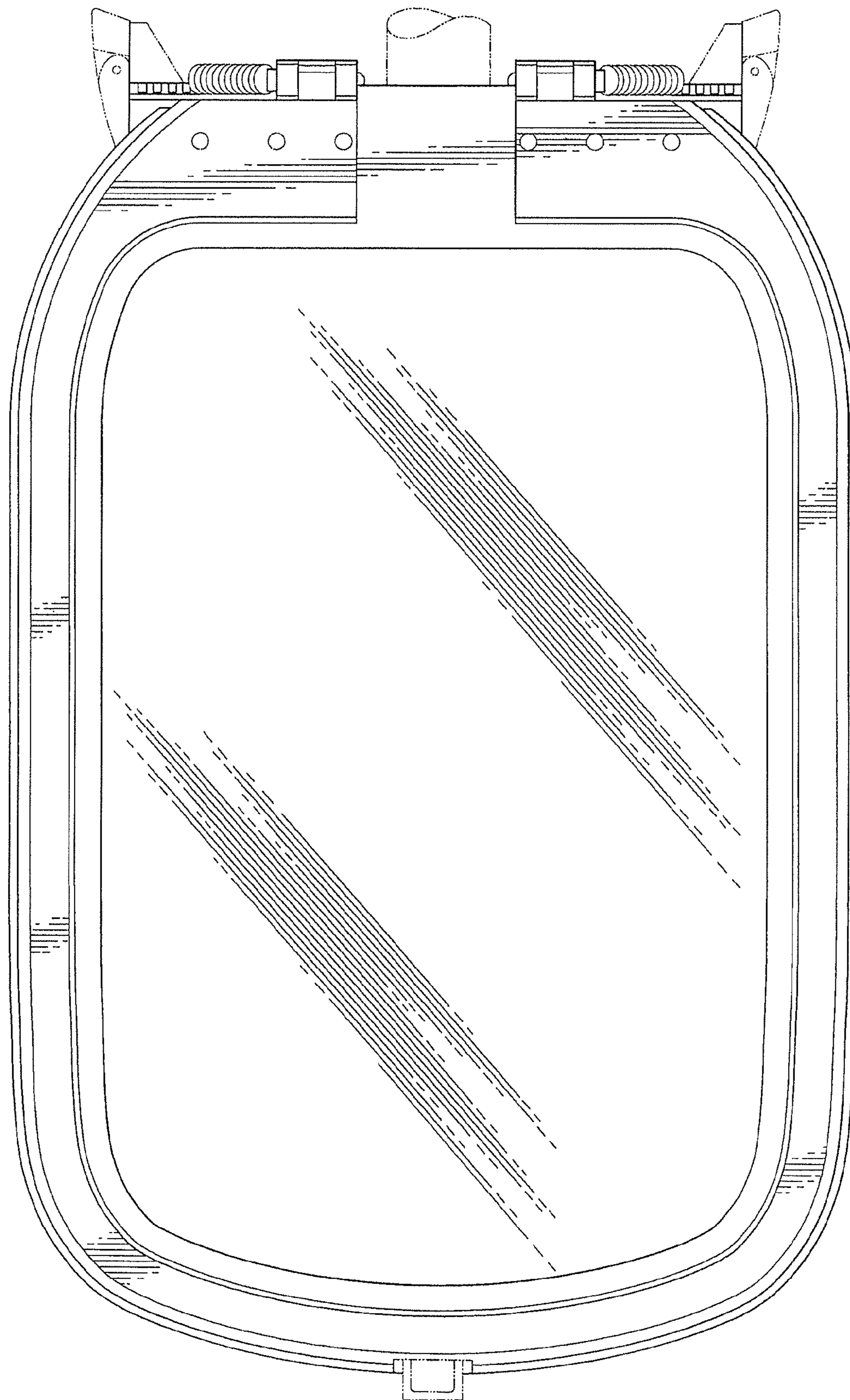

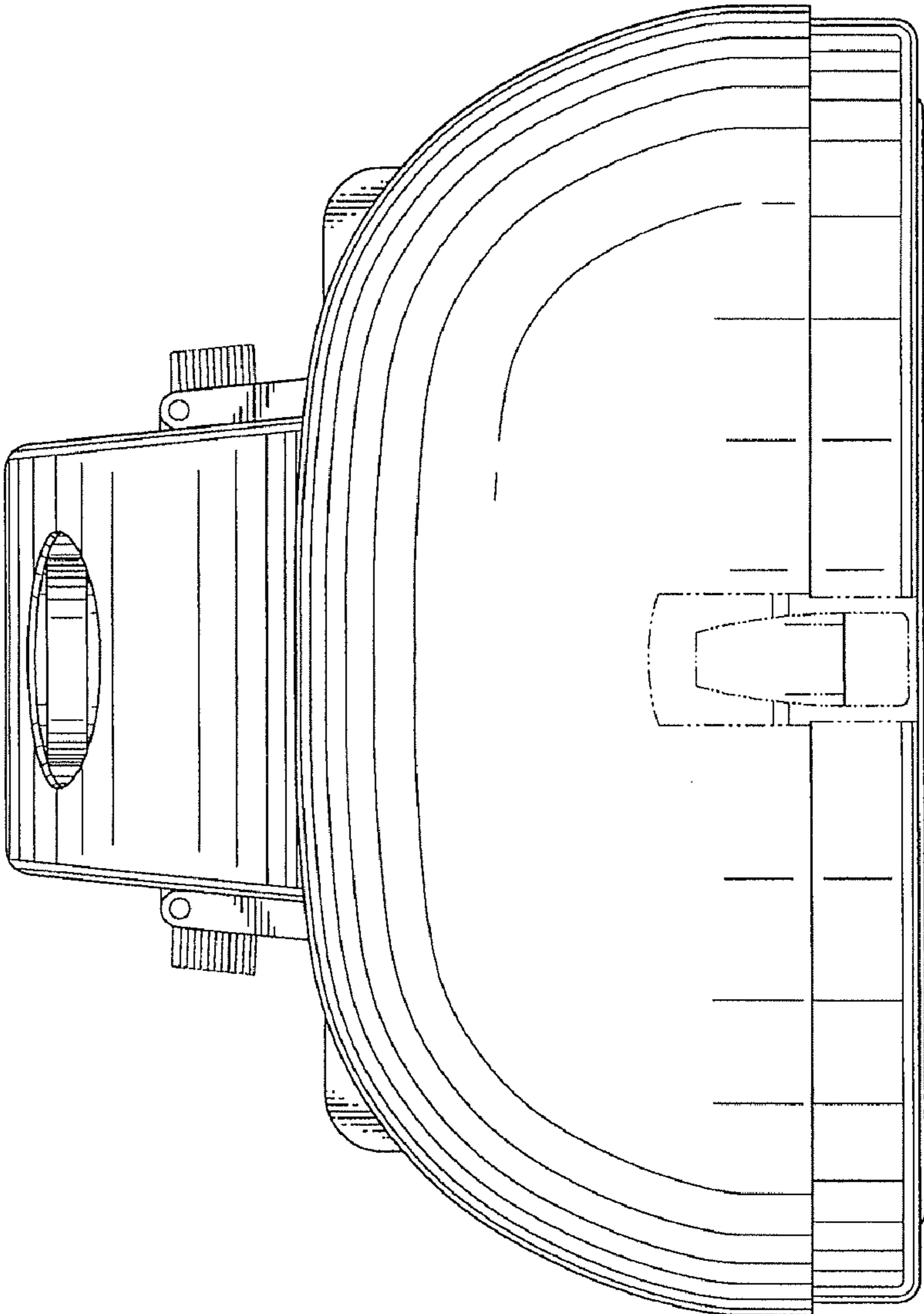
