FIG. 4 is a right side view the design for the laser comb;

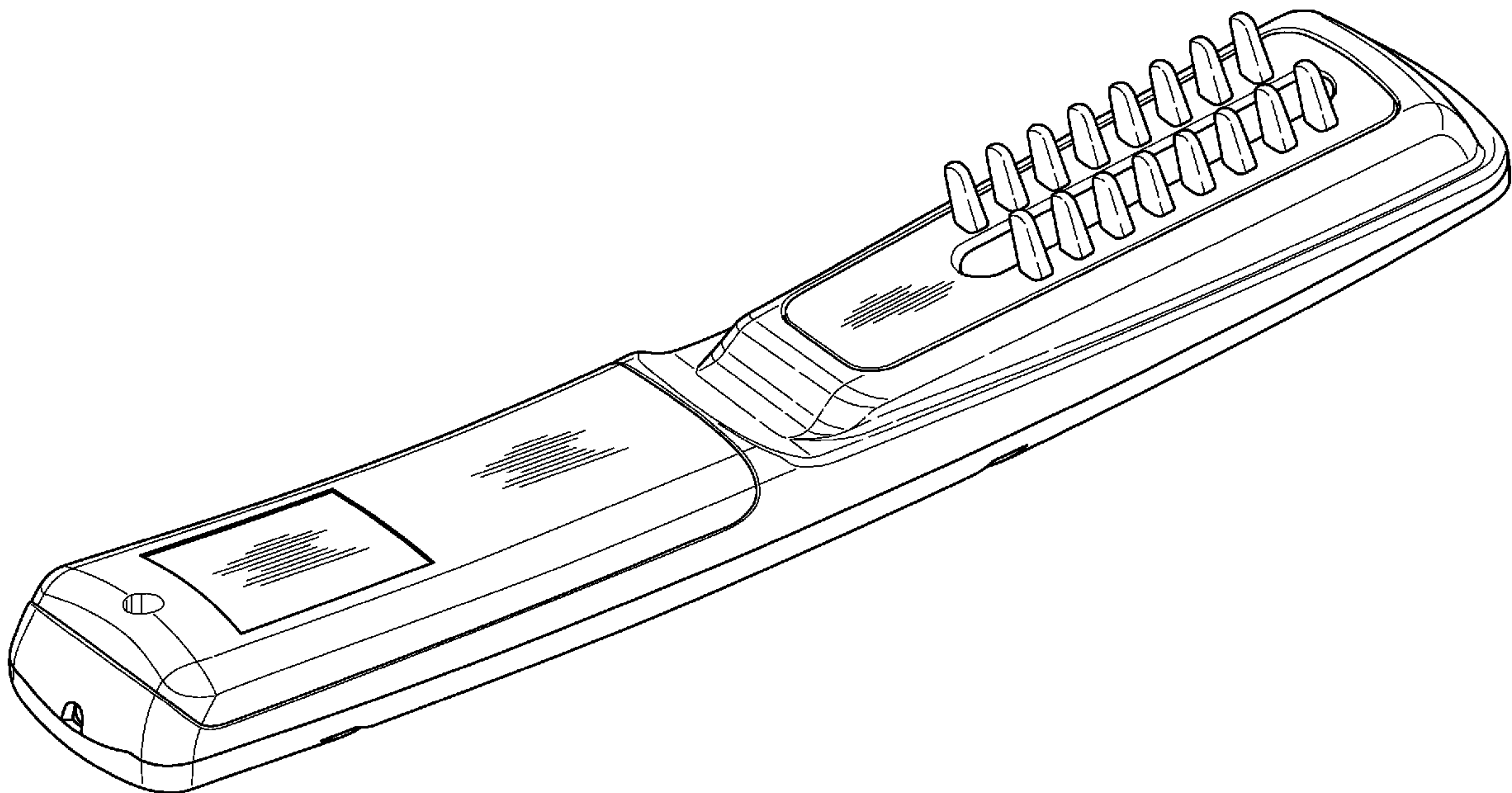
FIG. 5 is a left side view the design for the laser comb;

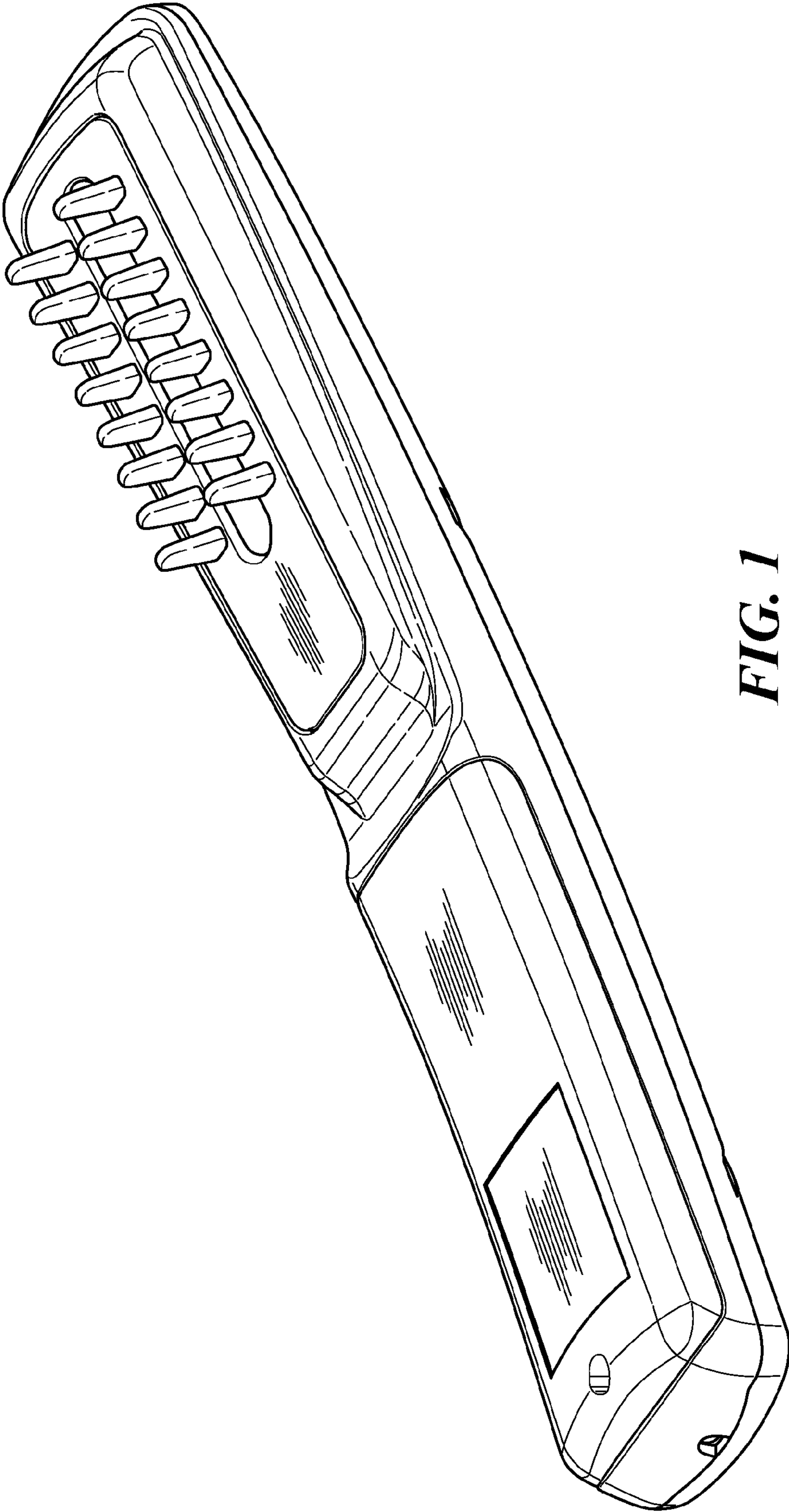

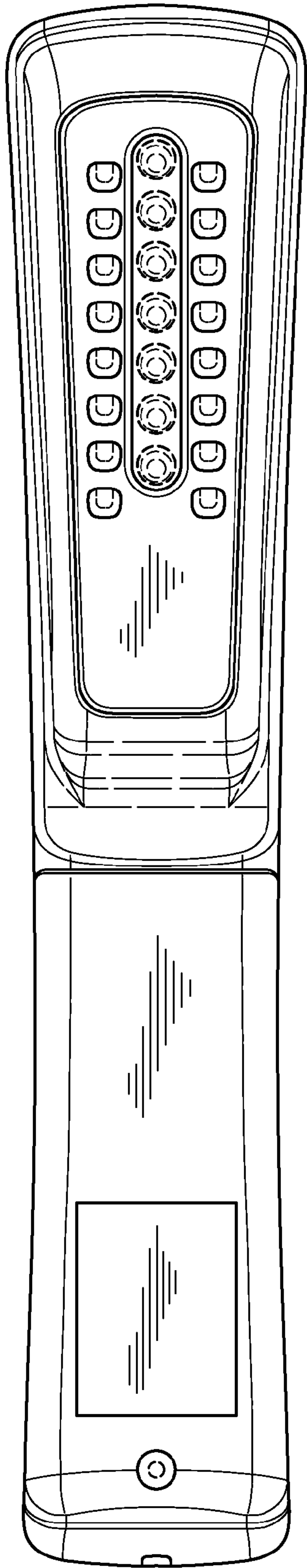

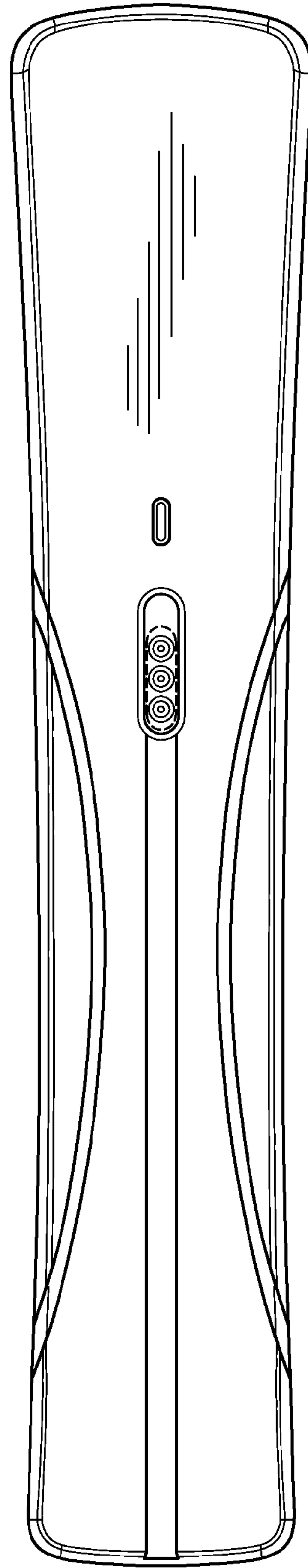

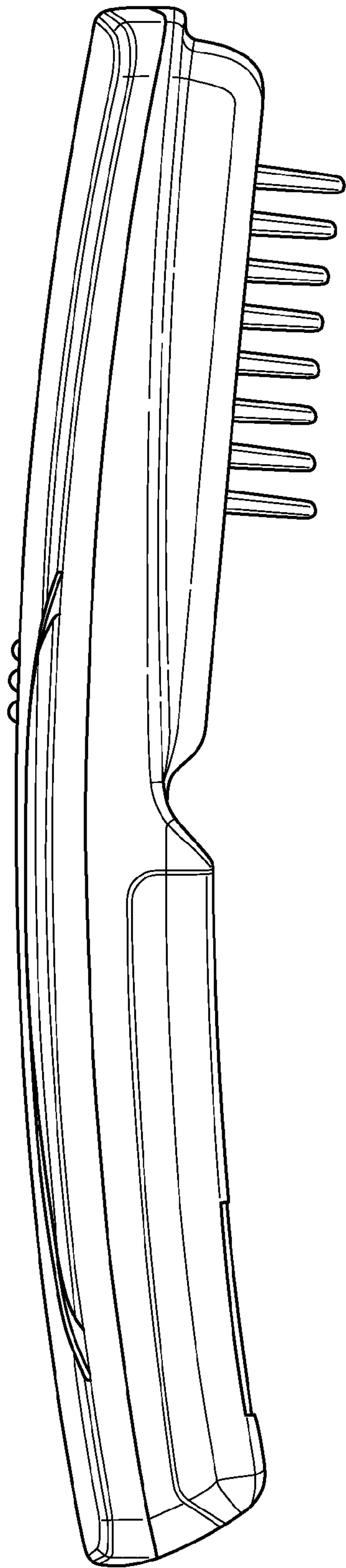

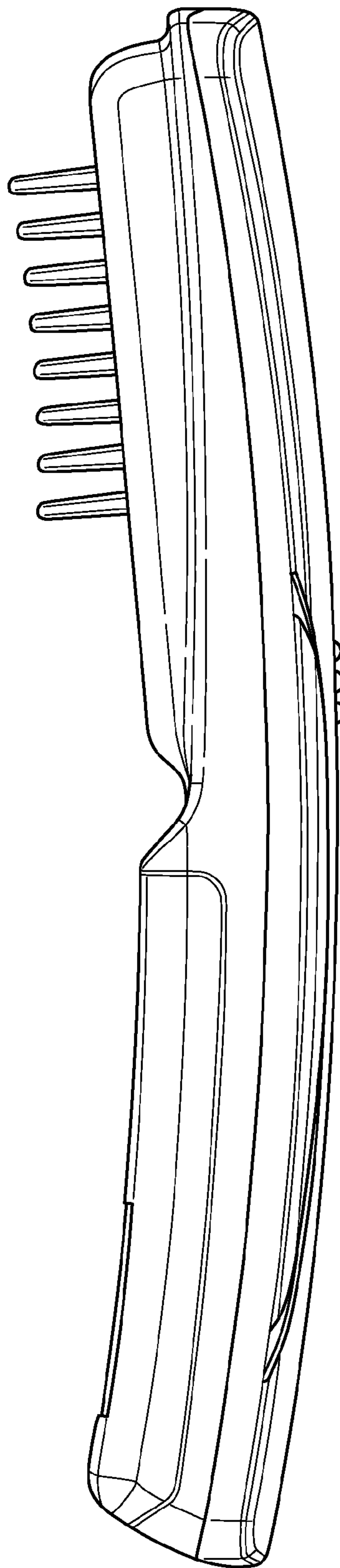

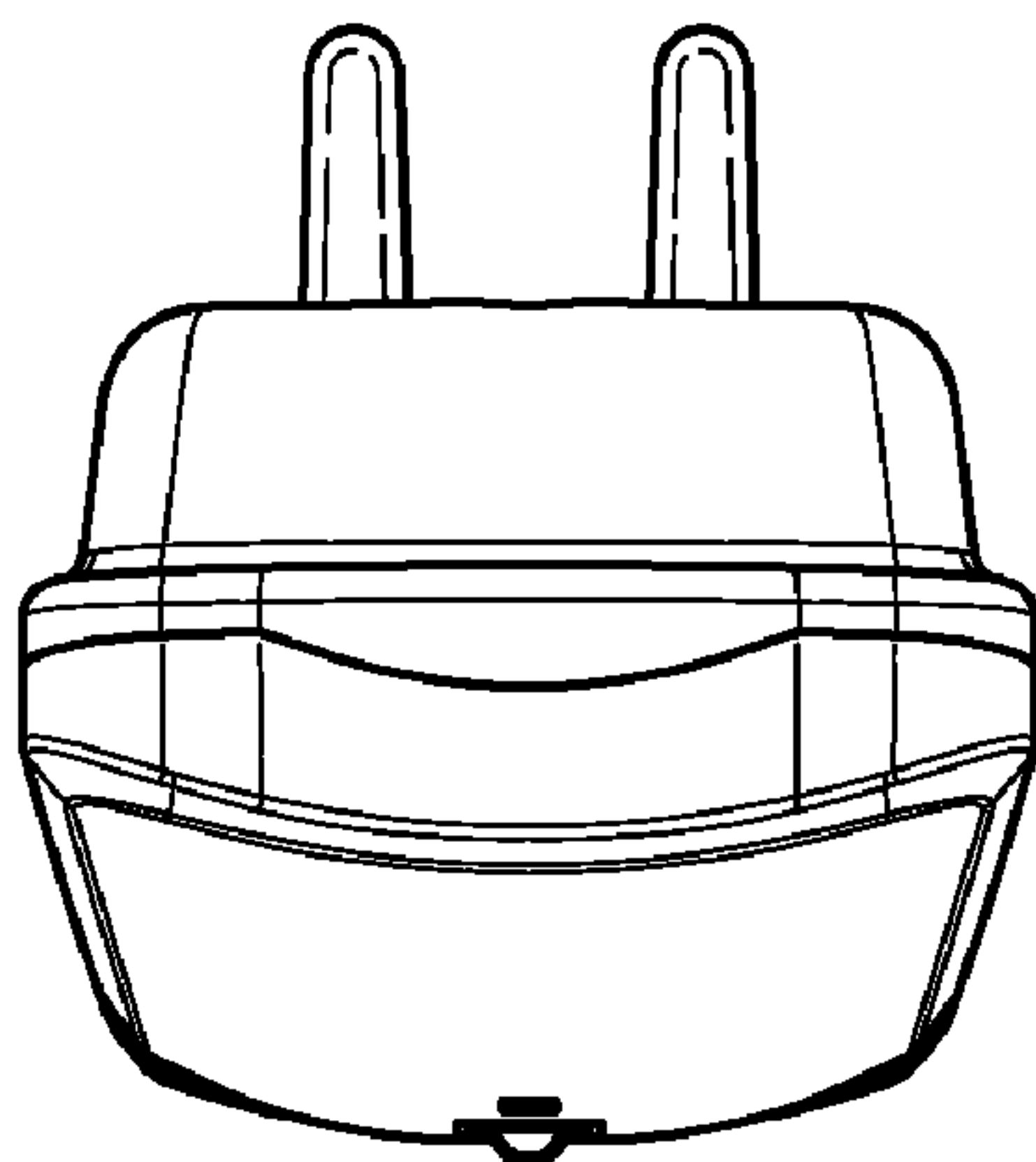

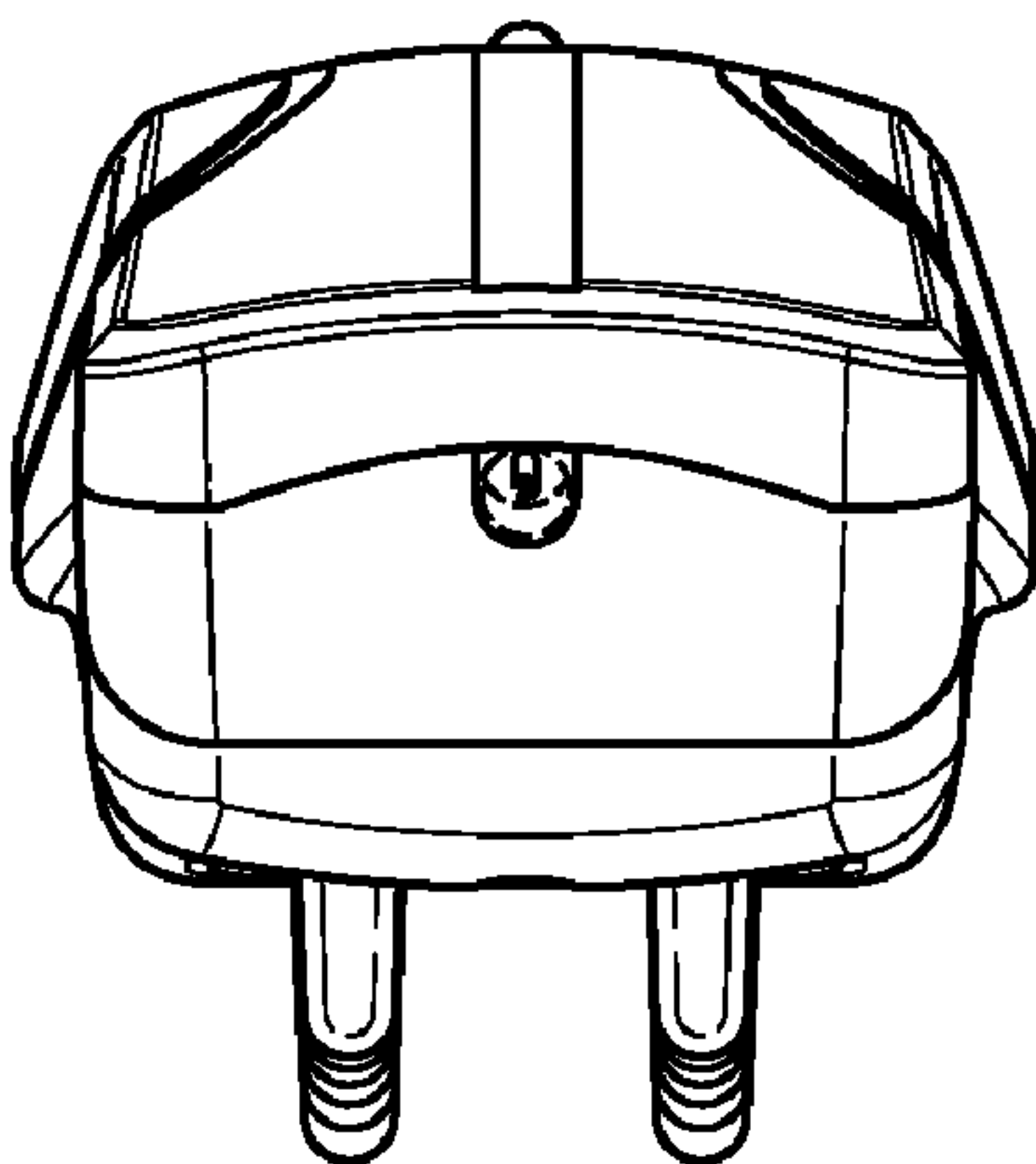
