We claim the ornamental design for a collapsible hanger, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the collapsible hanger;

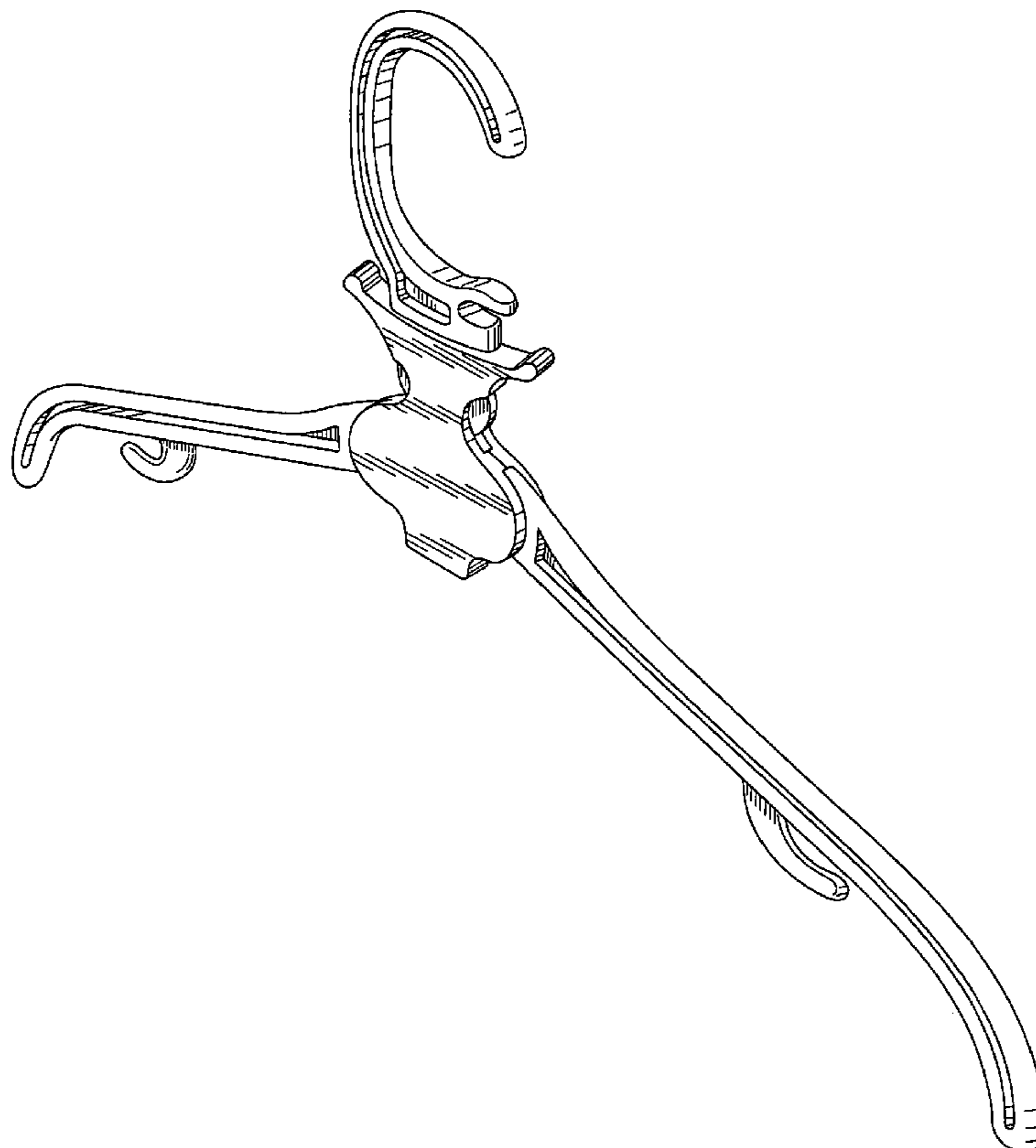

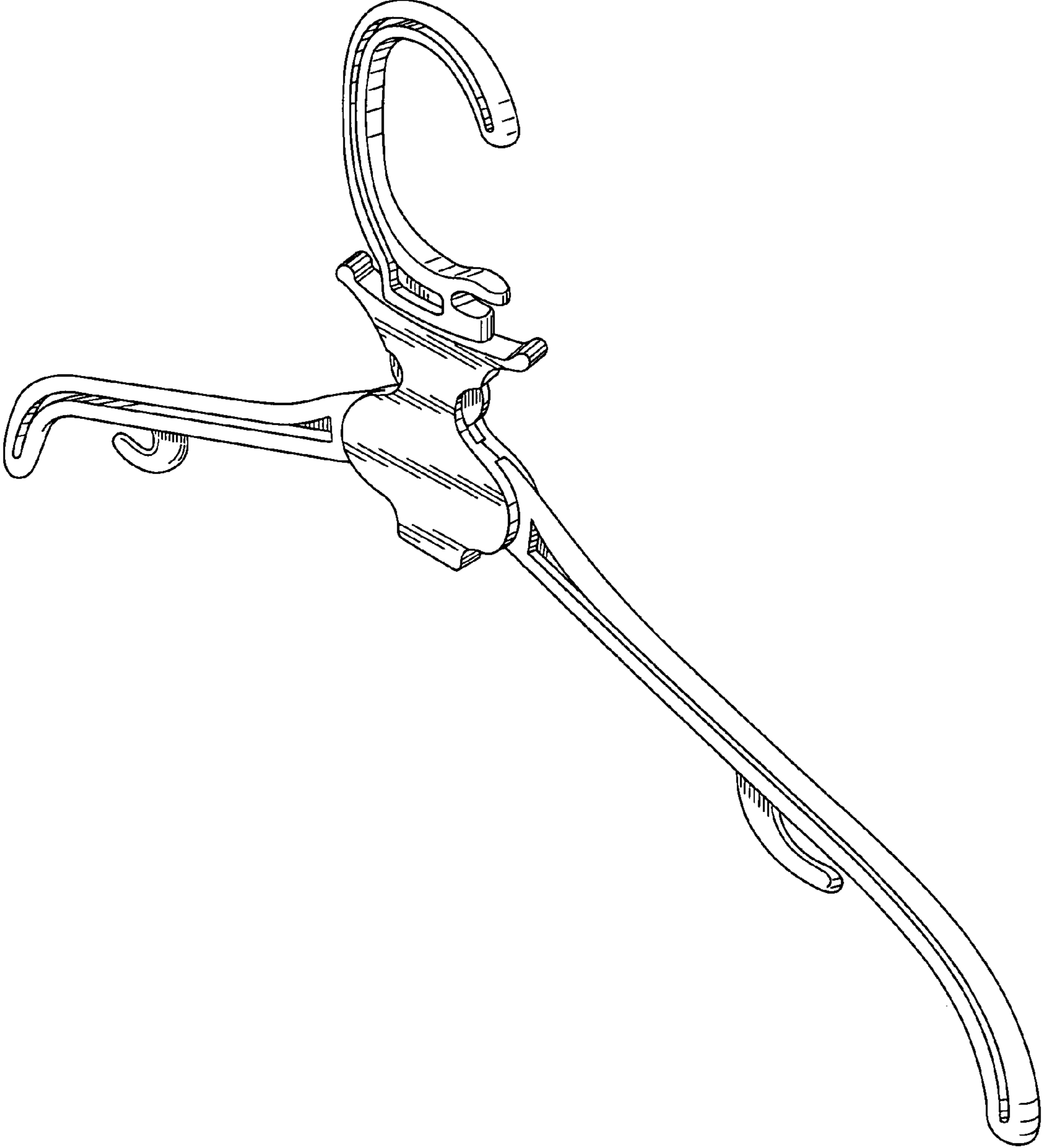

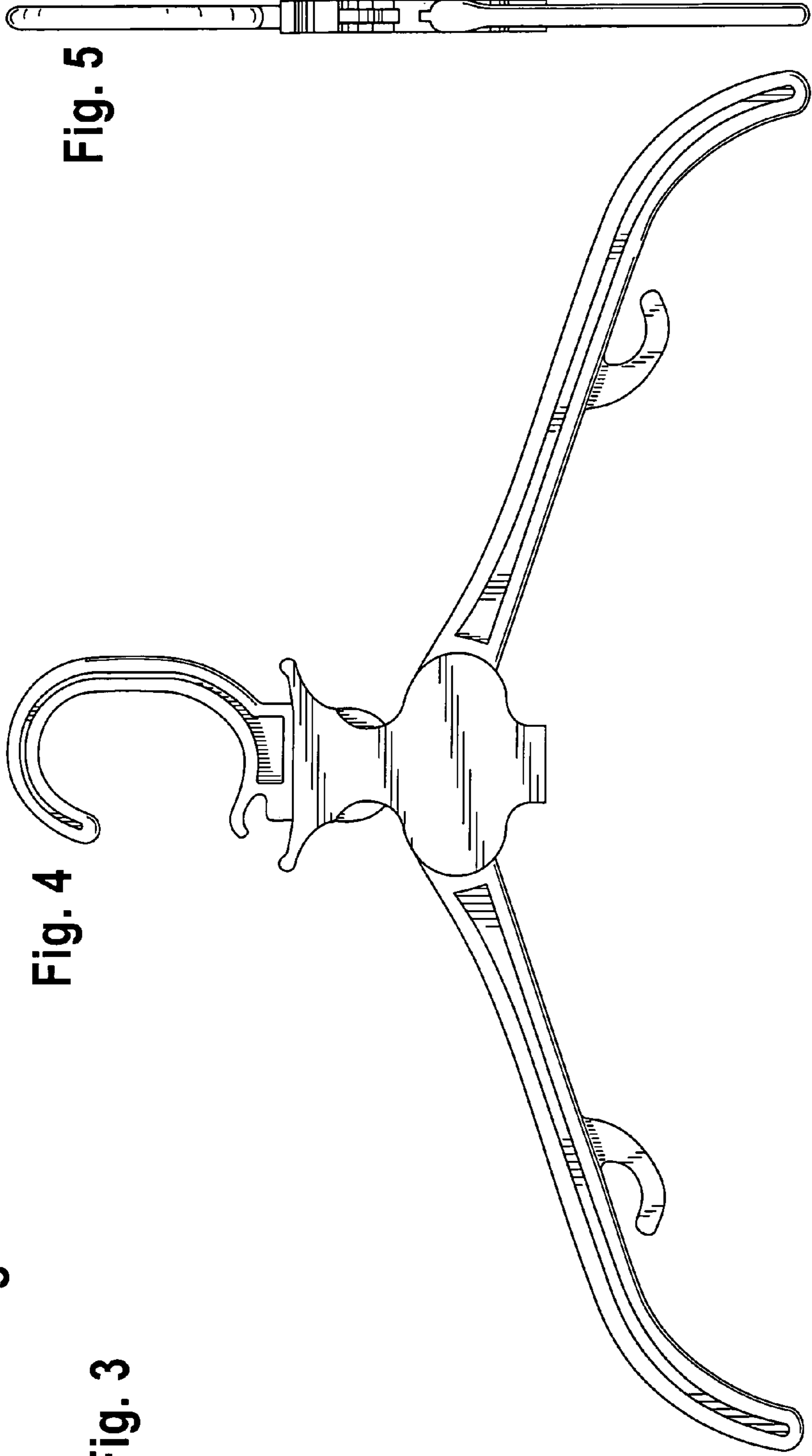
