(57) **CLAIM**

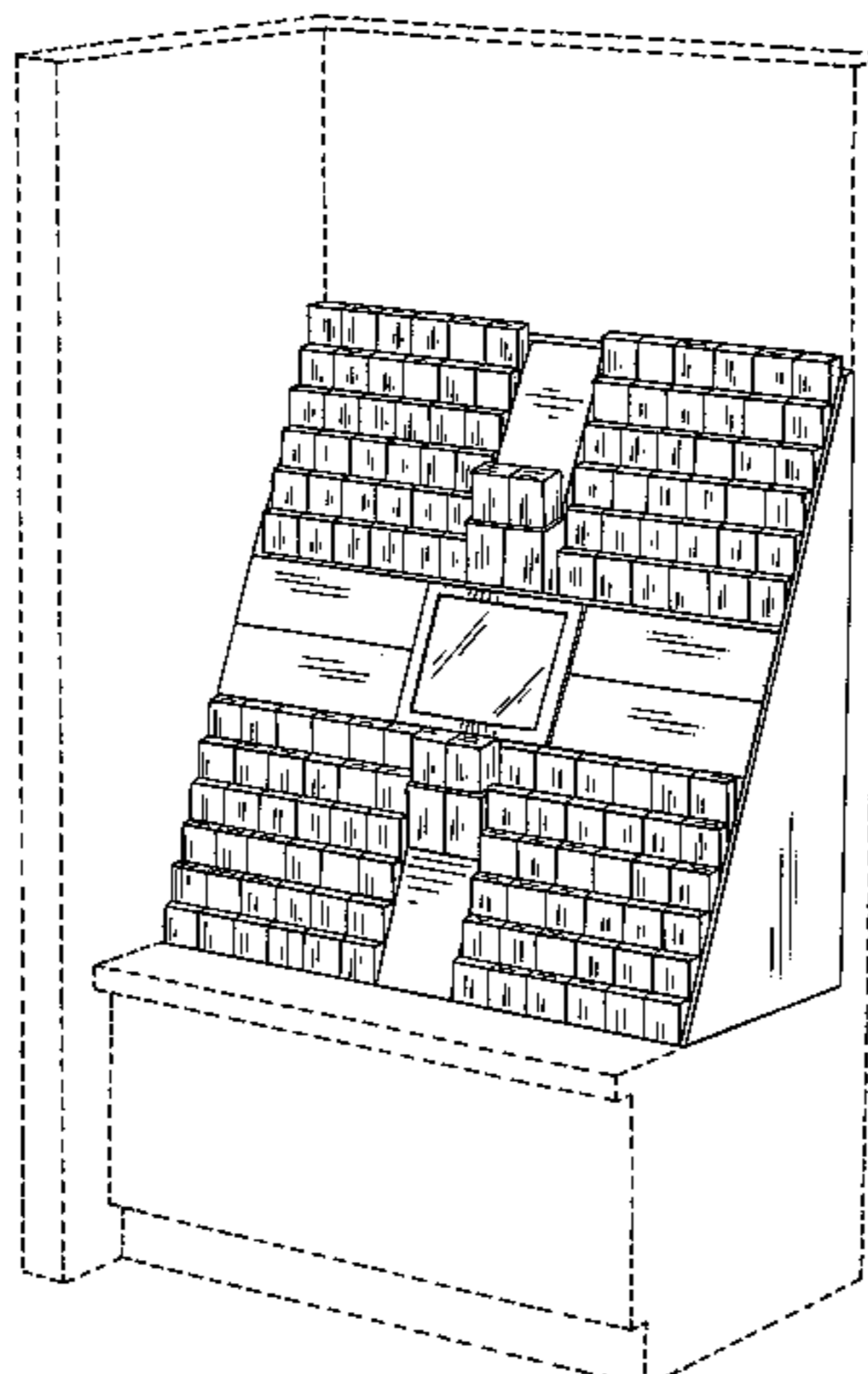
The ornamental design for a display module, as shown and described.

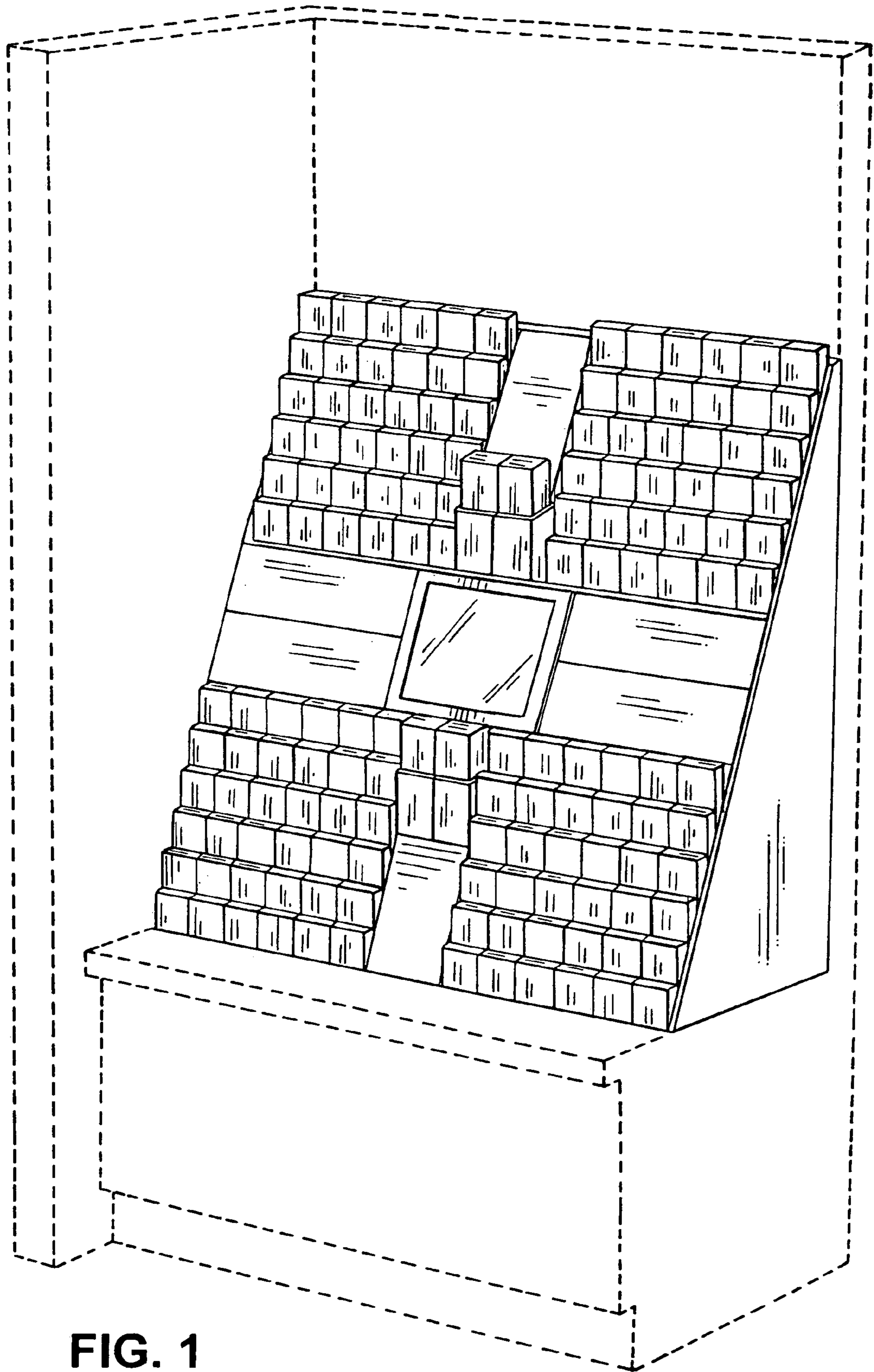

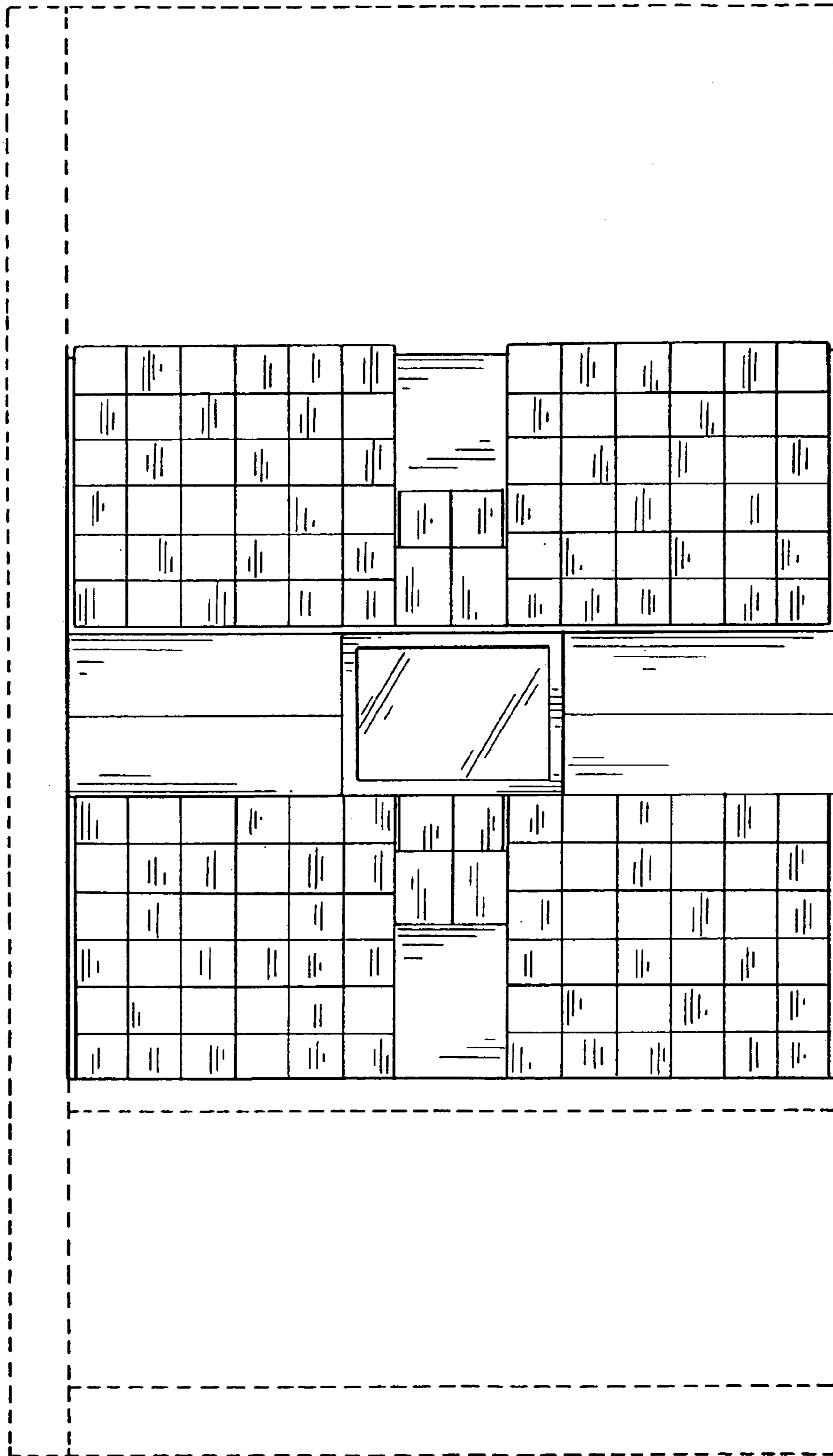

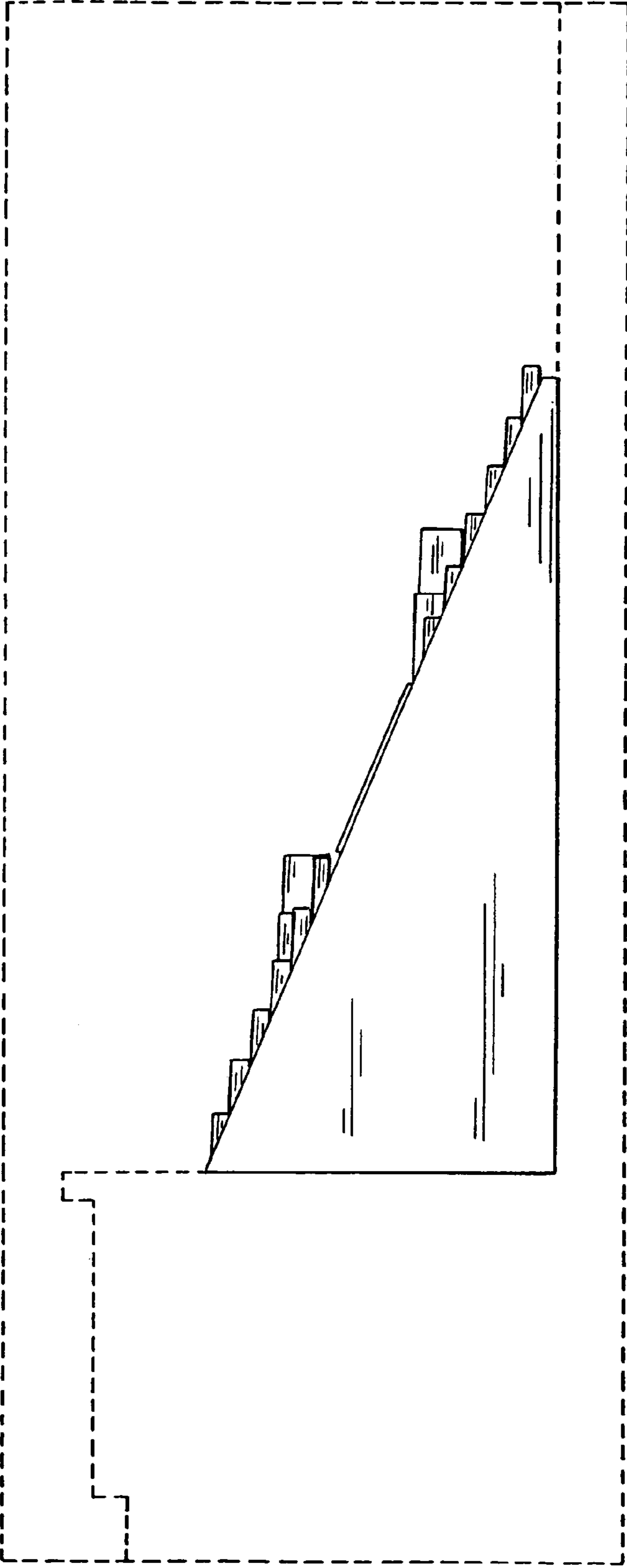

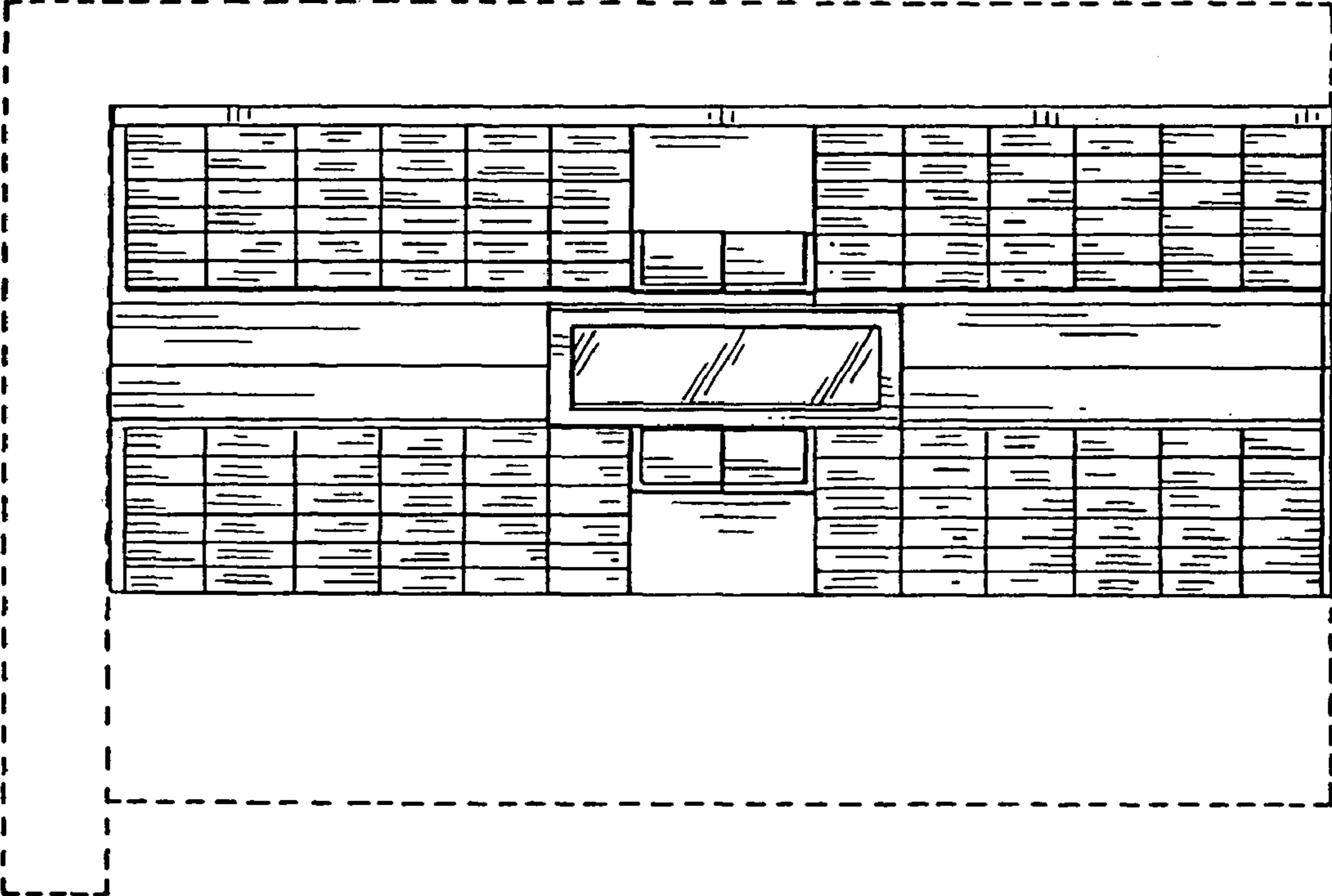
