(57) **CLAIM**

The ornamental design for a steam cooker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the steam cooker, shown with the lid closed for ease of illustration;

FIG. 2 is an exploded perspective view of the steam cooker, shown with the lid open and handle removed for completeness of illustration;

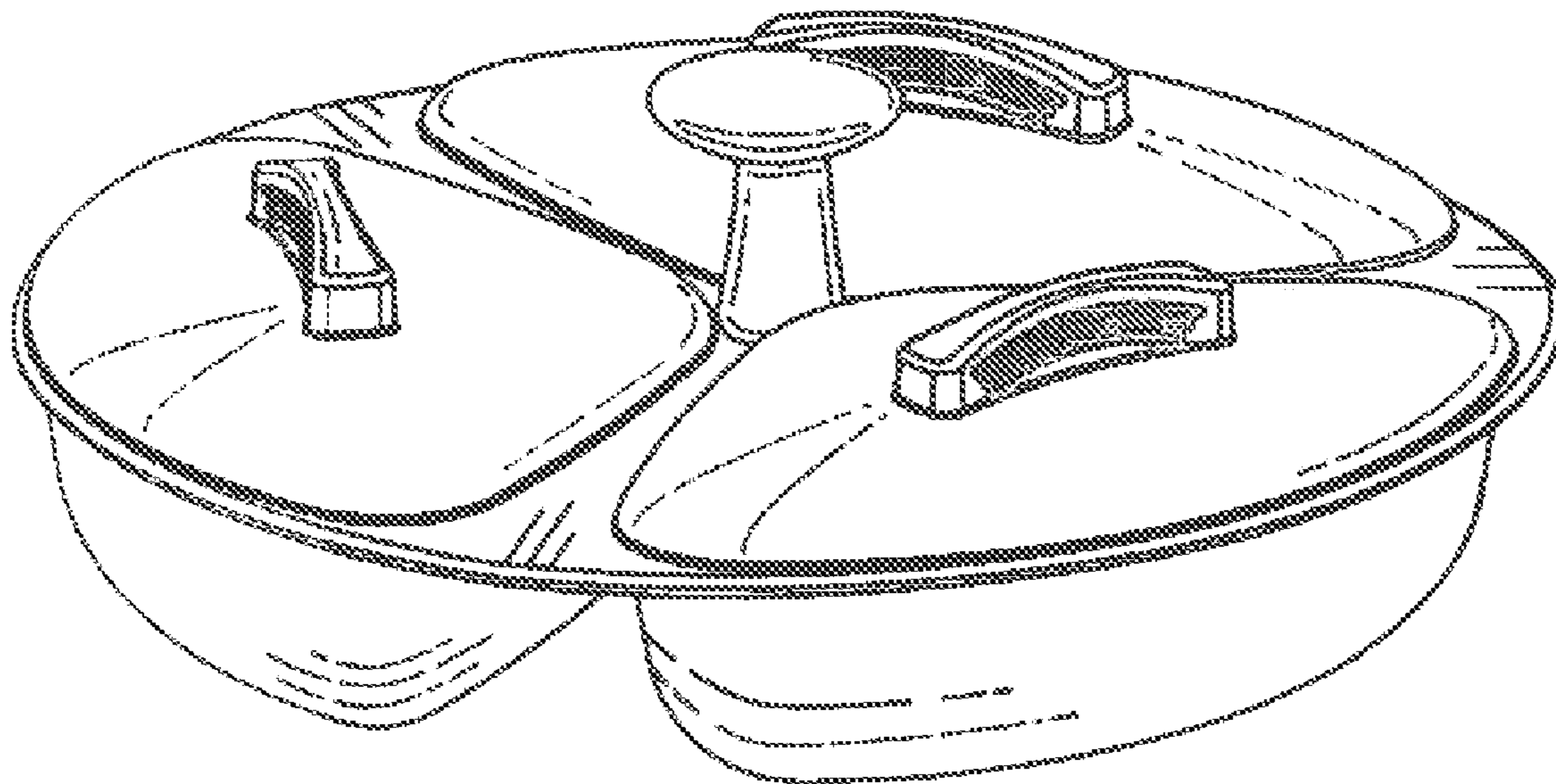
FIG. 3 is a top view of the steam cooker shown in FIG. 1;

FIG. 4 is a cross-sectional view along 4—4 of the steam cooker shown in FIG. 3;

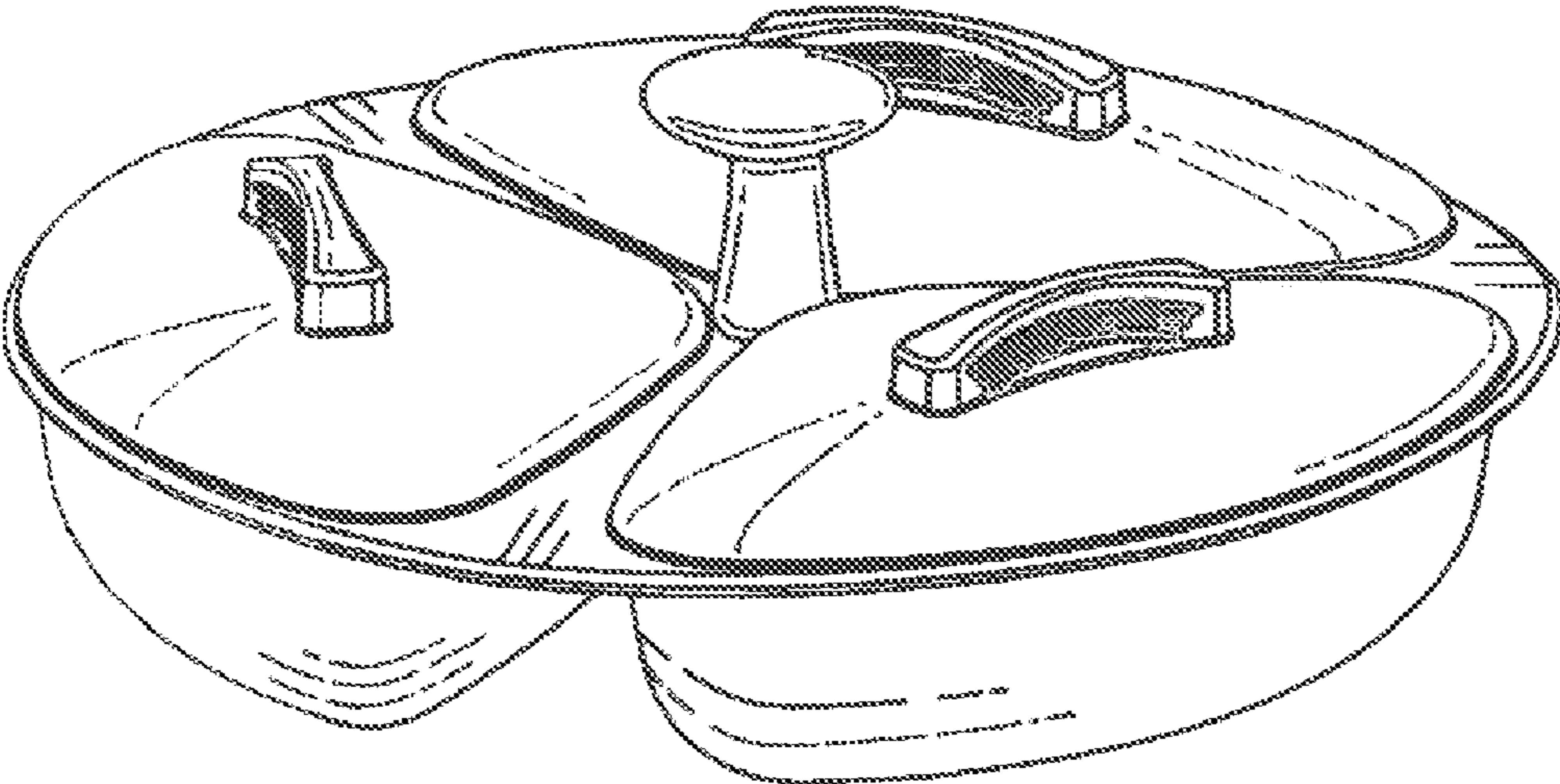

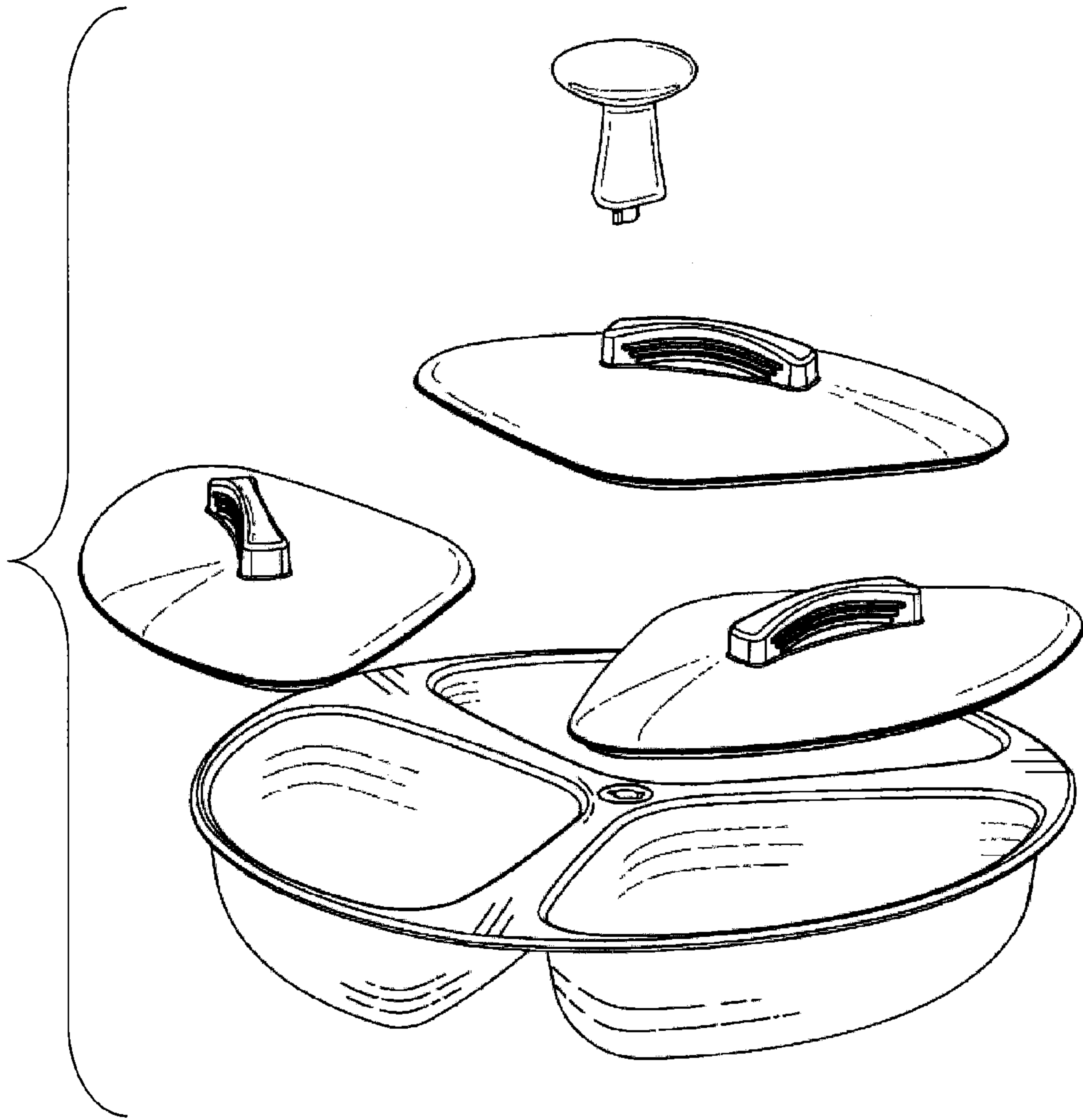

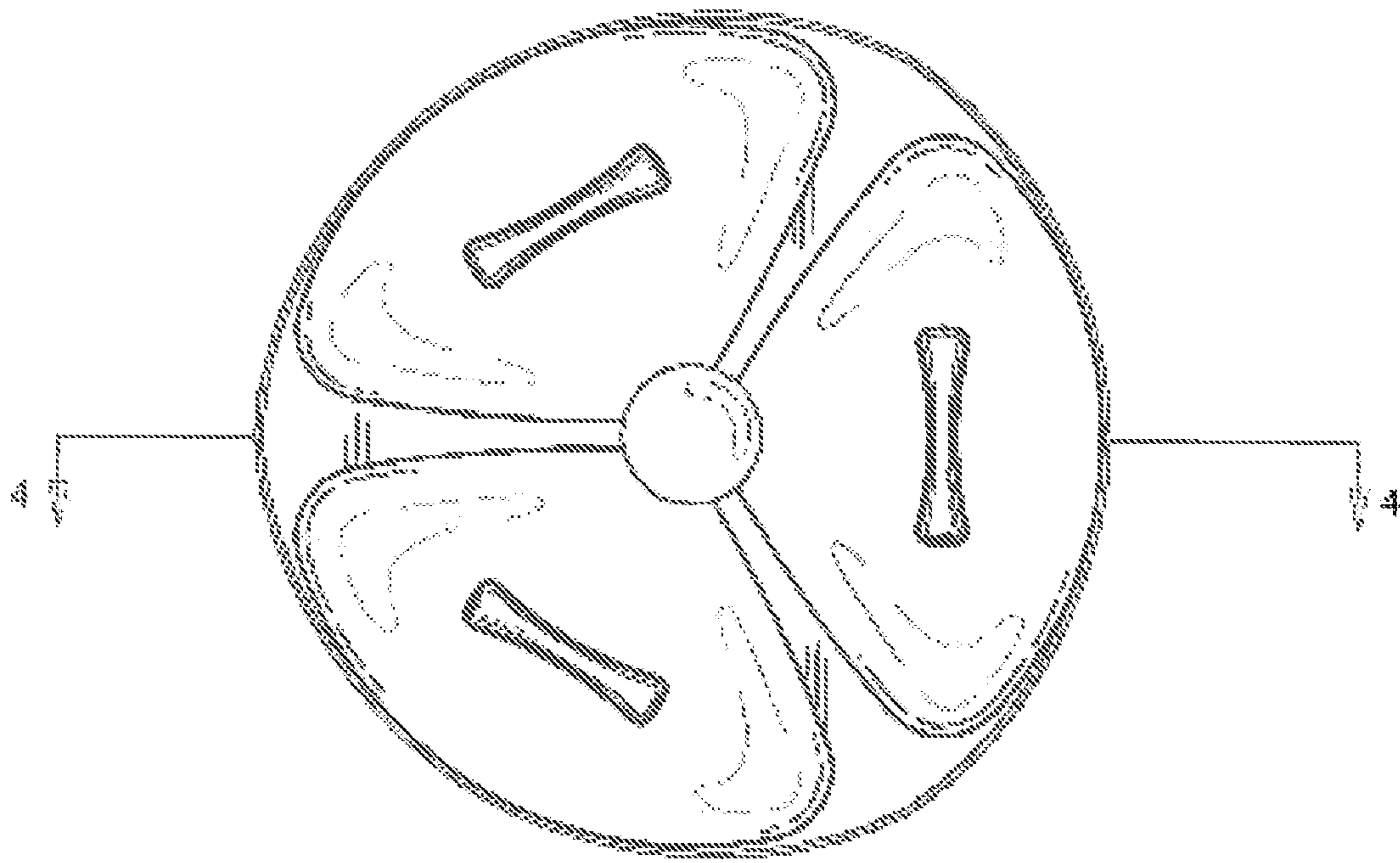

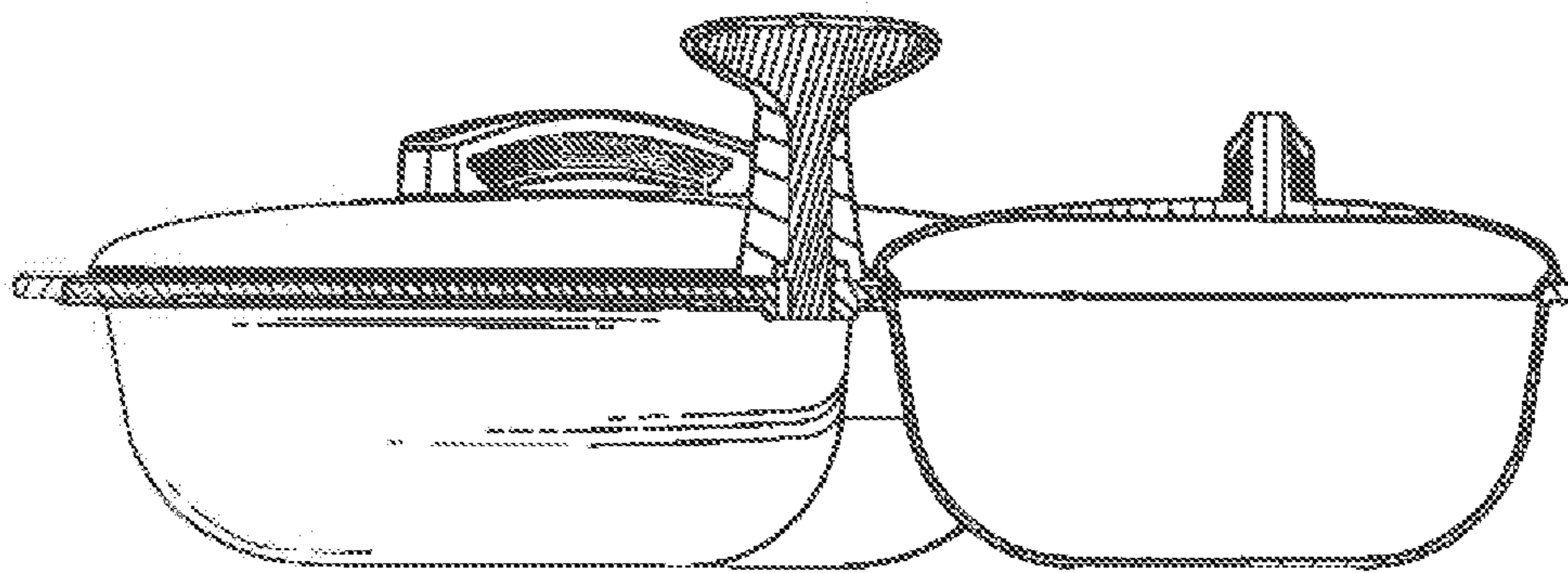

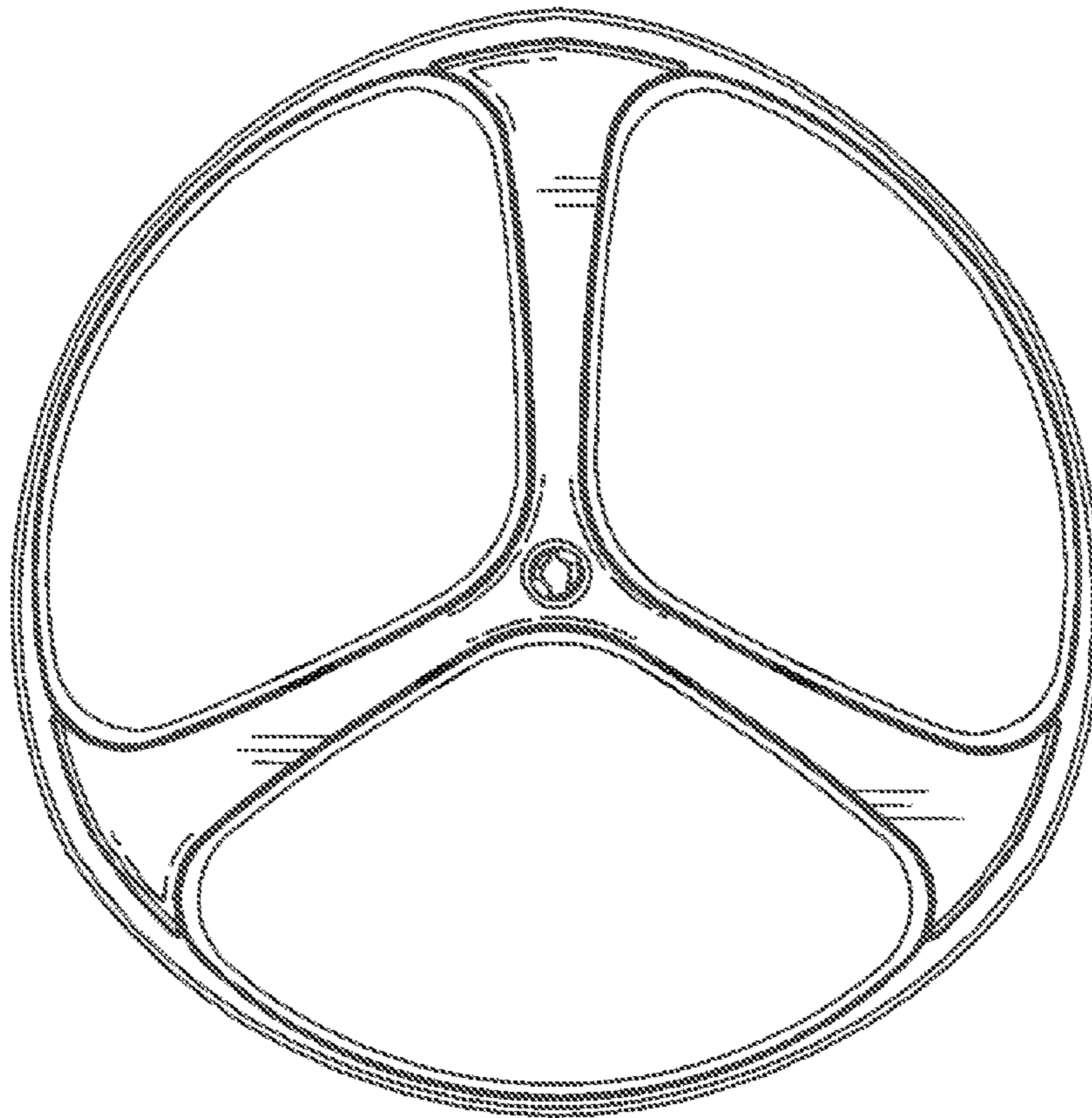

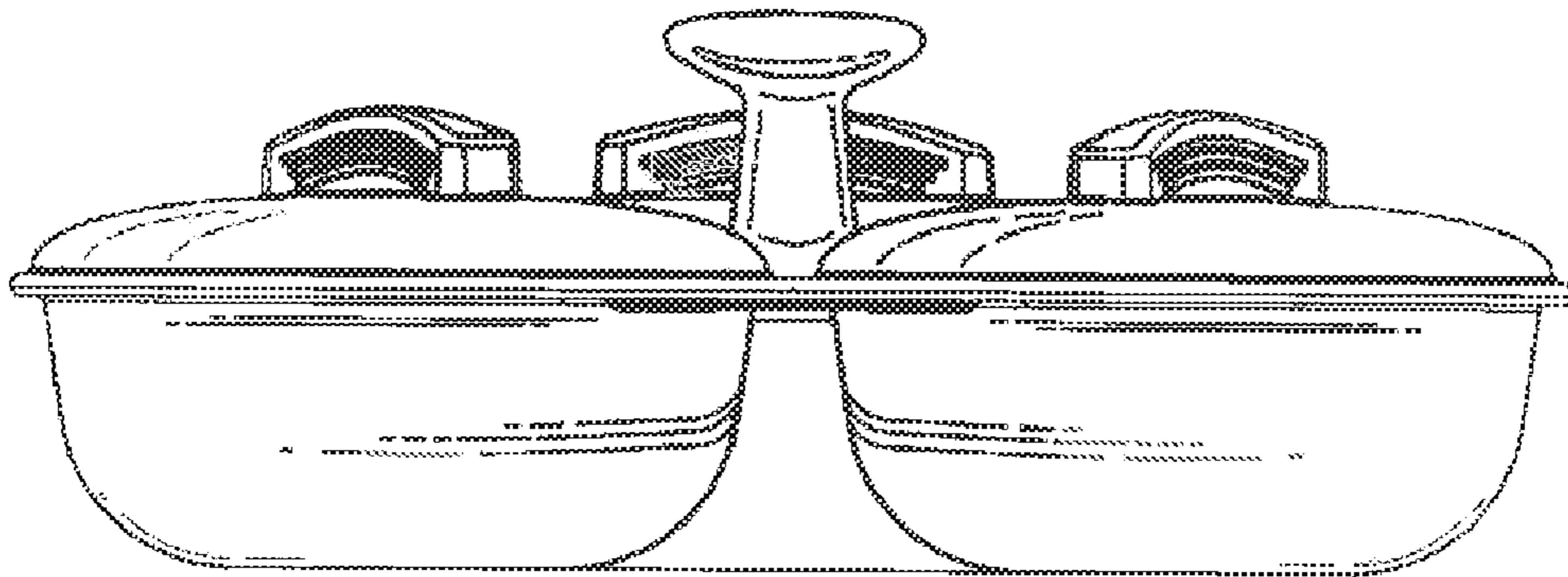
