(57) **CLAIM**

We claim the ornamental design for a casserole dish, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a casserole dish according to the new design;

FIG. 2 is a top view of a casserole dish according to the new design shown in FIG. 1

FIG. 3 bottom view of a casserole dish according to the new design shown in FIG. 1

FIG. 4 is a front elevation view of the casserole dish shown in FIG. 1;

FIG. 5 is a rear elevation view of the casserole dish shown in FIG. 1;

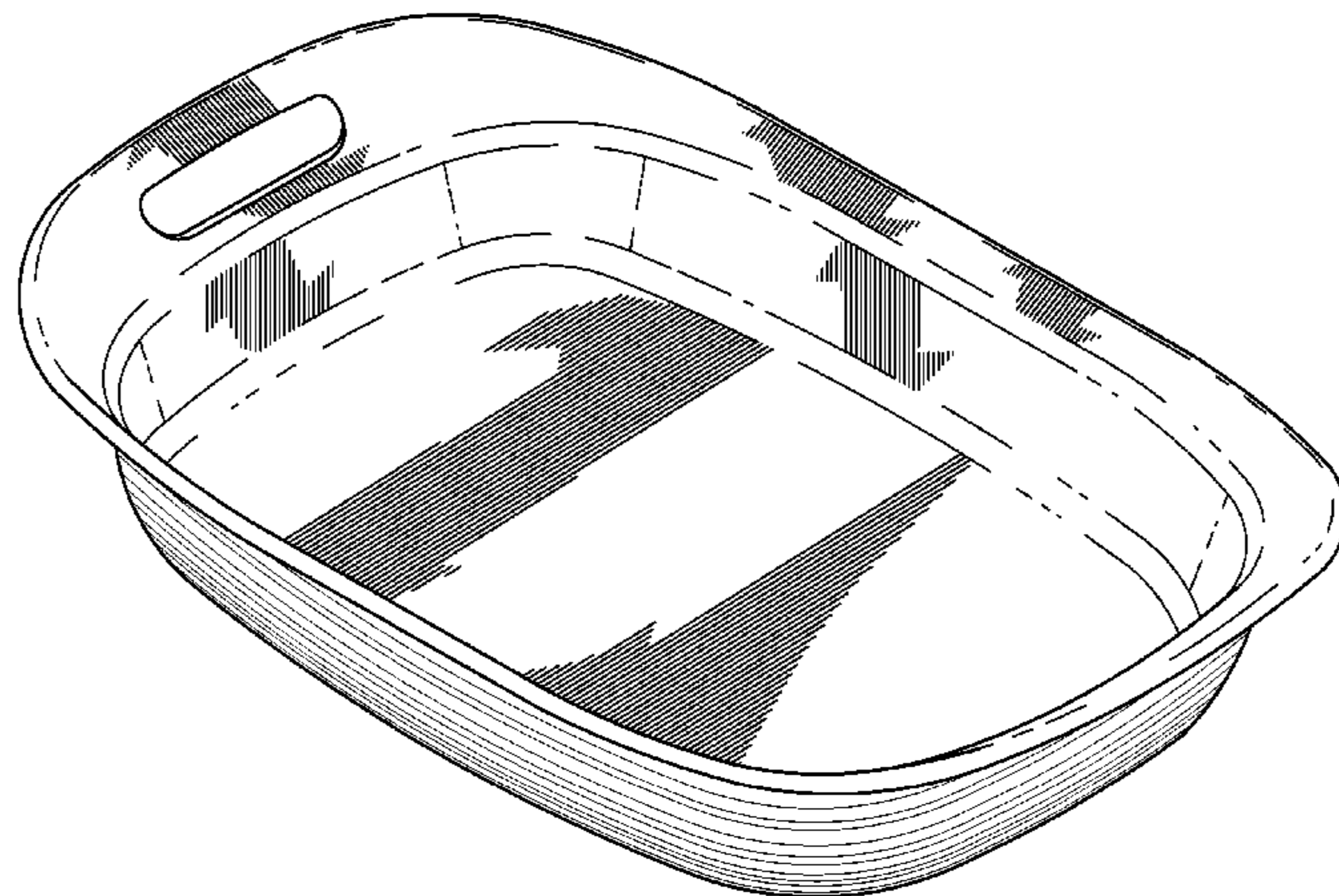
FIG. 6 is a left side elevation view of the casserole dish shown in FIG. 1;

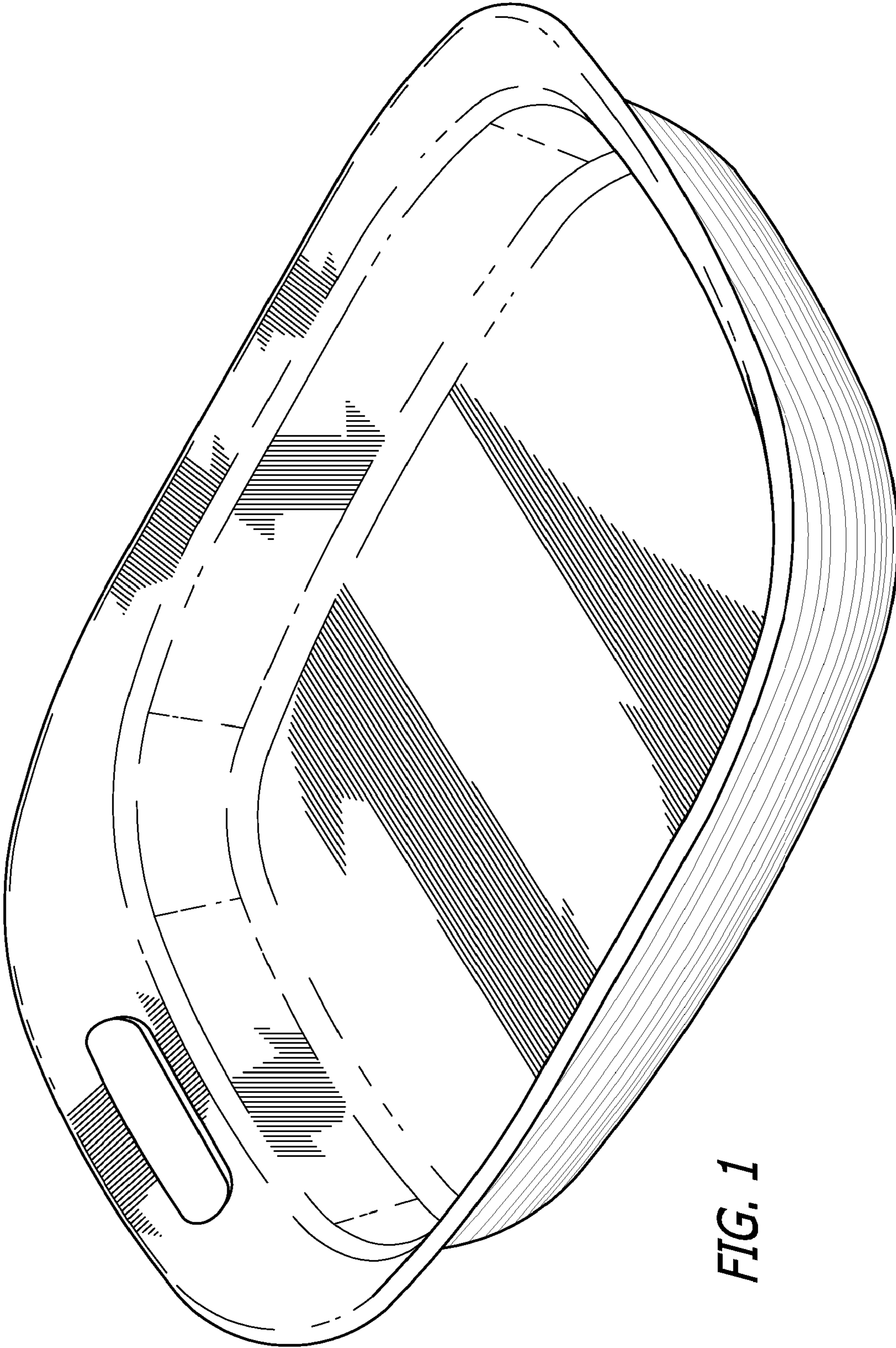

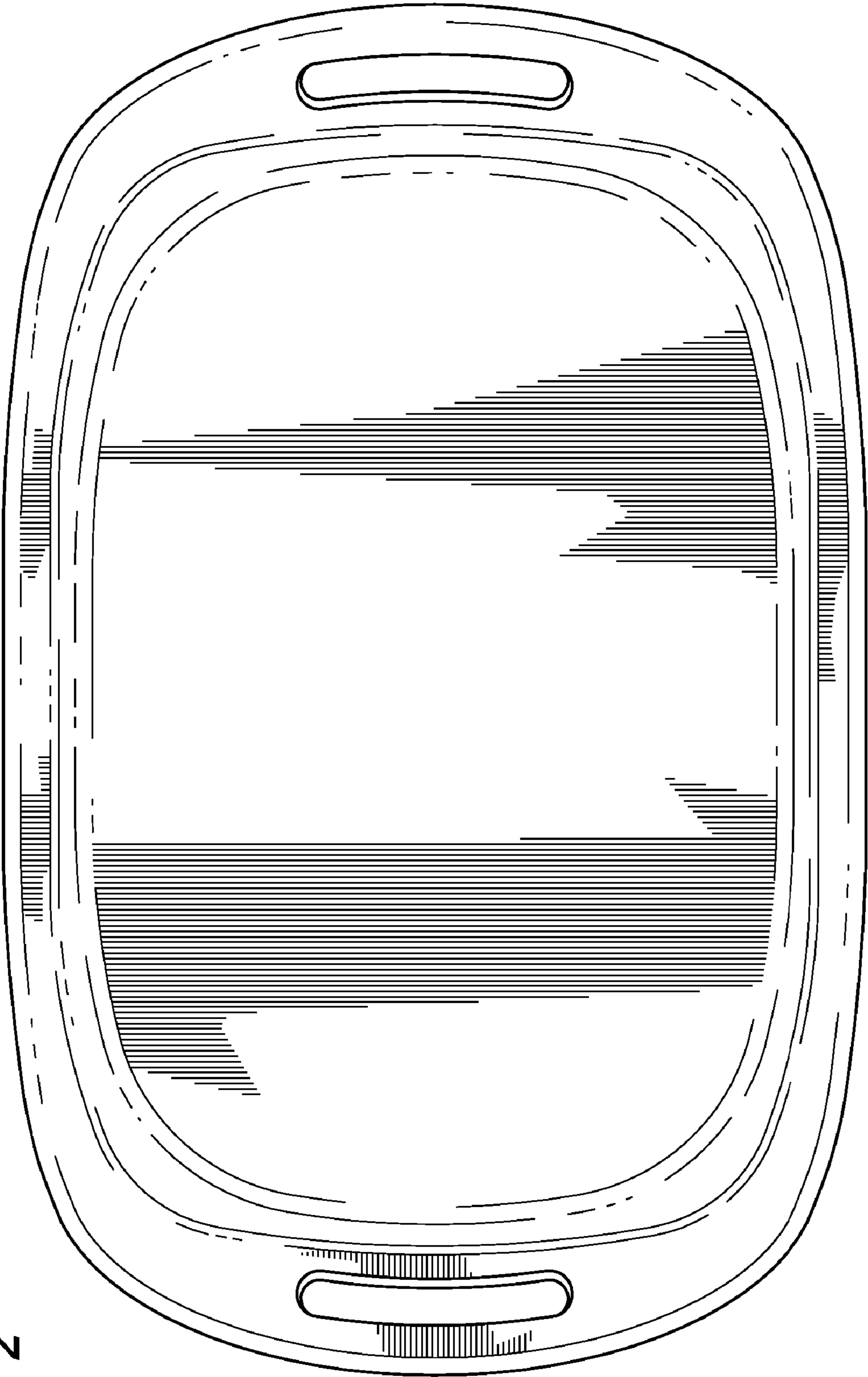

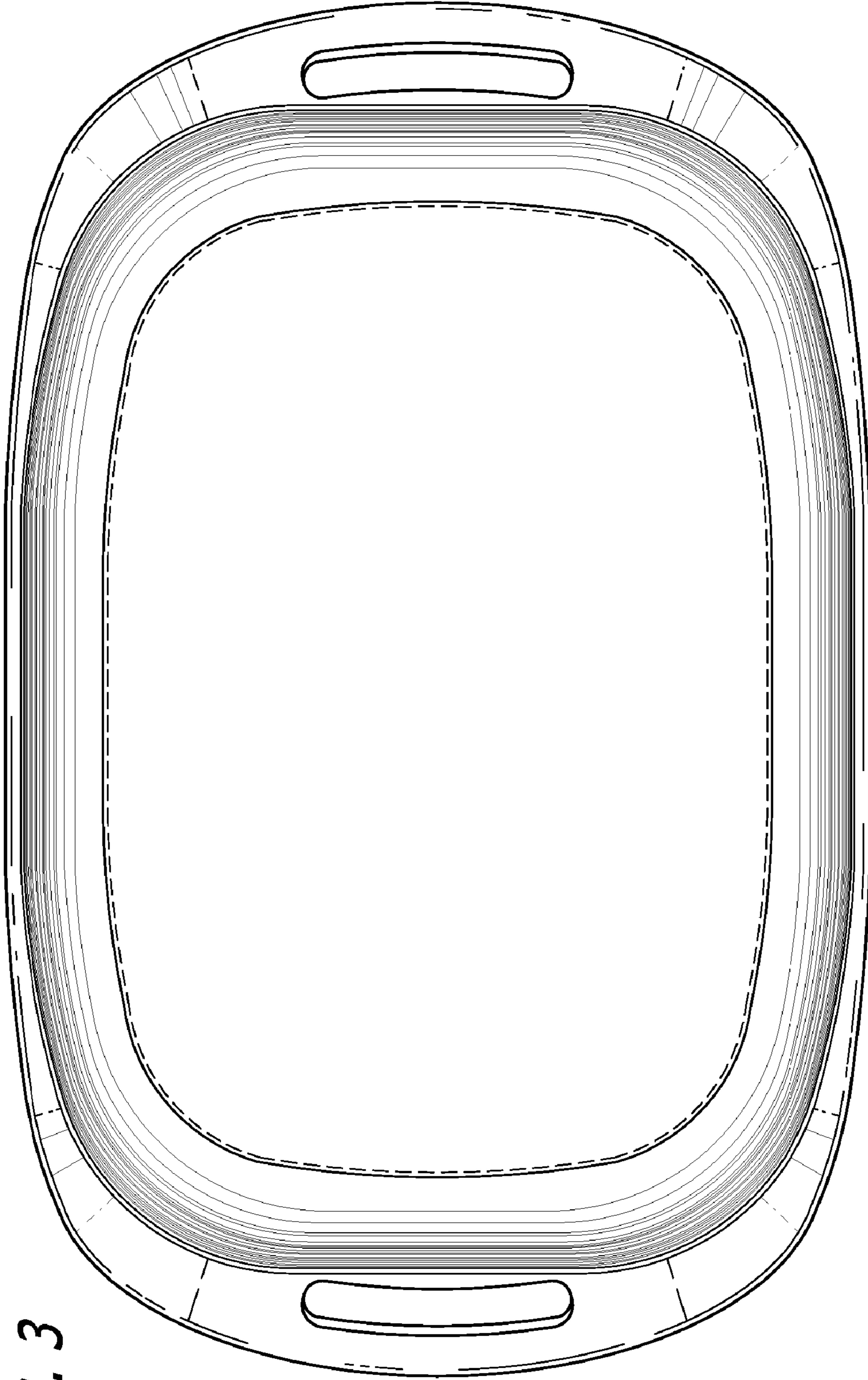

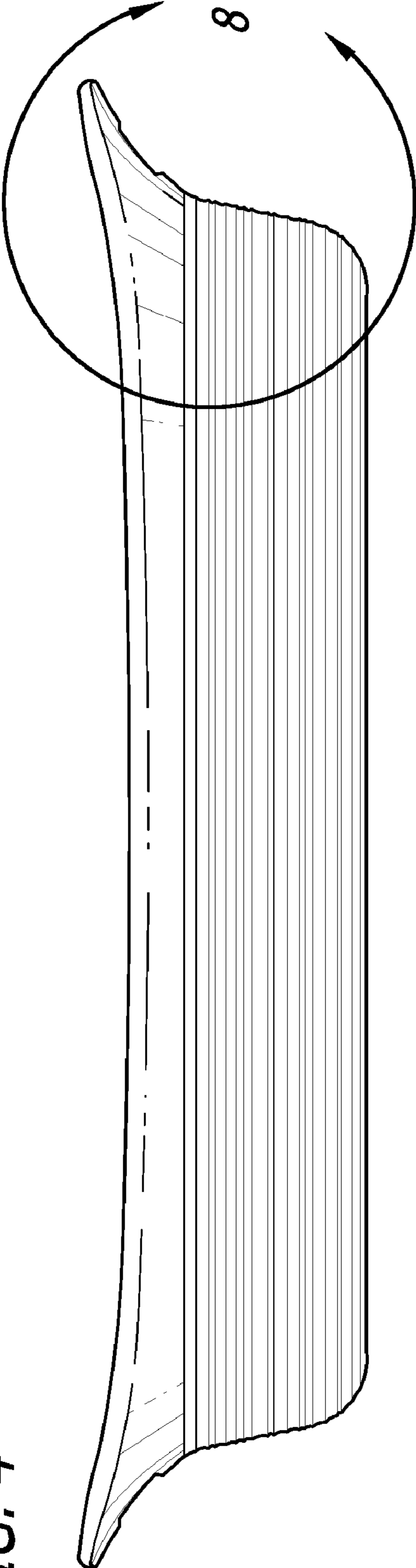

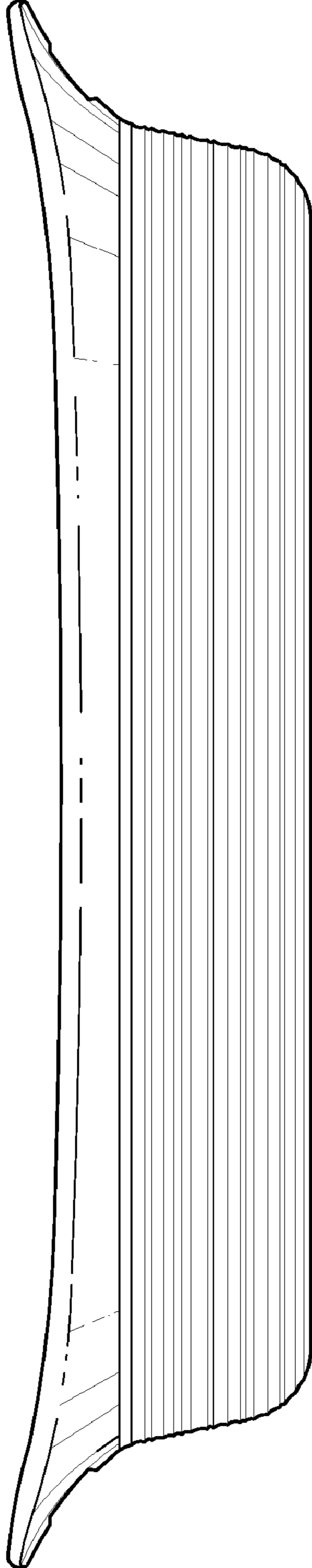

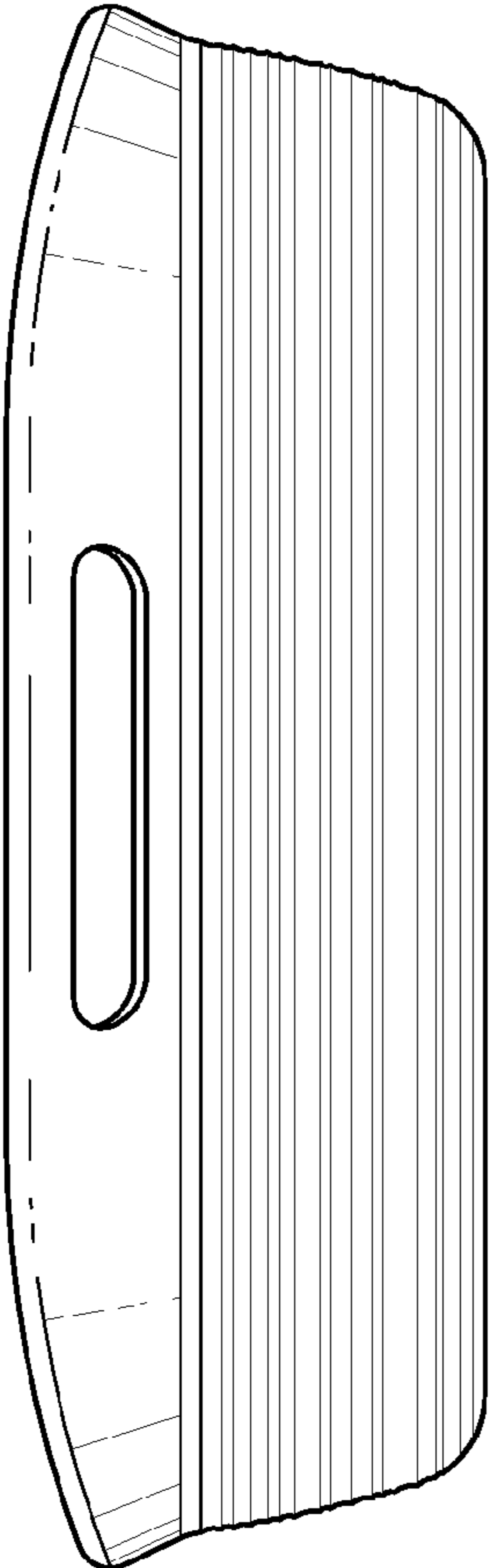

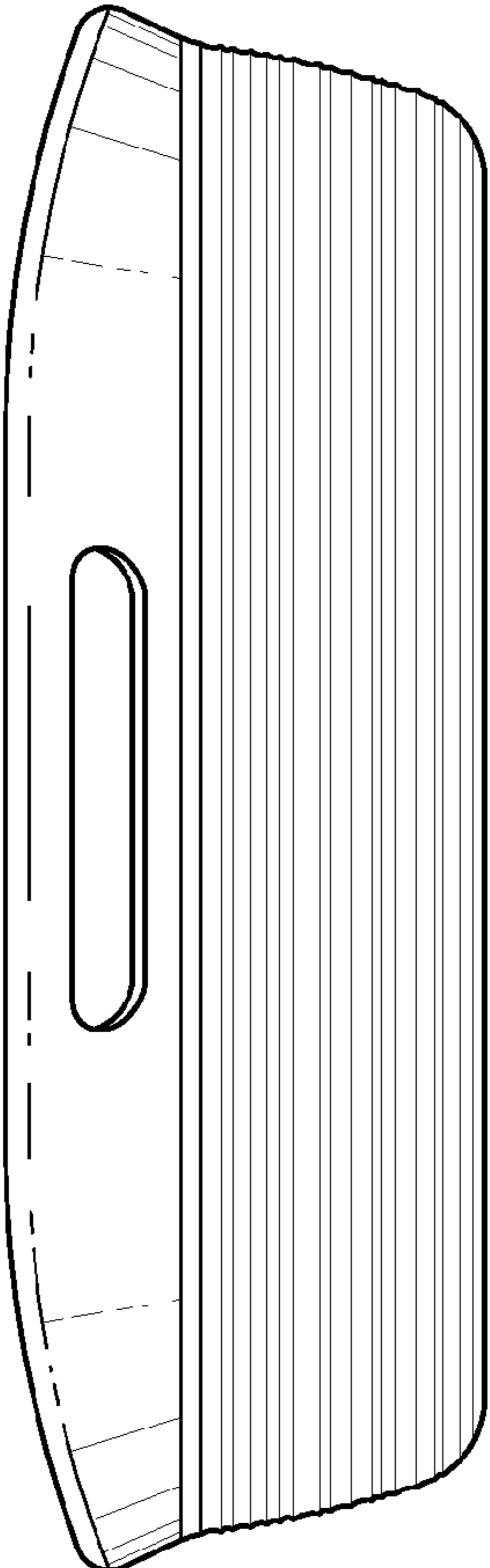
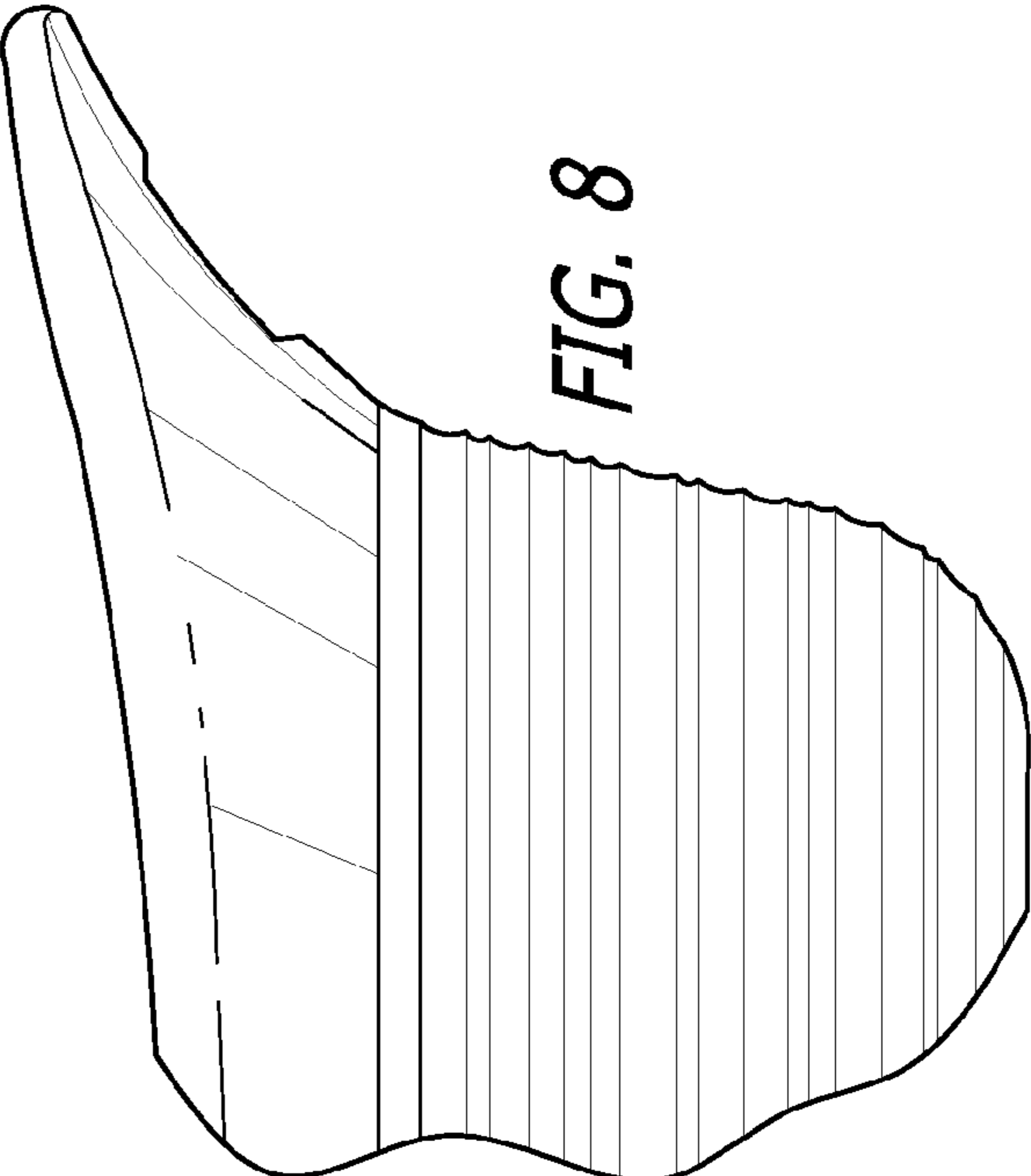
