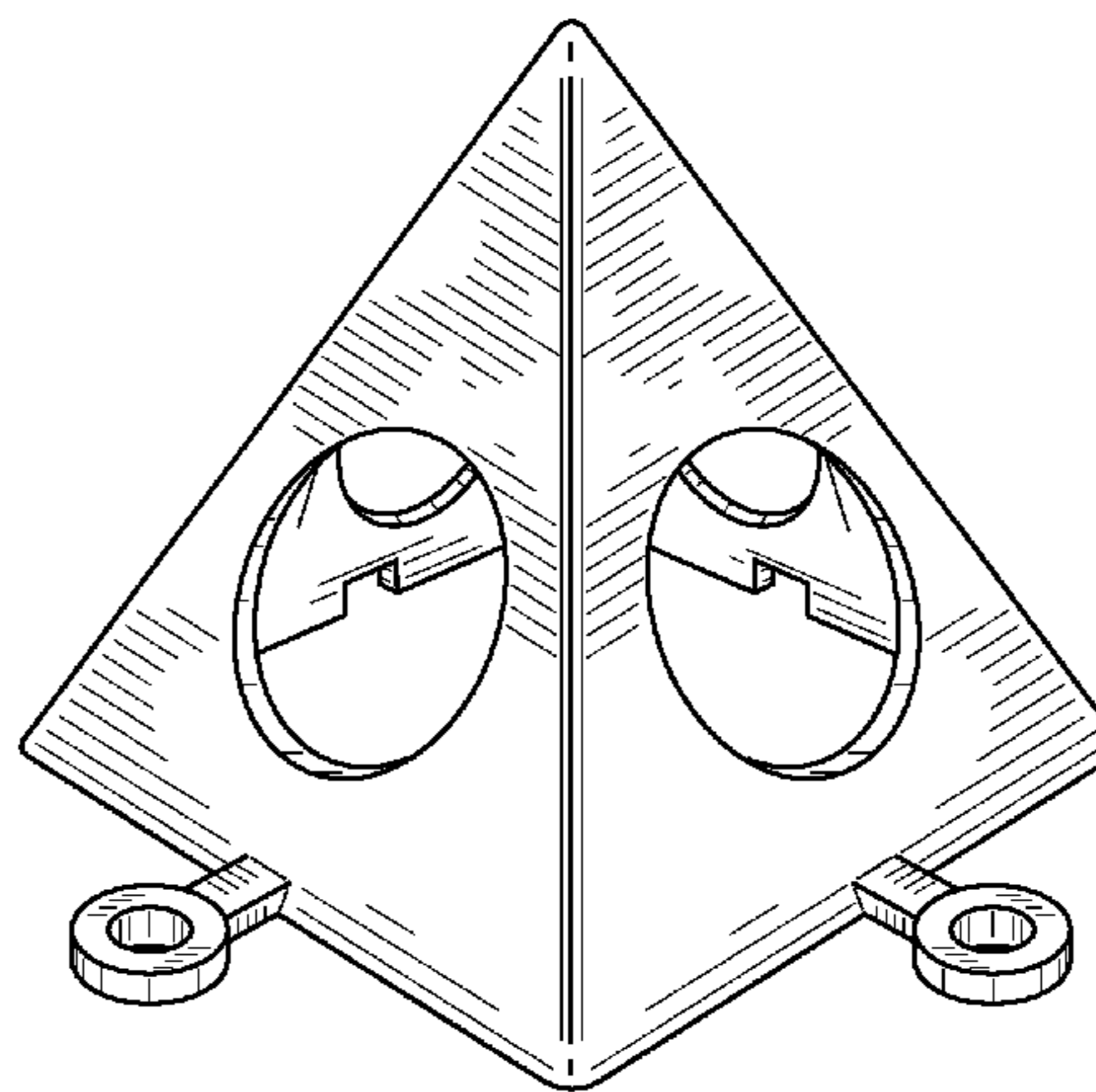
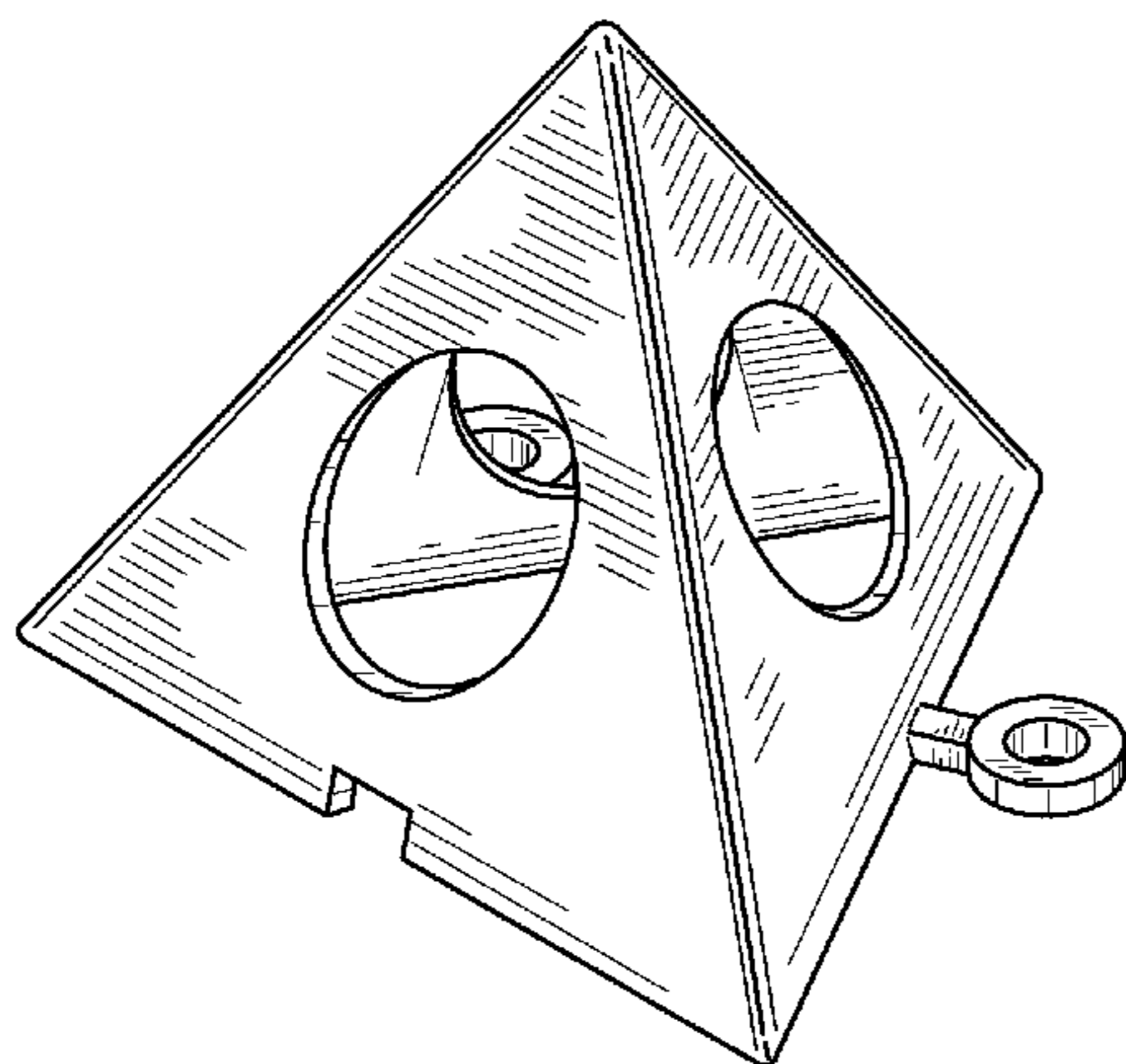
(57) **CLAIM**

I claim the ornamental design for a device for supporting an object, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of one embodiment of a device for supporting an object showing the new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a top view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a perspective view of an alternative embodiment of a device for supporting an object;

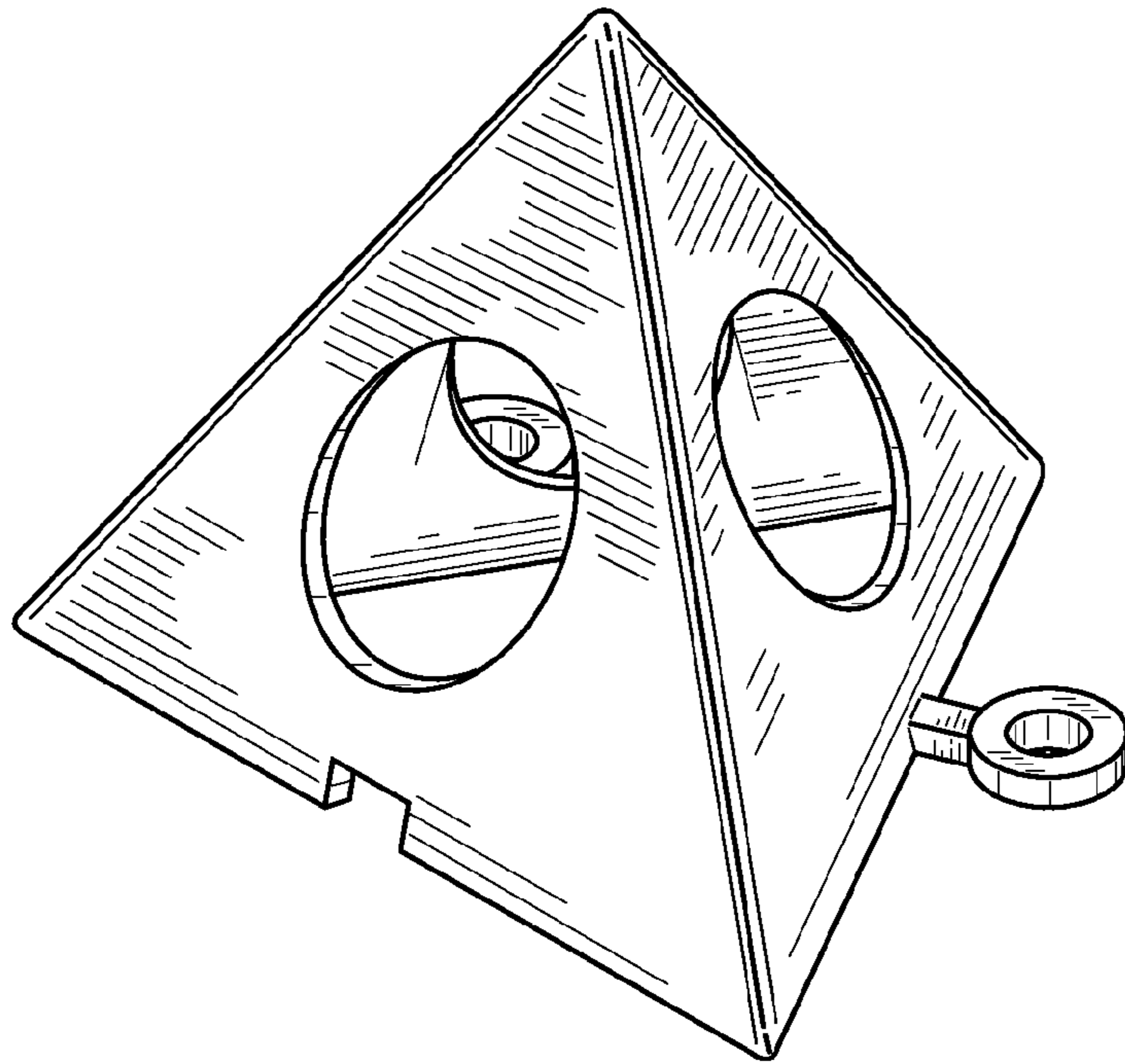

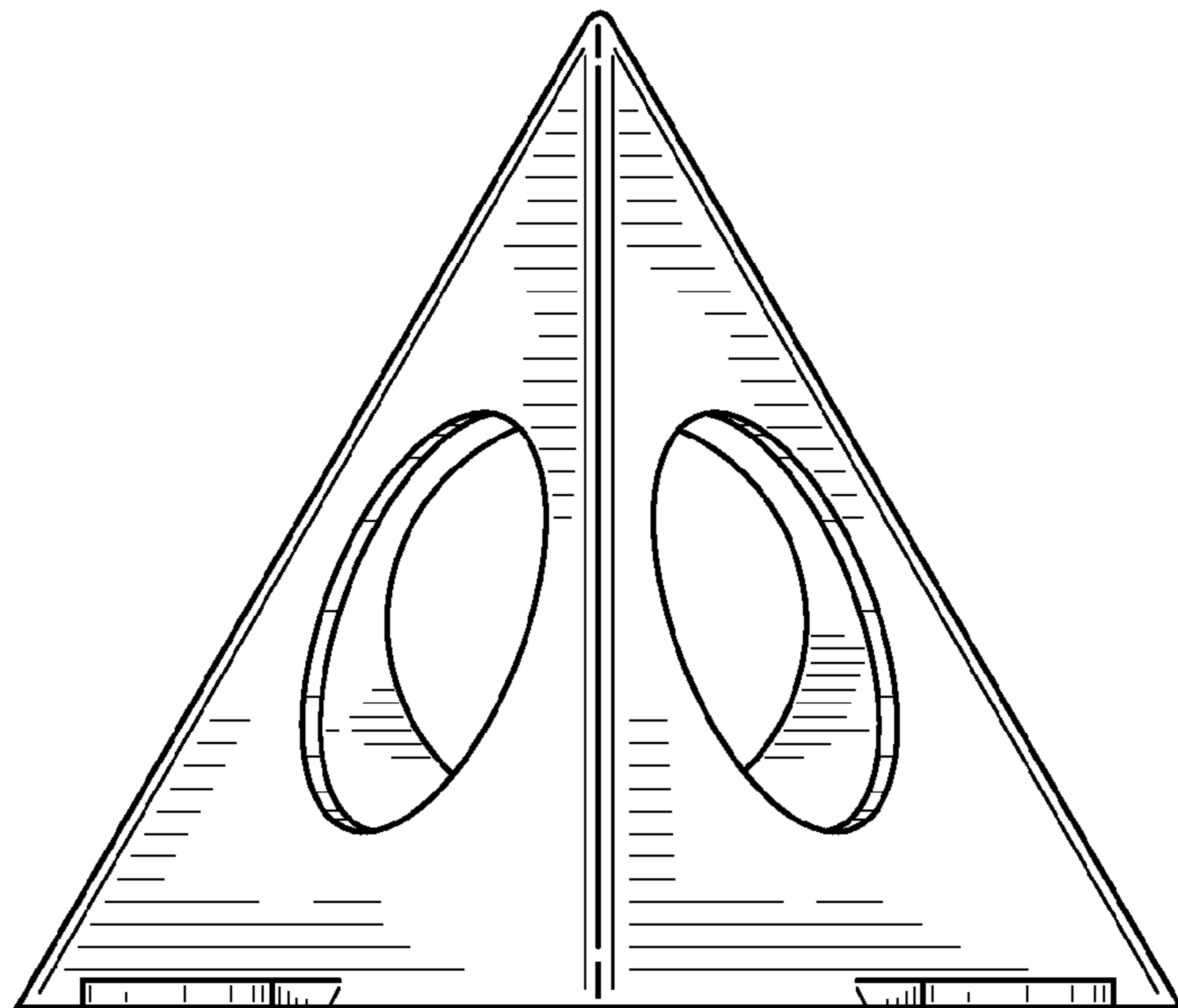

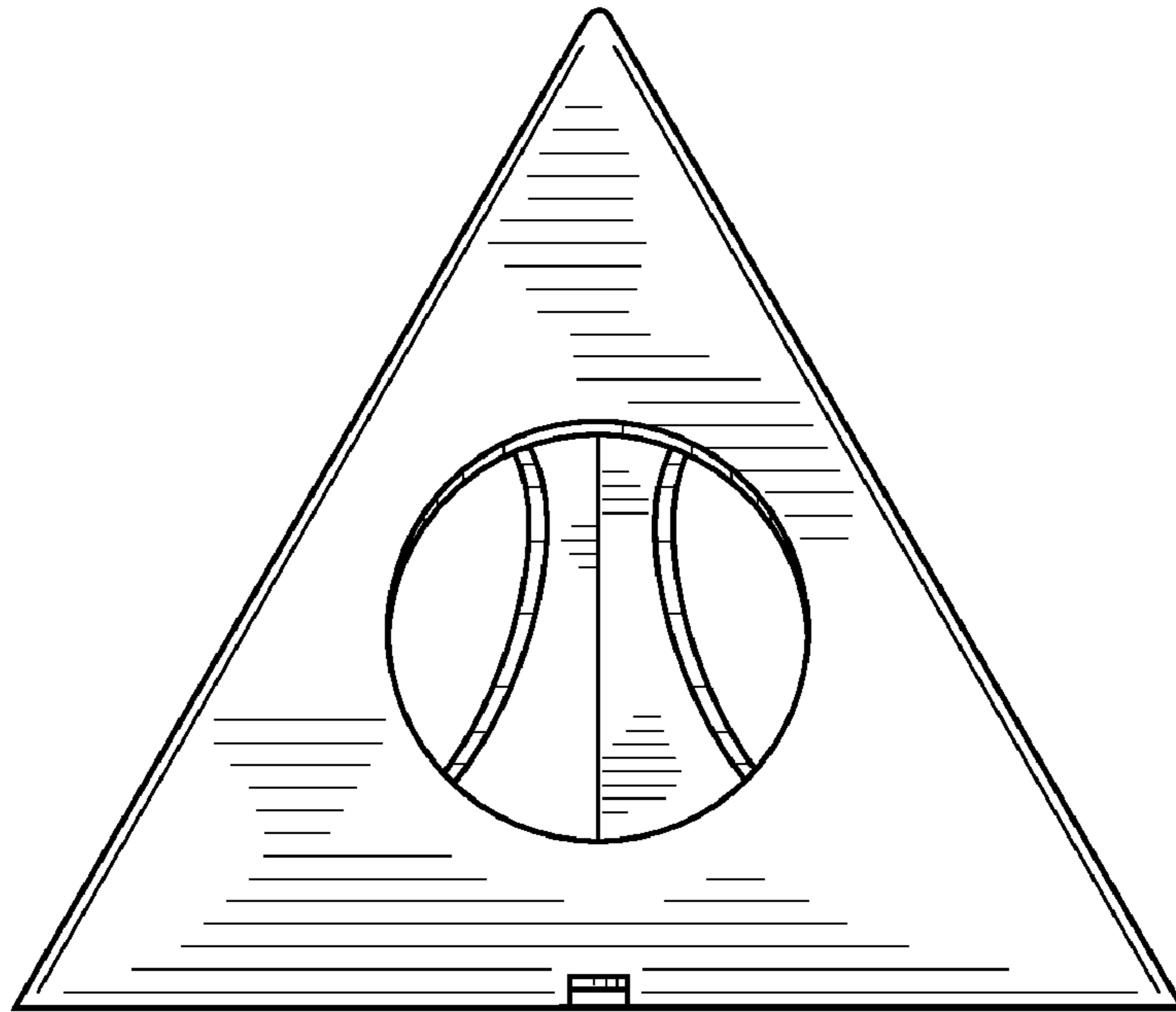

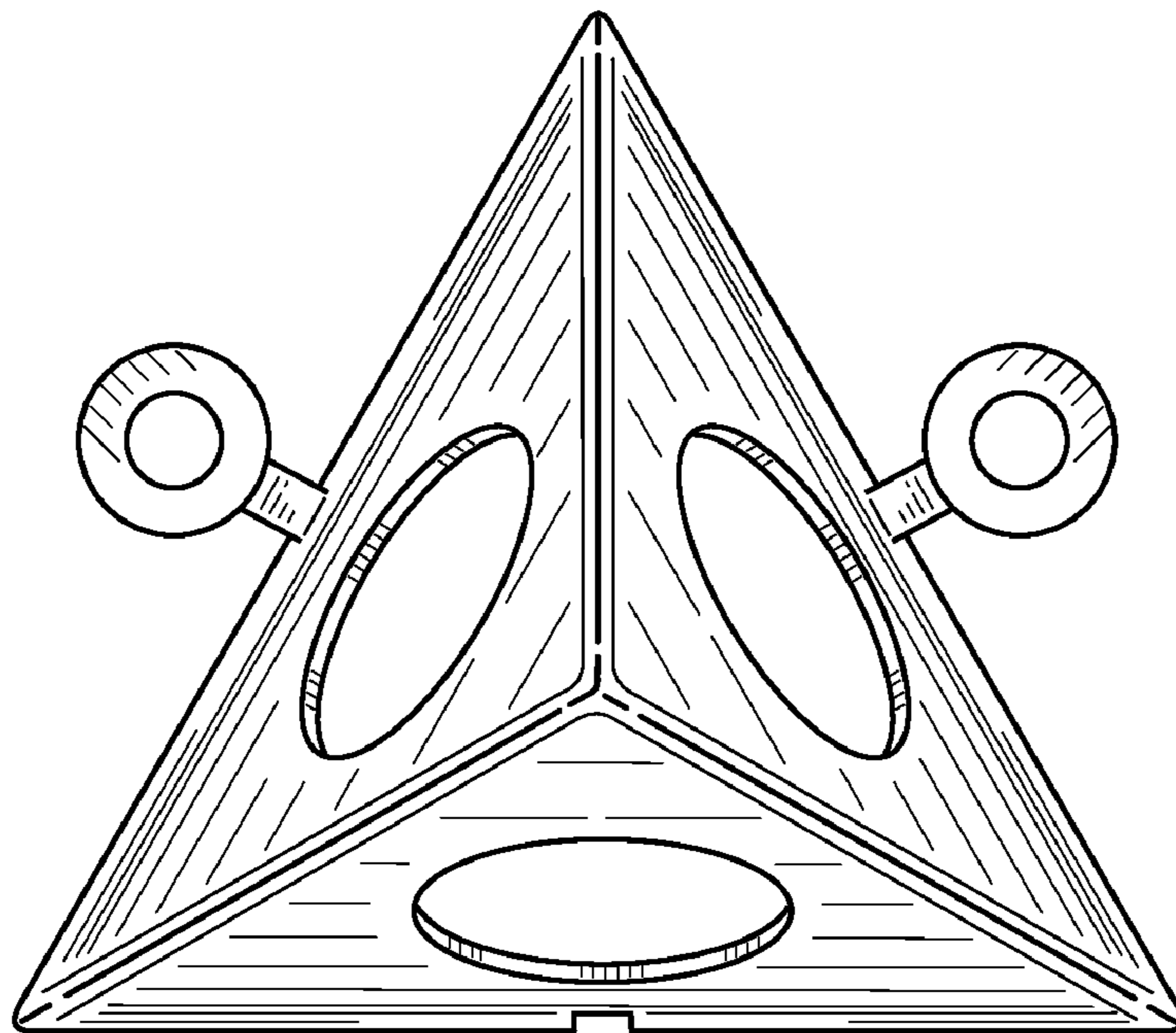

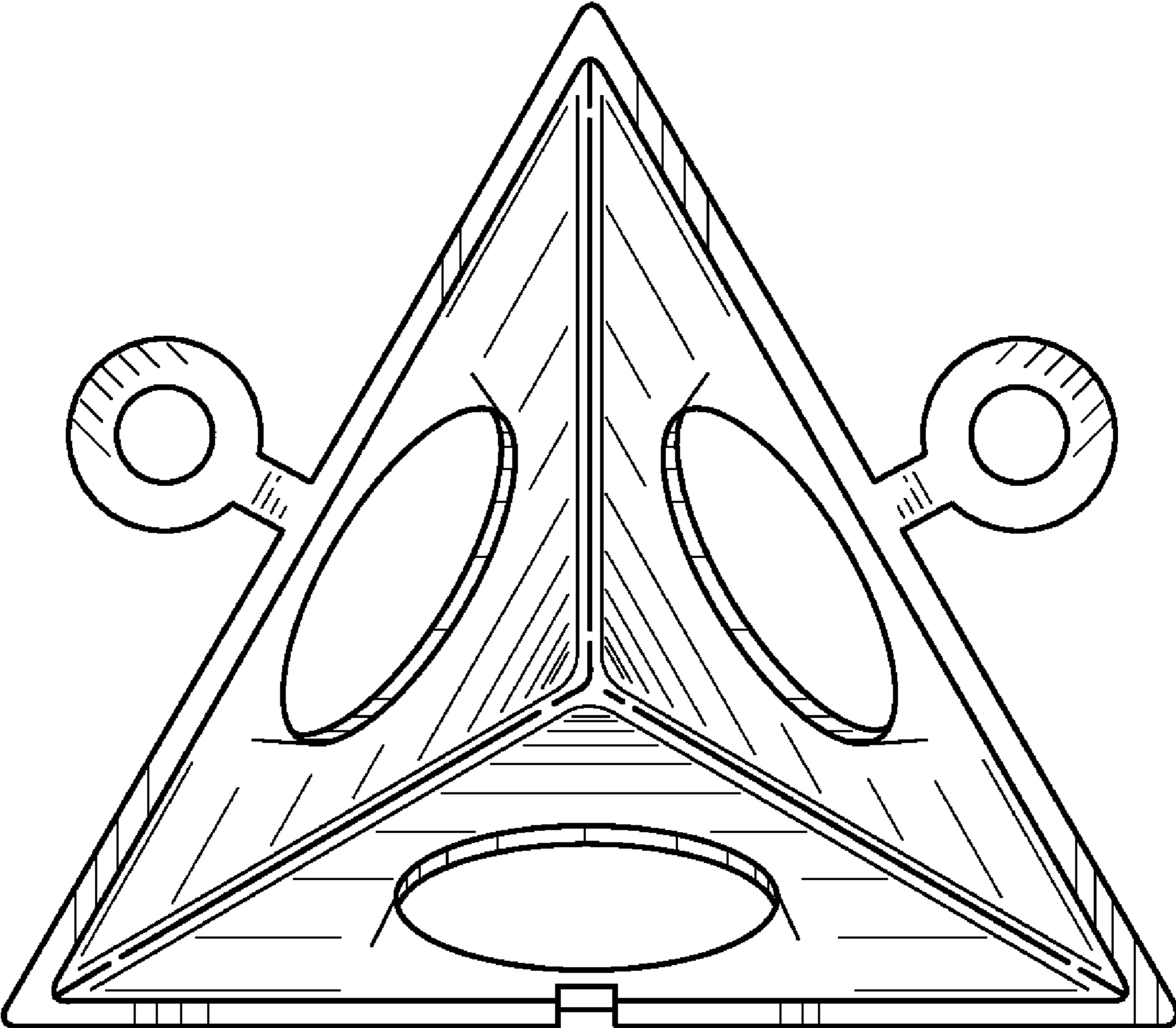

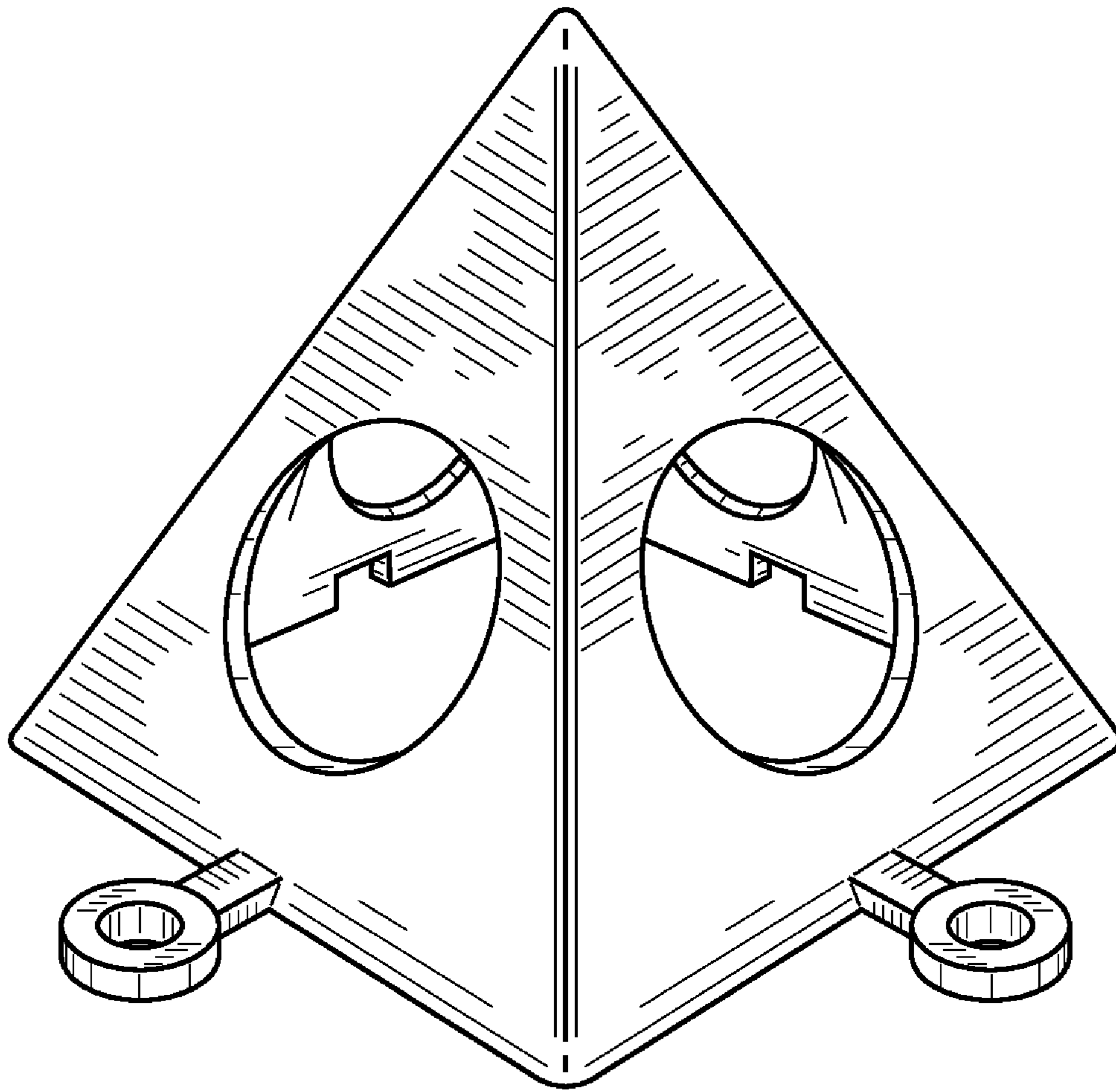

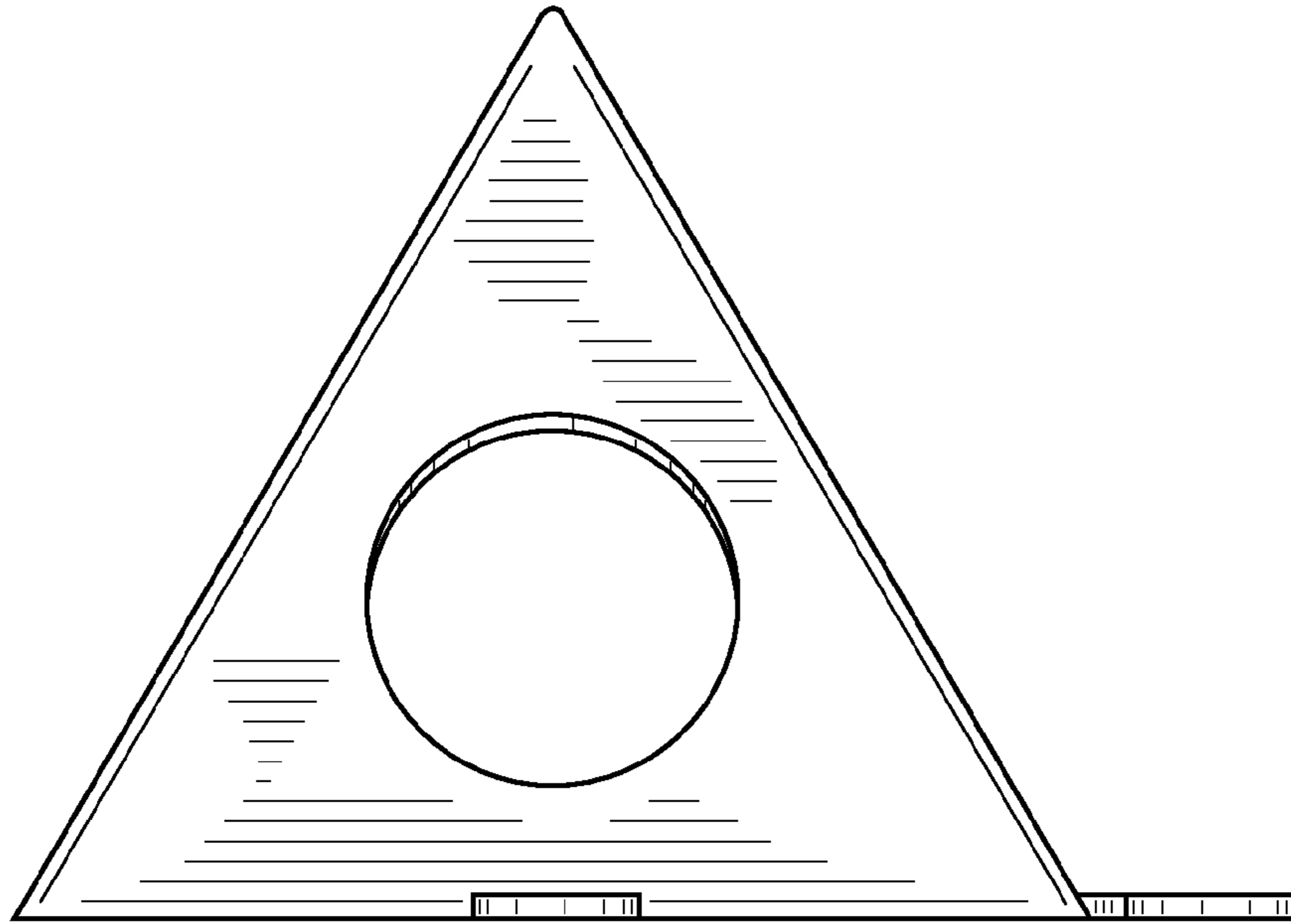

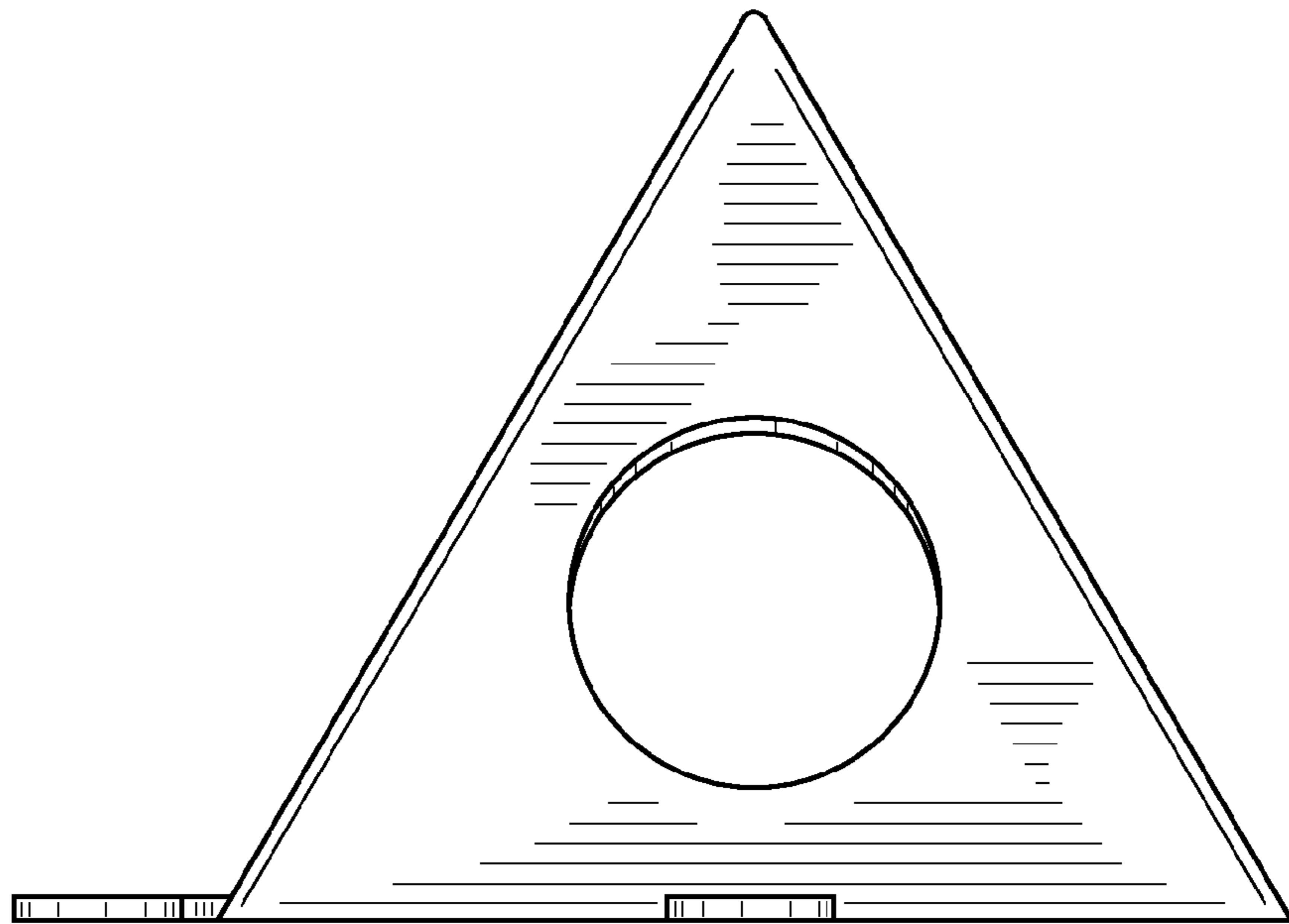

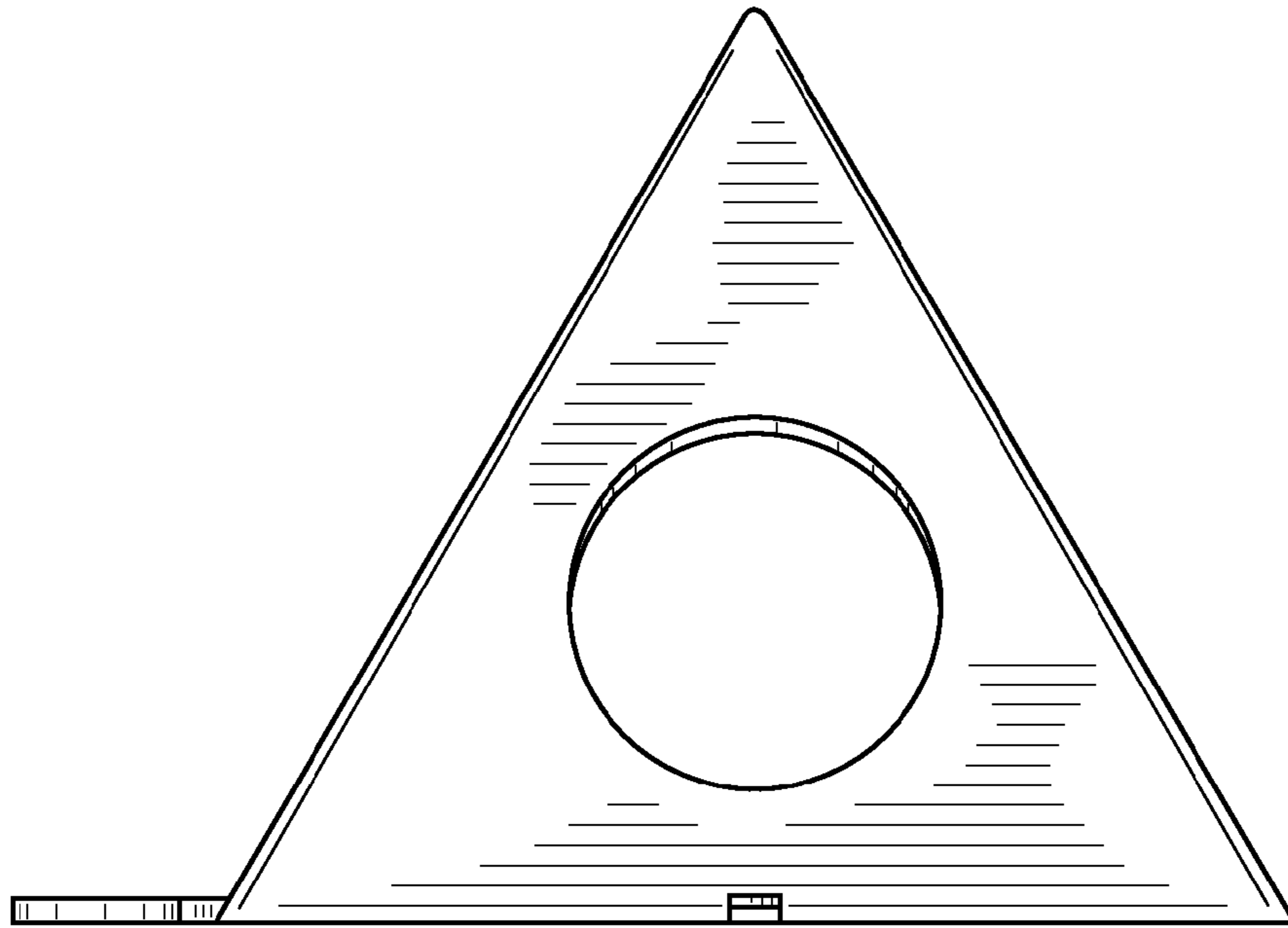

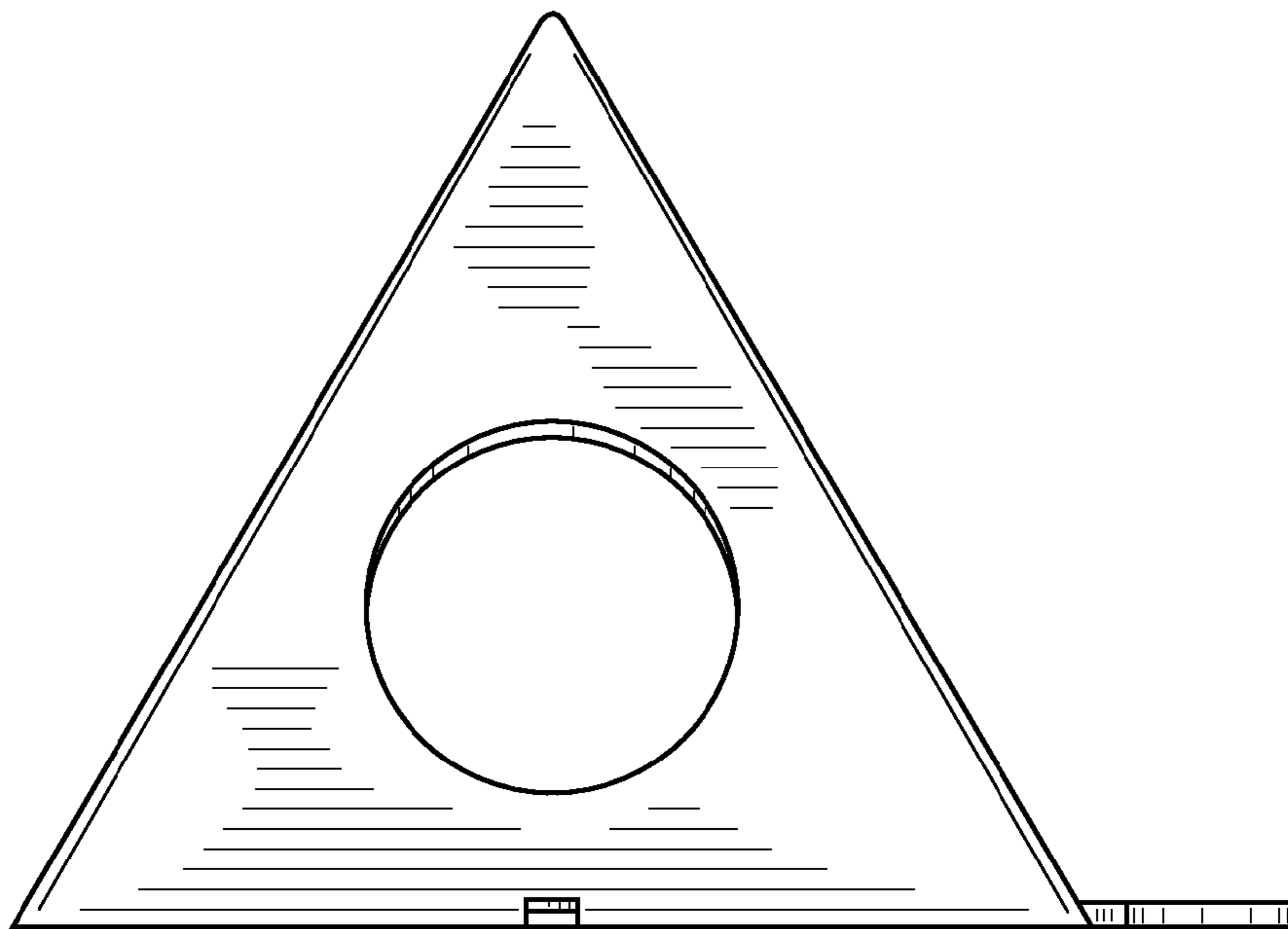

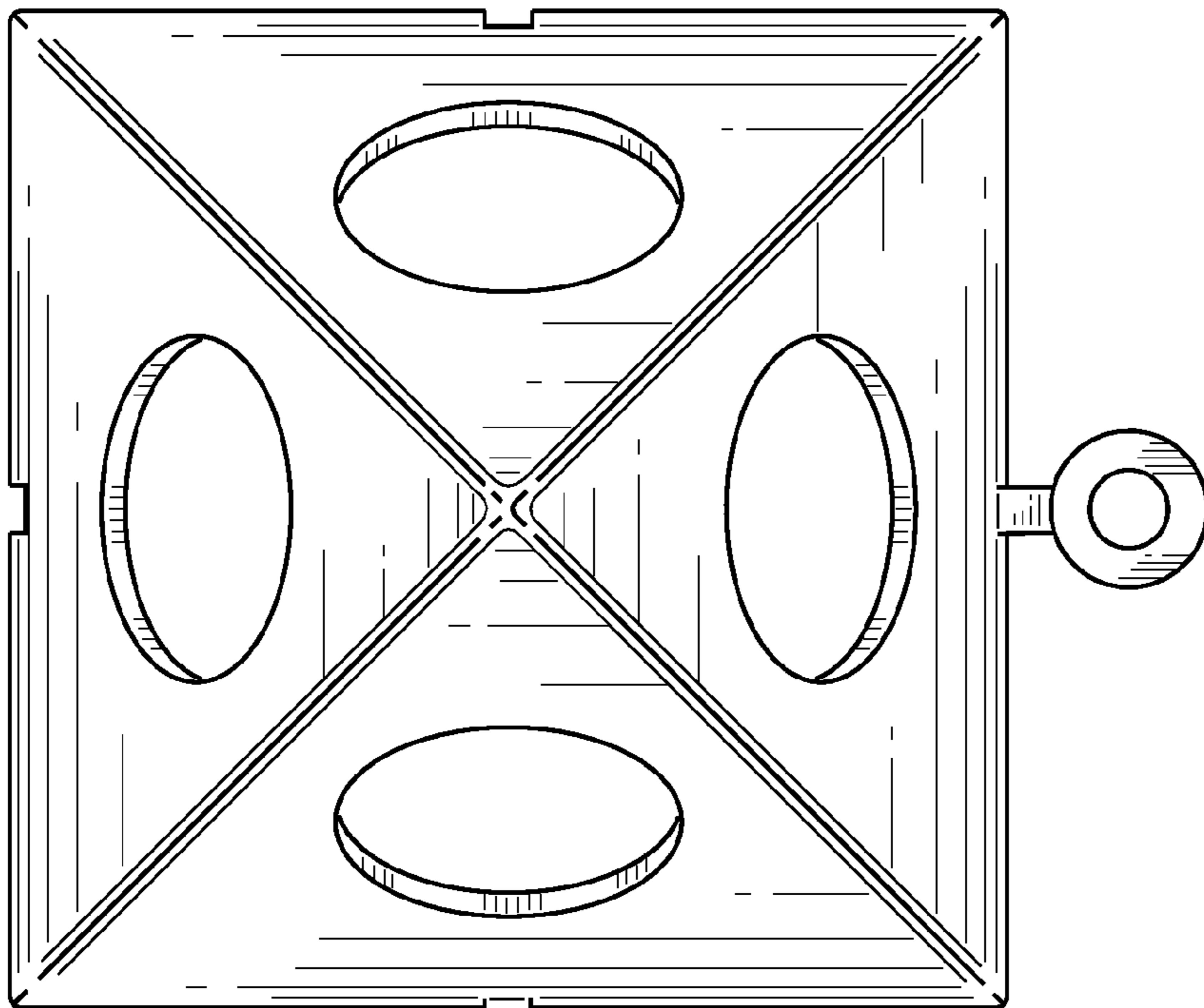

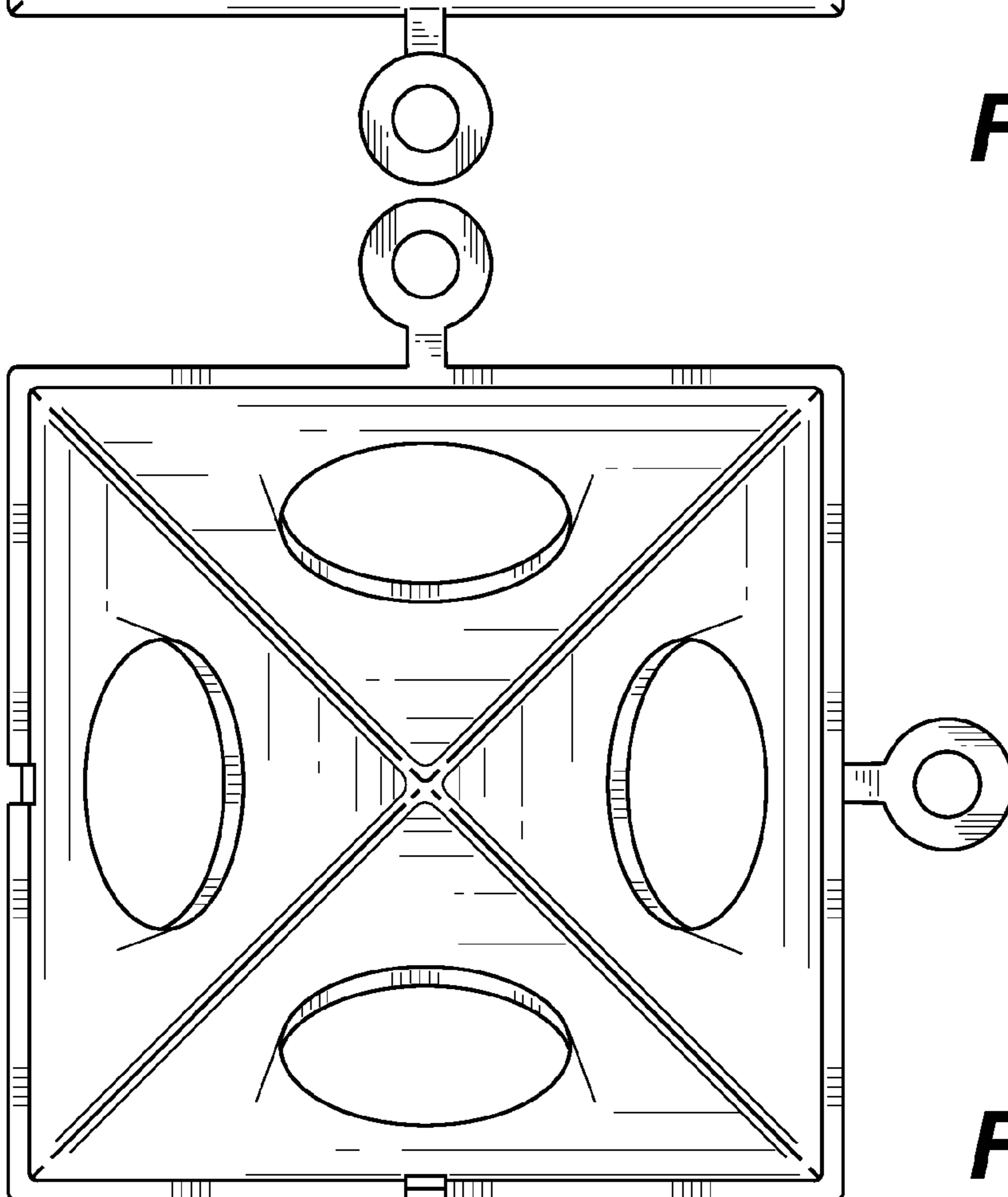
