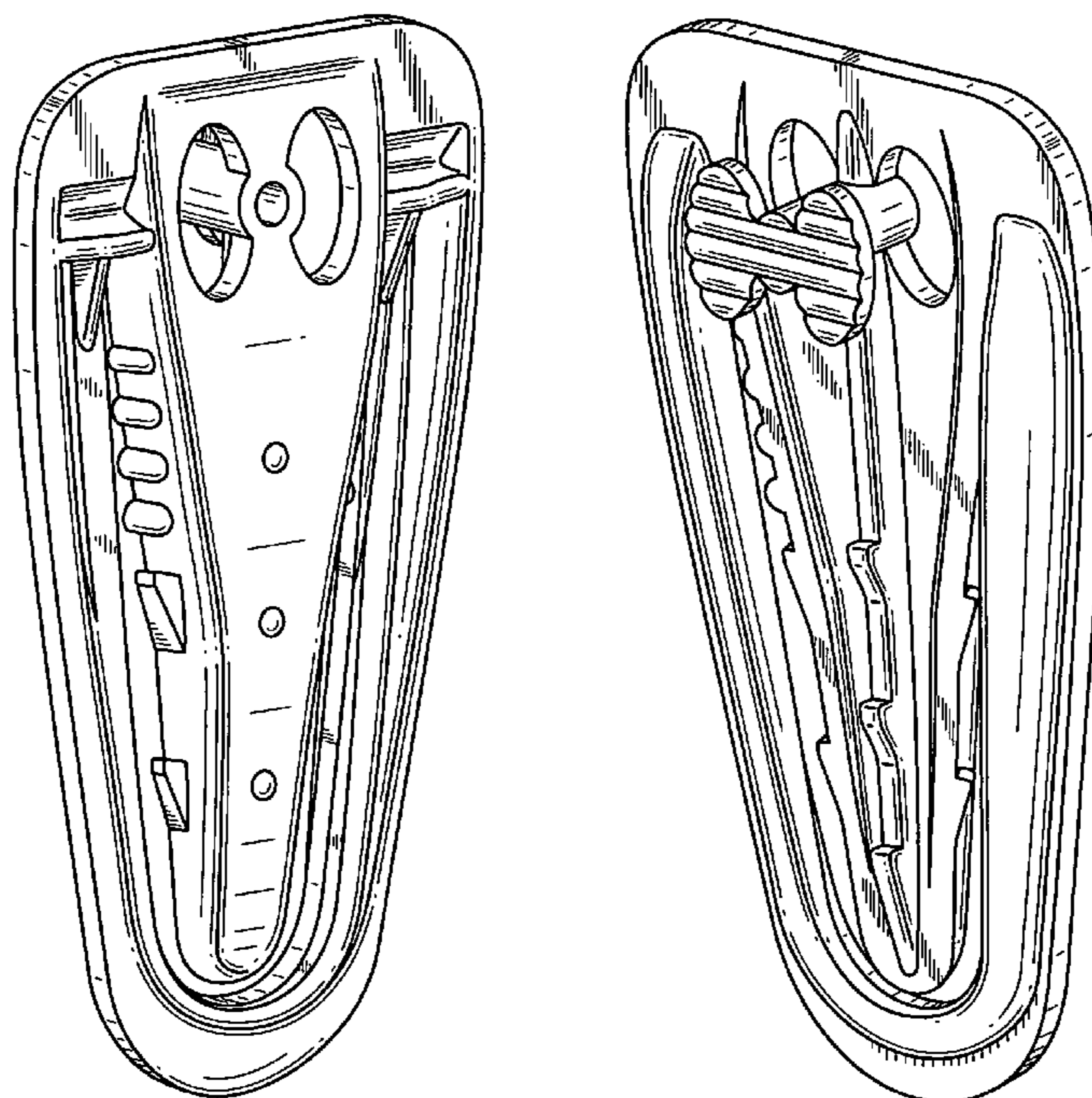
(57) **CLAIM**

I claim the ornamental design for a clip for identification badges, as shown.

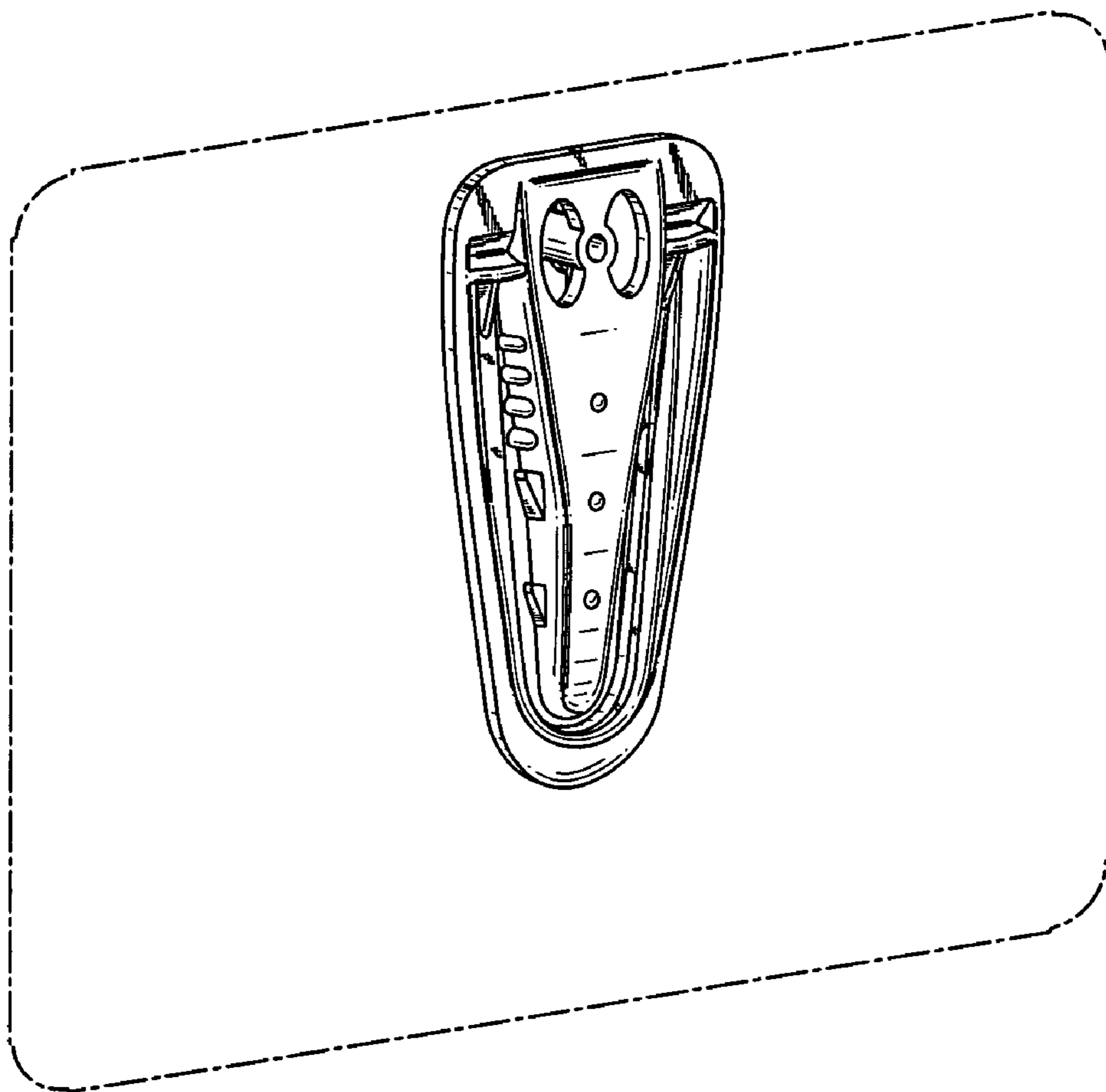
**DESCRIPTION**

FIG. 1 is a front perspective view of a clip for identification badges showing my new design in use;  
FIG. 2 is a front perspective view of a clip for identification badges showing my new design;  
FIG. 3 is a rear perspective view thereof;  
FIG. 4 is a front plan view thereof;  
FIG. 5 is side view thereof, with the other side being identical thereto;  
FIG. 6 is a back plan view thereof; and  
FIG. 7 is a top view thereof; and  
FIG. 8 is a bottom view thereof.  
The broken line showing of an identification badge in FIG. 1 depicts environmental subject matter only and forms no part of the claimed design.

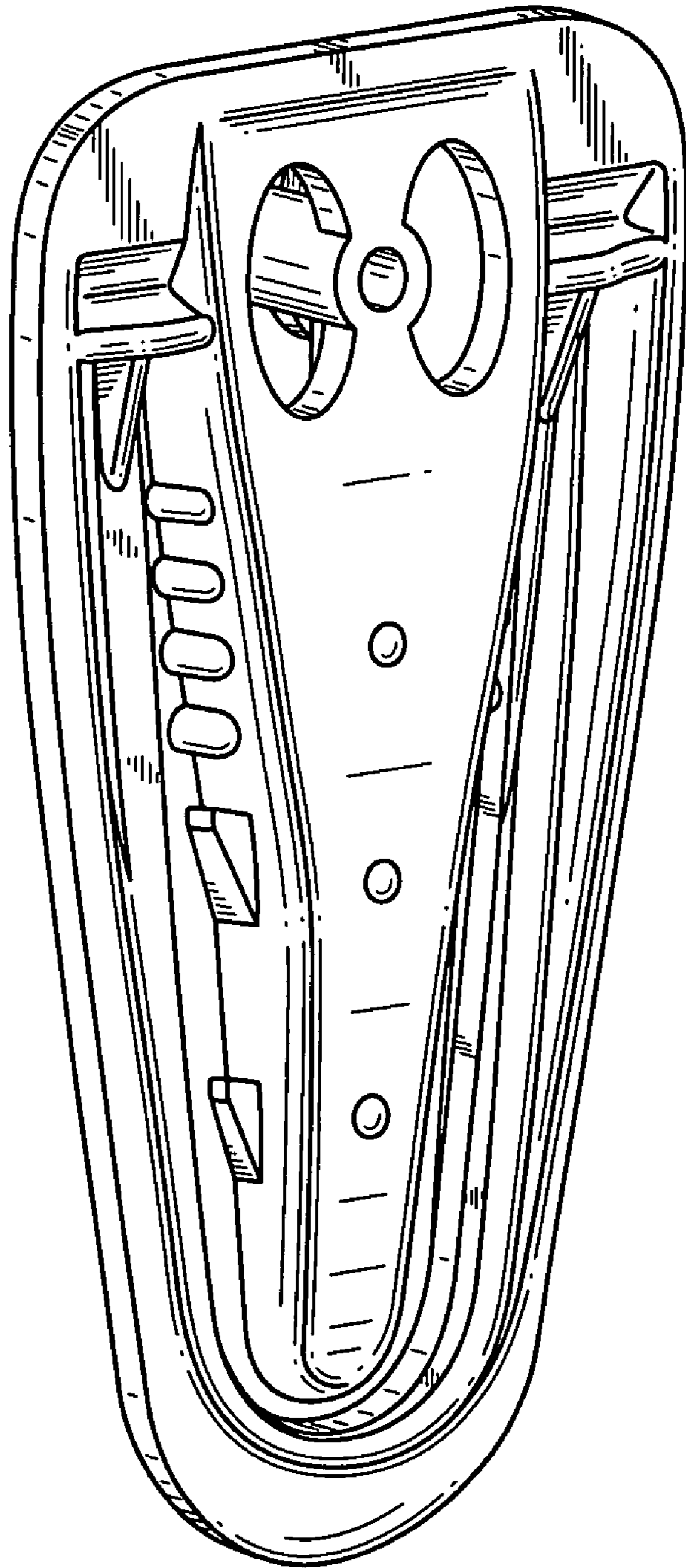

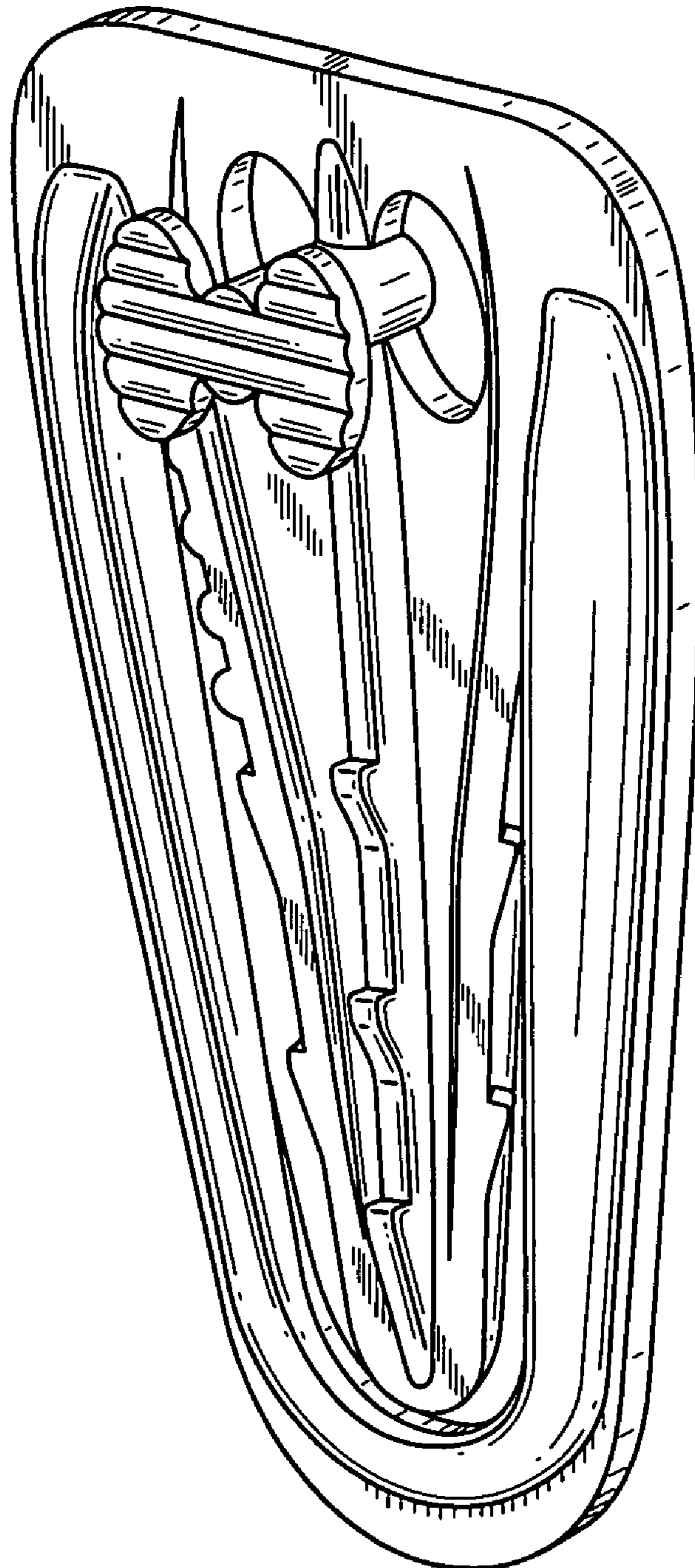

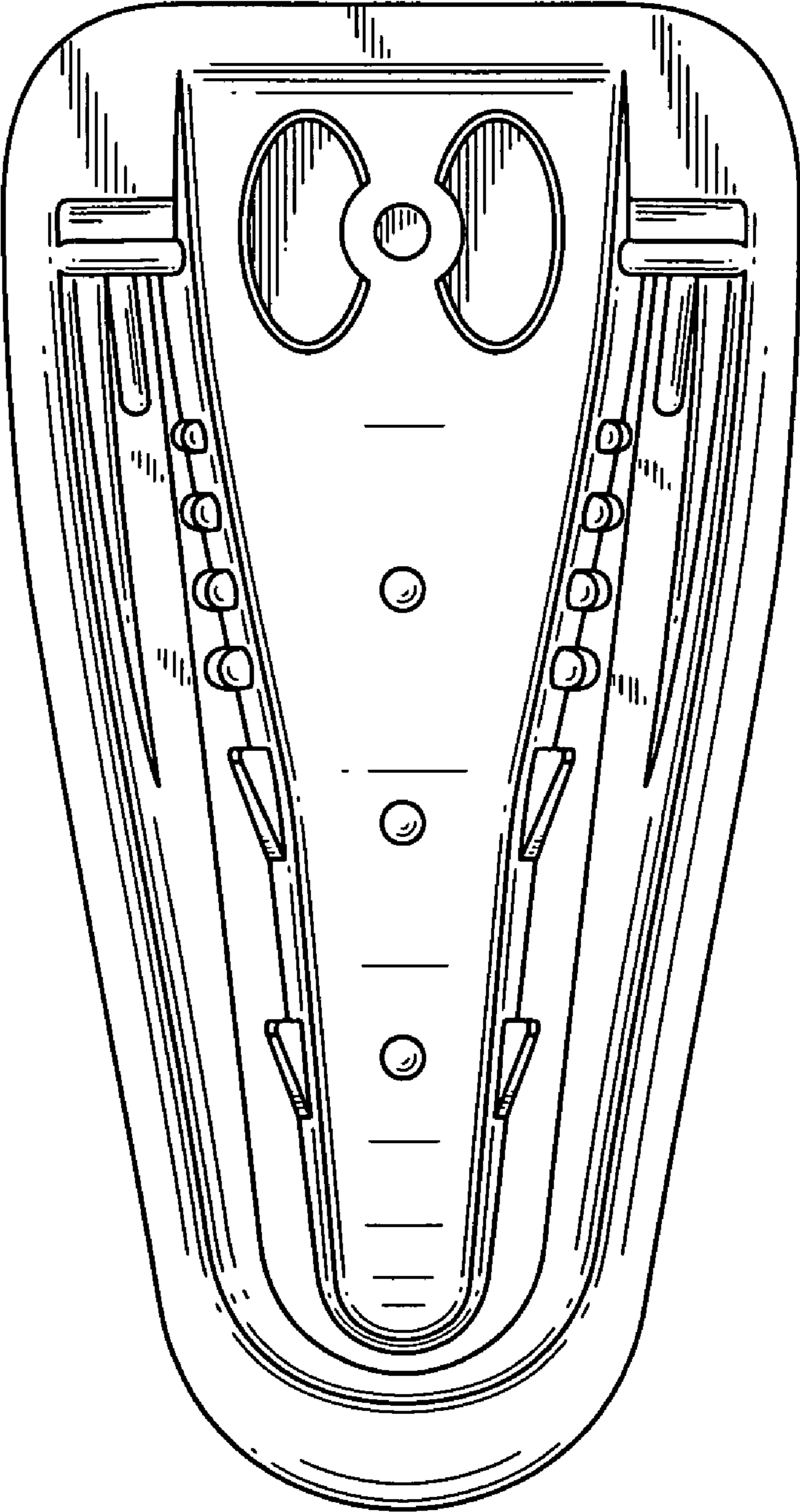

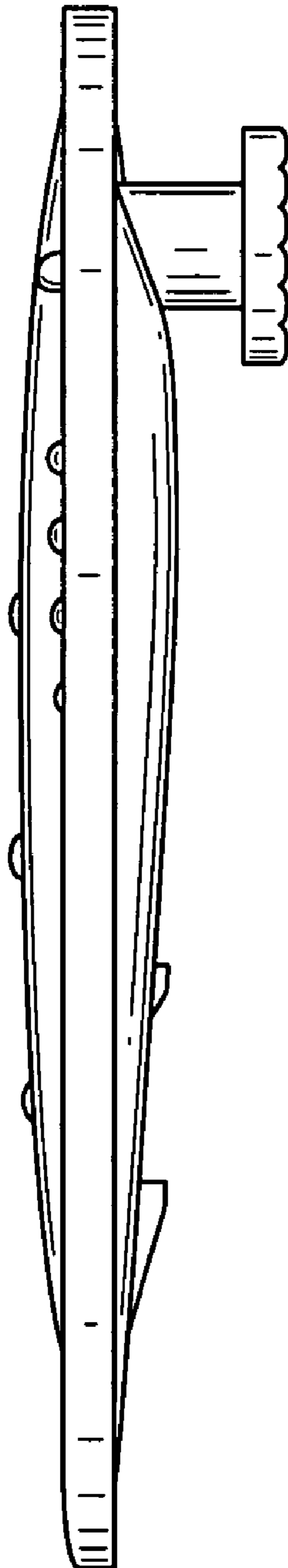

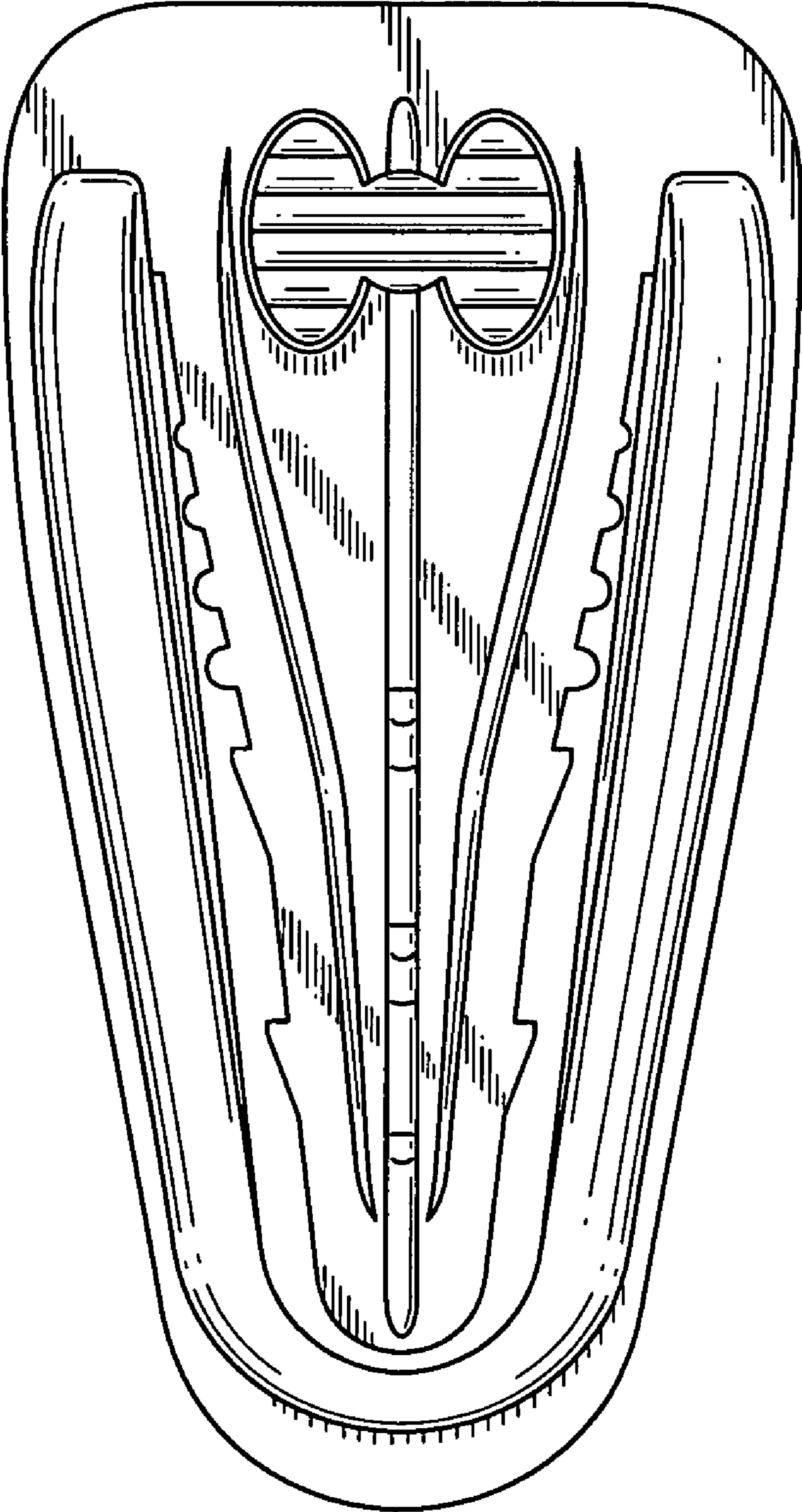

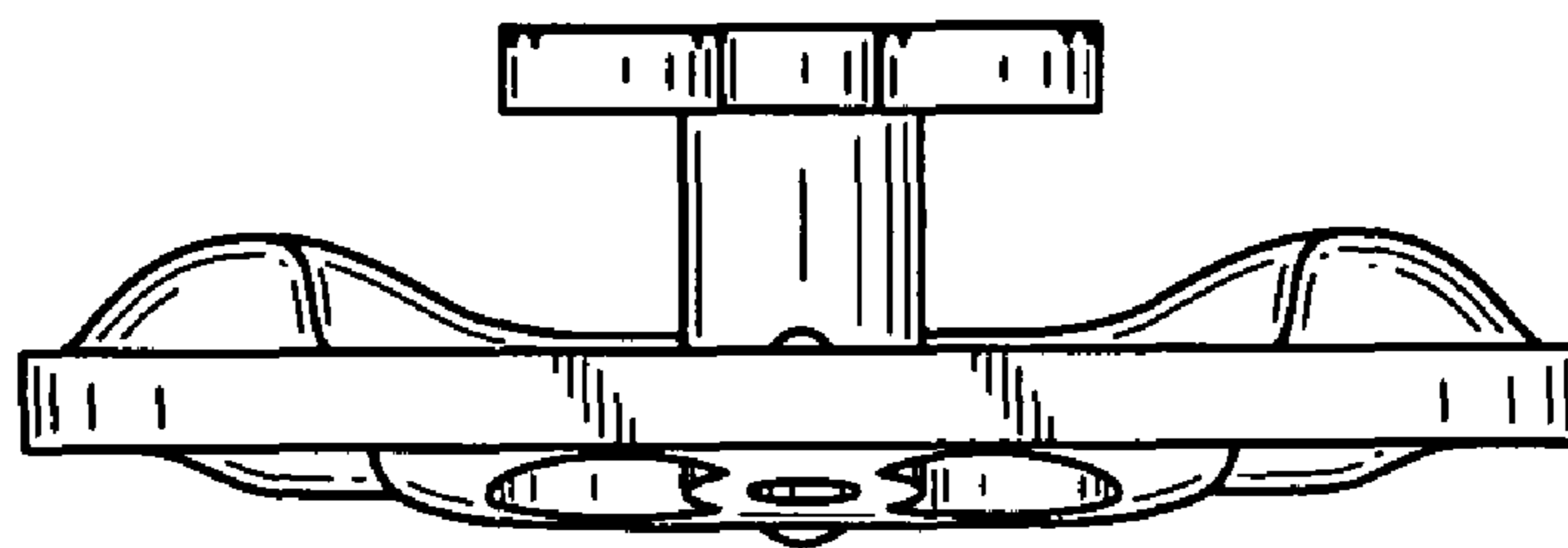
