**DESCRIPTION**

FIG. 1 is a perspective view showing our new design;

FIG. 2 is a front elevational view thereof, the rear elevational view being identical except for the unclaimed threads;

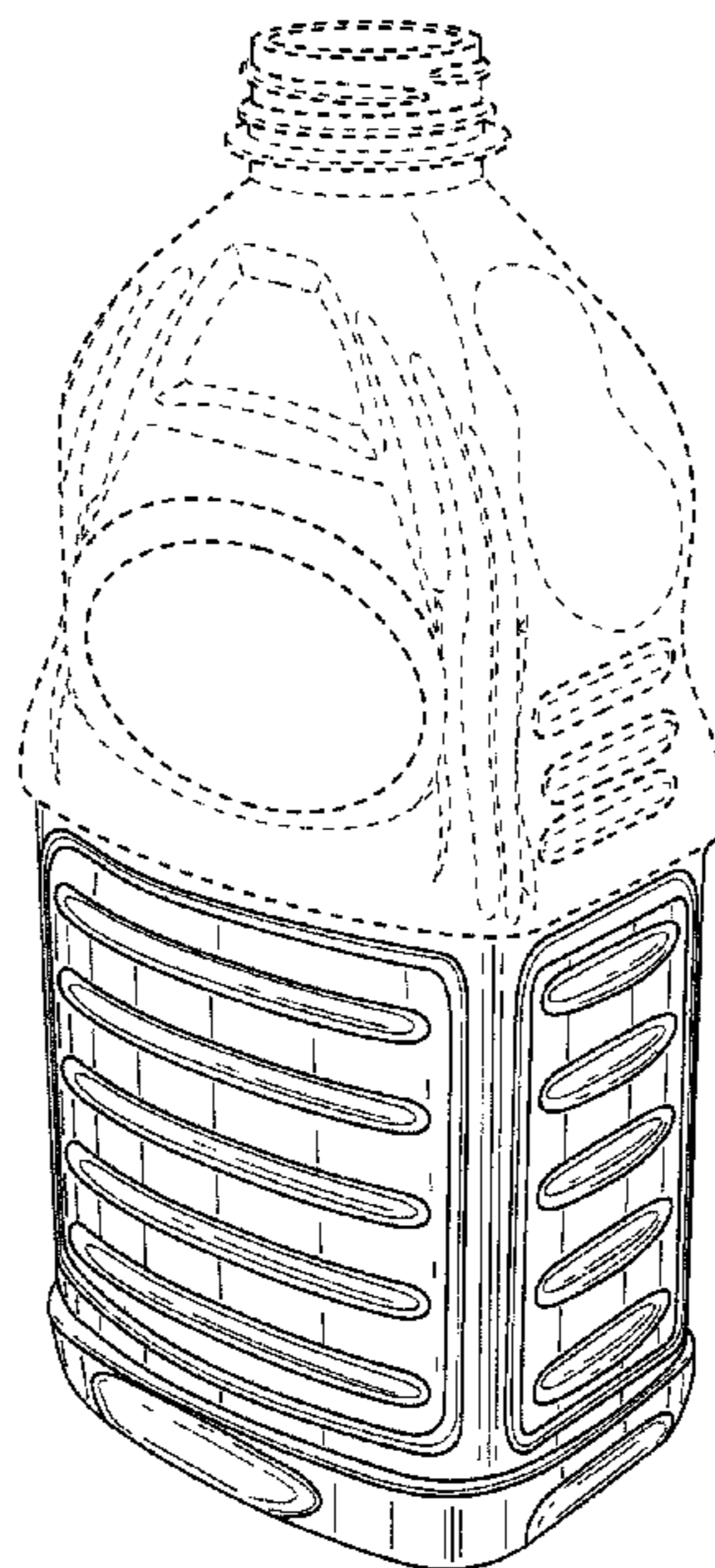
FIG. 3 is a right side elevational view thereof, the left side elevational view being identical except for the unclaimed threads;

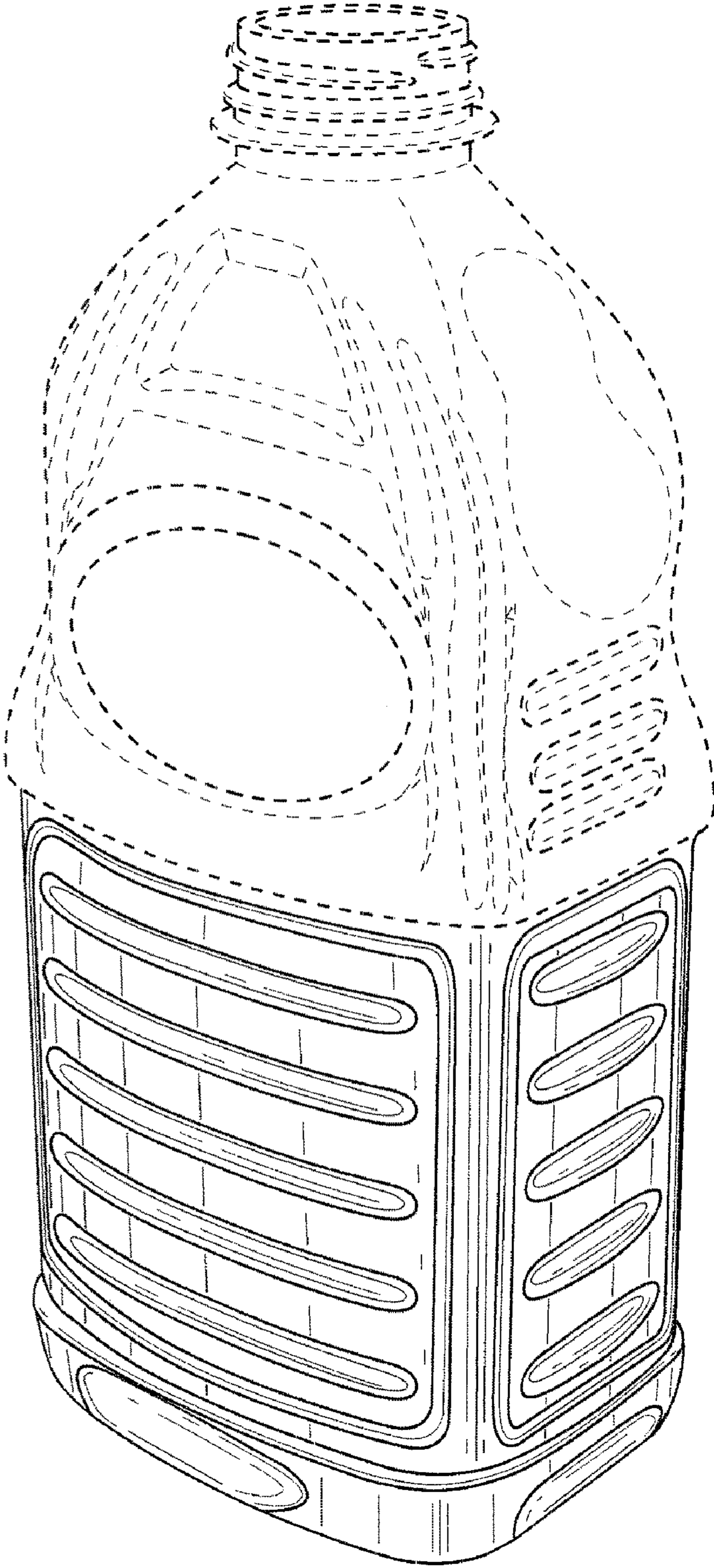
FIG. 4 is a top plan view thereof; and,

FIG. 5 is a bottom plan view thereof.

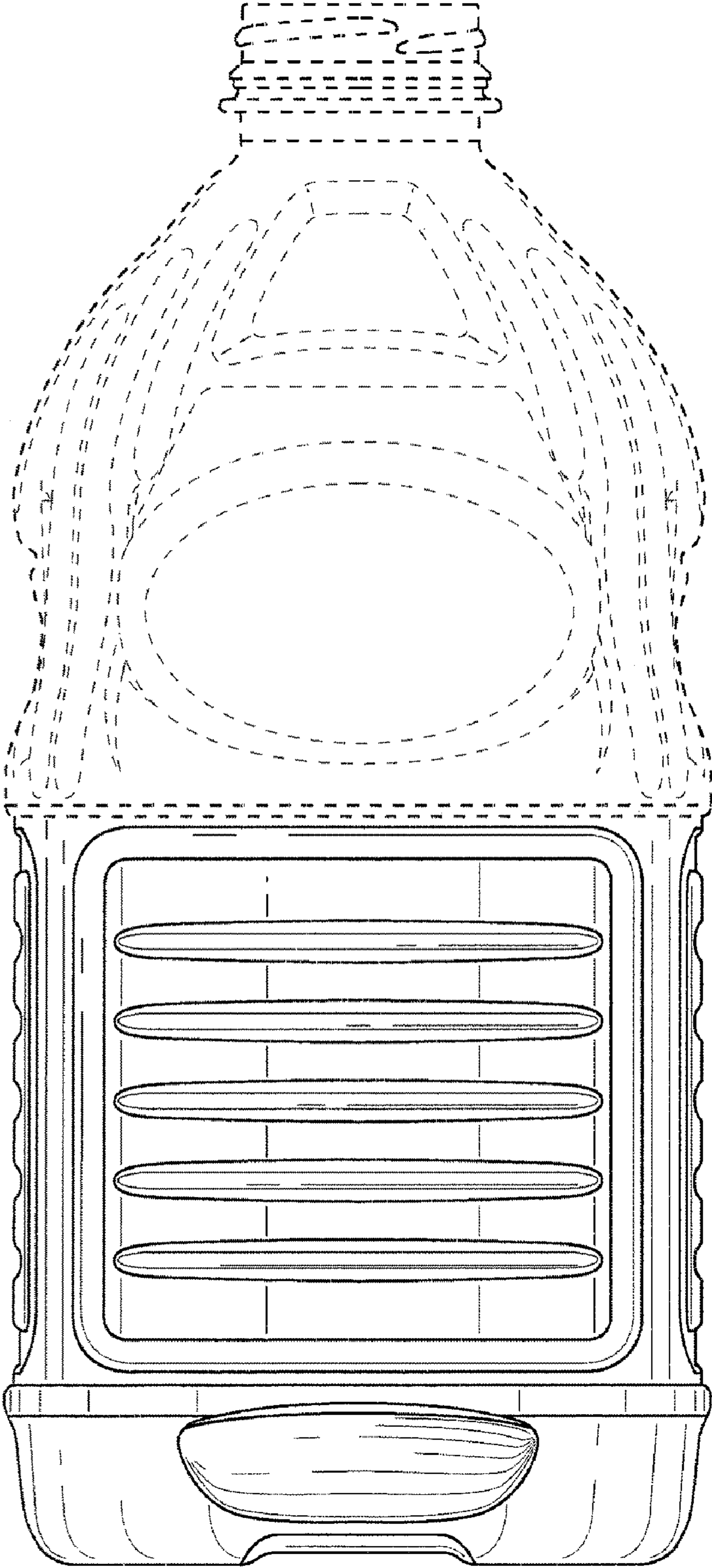
The broken lines shown in the drawing views are included for the purpose of showing environmental structure that forms no part of the claimed design.

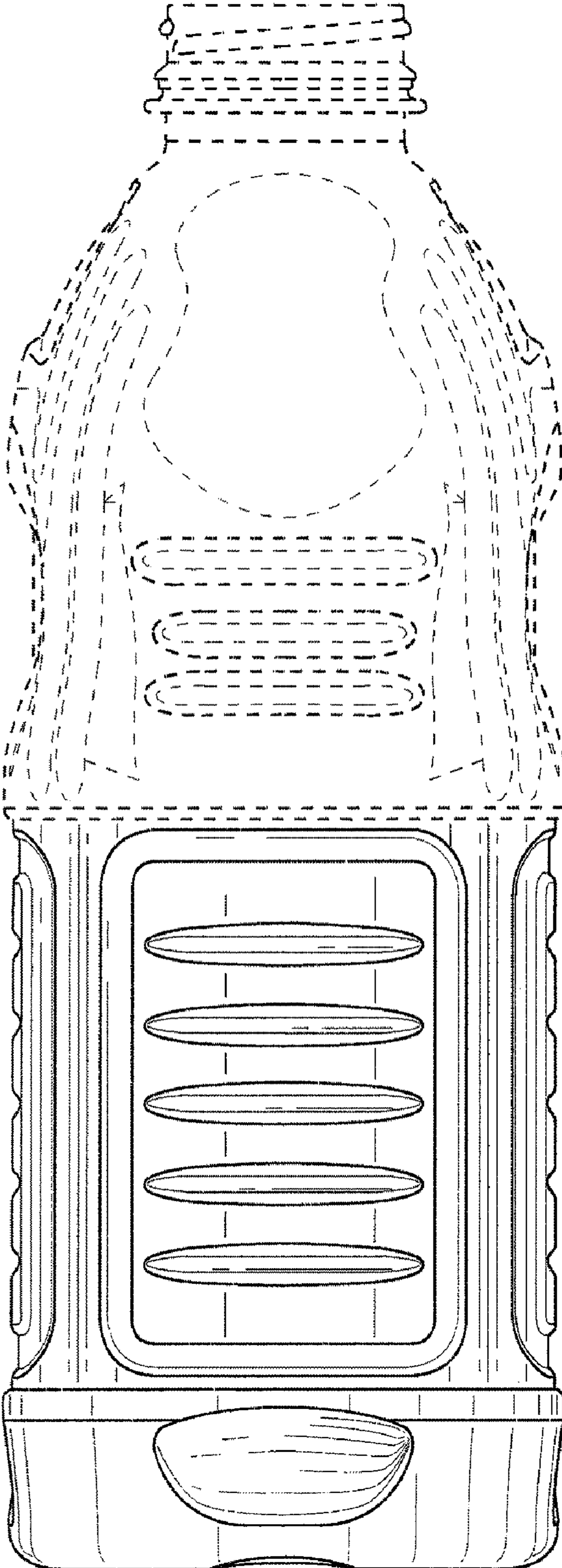




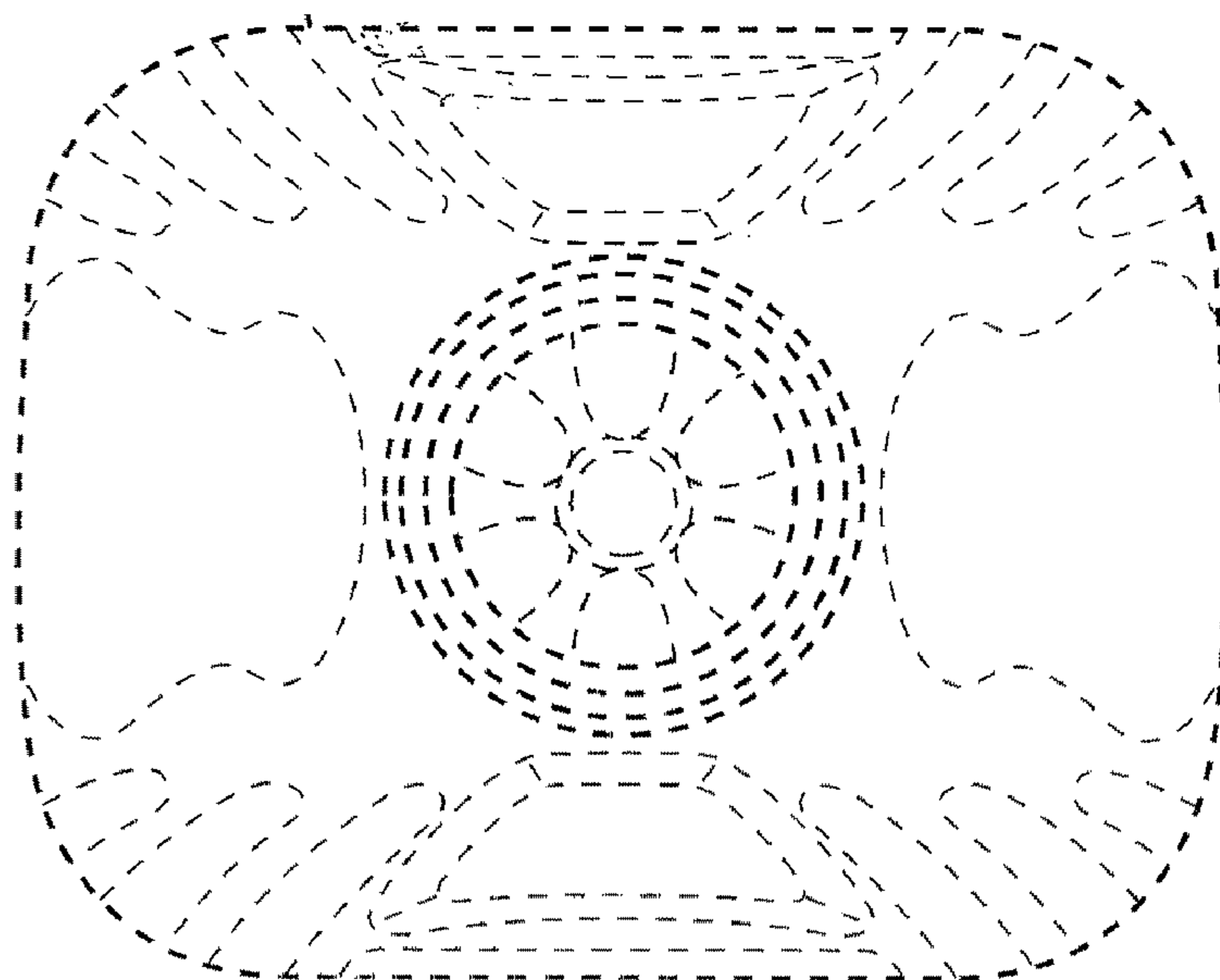

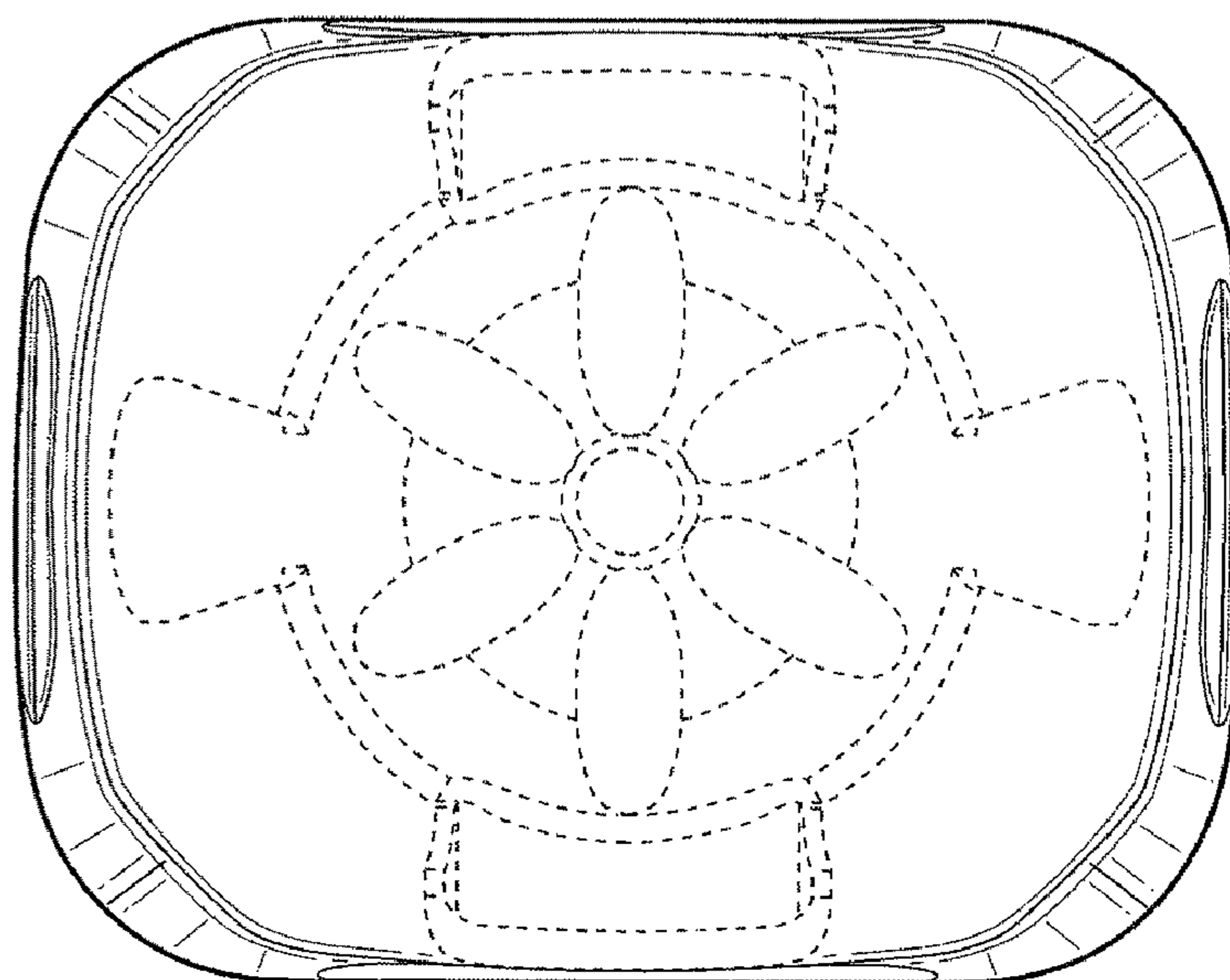
