FIG. 3 is a side view of the invention;

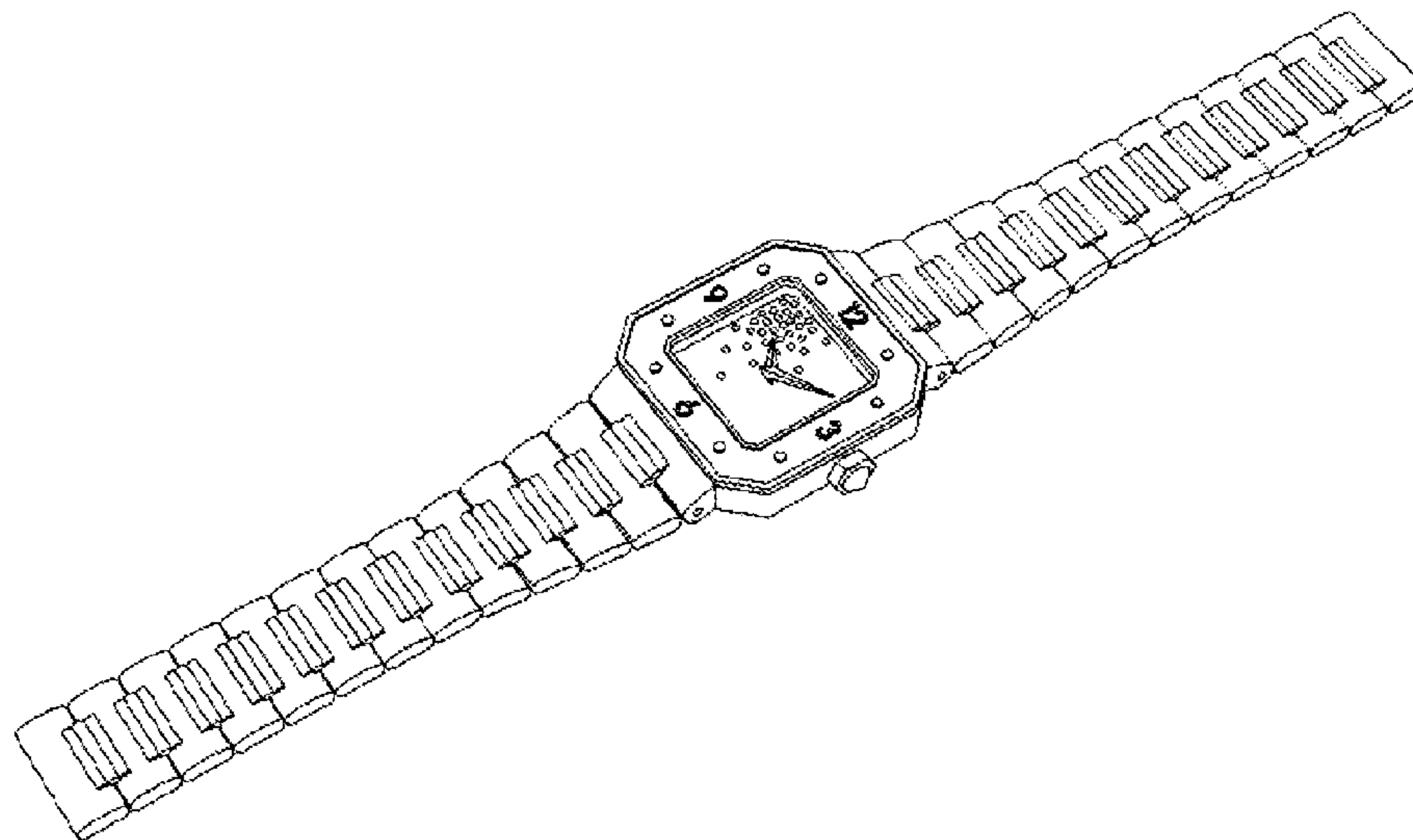
FIG. 4 is another side view of the invention, showing the side opposite that shown in FIG. 3;

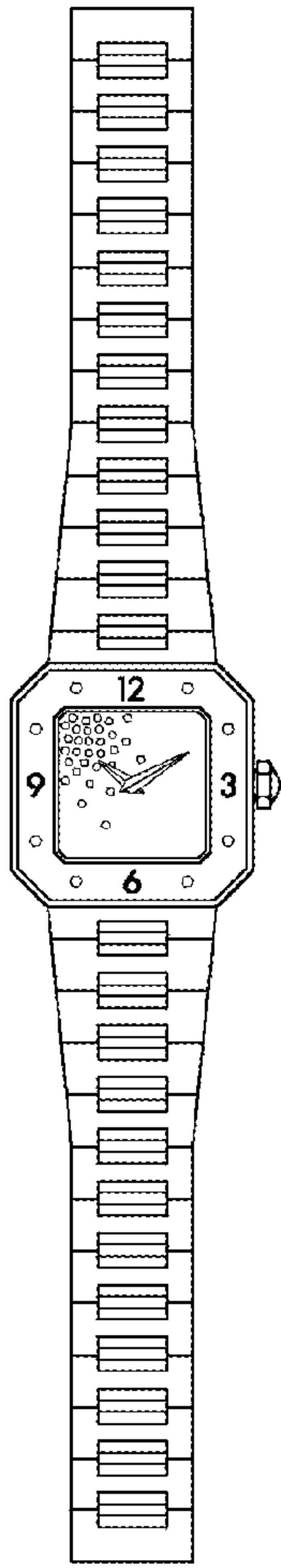

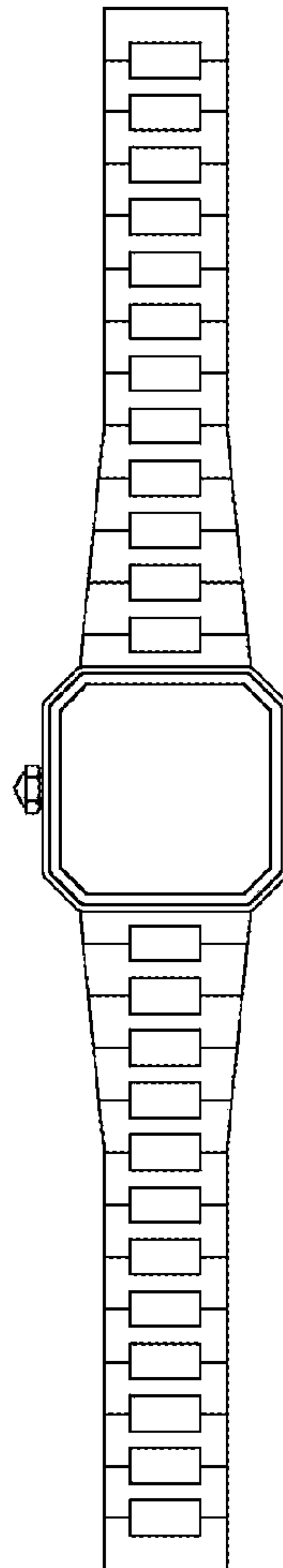

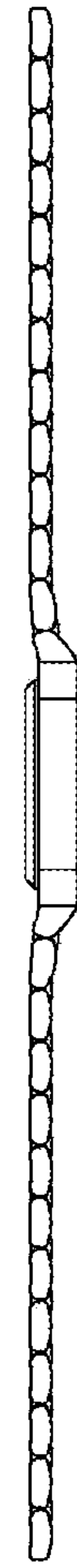

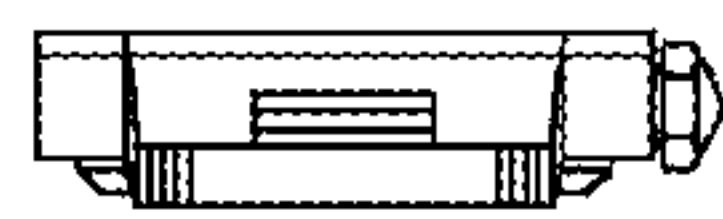

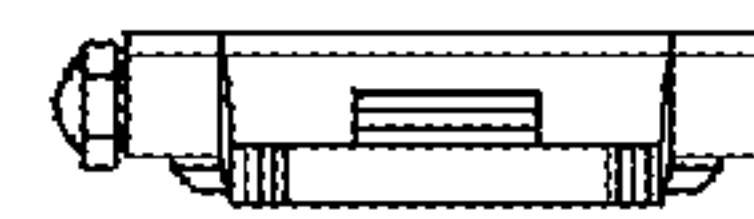

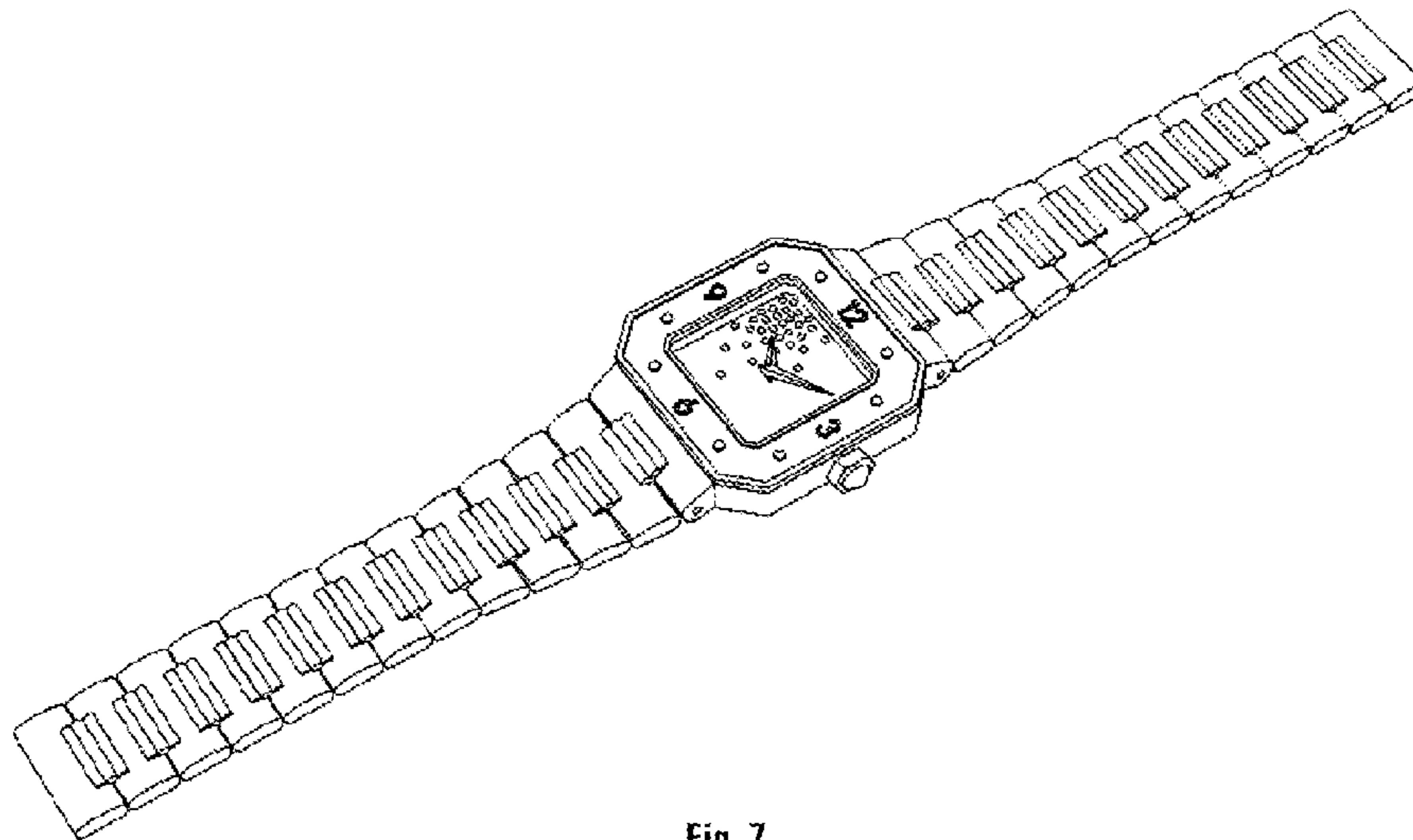
