The ornamental design for a windshield for motorcycle fairing, as shown and described.

**DESCRIPTION**

FIG. 5 is a bottom elevation view thereof.

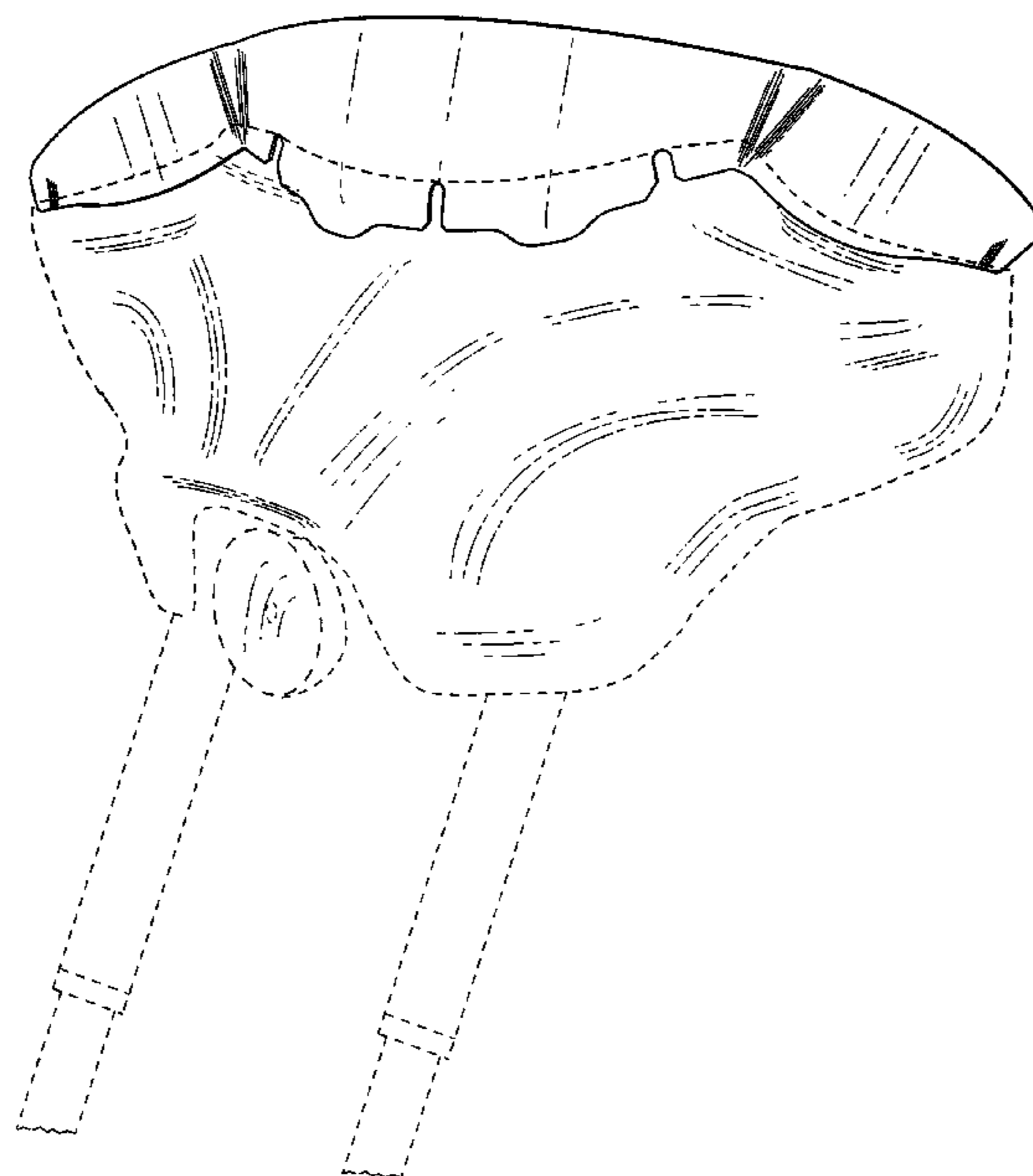
FIG. 6 is a top elevation view thereof.

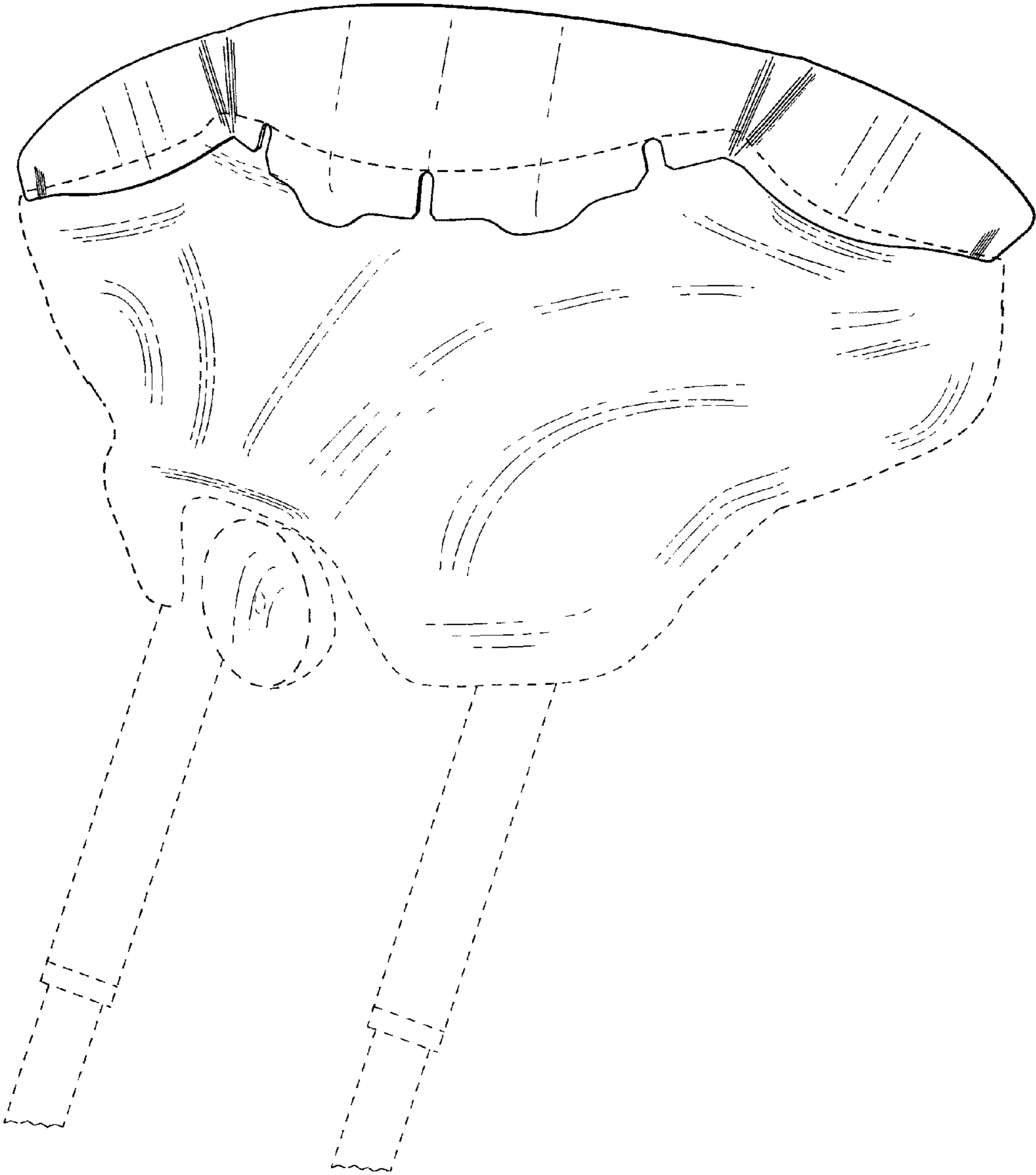

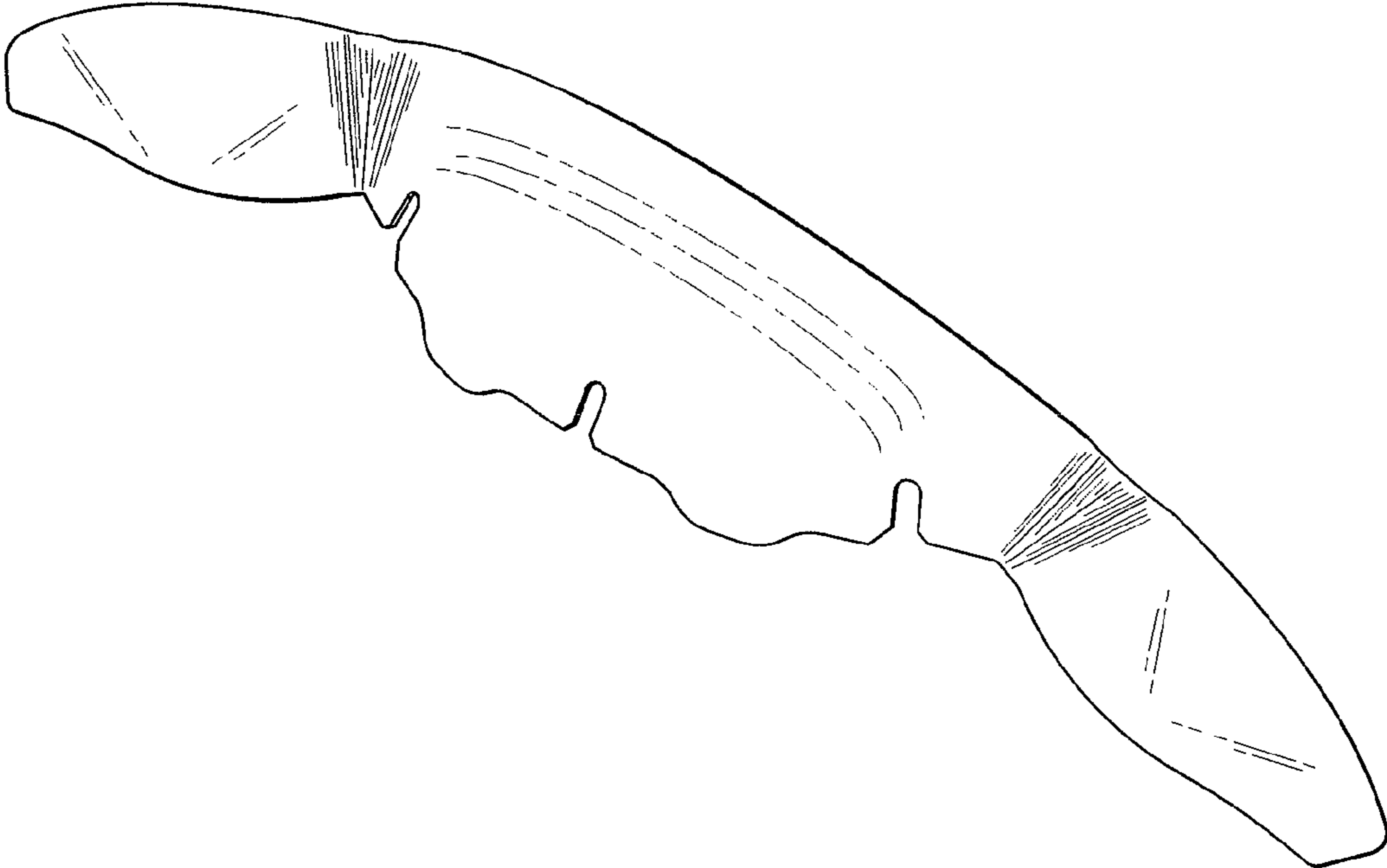

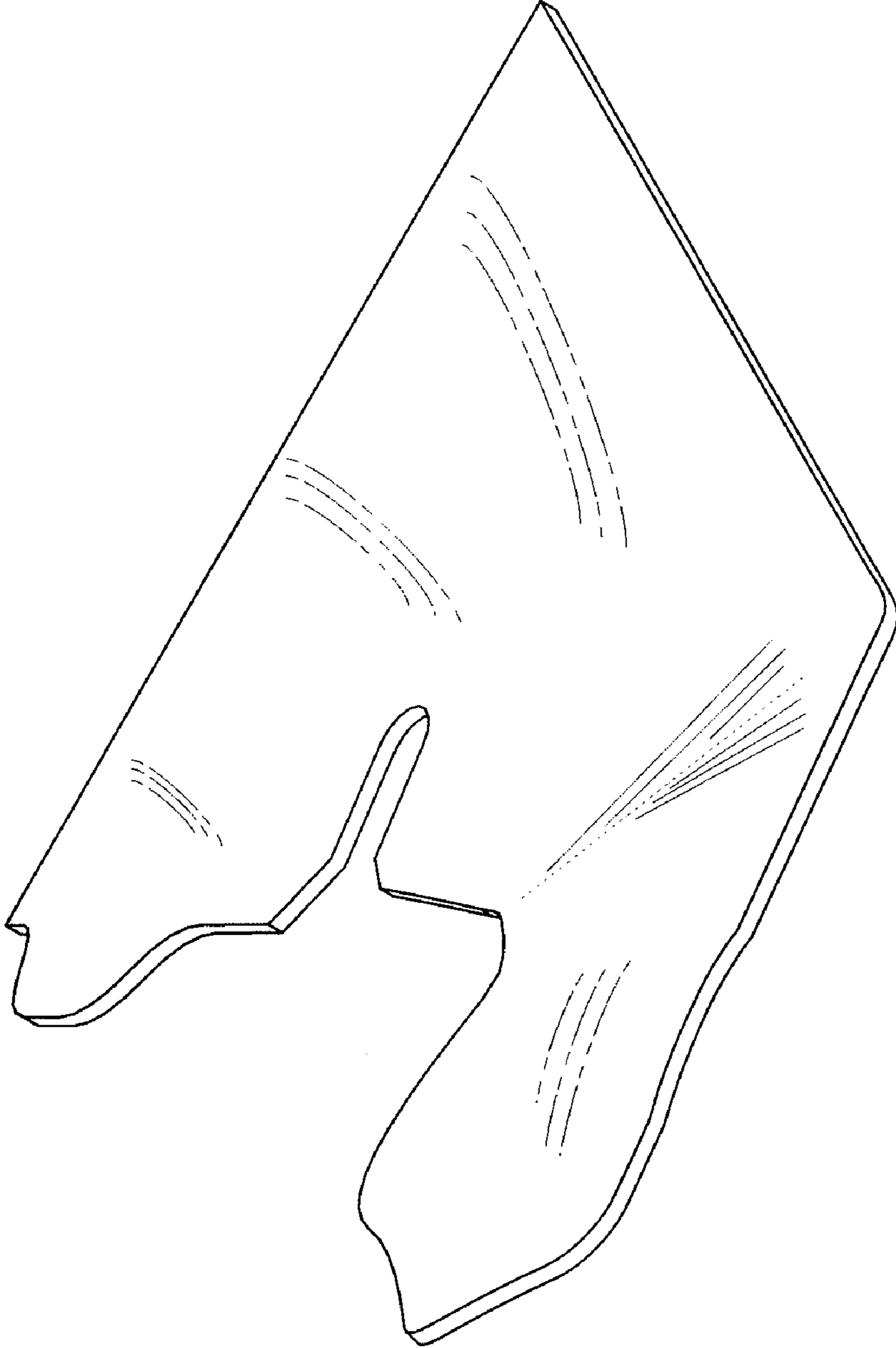

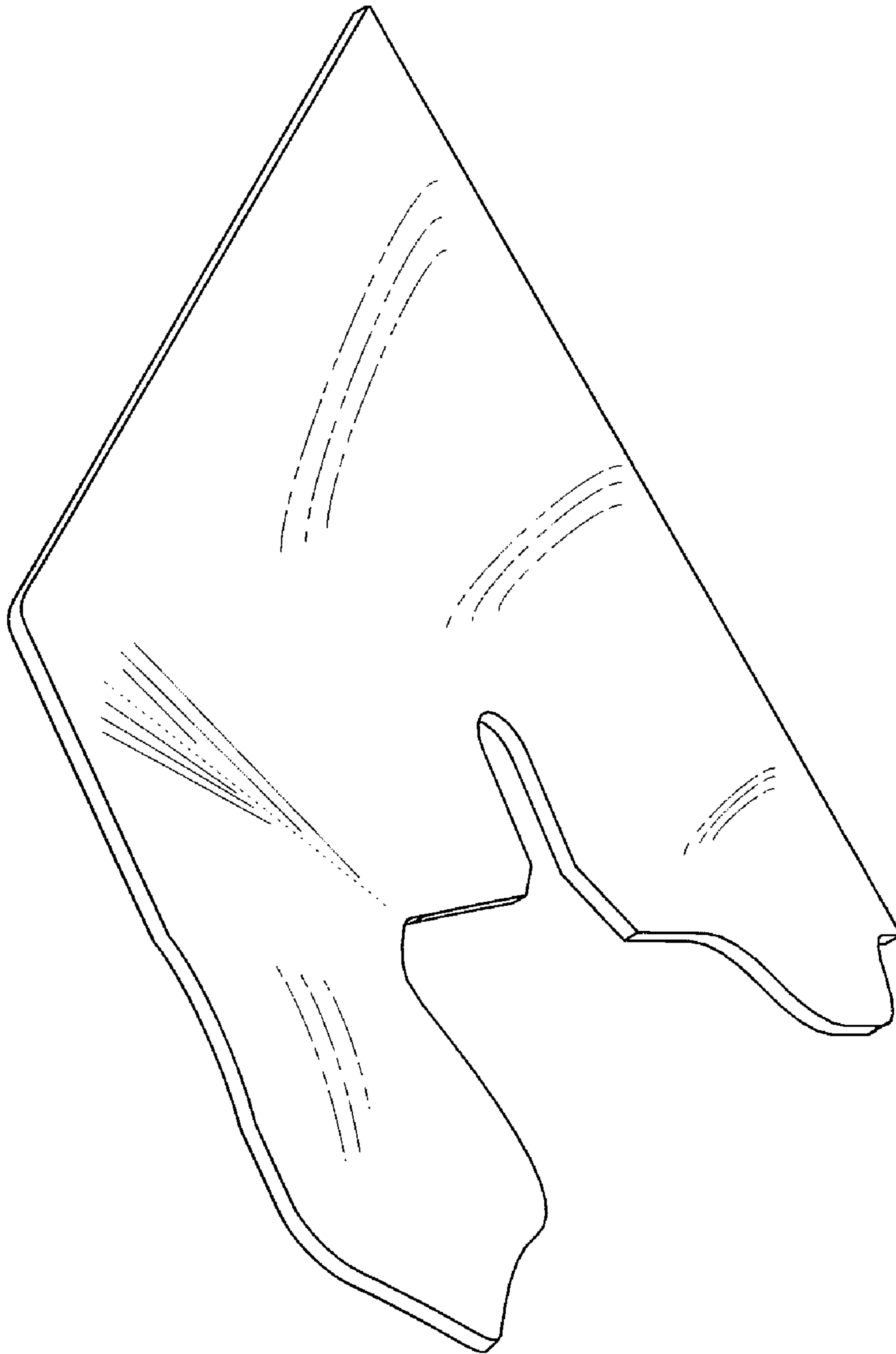

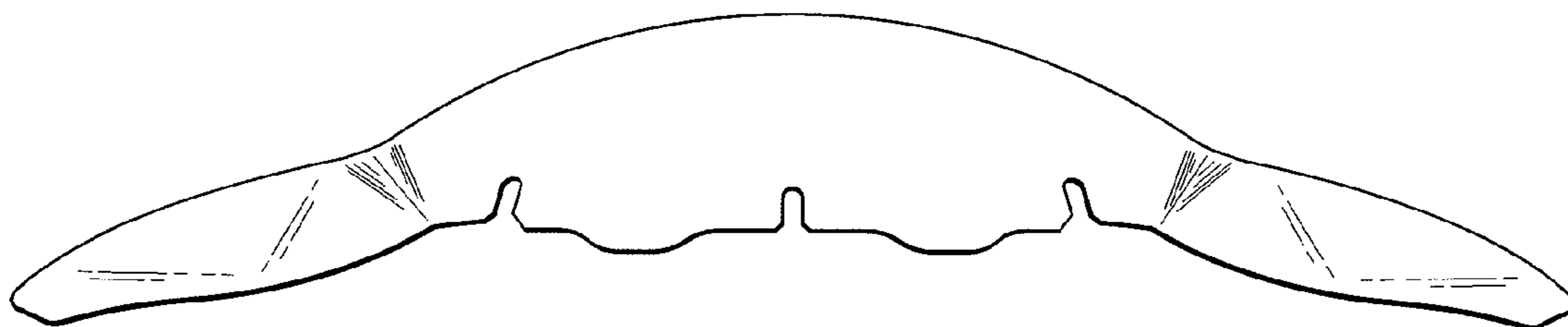

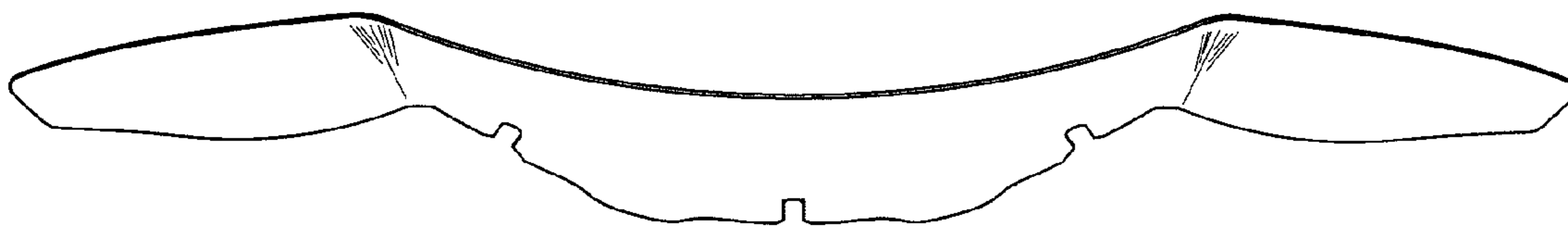

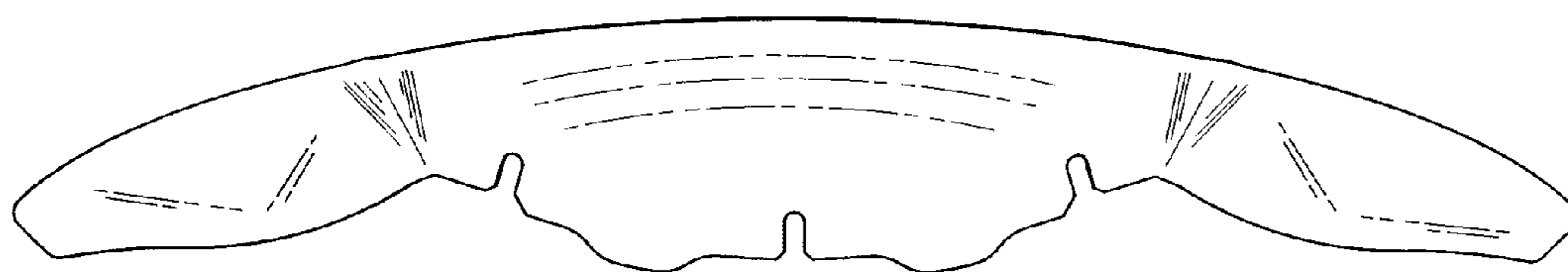

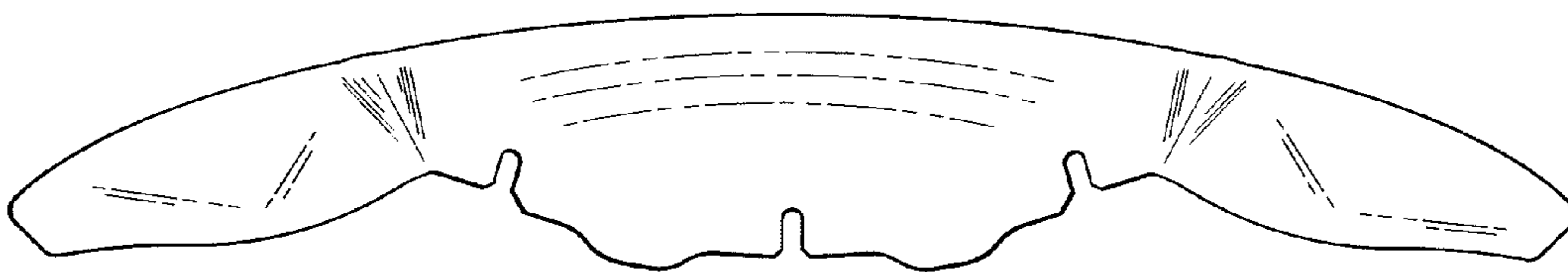
