DESCRIPTION

FIG. 1 is a top, left perspective view of a first embodiment of a decorative element for a vehicle according to my design;

FIG. 2 is a left perspective view thereof;

FIG. 3 is a right perspective view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is a left side view thereof; and

FIG. 6 is a right side view thereof.

FIG. 7 is a top, right perspective view of a second embodiment of a decorative element for a vehicle according to my design;

FIG. 8 is a right perspective view thereof;

FIG. 9 is a left perspective view thereof;

FIG. 10 is a front view thereof;

FIG. 11 is a right side view thereof; and,

FIG. 12 is a left side view thereof.

The second embodiment is a mirror image of the left decorative element for a vehicle as shown in FIGS. 1-6.

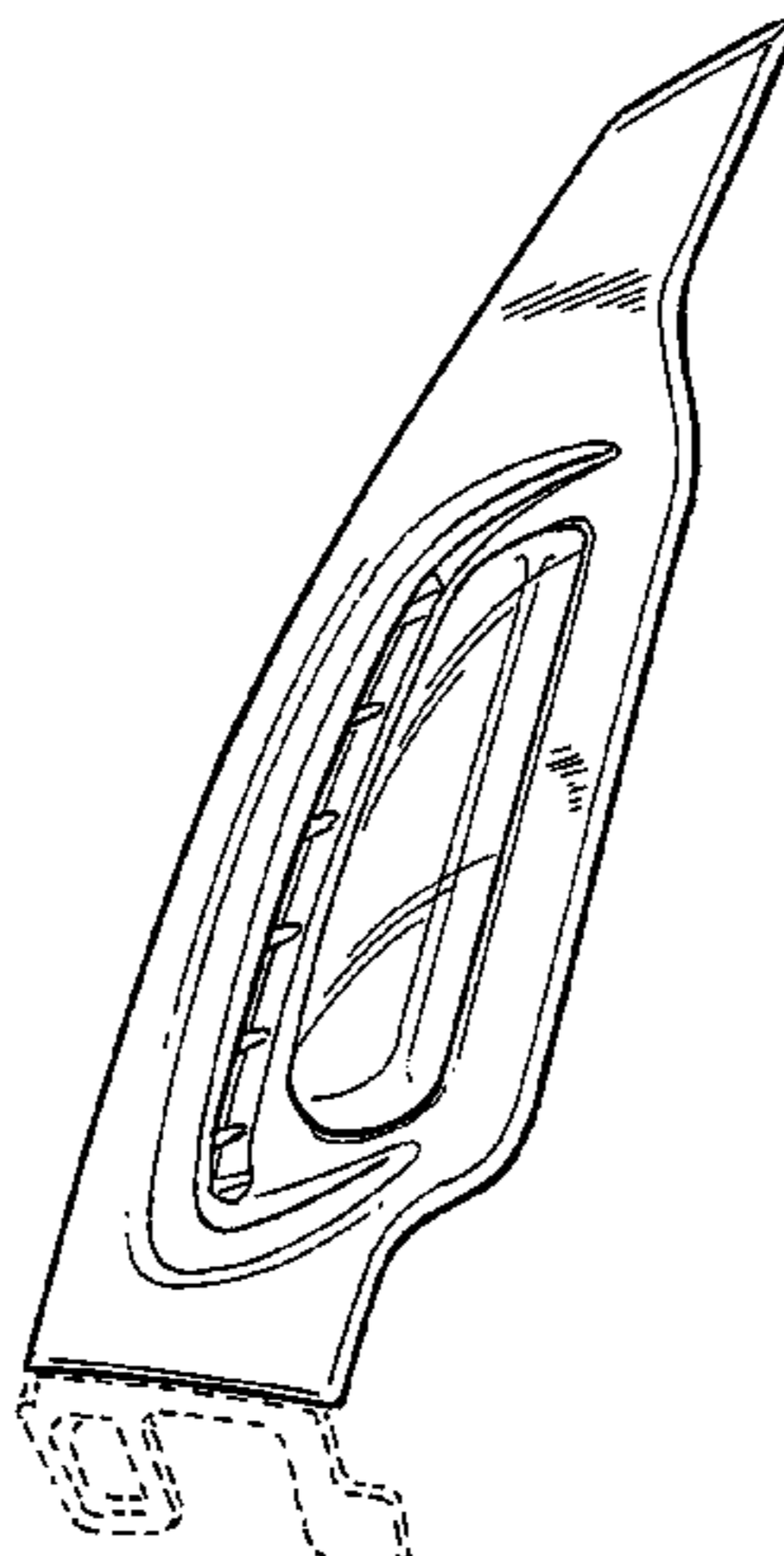

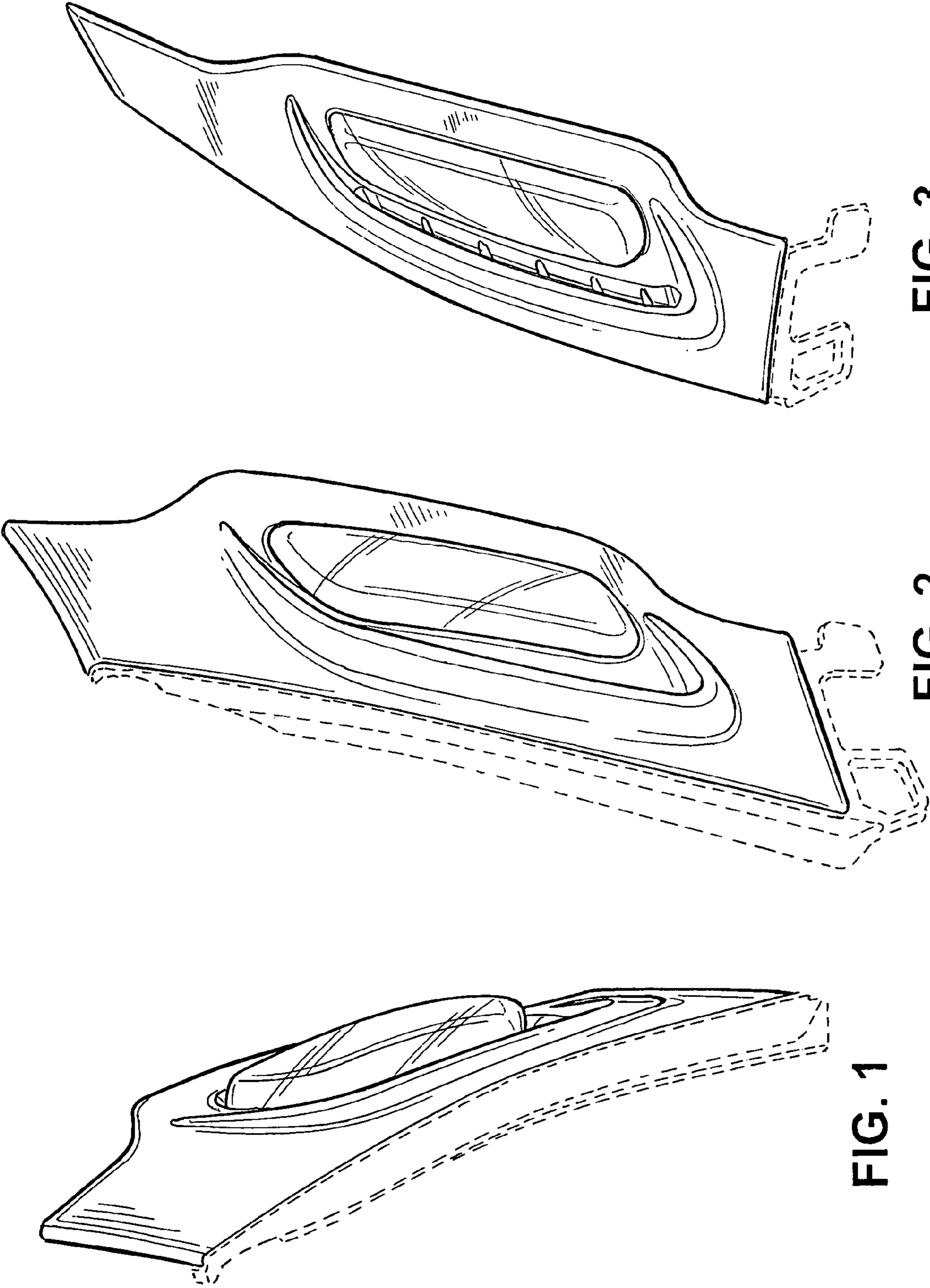

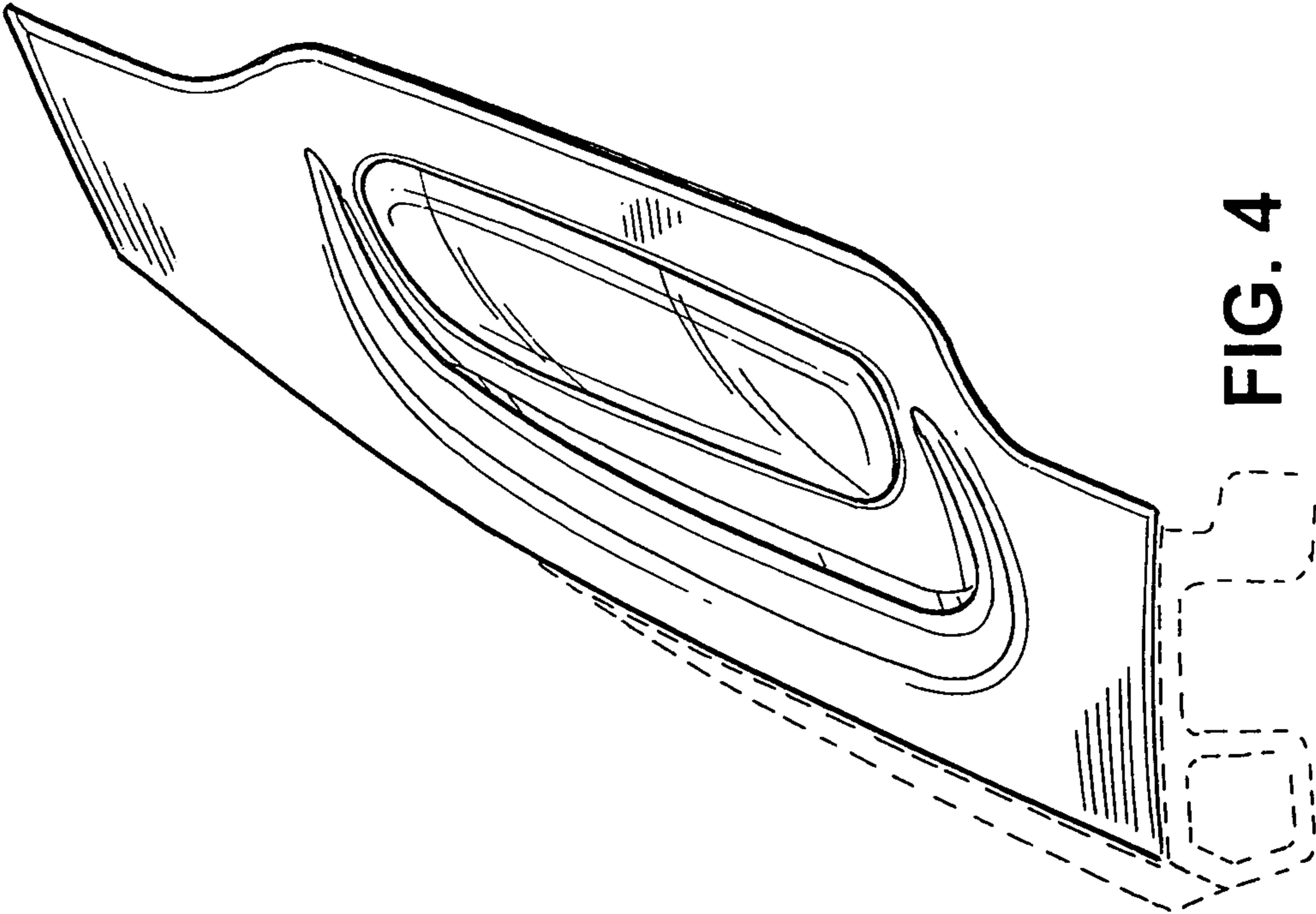

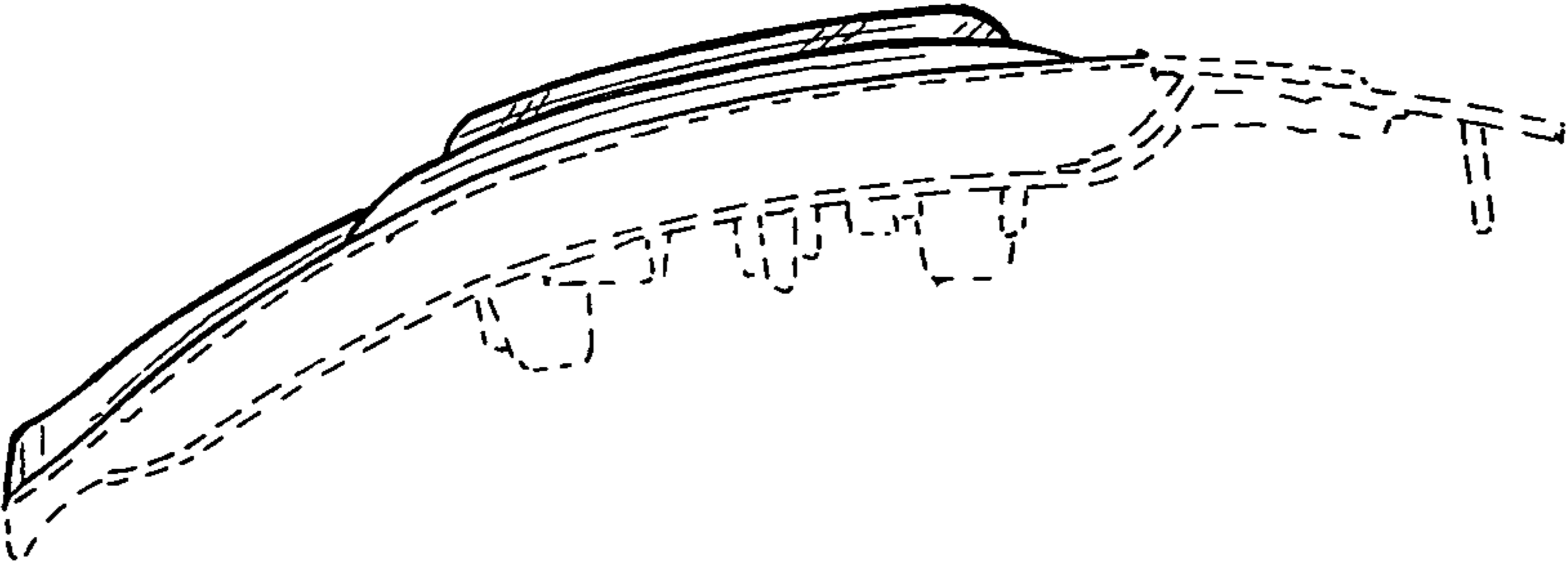

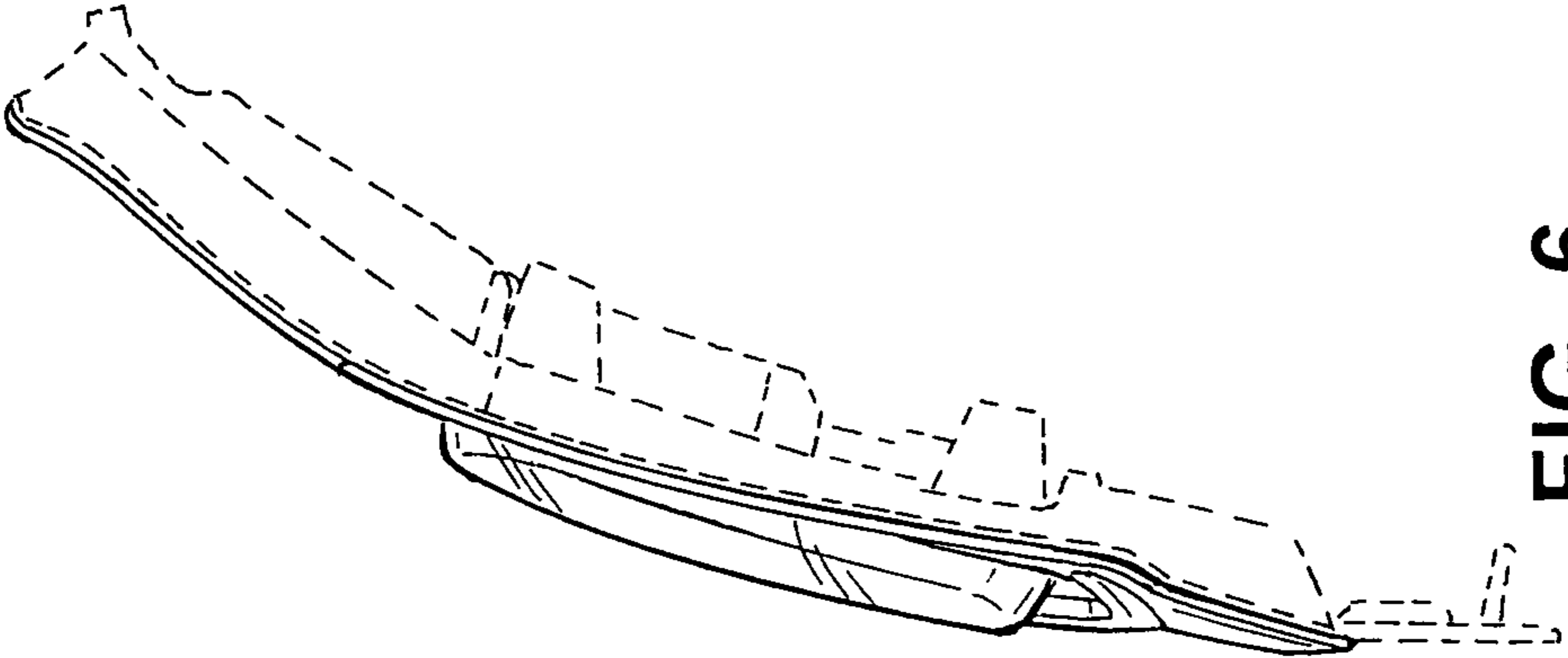

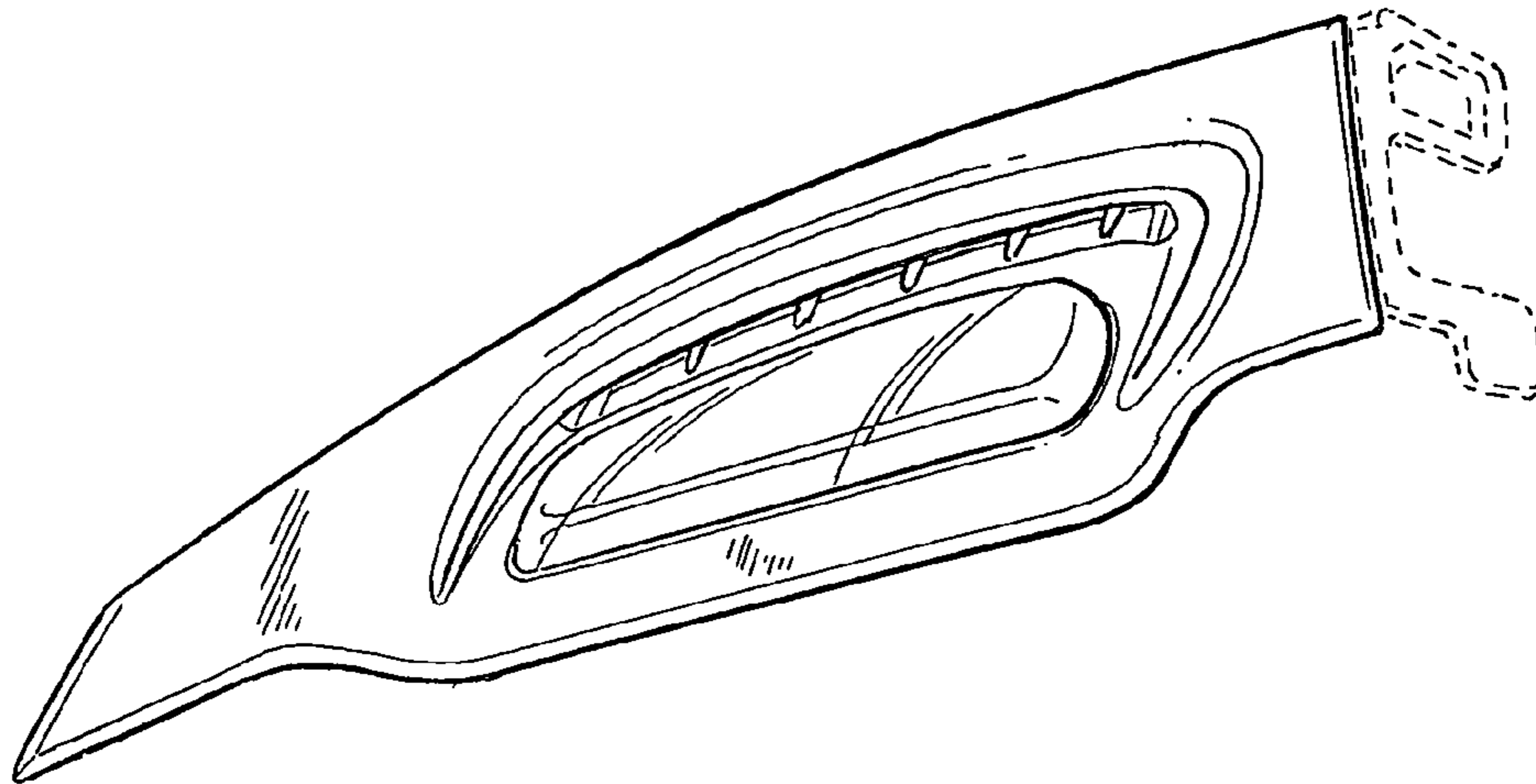

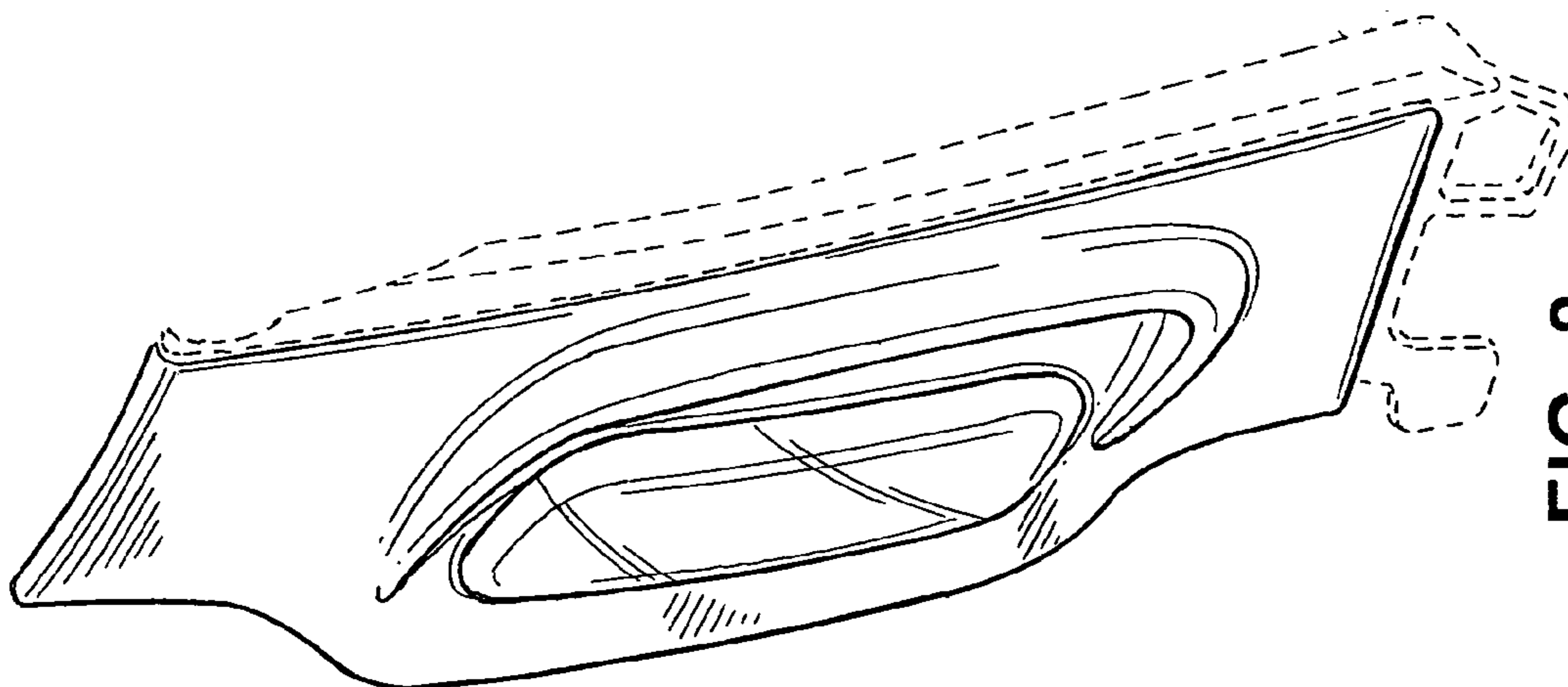

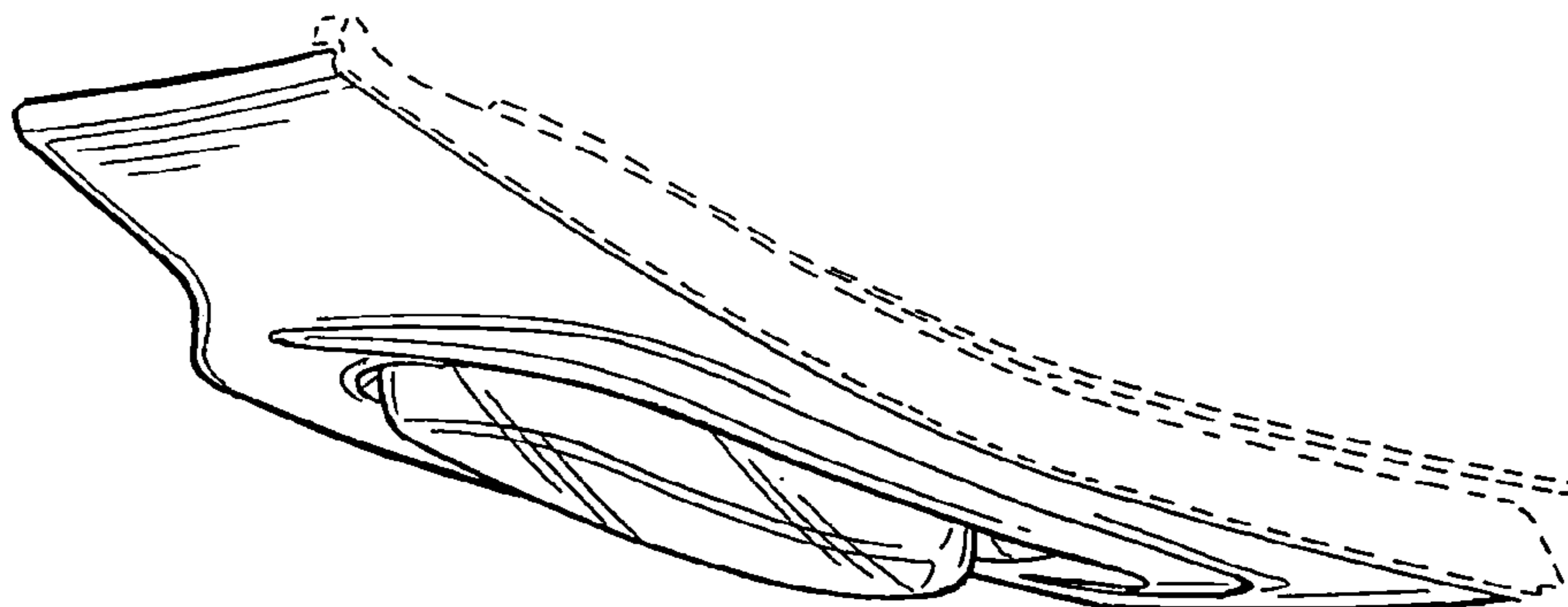

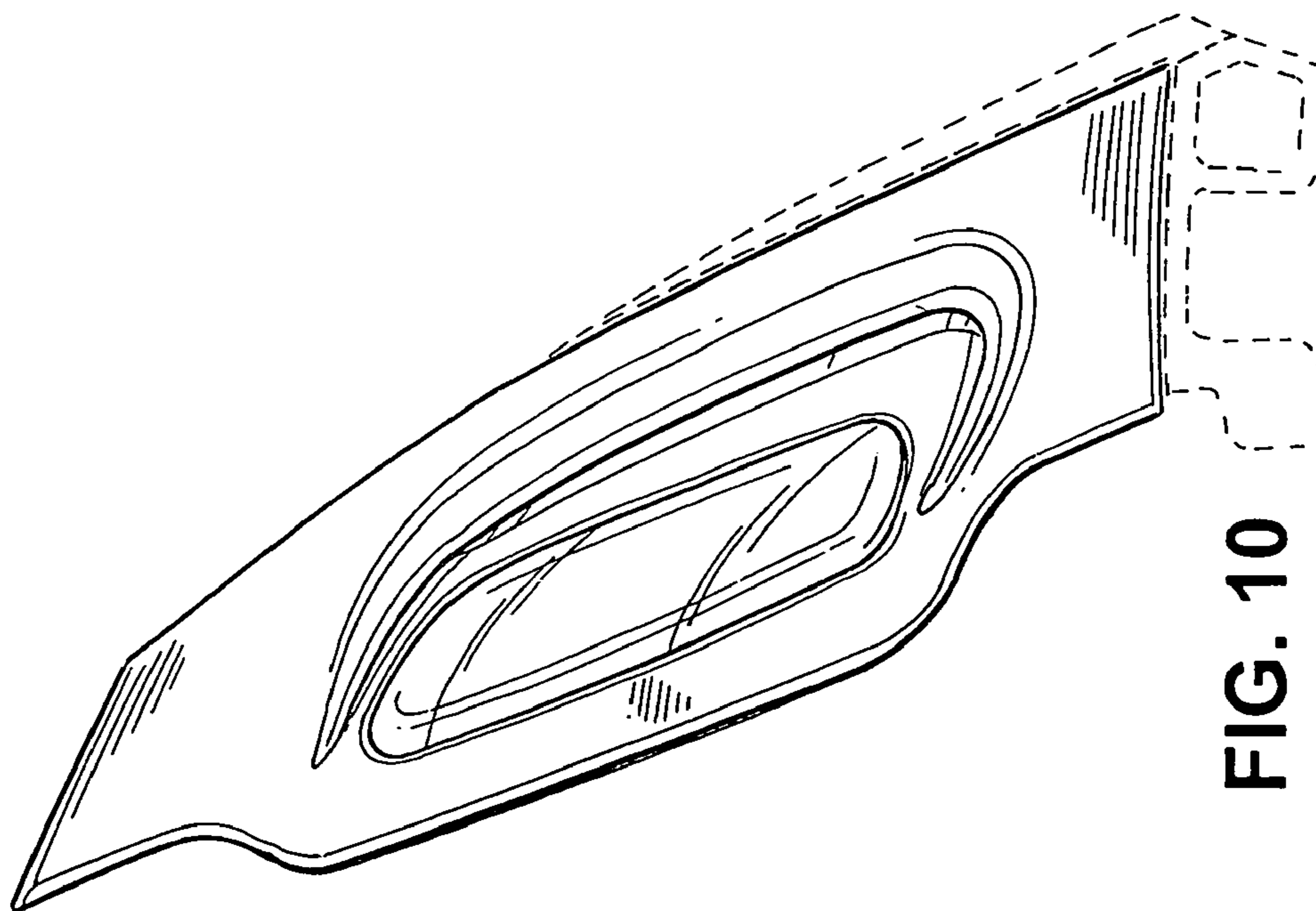

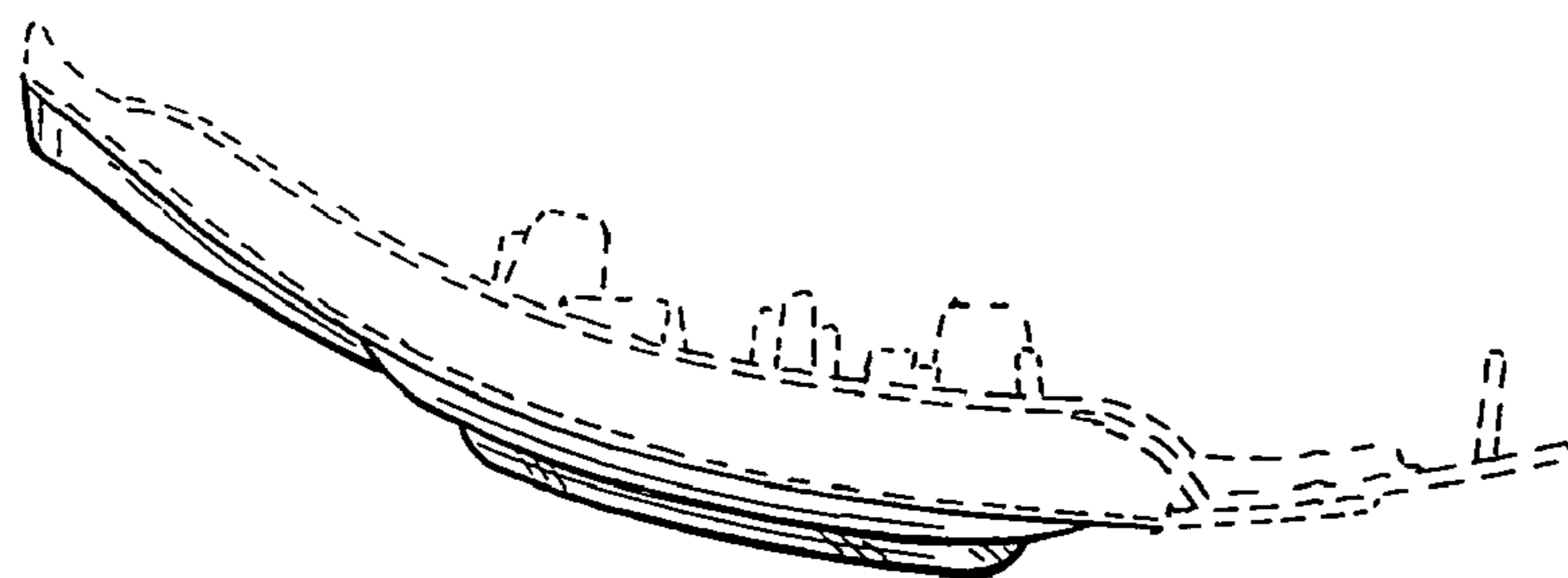

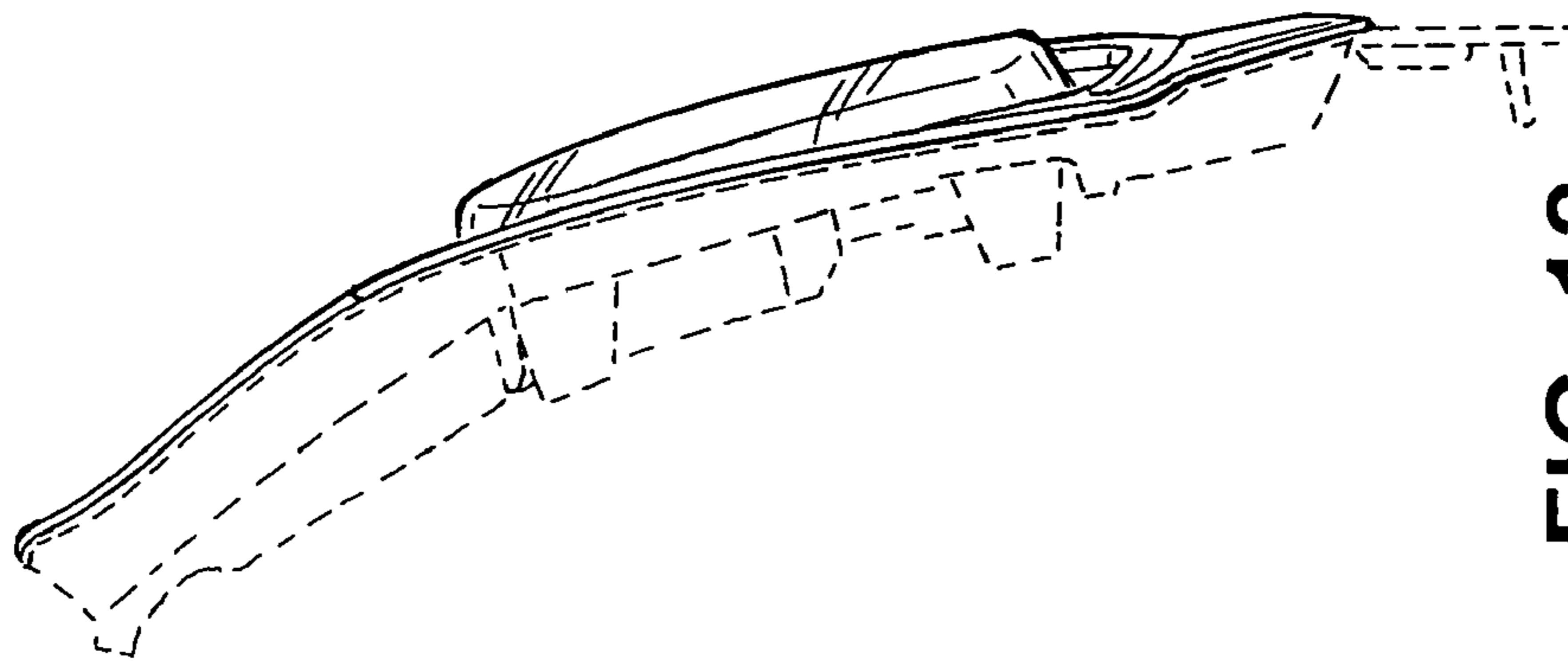
