The ornamental design for a portion of a loudspeaker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portion of a loudspeaker showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is an end elevational view of one side thereof;

FIG. 6 is an end elevational view of the other side thereof;

FIG. 7 is a perspective view of a portion of a loudspeaker showing another embodiment of my new design;

FIG. 8 is a front elevational view thereof;

FIG. 9 is a top plan view thereof;

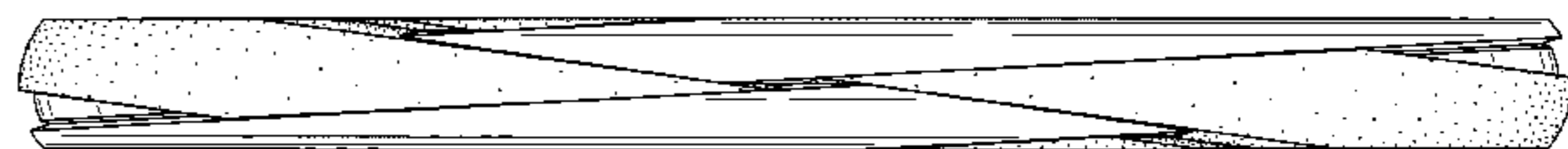
FIG. 10 is a bottom plan view thereof;

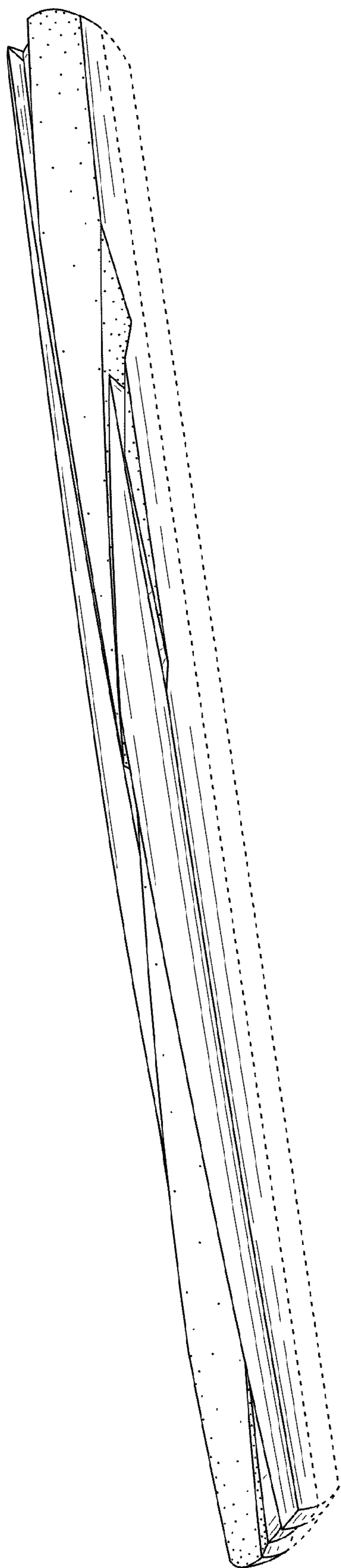

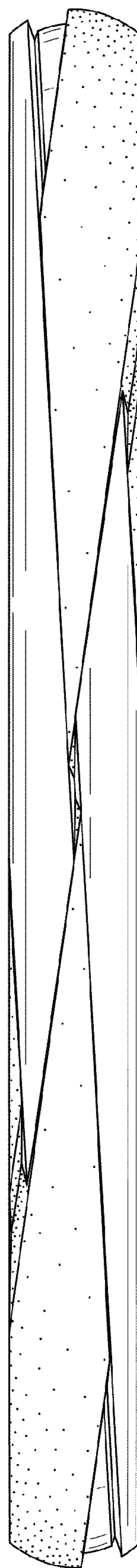

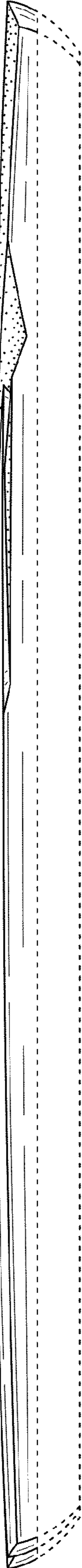

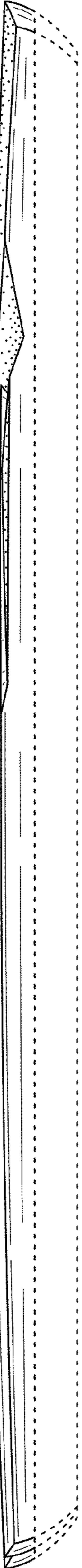

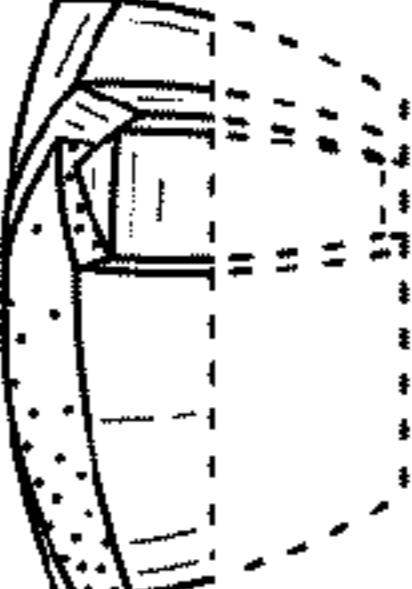

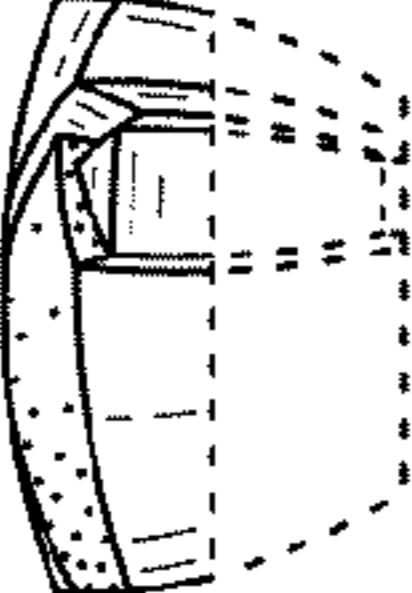

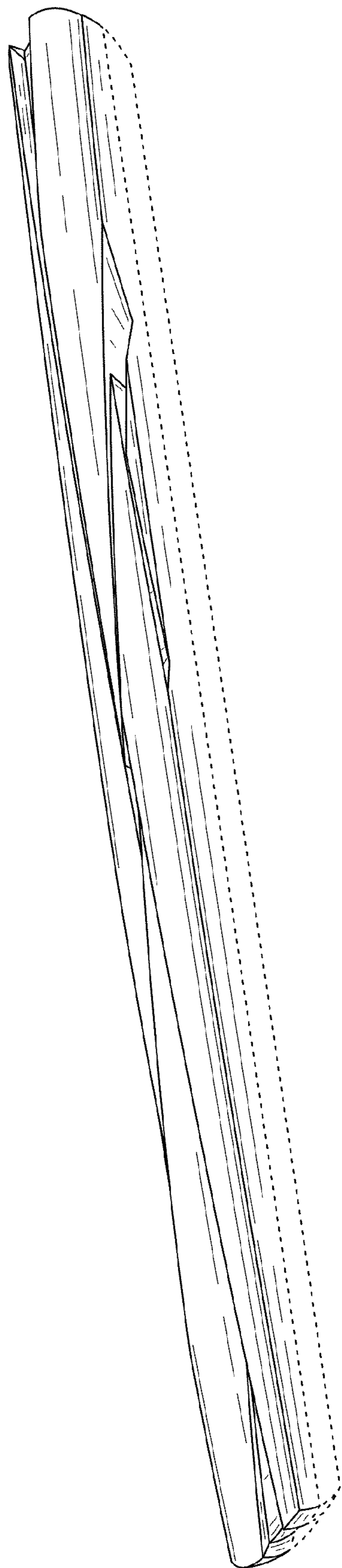

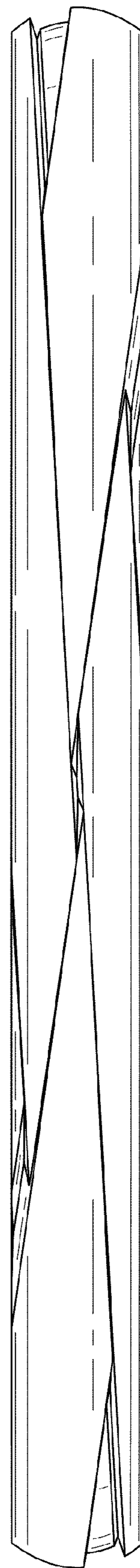

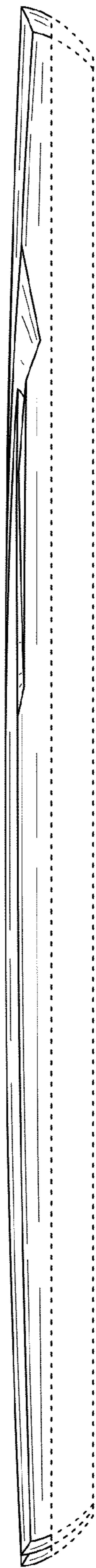

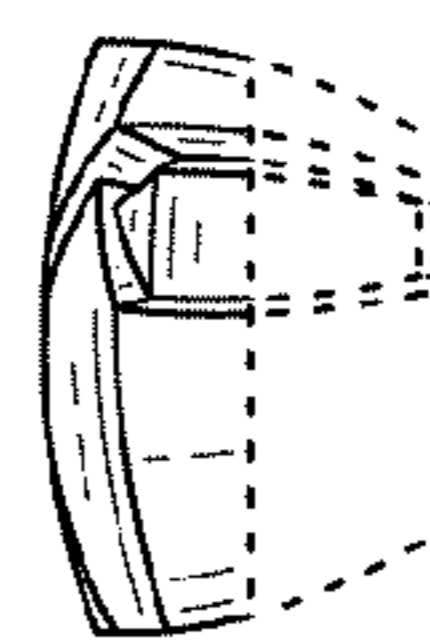

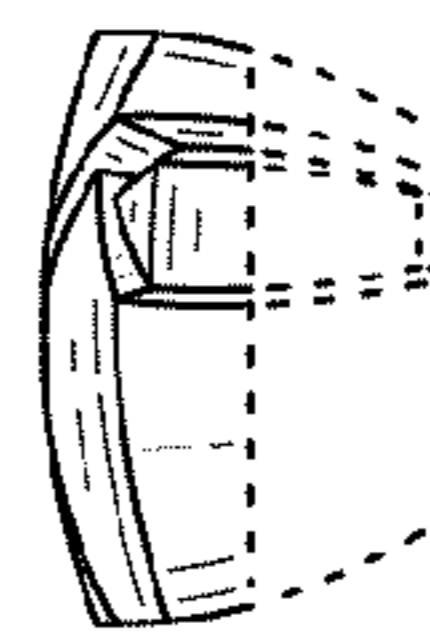
