FIG. 6 is a top view thereof;

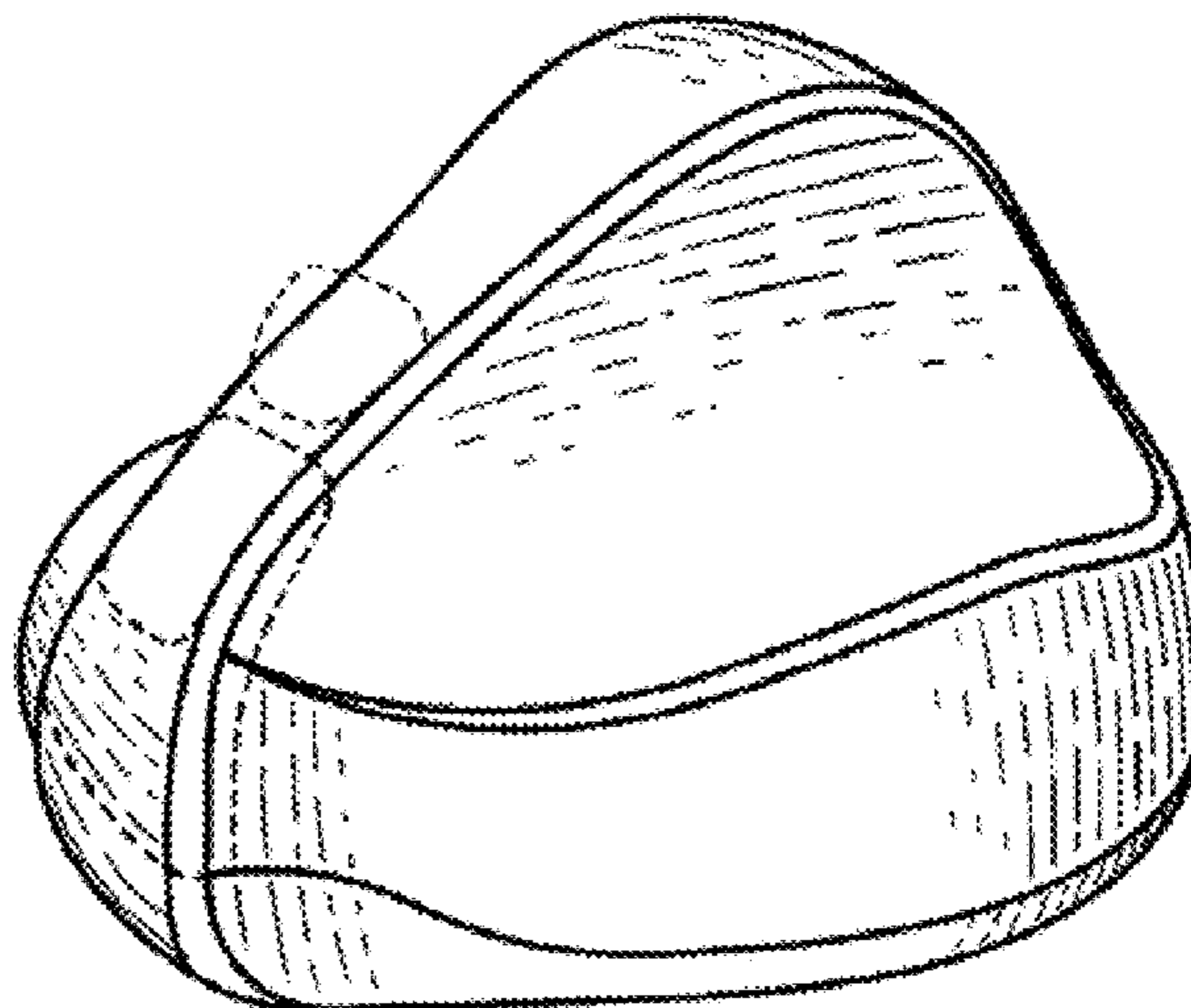
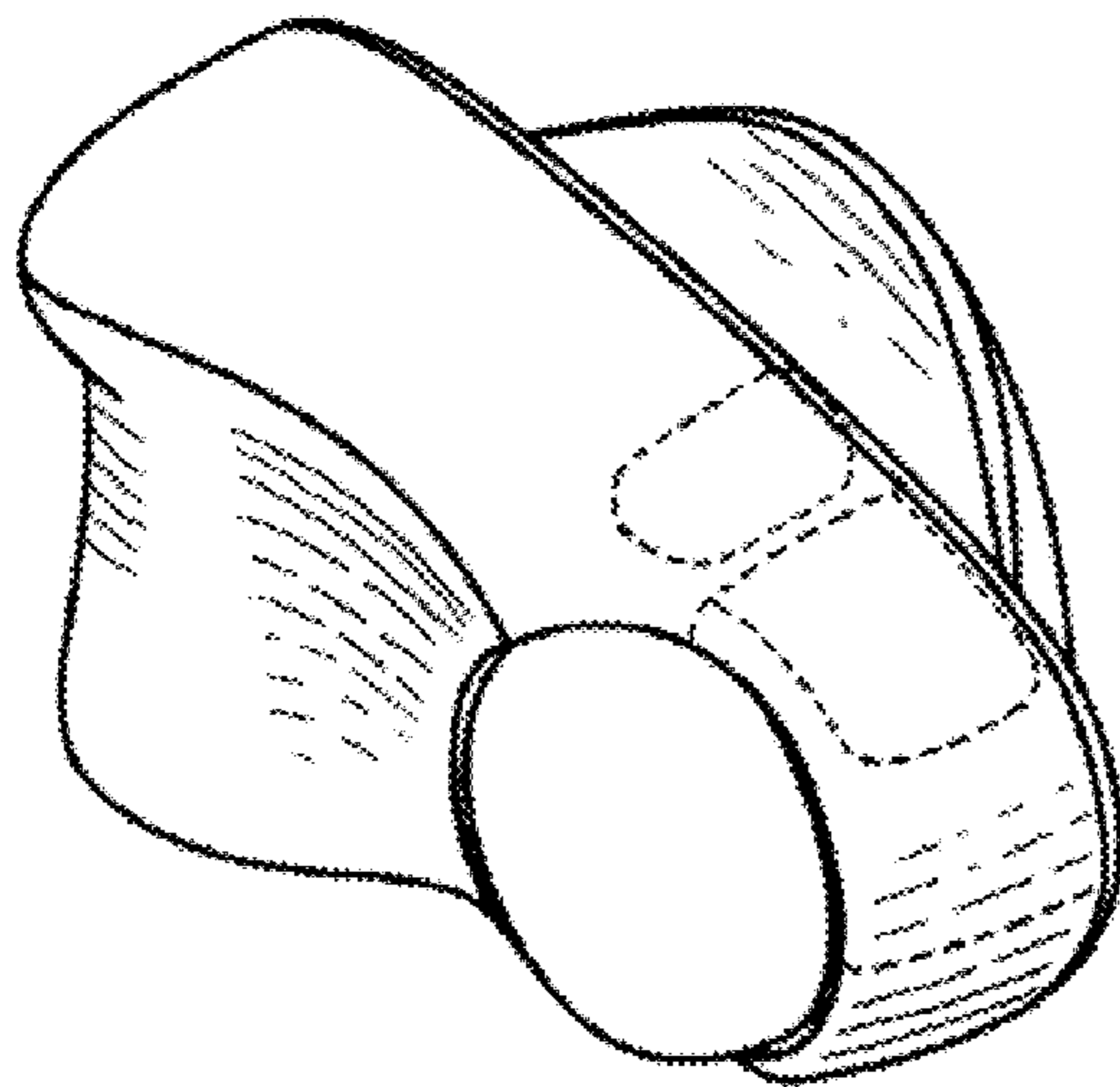
FIG. 7 is a front view thereof;

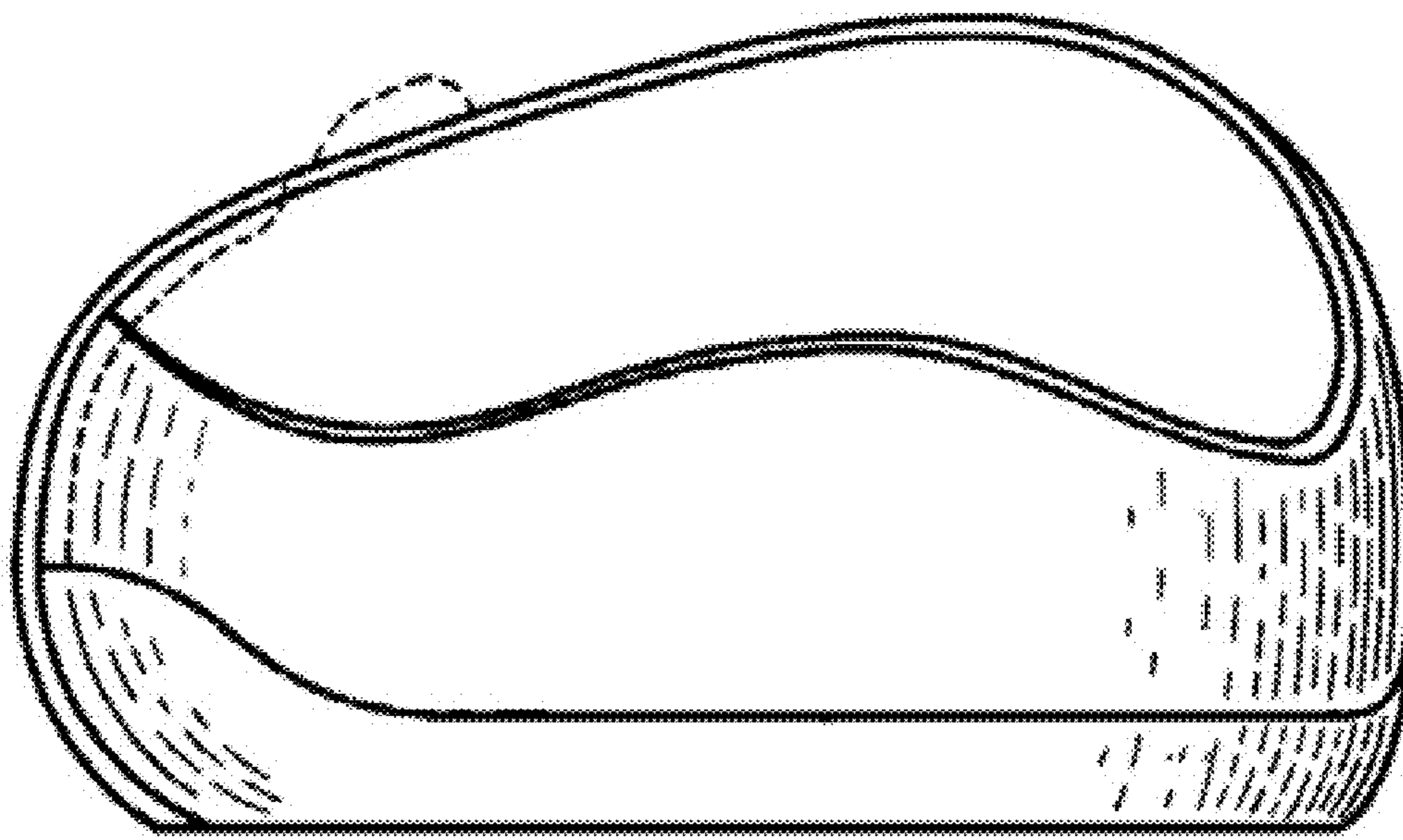

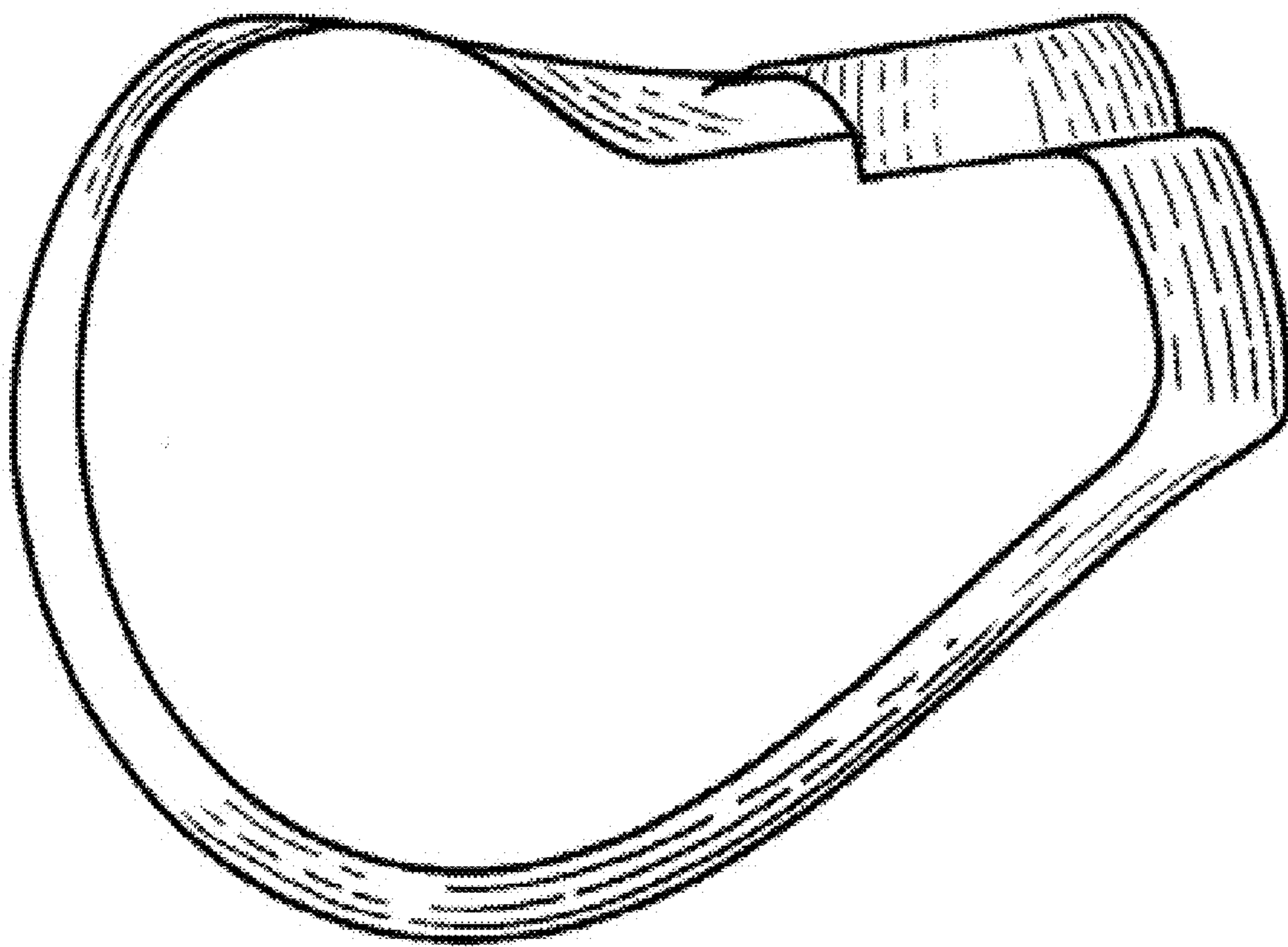

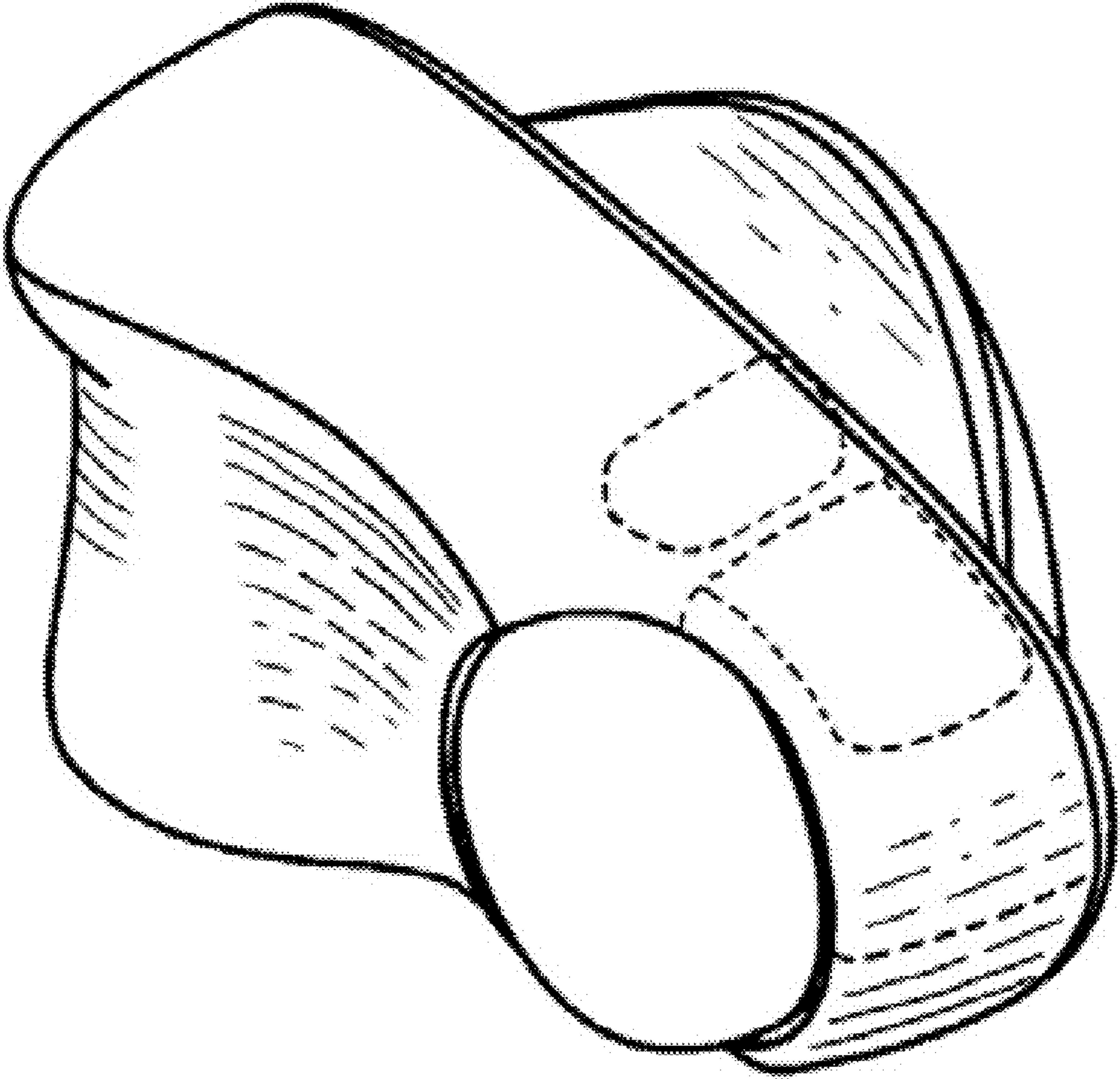

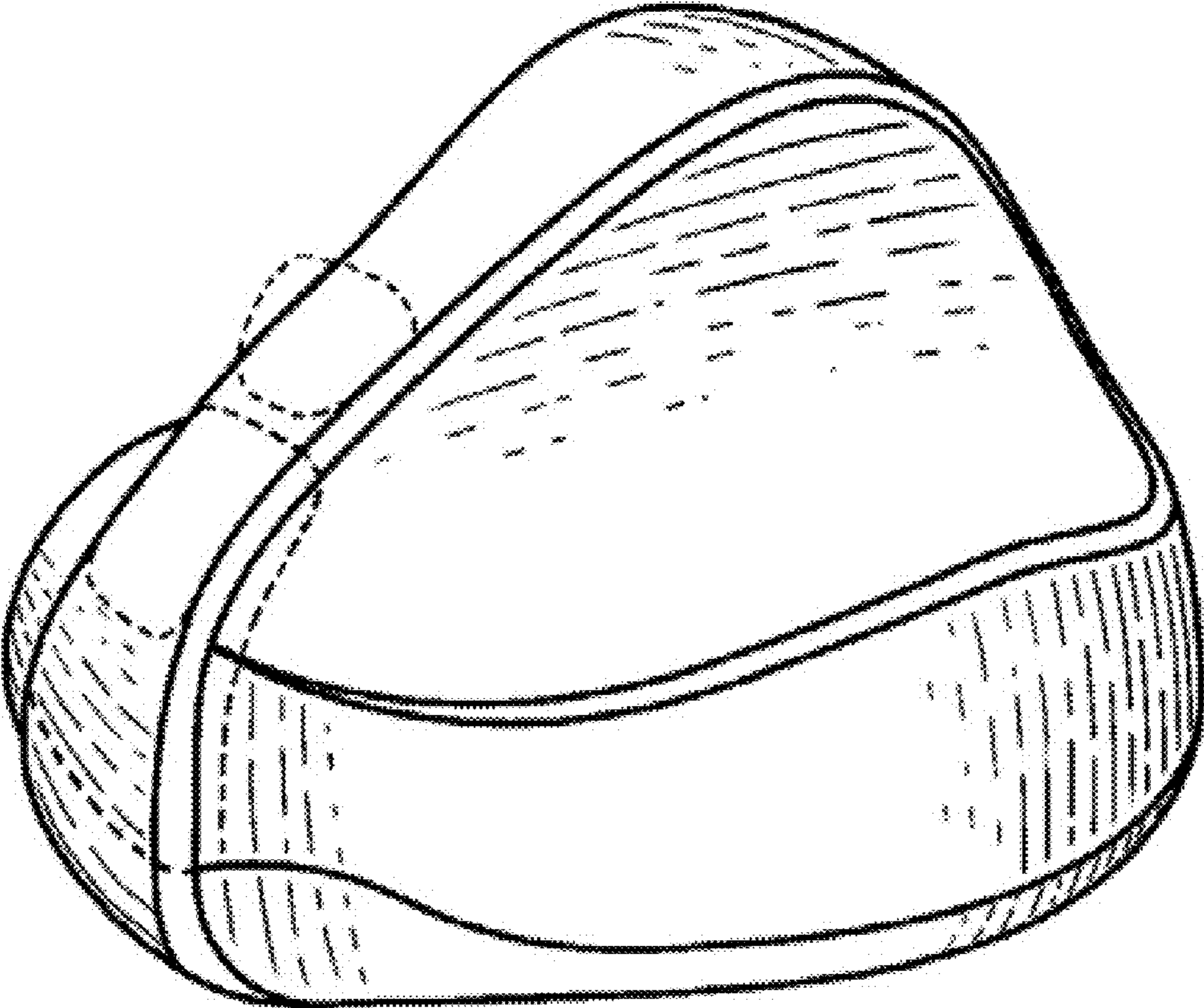

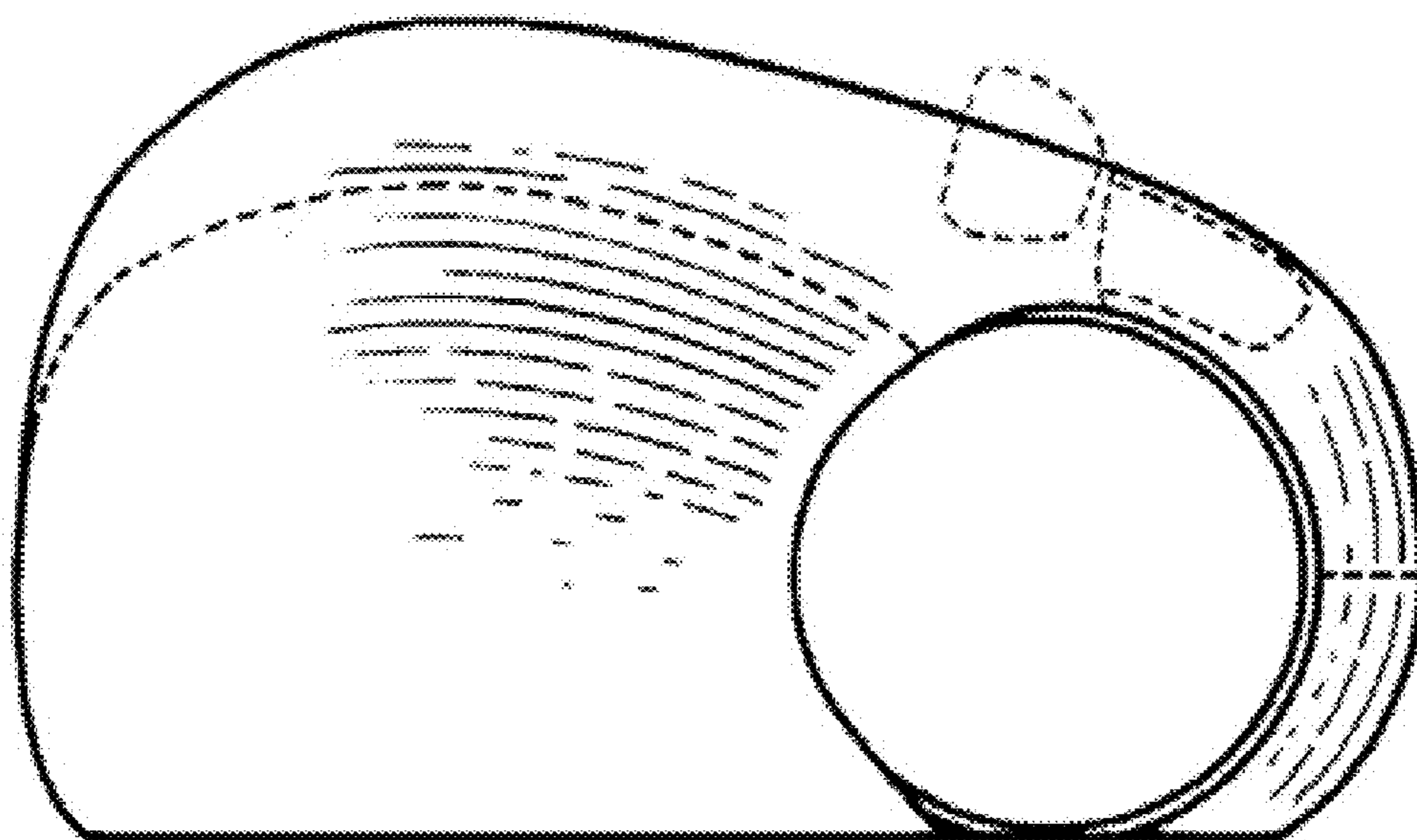

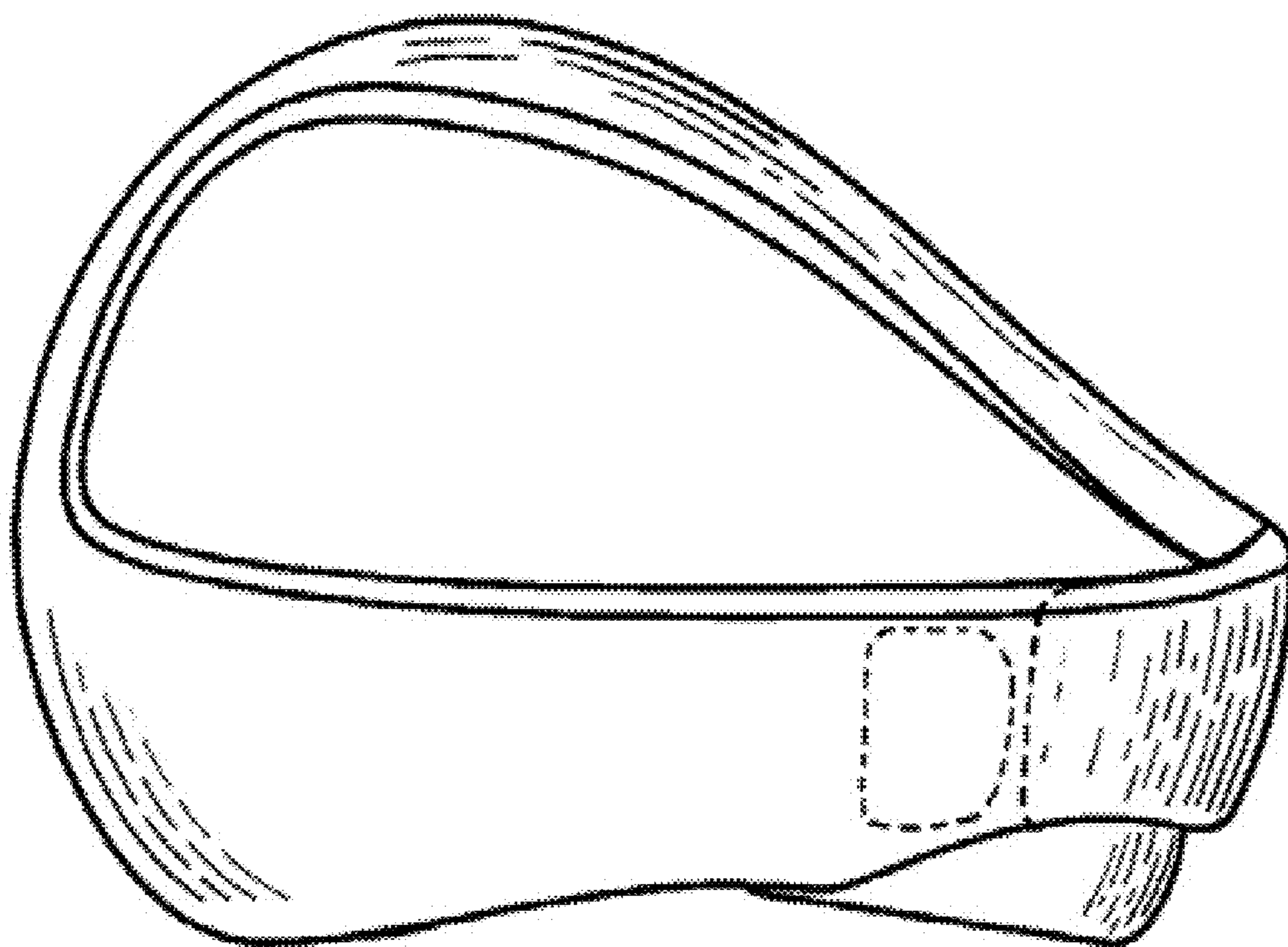

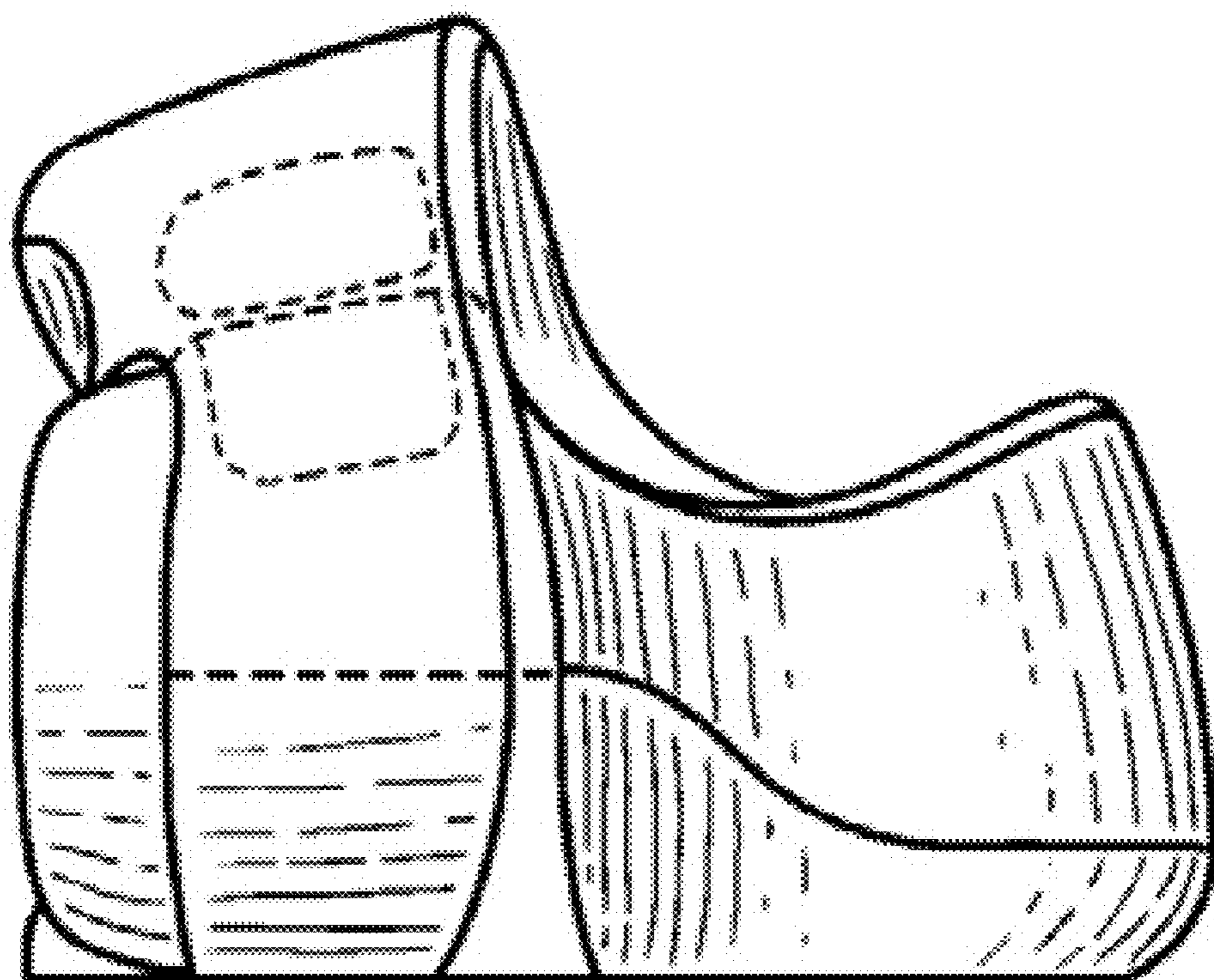

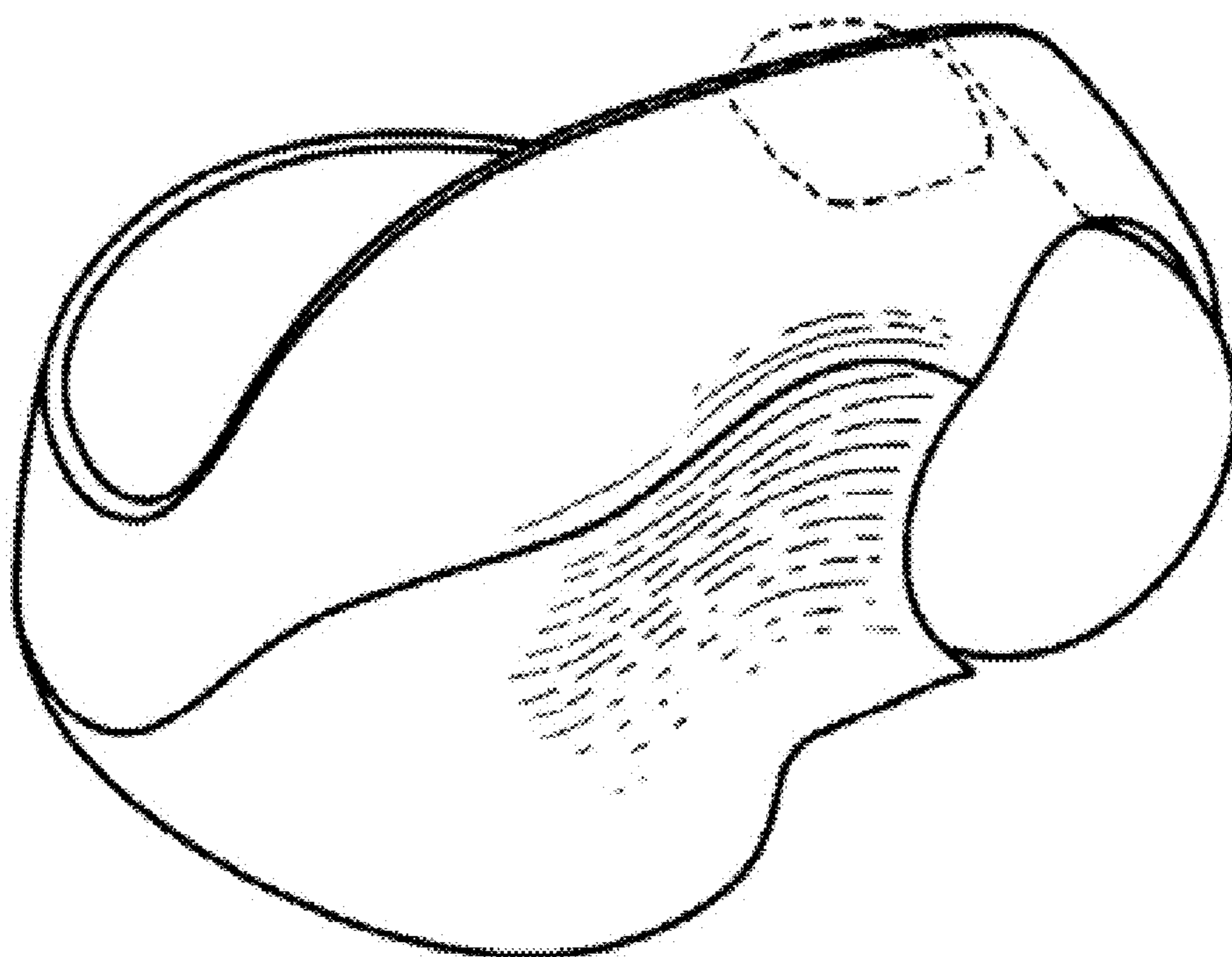

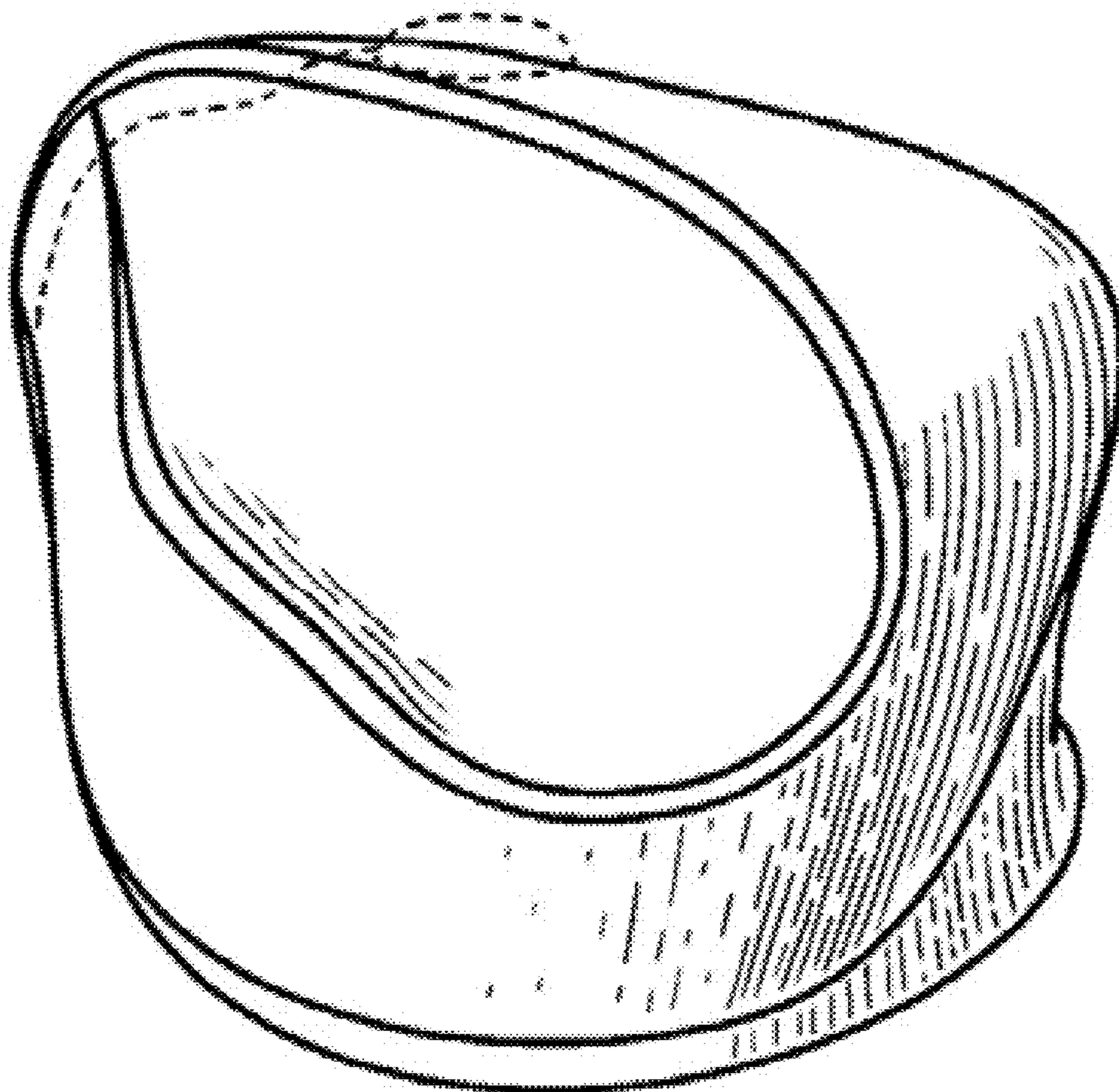
