FIG. 3 is a front and right side perspective view of the label printer of FIG. 1;

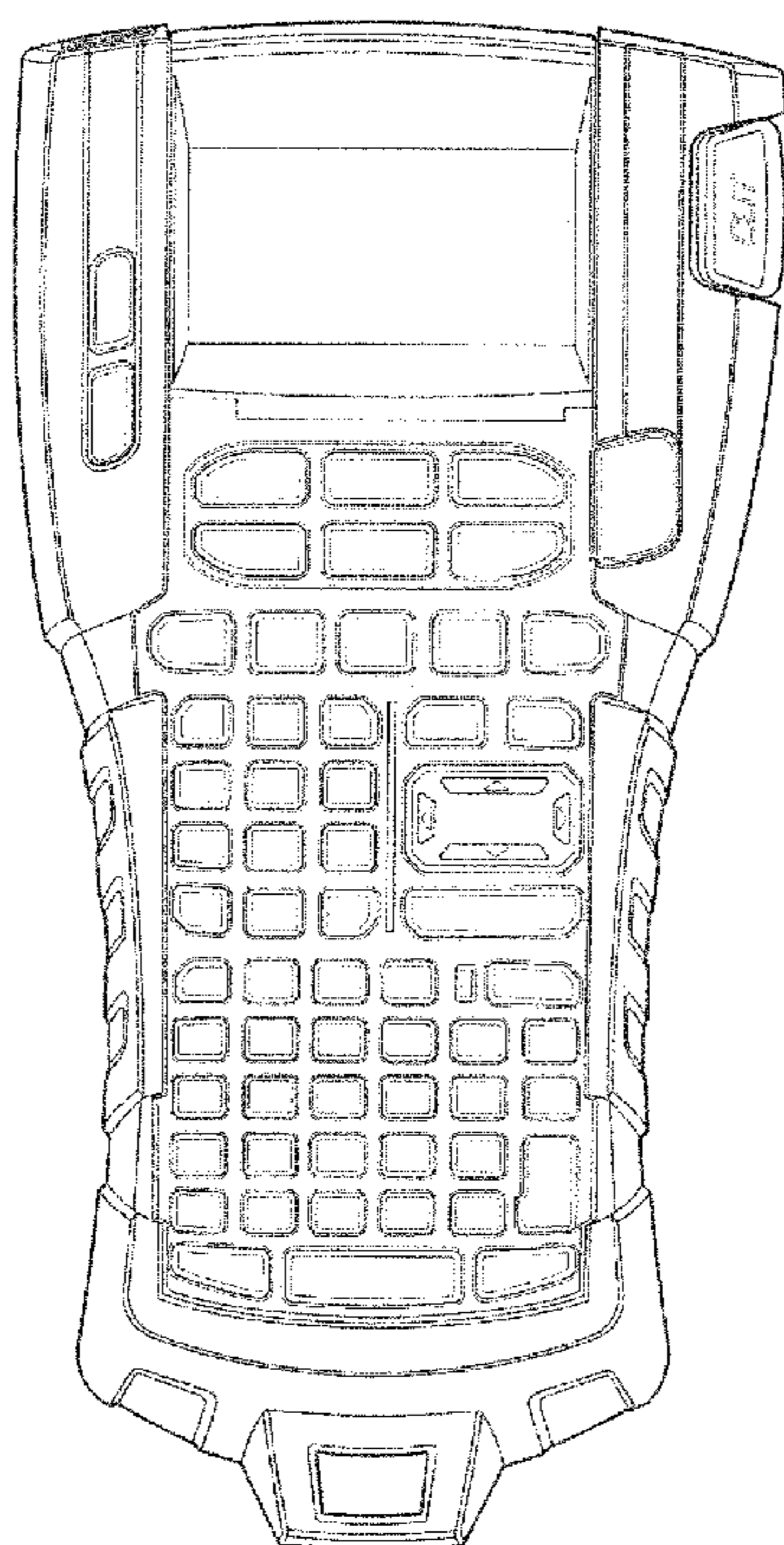
FIG. 4 is a front and left side perspective view of the label printer of FIG. 1;

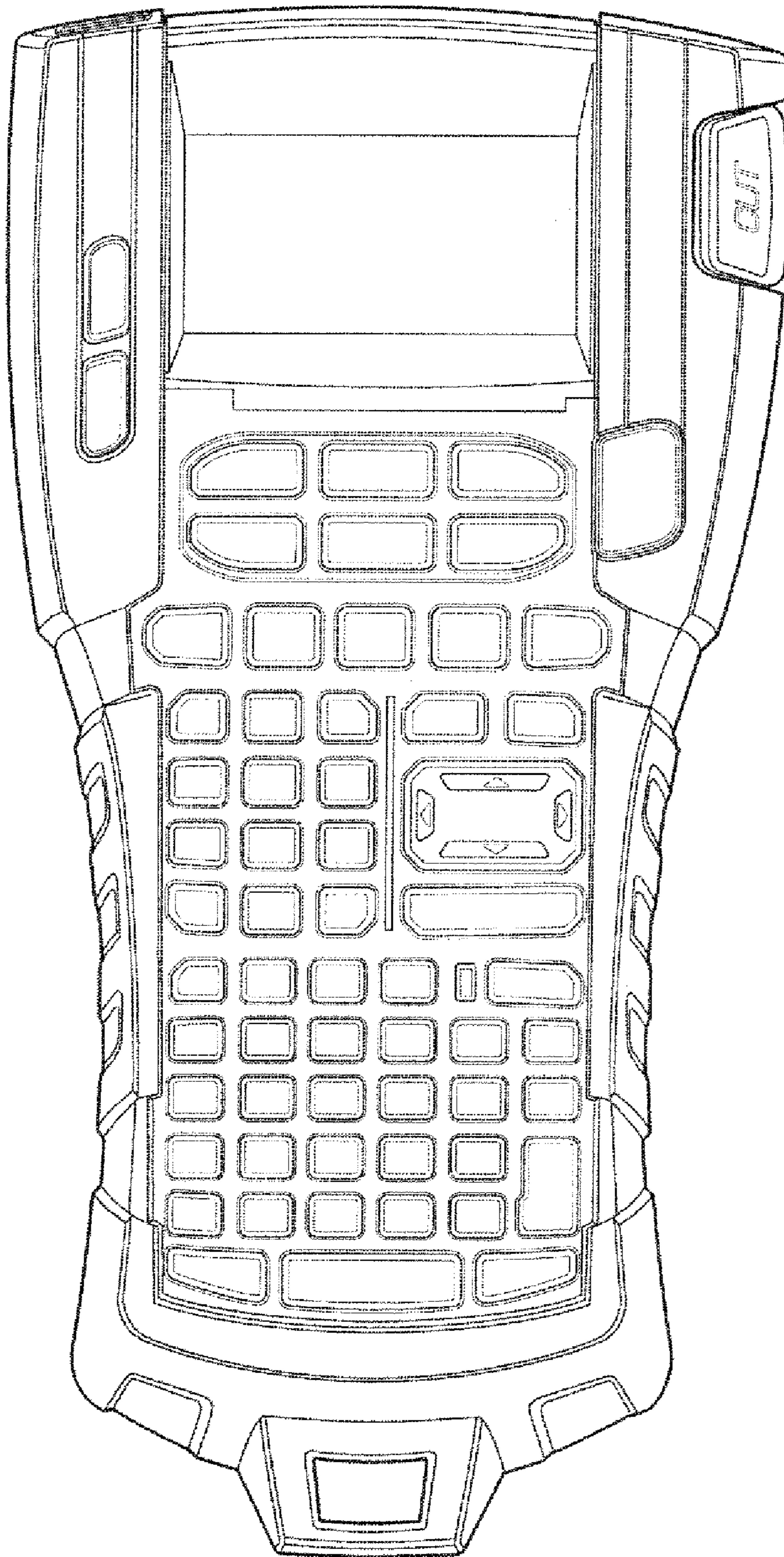

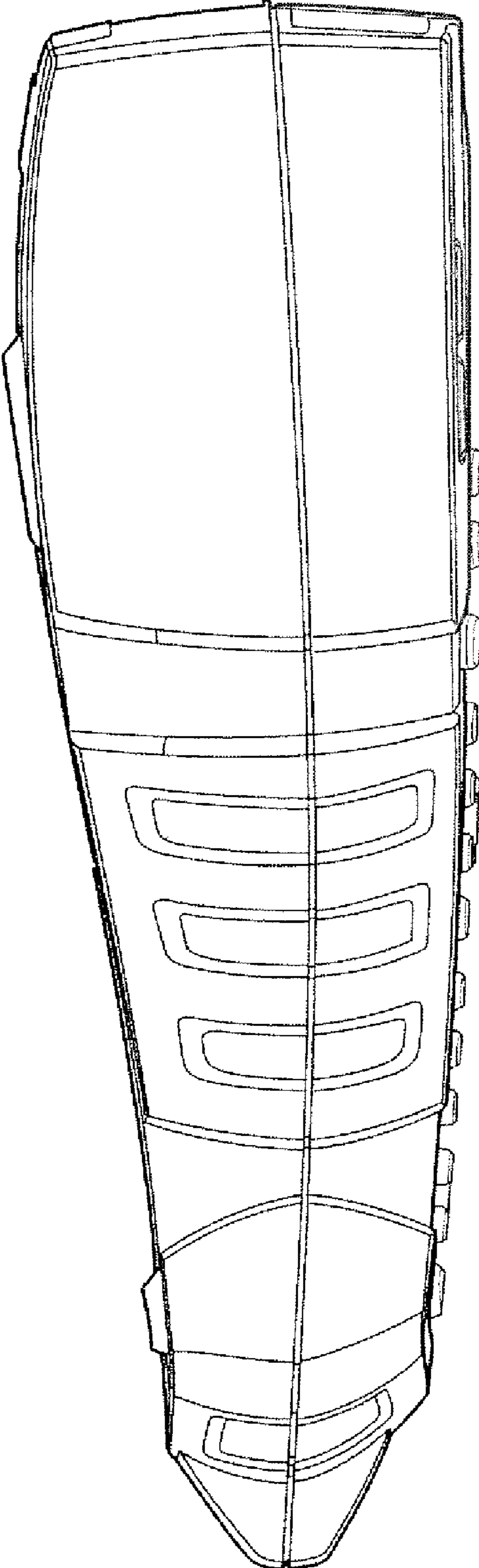

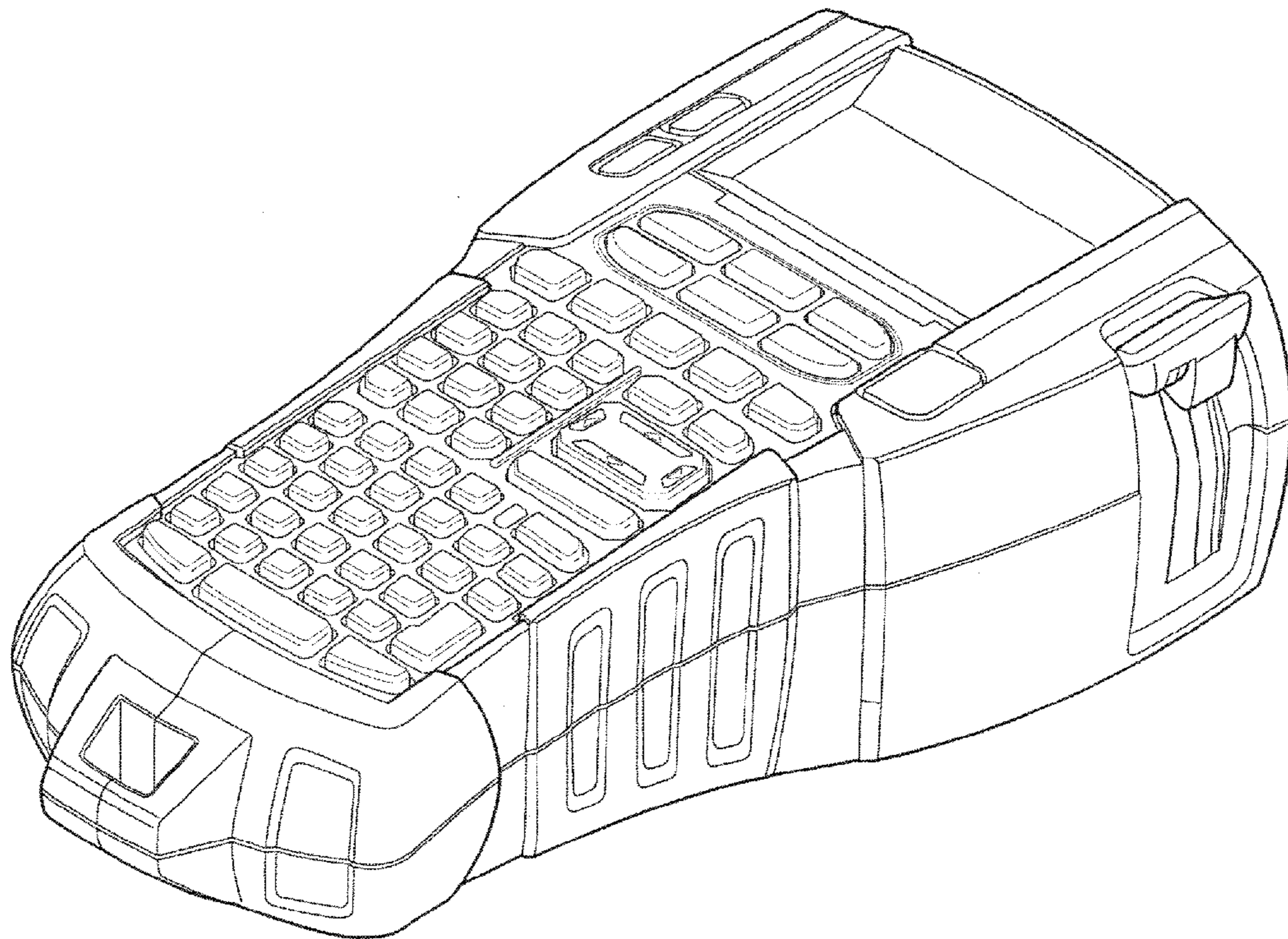

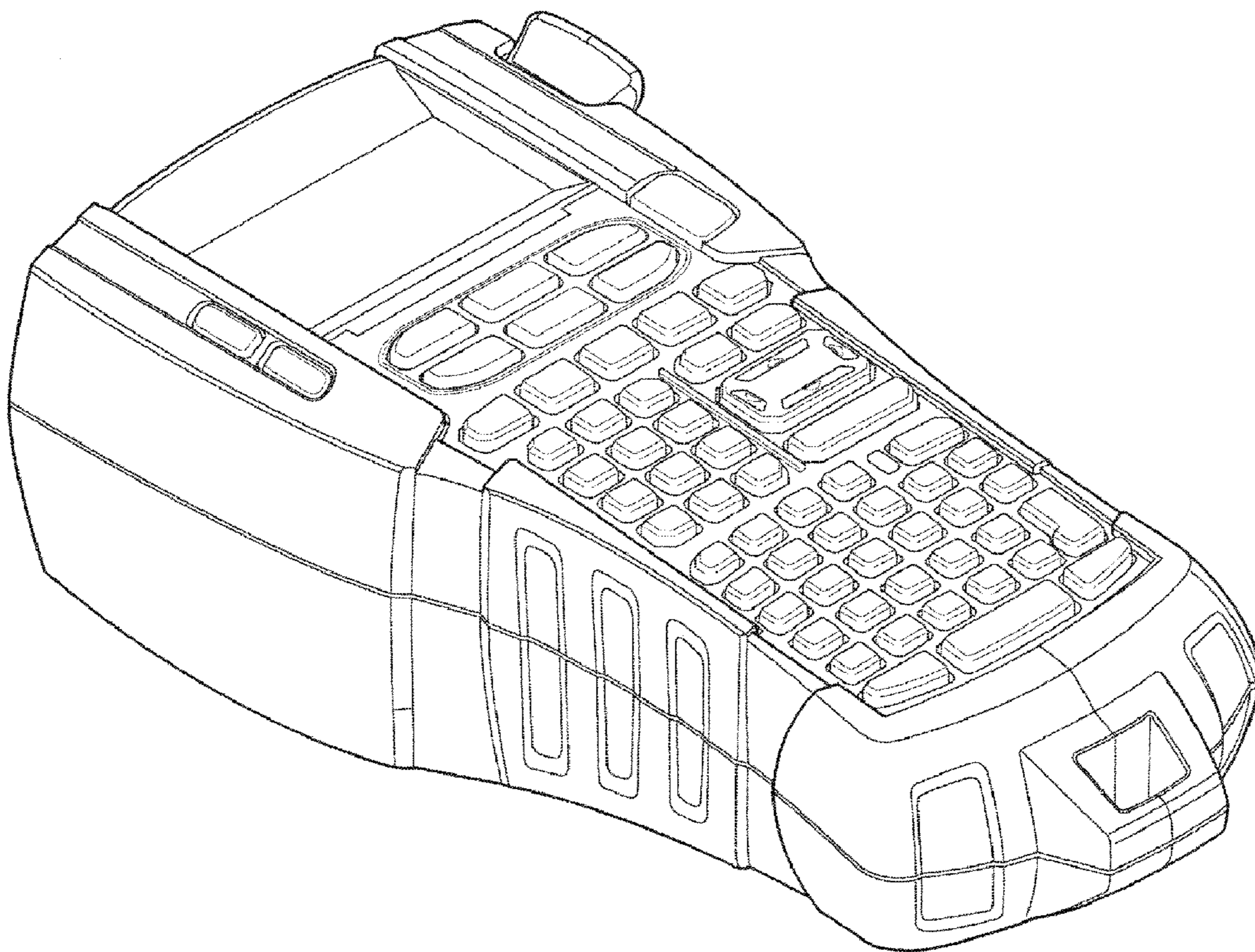

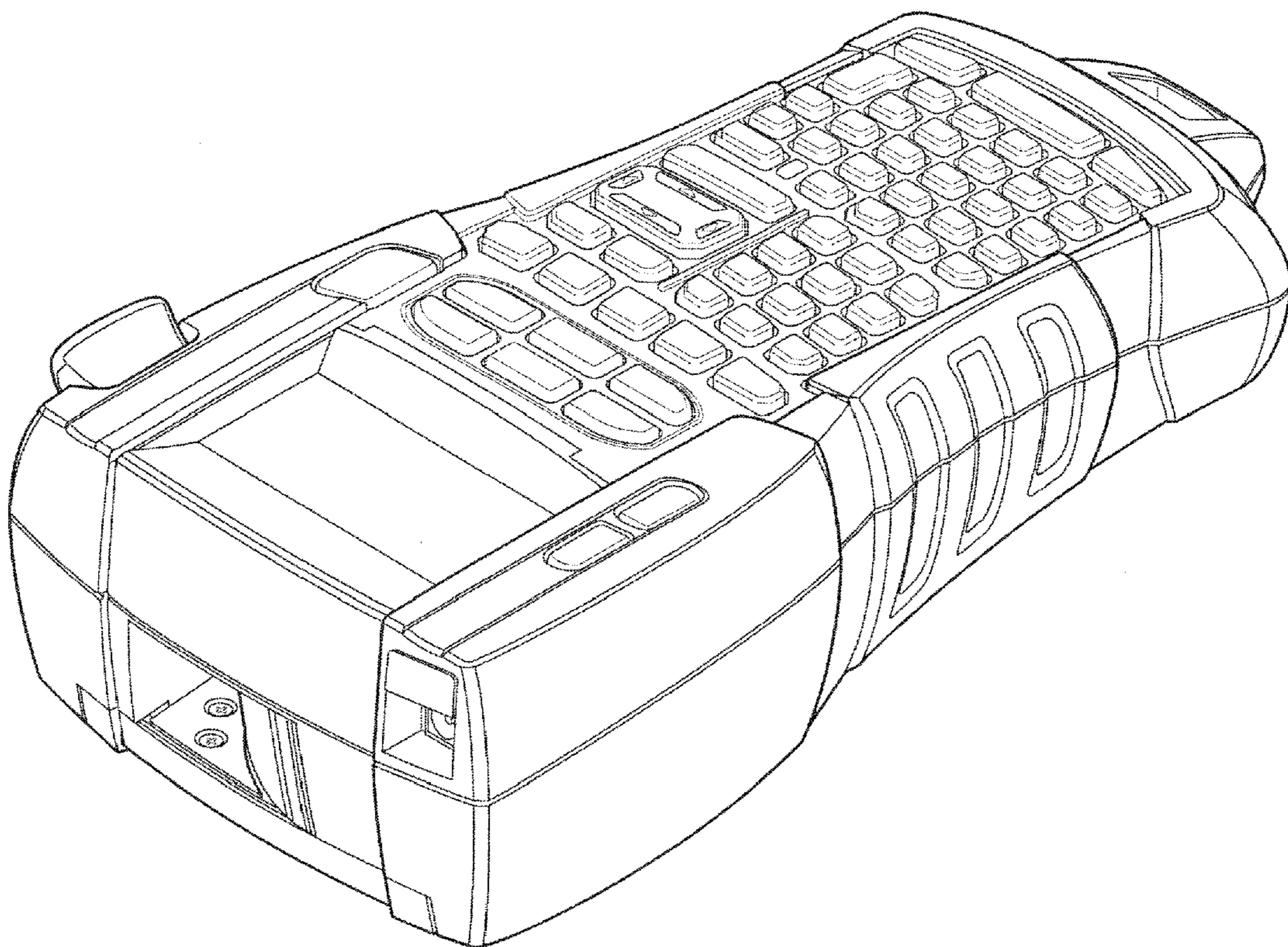

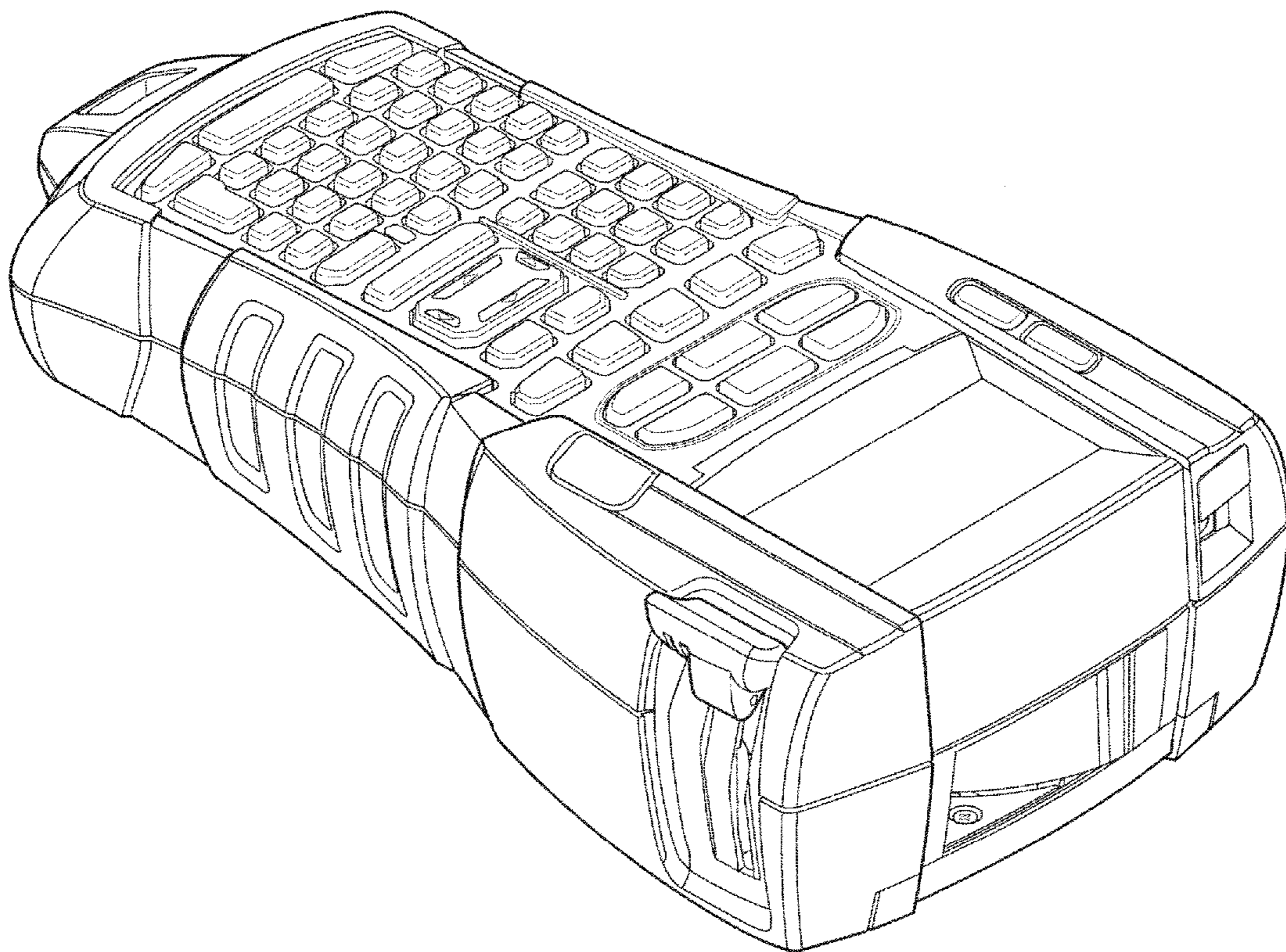

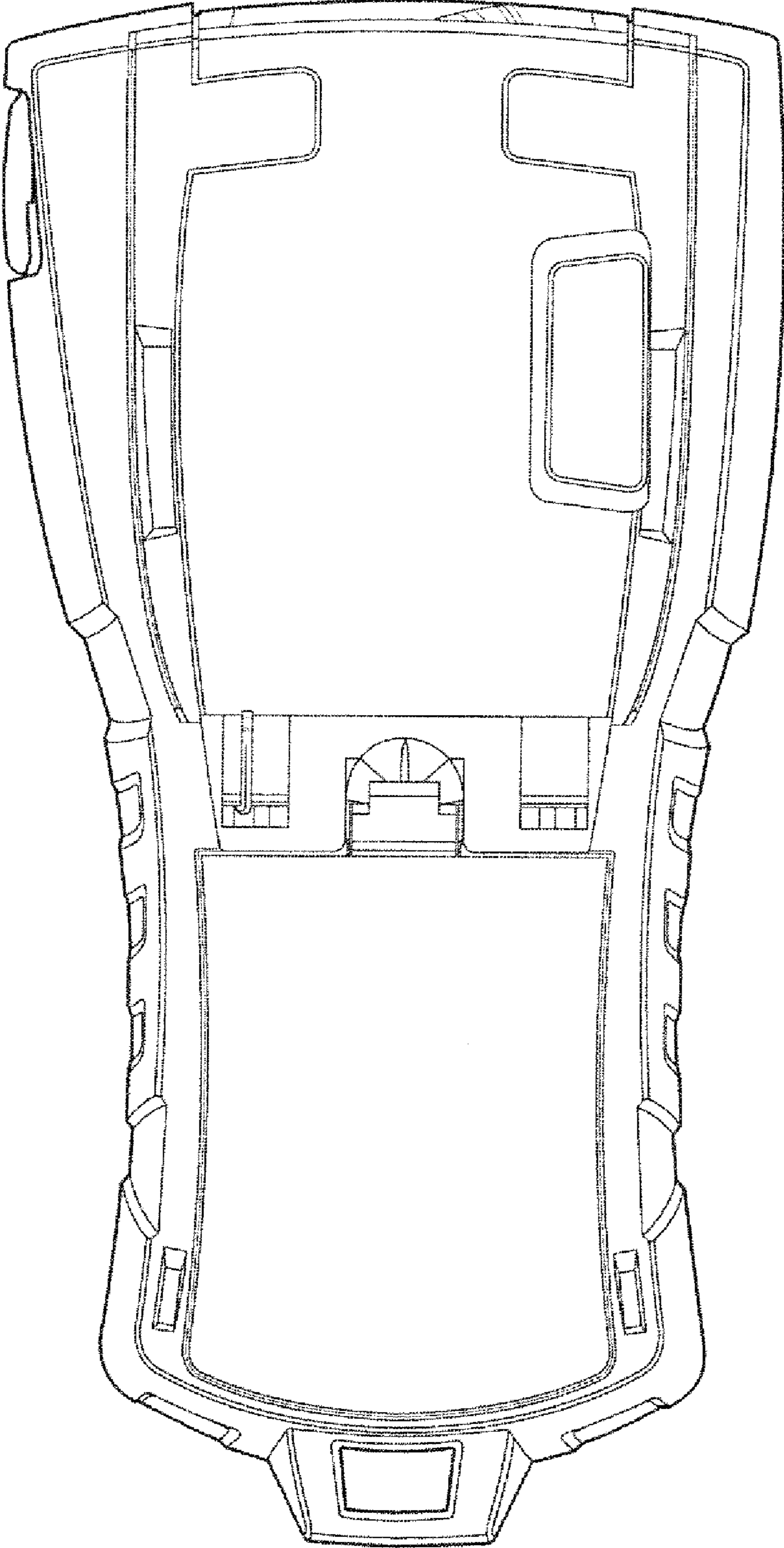
