DESCRIPTION

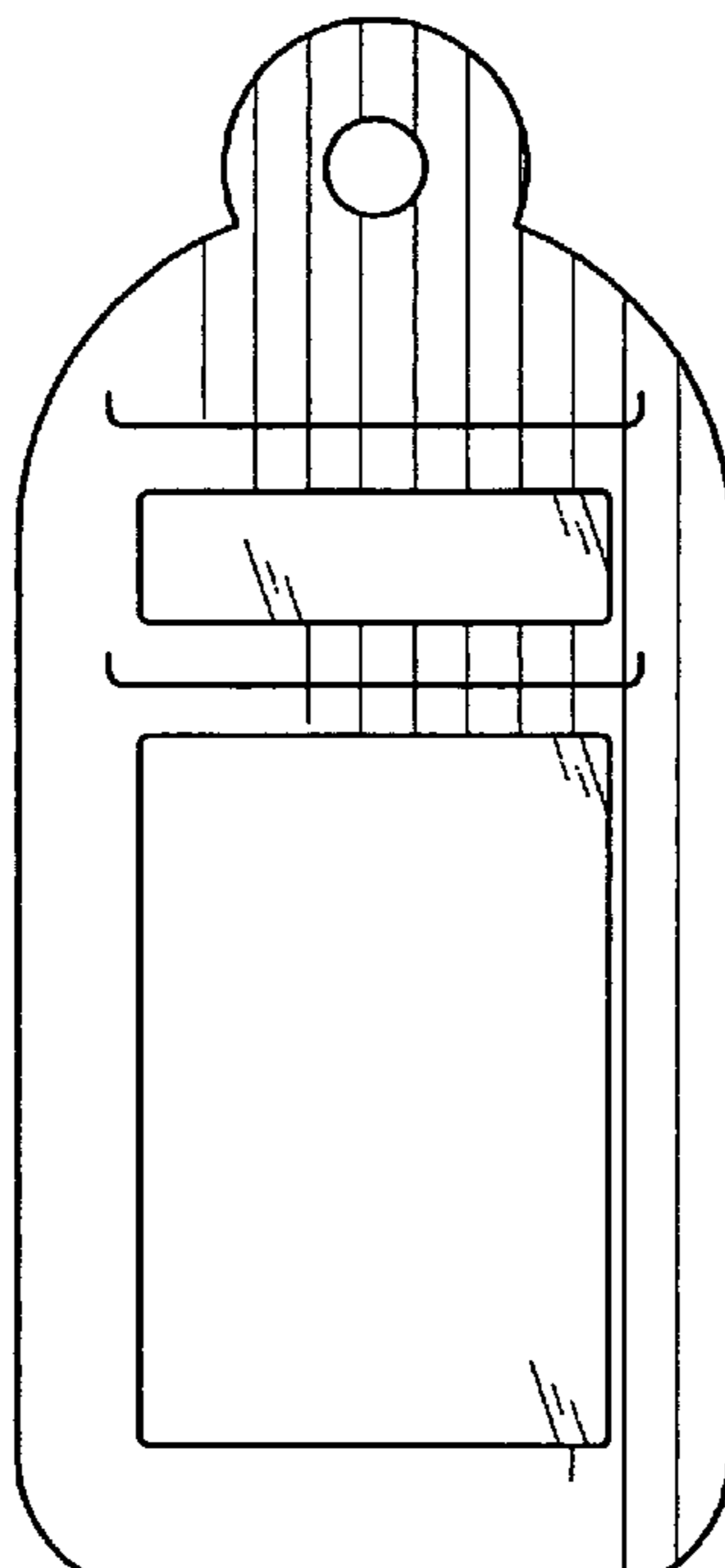
FIG. 1 is a front elevational view of the new design for the

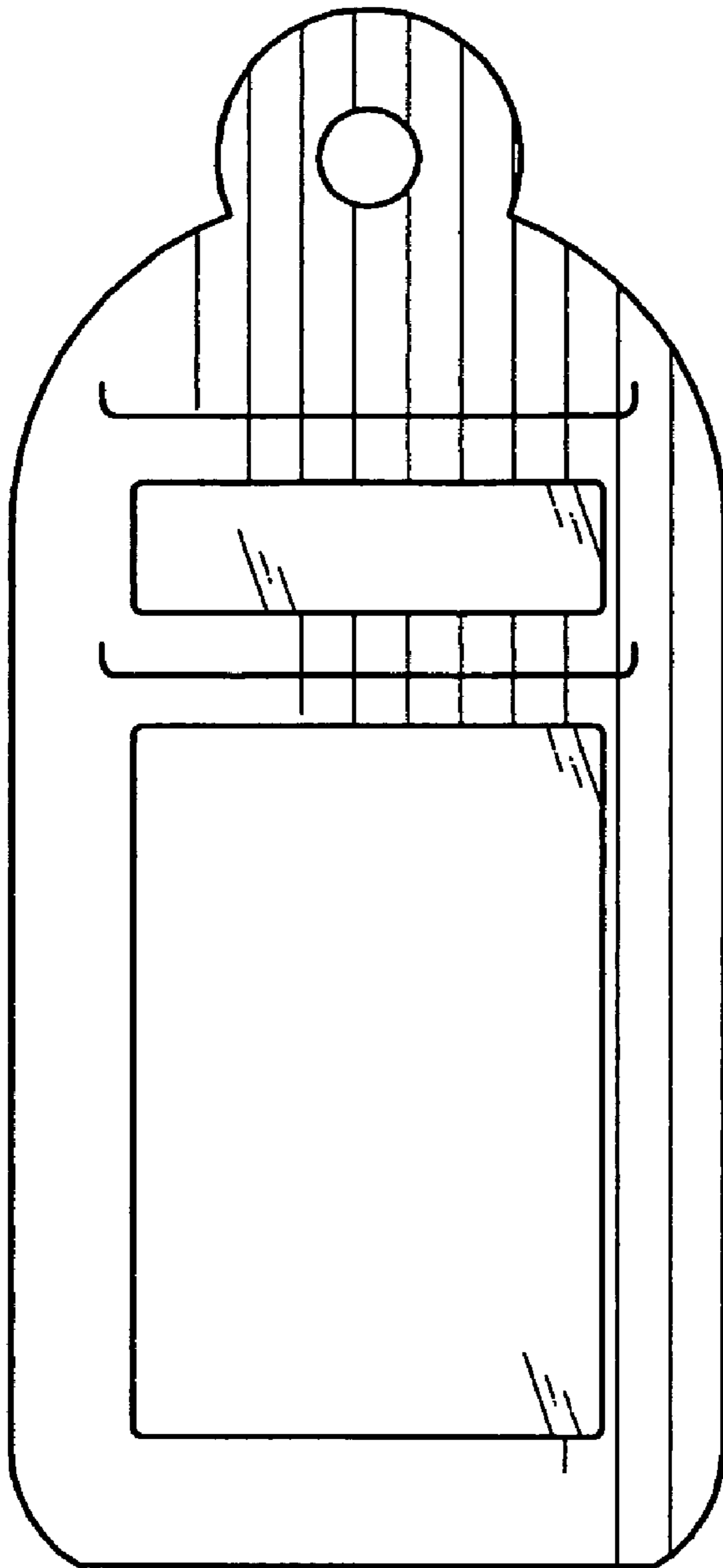

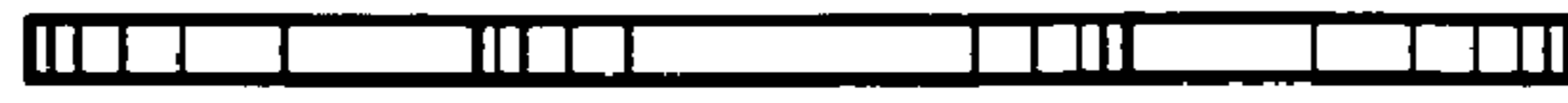

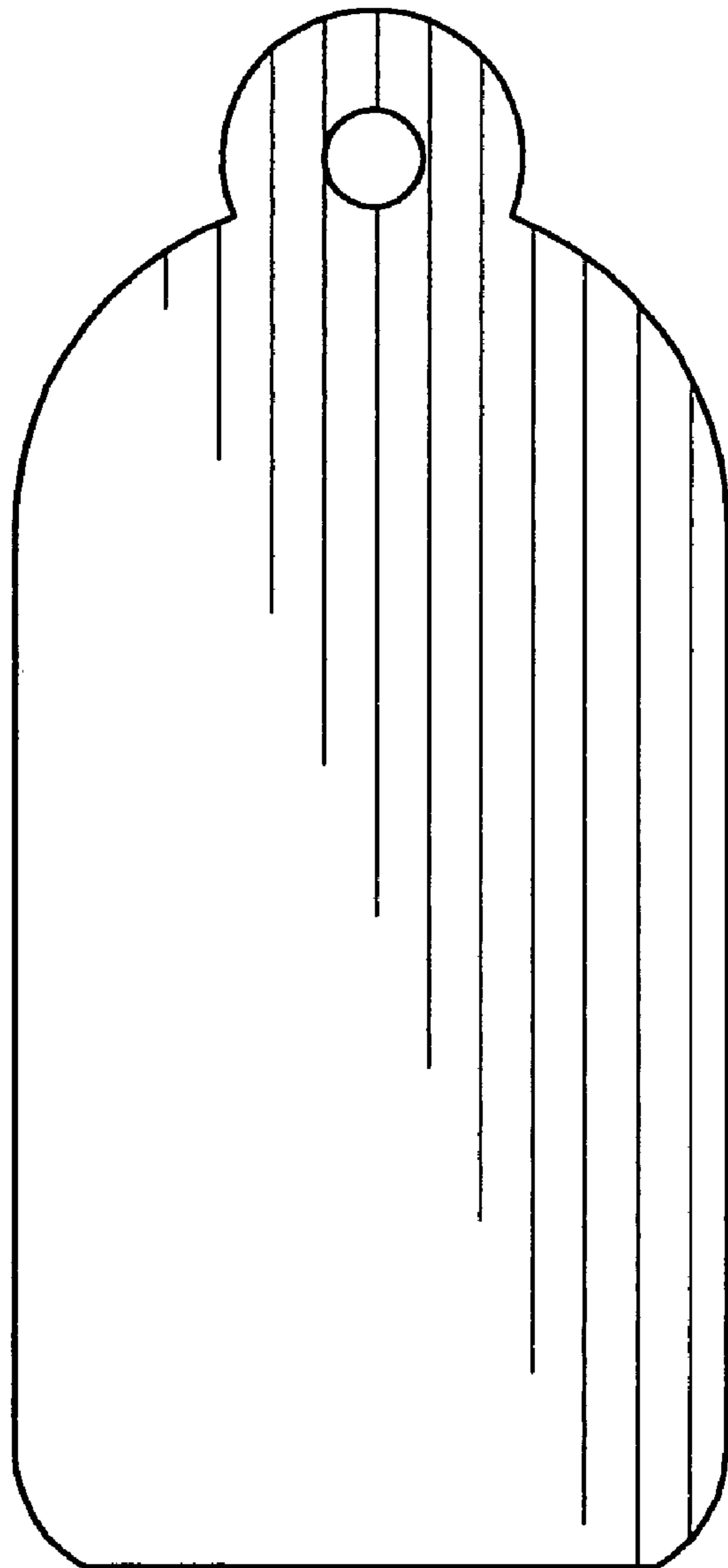
