The ornamental design for a sanitary napkin, as shown and described.

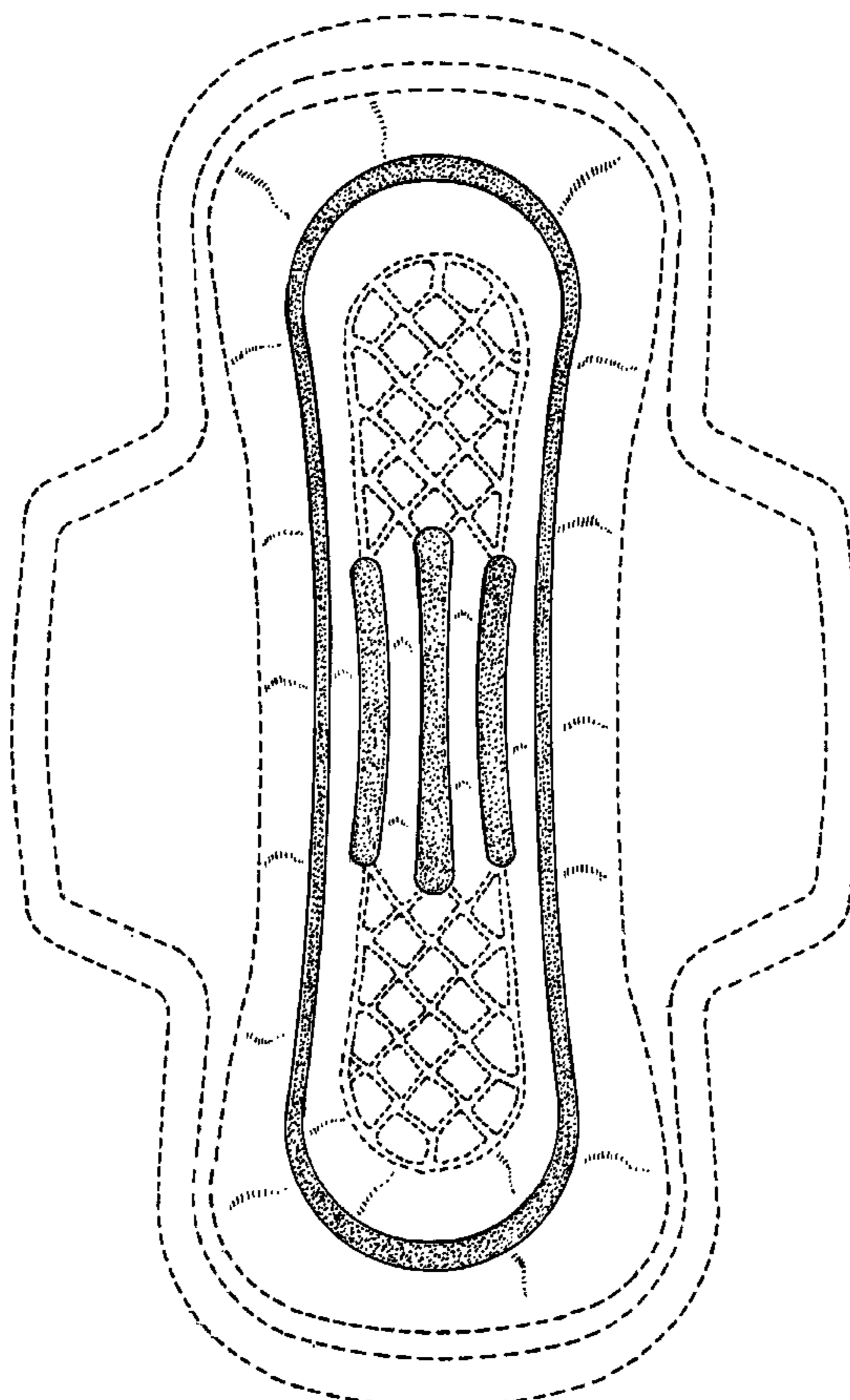
**DESCRIPTION**

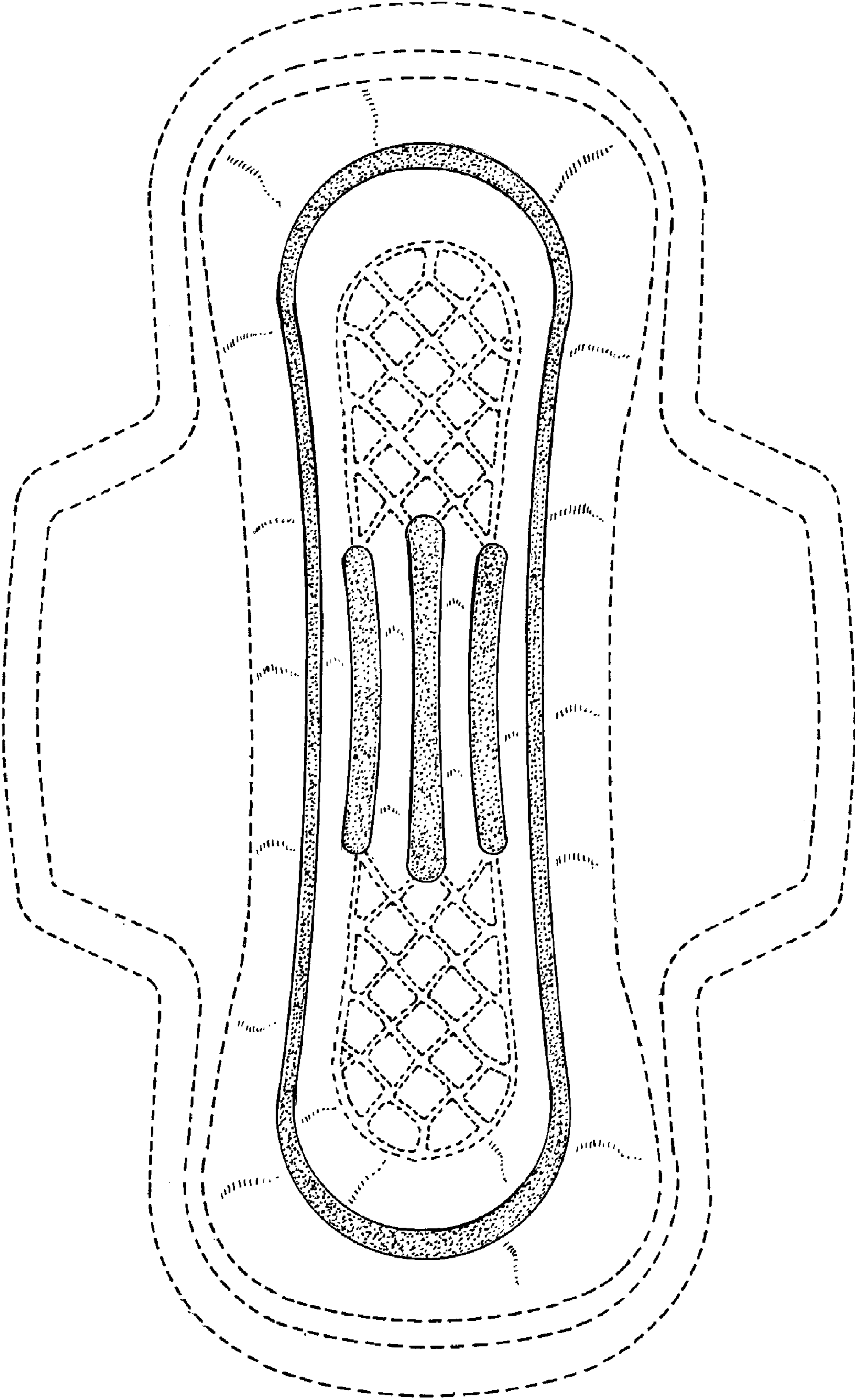
FIG. 1 is a top plan view of a sanitary napkin according to the present invention; and,

FIG. 2 is a bottom plan view of the sanitary napkin shown in FIG. 1.

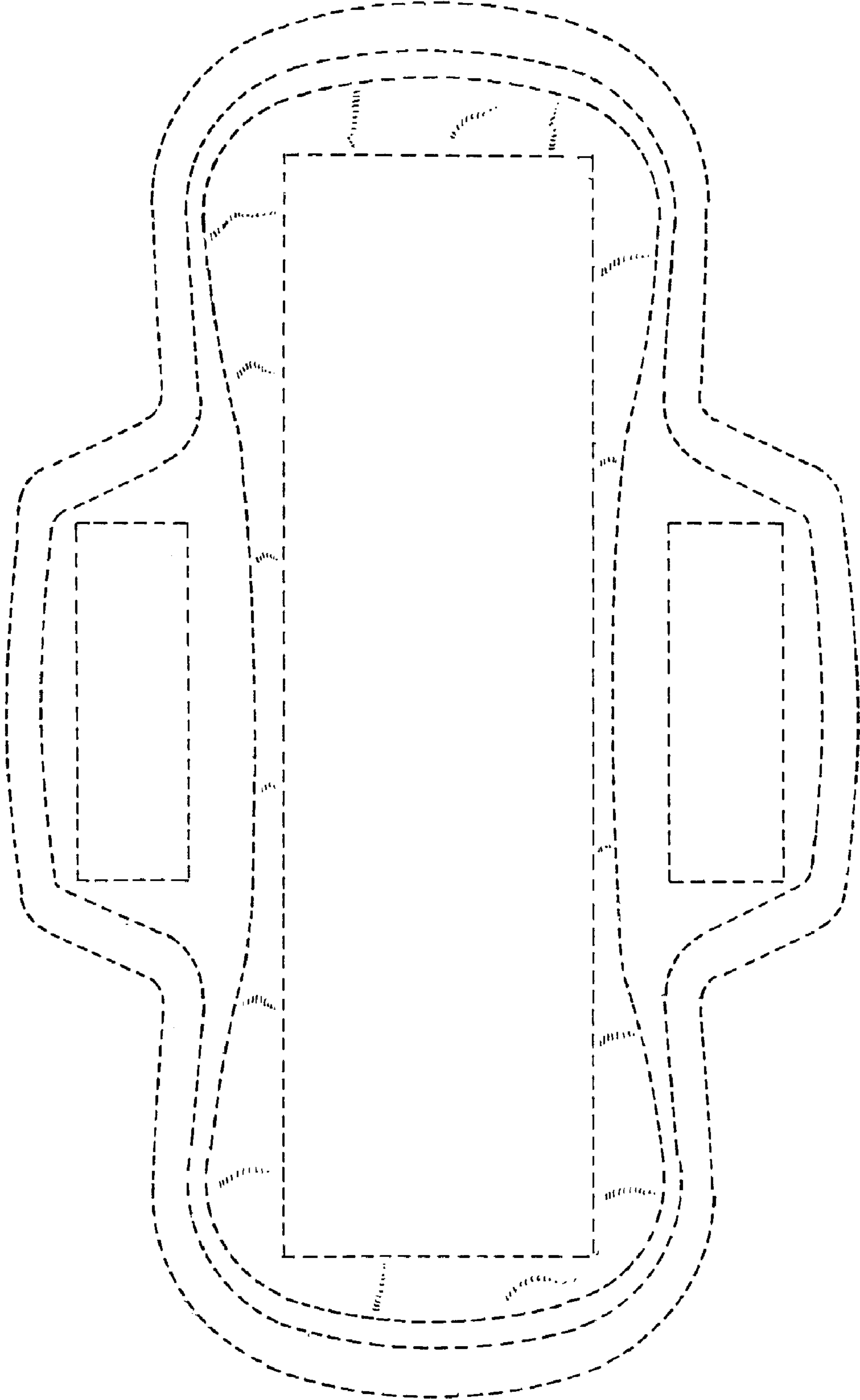
