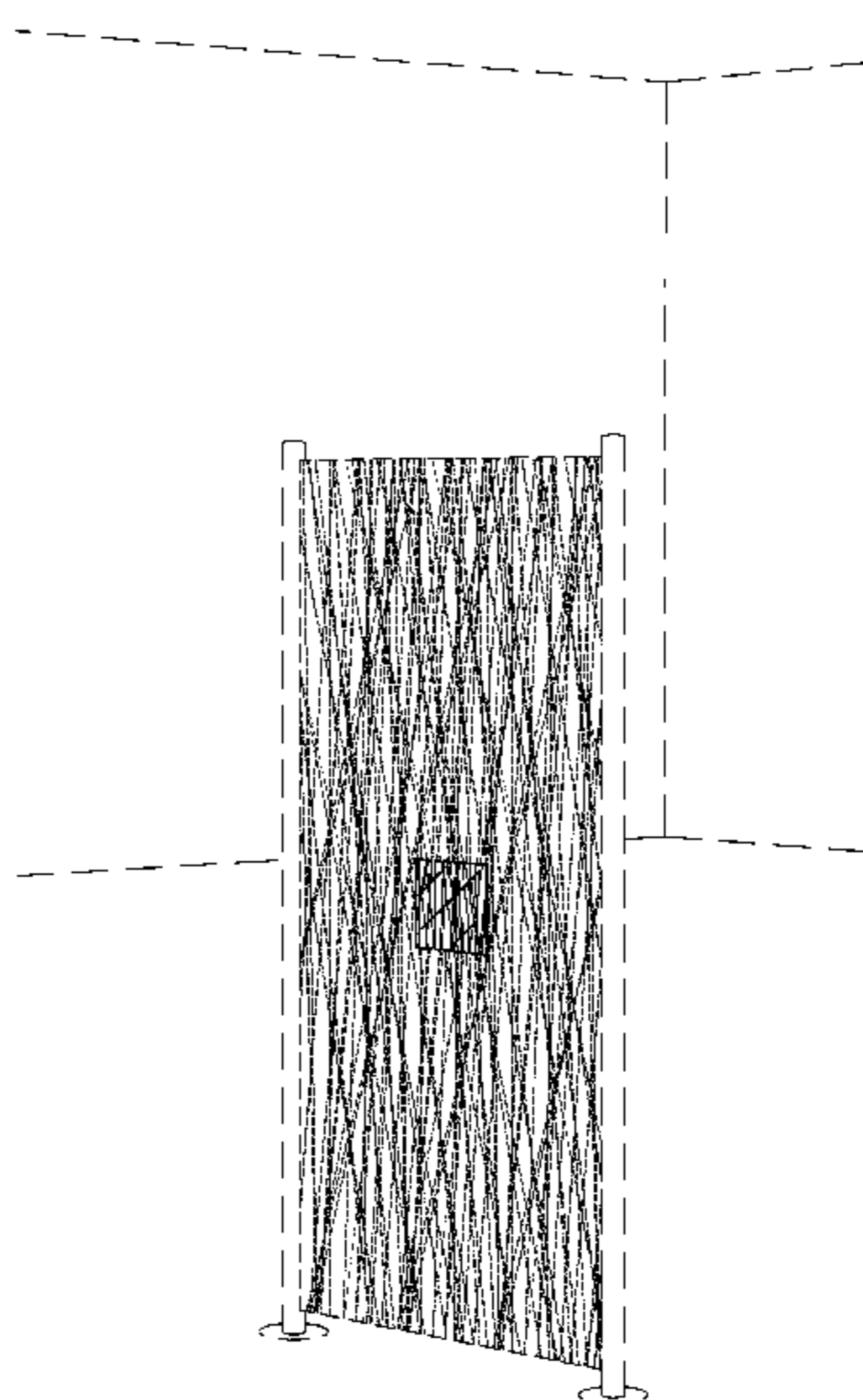
FIG. 6 is a bottom sectional view taken along line 6—6 of FIG. 4;

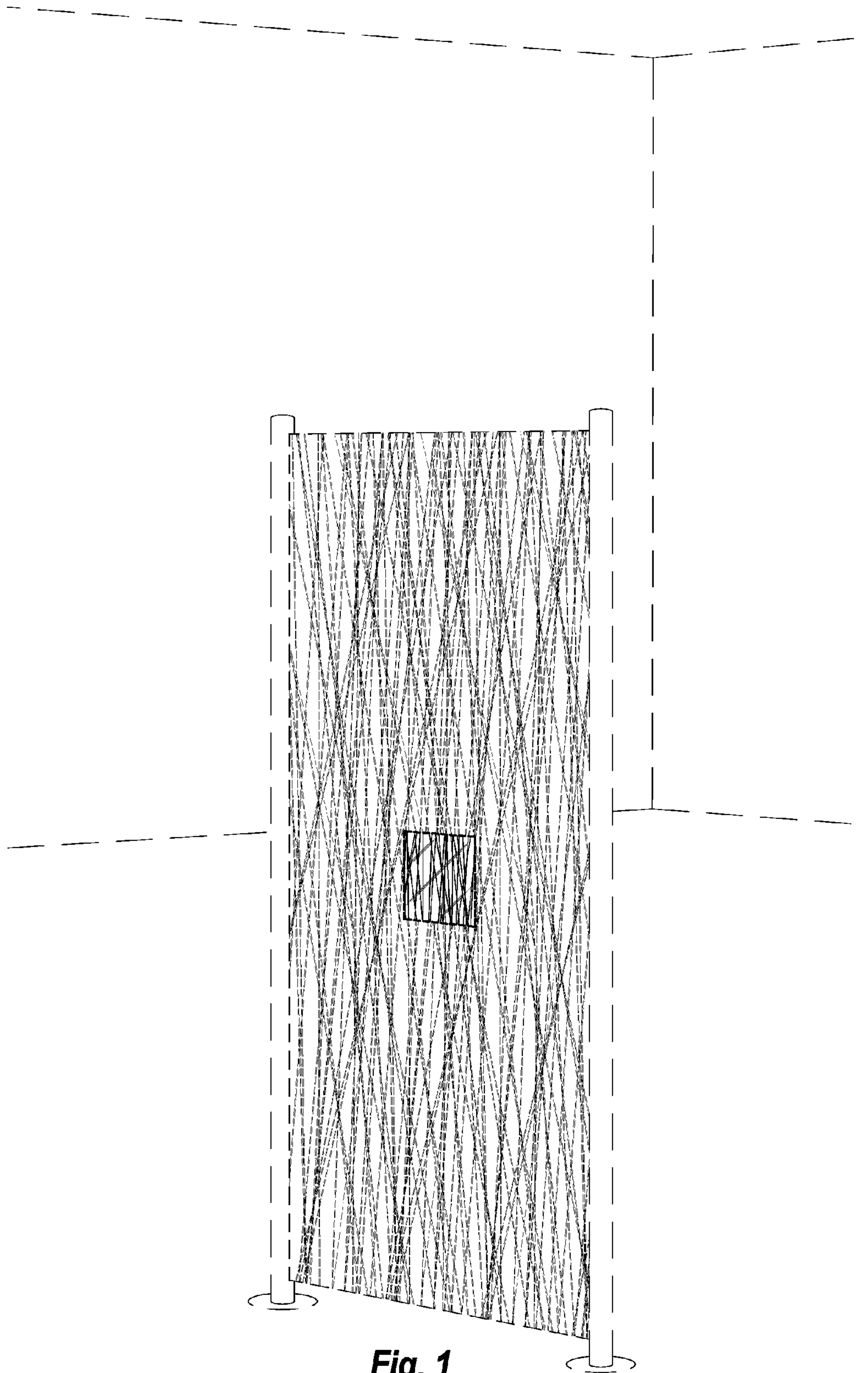

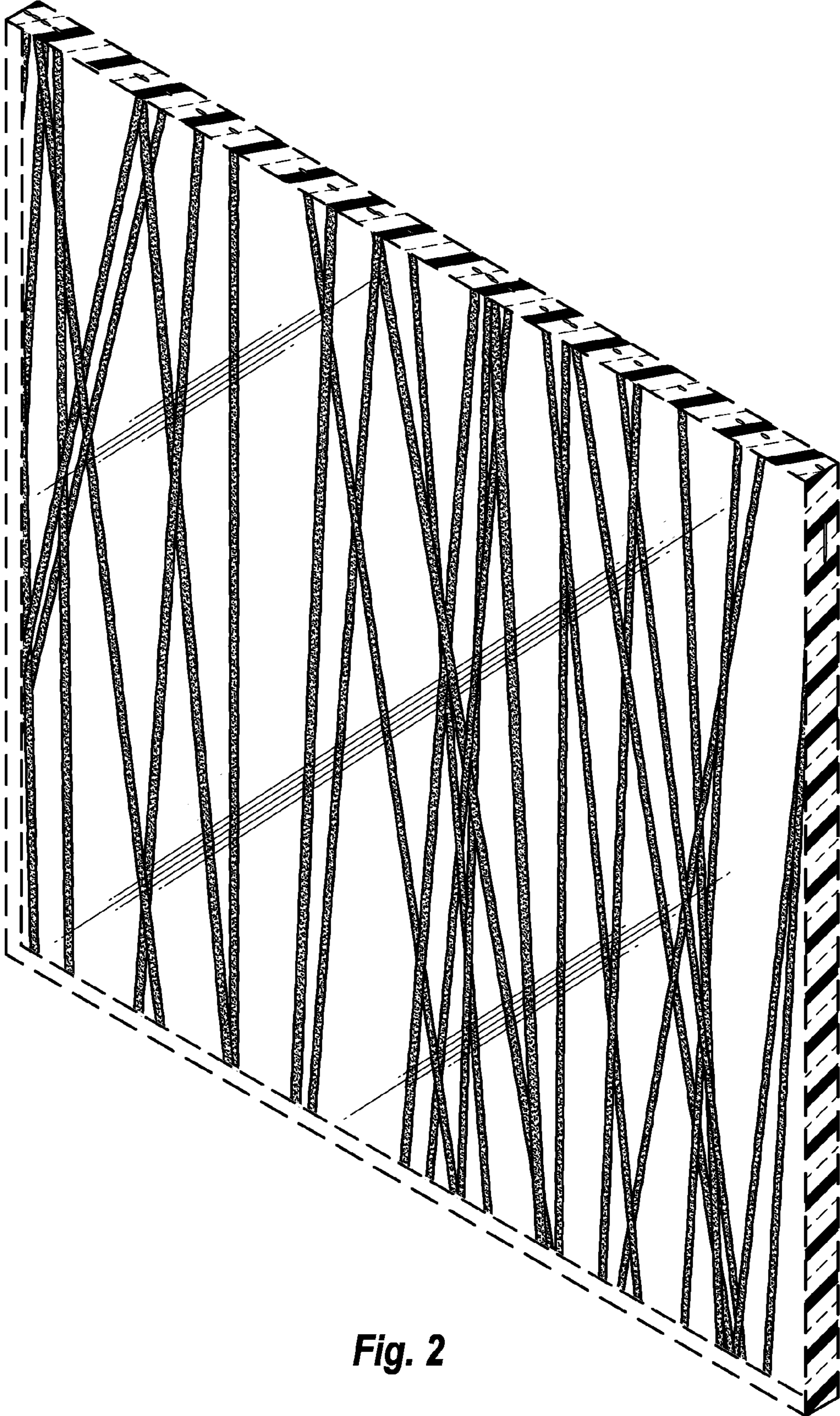

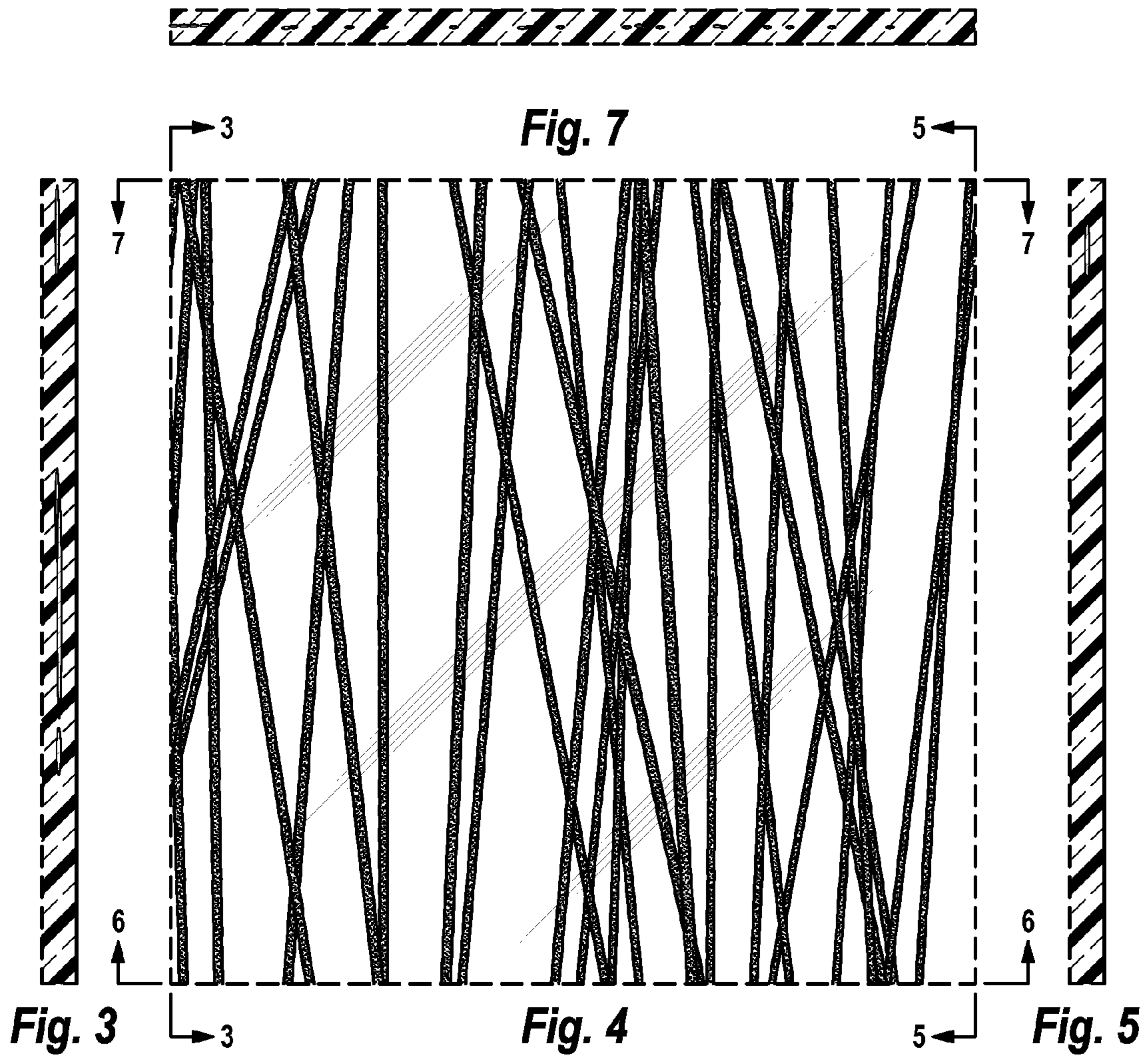

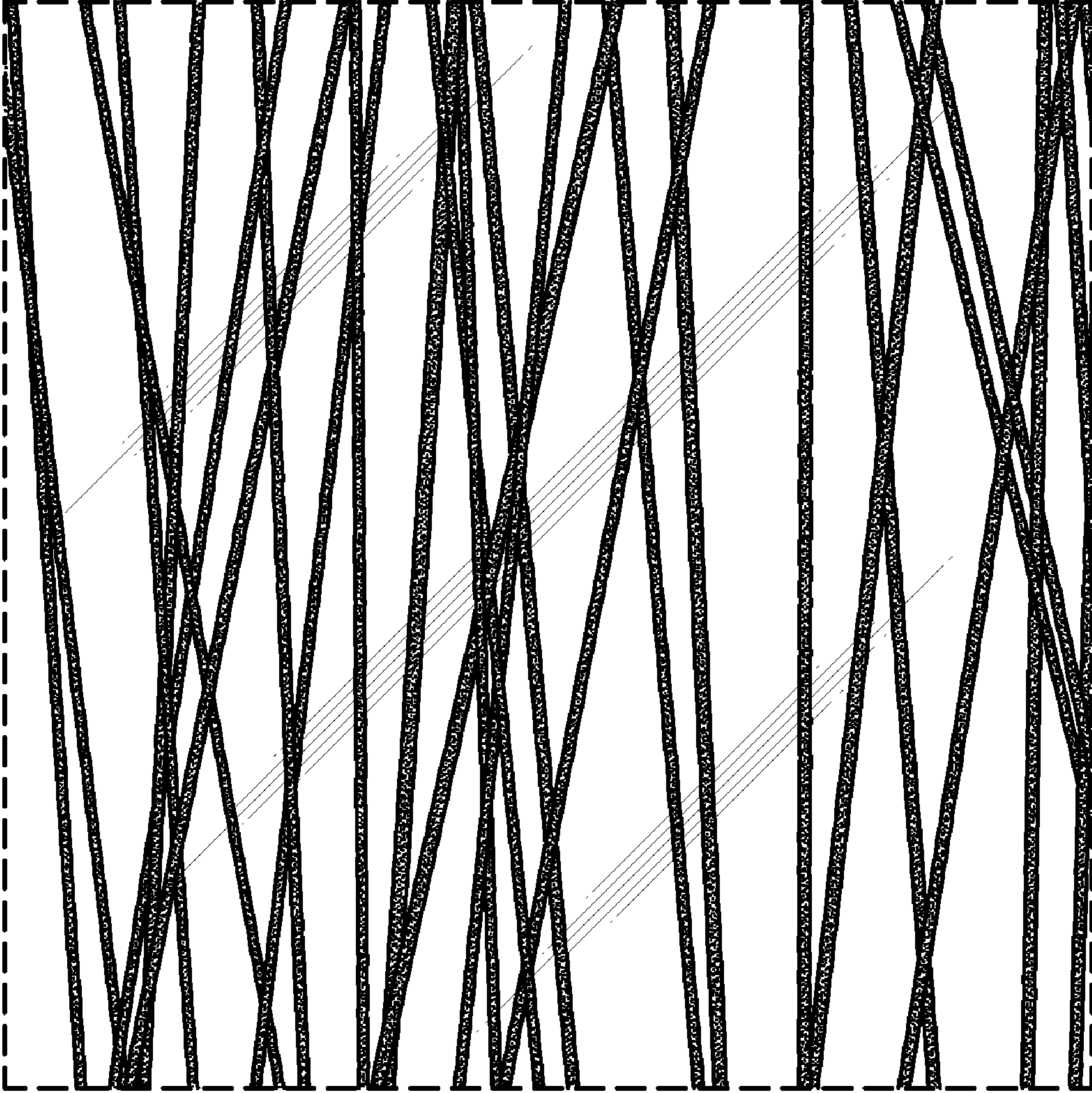
