FIG. 4 is a left side view thereof, the right side view being a mirror image of the left side view;

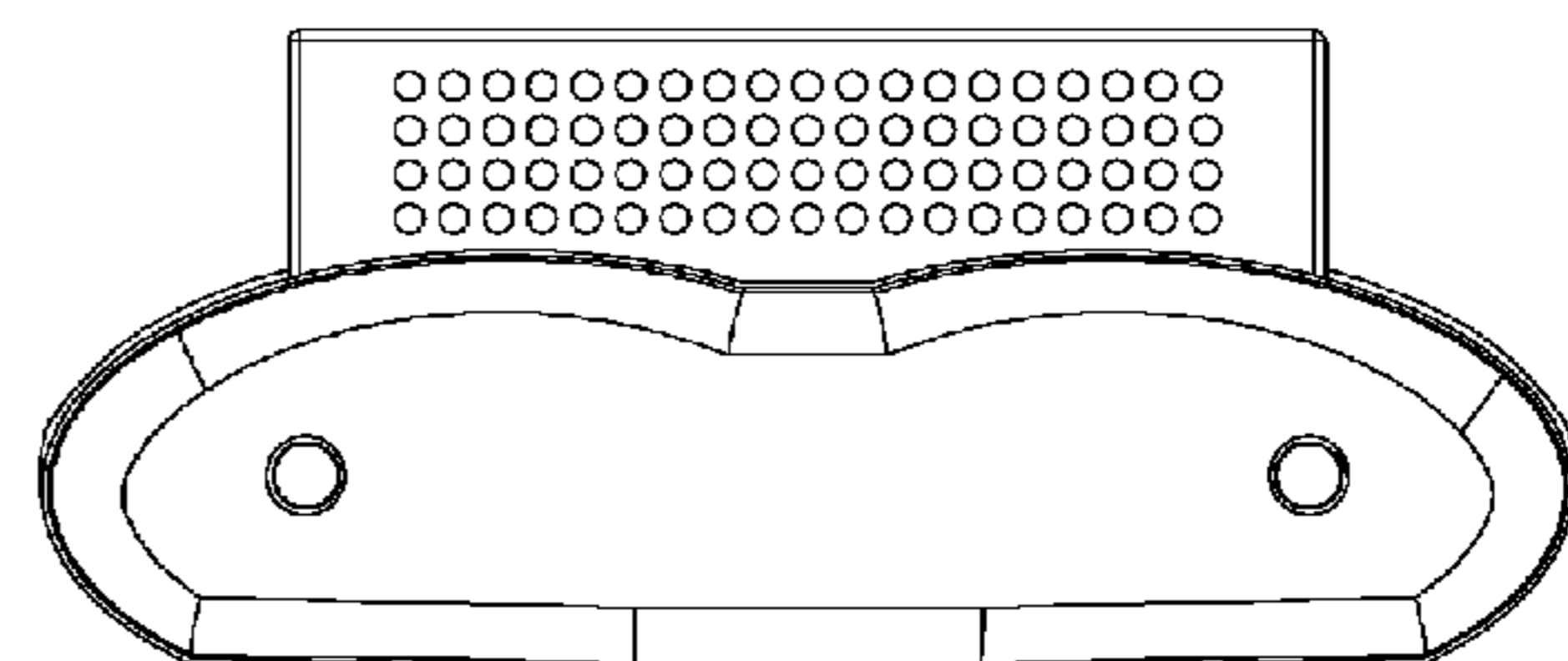
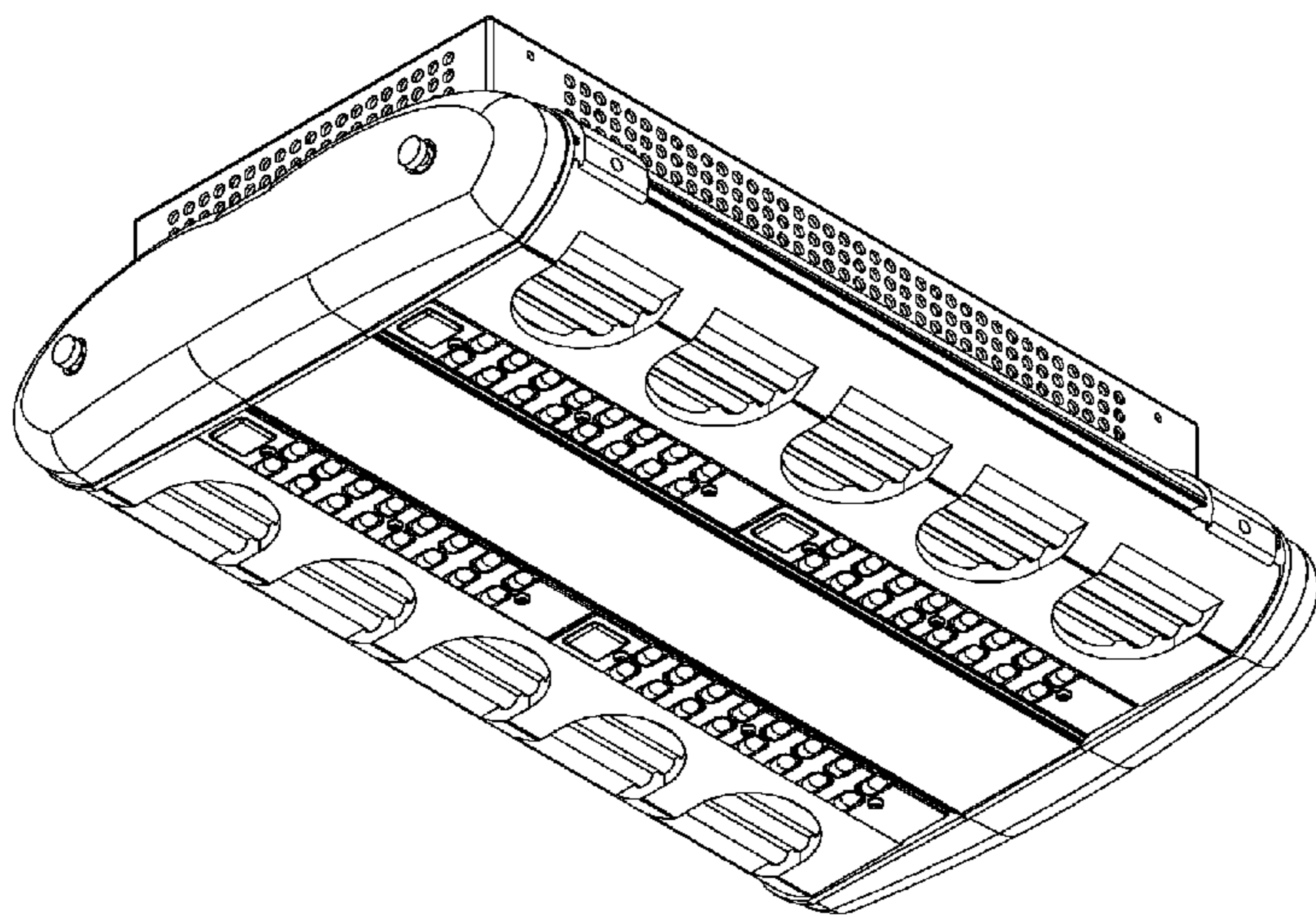
FIG. 5 is a top view thereof;

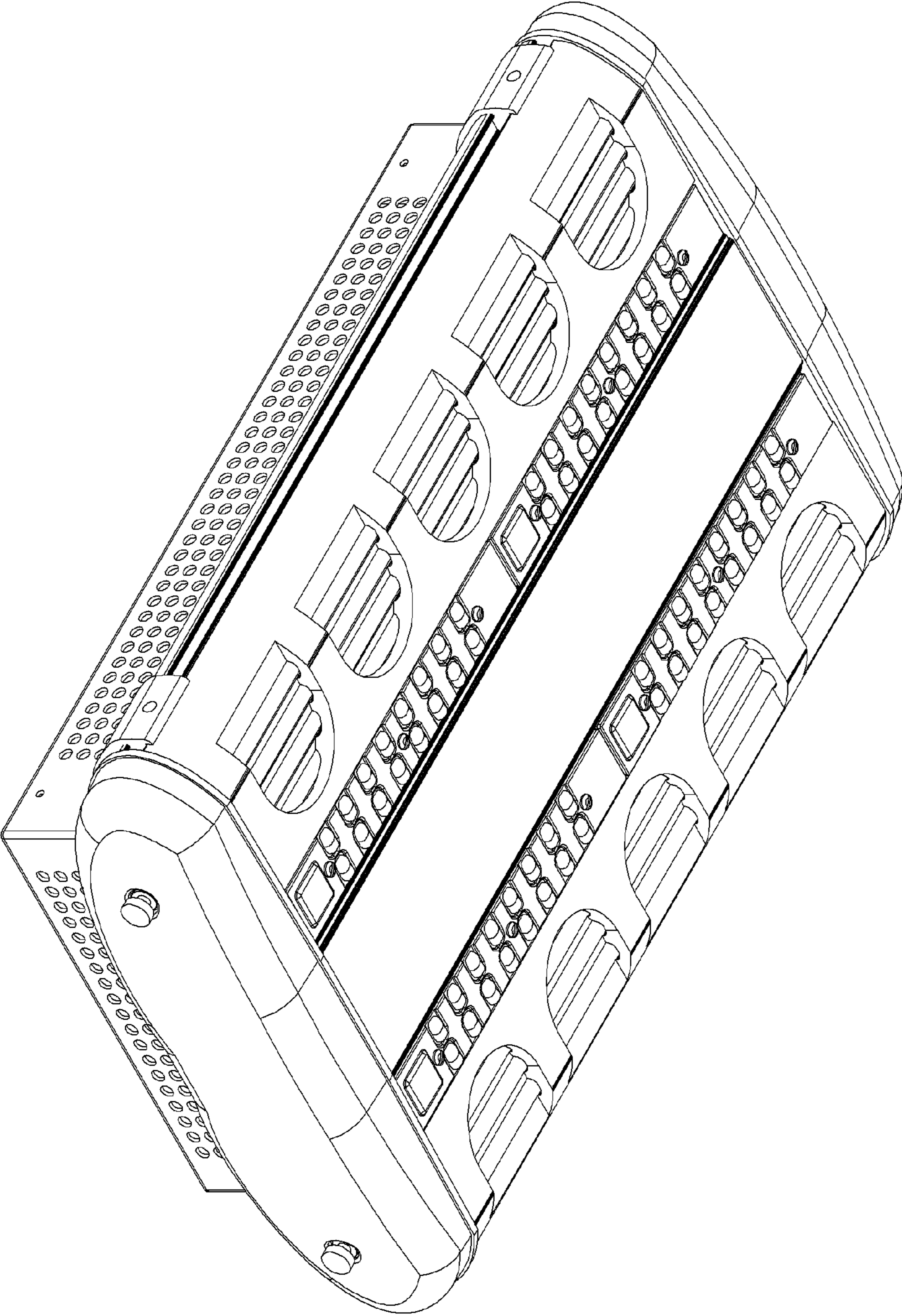

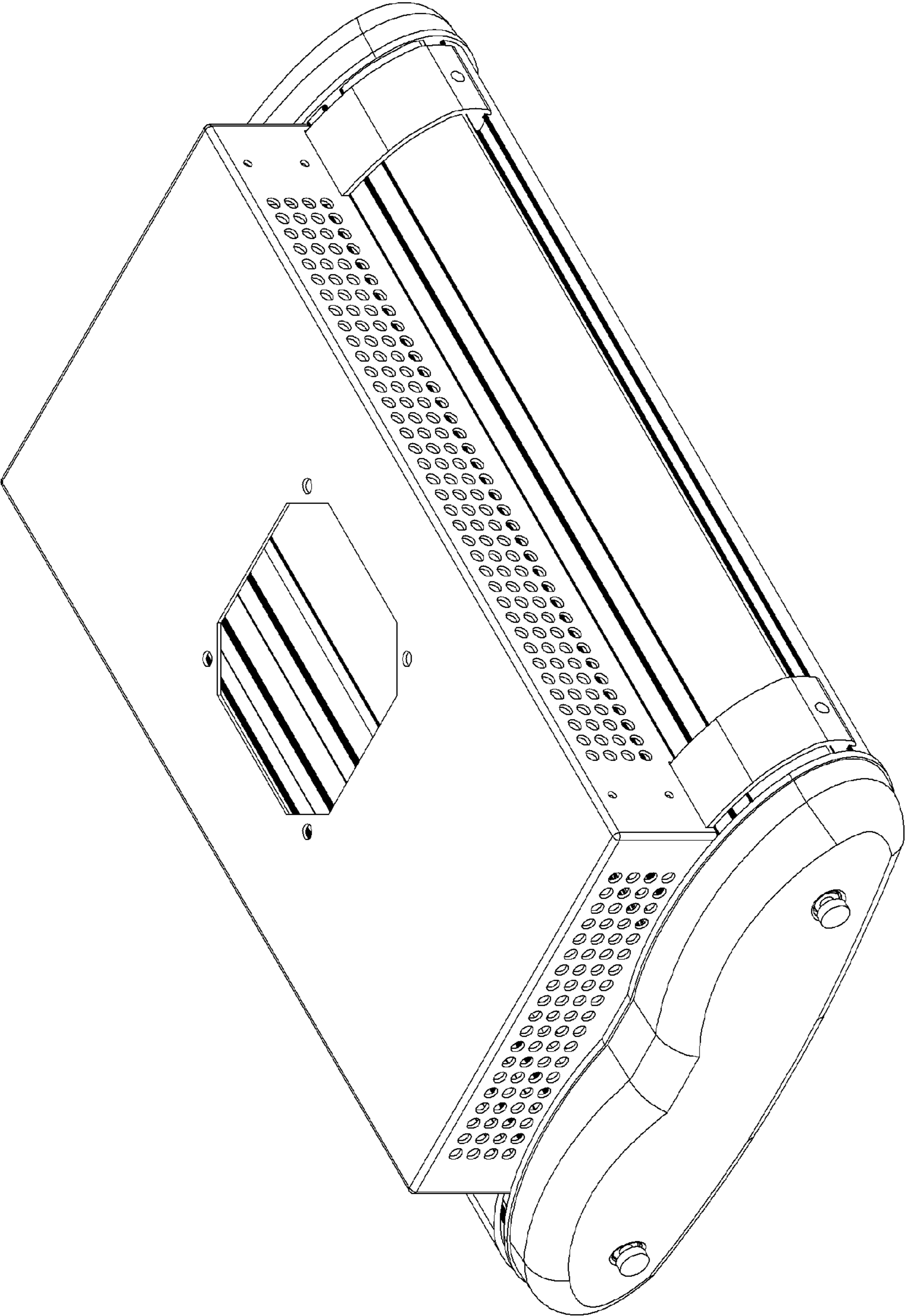

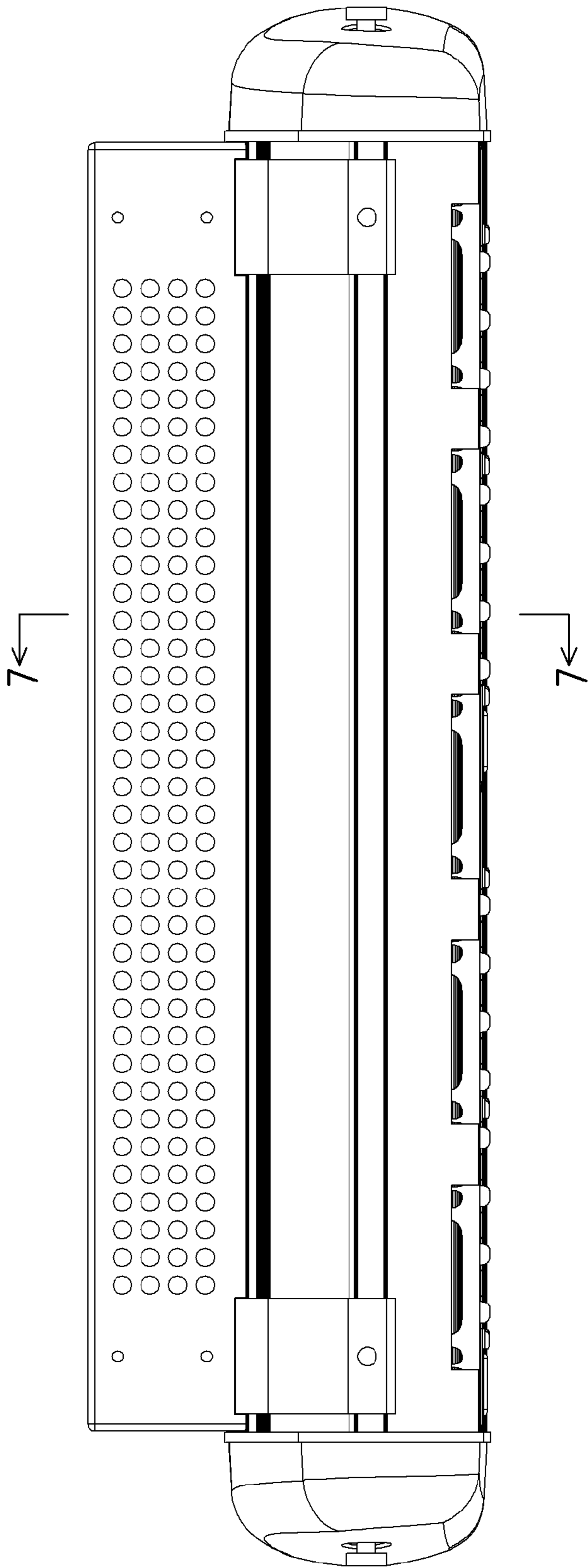

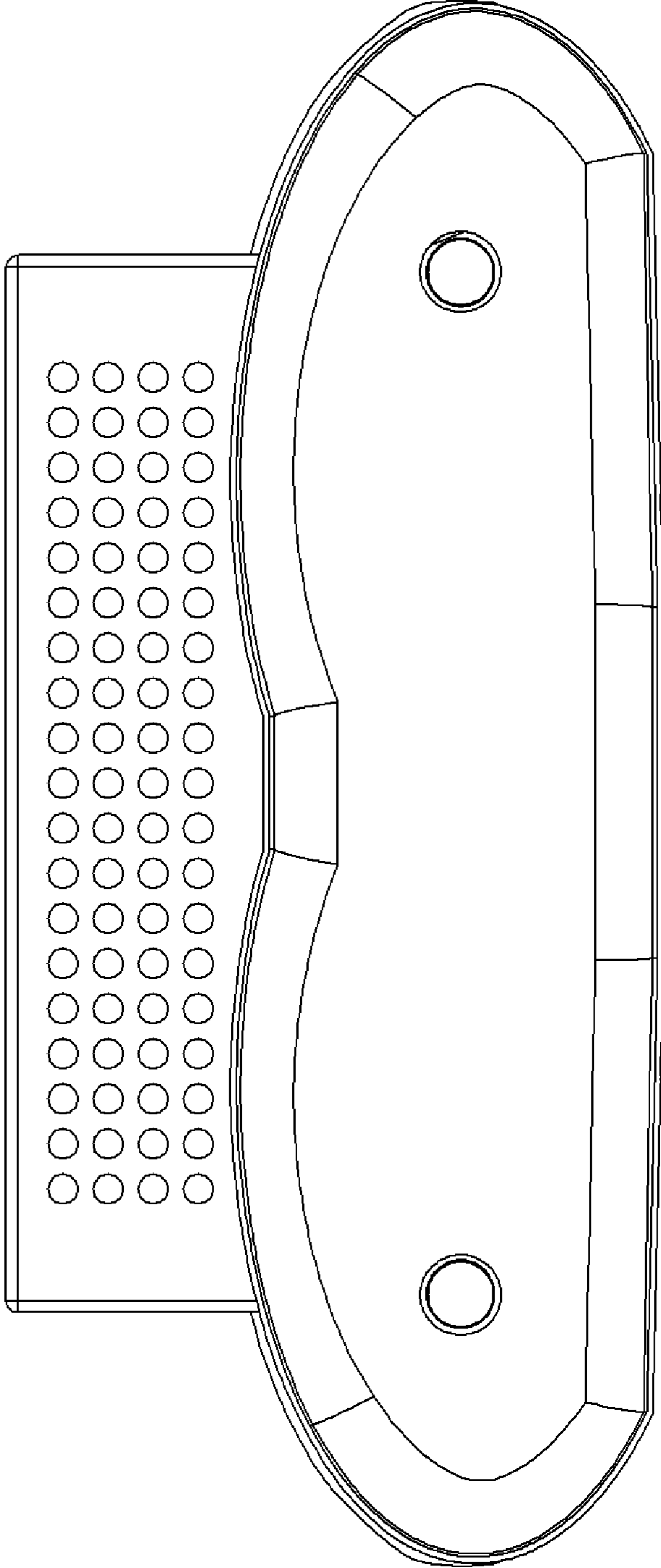

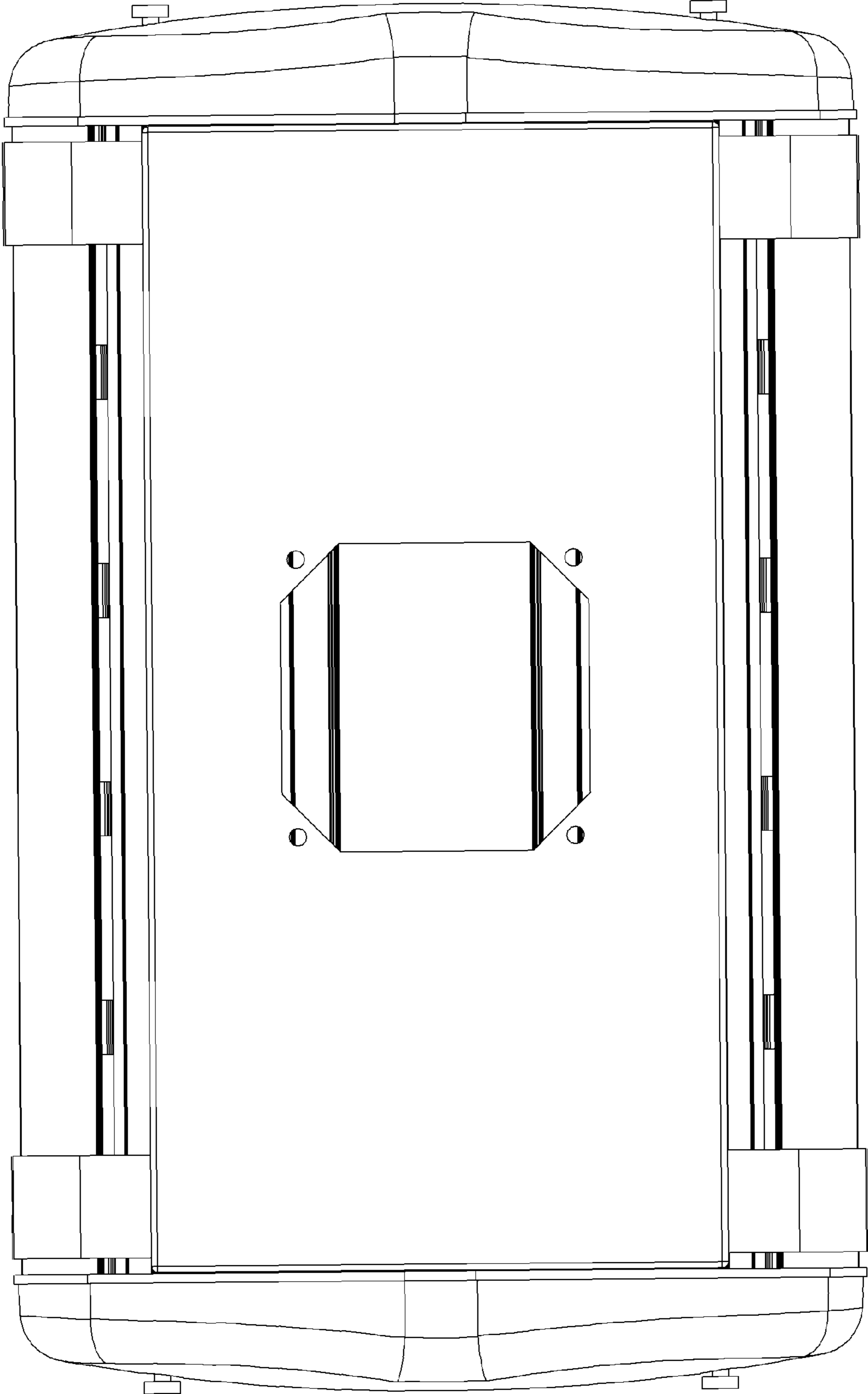

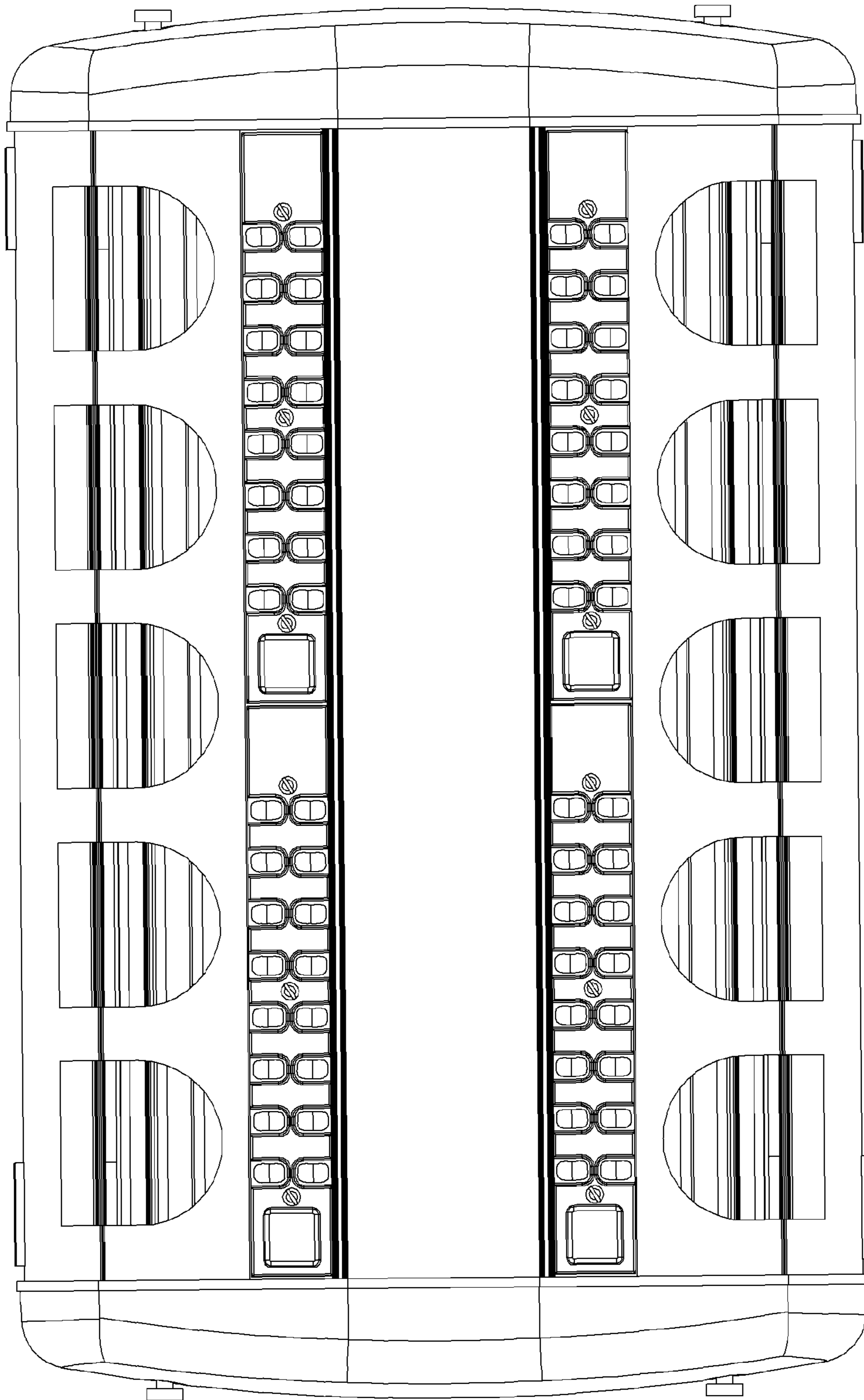

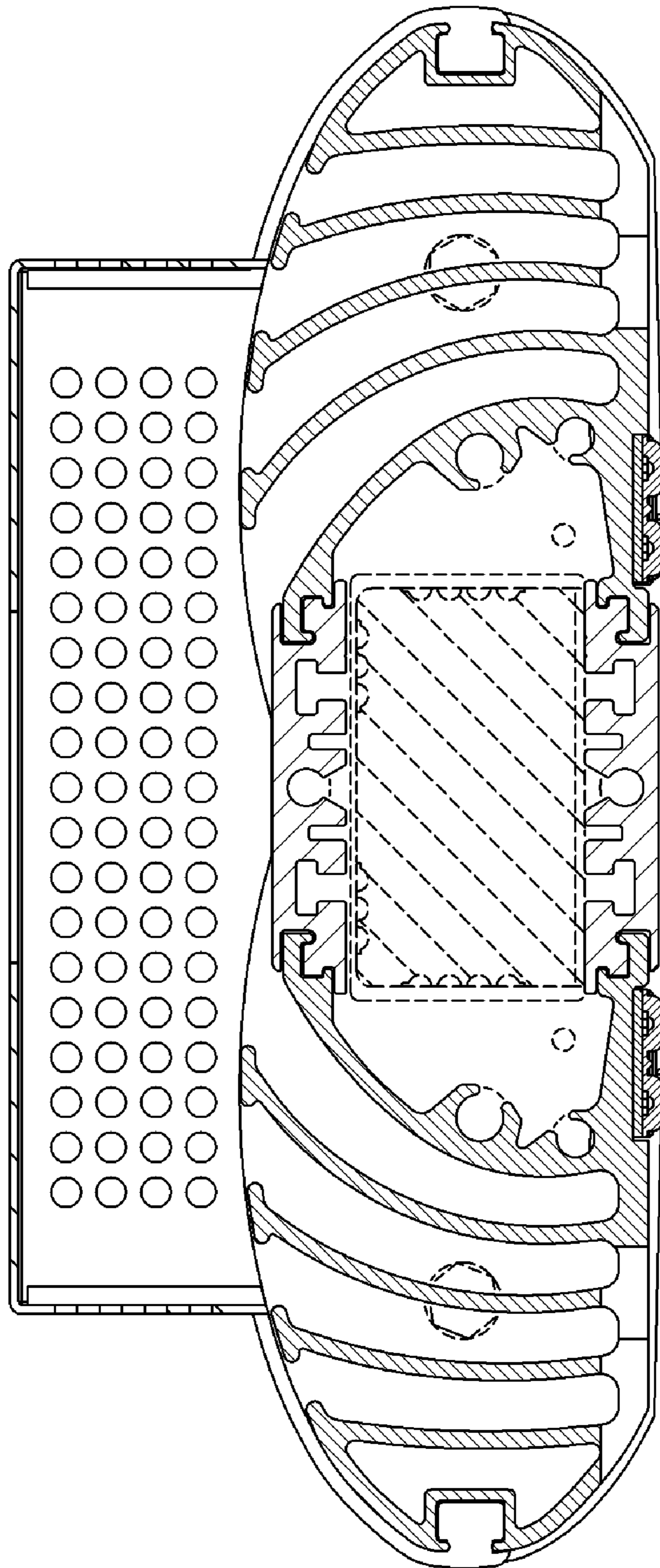
