We claim the ornamental design for an LED lighting, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an LED lighting showing my new design:

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left-side elevation view thereof;

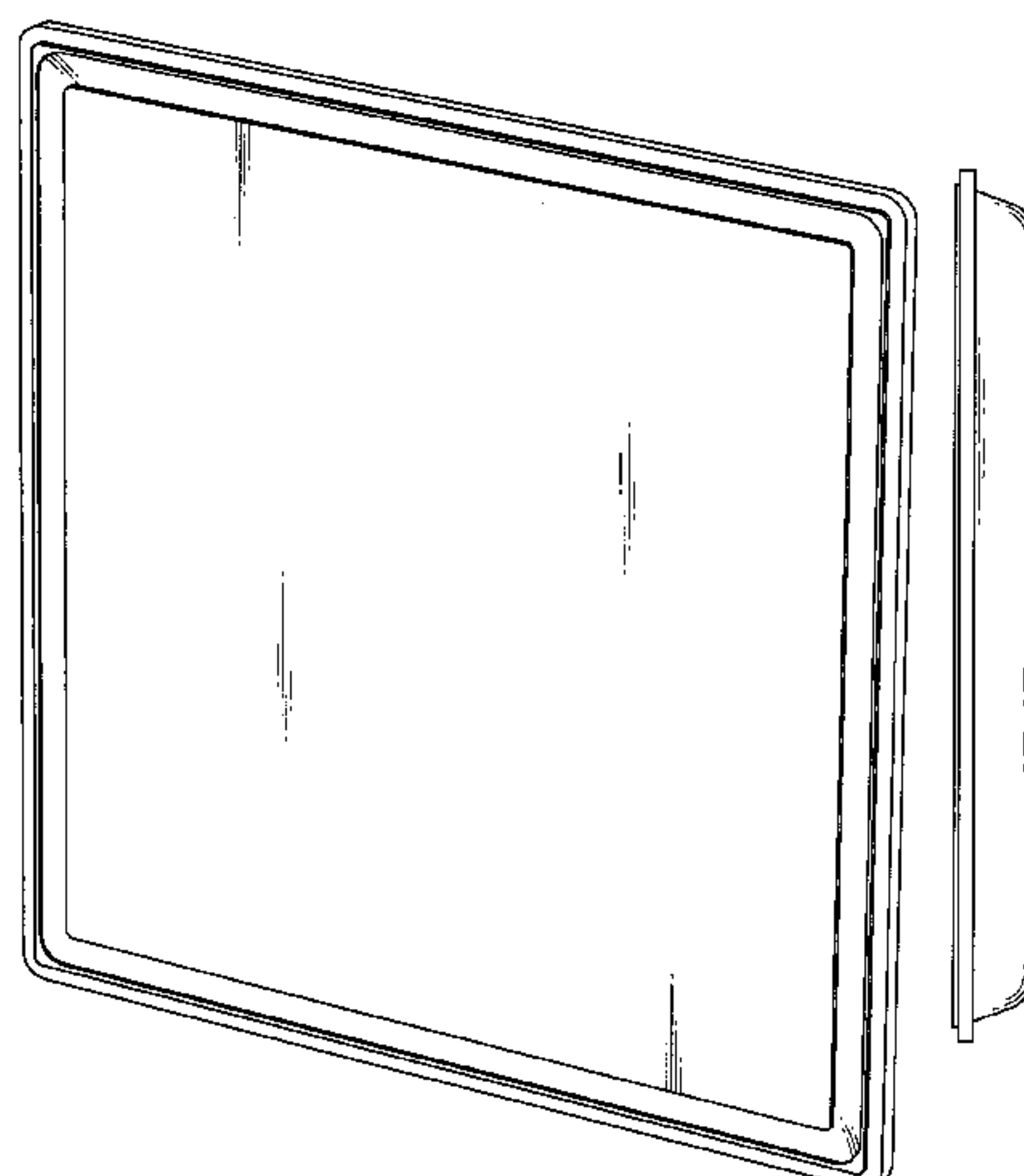
FIG. 5 is a right-side elevation view thereof;

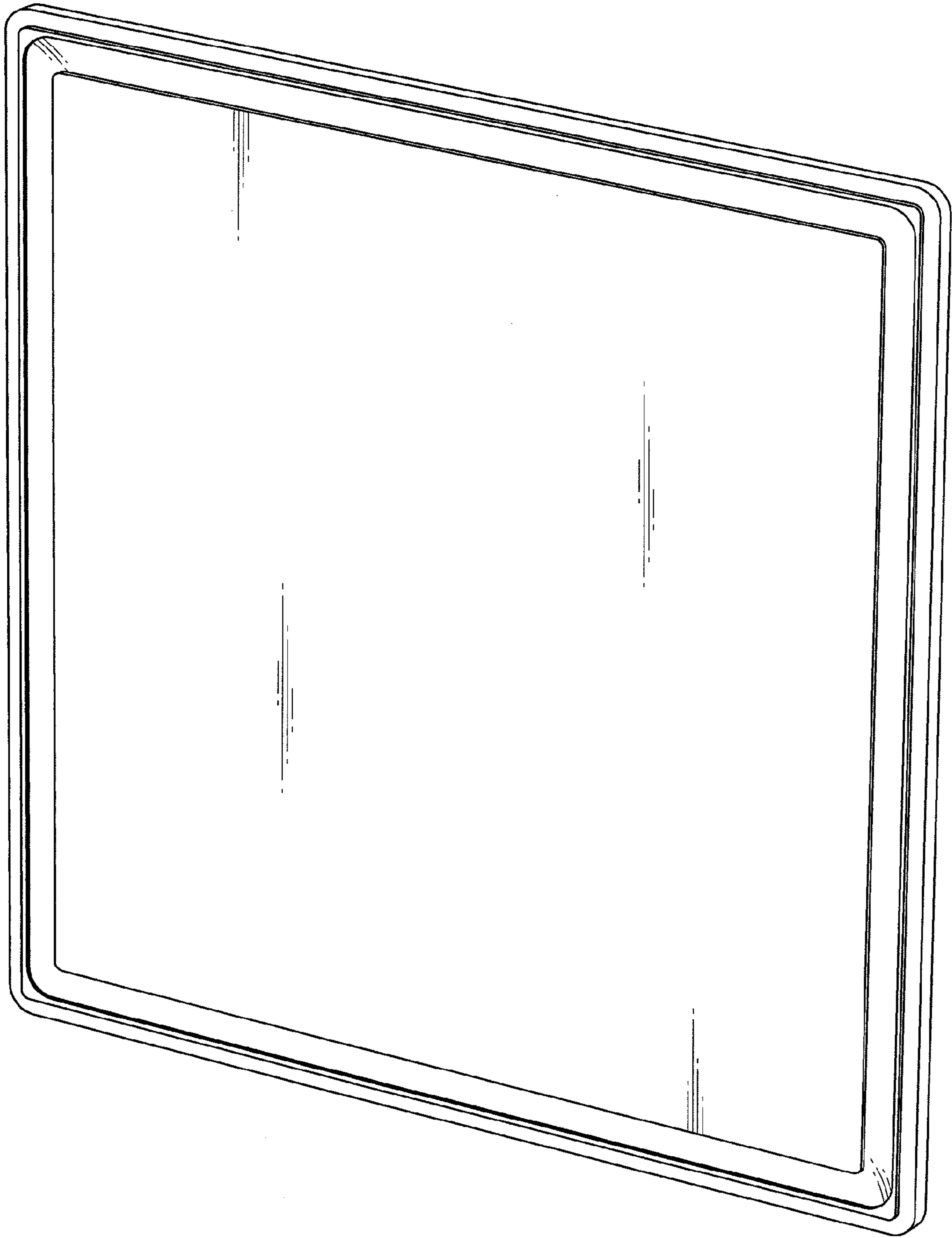

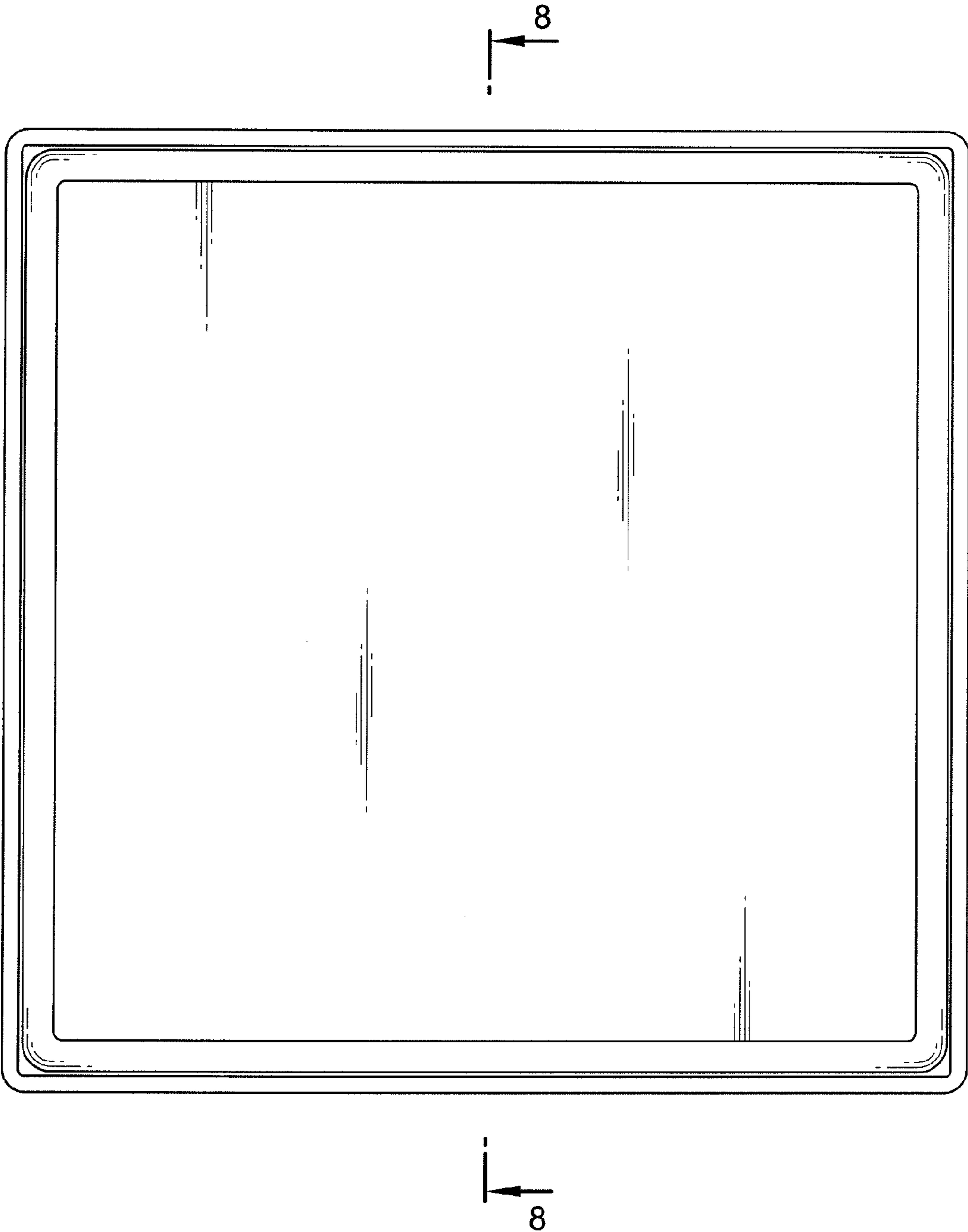

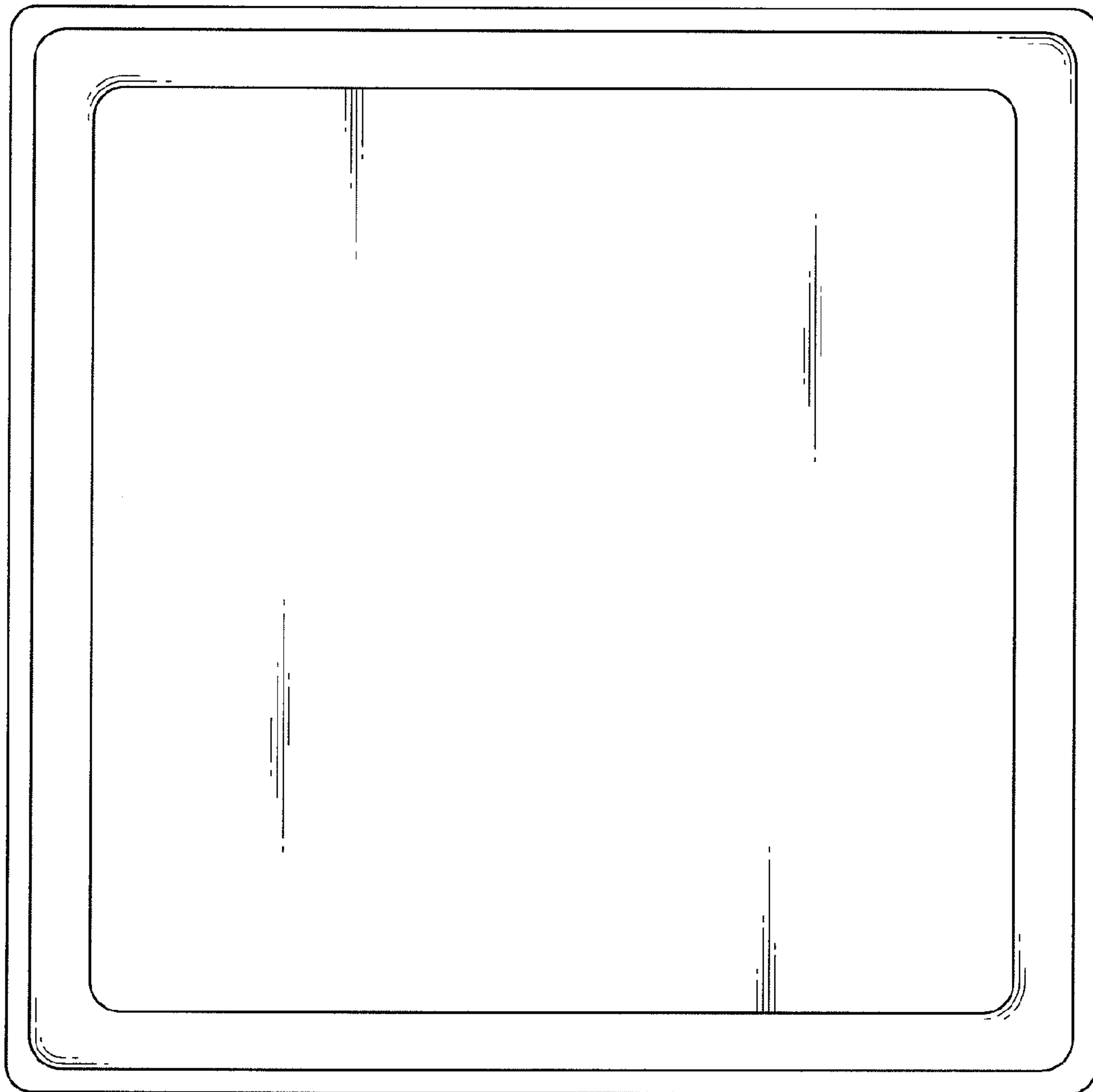

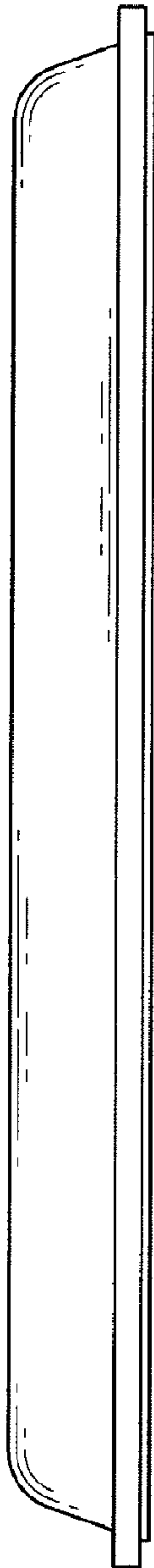

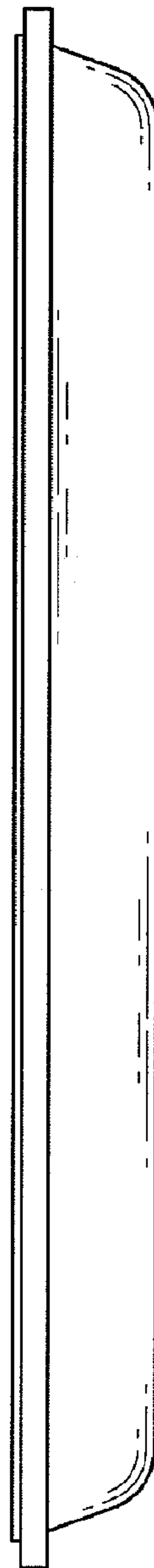

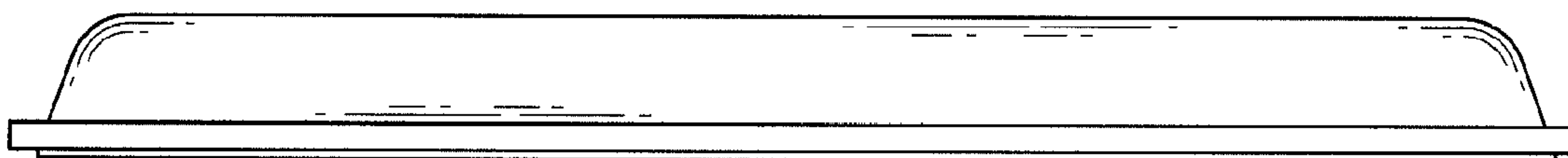

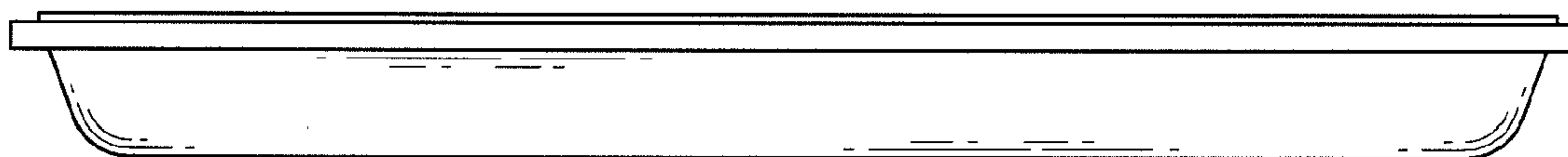

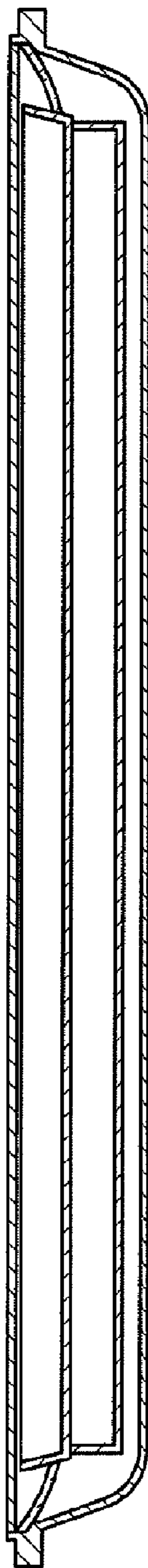
