(57) **CLAIM**

I claim the ornamental design for a toe spreader, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the toe spreader.

FIG. 2 is a bottom plan view of the toe spreader of FIG. 1.

FIG. 3 is a top plan view of the toe spreader of FIG. 1.

FIG. 4 is a front elevation view of the toe spreader of FIG. 1.

FIG. 5 is a rear elevation view of the toe spreader of FIG. 1.

FIG. 6 is a right side view of the toe spreader of FIG. 1; and,

FIG. 7 is a left side view of the toe spreader of FIG. 1.

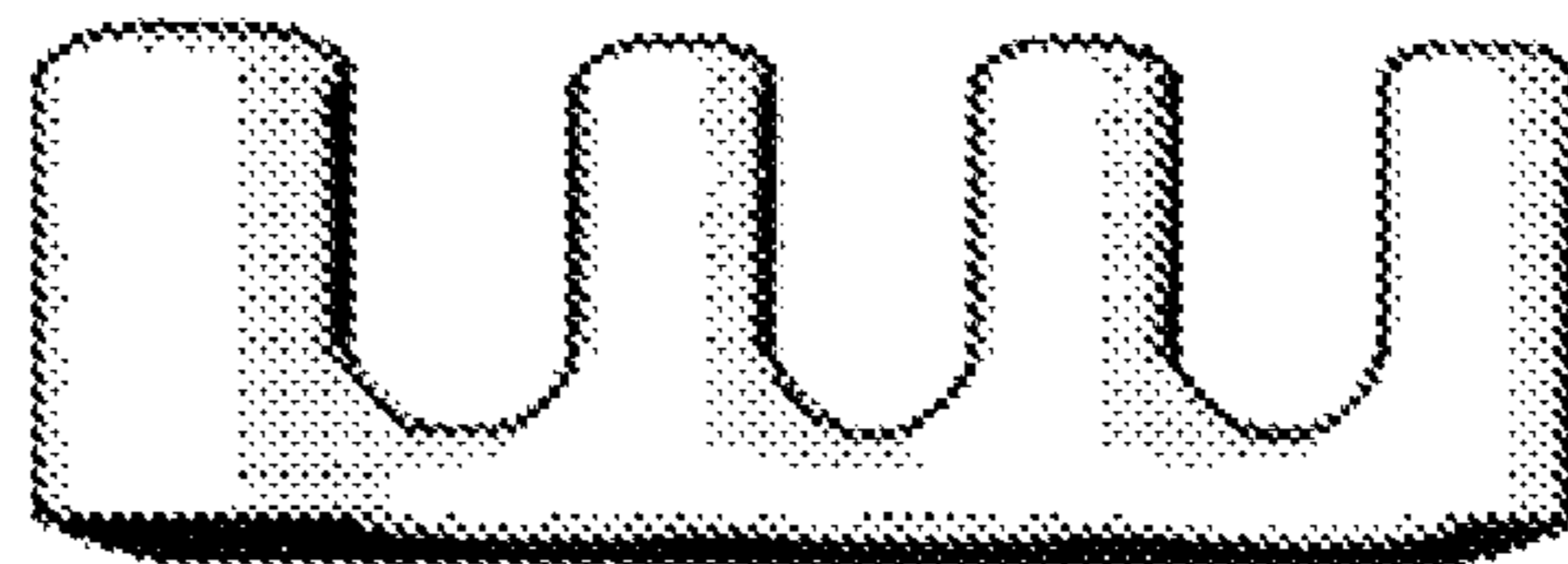
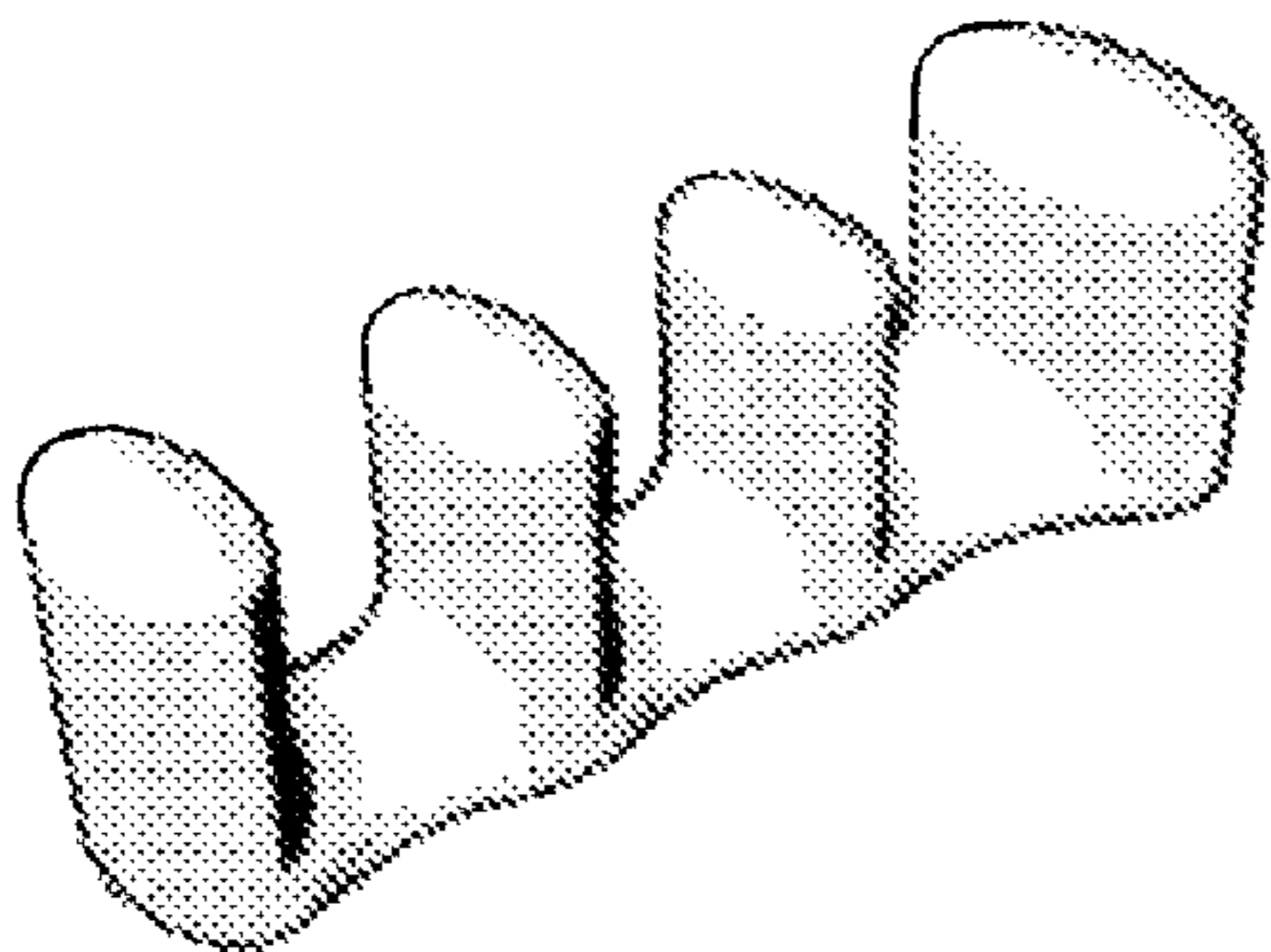

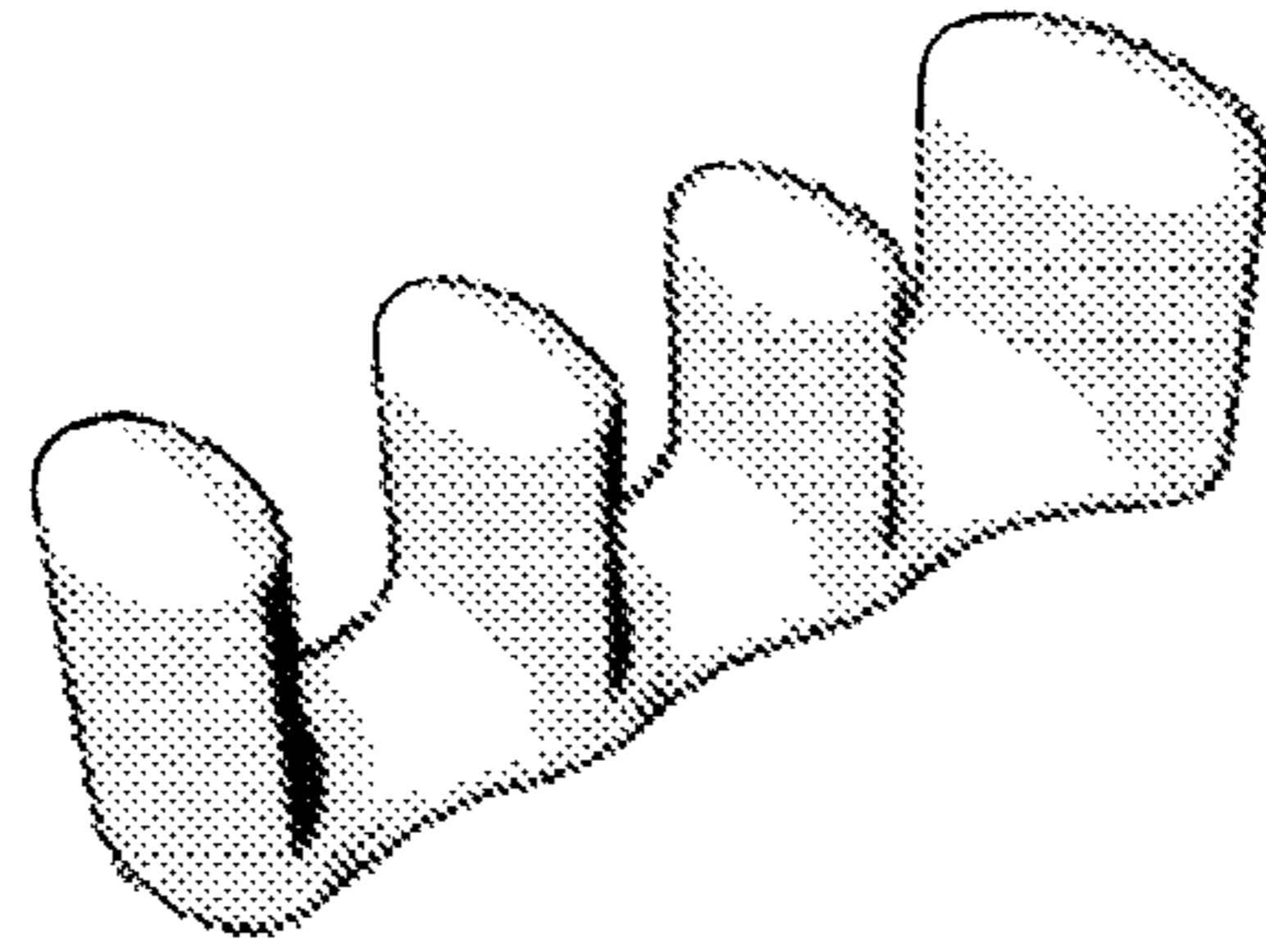

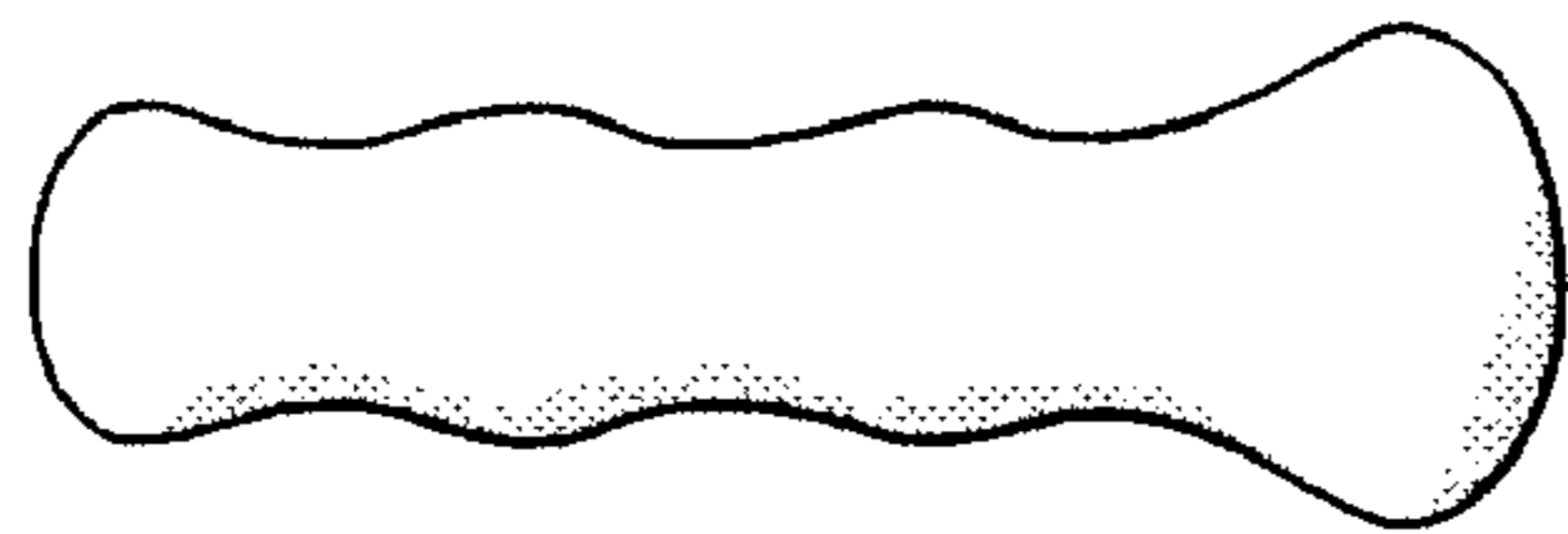

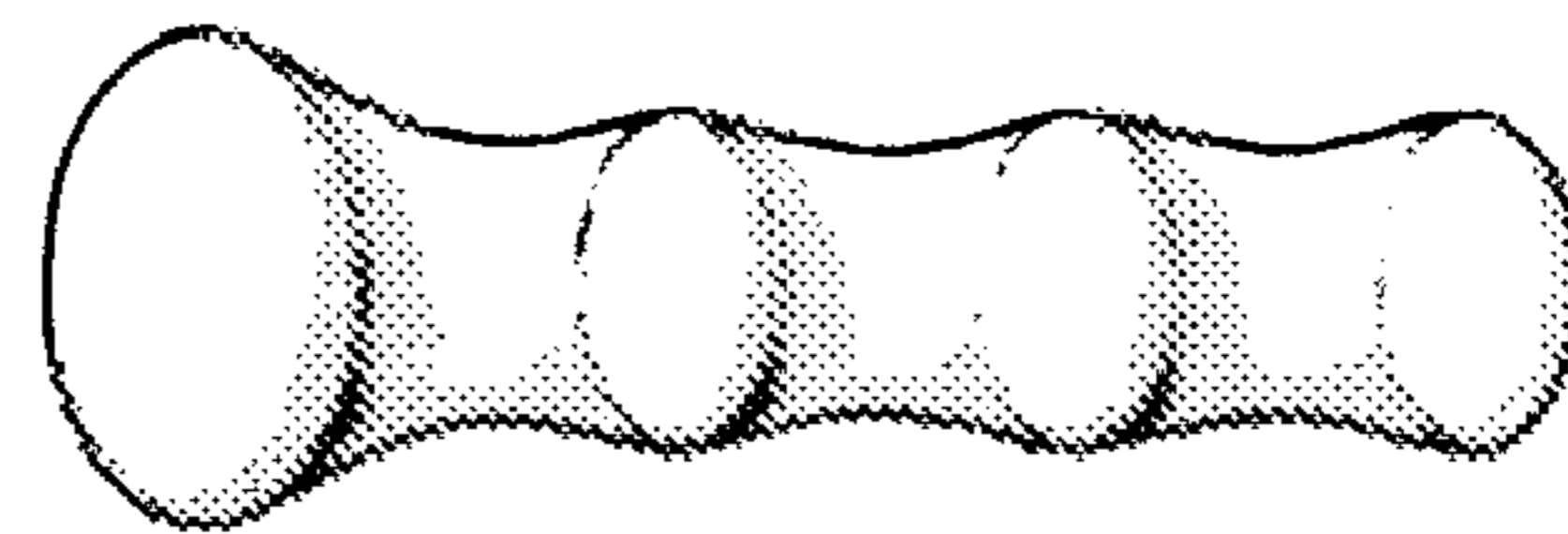

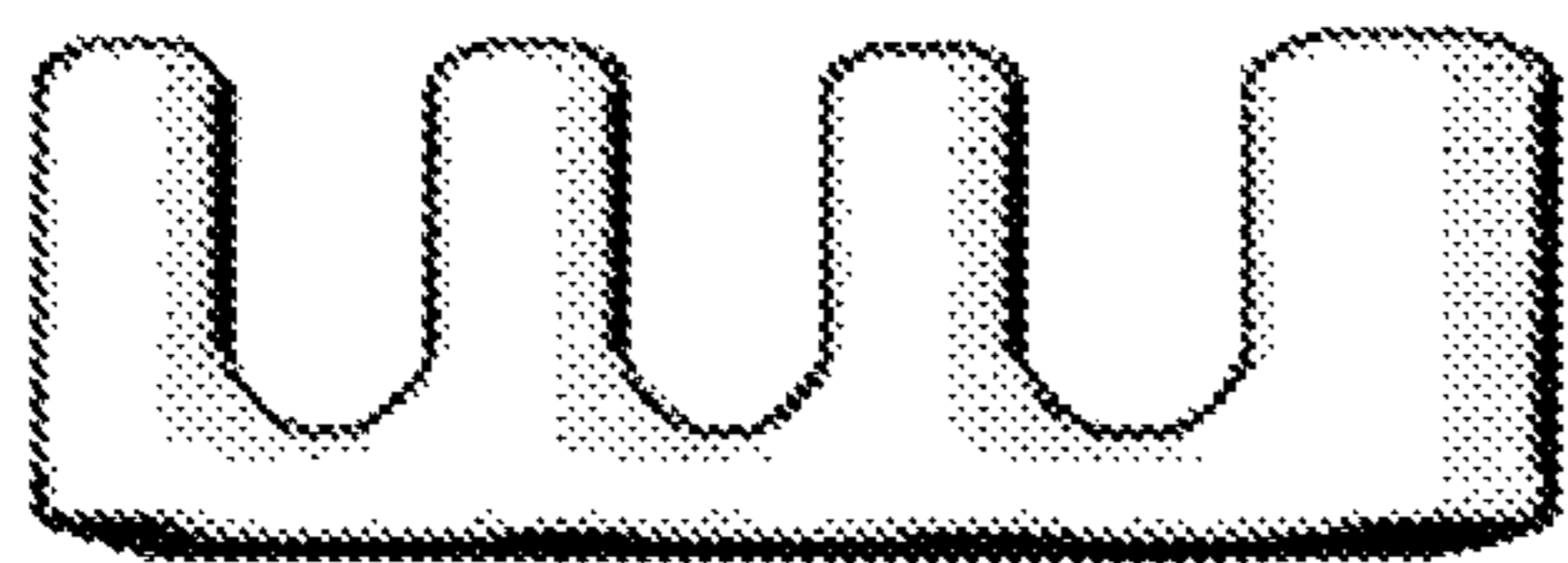

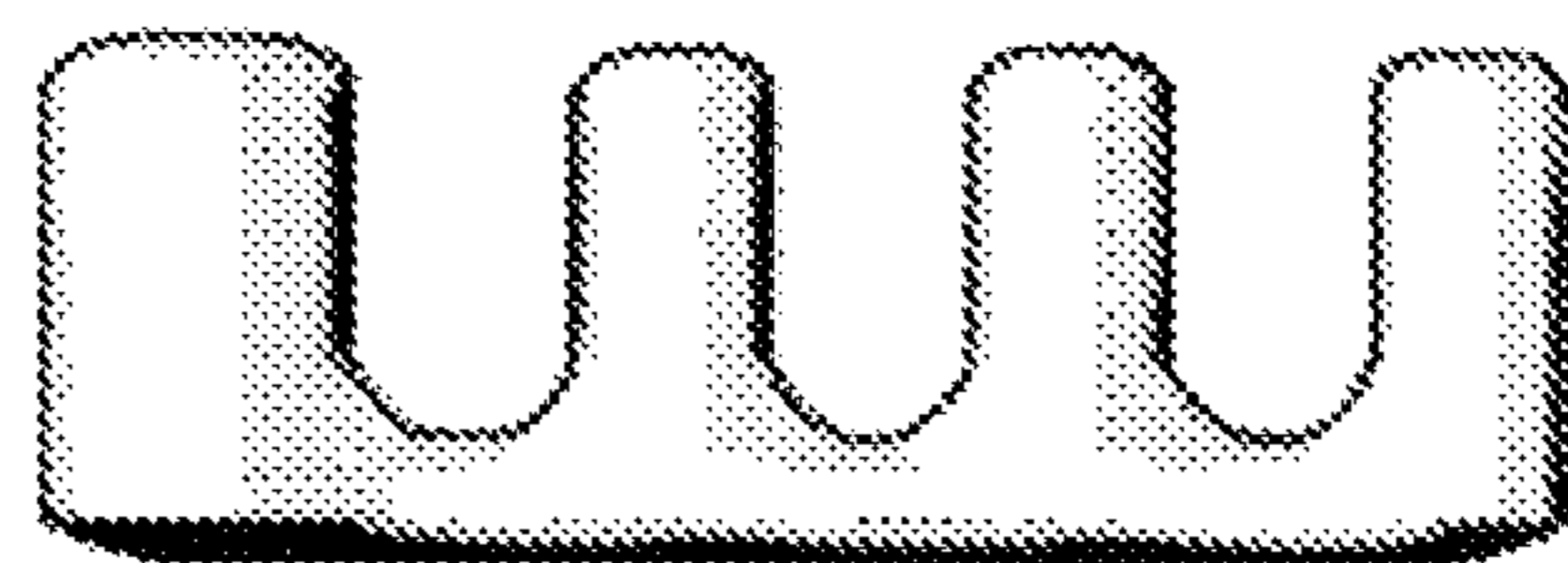

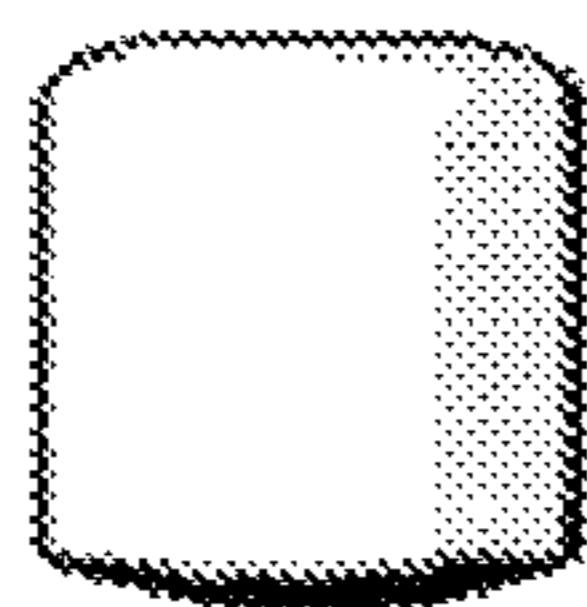
