**DESCRIPTION**

FIG. 1 is a perspective view of a lipstick container of the present invention;

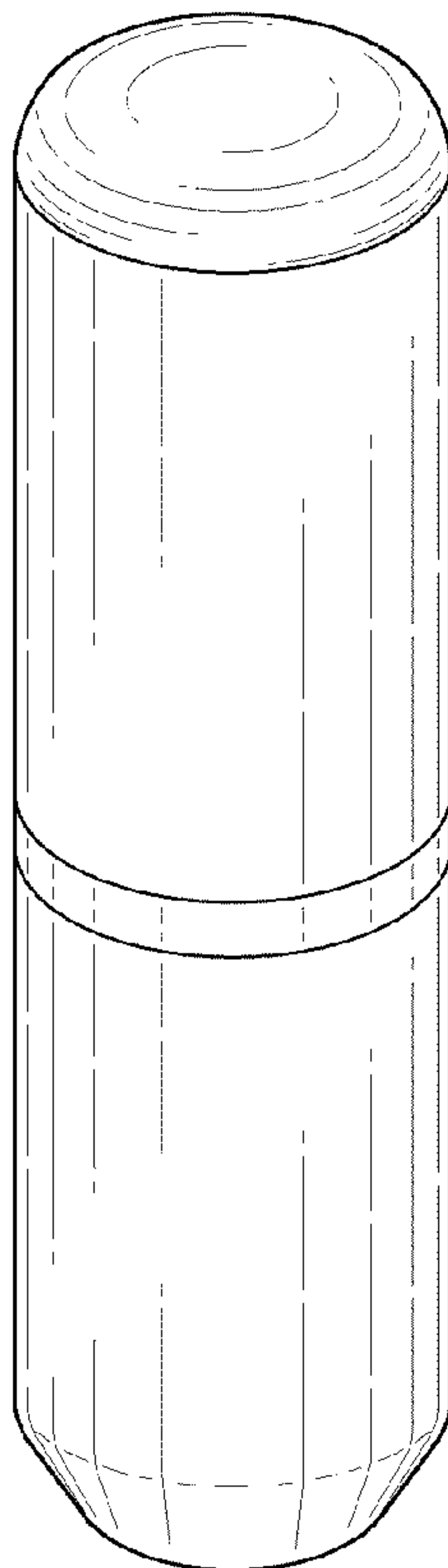
FIG. 2 is a front elevation view of the lipstick container shown in FIG. 1, the rear elevation being identical thereto;

FIG. 3 is a left side elevation view of the lipstick container shown in FIG. 1, the right side elevation being identical thereto;

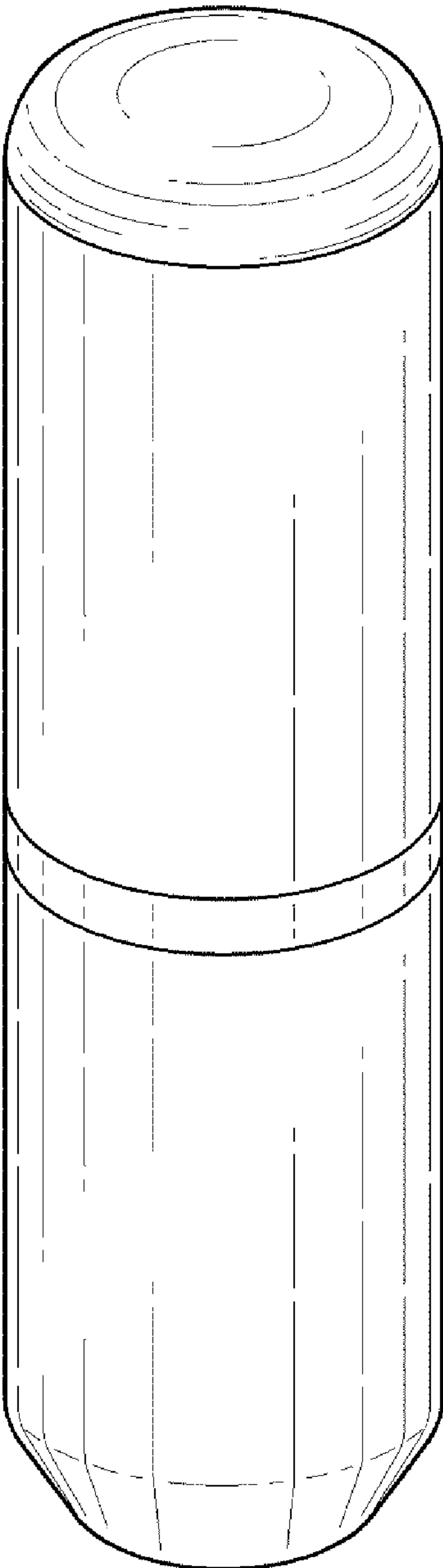
FIG. 4 is a top plan view of the lipstick container shown in FIG. 1; and,

FIG. 5 is a bottom plan view of the lipstick container shown in FIG. 1.

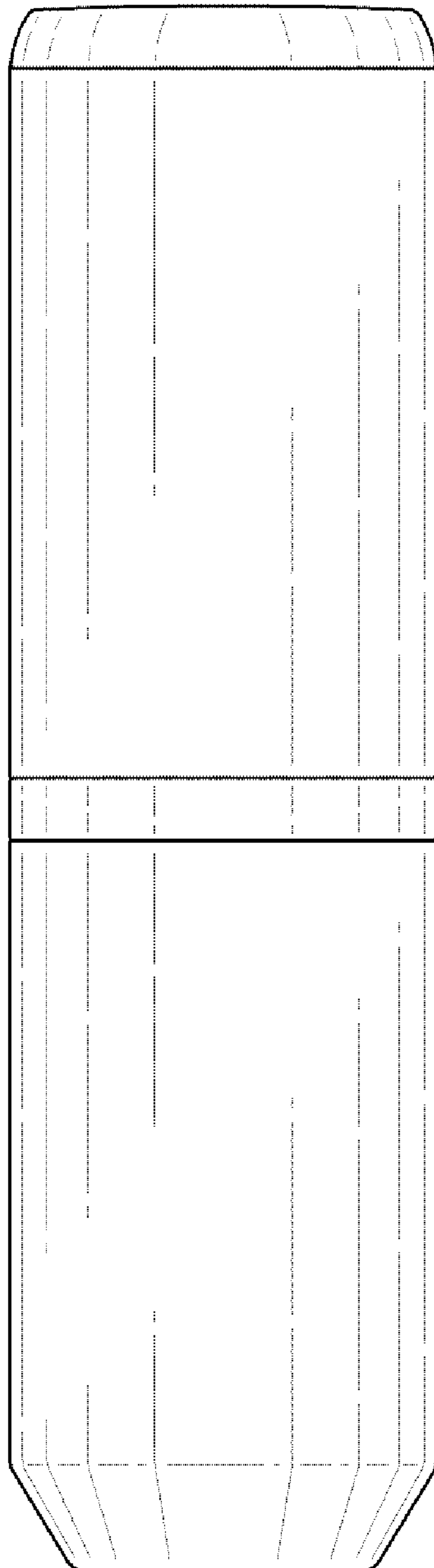

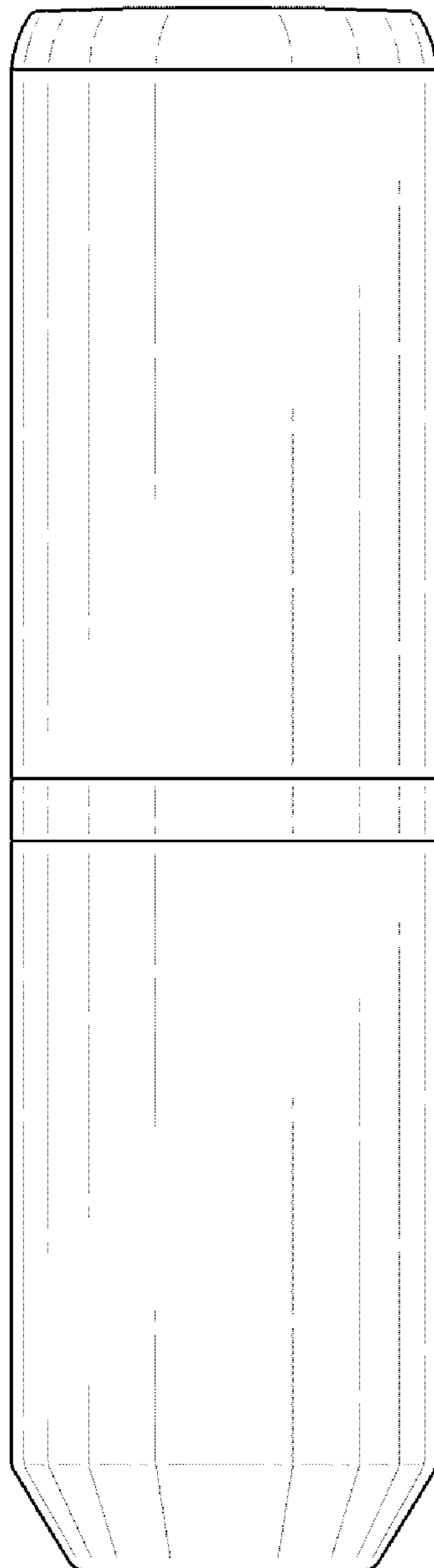

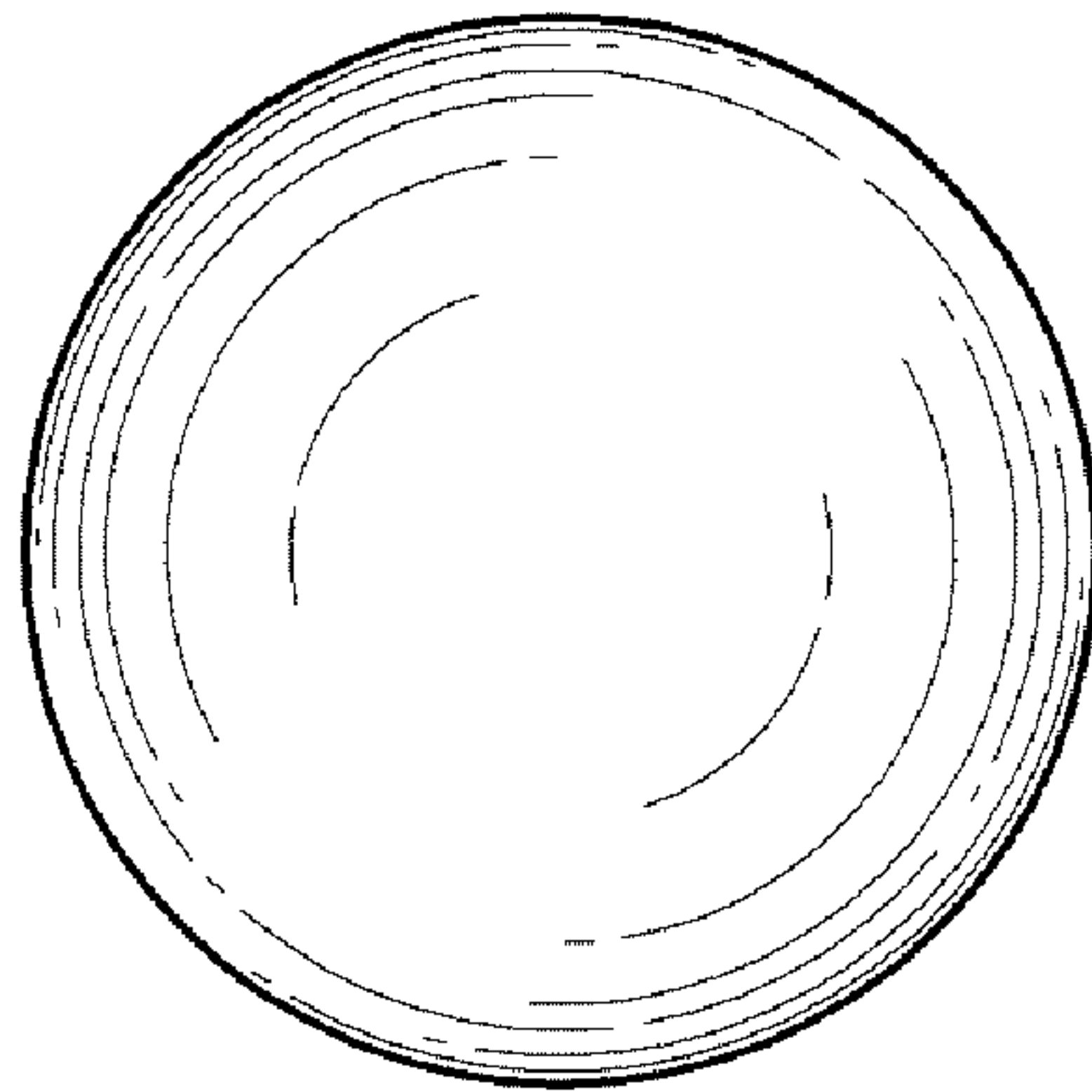
