The ornamental design for a garment, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a front elevation view of Embodiment 1, of a garment;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a right elevation view thereof;

FIG. 4 is a left elevation view thereof;

FIG. 5 is a right side elevation view of Embodiment 2, of a garment, where the front and rear elevation views are the same as FIGS. 1-2;

FIG. 6 is a left elevation view of Embodiment 2, of a garment.

FIG. 7 is a front elevation view of Embodiment 3, of a garment;

FIG. 8 is a rear elevation view thereof;

FIG. 9 is a right elevation view thereof;

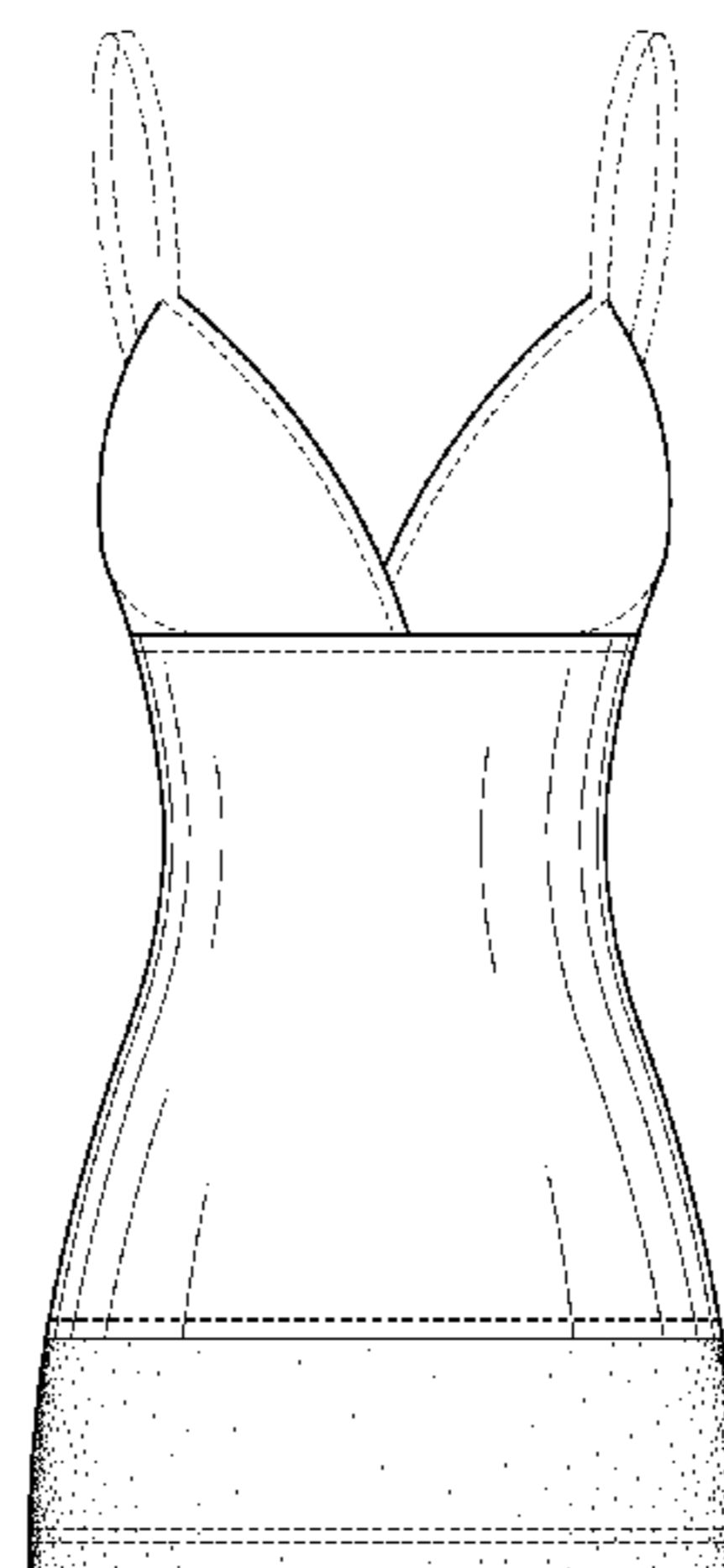
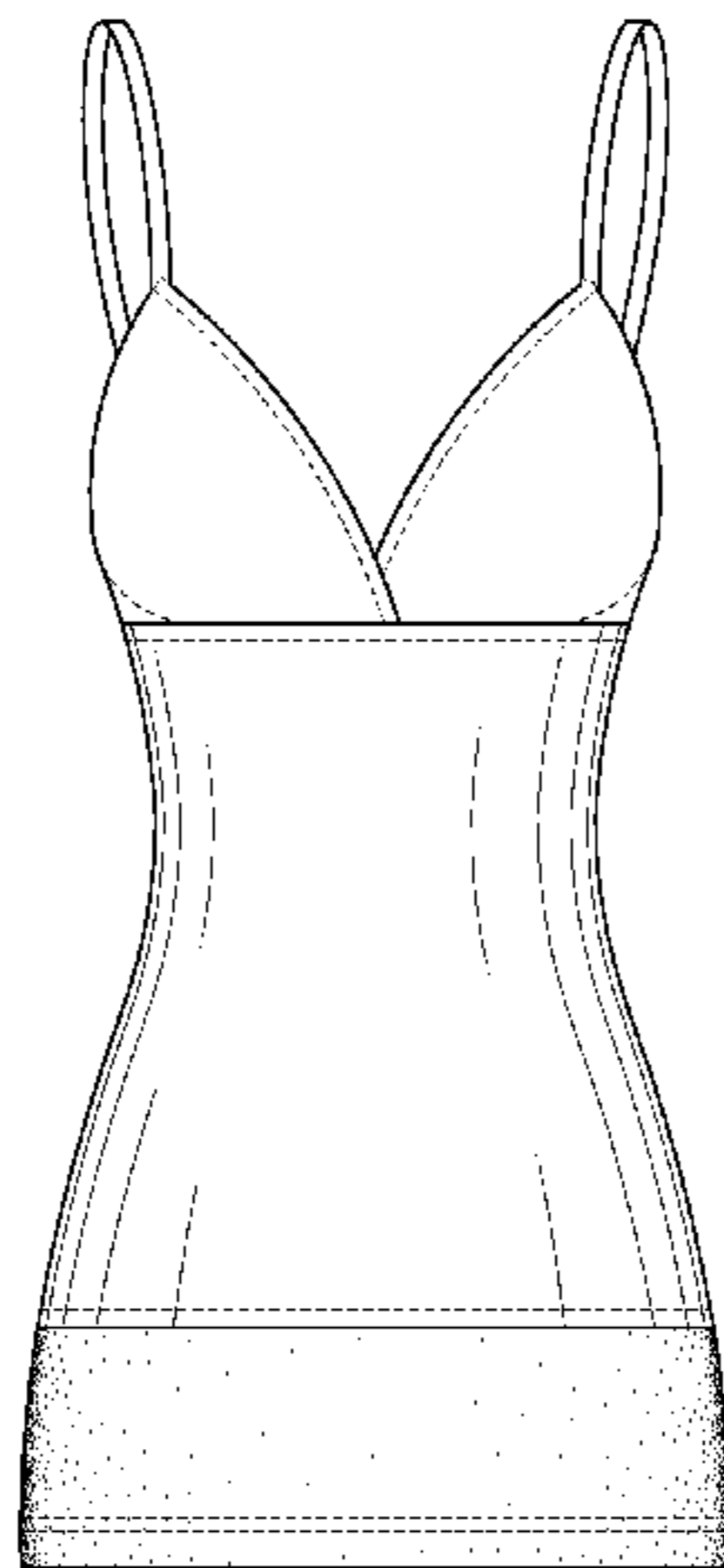
FIG. 10 is a left elevation view thereof;

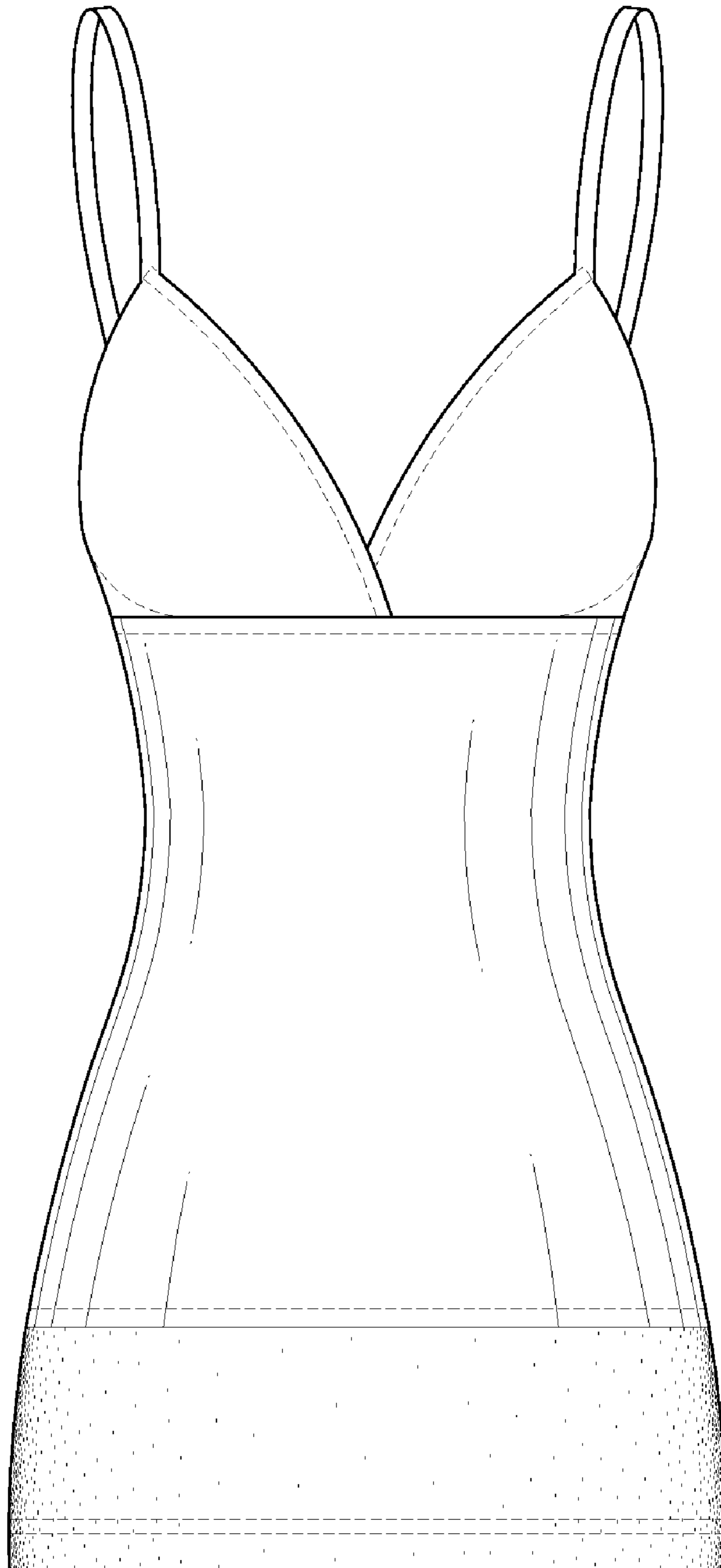

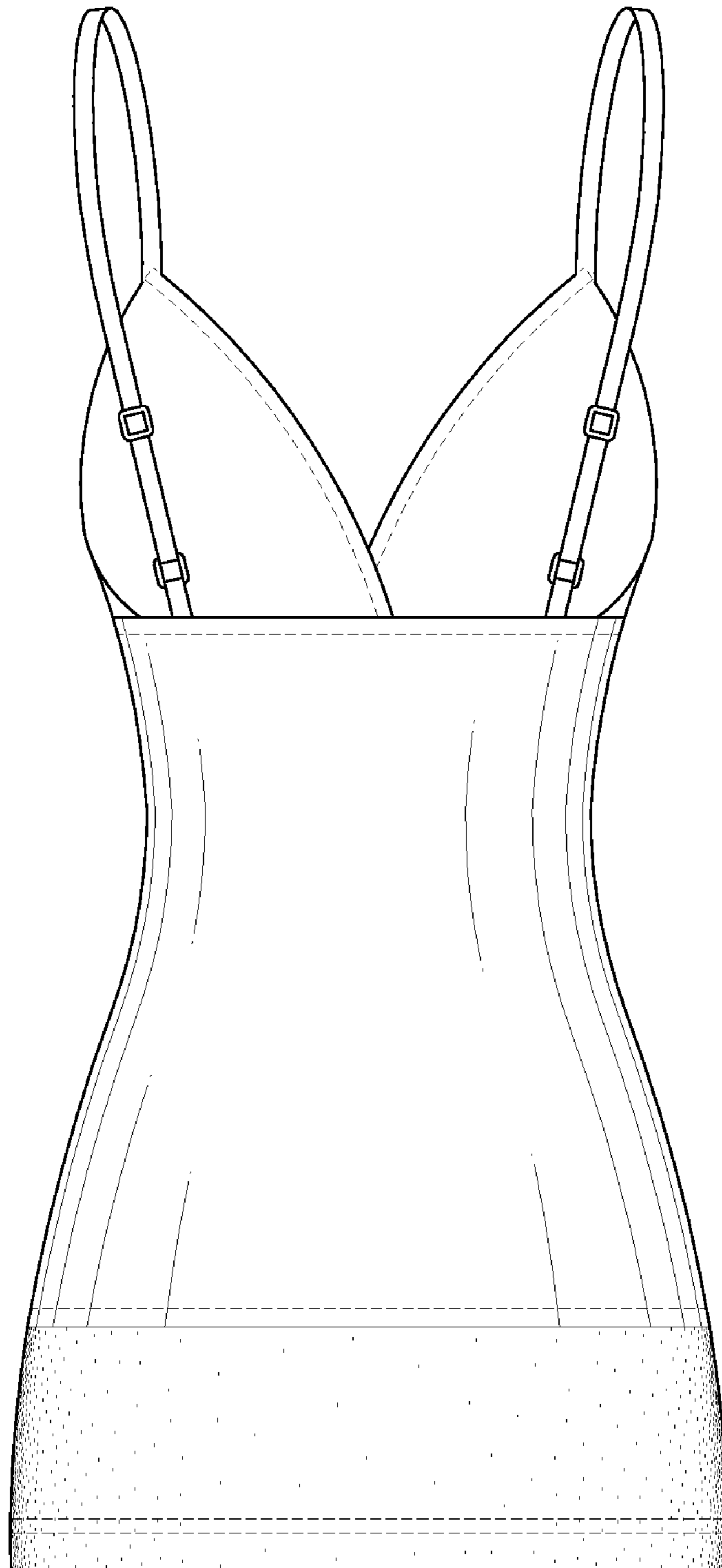

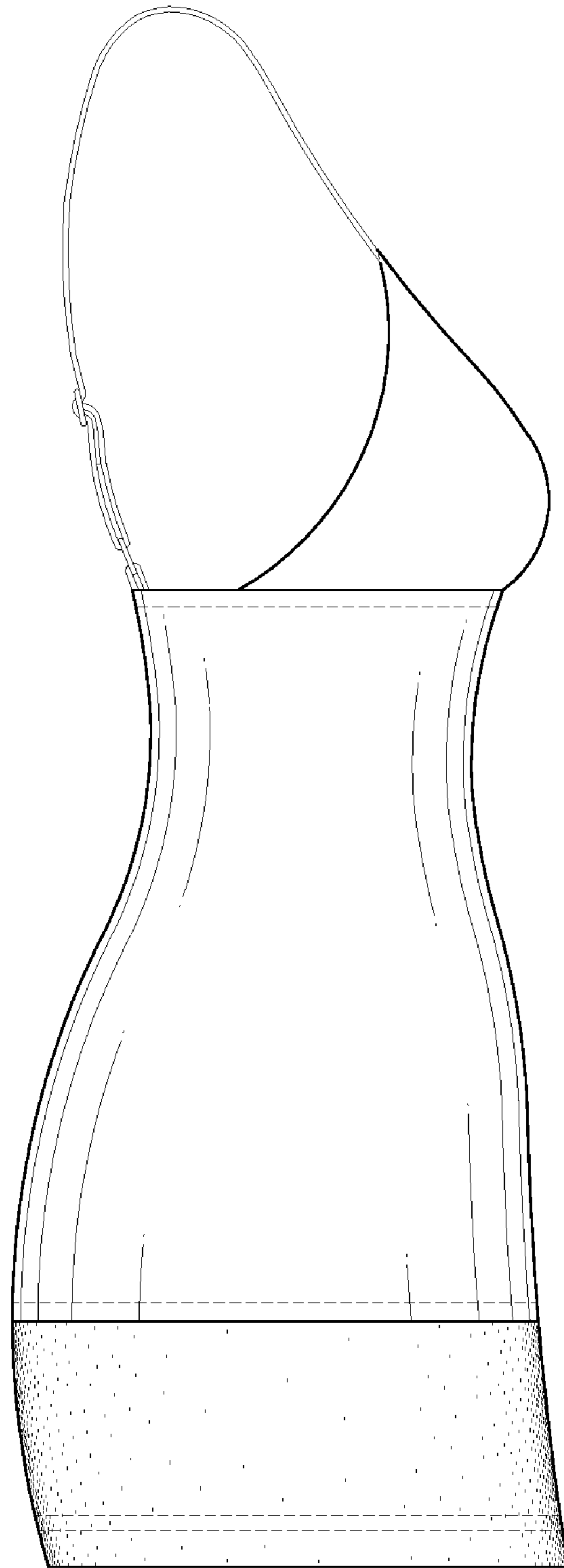

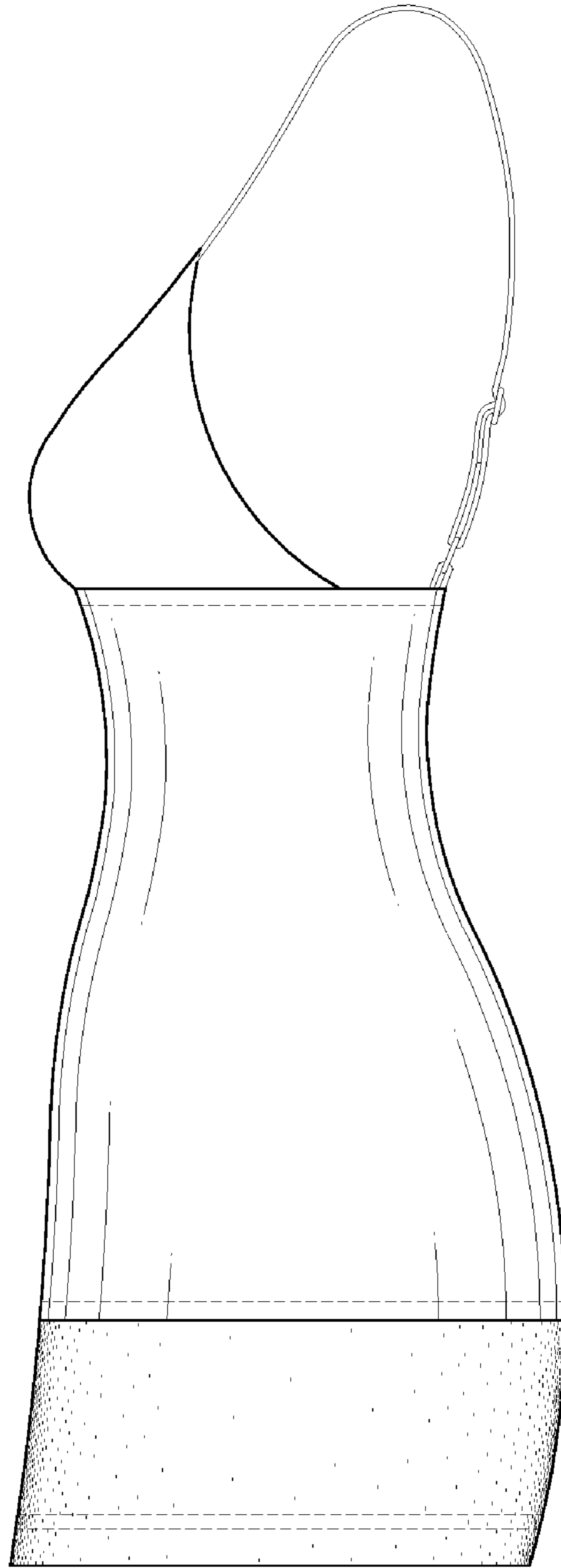

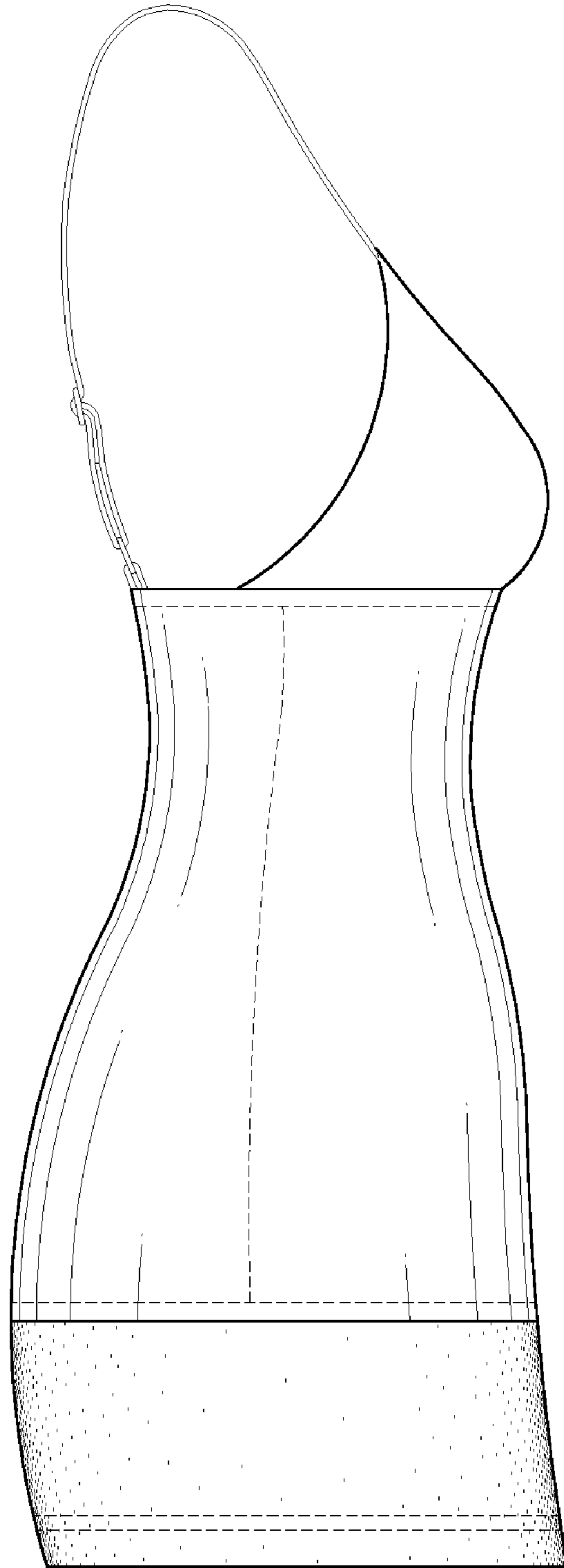

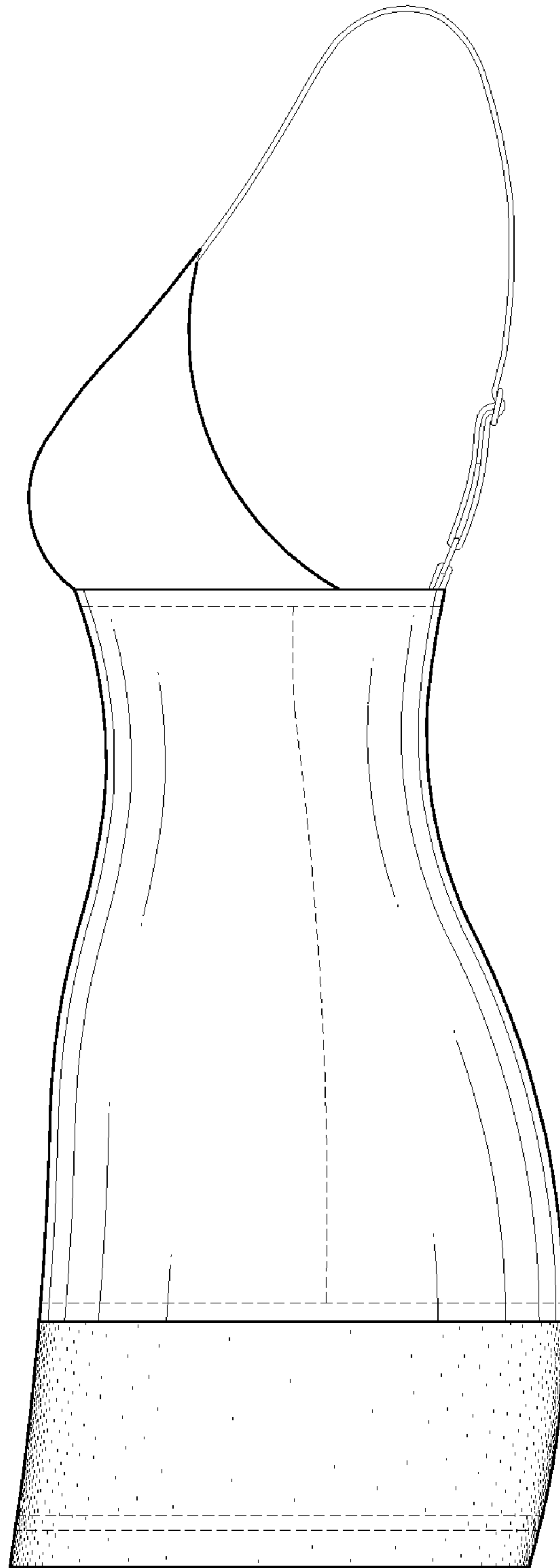

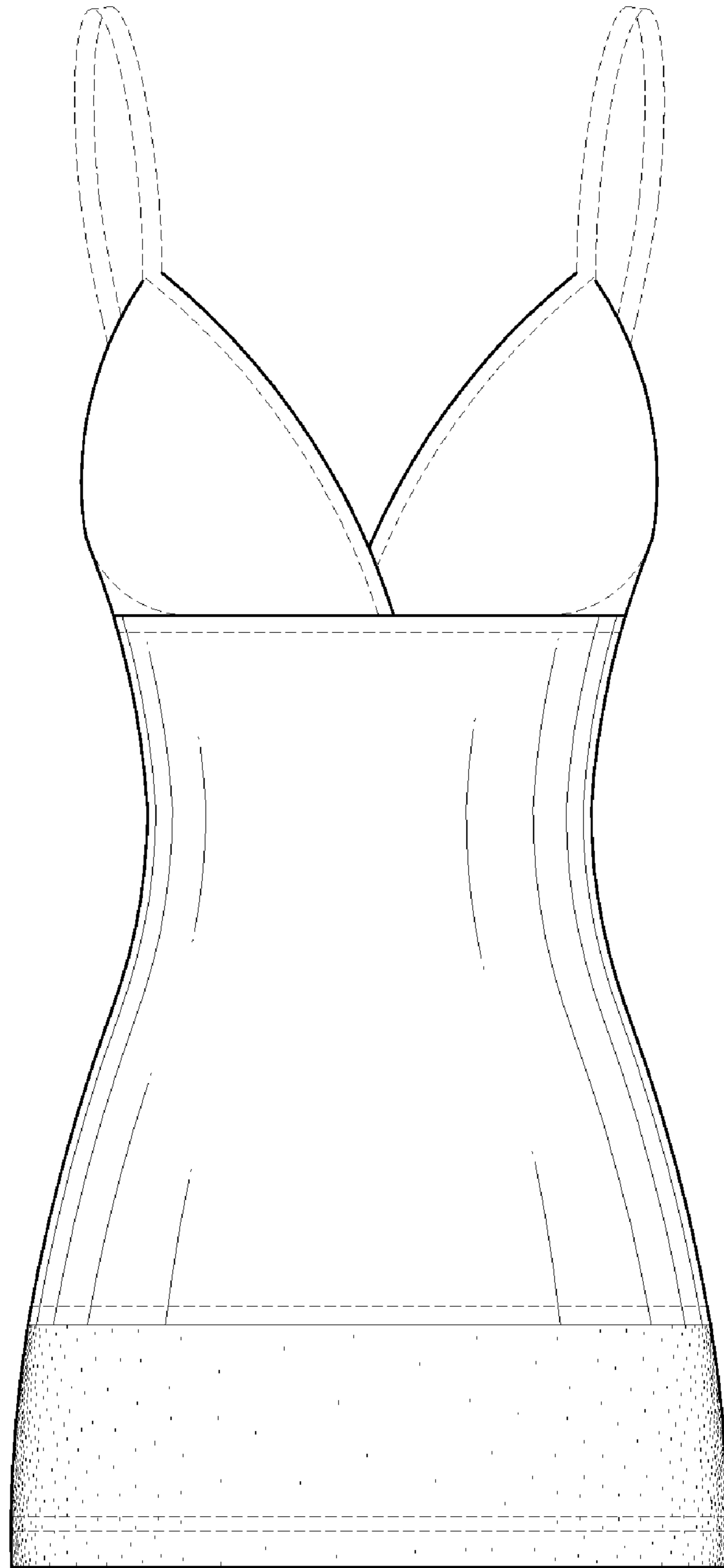

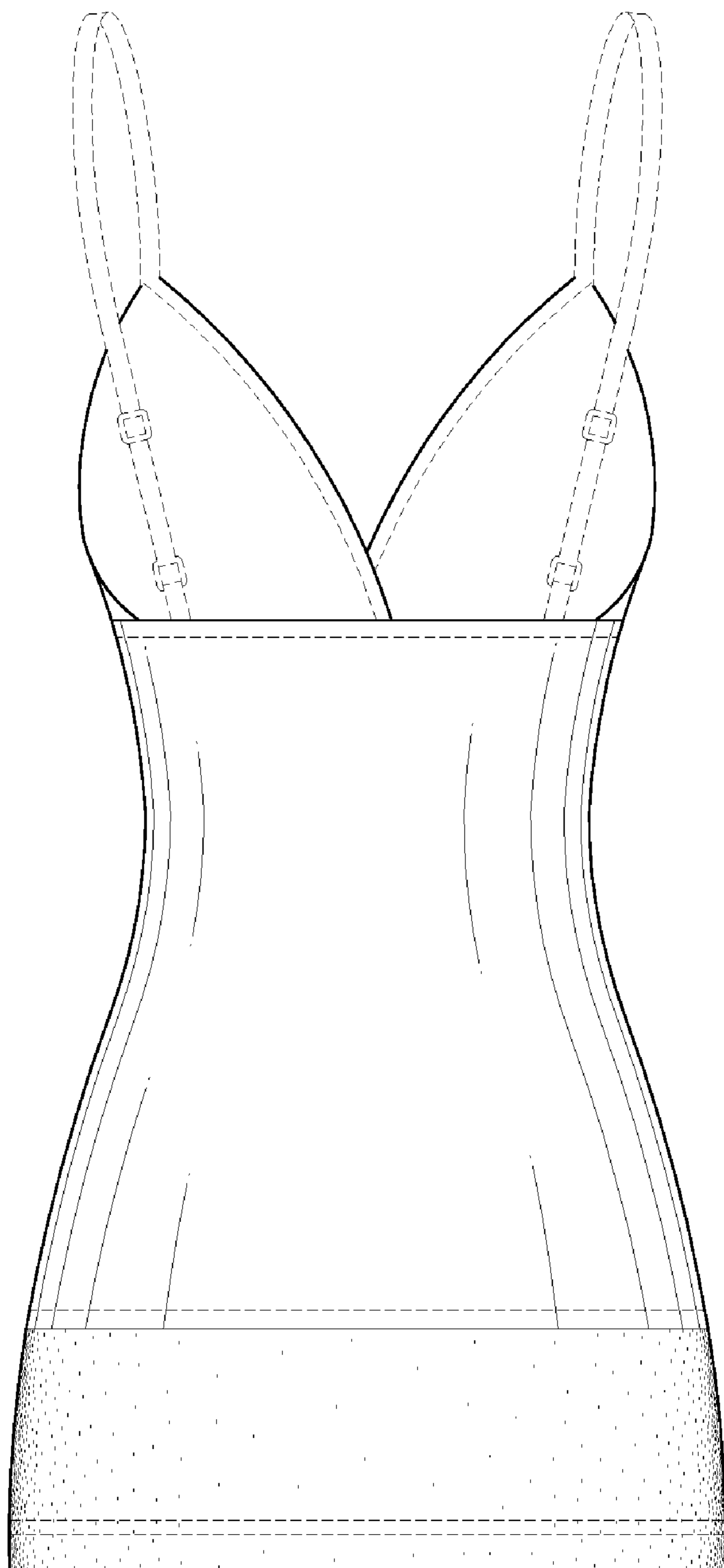

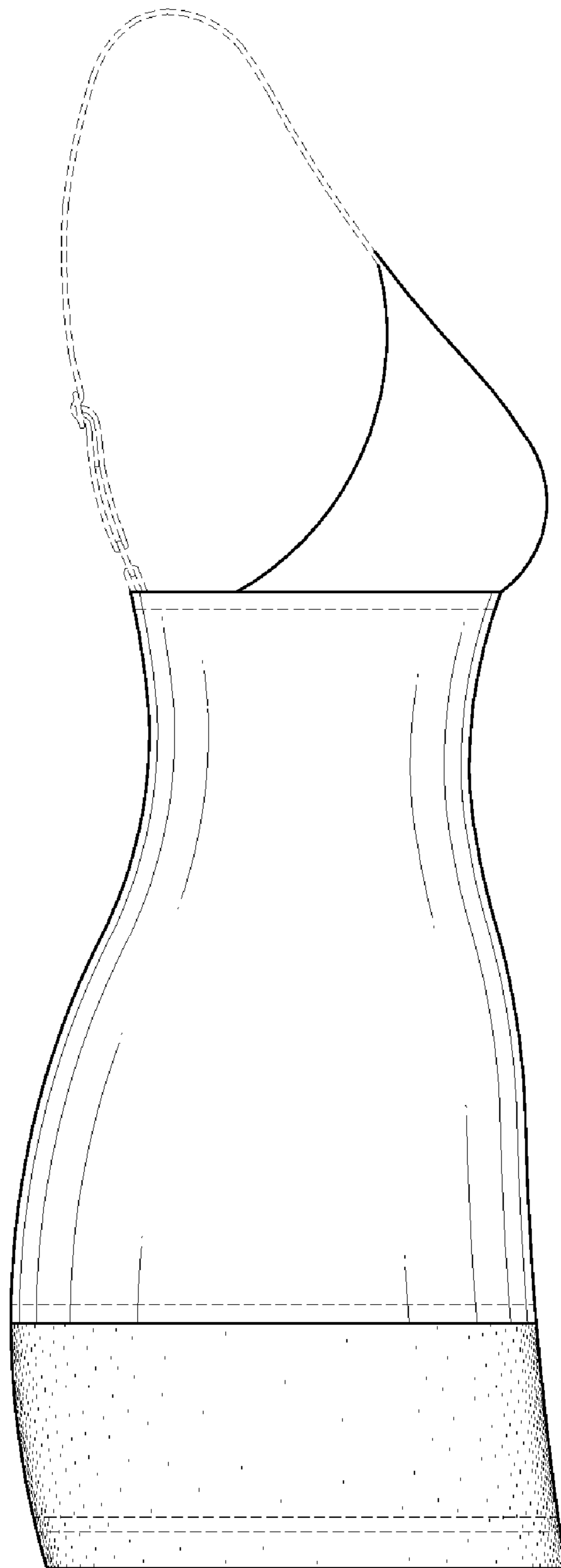

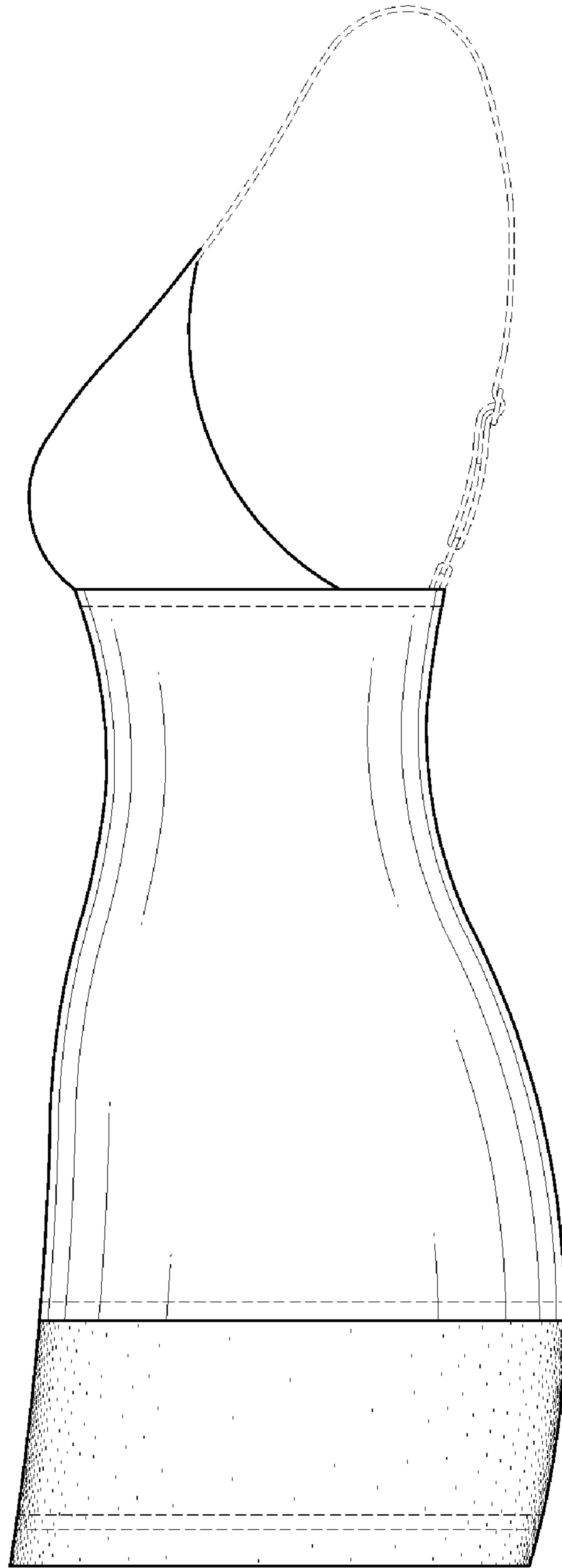

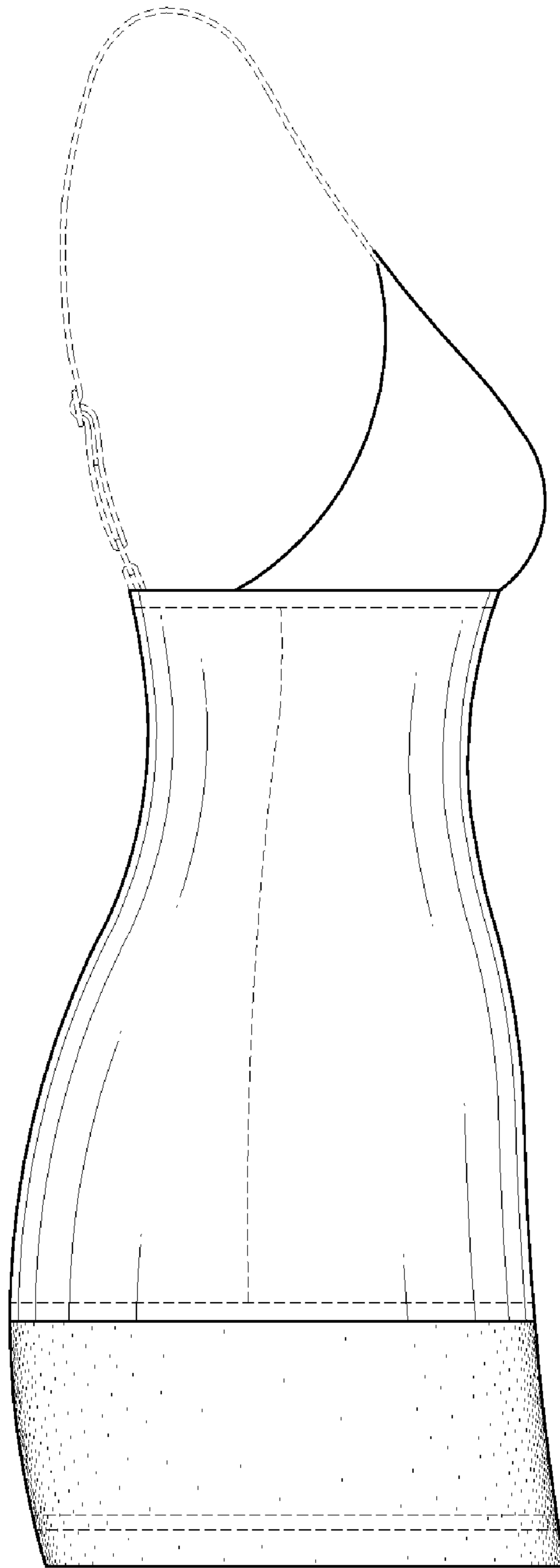

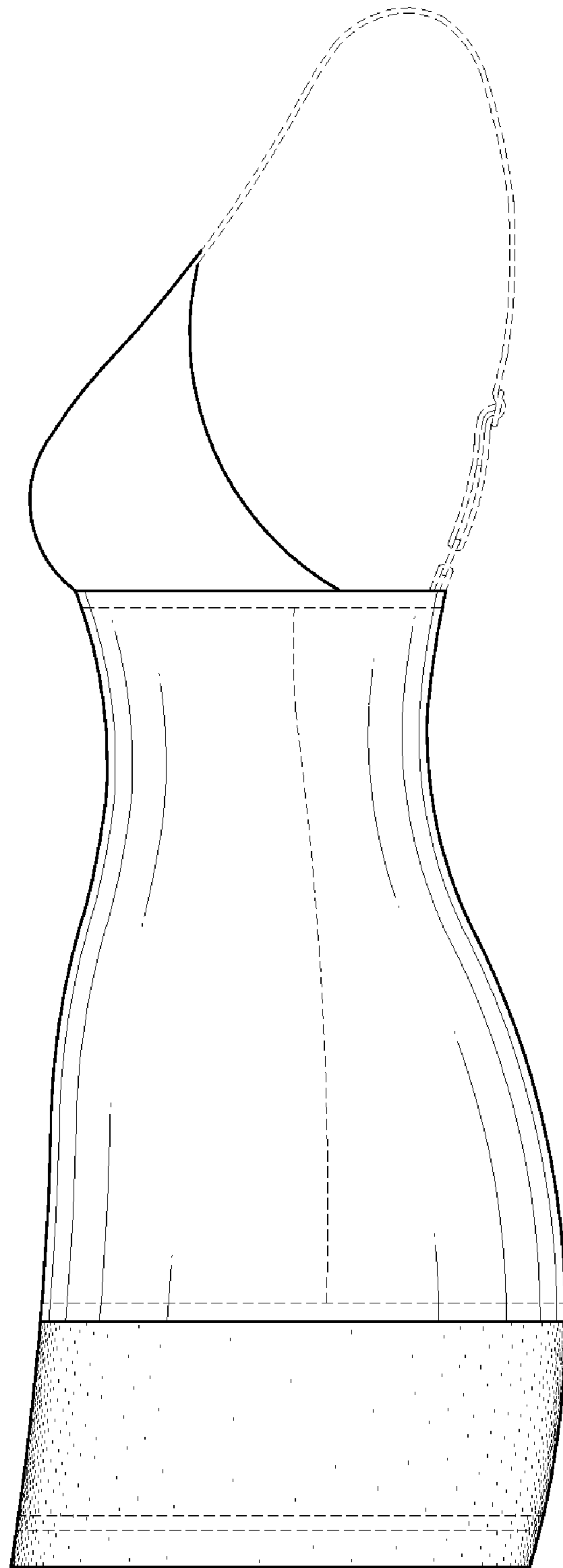
