(57) **CLAIM**

I claim the ornamental design for a tee shirt with bottle-opening high-friction substrate, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tee shirt with bottle-opening high-friction substrate, showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

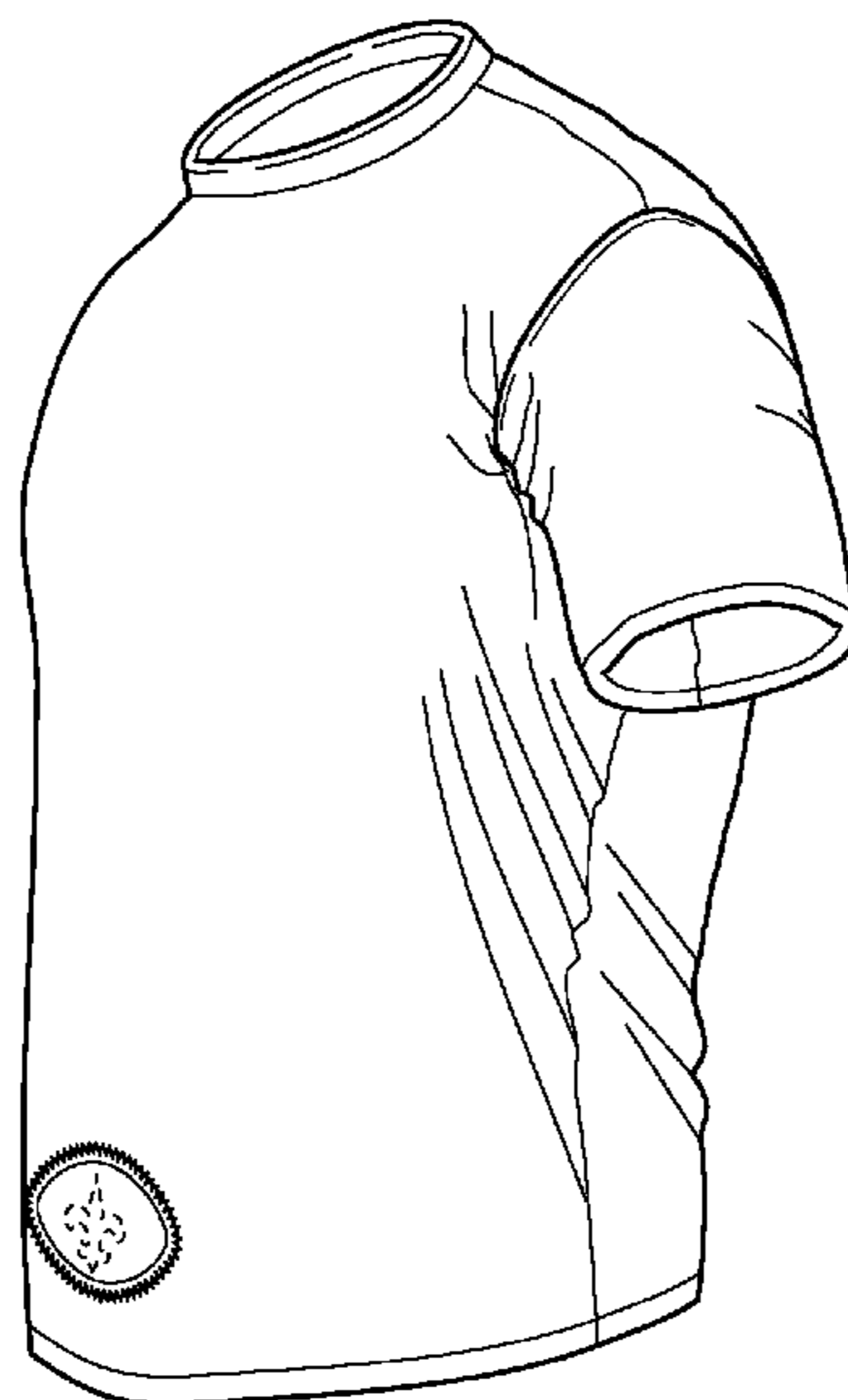
FIG. 4 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof;

FIG. 5 is a top plan view thereof; and,

FIG. 6 is a bottom plan view thereof.

The broken lines showing a sports logo on the rubber substrate in FIGS. 1, 2 and 4 are included for the purpose of illustrating the invention in use, and form no part of the claimed design.

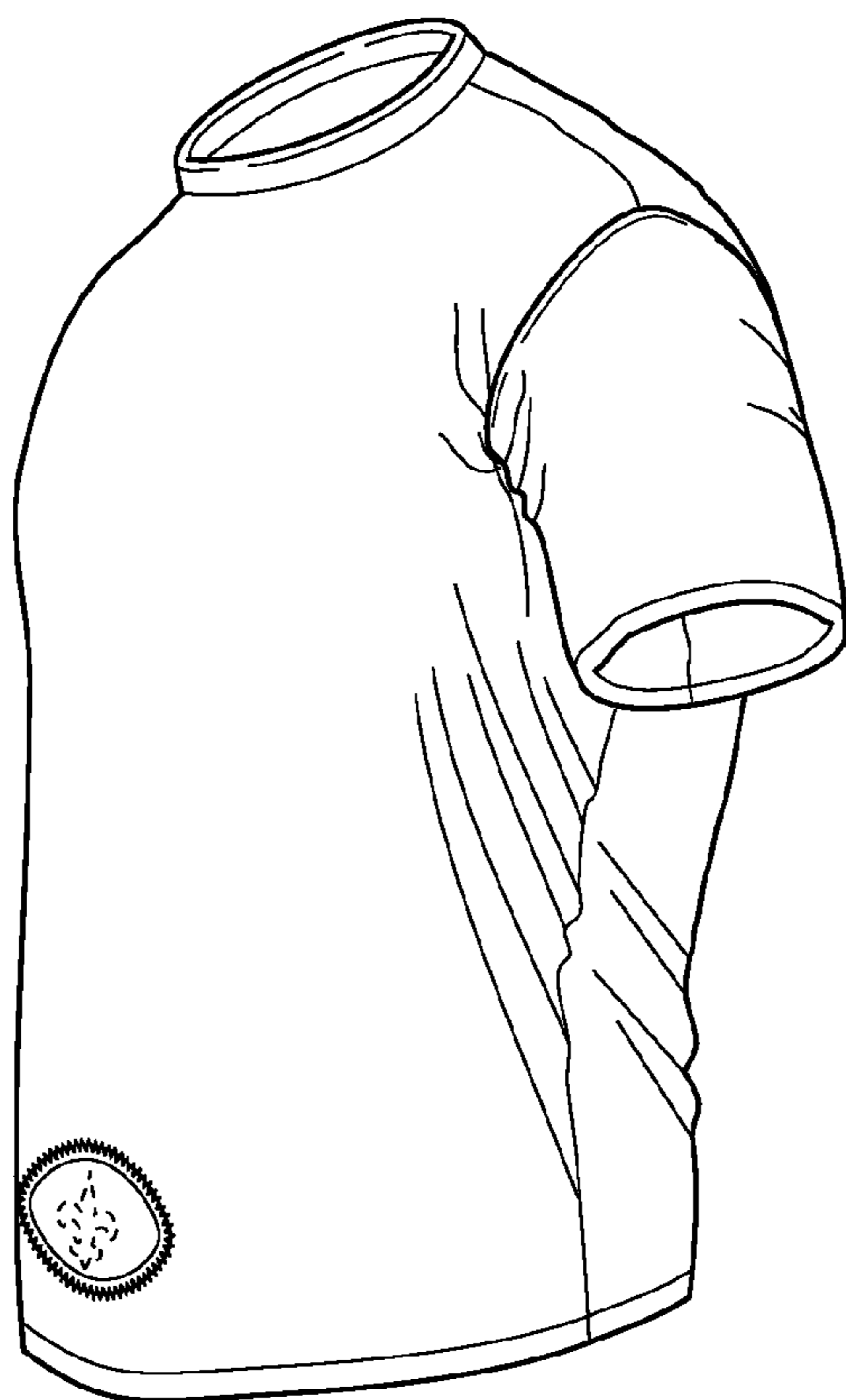

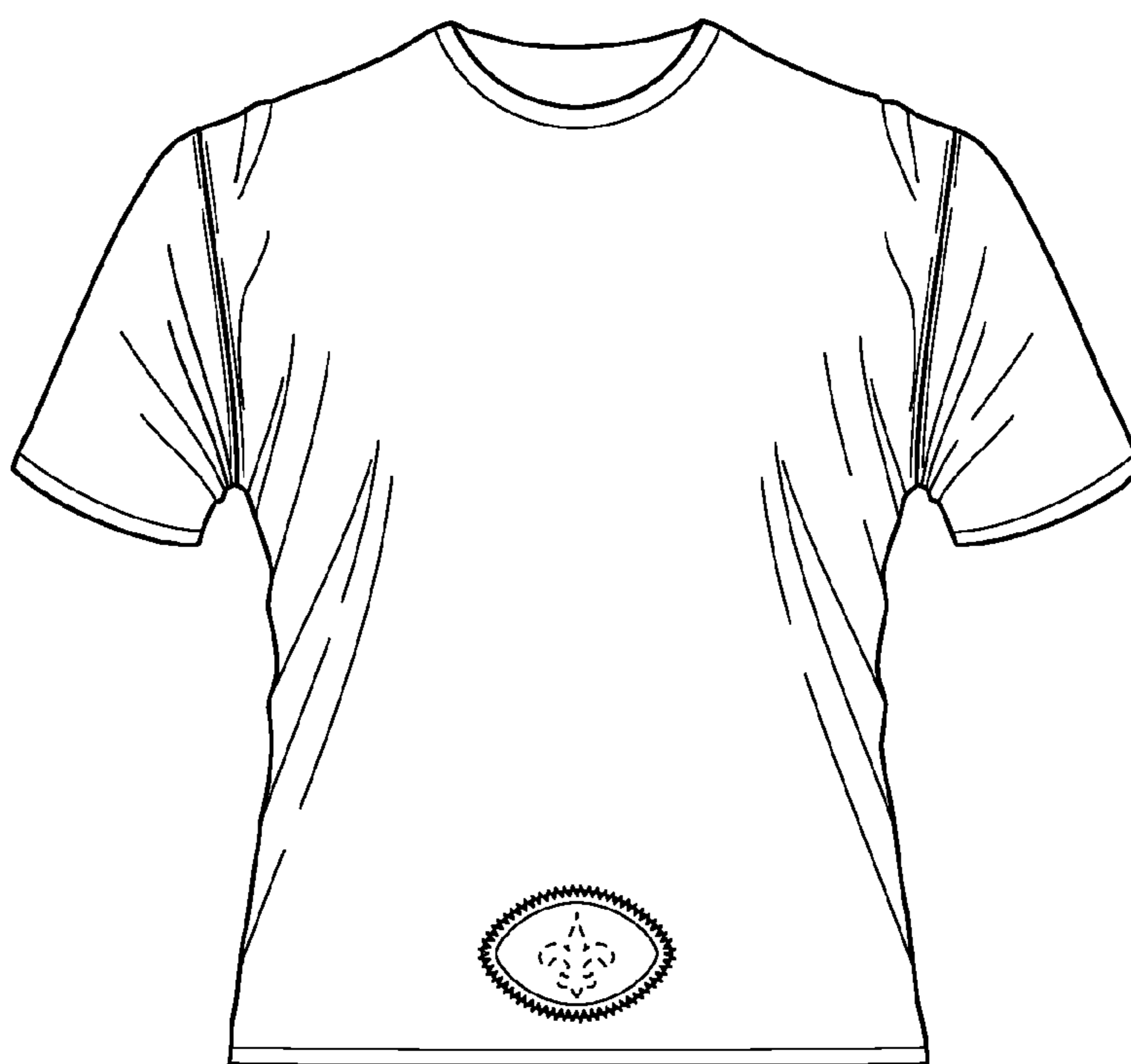

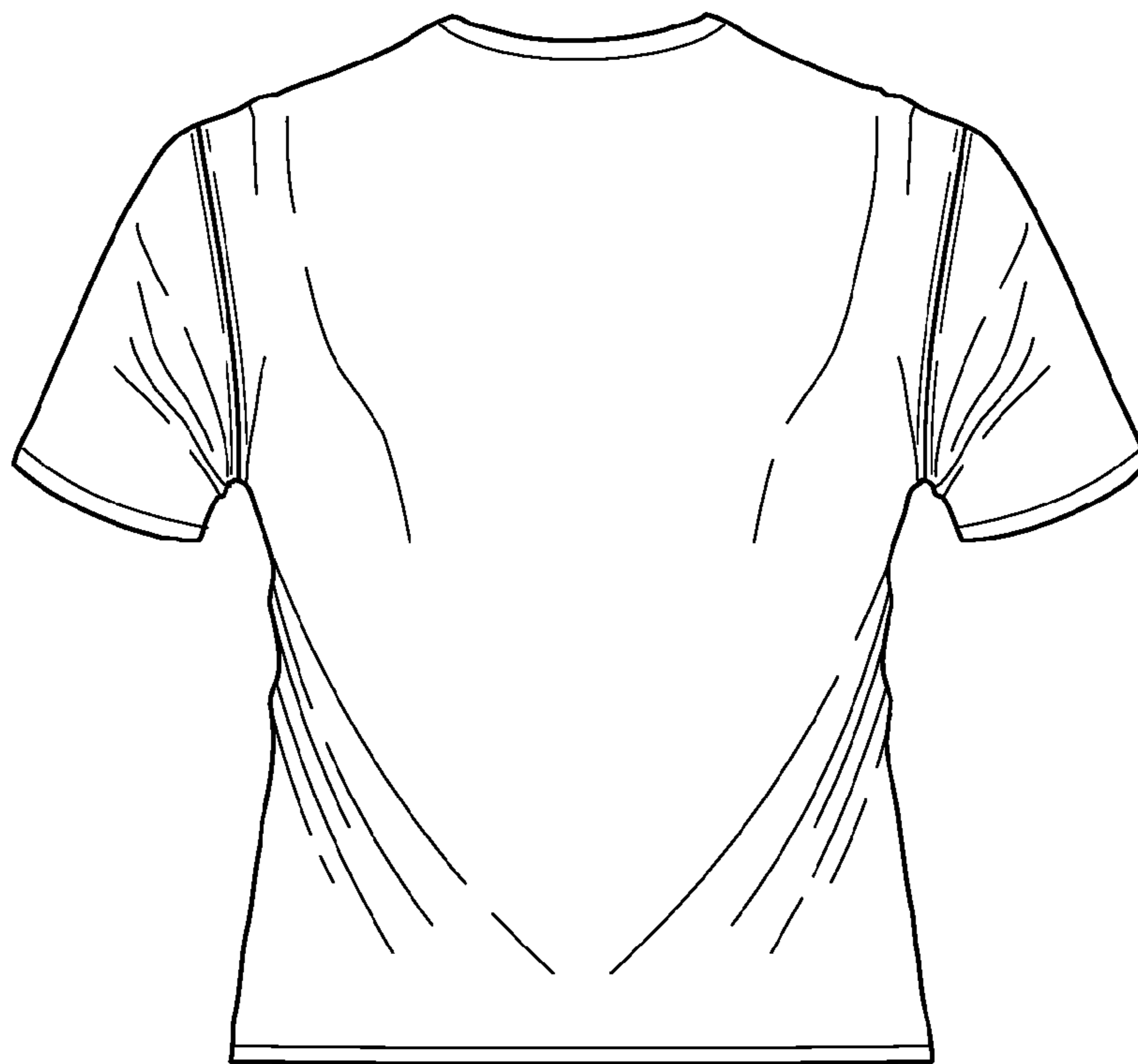

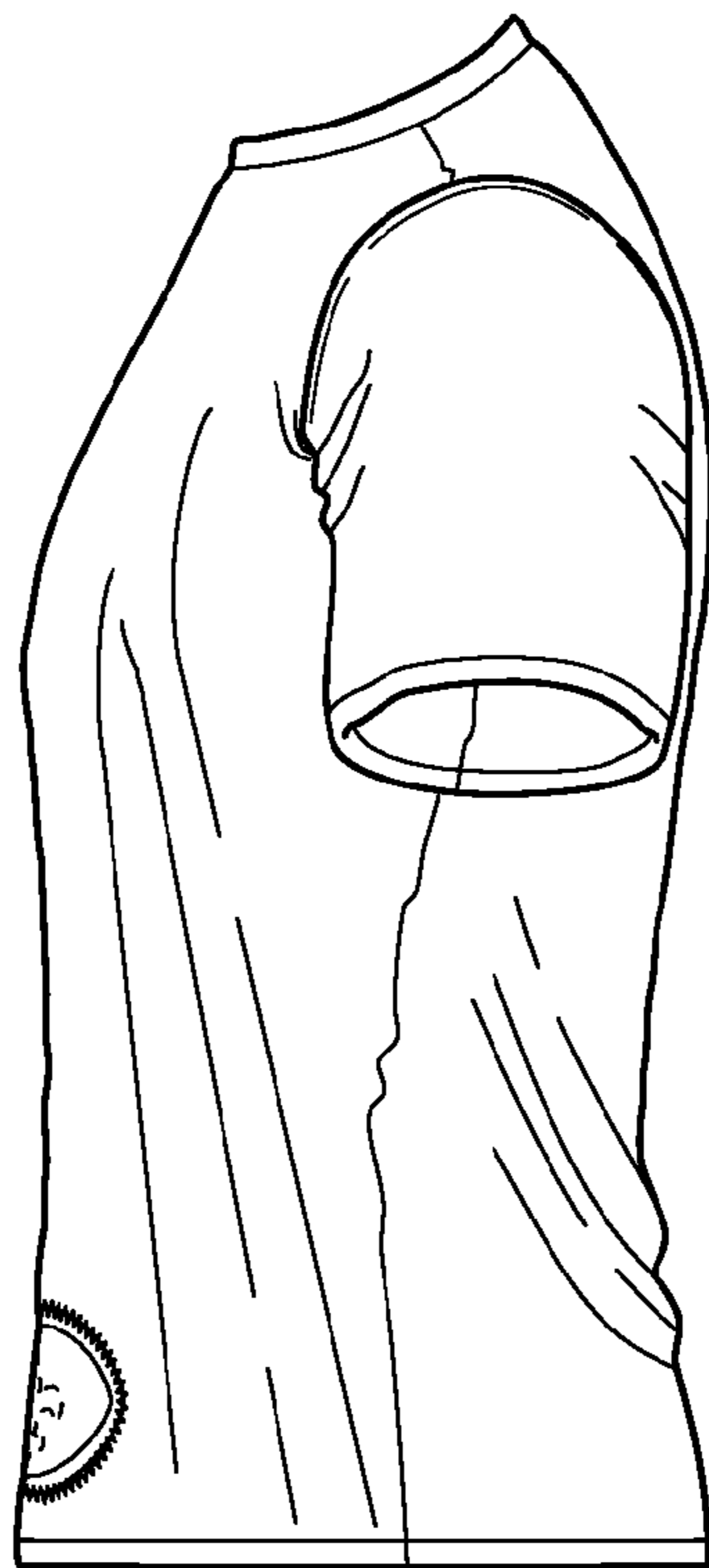

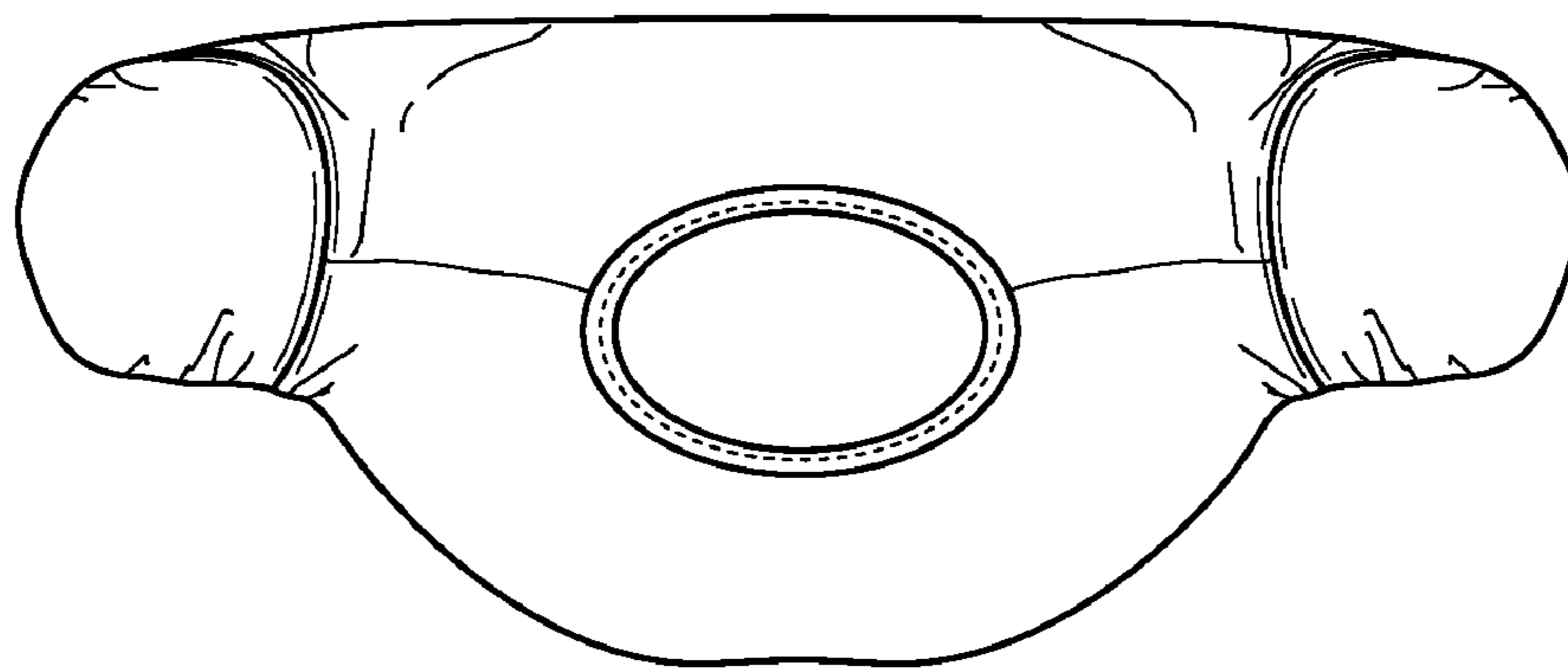

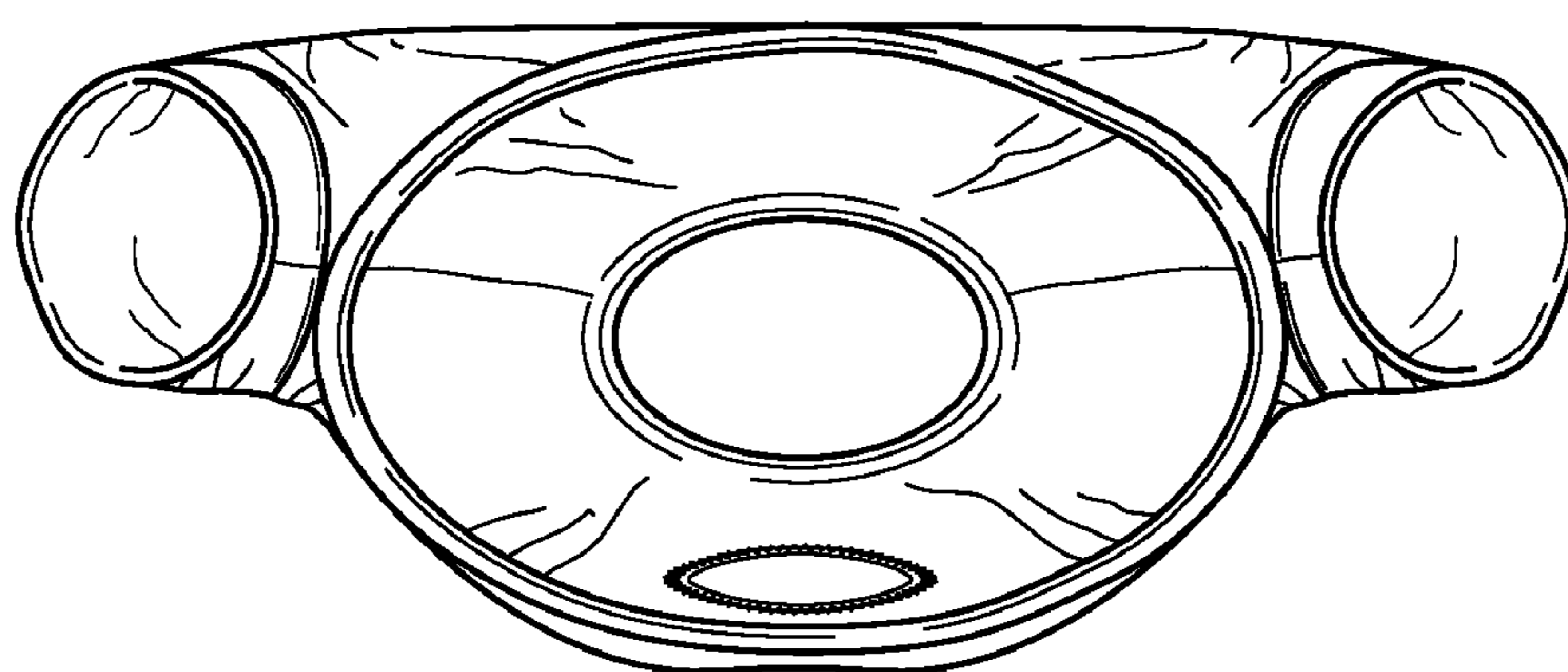
