FIG. 1 is a front elevational view of a place saver for stadium seating, showing my new design;

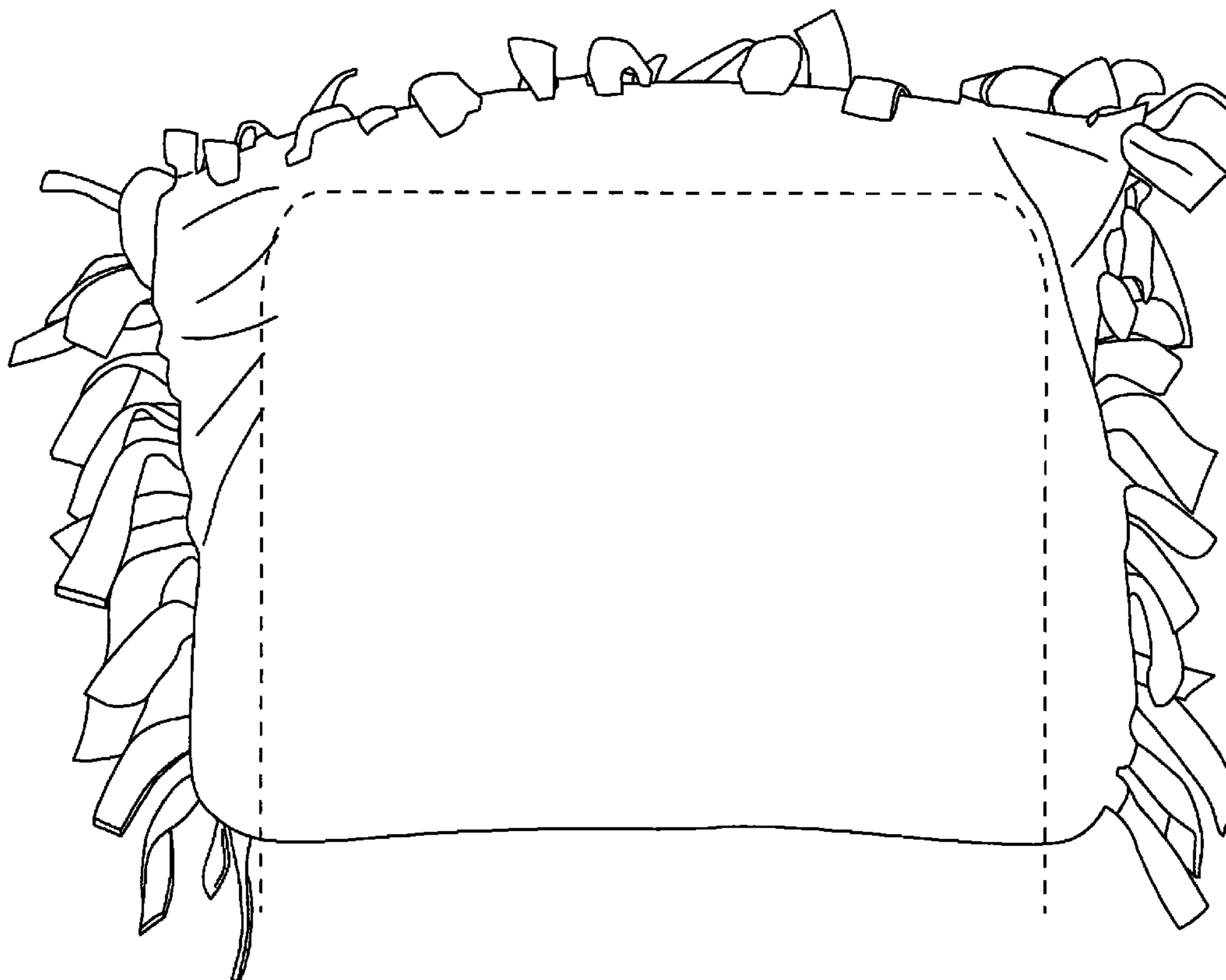
FIG. 2 is a left side view thereof;

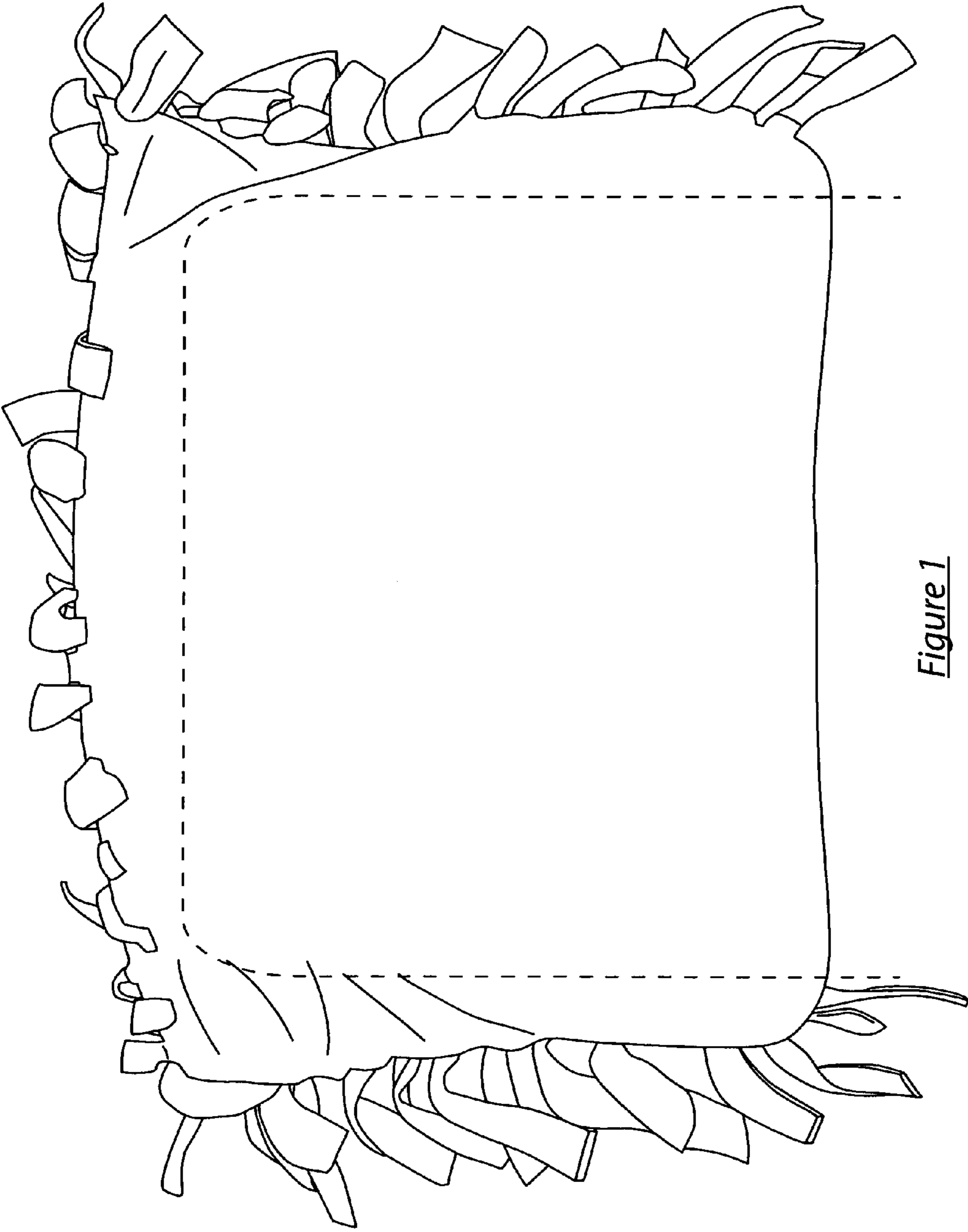

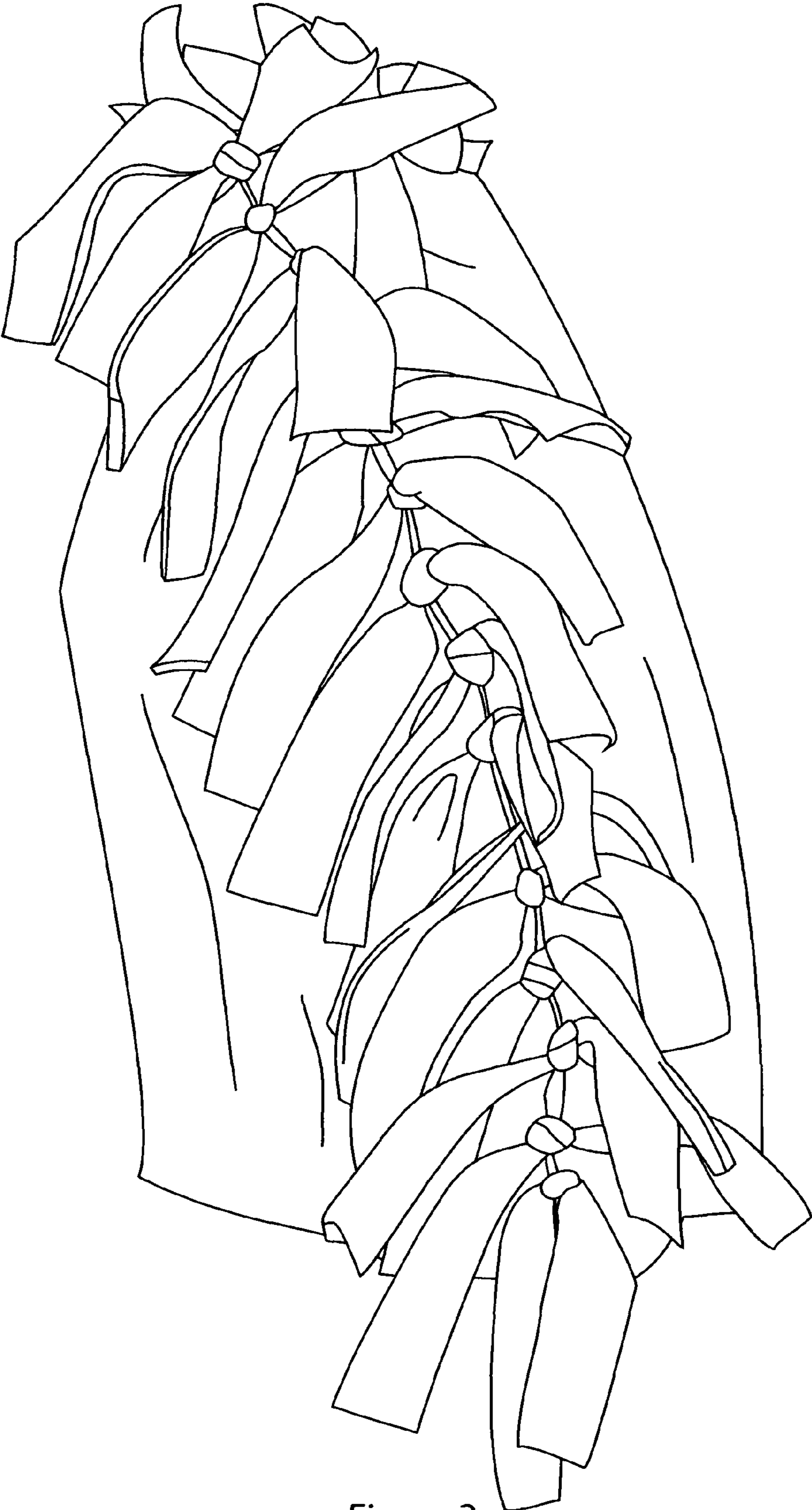

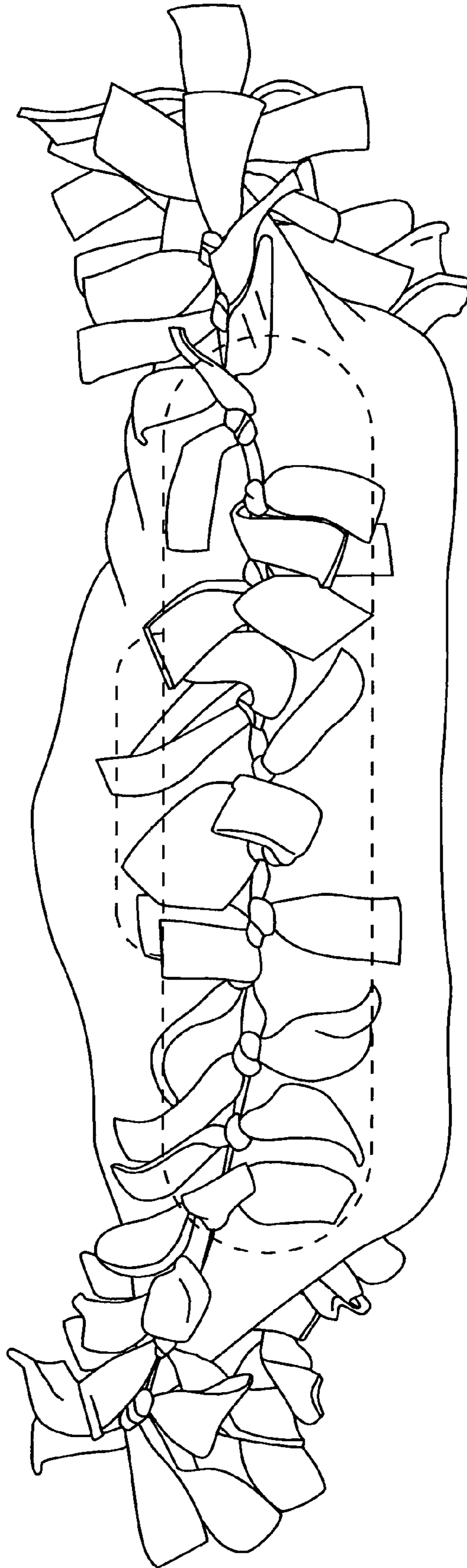

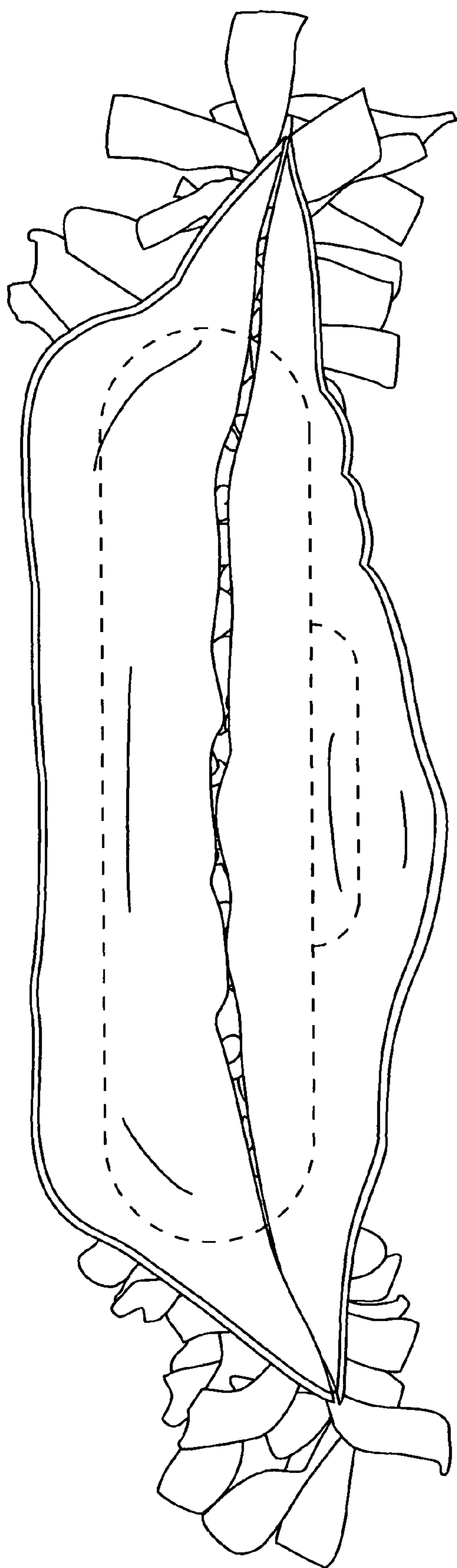
