(57) **CLAIM**

I claim the ornamental design for a protective case with integrated pivot for a portable computing device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a protective case with integrated pivot for a portable computing device showing my new design, in an open configuration;

FIG. 2 is a top view thereof;

FIG. 3 is a left side view, the right side being a mirror image thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a frontal view thereof;

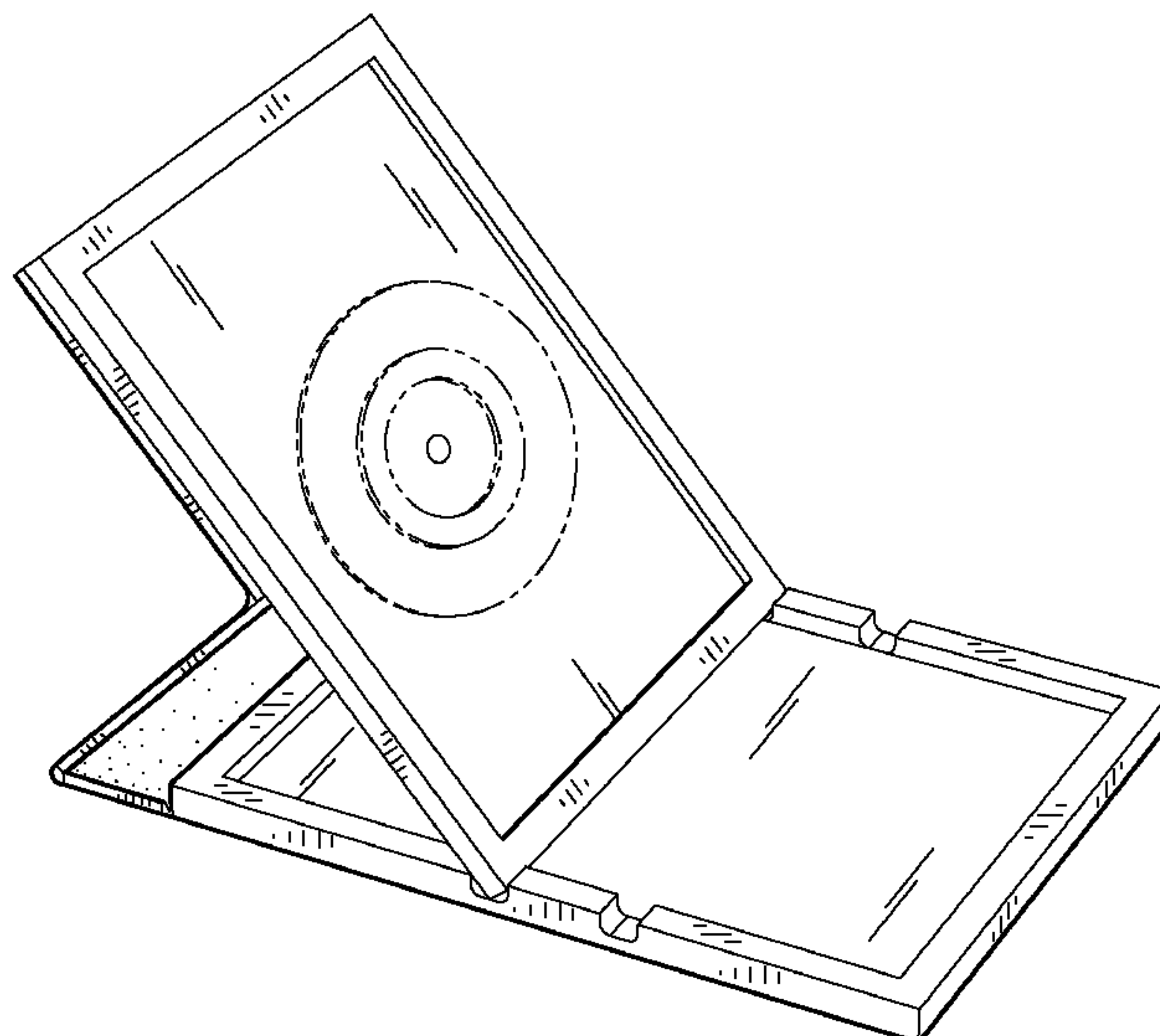
FIG. 6 is a bottom view thereof; and,

FIG. 7 is a perspective view thereof with the protective case with integrated pivot for a portable computing device shown in a closed configuration.

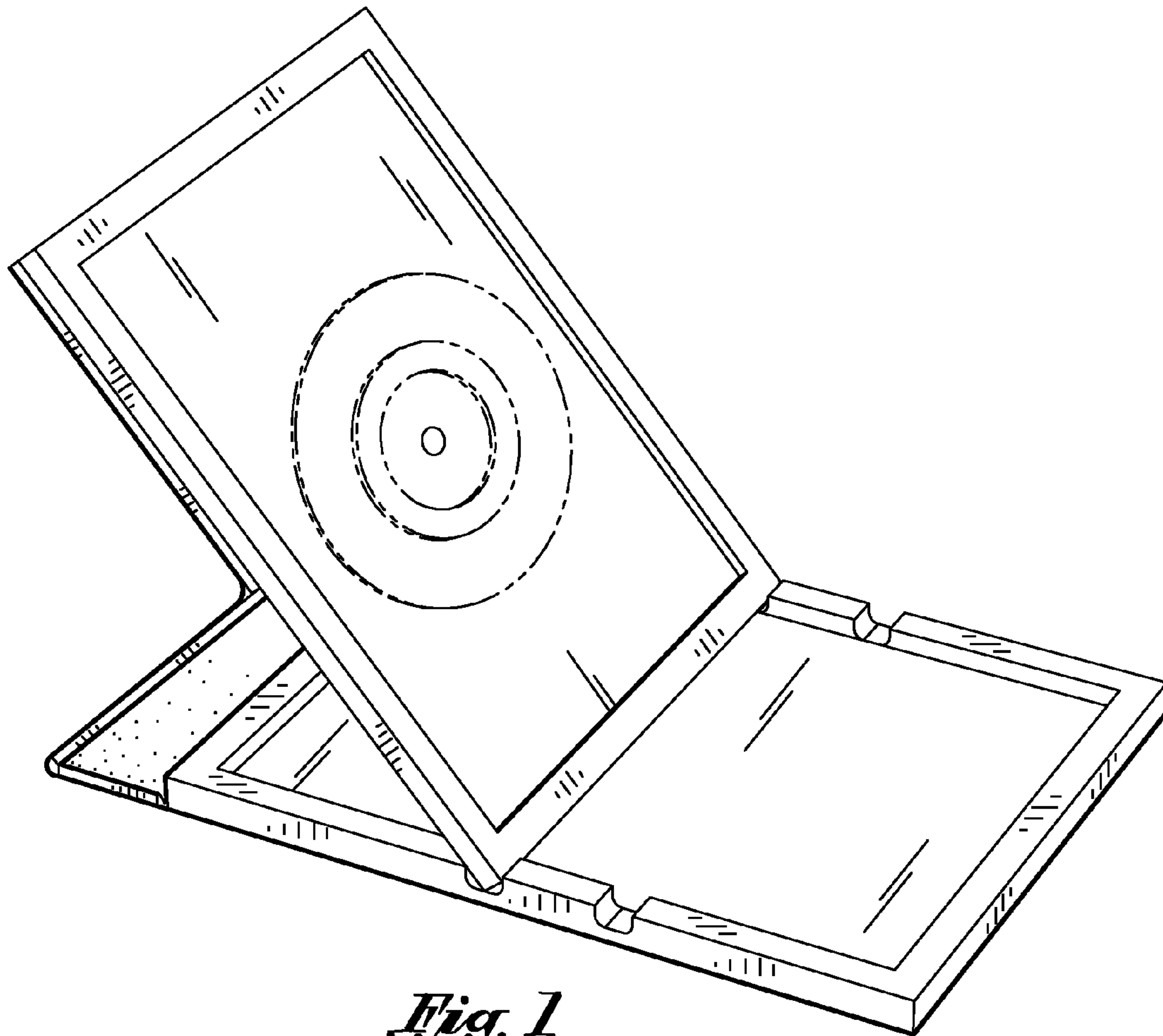

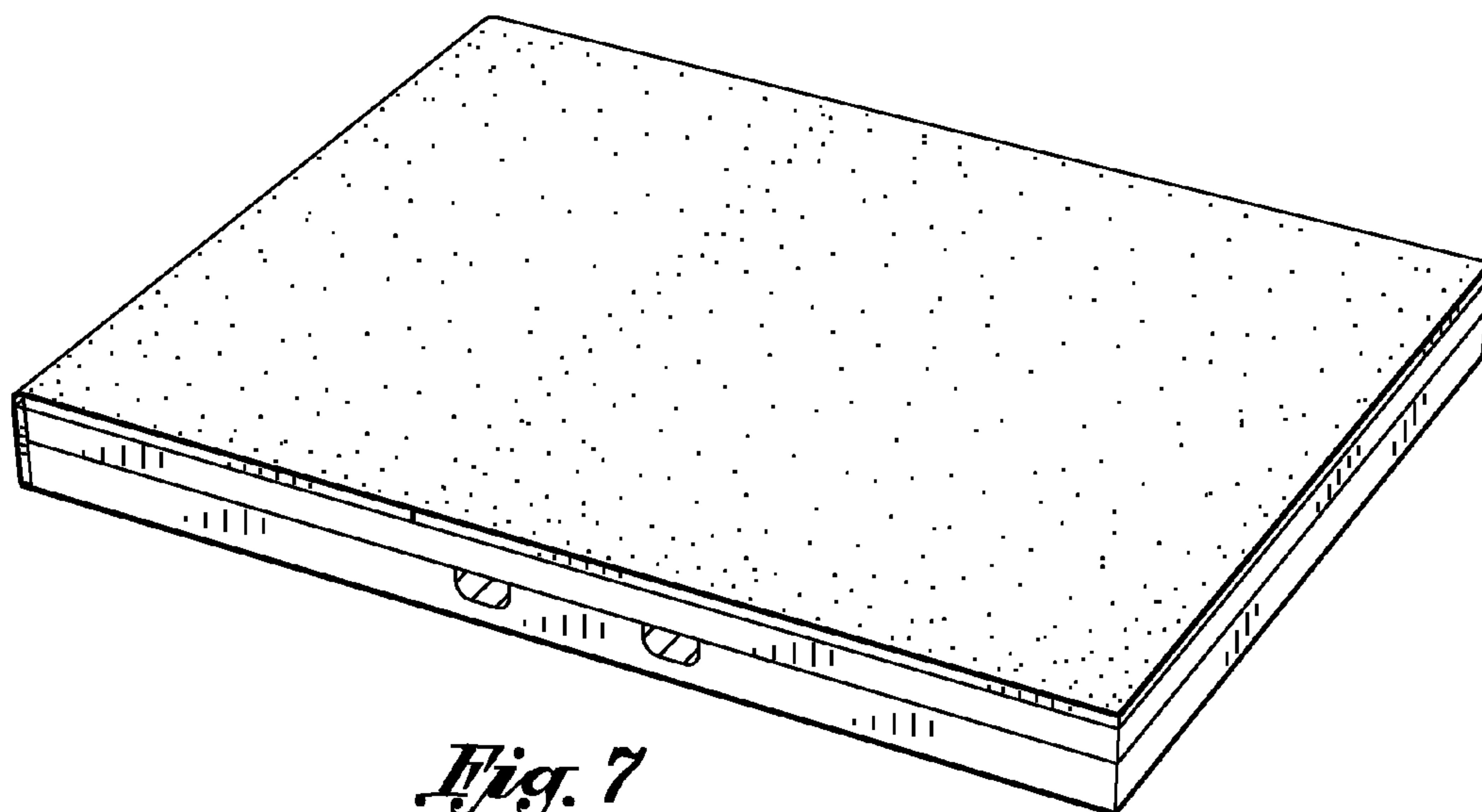

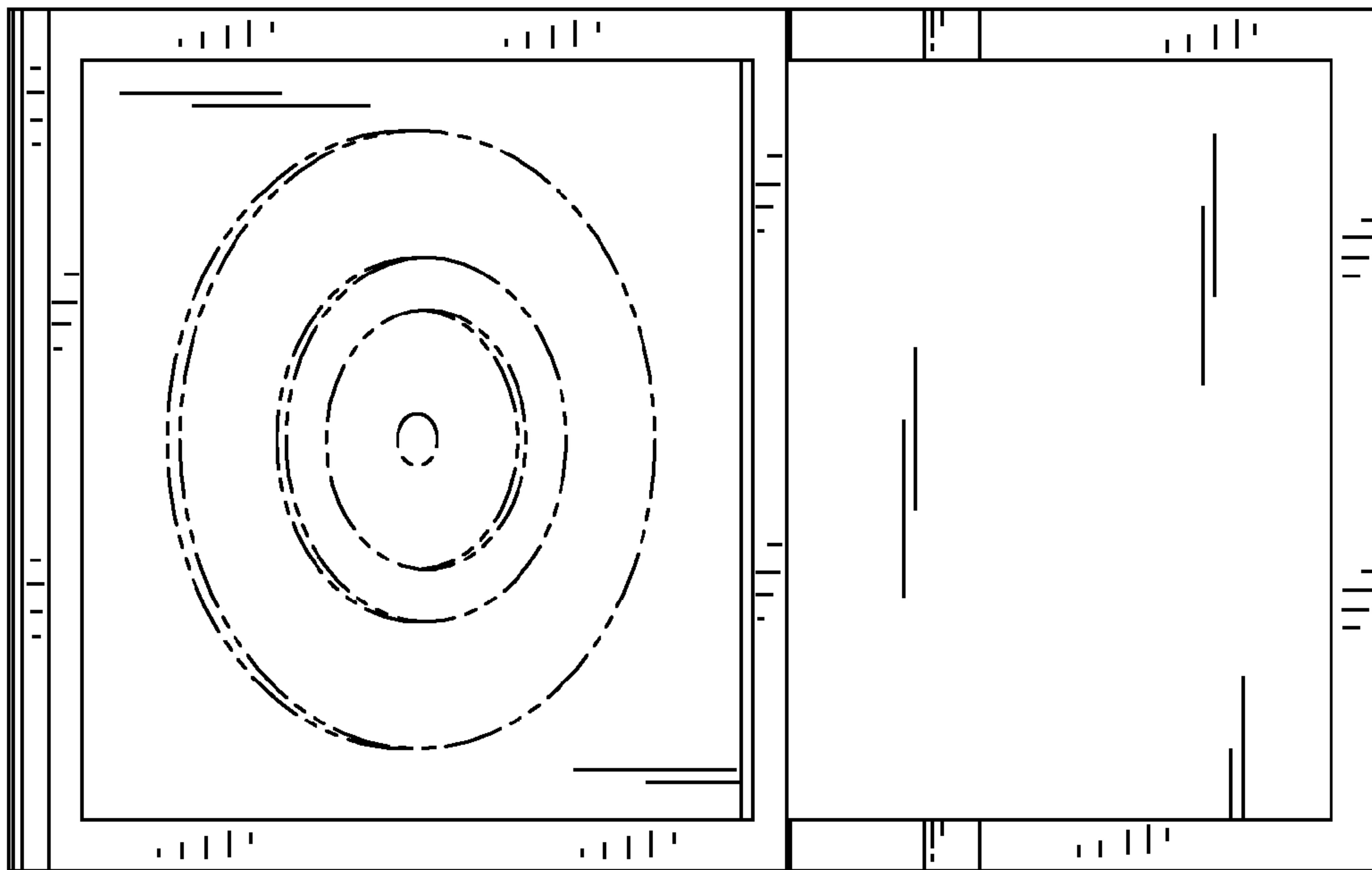

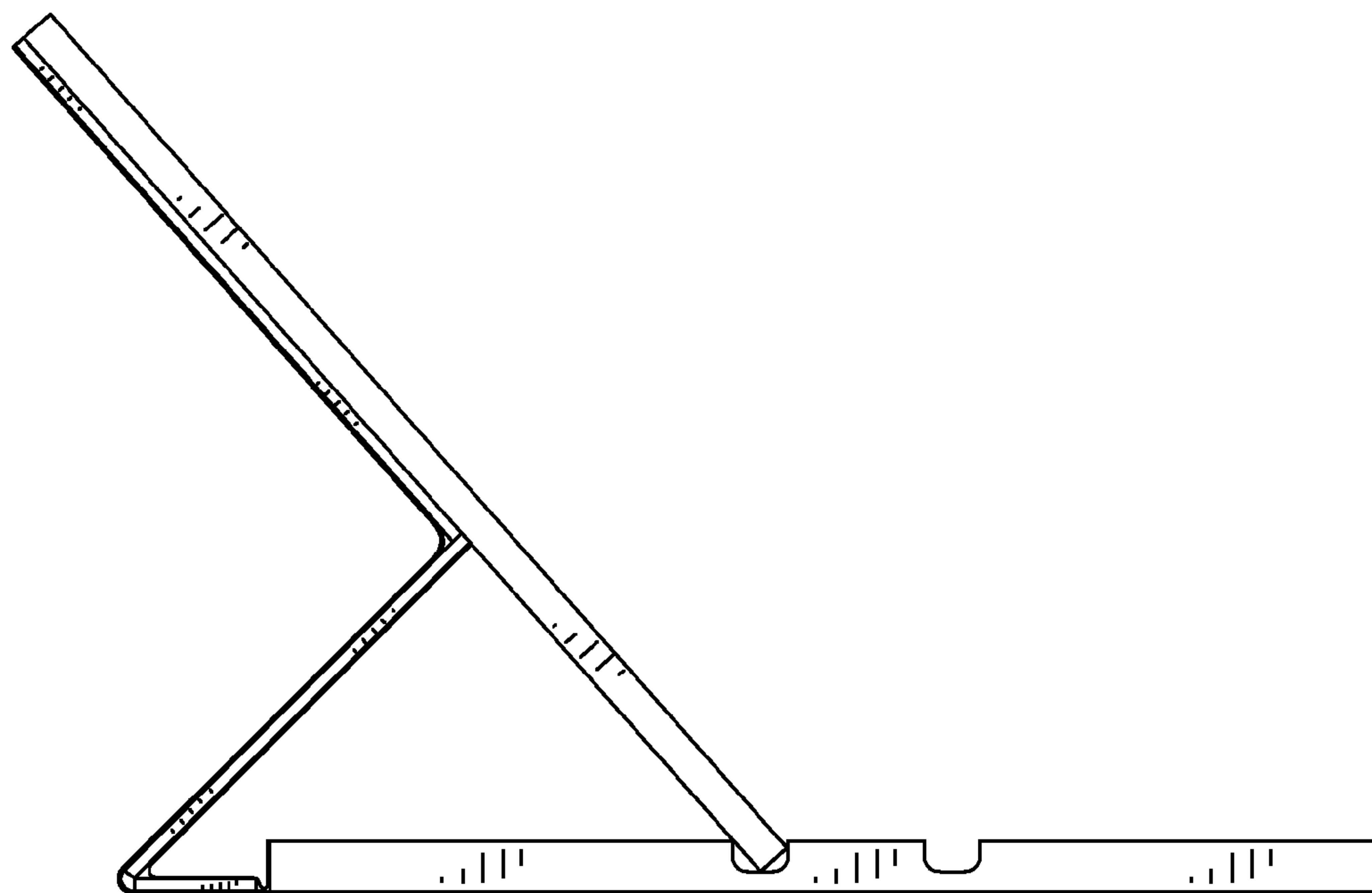

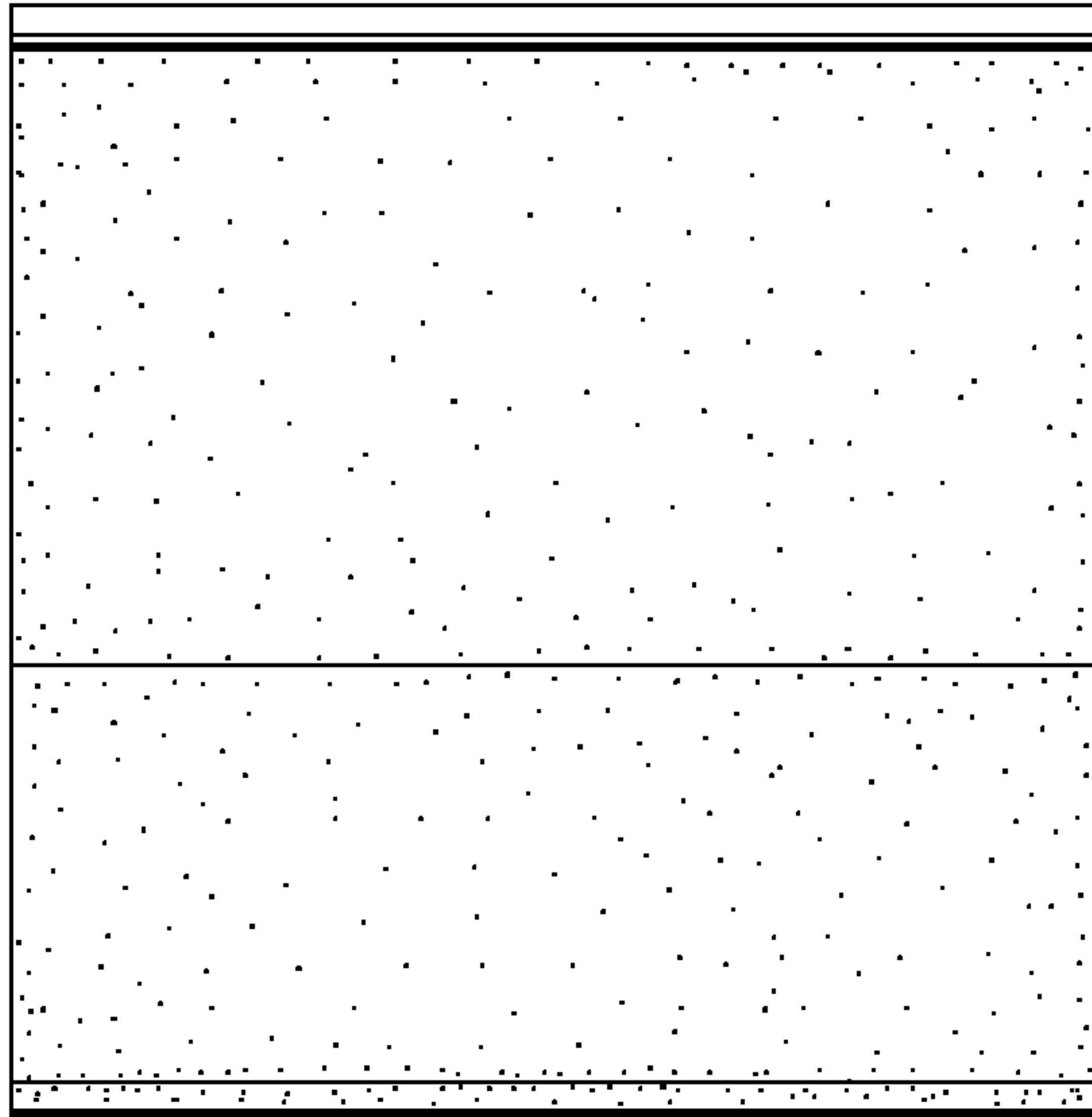

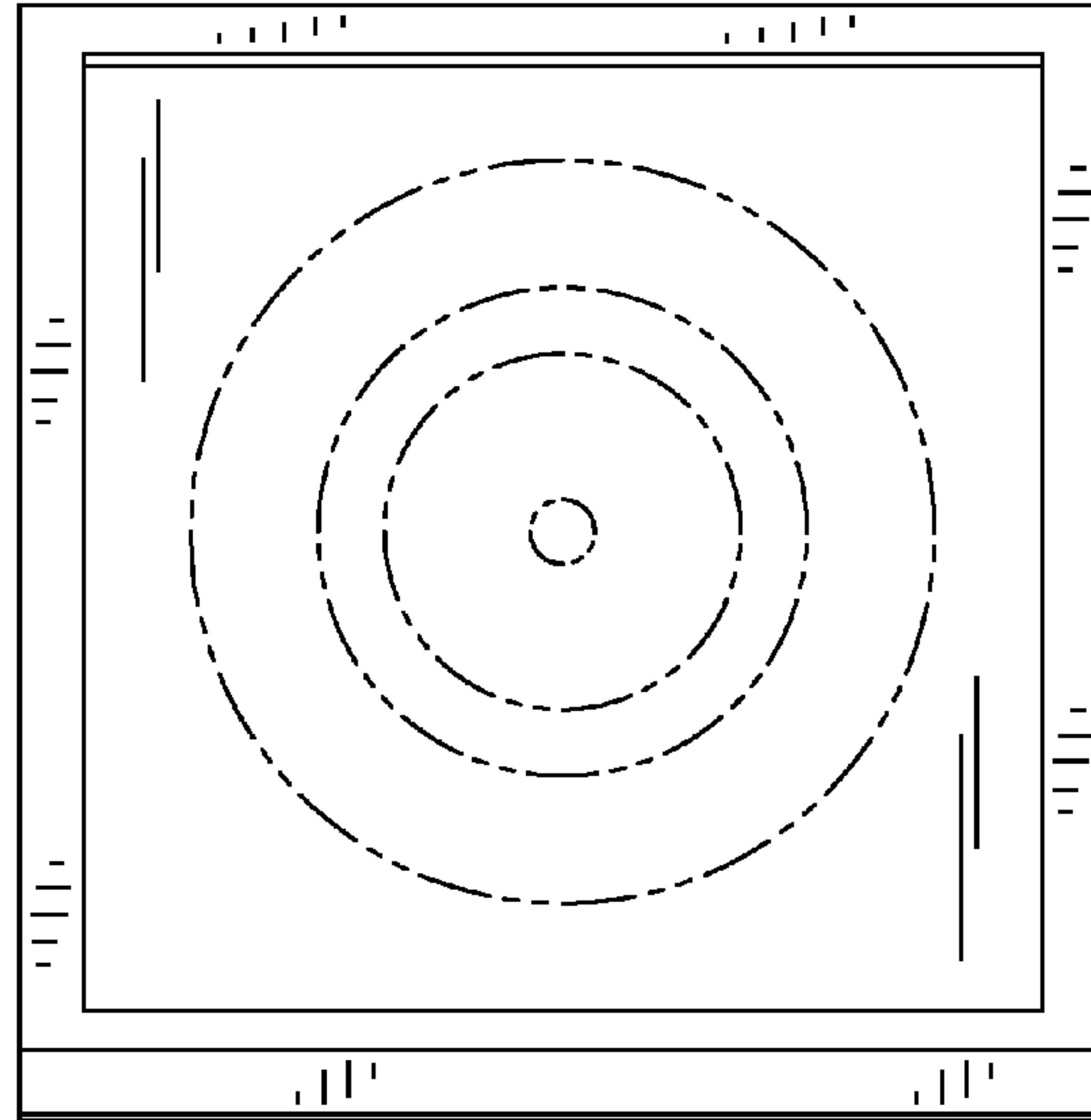

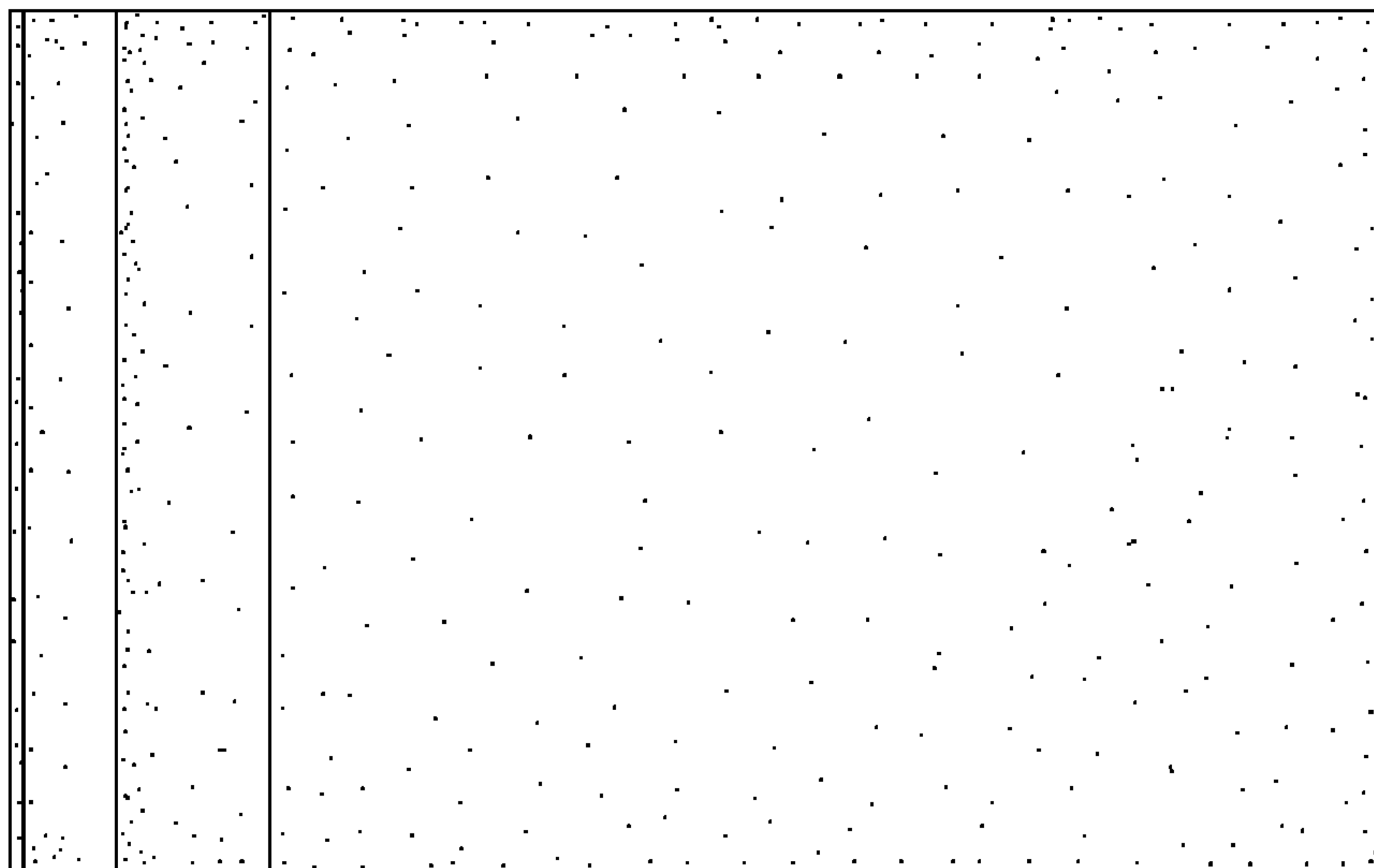
