FIG. 3 is a right view of the packaging of FIG. 1;

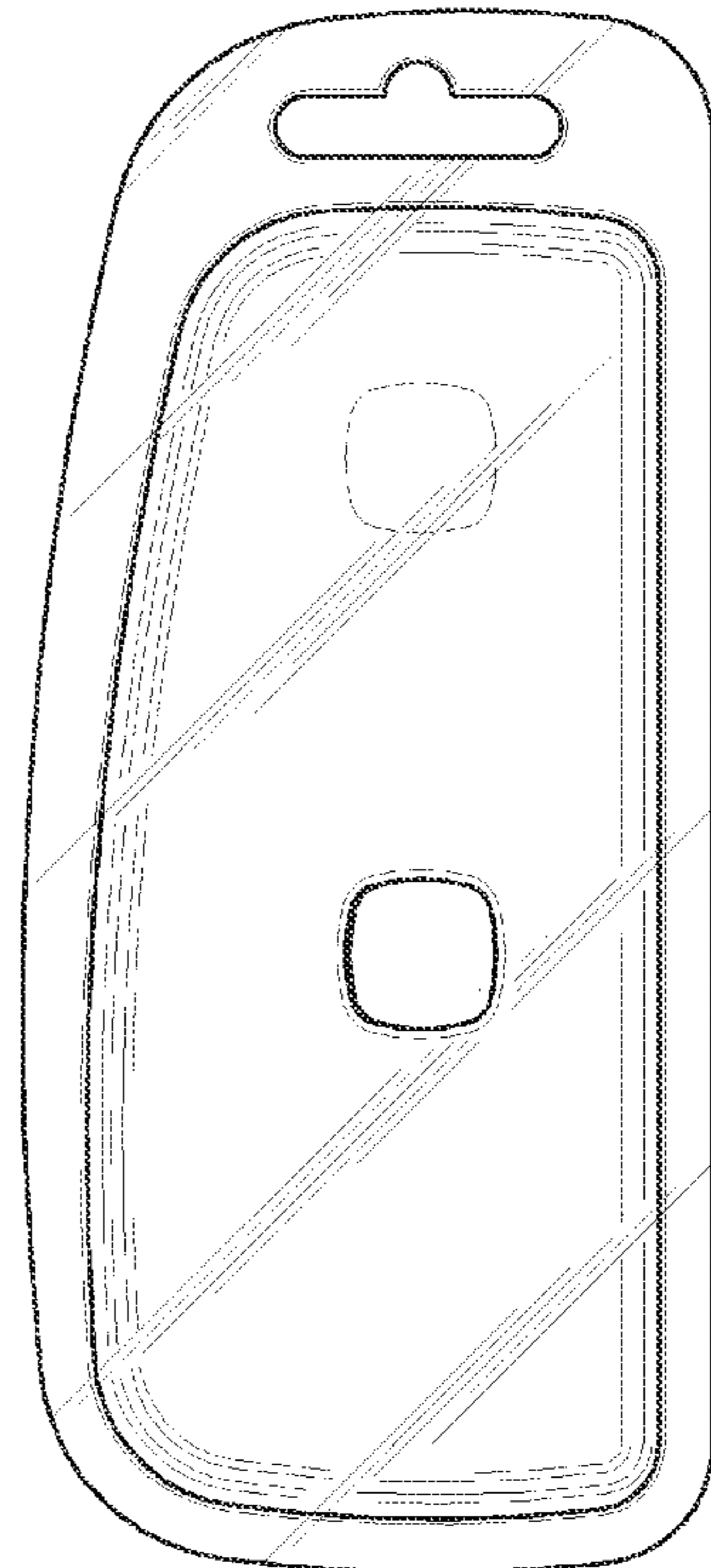
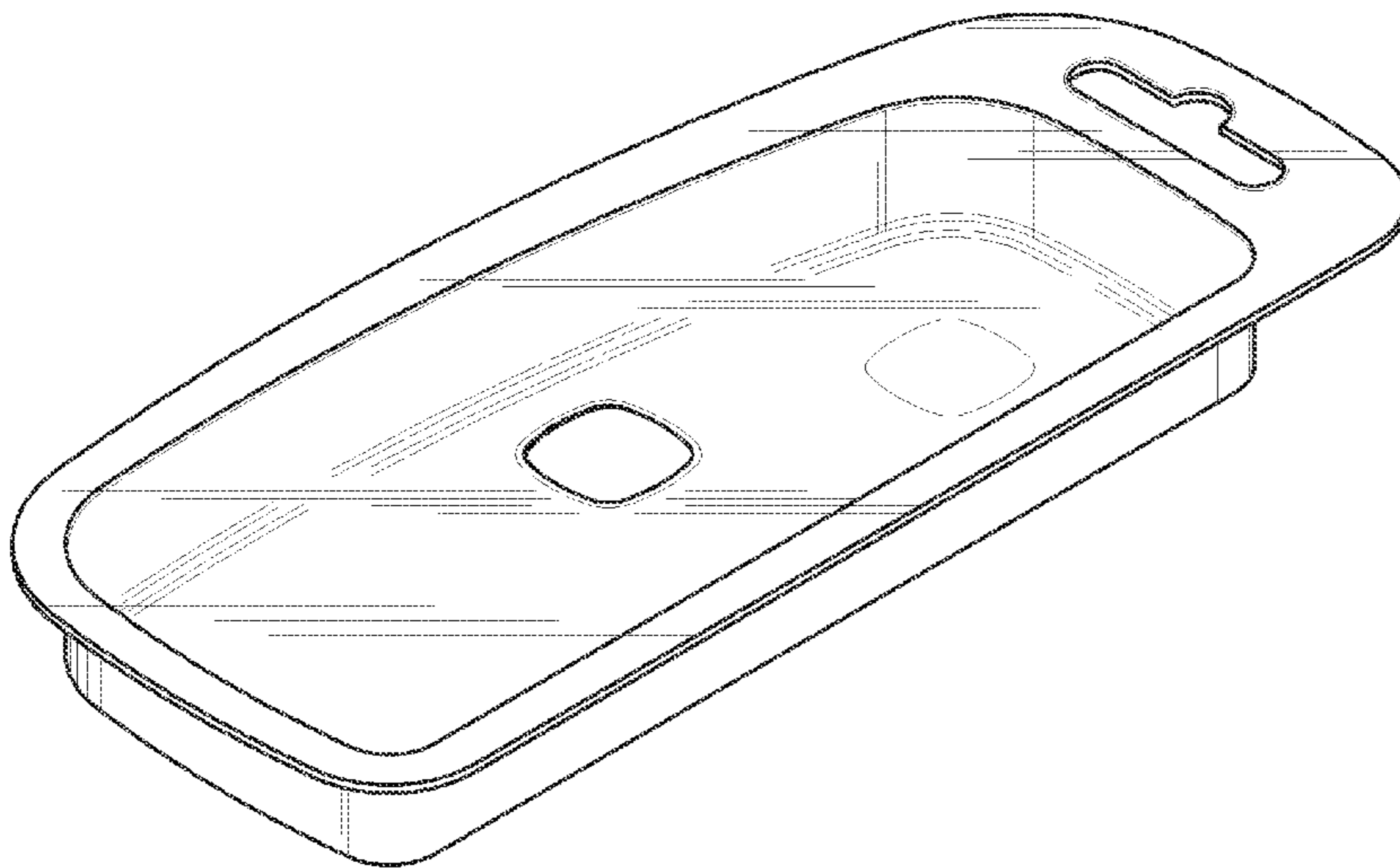
FIG. 4 is a bottom side view of the packaging of FIG. 1;

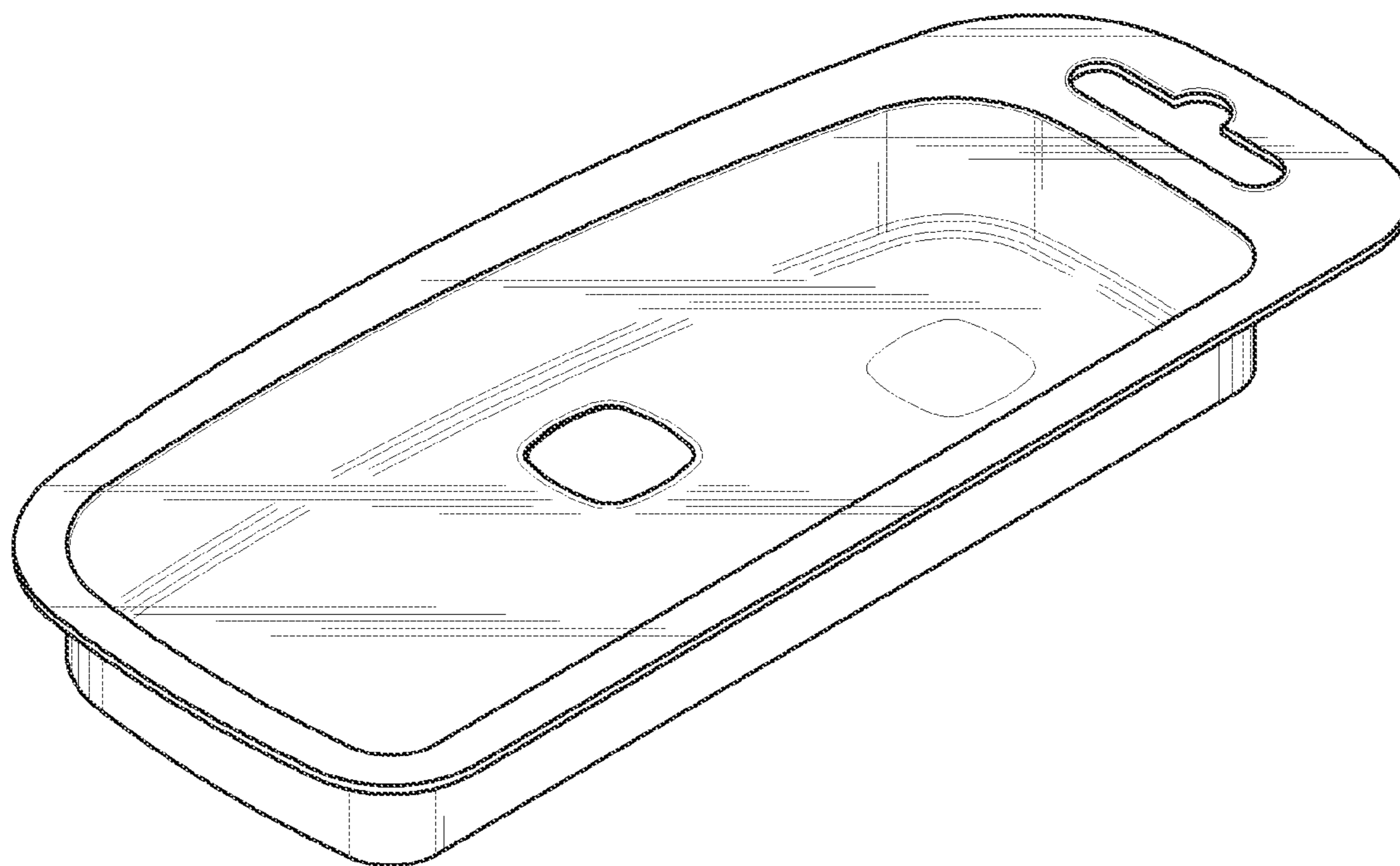
FIG. 5 is a left side view of the packaging of FIG. 1;

FIG. 6 is a front view of the packaging of FIG. 1; and,

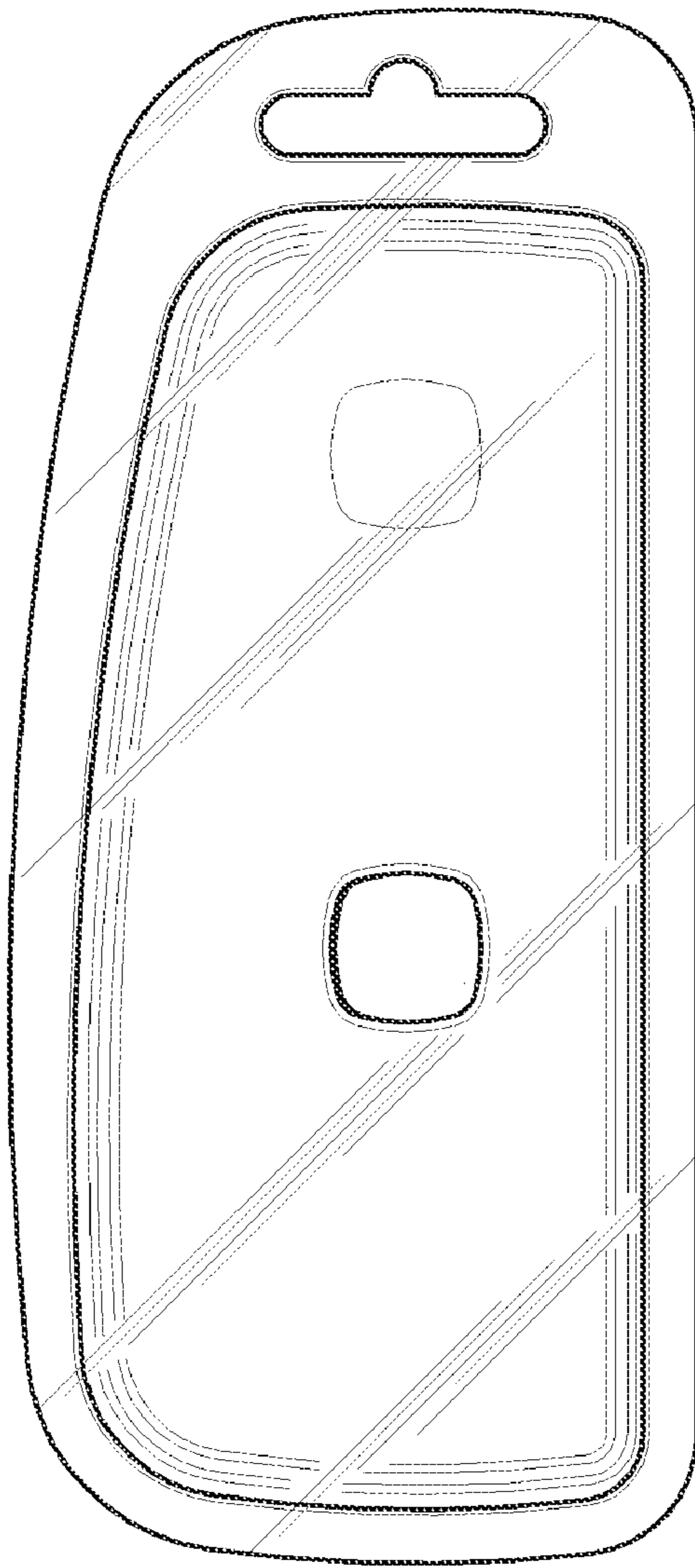
FIG. 7 is a back view of the packaging of FIG. 1.

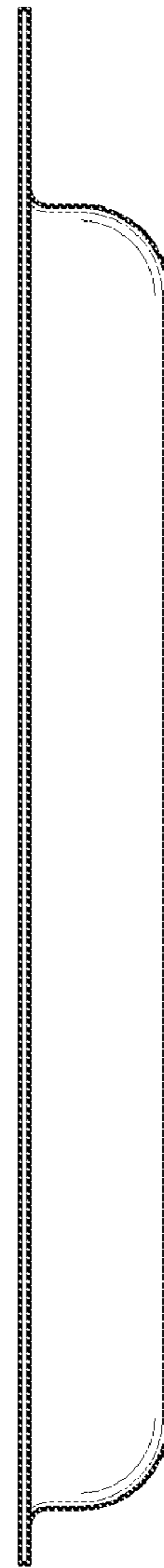




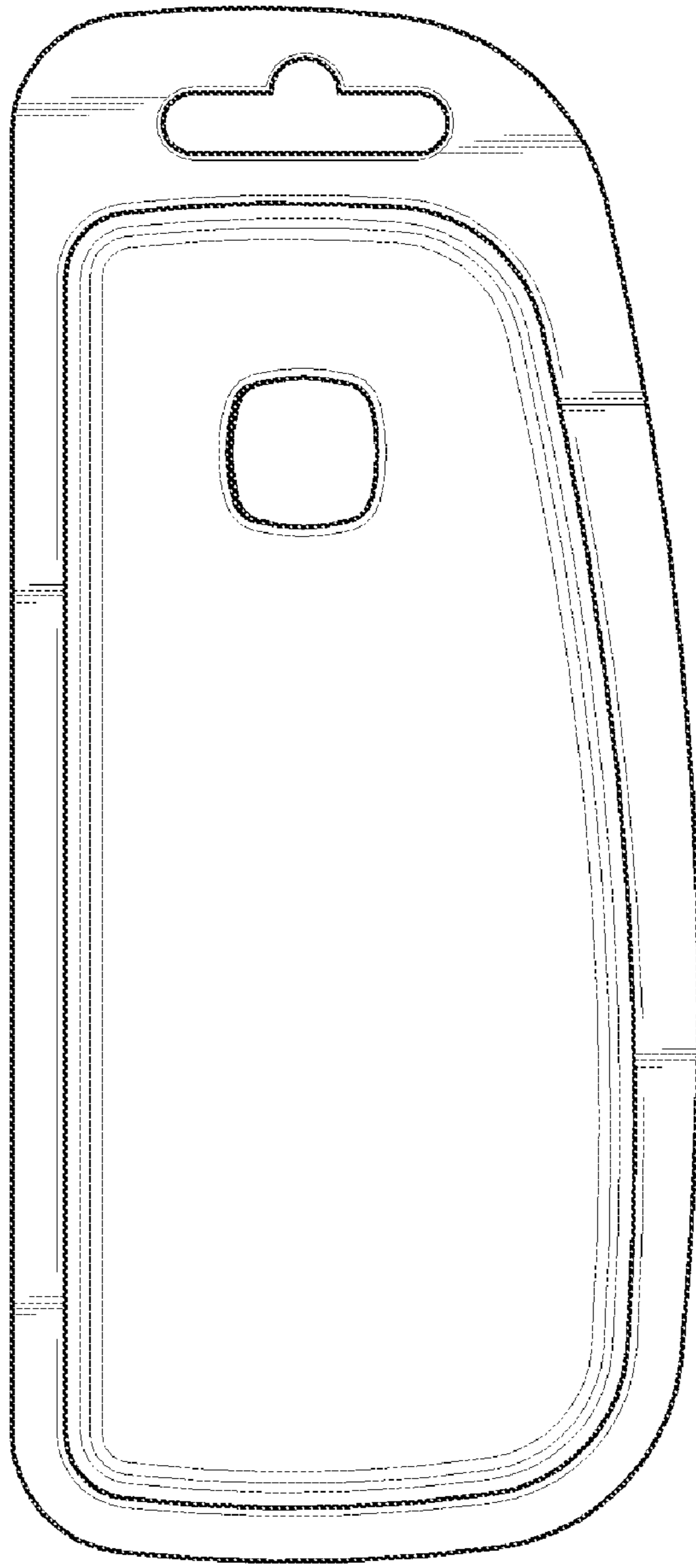

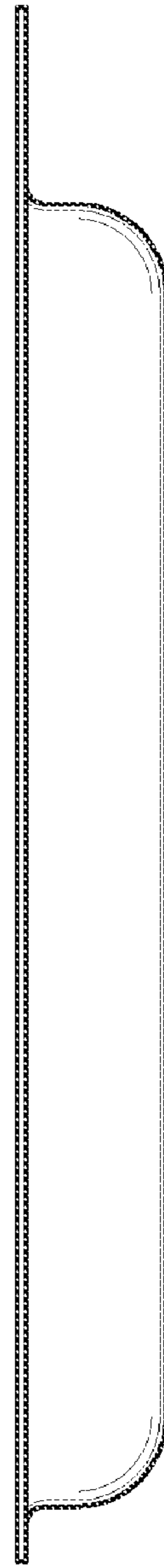
